TYPICALITY OF OPERATORS ON FRECHET ALGEBRAS ´ ADMITTING A HYPERCYCLIC ALGEBRA

Abstract. This paper is devoted to the study of typical properties (in the Baire Category sense) of certain classes of continuous linear operators acting on Fréchet algebras, endowed with the topology of pointwise convergence. Our main results show that within natural Polish spaces of continuous operators acting on the algebra $H(\mathbb{C})$ of entire functions on C, a typical operator supports a hypercyclic algebra. We also investigate the case of the complex Fréchet algebras $X = \ell_p(\mathbb{N}), 1 \leq p < +\infty$, or $X = c_0(\mathbb{N})$ endowed with the coordinatewise product, and show that whenever $M > 1$, a typical operator on X of norm less than or equal to M admits a hypercyclic algebra.

1. Introduction and main results

Our main aim in this work is to show that within certain natural classes of continuous linear operators acting on Fréchet algebras, endowed with the topology of pointwise convergence, a typical operator possesses a hypercyclic algebra. Its set of hypercyclic vectors thus has one of the richest structures for which one can hope.

Let us recall some pertinent definitions: given a continuous operator T on a topological vector space X, a vector x is said to be a hypercyclic vector for T if its orbit $\{T^n x; n \geq 0\}$ under the action of T is dense in X. The set of hypercyclic vectors for T is denoted by $HC(T)$, and it is dense in X as soon as it is nonempty. Whenever X is a second-countable Baire space, $HC(T)$ is a G_{δ} set (i.e. a countable intersection of open sets), so it is residual in X as soon as it is nonempty. The study of the linear structure of this set $HC(T)$ has been the object of many interesting and deep studies: it is known that whenever $HC(T)$ is nonempty, the set $HC(T) \cup \{0\}$ contains a dense linear manifold [10]. For certain classes of hypercyclic operators T, $HC(T) \cup \{0\}$ contains a closed infinite-dimensional subspace. See for instance [15] for a characterization in spectral terms of operators acting on complex separable Banach spaces with this property. We mention also the work [24].

When X is a topological algebra, it makes sense to ask whether $HC(T) \cup \{0\}$ contains a non-trivial subalgebra of X. Such an algebra will be called a *hypercyclic algebra*, and whenever it exists, we will say that T admits a hypercyclic algebra. This question of the existence of a hypercyclic algebra was first considered by Bayart and Matheron in

[4, Chapter 8], and independently by Shkarin in [28]: they showed that the differentiation operator $D: f \mapsto f'$ on the algebra $H(\mathbb{C})$ of entire functions on the complex plane admits a hypercyclic algebra. On the other hand, the translation operators $T_a : f \mapsto f(\cdot + a)$, $a \neq 0$, acting on $H(\mathbb{C})$ do not admit hypercyclic algebras [1]. The study of the existence of hypercyclic algebras has by now developed into a flourishing branch of linear dynamics. See for instance the works $[7]$, $[2]$, $[5]$, $[9]$, $[8]$, $[13]$ and $[3]$ among many other relevant references.

Several of these papers deal with the important question of characterizing the entire functions ϕ of exponential type such that $\phi(D)$ admits a hypercyclic algebra. The paper [2] by Bayart introduces an approach to this problem based on the study of the eigenvectors of the operator $\phi(D)$, which will be of particular importance in this paper.

Our aim is to study the question of the existence of hypercyclic algebras from the Baire Category point of view. Recall that if (E, τ) is a Polish space (i.e. separable and completely metrizable), and (P) is a certain property of elements of E, we say that (P) is typical (or equivalently, that a typical $x \in E$ has property (P)) if the set $\{x \in E : x \text{ has (P)}\}$ is comeager in E. A comeager set in E is a set which contains a dense G_{δ} set, i.e. which is large in E in the sense of Baire Category. Thus given a particular Polish space (E, τ) , it may be of interest to determine whether some natural properties of elements of E are typical or not.

Given a separable Fréchet algebra X (i.e. a separable completely metrizable topological algebra), our general goal is to define some natural spaces $\mathcal L$ of continuous linear operators on X , which are Polish spaces when endowed with the topology of pointwise convergence on X, and to determine whether a typical operator T in such a space $\mathcal L$ possesses a hypercyclic algebra. When $(X, \|\cdot\|)$ is a separable Banach algebra, natural spaces $\mathcal L$ to consider are the closed balls $\mathcal{B}_M(X)$ consisting of bounded operators T on X with $||T|| \leq M$, with $M > 1$ (so as to have a chance that a typical $T \in \mathcal{B}_M(X)$ for the topology of pointwise convergence on X is hypercyclic). In this Banach space setting, we denote by $\mathcal{B}(X)$ the algebra of bounded operators on X. The topology on $\mathcal{B}(X)$ defined as the topology of pointwise convergence on X is usually called the *Strong Operator Topology* (SOT): if T_{α} is a net of elements of $\mathcal{B}(X)$, and if $T \in \mathcal{B}(X)$, $T_\alpha \to T$ for the SOT if and only if $T_\alpha x \stackrel{\|\cdot\|}{\longrightarrow} Tx$ for every $x \in X$. When X is a separable Banach space, $(\mathcal{B}_M(X), SOT)$ is a Polish space for every $M > 0$. The study of typical properties of operators $T \in (\mathcal{B}_M(X), SOT)$ was initiated in the Hilbertian setting by Eisner and Mátrai $[12]$ and continued in the works $[18]$ and [19] in the case where $X = \ell_p(\mathbb{N}), 1 \leq p < +\infty$, or $X = c_0(\mathbb{N})$. Typical properties of operators for other Polish topologies on closed balls $\mathcal{B}_M(X)$ were also studied in [11] and [16], as well as in the monograph [17].

When X is a separable Fréchet space, we denote by $\mathcal{L}(X)$ the algebra of continuous linear operators on X, and by SOT the topology on $\mathcal{L}(X)$ of pointwise convergence on X. Let $(N_j)_{j\geqslant1}$ be a sequence of semi-norms on X defining its topology. Given a sequence $(M_j)_{j\geq 1}$ of positive real numbers and a sequence $(k_j)_{j\geq 1}$ of positive integers, we define

$$
\mathcal{L}_{(M_j),(k_j)}(X) := \{ T \in \mathcal{L}(X) \; ; \; \forall j \geq 1, \; \forall x \in X, \; N_j(Tx) \leq M_j \, N_{k_j}(x) \}
$$

We will show in Proposition 2.1 below that $(\mathcal{L}_{(M_j),(k_j)}(X), SOT)$ is a Polish space. Of course, this space may be very small for certain choices of the sequences $(M_i)_{i\geq 1}$ and $(k_i)_{i\geq 1}$, but in general, it makes sense to study SOT-typical properties of elements of $\mathcal{L}_{(M_j),(k_j)}(X)$. Observe that the space $\mathcal{L}_{(M_j),(k_j)}(X)$ depends on the choice of the sequence of semi-norms $(N_i)_{i\geqslant1}$.

The main result of this paper deals with the case where $X = H(\mathbb{C})$, the space of entire functions on C endowed with the topology of uniform convergence on compact sets. This topology on $H(\mathbb{C})$ can be defined via the following sequence $(N_j)_{j\geq 1}$ of semi-norms:

for every
$$
f \in H(\mathbb{C})
$$
, $f(z) = \sum_{m \ge 0} a_m z^m$, $z \in \mathbb{C}$, let $N_j(f) := \sum_{m \ge 0} |a_m| j^m$.

There are of course plenty of different choices of sequences of semi-norms defining the topology of $H(\mathbb{C})$, but for our purposes this choice is the most convenient. To simplify the notation, we will write $\mathcal{L}_{(M_j),(k_j)} := \mathcal{L}_{(M_j),(k_j)}(H(\mathbb{C}))$, subordinated to this choice of the sequence $(N_i)_{i\geqslant1}$.

We are now ready to state our main result.

Theorem 1.1. Let the sequences $(M_i)_{i\geq 1}$ and $(k_i)_{i\geq 1}$ be such that

- (i) for all $\alpha \geqslant 1$, $j^{\alpha} = o(M_j)$ as j tends to infinity;
- (ii) for all $j \geq 1$, $M_j \geq j + 1$;
- (iii) for all $j \geqslant 1$, $k_j \geqslant j + 2$;
- (iv) $M_1 < k_1$ and $k_j \geq k_1$ for all $j \geq 1$.

Then a typical operator $T \in (\mathcal{L}_{(M_j),(k_j)}, \text{SOT})$ admits a hypercyclic algebra.

Choosing the sequences $(M_j)_{j\geq 1}$ and $(k_j)_{j\geq 1}$ in such a way that for all $j \geq 1, M_j \geq j+1$ and $k_j \geq j + 2$ ensures that the differentiation operator D – the crucial example of an operator on $H(\mathbb{C})$ which admits a hypercyclic algebra – belongs to $\mathcal{L}_{(M_j),(k_j)}$. The operators D and $\frac{1}{n!}D^n$ will be of special importance in the proof of Theorem 1.1; they will play a role analogous to the left shift operator and its iterates in the Banach space case.

Before going further, we notice that the differentiation operator is a so-called tame operator, and that the spaces $\mathcal{L}_{(M_j),(k_j)}$ in Theorem 1.1 include spaces of tame operators. They are thus natural spaces to be considered in the context of Fréchet spaces. We recall briefly the definition of a tame operator, and we refer to the survey [21] for more on tame Fréchet spaces. Let X be a Fréchet space whose topology is given by a certain increasing family of semi-norms $(\tilde{N}_j)_{j\geqslant 1}$, and let $\tilde{T} : \tilde{X} \to \tilde{X}$ be a linear map. The map \tilde{T} is called tame if there exist two integers $b, r \geq 1$ such that for every $j \geq b$, the following is true: there exists a constant $C_j > 0$ such that $\tilde{N}_j(\tilde{T}x) \leqslant C_j \tilde{N}_{j+r}(x)$ for every $x \in \tilde{X}$. A tame linear map is automatically continuous. It can easily be observed that the differentiation operator D is tame, and the operators belonging to the space $\mathcal{L}_{(M_i),(k_i)}$ considered in Theorem 1.1 are tame provided that there exists an integer $r \geq 2$ such that $k_j = j + r$ for all j sufficiently large.

In order to prove Theorem 1.1, we must exhibit a dense set of operators T belonging to $\mathcal{L}_{(M_i),(k_i)}$ admitting a hypercyclic algebra. These operators will be of the form

$$
T = A + \frac{1}{(n+1)!} D^{n+1}
$$

for some integer $n \geq 0$, where A acts on $\mathbb{C}_n[z]$ (the vector space of complex polynomials of degree at most n) as a nilpotent endomorphism, and $A(z^j) = 0$ for every $j > n$. We note that these operators are in general not of the form $\phi(D)$, where ϕ is an entire function of exponential type (compare to $[2], [3], [7]$); thus they provide a new family of operators acting on $H(\mathbb{C})$ that admit hypercyclic algebras.

We also investigate the case of the complex Fréchet algebras $X = \ell_p(\mathbb{N}), 1 \leq p < +\infty$ or $X = c_0(\mathbb{N})$ endowed with the coordinatewise product: if $x = (x_n)_{n \geq 1}$ and $y = (y_n)_{n \geq 1}$ are two sequences of complex numbers belonging to X, we define $x \cdot y = (x_n y_n)_{n \geq 1}$. Then $||x \cdot y|| \le ||x|| \cdot ||y||$, where $|| \cdot ||$ denotes the classical ℓ_p - or c_0 -norm on X. As X is a Banach space, we place ourselves in the closed balls $\mathcal{B}_M(X)$ of $\mathcal{B}(X)$, $M > 1$, and we prove the following theorem.

Theorem 1.2. Let $X = \ell_p(\mathbb{N})$, $1 \leq p \leq +\infty$, or $X = c_0(\mathbb{N})$, endowed with the coordinatewise product. Let $M > 1$. A typical operator $T \in (\mathcal{B}_M(X), SOT)$ admits a hypercyclic algebra.

The proofs of Theorems 1.1 and 1.2 build on the approach via eigenvectors introduced by Bayart in [2], and further developed by Bayart et al. in [3]. These results show, in two different classical contexts, that having a hypercyclic algebra is a quite common phenomenon, at least from the Baire Category point of view.

However, at this point a word of caution is in order: as explained in [18, Proposition 3.2], hitherto the properties (P) of operators (on $X = \ell_p(\mathbb{N})$ or $c_0(\mathbb{N})$) which have been studied from the typicality perspective are either typical or "atypical" in $(\mathcal{B}_M(X), SOT)$; in other words, for such a property (P), either a typical $T \in (\mathcal{B}_M(X), SOT)$ has (P), or a typical $T \in (\mathcal{B}_M(X), SOT)$ does not possess (P). This relies on the topological $0 - 1$ law (cf. [22, Theorem 8.46], and [18, Proposition 3.2] for its application in our context) and on the fact that for the properties under consideration, T has (P) if and only if JTJ^{-1} has (P) for every surjective isometry J of X. In our setting, this argument fails: having a hypercyclic algebra is not a property which is a priori stable by conjugation by invertible isometries (cf. [3, Remark 4.7], where it is observed that admitting a hypercyclic algebra is not a property which is preserved by similarity).

The paper is organized as follows: Sections 2, 3, 4 and 5 are devoted to the proof of our main result, Theorem 1.1. We introduce in Section 2 our Polish spaces of operators on the algebra of entire functions; then a technical result regarding the density of certain classes of operators in $(\mathcal{L}_{(M_j),(k_j)},$ SOT) is proved in Section 3; in Section 4 we show, using the Godefroy-Shapiro Criterion, that hypercyclic operators form a dense G_{δ} subset of $(\mathcal{L}_{(M_j),(k_j)}$, SOT); finally in Section 5, after recalling the Baire Category Criterion from [3, Corollary 2.4] which we use to prove the existence of a hypercyclic algebra for the operators under consideration, we prove Theorem 1.1. Theorem 1.2 is proved in Section 6. Section 7 contains the additional result that when $X = \ell_p(\mathbb{N}), 1 \leq p < +\infty$, or $X = c_0(\mathbb{N}),$ and $M > 1$, a typical $T \in (\mathcal{B}_M(X), SOT)$ admits a closed infinite-dimensional hypercyclic subspace (Theorem 7.2).

2. Polish Space of operators on the algebra of entire functions.

We present in this section some general facts which will be of use in the sequel. We begin by proving the following proposition for a general separable Fréchet space X .

Proposition 2.1. Let X be a separable Fréchet space, and let $(N_j)_{j\geq 1}$ be a sequence of semi-norms defining its topology. Let $(M_i)_{i\geq 1}$ be a sequence of positive real numbers and let $(k_j)_{j\geq 1}$ be a sequence of positive integers. Then **(A)**

$$
\mathcal{L}_{(M_j),(k_j)}(X) := \{ T \in \mathcal{L}(X) \; ; \; \forall j \geq 1, \; \forall x \in X, \; N_j(Tx) \leq M_j \, N_{k_j}(x) \}
$$

is a Polish space when endowed with the SOT.

Proof. The proof is similar to that of [18, Lemma 3.1]. We recall it here briefly for the sake of completeness. We denote by Z a countable dense subset of X . Then let

$$
\tilde{\mathcal{L}}_{(M_j),(k_j)}(Z) \coloneqq \{T: Z \to X; \ T \text{ is linear and } \forall j \geqslant 1, \forall x \in Z, \ N_j(Tx) \leqslant M_j N_{k_j}(x)\}.
$$

Then $\tilde{\mathcal{L}}_{(M_j),(k_j)}(Z)$ is closed in X^Z , where X^Z is endowed with the product topology. Indeed, since X^Z is metrizable, let $(T_k)_k$ be a sequence of elements of $\tilde{\mathcal{L}}_{(M_j),(k_j)}(Z)$ which converges to T. Since the product topology in X^Z is the pointwise topology, T is necessarily linear; since for all $j \geq 1$, and all $x \in Z$, the sequence $(N_j (T_k x))_k$ converges to $N_j (Tx)$, we also have that $N_j(Tx) \leq M_j N_{k_j}(x)$, and so T belongs to $\tilde{\mathcal{L}}_{(M_j),(k_j)}(Z)$.

Since X^Z is a Polish space, $\tilde{\mathcal{L}}_{(M_j),(k_j)}(Z)$ is a Polish space as a closed subset of a Polish space. Now, we observe that the map $\Phi: (\mathcal{L}_{(M_j),(k_j)}(X), SOT) \to \tilde{\mathcal{L}}_{(M_j),(k_j)}(Z)$ defined by $\Phi(T) = T|_Z$ is a homeomorphism, and we conclude that $(\mathcal{L}_{(M_j),(k_j)}(X), SOT)$ is also a Polish space.

From now on, we will consider the case where $X = H(\mathbb{C})$, the space of entire functions on the complex plane endowed with the topology of uniform convergence on compact sets. We denote by $(z^k)_k$ the monomial basis of $H(\mathbb{C})$ and for $z \in \mathbb{C}$ and $r > 0$, we let $D(z, r)$ be the open disk of center z and radius r . We record here the following property.

Property 2.2. For every $f \in H(\mathbb{C})$ and every $j \geq 1$, we have

$$
\sup_{D(0,j)}|f| \le N_j(f) \le (j+1)\sup_{D(0,j+1)}|f|.
$$

Proof. The lefthand-side inequality is trivial, and the righthand-side inequality follows from Cauchy's inequalities: for all $k \in \mathbb{N}$ and all $r > 0$, we have $\frac{1}{2}$ $\frac{1}{2}$ $\frac{1}{2}$ $\frac{1}{2}$ $\frac{1}{2}$ $\frac{1}{2}$ $\frac{1}{2}$

$$
\frac{1}{k!}\left|\frac{\partial^k f}{\partial z^k}(0)\right|=\frac{1}{2\pi}\left|\int_{|\zeta|=r}\frac{f(\zeta)}{\zeta^{k+1}}d\zeta\right|\leqslant \frac{1}{r^k}\sup_{D(0,r)}|f|.
$$

This implies that

$$
N_j(f) \leq \sum_{k=0}^{+\infty} \left(\frac{j}{j+1}\right)^k \sup_{D(0,j+1)} |f| = (j+1) \sup_{D(0,j+1)} |f|.
$$

Therefore a sequence $(f_n)_n$ of functions in $H(\mathbb{C})$ converges to f in $H(\mathbb{C})$ if and only if the sequence $(N_j (f_n - f))_n$ converges to 0 for every $j \geq 1$; thus the family $(N_j)_j$ indeed induces the topology of $H(\mathbb{C})$.

The next property provides a useful neighborhood basis of an element of $\mathcal{L}_{(M_j),(k_j)}$ for the SOT.

Property 2.3. Let T_0 belong to $\mathcal{L}_{(M_j),(k_j)}$. A neighborhood basis of T_0 for the SOT is given by the family of sets

$$
\mathcal{V}_{\varepsilon,r,K}^{T_0} = \{T \in \mathcal{L}_{(M_j),(k_j)} \, ; \, \forall k = 0,\ldots,K, \, N_r((T-T_0)z^k) < \varepsilon \},
$$

where $\varepsilon > 0$, and K, r are integers with $K \geq 0$ and $r \geq 1$.

Proof. It suffices to show that if $(T_k)_k$ is a sequence of elements of $\mathcal{L}_{(M_j),(k_j)}$ such that, for all $\varepsilon > 0$, all $K \geq 0$ and all $r \geq 1$, there exists $\kappa_0 \in \mathbb{N}$ such that for all $k \geq \kappa_0$, T_k belongs to $\mathcal{V}_{\varepsilon,r,K}^0$, then $(T_k)_k$ converges SOT to 0.

Let f be an entire function and let $j \geq 1$ be a positive integer. There exists an analytic nonzero polynomial P such that $N_{k_j}(f - P) < \frac{\varepsilon}{2M_j}$. Denote by d the degree of P, write P as $P(z) = \sum_{l=0}^{d} p_l z^l$, and set $\varepsilon' = \frac{\varepsilon}{2 \sum_{l=0}^{d} p_l}$ $\frac{\varepsilon}{2\sum_{l=0}^{d} |p_l|}$. By assumption, there exists $\kappa_0 \in \mathbb{N}$ such that for all $k \geq \kappa_0$, T_k belongs to $\mathcal{V}^0_{\varepsilon', d,j}$. Therefore we have

$$
N_j(T_k f) \le N_j(T_k(f - P)) + N_j(T_k P) \le M_j N_{k_j}(f - P) + \sum_{l=0}^d |p_l| N_j(T_k z^l)
$$

$$
\le M_j \frac{\varepsilon}{2M_j} + \varepsilon' \sum_{l=0}^d |p_l| = \varepsilon.
$$

This implies that the sequence $(T_kf)_k$ converges to 0 uniformly on any compact subset of \mathbb{C} , and thus $(T_k)_k$ converges SOT to 0.

In the forthcoming proof of Theorem 1.1, the operators $S_n := \frac{1}{n!} D^n$, $n \ge 1$, will play a crucial role. It is thus important to be able to demonstrate that they belong to the space $\mathcal{L}_{(M_j),(k_j)}$. In the next proposition, we provide conditions on the sequences $(M_j)_{j\geqslant1}$ and $(k_j)_{j\geqslant1}$ which ensure that this is indeed the case.

Proposition 2.4. Let $(M_j)_{j\geqslant1}$ be a sequence of positive real numbers and let $(k_j)_{j\geqslant1}$ be a sequence of positive integers such that for every $j \geq 1$, $M_j \geq j + 1$ and $k_j \geq j + 2$. Then S_n belongs to $\mathcal{L}_{(M_j),(k_j)}$ for every $n \geq 1$.

Proof. Let $n \geq 1$, $j \geq 1$, and let $z \in D(0, j + 1)$. By Cauchy's formula, we have:

$$
\frac{1}{n!} \frac{\partial^n f}{\partial z^n}(z) = \frac{1}{2i\pi} \int_{|\zeta - z| = 1} \frac{f(\zeta)}{(\zeta - z)^{n+1}} d\zeta
$$

so that $|S_n(f)(z)| \leq \sup_{D(0,j+2)} |f|$. We then deduce from Property 2.2 that

$$
N_j(S_nf) \le (j+1) \sup_{D(0,j+1)} |S_n(f)| \le (j+1) \sup_{D(0,j+2)} |f| \le (j+1)N_{j+2}(f),
$$

and this proves that S_n belongs to $\mathcal{L}_{(M_i),(k_i)}$ when $(M_i)_{i\geq 1}$ and $(k_i)_{i\geq 1}$ satisfy the assumptions of this proposition.

3. DENSE FAMILIES OF OPERATORS IN $\mathcal{L}_{(M_i),(k_i)}$

For every $n \geq 0$, we define the operator $T_n: H(\mathbb{C}) \to H(\mathbb{C})$ by setting

$$
T_n f(z) = \sum_{j=0}^n \frac{1}{j!} \frac{\partial^j f}{\partial z^j} (0) z^j, \text{ where } f \in H(\mathbb{C})
$$

and we note that for all $j \geq 1$, $N_i(T_nf) \leq N_i(f)$.

Given $A \in \mathcal{L}_{(M_j),(k_j)}$, our aim is to approximate A with an operator supporting a hypercyclic algebra. We first approximate A by an operator of the form $B_n = T_n A T_n$. When *n* goes to infinity, $(B_n)_n$ converges SOT to A, and for all $n \geq 1$, B_n belongs to $\mathcal{L}_{(M_j),(k_j)}$. Indeed, we have for every $f \in H(\mathbb{C})$ and every $n, j \geq 1$ that

$$
N_j(B_nf) \leq N_j(AT_nf) \leq M_j N_{k_j}(T_nf) \leq M_j N_{k_j}(f).
$$

When $M_j \ge j + 1$ and $k_j \ge j + 2$ for all $j \ge 1$, it follows from Proposition 2.4 that S_{n+1} belongs to $\mathcal{L}_{(M_j),(k_j)}$ for every $n \geq 0$. Hence, for every $\delta \in [0,1]$, the operator $(1-\delta)B_n + \delta S_{n+1}$ also belongs to $\mathcal{L}_{(M_j),(k_j)}$. Moreover, $((1-\delta)B_n + \delta S_{n+1})_{\delta \in (0,1)}$ SOT converges to B_n as δ goes to 0. Thus we have proved the following.

Proposition 3.1. Let $(M_j)_{j\geqslant1}$ be a sequence of positive real numbers, and let $(k_j)_{j\geqslant1}$ be a sequence of positive integers such that $M_j \geq j + 1$ and $k_j \geq j + 2$ for every $j \geq 1$. Then the following holds: for every $A \in \mathcal{L}_{(M_i),(k_i)}$ and every SOT-neighborhood V of A, there exist $n \geq 0$, an operator $B \in \mathcal{L}_{(M_j),(k_j)}$ satisfying $B = T_n BT_n$, and $\delta \in (0,1)$ such that $B + \delta S_{n+1}$ belongs to $\mathcal V$.

We will prove in Section 4 below that operators of the form $B + \delta S_{n+1}$ are hypercyclic, where $\delta > 0$, $n \geq 0$ and B is such that $B = T_n BT_n$. So the reader mainly interested in the density of hypercyclic operators in $\mathcal{L}_{(M_i),(k_i)}$ can proceed directly to Section 4.

On the other hand, it does not seem to be trivial that an operator of the form $B + \delta S_{n+1}$ with $\delta \in (0, 1), n \geq 0$ and B such that $B = T_n BT_n$ supports a hypercyclic algebra. What we will be able to prove in Section 5 is that if for every polynomial P , the sequence $(B^{j}P)_{j}$ converges to 0 in $H(\mathbb{C})$, then $B + \delta S_{n+1}$ indeed supports a hypercyclic algebra (cf. Theorem 5.1). With this result in view, we now show that the family of nilpotent operators B satisfying $B = T_n BT_n$ for some $n \geq 0$ is SOT dense in $\mathcal{L}_{(M_i),(k_i)}$ provided that the sequences $(M_j)_j$ and $(k_j)_j$ satisfy some suitable assumptions, which in fact ensure that $\mathcal{L}_{(M_i),(k_i)}$ contains sufficiently many operators.

Proposition 3.2. Let $(M_j)_{j\geqslant1}$ be a sequence of positive real numbers, and let $(k_j)_{j\geqslant1}$ be a sequence of positive integers such that

- (i) for all $\alpha \geqslant 1$, $j^{\alpha} = o(M_j)$ as j tends to infinity;
- (ii) $k_j > j$ for every $j \geq 1$;
- (iii) $M_1 < k_1$ and $k_j \geq k_1$ for every $j \geq 1$.

Let A be an operator belonging to $\mathcal{L}_{(M_i),(k_i)}$ and let V be an SOT-neighborhood of A in $\mathcal{L}_{(M_j),(k_j)}$. Then there exist $B \in \mathcal{V}$ and $n \geq 1$ such that $B = T_n BT_n$ (in particular, for all $f \in H(\mathbb{C})$, Bf is a polynomial of degree at most n) and $B^{n+1} = 0$.

Remark 3.3. Conditions (i) and (ii) of Proposition 3.2 ensure that $\mathcal{L}_{(M_i),(k_i)}$ contains sufficiently many operators. For example, for every $n \geq 0$ and every $a \in \mathbb{C}$ close enough to 0 (how close depends on n), the operator B_n defined by $B_n f = az^n f$, $f \in H(\mathbb{C})$, belongs to $\mathcal{L}_{(M_j),(k_j)}$. Indeed, for every $j \geq 1$ and every $i \geq 1$ we have

$$
N_j(B_n z^i) = N_j(az^{i+n}) = |a|j^{i+n}.
$$

Thus B_n belongs to $\mathcal{L}_{(M_j),(k_j)}$ if and only if $|a|j^{i+n} \leqslant M_j k_j^i$ for every $j \geqslant 1$. Condition (ii) ensures in particular that $j \leq k_j$, so that $N_j(B_n z^i) \leq |a|j^nk_j^i$ for every $i, j \geq 1$. Condition (i) ensures the existence of $j_0 \geq 1$ such that $j^n \leq M_j$ for every $j \geq j_0$; if $|a| \leq 1$, $N_j(B_n z^i) \leq M_j k_j^i$ for every $i \geq 1$ and every $j \geq j_0$. Now, if |a| is small enough, depending on *n*, we can ensure that $|a|j^n \leq M_j$ for every $1 \leq j \leq j_0$ and thus $N_j(B_n z^i) \leq M_j k_j^i$ for every $i \geq 1$ and every $j \leq j_0$. Hence B_n belongs to $\mathcal{L}_{(M_j),(k_j)}$.

Condition (iii) is a technical condition which will be needed in the proof of Proposition 3.2. It does not appear to be overly restrictive.

Remark 3.4. In the Hilbertian setting, it is known that nilpotent contractions on a complex separable Hilbert space H are SOT^* -dense in $\mathcal{B}_1(H)$, so in particular SOT-dense $([16, Proposition 4.6])$. It seems to be unknown whether this result can be extended to ℓ_p -spaces, $1 < p < +\infty$, $p \neq 2$.

The rest of this section is devoted to the proof of Proposition 3.2.

Proof of Proposition 3.2. Without loss of generality (cf. Property 2.3), we assume that V has the form

$$
\mathcal{V} = \mathcal{V}^A_{\varepsilon_0, r, K} = \{ B \in \mathcal{L}_{(M_j),(k_j)}; \ N_r(Bz^j - Az^j) < \varepsilon_0, \ j = 0, \dots, K \},
$$

where $\varepsilon_0 > 0$, and $r, K \geq 1$ are fixed.

Let $n_0 \geq K$ be a sufficiently large integer and $\delta \in (0, 1)$ a sufficiently small positive number. We set

$$
A_0 = (1 - \delta) T_{n_0} A T_{n_0}
$$

.

If n_0 is sufficiently large and δ is sufficiently small, then A_0 belongs to V. We now fix the parameters $n_0 \ge K$ and $\delta \in (0, 1)$. We then consider an operator B defined as follows:

$$
Bz^{j} = \begin{cases} A_{0}z^{j} + \varepsilon z^{n_{0}+1+j}, & 0 \leq j \leq n_{0} \\ \varepsilon z^{n_{0}+1+j}, & n_{0}+1 \leq j \leq (n_{0}+1)(n_{1}+1)-1 \\ z^{n_{0}+1+j}, & (n_{0}+1)(n_{1}+1) \leq j \leq (n_{0}+1)n_{2}-1 \\ D_{n_{0},n_{1},n_{2}}(z^{j}), & (n_{0}+1)n_{2} \leq j \leq (n_{0}+1)(n_{2}+1)-1 \\ 0, & j \geq (n_{0}+1)(n_{2}+1) \end{cases}
$$

where

$$
D_{n_0,n_1,n_2}(z^j) := -\sum_{m=0}^{n_1} \frac{1}{\varepsilon^{n_1-m+1}} z^{(n_0+1)m} A_0^{n_2+1-m} z^{j-n_2(n_0+1)} - \sum_{m=n_1+1}^{n_2} z^{(n_0+1)m} A_0^{n_2+1-m} z^{j-n_2(n_0+1)}
$$

and where $n_1, n_2 \geq 1$, $\varepsilon > 0$ have to be determined in order to ensure that B belongs to $\mathcal{L}_{(M_j),(k_j)}$. Our first goal is to show that with this definition, B is nilpotent – more precisely that $B^{n_2+1} = 0$.

Fact 3.5. For every $P \in \mathbb{C}_{n_0}[z]$ and every $1 \leq n \leq n_2$, we have

(3.1)
$$
B^{n}P = \sum_{k=0}^{\min(n,n_{1})} \varepsilon^{k} z^{k(n_{0}+1)} A_{0}^{n-k} P + \varepsilon^{n_{1}+1} \sum_{k=n_{1}+1}^{n} z^{k(n_{0}+1)} A_{0}^{n-k} P.
$$

Proof. Equality (3.1) is true for $n = 1$, since by definition $BP = A_0P + \varepsilon z^{n_0+1}P$. If we assume that (3.1) is true for some $n \geq 1$, then, for every $1 \leq k \leq n_1$, $z^{k(n_0+1)}A_0^{n-k}P$ is a sum of monomials whose degrees lie between $k(n_0 + 1)$ and $(k + 1)(n_0 + 1) - 1$; since $k(n_0 + 1) \geq n_0 + 1$ and $(k + 1)(n_0 + 1) - 1 \leq (n_1 + 1)(n_0 + 1) - 1$, it follows that

$$
B(z^{k(n_0+1)}A_0^{n-k}P) = \varepsilon z^{(k+1)(n_0+1)}A_0^{n-k}P
$$
 for $1 \le k \le n_1$.

Analogously, for $n_1 + 1 \le k \le n_2 - 1$, $z^{k(n_0+1)} A_0^{n-k} P$ is a sum of monomials whose degrees lie between $k(n_0 + 1)$ and $(k + 1)(n_0 + 1) - 1$, with $k(n_0 + 1) \ge (n_1 + 1)(n_0 + 1)$ and $(k + 1)(n₀ + 1) \le n₂(n₀ + 1) - 1$. Thus

$$
B(z^{k(n_0+1)}A_0^{n-k}P) = z^{(k+1)(n_0+1)}A_0^{n-k}P \quad \text{ for every } n_1 \le k \le n_2 - 1.
$$

We now consider separately two cases.

Case 1: If $n < n_1$, we have

$$
B^{n+1}P = BA_0^n P + \sum_{k=1}^n \varepsilon^k B\left(z^{k(n_0+1)}A_0^{n-k}P\right)
$$

= $A_0^{n+1}P + \varepsilon z^{n_0+1}A_0^n P + \sum_{k=1}^n \varepsilon^{k+1}z^{(k+1)(n_0+1)}A_0^{n-k}P$
= $A_0^{n+1}P + \varepsilon z^{n_0+1}A_0^n P + \sum_{k=2}^{n+1} \varepsilon^k z^{k(n_0+1)}A_0^{n+1-k}P$
= $\sum_{k=0}^{\min(n+1,n_1)} \varepsilon^k z^{k(n_0+1)}A_0^{n+1-k}P.$

Hence (3.1) still holds true at rank $n + 1$ when $n < n_1$.

Case 2: If $n_1 \leq n \leq n_2$, we have

$$
B^{n+1}P = BA_0^n P + \sum_{k=1}^{n_1} \varepsilon^k B\left(z^{k(n_0+1)}A_0^{n-k}P\right) + \varepsilon^{n_1+1} \sum_{k=n_1+1}^n B\left(z^{k(n_0+1)}A_0^{n-k}P\right)
$$

= $A_0^{n+1}P + \varepsilon z^{n_0+1}A_0^n P + \sum_{k=1}^{n_1} \varepsilon^{k+1} z^{(k+1)(n_0+1)}A_0^{n-k}P$
+ $\varepsilon^{n_1+1} \sum_{k=n_1+1}^n z^{(k+1)(n_0+1)}A_0^{n-k}P.$

This gives that

$$
B^{n+1}P = A_0^{n+1}P + \varepsilon z^{n_0+1}A_0^nP + \sum_{k=2}^{n_1+1} \varepsilon^k z^{k(n_0+1)}A_0^{n+1-k}P
$$

+ $\varepsilon^{n_1+1} \sum_{k=n_1+2}^{n+1} z^{k(n_0+1)}A_0^{n+1-k}P$
= $A_0^{n+1}P + \varepsilon z^{n_0+1}A_0^nP + \sum_{k=2}^{n_1} \varepsilon^k z^{k(n_0+1)}A_0^{n+1-k}P$
+ $\varepsilon^{n_1+1} \sum_{k=n_1+1}^{n+1} z^{k(n_0+1)}A_0^{n+1-k}P$.

Hence (3.1) is still true at rank $n + 1$ in this second case where $n_2 > n \geq n_1$, which ends the proof of Fact 3.5.

Fact 3.6. For every $P \in \mathbb{C}_{n_0}[z]$, we have $B^{n_2+1}P = 0$.

Proof. Fact 3.5 applied to $n = n_2$ yields that

$$
B^{n_2+1}P = B\left(\sum_{k=0}^{n_1} \varepsilon^k z^{k(n_0+1)} A_0^{n_2-k} P + \varepsilon^{n_1+1} \sum_{k=n_1+1}^{n_2} z^{k(n_0+1)} A_0^{n_2-k} P\right)
$$

= $A_0^{n_2+1}P + \varepsilon z^{n_0+1} A_0^{n_2} P + \sum_{k=1}^{n_1} \varepsilon^{k+1} z^{(k+1)(n_0+1)} A_0^{n_2-k} P$
+ $\varepsilon^{n_1+1} \sum_{k=n_1+1}^{n_2-1} z^{(k+1)(n_0+1)} A_0^{n_2-k} P - \varepsilon^{n_1+1} \sum_{m=0}^{n_1} \frac{1}{\varepsilon^{n_1-m+1}} z^{m(n_0+1)} A_0^{n_2+1-m} P$
- $\varepsilon^{n_1+1} \sum_{m=n_1+1}^{n_2} z^{m(n_0+1)} A_0^{n_2+1-m} P$.

Writing the sum

$$
\varepsilon^{n_1+1} \sum_{m=0}^{n_1} \frac{1}{\varepsilon^{n_1-m+1}} z^{m(n_0+1)} A_0^{n_2+1-m} P
$$

as

$$
A_0^{n_2+1}P + \sum_{m=0}^{n_1-1} \varepsilon^{m+1} z^{(m+1)(n_0+1)} A_0^{n_2-m} P,
$$

and the sum

$$
\varepsilon^{n_1+1}\sum_{m=n_1+1}^{n_2}z^{m(n_0+1)}A_0^{n_2+1-m}P
$$

as

$$
\varepsilon^{n_1+1} z^{(n_1+1)(n_0+1)} A_0^{n_2-n_1} P + \varepsilon^{n_1+1} \sum_{m=n_1+1}^{n_2-1} z^{(m+1)(n_0+1)} A_0^{n_2-m} P,
$$

we obtain that $B^{n_2+1}P = 0$, which proves Fact 3.6.

We are now ready to prove the next fact.

Fact 3.7. We have $B^{n_2+1} = 0$.

Proof. Let us first check that the family $(1, \ldots, z^{n_0}, B_1, \ldots, Bz^{n_0}, \ldots, B^{n_2}1, \ldots, B^{n_2}z^{n_0})$ *Proof.* Let us first check that the family $(1, \ldots, z^{n_0})$
is a basis of $\mathbb{C}_{(n_0+1)(n_2+1)-1}[z]$. Suppose that $\sum_{k=0}^{n_2}$ $\frac{1}{\nabla^{n_0}}$ $j=0 \lambda_{k,j} B^k z^j = 0$ for some complex is a basis of $\mathcal{L}_{(n_0+1)(n_2+1)-1}[z]$. Suppose that $\sum_{k=0}^{\infty} \sum_{j=0}^{\infty} \lambda_{k,j} D^{n} z^j = 0$ for some complex
numbers $\lambda_{k,j}$. Applying B^{n_2} to this equality, we obtain by Fact 3.6 that $\sum_{j=0}^{n_0} \lambda_{0,j} B^{n_2} z$ į,

0. Fact 3.5 then implies that
\n(3.2)
$$
\sum_{j=0}^{n_0} \lambda_{0,j} \left(\sum_{k=0}^{n_1} \varepsilon^k z^{k(n_0+1)} A_0^{n_2-k} z^j + \varepsilon^{n_1+1} \sum_{k=n_1+1}^{n_2} z^{k(n_0+1)} A_0^{n_2-k} z^j \right) = 0
$$

so that the two polynomials

$$
\sum_{j=0}^{n_0} \lambda_{0,j} \left(\sum_{k=0}^{n_1} \varepsilon^k z^{k(n_0+1)} A_0^{n_2-k} z^j + \varepsilon^{n_1+1} \sum_{k=n_1+1}^{n_2-1} z^{k(n_0+1)} A_0^{n_2-k} z^j \right)
$$

and

$$
-\varepsilon^{n_1+1}\sum_{j=0}^{n_0}\lambda_{0,j}z^{n_2(n_0+1)}z^j
$$

are equal. For $0 \le k \le n_2 - 1$ and $0 \le j \le n_0$, the degree of $z^{k(n_0+1)}A_0^{n_2-k}z^j$ is less than $n_2(n_0+1)-1$ while the degree of $z^{n_2(n_0+1)+j}$ is strictly greater than $n_2(n_0+1)-1$. It $n_2(n_0+1) - 1$ while the degree of $z^{n_2(n_0+1)+j}$ is strictly greater that follows that $\sum_{j=0}^{n_0} \lambda_{0,j} z^{n_2(n_0+1)+j} = 0$, and so that $\lambda_{0,0} = \cdots = \lambda_{0,n_0}$.

Suppose now that $\lambda_{0,0} = \cdots = \lambda_{0,n_0} = \cdots = \lambda_{l,0} = \cdots = \lambda_{l,n_0}$ for some $0 \leq l < n_2$. We Suppose now the
know that $\sum_{k=l+1}^{n_2}$ at λ
 ∇^{n_0} $j=0 \lambda_{k,j} B^k z^j = 0$, and we apply $B^{n_2-(l+1)}$ to this equality. We then obtain as previously that $\lambda_{l+1,0} = \cdots = \lambda_{l+1,n_0}$. By induction, $\lambda_{j,k} = 0$ for all j and k, and $(1, \ldots, z^{n_0}, B_1, \ldots, B_z^{n_0}, \ldots, B^{n_2}1, \ldots, B^{n_2}z^{n_0})$ is indeed a basis of $\mathbb{C}_{(n_0+1)(n_2+1)-1}[z]$.

Now, writing any polynomial $P \in \mathbb{C}_{(n_0+1)(n_2+1)-1}[z]$ as $P = \sum_{k=1}^{n_2}$ $k=0$ $\frac{n_0+1}{\nabla^n}$ $_{j=0}^{n_0}$ $\mu_{k,j}B^k z^j$, we obtain $B^{n_2+1}P = 0$. This proves Fact 3.7.

The last step in our proof of Proposition 3.2 is the following Fact 3.8, which shows that the operator B belongs to V for suitably chosen n_1 , n_2 and $\varepsilon > 0$.

Fact 3.8. There exist integers n_1 and n_2 large enough and $\varepsilon > 0$ small enough such that the operator B belongs to V .

Proof. Since $n_0 \geq K$, we have $Bz^j = A_0z^j + \varepsilon z^j$ for every $j = 0, ..., K$, and thus $N_r(Bz^j - Az^j) \le N_r(Bz^j - A_0z^j) + N_r(A_0z^j - Az^j)$ $\leq \varepsilon r^j + N_r(A_0 z^j - A z^j).$

Since A_0 belongs to V, we have $N_r(A_0z^j - Az^j) < \varepsilon_0$ for every $j = 0, \ldots, K$. One can choose $\varepsilon > 0$ small enough, so as to ensure that $N_r(Bz^j - Az^j) < \varepsilon_0$ also holds for every $j = 0, \ldots, K$. Therefore, to demonstrate that B belongs to V, the main problem is to show that B belongs to $\mathcal{L}_{(M_j),(k_j)}$ for suitable choices of the integers n_1 and n_2 (which will have to be large) and of the real number $\varepsilon > 0$ (which must be sufficiently small).

Since $\frac{M_j}{j^{n_0+1}} \to +\infty$ as $j \to +\infty$, there exists an integer $j_0 \in \mathbb{N}$ such that $j^{n_0+1} \leq M_j$ for all $j \geqslant j_0$, and provided that j_0 is large enough, we also have $M_1 k_1^{n_0} \frac{1}{i n_0}$ $\frac{1}{j_0^{n_0+1}} < 1$. Once j_0 is fixed, we choose n_1 , n_2 and ε as follows:

(i) Since $k_j > j$ for all j, we can first choose an integer n_1 sufficiently large, so that

$$
j_0^{n_0+1} \left(\frac{j}{k_j}\right)^{(n_1+1)(n_0+1)} \leq M_j \quad \text{for every } 1 \leq j \leq j_0.
$$

(ii) We next choose $\varepsilon > 0$ satisfying the following two properties:

$$
0 < \varepsilon \leq \delta \quad \text{and} \quad \varepsilon j_0^{2n_0+1} \leq \delta \min_{1 \leq j < j_0} M_j.
$$

(iii) Let
$$
c_0 := \sum_{m=0}^{+\infty} \left(M_1 k_1^{n_0} \frac{1}{j_0^{n_0+1}} \right)^m < +\infty
$$
. We choose an integer $j_1 > j_0$ such that
$$
c_0 \frac{1}{\varepsilon^{n_1+1}} M_1 k_1^{n_0} \frac{1}{j_1} < 1.
$$

- (iv) Lastly, using again the assumption that $k_j > j$ for all $j \geq 1$ and that $M_1 < k_1$, we choose an integer n_2 sufficiently large, such that ι_2

For these choices of the parameters n_1 , n_2 and $\varepsilon > 0$, we will prove that $N_i (Bz^m) \leq$ $M_j k_j^m$ for every integer m with $0 \le m \le (n_2 + 1)(n_0 + 1) - 1$ and every $j \ge 1$. Since $Bz^{\tilde{m}} = 0$ for all $m \geqslant (n_2 + 1)(n_0 + 1)$, this will imply that B belongs to $\mathcal{L}_{(M_j),(k_j)}$.

We fix $j \geq 1$, and separate the proof into four cases.

Case 1: $1 \leq m \leq n_0$.

We have $Bz^m = A_0 z^m + \varepsilon z^{n_0+1+m}$ so $N_j(Bz^m) \le N_j(A_0 z^m) + \varepsilon N_j(z^{n_0+1+m})$. Notice that

$$
N_j(A_0 z^m) = (1 - \delta) N_j(T_{n_0} A T_{n_0} z^m) \le (1 - \delta) N_j(A z^m) \le (1 - \delta) M_j k_j^m
$$

from which we deduce that

$$
N_j(Bz^m) \le (1 - \delta)M_j k_j^m + \varepsilon j^{n_0 + 1 + m}.
$$

If $j \geq j_0$, then $j^{n_0+1} \leq M_j$ so $N_j(Bz^m) \leq (1-\delta+\varepsilon)M_jk_j^m$ and since $\delta \geq \varepsilon$, we get $N_j(Bz^m) \leqslant M_j k_j^m$. j

If $1 \leqslant j \leqslant j_0$, $N_j (Bz^m) \leqslant (1-\delta) M_j k_j^m + \varepsilon j_0^{2n_0+1}$ and by (ii) we also have that $N_j(Bz^m) \leqslant M_j k_j^m$.

Case 2: $(n_1 + 1)(n_0 + 1) \leq m \leq n_2(n_0 + 1) - 1$. In this case we have $Bz^m = z^{m+n_0+1}$ so $N_j(Bz^m) = j^{m+n_0+1}$. If $j \geq j_0$, we have $j^{n_0+1} \leq M_j$ and $k_j > j$, so $N_j(Bz^m) \leq M_j k_j^m$. If $1 \leq j < j_0$,

$$
N_j(Bz^m) = j^{n_0+1} \left(\frac{j}{k_j}\right)^m k_j^m \leq j_0^{n_0+1} \left(\frac{j}{k_j}\right)^{(n_1+1)(n_0+1)} k_j^m \leq M_j k_j^m
$$

where the last inequality follows from (i).

Case 3: $(n_0 + 1) \le m \le (n_1 + 1)(n_0 + 1) - 1$.

For these values of m we have $Bz^m = \varepsilon z^{m+n_0+1}$ so $N_j (Bz^m) = \varepsilon j^{m+n_0+1}$. If $j \geq j_0$, we have $j^{n_0+1} \leqslant M_j$, $k_j > j$ and $\varepsilon < 1$, so $N_j (B z^m) \leqslant M_j k_j^m$. If $1 \leq j < j_0$,

$$
N_j(Bz^m)\leqslant \varepsilon j_0^{n_0+1}j^m\leqslant M_jk_j^m
$$

where the last inequality follows from (ii) and from the fact that $j < k_j$.

Case 4: $n_2(n_0 + 1) \leq m \leq (n_2 + 1)(n_0 + 1) - 1$.

We write m as $m = n_2(n_0 + 1) + l$ with $0 \le l \le n_0$. In this case we have that

$$
Bz^{m} = -\sum_{i=0}^{n_1} \frac{1}{\varepsilon^{n_1-i+1}} z^{(n_0+1)i} A_0^{n_2-i+1} z^l - \sum_{i=n_1+1}^{n_2} z^{(n_0+1)i} A_0^{n_2-i+1} z^l
$$

and since $0 < \varepsilon < 1$, it follows that

$$
N_j(Bz^m) \leq \frac{1}{\varepsilon^{n_1+1}} \sum_{i=0}^{n_2} N_j \left(z^{(n_0+1)i} A_0^{n_2-i+1} z^l \right) = \frac{1}{\varepsilon^{n_1+1}} \sum_{i=0}^{n_2} j^{(n_0+1)i} N_j \left(A_0^{n_2-i+1} z^l \right).
$$

Next we will estimate the norms of the iterates of A_0 . The main difficulty with this estimate comes from the fact that given a polynomial P, the quantity $N_j(A_0P)$ can be controlled by $N_{k_j}(P)$ only, and not by $N_j(P)$.

We remark that if P is a polynomial of degree at most d, we have $N_j(P) \leq j^d N_1(P)$. Thus for any polynomial P of degree at most n_0 , we have $N_1(A_0P) \leq M_1k_1^{n_0}N_1(P)$. It follows that

(3.3)
$$
N_1(A_0^n P) \le (M_1 k_1^{n_0})^n N_1(P)
$$
 for every $n \ge 0$.

– We consider first the case where $j \geq j_0$. For every $0 \leq i \leq n_2$ and every $0 \leq l' \leq n_0$, (3.3) gives

$$
N_j\left(A_0^{n_2-i+1}z^{l'}\right) \leq j^{n_0}N_1\left(A_0^{n_2-i+1}z^{l'}\right) \leq j^{n_0}\left(M_1k_1^{n_0}\right)^{n_2-i+1}.
$$

It then follows that

$$
N_j(Bz^m) \leq \frac{1}{\varepsilon^{n_1+1}} \sum_{i=0}^{n_2} j^{(n_0+1)i} j^{n_0} (M_1 k_1^{n_0})^{n_2-i+1}
$$

=
$$
\frac{j^{(n_0+1)(n_2+1)+n_0}}{\varepsilon^{n_1+1}} \sum_{i=0}^{n_2} \left(M_1 k_1^{n_0} \frac{1}{j^{n_0+1}} \right)^{n_2-i+1}
$$

.

By the definition of c_0 given in (iii), we get

$$
N_j\left(Bz^m\right) \leqslant \frac{j^{(n_0+1)(n_2+1)+n_0}}{\varepsilon^{n_1+1}} c_0 M_1 k_1^{n_0} \frac{1}{j^{n_0+1}}.
$$

Since $k_j \geq 1$ and $m \geq n_2(n_0 + 1)$ it follows that

$$
N_j\left(Bz^m\right) \leq M_j k_j^m c_0 \frac{1}{\varepsilon^{n_1+1}} M_1 k_1^{n_0} \left(\frac{j}{k_j}\right)^{n_2(n_0+1)} \frac{j^{n_0}}{M_j},
$$

and using the fact that $M_j \geq j^{n_0+1}$ (because $j \geq j_0$), it follows that

$$
N_j(Bz^m) \leq M_j k_j^m c_0 \frac{1}{\varepsilon^{n_1+1}} M_1 k_1^{n_0} \left(\frac{j}{k_j}\right)^{n_2(n_0+1)} \frac{1}{j}.
$$

If $j \geq j_1$, using that $\frac{j}{k_j} \leq 1$ as well as property (iii), we get that $N_j (B z^m) \leq M_j k_j^m$. If $j_0 \leq j < j_1$, (iv)-(a) gives the inequality $N_j (Bz^m) \leq M_j k_j^m$.

– It now remains to consider the integers j such that $1 \leq j \leq j_0$. For all polynomials P of degree at most n_0 we have

$$
N_j(A_0P) \le (1 - \delta)M_j N_{k_j}(P) \le (1 - \delta)M_j k_j^{n_0} N_1(P),
$$

from which it follows that

$$
N_j(Bz^m) \leq \frac{1}{\varepsilon^{n_1+1}} \sum_{i=0}^{n_2} j^{(n_0+1)i} N_j \left(A_0^{n_2-i+1} z^l \right)
$$

$$
\leq \frac{1}{\varepsilon^{n_1+1}} \sum_{i=0}^{n_2} j^{(n_0+1)i} (1-\delta) M_j k_j^{n_0} N_1 \left(A_0^{n_2-i} z^l \right).
$$

We use (3.3) in order to get N_1 $A_0^{n_2-i}z^l$ $\leqslant (M_1k_1^{n_0})^{n_2-i}$ and

$$
N_j(Bz^m) \leq \frac{1}{\varepsilon^{n_1+1}} M_j k_j^{n_0} \sum_{i=0}^{n_2} j^{(n_0+1)i} (M_1 k_1^{n_0})^{n_2-i}
$$

=
$$
\frac{1}{\varepsilon^{n_1+1}} M_j k_j^{n_0} j^{n_2(n_0+1)} \sum_{i=0}^{n_2} \left(M_1 k_1^{n_0} \frac{1}{j^{n_0+1}} \right)^{n_2-i}.
$$

If $M_1 k_1^{n_0} \frac{1}{i^{n_0}}$ $\frac{1}{j^{n_0+1}} \leq 1$, we obtain

$$
N_j(Bz^m) \leq \frac{1}{\varepsilon^{n_1+1}} M_j k_j^{n_0} j^{n_2(n_0+1)}(n_2+1) = M_j k_j^m \frac{n_2+1}{\varepsilon^{n_1+1}} \frac{j^{n_2(n_0+1)}}{k_j^{n_2(n_0+1)+l-n_0}}
$$

$$
\leq M_j k_j^m \frac{n_2+1}{\varepsilon^{n_1+1}} \left(\frac{j}{k_j}\right)^{n_2(n_0+1)} \left(\max_{1 \leq i \leq j_0} k_i\right)^{n_0}.
$$

Then condition (iv)-(b) implies that $N_j(Bz^m) \leq M_j k_j^m$.

In the case where $M_1 k_1^{n_0} \frac{1}{i^{n_0}}$ $\frac{1}{j^{n_0+1}} \geqslant 1$, we have

$$
N_j(Bz^m) \leq \frac{1}{\varepsilon^{n_1+1}} M_j k_j^{n_0} j^{n_2(n_0+1)}(n_2+1) \left(M_1 k_1^{n_0} \frac{1}{j^{n_0+1}}\right)^{n_2}
$$

= $M_j k_j^m \frac{n_2+1}{\varepsilon^{n_1+1}} k_1^{n_0-l} \left(\frac{M_1}{k_1}\right)^{n_2} \frac{k_1^{n_2(n_0+1)+l-n_0}}{k_j^{n_2(n_0+1)+l-n_0}}$
 $\leq M_j k_j^m \frac{n_2+1}{\varepsilon^{n_1+1}} \left(\frac{M_1}{k_1}\right)^{n_2} k_1^{n_0-l}$

where the last inequality comes from the fact that $k_j \geq k_1$. Now (iv)-(c) gives that $N_j(Bz^m) \leqslant M_j k_j^m$. This shows for every $j \geqslant 1$ and every $m \geqslant 0$ that $N_j(Bz^m) \leqslant M_j k_j^m$, and Fact 3.8 is thus proved.

Combining Facts 3.7 and 3.8 concludes the proof of Proposition 3.2.

What we actually need in the proof of Theorem 1.1 is that operators of the form $B + \delta S_{n+1}$ are dense in $\mathcal{L}_{(M_j),(k_j)}$, for $\delta \in (0,1)$ and $B \in \mathcal{L}_{(M_j),(k_j)}$ nilpotent such that $B = T_n BT_n$. The following corollary shows that this is an easy consequence of Proposition 3.2.

Corollary 3.9. Let $(M_j)_{j\geq1}$ be a sequence of positive real numbers, and let $(k_j)_{j\geq1}$ be a sequence of positive integers such that

- (i) for all $\alpha \geqslant 1$, $j^{\alpha} = o(M_j)$ as j tends to infinity;
- (ii) $k_j > j$ for every $j \geq 1$;
- (iii) $M_1 < k_1$ and $k_j \geq k_1$ for every $j \geq 1$.

Let A be an operator belonging to $\mathcal{L}_{(M_i),(k_i)}$ and let V be an SOT-neighborhood of A in $\mathcal{L}_{(M_j),(k_j)}$. Then there exist $B \in \mathcal{L}_{(M_j),(k_j)}$, $\delta \in (0,1)$ and $n \geq 1$ such that $B = T_n BT_n$, $B^{n+1} = 0$ and $B + \delta S_{n+1}$ belongs to V.

Proof. We denote by $B' \in V$ a nilpotent operator with $B' = T_n B' T_n$ for some integer $n \geq 1$, given by Proposition 3.2. If $\delta \in (0, 1)$ is sufficiently small, $(1 - \delta)B' + \delta S_{n+1}$ belongs to $V, B = (1 - \delta)B'$ belongs to $\mathcal{L}_{(M_i),(k_i)}$ and it satisfies $B = T_nBT_n$ and $B^{n+1} = 0$.

4. Density of hypercyclic operators

Our aim in this section is to prove the following theorem.

Theorem 4.1. Let $(M_j)_{j\geq 1}$ be a sequence of positive real numbers, and let $(k_j)_{j\geq 1}$ be a sequence of positive integers such that $M_j \ge j + 1$ and $k_j \ge j + 2$ for every $j \ge 1$. Then the set of hypercyclic operators is a dense G_{δ} subset of $(\mathcal{L}_{(M_j),(k_j)}, \text{SOT})$.

The statement of Theorem 4.1 is not strictly necessary for the proof of Theorem 1.1. However, we will subsequently make use of many of the ingredients of its proof, in particular of the expression and the properties of the eigenvectors of operators of the form $B + \delta S_{n+1}$, where $B = T_n BT_n$ (cf. Proposition 3.1).

Proof. Let us begin by proving that the set of hypercyclic operators is G_{δ} in $\mathcal{L}_{(M_j),(k_j)}$. The argument for this is classical (cf. [17, Corollary 2.2]). Let $(\mathcal{U}_p)_{p\geq 1}$ be a countable basis of open sets of $H(\mathbb{C})$. The set of hypercyclic operators in $\mathcal{L}_{(M_j),(k_j)}$ can be expressed as

$$
\mathcal{G} = \left\{ T \in \mathcal{L}_{(M_j),(k_j)} \; ; \; \forall p, q \geq 1 \; \exists u \in \mathcal{U}_p \; \exists N \geq 1 \; \text{such that} \; T^N u \in \mathcal{U}_q \right\}
$$

$$
= \bigcap_{p,q \geq 1} \bigcup_{N \geq 1} \left\{ T \in \mathcal{L}_{(M_j),(k_j)} \; ; \; \exists u \in \mathcal{U}_p \; \text{such that} \; T^N u \in \mathcal{U}_q \right\}.
$$

To establish that $\mathcal G$ is a G_δ set, it suffices to prove that, for all p, q and N, the set

$$
\mathcal{G}_{p,q,N} := \left\{ T \in \mathcal{L}(M_j), (k_j) \; ; \; \exists u \in \mathcal{U}_p \text{ such that } T^N u \in \mathcal{U}_q \right\}
$$

is SOT-open. This is a consequence of the following claim:

Claim 4.2. For every integer $N \geq 1$ and every function $u \in H(\mathbb{C})$, the map $\phi_{N,u} : T \mapsto$ $T^{N}u$ from $\mathcal{L}_{(M_{j}),(k_{j})}$ into $H(\mathbb{C})$ is SOT-continuous.

We take the claim for granted for the moment. Let T_0 belong to $\mathcal{G}_{p,q,N}$. Choose $u \in \mathcal{U}_p$ such that $T_0^N u$ belongs to \mathcal{U}_q . Then $\phi_{N,u}^{-1}(\mathcal{U}_q)$ is an SOT-open set contained in $\mathcal{G}_{p,q,N}$ containing T_0 . Therefore $\mathcal{G}_{p,q,N}$ is indeed SOT-open, and G is an SOT- G_{δ} set, provided the claim holds.

Proof of Claim 4.2. Let (T_n) be a sequence of elements of $\mathcal{L}_{(M_j),(k_j)}$ that SOT-converges to T. For every $j \geq 0$, define $\kappa(j) := k_j$. Note that for all $S \in \mathcal{L}_{(M_j),(k_j)}$, all $l \geq 1$, all $f \in H(\mathbb{C})$ and all $j \geqslant 1$, we have

(4.1)
$$
N_j(S^l f) \leqslant \left(\prod_{m=1}^l M_{\kappa^{m-1}(j)}\right) N_{\kappa^l(j)}(f),
$$

where $\kappa^{m}(j) = \kappa \circ \cdots \circ \kappa(j), j \geq 0$, is the composition of the function κ with itself m times. Now we express $\phi_{N,u}(T_n) - \phi_{N,u}(T)$ as follows:

$$
\phi_{N,u}(T_n) - \phi_{N,u}(T) = \sum_{l=1}^N \left(T_n^l T^{N-l} u - T_n^{l-1} T^{N-l+1} u \right) = \sum_{l=1}^N T_n^{l-1} (T_n - T) T^{N-l} u.
$$

Thus, by (4.1), we have for all $j \geq 1$ that

$$
N_j(\phi_{N,u}(T_n) - \phi_{N,u}(T)) \leq \sum_{l=1}^N N_j \left(T_n^{l-1} (T_n - T) T^{N-l} u \right)
$$

$$
\leq \sum_{l=1}^N \left(\prod_{m=1}^{l-1} M_{\kappa^{m-1}(j)} \right) N_{\kappa^{l-1}(j)} \left((T_n - T) T^{N-l} u \right).
$$

Since $N \geq 1$ and $u \in H(\mathbb{C})$ are fixed, and since the sequence $(T_n)_n$ SOT-converges to T, we have $N_{\kappa^{l-1}(j)}((T_n-T)T^{N-l}u) \longrightarrow 0$ as $n \to +\infty$ for every $l = 1, ..., N$. Thus $N_j(\phi_{N,u}(T_n) - \phi_{N,u}(T)) \longrightarrow 0$, proving the claim.

Next we prove that hypercyclic operators are SOT-dense in $\mathcal{L}_{(M_j),(k_j)}$. To this end, by Proposition 3.1 it suffices to prove that the operators $B + \delta S_{n+1}$, with $n \geq 0$ and $B = T_n BT_n$, are hypercyclic.

The general strategy of the proof is the following: we will show (cf. Lemma 4.5 below) that if a subset A of $\mathbb C$ has an accumulation point in $\mathbb C$, then the linear span of entire functions f which satisfy $(B + \delta S_{n+1})f = \lambda f$ for some $\lambda \in A$ is dense in $H(\mathbb{C})$. The Godefroy-Shapiro Criterion (cf. for instance [20, Theorem 3.1]) will then imply that $B +$ δS_{n+1} is hypercyclic, and thus Theorem 4.1 will follow.

Our first task is to describe the eigenvectors of $B + \delta S_{n+1}$. For $n \geq 0$, we denote by $\Pi_{n+1} : \mathbb{C}^{n+1} \to \mathbb{C}$ the canonical projection defined by $\Pi_{n+1}(z_0, \ldots, z_n) = z_n$ for every $(z_0, \ldots, z_n) \in \mathbb{C}^{n+1}$. For $\lambda \in \mathbb{C}$, let M_λ be the $(n+1)$ -square matrix defined as

$$
M_{\lambda} = \begin{pmatrix} 0 & \cdots & \cdots & 0 & \frac{(n+1)!}{\delta} \lambda \\ 1 & \ddots & & 0 & 0 \\ 0 & \ddots & \ddots & & \vdots \\ \vdots & \ddots & \ddots & \ddots & \vdots \\ 0 & \cdots & 0 & 1 & 0 \end{pmatrix}.
$$

We begin by proving the following lemma.

Lemma 4.3. Let B be a continuous linear operator on $H(\mathbb{C})$ and let $\delta > 0$. Suppose that there exists $n \geq 0$ such that $B = T_n BT_n$. Then for every polynomial $P \in \mathbb{C}_n[z]$ and every $\lambda \in \mathbb{C}$, the entire function $f_{\lambda,P}$ defined by

$$
f_{\lambda,P}(z) = P(z) + \Pi_{n+1} \left(\int_{[0,z]} \frac{(n+1)!}{\delta} \exp((z-t)M_{\lambda}) \left((-B + \lambda I)P(t), 0, \dots, 0 \right) dt \right)
$$

is the only eigenvector of $B + \delta S_{n+1}$ associated to the eigenvalue λ such that $T_n f_{\lambda,P} = P$. In particular, dim ker $(B + \delta S_{n+1} - \lambda I) = n + 1$.

Proof of Lemma 4.3. Let f belong to $H(\mathbb{C})$. We set $P = T_n f$ and $g = f - P$. Since $B = T_n BT_n$ and $T_n g = 0$, we have that $Bg = 0$. Therefore $(B + \delta S_{n+1})f = \lambda f$ if and only if $BP + \delta S_{n+1}g = \lambda g + \lambda P$.

Thus g is a solution of the ordinary differential equation

$$
(E): \begin{cases} y^{n+1} - \lambda \frac{(n+1)!}{\delta} y = \frac{(n+1)!}{\delta} (\lambda I - B)P \\ y^{(n)}(0) = \dots = y(0) = 0. \end{cases}
$$

Hence there exists a unique eigenvector $f_{\lambda,P}$ of $B + \delta S_{n+1}$ associated to the eigenvalue λ such that $T_n f_{\lambda,P} = P$. It has the form $f_{\lambda,P} = P + g$, where g is the unique solution of $(E).$

As usual, in order to solve the differential equation (E) , one sets $Y = (y^{(n)}, \ldots, y)$. Then y is a solution of (E) if and only if Y is a solution of the system

$$
(E') : \begin{cases} Y' = M_{\lambda} Y + \frac{(n+1)!}{\delta} \left((-B + \lambda I) P(t), 0, \dots, 0 \right) \\ Y(0) = 0. \end{cases}
$$

The unique solution of
$$
(E')
$$
 is given by
\n
$$
Y(z) = \int_{[0,z]} \frac{(n+1)!}{\delta} \exp((z-t)M_\lambda) \left((-B + \lambda I)P(t), 0, \dots, 0 \right) dt
$$

which yields the expression of $f_{\lambda,P}$ as given in the statement of Lemma 4.3.

We will need a more explicit expression of $f_{\lambda,P}$ when P describes the canonical basis P_0, \ldots, P_n of $\mathbb{C}_n[z]$, with $P_l(z) = z^l$, $l = 0, \ldots, n$. For $i, j = 0, \ldots, n$, let $a_{ij} \in \mathbb{C}$ be such that

$$
Bz^j = \sum_{i=0}^n a_{ij} z^i \quad \text{ for every } 0 \le j \le n.
$$

We also set, for $j = 0, \ldots, n$ and $l \ge 1$,

$$
\alpha_l^{(j)} = \sum_{m=0}^j \binom{j}{m} \frac{(-1)^m}{(n+1)l + m} \quad \text{and} \quad \alpha_0^{(j)} = 1.
$$

Lemma 4.4. Let B be a continuous linear operator on $H(\mathbb{C})$ and let $\delta > 0$. Suppose that there exists $n \geq 0$ such that $B = T_n BT_n$. Then we have for every $i = 0, ..., n$
 $\downarrow \in \mathcal{L}$ $((n+1)!)^{\{+1\}}$

$$
f_{\lambda, P_i}(z) = z^i + \sum_{l=0}^{+\infty} \left(\left(\frac{(n+1)!}{\delta} \right)^{l+1} \frac{1}{((n+1)l+n)!} \left(\lambda^{l+1} \alpha_{l+1}^{(i)} z^{i+(n+1)(l+1)} -\lambda^l \sum_{j=0}^n a_{ji} z^{(n+1)(l+1)+j} \alpha_{l+1}^{(j)} \right) \right).
$$

Proof of Lemma 4.4. We define the matrices $J^{(j)}$ = $J_m^{(j)}$ $\binom{n(j)}{m,l}_{1 \leq m,l \leq n+1}$, for $j = 0, ..., n$, by setting #

$$
J_{m,l}^{(j)} = \begin{cases} 1, & \text{for } m = j+1, \dots, n+1 \text{ and } l = m-j \\ 0, & \text{otherwise} \end{cases}
$$

and
$$
N^{(j)} = \left(N_{m,l}^{(j)}\right)_{1 \leq m, l \leq n+1}
$$
, for $j = 1, \ldots, n$, by setting\n
$$
N_{m,l}^{(j)} = \begin{cases} 1, & \text{for } m = 1, \ldots, n+1-j \text{ and } l = j+m \\ 0, & \text{otherwise} \end{cases}
$$

with $N^{(n+1)} = 0$.

We then have, for every $j = 0, ..., n$ and every $l \geq 0$ that

$$
M_{\lambda}^{(n+1)l+j} = \left(\lambda \frac{(n+1)!}{\delta}\right)^l \left(J^{(j)} + \lambda \frac{(n+1)!}{\delta} N^{(n+1-j)}\right),
$$

which implies that

which implies that
\n
$$
\exp((z-t)M_{\lambda}) = \sum_{l=0}^{+\infty} \left(\sum_{j=0}^{n} \frac{(z-t)^{(n+1)l+j}}{((n+1)l+j)!} \left(\lambda \frac{(n+1)!}{\delta} \right)^{l} \left(J^{(j)} + \lambda \frac{(n+1)!}{\delta} N^{(n+1-j)} \right) \right).
$$

It then follows from Lemma 4.3 that

$$
f_{\lambda, P_i}(z) = z^i + \int_{[0, z]} \sum_{l=0}^{+\infty} \frac{(z-t)^{(n+1)l+n}}{((n+1)l+n)!} \left(\frac{(n+1)!}{\delta}\right)^{l+1} \lambda^l \left(\lambda t^i - \sum_{j=0}^n a_{ji} t^j\right) dt.
$$

For the compute the above integral, we decompose t^j as $t^j - \sum_{j=0}^j (j) \lambda^{j-m} t$.

In order to compute the above integral, we decompose t^j as $t^j = \sum_{r=1}^{j}$ $m=0$ m $z^{j-m}(t-z)^m$ and thus obtain that the integral in the expression above is equal to

$$
\int_{[0,z]} \sum_{l=0}^{+\infty} \left(\frac{(-1)^{(n+1)l+n}}{((n+1)l+n)!} \left(\frac{(n+1)!}{\delta} \right)^{l+1} \lambda^l \left(\lambda \sum_{m=0}^i \binom{i}{m} z^{i-m} (t-z)^{(n+1)l+n+m} - \sum_{j=0}^n a_{ji} \sum_{m=0}^j \binom{j}{m} z^{j-m} (t-z)^{(n+1)l+n+m} \right) \right) dt
$$

$$
= \sum_{l=0}^{+\infty} \left(\frac{(-1)^{(n+1)(l+1)}}{((n+1)l+n)!} \left(\frac{(n+1)!}{\delta} \right)^{l+1} \lambda^l \left(\lambda \sum_{m=0}^i \binom{i}{m} \frac{z^{i-m} (-z)^{(n+1)(l+1)+m}}{(n+1)(l+1)+m} - \sum_{j=0}^n a_{ji} \sum_{m=0}^j \binom{j}{m} \frac{z^{j-m} (-z)^{(n+1)(l+1)+m}}{(n+1)(l+1)+m} \right) \right).
$$

This then yields that

$$
f_{\lambda, P_i}(z) = z^i + \sum_{l=0}^{+\infty} \left(\frac{1}{((n+1)l+n)!} \left(\frac{(n+1)!}{\delta} \right)^{l+1} \left(\alpha_{l+1}^{(i)} \lambda^{l+1} z^{i+(n+1)(l+1)} - \lambda^l \sum_{j=0}^n \alpha_{l+1}^{(j)} a_{ji} z^{(n+1)(l+1)+j} \right) \right),
$$

which is exactly the expression given in Lemma 4.4. \Box

Our last task is to prove the density of the vector space spanned by the functions $f_{\lambda,P}$, where P ranges over $P \in \mathbb{C}_n[z]$ and λ ranges over a certain subset A of C having an accumulation point in C.

Lemma 4.5. Let B be a continuous linear operator on $H(\mathbb{C})$ such that $B = T_nBT_n$ for some $n \geq 0$ and let $\delta > 0$. For every subset A of C which has an accumulation point in C, the vector space for the control of the cont

$$
\operatorname{span}\left[\bigcup_{\lambda \in \mathcal{A}} \ker(B + \delta S_{n+1} - \lambda I)\right]
$$

is dense in $H(\mathbb{C})$.

Proof of Lemma 4.5. We proceed as in the proof of [14, Theorem 5.1]. Let Λ be a continuous linear functional on $H(\mathbb{C})$ that vanishes on each function $f_{\lambda,P}, \lambda \in \mathcal{A}, P \in \mathbb{C}_n[z]$. The lemma will be proved as soon as we show that $\Lambda = 0$. As in [14], we use the fact that there exists a complex Borel measure μ on C, supported on a disk of radius $r > 0$ and centered at the origin, such that for every $f \in H(\mathbb{C})$

$$
\Lambda(f) = \int_{\mathbb{C}} f d\mu.
$$

For $0 \leq i \leq n$ and $l \geq 0$, we set

$$
u_l^{(j)} = \int_{\mathbb{C}} z^{(n+1)l+j} \mathrm{d}\mu(z).
$$

We aim to prove for all j and l, that $u_l^{(j)} = 0$. The continuity of Λ will then imply that $\Lambda = 0.$

For every polynomial $P \in \mathbb{C}_n[z]$, we define $F_P : \mathbb{C} \to \mathbb{C}$ by setting

$$
F_P(\lambda) = \int_{\mathbb{C}} f_{\lambda, P} d\mu, \quad \lambda \in \mathbb{C}.
$$

On the one hand, since $\Lambda(f_{\lambda,P}) = 0 = \int_{\mathbb{C}} f_{\lambda,P} d\mu$ for every $\lambda \in \mathcal{A}$ and every $P \in \mathbb{C}_n[z]$, we have $F_P(\lambda) = 0$ for every $\lambda \in \mathcal{A}$.

On the other hand, since $f_{\lambda,P}$ depends holomorphically on λ by Lemma 4.3, and since μ is compactly supported, differentiation under the integral sign shows that F_P is an entire function. Since A has an accumulation point, we deduce that $F_P = 0$. In particular, for every $P \in \mathbb{C}_n[z]$ and every $l \geq 0$,

$$
F_P^{(l)}(0) = \int_{\mathbb{C}} \left. \frac{\partial^l f_{\lambda,P}}{\partial \lambda^l} \right|_{\lambda=0} \mathrm{d}\mu = 0.
$$

We will now show that the values of the $u_j^{(j)}$ $\binom{1}{l}$'s are linked to those of the derivatives $F_{\star i}^{(l)}$ $z_j^{(t)}(0)$. In order to do this, we need to compute the successive derivatives of f_{λ,z_j} with respect to λ at the point $\lambda = 0$.

We continue to denote by B the $(n+1)$ -square matrix $B = (a_{ij})_{1\leq i,j\leq n+1}$, i.e. the matrix of the restriction of the operator B to $\mathbb{C}_n[z]$ with respect to the canonical basis of $\mathbb{C}_n[z]$. We also denote by \tilde{U}_l the vector \mathbb{C}^{n+1} defined by $\tilde{U}_l = (\alpha_l^{(0)})^n$ $\stackrel{(0)}{u_l}$ $\stackrel{(0)}{l},\stackrel{(1)}{\alpha_l^{(1)}}$ $\begin{pmatrix} 1 \\ l \end{pmatrix} u_l^{(1)}$ $\alpha_l^{(1)}, \ldots, \alpha_l^{(n)}$ $\hat{u}_l^{(n)}u_l^{(n)}$ $\binom{n}{l}$. From Lemma 4.4 we deduce that

$$
F_{P_i}(0) = u_0^{(i)} - \frac{(n+1)!}{\delta} \frac{1}{n!} \sum_{j=0}^n a_{ji} \alpha_1^{(j)} u_1^{(j)} \quad \text{for every } i = 0, \dots n,
$$

and since $F_{P_i}(0) = 0$ for $i = 0, \ldots, n$ we get that

$$
\tilde{U}_0 = \frac{(n+1)!}{\delta n!} {}^{\mathsf{T}} B \tilde{U}_1,
$$

where the notation \overline{B} denotes the transpose of the matrix B. For $l \geq 1$, we differentiate with respect to λ the expression given in Lemma 4.4 and obtain that for every $i = 0, \ldots, n$,

$$
\frac{\partial^l F_{P_i}}{\partial \lambda^l}(0) = \left(\frac{(n+1)!}{\delta}\right)^l \left(\frac{l!}{((n+1)(l-1)+n)!} \alpha_l^{(i)} u_l^{(i)} -\frac{(n+1)!}{\delta} \frac{l!}{((n+1)l+n)!} \sum_{j=0}^n a_{ji} \alpha_{l+1}^{(j)} u_{l+1}^{(j)}\right) = 0
$$

from which we deduce that

$$
\tilde{U}_l = \frac{(n+1)!}{\delta} \frac{((n+1)(l-1)+n)!}{((n+1)l+n)!} T B \tilde{U}_{l+1}.
$$

It follows that for every $m \geqslant 0$ and every $l \geqslant 0$,

$$
\tilde{U}_l = \left(\frac{(n+1)!}{\delta}\right)^m \frac{((n+1)(l-1)+n)!}{((n+1)(l+m-1)+n)!} T B^m \tilde{U}_{l+m},
$$

with the convention that $(-1)! = 1$.

If we denote by $\|\cdot\|$ the sup norm on \mathbb{C}^{n+1} and by $\|\cdot\|$ the norm on $(n+1)$ square

matrices subordinated to this norm, we get that
\n
$$
\left\|\tilde{U}_l\right\| \leqslant \left(\frac{(n+1)!}{\delta}\right)^m \frac{((n+1)(l-1)+n)!}{((n+1)(l+m-1)+n)!} \|\mathsf{T}B\|^{m} \left\|\tilde{U}_{l+m}\right\| \quad \text{for every } l,m \geqslant 0.
$$

We now observe that for every $j = 0, \ldots, n$ and every $l \geq 1$, we have

$$
\alpha_l^{(j)} = \sum_{m=0}^j \binom{j}{m} \frac{(-1)^m}{(n+1)l+m} = \int_0^1 \sum_{m=0}^j \binom{j}{m} (-1)^m t^{(n+1)l+m-1} \mathrm{d}t
$$

$$
= \int_0^1 t^{l(n+1)-1} (t-1)^j \mathrm{d}t,
$$

so that $0 \le \alpha_l^{(j)} \le 1$ for every $l \ge 1$. Recall also that $\alpha_0^{(j)} = 1$.

On the other hand, remembering that μ is supported on the disc centered at 0 and of radius r (which may be assumed to be bigger than 1), we have

$$
\left| u_l^{(j)} \right| = \left| \int_{\mathbb{C}} z^{(n+1)l+j} \mathrm{d} \mu(z) \right| \leqslant r^{(n+1)l+j} |\mu|(\mathbb{C}) \quad \text{ for every } j = 0, \dots, n \text{ and } l \geqslant 0.
$$

It thus follows that

$$
\|\tilde{U}_{l}\| \leqslant \left(\frac{(n+1)!}{\delta}\right)^{m} \frac{((n+1)(l-1)+n)!}{((n+1)(l+m-1)+n)!} \|\mathsf{T}B\|^{m} r^{(n+1)(l+m)+n} |\mu|(\mathbb{C}).
$$

Letting m go to infinity, we conclude that $\tilde{U}_l = 0$. Thus $u_l^{(j)} = 0$ for all $j, l \geqslant 0$, from which it follows that $\Lambda = 0$. Lemma 4.5 is thus proved.

As explained at the beginning of the proof of Theorem 4.1, Lemma 4.5 combined with the Godefroy-Shapiro Criterion allows us to conclude that operators in $\mathcal{L}_{(M_i),(k_i)}$ of the form $B+\delta S_{n+1}$, with $\delta > 0$, $n \geq 0$ and $B = T_nBT_n$, are hypercyclic. Hypercyclic operators are thus dense in $(\mathcal{L}_{(M_j),(k_j)},$ SOT). We have already observed that the set of hypercyclic operators is G_{δ} in $(\mathcal{L}_{(M_j),(k_j)},$ SOT $)$, so this concludes the proof of Theorem 4.1.

5. Operators supporting a hypercyclic algebra: proof of Theorem 1.1

A last crucial step in the proof of Theorem 1.1 is the following result.

Theorem 5.1. Let B be a continuous linear operator on $H(\mathbb{C})$ such that there exists $n \geq 0$ which satisfies $B = T_n BT_n$. Suppose also for every $j \geq 0$ that the sequence $(B^{m}z^{j})_{m}$ converges to 0 in $H(\mathbb{C})$ as m goes to infinity. Then for every $\delta \in (0,1)$, the operator $A = B + \delta S_{n+1}$ supports a hypercyclic algebra.

To prove Theorem 5.1, we will apply [2, Lemma 1.6] (cf. also [3, Corollary 2.4]), which provides a useful "Birkhoff-type Criterion" for proving that an operator admits a hypercyclic algebra.

Lemma 5.2 ([2]). Let A be a continuous operator on a separable, metrizable and complete topological algebra X. Assume that for any pair $(\mathcal{U}, \mathcal{V})$ of nonempty open sets in X, any neighborhood W of 0 in X, and for any integer $m \geq 1$, one can find a vector $u \in U$ and an integer $N \geqslant 0$ such that $A^N(u^j)$ belongs to W for every $1 \leqslant j < m$ and $A^N(u^m)$ belongs to V . Then A supports a hypercyclic algebra.

In $[2]$, this criterion is applied in the following way: the vector u is found in a dense linear subspace of the space X spanned by holomorphic vector fields $(E_{\lambda})_{\lambda \in \mathbb{C}}$ of eigenvectors of A. To compute $A^N(u^j)$, we require that these eigenvector fields be multiplicative, i.e. that $E_{\lambda+\mu} = E_{\lambda} \cdot E_{\mu}$ for every λ and μ in C. In our case, the product of two eigenvectors is not necessarily an eigenvector. To overcome this obstacle, we will introduce multiplicative vector fields whose powers are close to powers of eigenvectors fields. It is here that the assumption that the sequences $(B^m z^j)_m$, $j \geq 0$, converge to 0 in $H(\mathbb{C})$ plays a crucial role.

We begin by giving a simpler expression for some of the eigenvectors exhibited in Lemma 4.3. Let B be an operator satisfying the hypothesis of Theorem 5.1 and let A be the operator $A = B + \delta S_{n+1}$, with $\delta \in (0, 1)$. For every $\alpha \in \mathbb{C}$, we denote by e_{α} the function defined by $e_{\alpha}(z) = \exp(\alpha z)$, $z \in \mathbb{C}$. We also set

$$
x_0 = \left(\frac{(n+1)!}{\delta}\right)^{\frac{1}{n+1}},
$$

and we denote by ϕ the function defined by

$$
\phi(z) = \left(\frac{z}{x_0}\right)^{n+1} = \frac{\delta}{(n+1)!} z^{n+1} \quad \text{for every } z \in \mathbb{C}.
$$

For every $\beta \in \mathbb{C} \backslash \phi^{-1}(\sigma (B))$, where $\sigma (B)$ denotes the spectrum of the operator B acting on $H(\mathbb{C})$, we put

$$
\varepsilon_{\beta} = e_{\beta} + (\phi(\beta)I - B)^{-1} Be_{\beta}.
$$

We note that $\sigma(B)$ is finite. Keeping in mind that $B\varepsilon_{\beta}$ is a polynomial of degree at most n, we have

$$
A\varepsilon_{\beta} = \frac{\delta}{(n+1)!} \beta^{n+1} e_{\beta} + B e_{\beta} + B (\phi(\beta)I - B)^{-1} B e_{\beta}
$$

= $\phi(\beta)e_{\beta} + \phi(\beta) (\phi(\beta)I - B)^{-1} B e_{\beta} + B e_{\beta} - (\phi(\beta)I - B) (\phi(\beta)I - B)^{-1} B e_{\beta}$
= $\phi(\beta)\varepsilon_{\beta}$,

i.e. ε_{β} is an eigenvector of A associated to the eigenvalue $\phi(\beta)$.

We now prove the following density lemma.

Lemma 5.3. Let β be a subset of $\mathbb C$ which has an accumulation point and is such that $\beta e^{\frac{2i\pi j}{n+1}}$ belongs to B for every $0 \leqslant j \leqslant n$ and every $\beta \in \mathcal{B}$. Then the linear vector space

$$
\text{span}\left[\varepsilon_{\beta} \, ; \, \beta \in \mathcal{B} \backslash \phi^{-1} \left(\sigma\left(B\right)\right)\right]
$$

is dense in $H(\mathbb{C})$.

Proof. We will show that for every $\beta \in \mathcal{B}\backslash \phi^{-1}(\sigma (B))$, we have
span $\left[\varepsilon_{\beta'}; \ \beta' = \beta e^{\frac{2i\pi j}{n+1}}, \ j = 0, \dots, n\right] = \ker(A)$

$$
\mathrm{span}\left[\varepsilon_{\beta'}\,;\,\,\beta'=\beta e^{\frac{2i\pi j}{n+1}},\,\,j=0,\ldots,n\right]=\ker(A-\phi(\beta)I).
$$

Then, since for every $\beta \in \mathcal{B}\backslash \phi^{-1}(\sigma (B))$ and every $0 \leq \gamma \leq n$ the complex numbers $\beta e^{\frac{2i\pi j}{n+1}}$ still belong to $\mathcal{B}\backslash \phi^{-1}(\sigma (B))$, it will follow that

$$
\operatorname{span}\left[\bigcup_{\lambda\in\phi(\mathcal{B})\setminus\sigma(B)}\ker(A-\lambda I)\right]=\operatorname{span}\left[\varepsilon_{\beta}\,;\,\beta\in\mathcal{B}\setminus\phi^{-1}\left(\sigma\left(B\right)\right)\right].
$$

Since $\phi(\mathcal{B})\setminus\sigma(B)$ has an accumulation point in C, Lemma 4.5 will imply that the linear Since $\phi(\mathcal{B})\setminus\sigma(\mathcal{B})$ has an accumulation point in \mathbb{C} , Lemma 4.5 will imply that vector space spanned by the family $\{\varepsilon_\beta: \beta \in \mathcal{B}\setminus\phi^{-1}(\sigma(B))\}$ is dense in $H(\mathbb{C})$.

So, let β belong to $\mathcal{B}\backslash \phi^{-1}(\sigma (B))$, and set $\beta_j = \beta e^{\frac{2i\pi j}{n+1}}$, $j = 0, \ldots, n$. We will check that the functions $\varepsilon_{\beta_0}, \ldots, \varepsilon_{\beta_n}$ are linearly independent in $H(\mathbb{C})$. Since for every $j = 0, \ldots, n$ the function ε_{β_j} is an eigenvector of A associated to the eigenvalue $\phi(\beta)$, and since, by Lemma 4.3, dim ker $(A - \phi(\beta)I) = n + 1$, Lemma 5.3 will thus be proven.

Let $\gamma_0, \ldots, \gamma_n$ be $n+1$ complex numbers such that $\sum_{j=0}^n \gamma_j \varepsilon_{\beta_j} = 0$. Since for every j the function ε_{β_j} is the sum of e_{β_j} and a polynomial of degree at most n, differentiating $n+1$

times the latter sum we get that $\sum_{j=0}^{n} \beta^{n+1} \gamma_j e_{\beta_j} = 0$. Since $\phi(0) = 0$ is an eigenvalue of times the latter sum we get that $\sum_{j=0}^n \beta^{N} \gamma_j e_{\beta_j} = 0$. Since $\varphi(0) = 0$ is an eigenvalue of B , $\beta^{n+1} \neq 0$, and we thus have $\sum_{j=0}^n \gamma_j e_{\beta_j} = 0$. Now since $e_{\beta_0}, \ldots, e_{\beta_n}$ are linearly independent functions in $H(\mathbb{C})$, $\gamma_0 = \cdots = \gamma_j = 0$, and $\varepsilon_{\beta_0}, \ldots, \varepsilon_{\beta_n}$ are linearly independent. Lemma 5.3 is thus proved. \square

The vectors ε_{β} , $\beta \in \mathcal{B}$, thus span a dense linear subspace of $H(\mathbb{C})$ provided that $\mathcal B$ has an accumulation point and is invariant by the rotation of angle $\frac{2\pi}{n+1}$. However, in general it does not hold that $\varepsilon_{\alpha} \cdot \varepsilon_{\beta} = \varepsilon_{\alpha+\beta}$. In order to overcome this difficulty, we will take advantage of the fact that, of course, $e_{\alpha} \cdot e_{\beta} = e_{\alpha+\beta}$, and of the link between $A^m e_{\beta}$ and $A^m \varepsilon_\beta$ given by the following Fact 5.4.

Fact 5.4. For every
$$
\beta \in \mathbb{C} \backslash \phi^{-1}(\sigma(B))
$$
 and every $m \ge 0$, we have
(5.1)
$$
A^{m}e_{\beta} = \phi(\beta)^{m}\varepsilon_{\beta} - (\phi(\beta)I - B)^{-1}B^{m+1}e_{\beta}.
$$

Proof. By definition of ε_{β} , we have the equality $e_{\beta} = \varepsilon_{\beta} - (\phi(\beta)I - B)^{-1}Be_{\beta}$. If we assume for some integer $m \geq 0$ that (5.1) is true, then, since $(\phi(\beta)I - B)^{-1}B^{m+1}e_{\beta}$ is a polynomial of degree at most n , we have

$$
A^{m+1}e_{\beta} = \phi(\beta)^m A \varepsilon_{\beta} - B (\phi(\beta)I - B)^{-1} B^{m+1} e_{\beta}
$$

= $\phi(\beta)^{m+1} \varepsilon_{\beta} - (\phi(\beta)I - B)^{-1} B^{m+2} e_{\beta}.$

Therefore, by induction, (5.1) is valid for every $m \ge 0$.

When $(B^mP)_m$ converges to 0 for every polynomial P of degree at most n, Fact 5.4 implies that $A^m e_\beta$ is close to $A^m \varepsilon_\beta = \phi(\beta)^m \varepsilon_\beta$. This will be a key element in showing that A satisfies the assumptions of Lemma 5.2, cf. Lemma 5.6 below. In the proof of this lemma, we will need Lemma 5.5, which can be compared to the beginning of the proof of Theorem 2.1 in [2].

Lemma 5.5. Let m be a positive integer, and let η and ε be positive real numbers. To the parameters η and ε we associate two subsets A and B of C defined as follows: $A = D(0, \eta)$ is the open disk of center 0 and of radius η in \mathbb{C} , and \mathcal{B} is the set

$$
\mathcal{B} = \bigcup_{j=1}^{n} \left\{ \zeta_j(1+it) \; ; \; t \in [-\eta, \eta] \right\}
$$

where $\zeta_j = x_0(1+\varepsilon)e^{\frac{2i\pi j}{n+1}}$ for every $0 \leqslant j \leqslant n$. Then there exist $\eta > 0$ and $\varepsilon > 0$ sufficiently small such that for every $j = 1, \ldots, m$, every $d = 0, \ldots, j$ with $d \neq m$, every $\tilde{\xi}_1,\ldots,\tilde{\xi}_{j-d} \in \mathcal{A}$ and every $\xi_1,\ldots,\xi_d \in \mathcal{B}$, we have ˙ˇ

(5.2)
$$
\left|\phi\left(\tilde{\xi}_1 + \cdots + \tilde{\xi}_{j-d} + \frac{\xi_1 + \cdots + \xi_d}{m}\right)\right| < 1,
$$

and for every $l = 1, ..., m$ and every $\xi_1, ..., \xi_l \in \mathcal{B}$ which are not all equal, we have

(5.3)
$$
\left|\phi\left(\frac{\xi_1+\cdots+\xi_l}{m}\right)\right| < |\phi(\xi_1)|^{\frac{1}{m}}\cdots|\phi(\xi_l)|^{\frac{1}{m}}.
$$

Proof. We first prove (5.3). We consider first the case where $l < m$: in this case we have

$$
\left|\frac{\xi_1 + \dots + \xi_l}{m}\right| \leq \frac{m-1}{m}x_0(1+\varepsilon)(1+\eta) < x_0
$$

as soon as ε and η are sufficiently small. Thus

$$
\left|\phi\left(\frac{\xi_1+\cdots+\xi_l}{m}\right)\right|<\phi(x_0)=1.
$$

On the other hand, for every $i = 1, ..., l$, $|\phi(\xi_i)| = (1 + \varepsilon)^{n+1} > 1$ for every $\varepsilon > 0$. Thus

$$
\left|\phi\left(\frac{\xi_1+\cdots+\xi_l}{m}\right)\right|<|\phi(\xi_1)|^{\frac{1}{m}}\cdots|\phi(\xi_l)|^{\frac{1}{m}}.
$$

In the case where $l = m$, we denote by i_j the unique integer with $0 \leq i_j \leq n$ such that $\xi_j = \zeta_{i_j}(1+it_j) = x_0(1+\varepsilon)e^{\frac{2i\pi}{n+1}i_j}(1+it_j)$ for some $t_j \in [-\eta, \eta]$.

We first assume that the sequence $(i_j)_{1 \leq j \leq m}$ is not constant. Since the unit disc is strictly convex, we have

$$
\alpha \coloneqq \sup \left| \frac{1}{m} \sum_{p=1}^m e^{\frac{2i\pi}{n+1} j_p} \right| < 1
$$

where the upper bound is taken over all the m-tuples of integers (j_1, \ldots, j_m) lying between 0 and *n* which are not all equal. Hence if ε is sufficiently small

$$
\left|\frac{\zeta_{i_1} + \dots + \zeta_{i_m}}{m}\right| \leq \alpha x_0 (1 + \varepsilon) < x_0.
$$

By continuity, if η is sufficiently small (depending on ε but not on the ξ_j 's), we have

$$
\left|\frac{\xi_1+\cdots+\xi_m}{m}\right|
$$

and as before this yields that

$$
\left|\phi\left(\frac{\xi_1+\cdots+\xi_m}{m}\right)\right|<1\leqslant|\phi(\xi_1)|^{\frac{1}{m}}\cdots|\phi(\xi_m)|^{\frac{1}{m}}.
$$

Next, we assume that the sequence $(i_j)_{1\leq j\leq m}$ is constant, i.e. $i_j = i_1$ for every $1 \leq$ $j \leq m$, and we consider the function ψ defined on R by $\psi(t) = \ln |\phi(\zeta_{i1}(1+it))|$ = $\frac{n+1}{2}\ln(1+t^2) + (n+1)\ln(1+\varepsilon)$. We have $\psi''(t) = (n+1)\frac{1-t^2}{(1+t^2)}$ $\frac{1-t^2}{(1+t^2)^2}$ and if $0 < \eta < 1$, the function ψ is strictly convex on $[-\eta, \eta]$. It follows that

$$
\left|\phi\left(\frac{\xi_1+\cdots+\xi_m}{m}\right)\right|<\left|\phi(\xi_1)\right|^{\frac{1}{m}}\cdots\left|\phi(\xi_m)\right|^{\frac{1}{m}},
$$

and so (5.3) is shown in this case as well.

We now establish (5.2). Provided ε and η are sufficiently small, we have

$$
\left|\tilde{\xi}_1 + \dots + \tilde{\xi}_{j-d} + \frac{\xi_1 + \dots + \xi_d}{m}\right| \leq (j-d)\eta + \frac{dx_0(1+\varepsilon)}{m}
$$

$$
\leq m\eta + \frac{m-1}{m}x_0(1+\varepsilon) < x_0
$$

and (5.2) readily follows from these inequalities.

Next, we finally prove that the operator A satisfies the hypothesis of Lemma 5.2.

Lemma 5.6. Let B be a continuous linear operator on $H(\mathbb{C})$ such that there exists $n \geq 0$ which satisfies $B = T_nBT_n$. We suppose that the sequence $(B^mz^j)_m$ converges to 0 in $H(\mathbb{C})$ as m tends to infinity for every $j \geq 0$. Let $\delta \in (0, 1)$ and we set $A = B + \delta S_{n+1}$. Then A fulfills the assumptions of Lemma 5.2.

Proof. Let U and V be two open sets in $H(\mathbb{C})$, let W be a neighborhood of 0 in $H(\mathbb{C})$ and let m be a positive integer. Let A and B be the subsets of $\mathbb C$ given by Lemma 5.5. Since A has accumulation points in C, the linear vector space span $[e_\alpha : \alpha \in A]$ is dense in $H(\mathbb{C})$. Thus there exist $a_1, \ldots, a_p \in \mathbb{C}$ and $\alpha_1, \ldots, \alpha_p \in \mathcal{A}$ such that the function $\sum_{j=1}^p a_j e_{\alpha_j}$ belongs to \mathcal{U} .

Since β is invariant by the rotation of angle $\frac{2\pi}{n+1}$, and since β has accumulation points, Lemma 5.3 asserts that span $\lbrack \varepsilon_\beta : \beta \in \mathcal{B} \rbrack$ is dense in $H(\mathbb{C})$. Thus there exist $b_1, \ldots, b_q \in \mathbb{C}$ Lemma 5.3 asserts that span $[\varepsilon_{\beta}$; $\rho \in \mathcal{B}]$ is dense in $H(\mathbb{C})$. Thus the function $\sum_{j=1}^{q} b_j \varepsilon_{\beta_j}$ belongs to \mathcal{V} .

will appear, where the r_j 's and s_j 's are positive integers such that $\sum_{j=1}^p r_j + \sum_{j=1}^q r_j$ will appear, where the r_j 's and s_j 's are positive integers such that $\sum_{j=1}^p r_j + \sum_{j=1}^q s_j \leq m$.
We will need to be able to ensure that the sums $\sum_{j=0}^p r_j \alpha_j + \frac{1}{m} \sum_{j=0}^q s_j \beta_j$ do not belong m $\frac{L}{\nabla^q}$ $g_{j=0}^{q} s_j \beta_j$ do not belong to the spectrum of B. In order to ensure this condition, we notice that for all tuples

is a closed subset of $\mathcal{A}^p \times \mathcal{B}^q$ with empty interior. Since $\sum_{j=1}^p r_j + \sum_{j=1}^q r_j$ $_{j=1}^{q} s_j \leq m$, there are only finitely many such sets. Therefore, the set

\mathcal{A}^{p} \times \mathcal{B}^{q} \setminus \left(\bigcup_{\substack{r \in \mathbb{N}^{p}, s \in \mathbb{N}^{q} \\ \sum_{j=1}^{p} r_{j} + \sum_{j=1}^{q} s_{j} \leq m}} E_{r,s} \right)
$$

is dense in $\mathcal{A}^p \times \mathcal{B}^q$.

We now observe that $e_{\alpha'}$ tends to e_{α} in $H(\mathbb{C})$ as α' tends to α , and that $\varepsilon_{\beta'}$ tends to ε_β in $H(\mathbb{C})$ as β' tends to β , with $\beta, \beta' \in \mathbb{C} \backslash \phi^{-1}(\sigma(B))$. The first assertion is obvious. In order to prove the second assertion, let r be a positive integer. We equip $\mathbb{C}_n[z]$ with the norm N_r and denote by \mathcal{N}_r the norm on the space $\mathcal{B}(\mathbb{C}_n[z])$ of linear continuous operators on $\mathbb{C}_n[z]$ induced by N_r . We notice that for every $w \in \mathbb{C} \setminus \sigma(B)$, for every polynomial P, $(wI - B)^{-1}P$ is still a polynomial, and that the map $\Theta : w \mapsto (wI - B)^{-1}B$ from $\mathbb{C}\setminus\sigma(B)$ into $\mathcal{B}(\mathbb{C}_n[z])$ is well defined and continuous.

Now for all $\beta, \beta' \in \mathbb{C} \backslash \phi^{-1}(\sigma(B))$, we have

$$
N_r \left(\varepsilon_{\beta'} - \varepsilon_{\beta}\right) = N_r \left(e_{\beta'} - e_{\beta} + \Theta(\phi(\beta'))T_n e_{\beta'} - \Theta(\phi(\beta))T_n e_{\beta}\right)

\le N_r \left(e_{\beta'} - e_{\beta}\right) + \mathcal{N}_r \left(\Theta(\phi(\beta')) - \Theta(\phi(\beta))\right) N_r \left(e_{\beta'}\right)

+ \mathcal{N}_r \left(\Theta(\phi(\beta)) N_r \left(e_{\beta'} - e_{\beta}\right).
$$

Therefore, the continuity of Θ implies that $N_r(\varepsilon_{\beta'}-\varepsilon_{\beta})$ tends to zero as $\beta'\in\mathbb{C}\setminus\phi^{-1}(\sigma(B))$ tends to $\beta \in \mathbb{C} \backslash \phi^{-1}(\sigma (B))$. Hence, $\varepsilon_{\beta'}$ tends to ε_{β} in $H(\mathbb{C})$ when $\beta' \in \mathbb{C} \backslash \phi^{-1}(\sigma (B))$ tends to $\beta \in \mathbb{C} \backslash \phi^{-1}(\sigma (B)).$

Therefore, by choosing $((\alpha'_1, \ldots, \alpha'_p), (\beta'_1, \ldots, \beta'_q))$ in the set defined in (5.4) close enough to $((\alpha_1, ..., \alpha_p), (\beta_1, ..., \beta_q))$, we can assume that for every $r \in \mathbb{N}^p$ and every $s \in \mathbb{N}^q$ such

For every $\beta \in \mathcal{B}$, we have $|\beta| > x_0$, thus $|\phi(\beta)| > 1$ and the sequence

converges to 0 in $H(\mathbb{C})$ as N goes to infinity. Consequently, u_N belongs to U if N is large enough.

We now compute the quantities u_N^k and $A^N u_N^k$ for every $k \in \{1, ..., m\}$. For every d-tuple $L = (l_1, \ldots, l_d) \in \{1, \ldots, p\}^d$, we put $a_L = a_{l_1} \cdots a_{l_d}$ when $d \geq 1$ and $a_{\emptyset} = 1$. For every $J = (j_1, \ldots, j_{k-d}) \in \{1, \ldots, q\}^{k-d}$, we put $c_J(N) = c_{j_1}(N) \cdots c_{j_{k-q}}(N)$ when $k - d \geq 1$, and $c_{\emptyset}(N) = 1$. We have

u_N^k = \sum_{d=0}^k \sum_{\substack{L \in \{1,\ldots,p\}^k-d \\ J \in \{1,\ldots,q\}^d}} h(L,J) a_L c_J(N) e_{\alpha_{l_1} + \cdots + \alpha_{l_{k-d}} + \frac{1}{m}(\beta_{j_1} + \cdots + \beta_{j_d})}

where the $h(L, J)$'s are constants depending only on L and J but not on N (cf. the proof of [2, Theorem 2.1]).

It suffices to show that $\mathcal{G}_{p,q,r,m,u,N}$ is an open set in $\mathcal{L}_{(M_j),(k_j)}$. Let T_0 belong to $\mathcal{G}_{p,q,r,m,u,N}$. If T is sufficiently SOT-close to T_0 , then Claim 4.2 implies that for every $0 \leq n \leq m$, $T^N u^n$

.

belongs to W_r and $T^N u^m$ belongs to \mathcal{U}_q . Thus $\mathcal{G}_{p,q,r,m,u,N}$ is indeed SOT-open and $\mathcal G$ is a G_{δ} set.

We now check that G is dense in $\mathcal{L}_{(M_j),(k_j)}$. Let A belong to $\mathcal{L}_{(M_j),(k_j)}$ and let V be a SOT-neighborhood of A in $\mathcal{L}_{(M_j),(k_j)}$. It follows from Corollary 3.9 that there exist $B \in \mathcal{L}_{(M_j),(k_j)}, \delta \in (0,1)$ and $n \geq 1$ such that $B + \delta S_{n+1}$ belongs to $\mathcal{V}, B = T_nBT_n$ and $B^{n+1} = 0$. By Lemma 5.6, the operator $B + \delta S_{n+1}$ satisfies the hypothesis of Lemma 5.2 and thus belongs to G. Hence G is dense in $\mathcal{L}_{(M_j),(k_j)}$. This concludes the proof of Theorem 1.1.

6. Proof of Theorem 1.2 and related results

In this section, the setting is the following: X is one of the (complex) Banach spaces $\ell_p(\mathbb{N}), 1 \leq p < +\infty$, or $c_0(\mathbb{N}).$ We endow X with the coordinatewise product, so that it becomes a Banach algebra. For every $M > 1$, a typical operator $T \in (\mathcal{B}_M(X), SOT)$ is hypercyclic, see the proof of [17, Proposition 2.3] which can be adapted in a straightforward way from the Hilbertian setting to the case where $X = \ell_p(\mathbb{N}), 1 \leq p < +\infty$, or $X = c_0(\mathbb{N}).$ Theorem 1.2 augments this statement by showing that, in fact, a typical T admits a hypercyclic algebra.

Proof of Theorem 1.2. Let $(U_q)_{q\geq 1}$ be a basis of the topology of X consisting of open balls. We write $U_q = B(x_q, \rho_q)$ for each $q \geq 1$, where x_q is the center of the ball and ρ_q its radius. For each $s \geq 1$, we set $W_s = B(0, 2^{-s})$, so that $(W_s)_{s \geq 1}$ is a basis of neighborhoods of 0 in X. Set also $\mathcal{U}_q = B(x_q, \frac{1}{2})$ X. Set also $\mathcal{U}_q = B(x_q, \frac{1}{2}\rho_q)$ and $\mathcal{W}_s = B(0, 2^{-(s+1)})$, so that $\overline{\mathcal{U}}_q \subseteq U_q$ and $\overline{\mathcal{W}}_s \subset W_s$. Let U_q , $U_{r_l}, W_{s_l}, m_{0,l}, m_{1,l}$ $\}_{l \geq 1}$ be an enumeration of all the tuples (U, V, W, m_0, m_1) , where U and V belong to the set $\{U_q : q \geq 1\}$, W belongs to the set $\{W_s : s \geq 1\}$, and (m_0, m_1) is a pair of positive integers with $m_0 < m_1$.

Proceeding as in the proof of Theorem 1.1, we consider the set

$$
G_M(X) = \{ T \in \mathcal{B}_M(X) \; ; \forall l \geq 1, \; \exists u_l \in U_q, \; \exists k_l \geq 1 \text{ such that } T^{k_l} (u_l^{m_{0,l}}) \in U_{r_l}
$$

and
$$
T^{k_l} (u_l^n) \in W_{s_l} \text{ for every } n \text{ with } m_{0,l} < n \leq m_{1,l} \}.
$$

Using the fact that all the maps $T \mapsto T^k$, $k \geq 1$, from $(\mathcal{B}_M(X), SOT)$ into $\mathcal{B}(X)$ are continuous [17, Lemma 2.1], it is easy to show that $G_M(X)$ is a G_δ set in $(\mathcal{B}_M(X), SOT)$. By [3, Corollary 2.4] (or by Lemma 5.2 in Section 5 above), every operator belonging to $G_M(X)$ admits a hypercyclic algebra. In order to show that the property of having a hypercyclic algebra is typical in $(\mathcal{B}_M(X), SOT)$, it thus suffices to show that $G_M(X)$ is SOT-dense in $\mathcal{B}_M(X)$.

Let d be a distance on $\mathcal{B}_M(X)$ which induces the SOT and turns $\mathcal{B}_M(X)$ into a complete separable metric space. The main step in order to show the density of $G_M(X)$ in $(\mathcal{B}_M(X),$ SOT) is the following lemma.

Lemma 6.1. Let $S \in \mathcal{B}_M(X)$ with $||S|| < M$, and let $\varepsilon > 0$. Let also U and V be two nonempty open subsets of X, let W be an open neighborhood of 0, and let $m_0 < m_1$ be two positive integers. Then there exists an operator $T \in \mathcal{B}_M(X)$ with $||T|| < M$, an integer $k \geq 1$ and a vector $b \in X$ such that:

(a) $d(T, S) < \varepsilon$;

(b)
$$
b \in \mathcal{U}
$$
;

(b) $b \in l$
(c) T^k (b^{m_0} $\in \mathcal{V}$ and $\forall m_0 < n \leqslant m_1$, T^k (b^n) $\in \mathcal{W}.$

Proof. Denote by $(e_n)_{n\geq 0}$ the canonical basis of X, and let $E_N := [e_0, e_1, \ldots, e_N]$ be the linear span of the first $N + 1$ basis vectors in $X, N \geq 0$. Let also P_N denote the canonical projection of X onto E_N , and set $S_N = P_N SP_N$. We have $||S_N|| \le ||S|| < M$. Let $\delta > 0$ and $\gamma > 0$ be such that max $(1, \|S\| + \delta) < M - \gamma < M$.

Setting $M' := M - \gamma$, we consider the operator T acting on X defined by

$$
Te_n = \begin{cases} S_N e_n, & \text{for } 0 \leqslant n \leqslant N \\ \delta e_{n-(N+1)}, & \text{for } N+1 \leqslant n \leqslant 2N+1 \\ M' e_{n-(N+1)}, & \text{for } n > 2N+1. \end{cases}
$$

Then T is a bounded operator on X with $||T|| = M' < M$. Moreover, T can be made as close to S as we wish with respect to the SOT, provided that N is chosen sufficiently large. We fix N so large that $d(T, S) < \frac{\varepsilon}{2}$.

Operators of this form were introduced in [17, Proposition 2.10], where it is shown that for every complex number λ with $|\lambda| < M'$, the eigenspace ker $(T - \lambda I)$ is $(N + 1)$ dimensional. Whenever Λ is a subset of the open disk $D(0, M') \subset \mathbb{C}$, which has an accumulation point in $D(0, M')$, the eigenspaces ker $(T - \lambda I)$, $\lambda \in \Lambda$, span a dense linear subspace of X . In particular, the vector space

$$
H_{-}(T) \coloneqq \text{span}\left[\ker(T - \lambda I)\,;\; |\lambda| < 1\right]
$$

is dense in X. For every $k \geq 1$ and every $n \geq 0$, we have:

(6.1)
$$
T^{k}e_{k(N+1)+n} = \begin{cases} M'^{k-1}\delta e_n, & \text{if } 0 \leq n \leq N\\ M'^{k}e_n, & \text{if } n > N. \end{cases}
$$

We choose a vector $z \in \mathcal{U}$, with finite support, which we write as $z = \sum_{i=1}^{N}$ $\gamma_{j=0}^J \gamma_j e_j.$ Since $H_-(T)$ is dense in X, there exists for each $0 \leq j \leq J$ a vector $f_j \in H_-(T)$ with $||f_j - e_j|| < \frac{\delta_1}{J+1}$, where $0 < \delta_1 < \varepsilon$ is sufficiently small (how small will be specified in the $||J_j - e_j|| \leq \frac{1}{J+1}$, where α
sequel). Letting $u = \sum_{i=1}^{J}$ $\int_{j=0}^{J} \gamma_j f_j$, for δ_1 sufficiently small, u belongs to U. We now set for every $n \geq 1$

(6.2)
$$
\widetilde{u}^{*n} := \sum_{j=0}^{J} \gamma_j^n f_j.
$$

Observe that \tilde{u}^{*n} belongs to $H_{-}(T)$ for every $n \geq 1$, so that

$$
\left\|T^k\widetilde{u}^{*n}\right\| \longrightarrow 0 \quad \text{as} \quad k \longrightarrow +\infty.
$$

We have $\widetilde{u}^{*1} = u$.

Let now v be a vector belonging to V, of the form $v = \sum_{i=1}^{d}$ $\sum_{i=0}^{d} \alpha_i e_i$, with $d > N$. For every $k \geqslant 1$, we set

(6.3)
$$
v^{(k)} := \sum_{i=0}^{N} \left(\frac{\alpha_i}{M'^{k-1}\delta}\right)^{1/m_0} e_{k(N+1)+i} + \sum_{i=N+1}^{d} \left(\frac{\alpha_i}{M'^{k}}\right)^{1/m_0} e_{k(N+1)+i}.
$$

Since $M' > 1$, we have

$$
\left\|v^{(k)}\right\| \longrightarrow 0 \quad \text{as} \quad k \longrightarrow +\infty.
$$

For $n = m_0, m_0 + 1, ..., m_1$ we have

$$
[v^{(k)}]^n = \sum_{i=0}^N \left(\frac{\alpha_i}{M'^{k-1}\delta}\right)^{n/m_0} e_{k(N+1)+i} + \sum_{i=N+1}^d \left(\frac{\alpha_i}{M'^k}\right)^{n/m_0} e_{k(N+1)+i}
$$

(recall that the product considered on X is the coordinatewise product with respect to (recall that the product considered on X is the coordinatewise product with respect t
the canonical basis). We thus have $T^k[v^{(k)}]^{m_0} = v$ by (6.1). Since $M' > 1$, we also have

$$
\left\| \left[v^{(k)} \right]^{m_0} \right\| \longrightarrow 0 \quad \text{as} \quad k \longrightarrow +\infty.
$$

On the other hand, if $m_0 < n \leq m_1$, we have

$$
T^{k}[v^{(k)}]^{n} = \sum_{i=0}^{N} \left(\frac{\alpha_{i}}{M'^{k-1}\delta}\right)^{n/m_{0}} M'^{k-1}\delta e_{i} + \sum_{i=k+1}^{d} \left(\frac{\alpha_{i}}{M'^{k}}\right)^{n/m_{0}} M'^{k} e_{i}
$$

by (6.1) . So

$$
T^{k}[v^{(k)}]^{n} = \sum_{i=0}^{N} \alpha_i^{n/m_0} \cdot \frac{1}{(M'^{k-1}\delta)^{n/m_0-1}} \cdot e_i + \sum_{i=N+1}^{d} \alpha_i^{n/m_0} \cdot \frac{1}{(M'^{k})^{n/m_0-1}} \cdot e_i
$$

and since $\frac{n}{m_0} - 1 > 0$, we obtain that

$$
\left\|T^k\big[v^{(k)}\big]^n\right\| \longrightarrow 0 \quad \text{as} \quad k \longrightarrow +\infty \quad \text{for every} \quad m_0 < n \leq m_1.
$$

Summarising, we have shown that

(6.4)
$$
u + v^{(k)} \longrightarrow u \quad \text{as } k \longrightarrow +\infty
$$

(6.5)
$$
T^k(\tilde{u}^{*m_0} + [v^{(k)}]^{m_0}) \longrightarrow v
$$
 as $k \longrightarrow +\infty$

(6.6)
$$
T^{k}(\tilde{u}^{*n} + [v^{(k)}]^{n}) \longrightarrow 0 \quad \text{as } k \longrightarrow +\infty \quad \text{for every } m_{0} < n \leq m_{1}.
$$

We now define a bounded operator L on X by setting

$$
Le_j = \begin{cases} f_j, & \text{if } 0 \leq j \leq J \\ e_j, & \text{if } j > J. \end{cases}
$$

Then we have

$$
||Lx - x|| = \left\| \sum_{j=0}^{J} x_j (f_j - e_j) \right\| \le \max_{0 \le j \le J} |x_j| \sum_{j=0}^{J} ||f_j - e_j|| \le \delta_1 \cdot ||x|| \text{ for every } x \in X,
$$

so that $||L - I|| \le \delta_1 < \varepsilon$. If $0 < \delta_1 < 1$, L is invertible, and

$$
||L^{-1} - I|| \le \frac{\delta_1}{1 - \delta_1} \le 2\delta_1
$$

as soon as $0 < \delta_1 < 1/2$. Let now $x_k = u + v^{(k)}$ and $y_k = L^{-1}(u + v^{(k)})$. If k is sufficiently large, the support of $v^{(k)}$ is disjoint from the interval $[0, J]$. We have

$$
y_k = \sum_{j=0}^{J} \gamma_j e_j + \sum_{i=0}^{N} \left(\frac{\alpha_i}{M'^{k-1}\delta}\right)^{1/m_0} e_{k(N+1)+i} + \sum_{i=N+1}^{d} \left(\frac{\alpha_i}{M'^k}\right)^{1/m_0} e_{k(N+1)+i}
$$

so that for every $n \geq 1$.

$$
y_k^n = \sum_{j=0}^J \gamma_j^n e_j + \sum_{i=0}^N \left(\frac{\alpha_i}{M'^{k-1}\delta}\right)^{n/m_0} e_{k(N+1)+i} + \sum_{i=N+1}^d \left(\frac{\alpha_i}{M'^k}\right)^{n/m_0} e_{k(N+1)+i}.
$$

It follows that

(6.7) $L(y_k^n) = \tilde{u}^{*n} +$ " $[v^{(k)}]$ ⁿ for all k sufficiently large.

By (6.4) , (6.5) , and (6.6) , combined with (6.7) , we have, as k goes to infinity,

(6.8)
$$
x_k \longrightarrow u \text{ and } y_k \longrightarrow L^{-1}u
$$

$$
T^k L(y_k^{m_0}) \longrightarrow v
$$

$$
T^k L(y_k^n) \longrightarrow 0 \text{ for every } m_0 < n \le m_1.
$$

Set now $T_1 := L^{-1}TL$. Then

$$
||T_1 - T|| = ||L^{-1}TL - T|| \le ||L^{-1}T(L - I)|| + ||(L^{-1} - I)T||
$$

\n
$$
\le ||T|| \delta_1 (1 + 2\delta_1) + ||T|| \cdot 2\delta_1 < 4||T|| \delta_1,
$$

so that $||T_1|| < M$ and $d(T_1, T) < \frac{\varepsilon}{2}$, provided that δ_1 is sufficiently small. We also deduce from the properties above that, as k goes to infinity,

$$
(6.9) \t T_1^k(y_k^{m_{0,1}}) \longrightarrow L^{-1}v
$$

(6.10) $T_1^k(y_k^n) \longrightarrow 0$ for every $m_0 < n \leq m_1$.

Now, $L^{-1}u = z$ belongs to U and if δ_1 is sufficiently small, $L^{-1}v$ belongs to V. If we choose k sufficiently large, and then set $b = y_k$, we eventually obtain that $b \in \mathcal{U}$ (by (6.8)), $T_1^k(b^{m_0}) \in \mathcal{V}$ (by (6.9)), and $T_1^k(b^n) \in \mathcal{W}$ for every $m_0 < n \leq m_1$ (by (6.10)) which is exactly what is required by Lemma 6.1.

Returning to the proof of Theorem 1.2, we now consider an operator $S \in \mathcal{B}_M(X)$ with $||S|| < M$, and $\varepsilon > 0$. Our aim is to construct an operator $T \in G_M(X)$ with $d(T, S) < \varepsilon$. $||S|| < M$, and $\varepsilon > 0$. Our aim is to construct an operator $T \in G_M(X)$ with $d(T, S) < \varepsilon$.
Let $(\varepsilon_l)_{l \geq 1}$ be a sequence of positive numbers such that $\sum_{l \geq 1} \varepsilon_l < \varepsilon$. Using Lemma 6.1, we can construct by induction on $l \geq 1$

- a sequence $(T_l)_{l\geq0}$ of operators on X, with $T_0 = S$,
- a sequence $(b_l)_{l\geqslant1}$ of vectors of X,
- a sequence $(k_l)_{l\geq 1}$ of positive integers

such that for every $l \geq 1$,

(a)
$$
d(T_l, T_{l-1}) < \varepsilon_l
$$
;
\n(b) $b_l \in \mathcal{U}_{q_l} \subseteq U_{q_l}$;
\n(c) $\forall 1 \le l' \le l$, $T_l^{k_{l'}}(b_{l'}^{m_{0,l'}}) \in \mathcal{U}_{r_{l'}}$ and $\forall m_{0,l'} < n \le m_{1,l'}$, $T_l^{k_{l'}}(b_{l'}^n) \in \mathcal{W}_{s_{l'}}$.

The fact that we can ensure, at each step $l \geq 1$, that condition (c) holds for every $1 \leq l' \leq l$, and not only for l, relies on the observation that the maps $T \mapsto T^k$, $k \geq 1$, are SOT-continuous from $\mathcal{B}_M(X)$ into $\mathcal{B}(X)$. Thus if T_l is constructed sufficiently close to T_{l-1} , i.e. if $d(T_l, T_{l-1})$ is sufficiently small, our induction assumption implies that (c) is true for every $1 \leq l' < l$.

Since $(\mathcal{B}_M(X), d)$ is a complete metric space, the sequence of operators $(T_l)_{l\geq 1}$ converges in $(\mathcal{B}_M(X), d)$ to an operator $T \in \mathcal{B}_M(X)$ such that $d(T, S) < \varepsilon$. Moreover, letting l tend to infinity in (c) above, and using again the **SOT**-continuity of the maps $T \mapsto T^k$, we obtain that for all $l \geq 1$, $T^{k_l} (b_l^{m_{0,l}})$ $\left(\overline{\mathcal{U}}_{n_l}\right)\in\overline{\mathcal{U}}_{r_l}\subseteq U_{r_l}, \text{ and }T^{k_l}\left(b_l^n\right)\in\overline{\mathcal{W}}_{s_{l'}}\subseteq W_{s_l} \text{ for all }m_{0,l}$ Hence T belongs to $G_M(X)$.

We have thus proved that $G_M(X)$ is dense in $(\mathcal{B}_M(X), SOT)$. This finishes the proof of Theorem 1.2. \Box

There are other interesting topologies which can turn the operator balls $\mathcal{B}_M(X)$ into Polish spaces. One of the most relevant is the so-called Strong* Operator Topology (SOT*): if (T_α) is a net of operators in $\mathcal{B}(X)$, $T \in \mathcal{B}(X)$ and $T^* \in \mathcal{B}(X^*)$ is the adjoint of T, then we say that

 $T_{\alpha} \xrightarrow{\text{SOT}^*} T$ if and only if $T_{\alpha} \xrightarrow{\text{SOT}} T$ in X and $T_{\alpha}^* \xrightarrow{\text{SOT}} T^*$ in X^* .

When X is a Banach space with separable dual, the balls $\mathcal{B}_M(X)$, $M > 0$, are Polish spaces when endowed with the SOT^* topology. See the works $[12]$, $[17]$, $[18]$, $[19]$, and $[16]$ for a study of typical properties of operators for the SOT^* , as well as explanations on the relevance of this topology.

Theorem 1.2 admits the following analogue for the SOT^{*} topology.

Theorem 6.2. Let $X = \ell_p(\mathbb{N})$, $1 < p < +\infty$, or $X = c_0(\mathbb{N})$, endowed with the coordinatewise product. Let $M > 1$. A typical operator $T \in (\mathcal{B}_M(X), SOT^*)$ admits a hypercyclic algebra.

Proof. The proof is similar to that of Theorem 1.2. Since the set $G_M(X)$ is SOT- G_δ , it is also SOT^* - G_δ . And a look at the proof of Theorem 1.2 shows that $G_M(X)$ is in fact SOT^{*}-dense in $\mathcal{B}_M(X)$.

We say that $T \in \mathcal{B}(X)$ is dual hypercyclic if both T and its adjoint T^* are hypercyclic. The first examples of such operators were obtained by Salas [26,27] and Petersson [25], and it is an immediate consequence of the remark after [17, Proposition 2.3] (see also [16, Fact 2.1]) that when $X = \ell_p(\mathbb{N})$, $1 < p < +\infty$, or $X = c_0(\mathbb{N})$, an SOT^{*}-typical $T \in \mathcal{B}_M(X)$ is dual hypercyclic. Using the same argument, we can deduce from Theorem 6.2 the following result.

Proposition 6.3. If $X = \ell_p(\mathbb{N})$, $1 < p < +\infty$, or $X = c_0(\mathbb{N})$, and $M > 1$, a typical operator $T \in (\mathcal{B}_M(X), \text{SOT}^*)$ is such that both T and T^* admit a hypercyclic algebra (with respect to the coordinatewise product).

The existence of $T \in \mathcal{B}(X)$ such that both T and T^* admit a hypercyclic algebra can also be deduced directly from [3, Corollary 4.11] and [26].

7. Typicality of Admitting a Hypercyclic Subspace

Let X be a complex separable infinite-dimensional Banach space. Our aim in this final section is to study whether, given $M > 1$, a typical operator $T \in (\mathcal{B}_M(X), SOT)$ admits a closed infinite-dimensional hypercyclic subspace. When it makes sense, we also consider this question for $T \in (\mathcal{B}_M(X), SOT^*)$.

For a hypercyclic operator $T \in \mathcal{B}(X)$, a hypercyclic subspace is defined as a closed infinite-dimensional subspace $Z \subseteq X$ such that every nonzero vector in Z is hypercyclic for T. Since the early work of Bernal González and Montes-Rodríguez $[6]$, the investigation of hypercyclic subspaces has amassed a vast literature, as documented in $[4,$ Chapter 8 and [20, Chapter 10]. In contrast to the generic property that the set $HC(T) \cup \{0\}$ always contains a dense linear manifold of hypercyclic vectors, it turns out that there exist hypercyclic operators that do not admit a hypercyclic subspace. Examples of operators that support hypercyclic subspaces in the Fréchet space setting include the differentiation and translation operators acting on the space $H(\mathbb{C})$ of entire functions (cf. [20, Examples 10.12 and 10.13]). For the Banach spaces $X = \ell^p(\mathbb{N})$, $1 \leq p < \infty$, or $X = c_0(\mathbb{N})$, a weighted backward shift $B_w \in \mathcal{B}(X)$ admits a hypercyclic subspace if

$$
\sup_{n\geq 1} \prod_{j=1}^n |w_j| = +\infty \text{ and } \sup_{n\geq 1} \limsup_{k\to\infty} \prod_{j=1}^n |w_{j+k}| < +\infty,
$$

cf. [20, Example 10.10]. However, it is well known that scalar multiples cB of the backward shift for $|c| > 1$ do not possess hypercyclic subspaces (cf. [20, Example 10.26]).

The following characterization of operators that satisfy the Hypercyclicity Criterion and admit a hypercyclic subspace was identified by León-Saavedra and Montes-Rodríguez [23] in the Hilbert space setting, and by González et al. in $[15]$ for separable complex Banach spaces.

Theorem 7.1 ([15], [23]). Let X be a separable complex Banach space. Suppose that $T \in \mathcal{B}(X)$ satisfies the Hypercyclicity Criterion. The following assertions are equivalent.

- (i) T possesses a hypercyclic subspace.
- (ii) There exists some closed infinite-dimensional subspace $Z_0 \subseteq X$ and an increasing sequence of integers (n_k) such that $T^{n_k}x \to 0$ for all $x \in Z_0$.
- (iii) There exists some closed infinite-dimensional subspace $Z_0 \subseteq X$ and an increasing sequence of integers (n_k) such that $\sup_k ||T^{n_k}_{Z_n}||$ $\frac{m_k}{|Z_0|}$ | $< \infty$.
- (iv) The essential spectrum $\sigma_{\rm e}(T)$ of T intersects the closed unit disk.

We recall that an operator $T \in \mathcal{B}(X)$ is said to be Fredholm if both the dimension of its kernel dim ker (T) and the codimension of its range codim ran (T) are finite. Equivalently, T is Fredholm if and only if it has closed range and dim ker $(T) < \infty$ and dim ker $(T^*) < \infty$. The essential spectrum $\sigma_{\rm e}(T)$ of the operator $T \in \mathcal{B}(X)$ is defined to be

$$
\sigma_{\mathbf{e}}(T) \coloneqq \{ \lambda \in \mathbb{C} : T - \lambda \text{ is not Fredholm} \}.
$$

The following theorem is a straightforward consequence of results from [17] and [18].

Theorem 7.2. Let $X = \ell_p(\mathbb{N}), 1 \leq p < +\infty$, or $X = c_0(\mathbb{N}).$ For every $M > 1$, a typical $T \in (\mathcal{B}_M(X), \text{SOT})$ admits a hypercyclic subspace.

Proof. An elementary adaptation of the proofs of [17, Proposition 2.3] and [17, Proposition 2.16] shows that a typical operator $T \in (\mathcal{B}_M(X), SOT)$ satisfies the Hypercyclicity Criterion. It thus suffices to show that the essential spectrum of a typical $T \in (\mathcal{B}_M(X), SOT)$ is equal to the closed disk $\overline{D}(0, M)$. As observed in [18, Remark 4.5], it follows from [12, Lemma 5.13] that a typical $T \in (\mathcal{B}_M(X), SOT)$ is not Fredholm. Consider now the set

$$
\mathcal{A} \coloneqq \{T \in \mathcal{B}_M(X) \, ; \, \forall \lambda \in D(0, M), \, T - \lambda \text{ is surjective}\}.
$$

By the topological $0 - 1$ law [18, Proposition 3.2], A is either meager or comeager in $(\mathcal{B}_M(X),$ SOT $).$

– Suppose first that A is SOT-comeager in $(\mathcal{B}_M(X), SOT)$ (which is known to happen when $X = \ell_1(\mathbb{N})$ or when $X = \ell_2(\mathbb{N})$. Since a typical $T \in (\mathcal{B}_M(X), SOT)$ is not Fredholm, the continuity of the Fredholm index on $D(0, M)$ implies that for all $\lambda \in D(0, M)$, $T - \lambda$ is not Fredholm (see the argument just before Remark 4.5 in [18]). Hence $\sigma_{\rm e}(T) = \overline{D}(0, M)$.

– Suppose now that A is SOT-meager in $(\mathcal{B}_M(X), SOT)$ (which is known to happen when $X = \ell_p(\mathbb{N})$ for $p > 2$). As the set of operators $T \in (\mathcal{B}_M(X), SOT)$ such that $T - \lambda$ has dense range for every $\lambda \in D(0, M)$ is comeager in $(\mathcal{B}_M(X), SOT)$ (cf. [18, Proposition 3.9]), a typical $T \in (\mathcal{B}_M(X), SOT)$ is such that for every $\lambda \in D(0, M), T - \lambda$ does not have closed range. Hence $T - \lambda$ is not Fredholm, and $\sigma_{\rm e}(T) = \overline{D}(0, M)$.

The following shows that we have a similar statement for SOT^* -typical operators.

Theorem 7.3. Let $X = \ell_p(\mathbb{N})$, $1 < p < +\infty$. For every $M > 1$, a typical $T \in$ $(\mathcal{B}_M(X), \text{SOT}^*)$ admits a hypercyclic subspace.

Proof. This is a direct consequence of the fact that a typical operator $T \in (\mathcal{B}_M(X), SOT^*)$ satisfies the Hypercyclicity Criterion, and of [16, Theorem 3.1], which states that a typical $T \in (\mathcal{B}_M(X), \text{SOT}^*)$ is such that $\sigma_{\text{e}}(T) = \overline{D}(0, M)$.

We can also deduce from Theorem 7.3 the following result.

Proposition 7.4. Let $X = \ell_p(\mathbb{N})$, $1 < p < +\infty$. For every $M > 1$, a typical operator $T \in (\mathcal{B}_M(X), \text{SOT}^*)$ is such that T and its adjoint T^* both admit hypercyclic subspaces.
