Hierarchical equations of motion are a powerful tool to describe **quantum systems in interaction** with an **environment** (also called a bath).



They are particularly useful to describe some physicochemical processes:

- electron or proton transfers
- **excitation transfer** in photosynthetical complexes
- conical intersections

and are used to compute

- linear and non-linear spectroscopies
- laser optimal control
- **non-equilibrium fluxes** in molecular junctions.

Hierarchical equations of motion are a powerful tool to describe **quantum systems in interaction with an environment** (also called a bath).



The bath can be a bath of phonons, electrons, photons and can include some thermodynamical aspects.

They are particularly useful to describe some physicochemical processes:

- electron or proton transfers
- excitation transfer in photosynthetical complexes
- conical intersections

and are used to compute

- linear and non-linear spectroscopies
- laser optimal control
- **non-equilibrium fluxes** in molecular junctions.

Let's begin with the simplest model Hamiltonian, the spin-boson model.

$$H = \begin{pmatrix} 0 & V_{DA} \\ V_{DA} & \Delta E \end{pmatrix} + \frac{1}{2} \begin{pmatrix} \sum_{i=1}^{N} p_i^2 + \omega_i^2 q_i^2 & 0 \\ 0 & \sum_{i=1}^{N} p_i^2 + \omega_i^2 (q_i - d_i)^2 \end{pmatrix}$$

Electronic states

A system-bath partition arises here between the electronic states and the nuclei degrees of freedom:

Schrödinger equation is reversible. Irreversible processes seems *a priori* forbidden. However, if the state of the overall system is reversible, we only observe **a small subsystem** which **appears irreversible**.

Coherence arises from the wave-like nature of the matter. But many quantum phenomena do not remain at a macroscopic scale.

Interaction representation

The system-bath Hamiltonian can be split :

$$H = \underbrace{H_0}_{H_S + H_B} + S.B$$

We define the density matrix in interaction representation as:

$$\rho_I(t) = e^{iH_0t/\hbar}\rho(t)e^{-iH_0t/\hbar}$$

In interaction representation,

Due to the special shape of the system-bath Hamiltonian (harmonic oscillators with linear coupling), time evolution of the reduced system density matrix with initial system-bath factorization writes in interaction representation as an **exact second order cumulant expansion** :

How do we have access to the bath correlation function ?



 $B(t) = e^{iH_B t} B e^{-iH_B t}$

The key ingredient is the system-bath correlation function: $C(t-\tau) = Tr_B[B(t)B(\tau)\rho_B^{eq}]$

Let's write the harmonic oscillators coordinates and momentum with ladder operators :

Elimination of the bath

The bath correlation function writes as:

$$C(t-\tau) = \sum_{l=1}^{M} \frac{c_l^2}{2\omega_l} e^{-i\omega_l(t-\tau)} \frac{1}{1-e^{-\beta\omega_l}} + \sum_{l=1}^{M} \frac{c_l^2}{2\omega_l} e^{i\omega_l(t-\tau)} \frac{1}{e^{\beta\omega_l}-1}$$

We define the spectral density as :

$$J(\omega) = \frac{\pi}{2} \sum_{l=1}^{M} \frac{c_l^2}{\omega_l} \delta(\omega - \omega_l) \qquad \qquad \text{for} \quad \omega \in [0, +\infty[$$
with an odd parity $J(-\omega) = -J(\omega)$

If we assume a continuous distribution of modes,

$$C(t-\tau) = \frac{1}{\pi} \int_0^{+\infty} d\omega J(\omega) e^{-i\omega(t-\tau)} \frac{1}{1-e^{-\beta\omega}} + J(\omega) e^{i\omega(t-\tau)} \frac{1}{e^{\beta\omega} - 1}$$

Fluctuation-dissipation relation
$$C(t-\tau) = \frac{1}{\pi} \int_{-\infty}^{+\infty} d\omega e^{i\omega(t-\tau)} \frac{J(\omega)}{e^{\beta\omega} - 1}$$

Spectral density

If we know the spectral density, we can compute the bath correlation function.

$$J(\omega) = \frac{\pi}{2} \sum_{l=1}^M \frac{c_l^2}{\omega_l} \delta(\omega - \omega_l) \quad \text{with an odd parity} \quad J(-\omega) = -J(\omega)$$

The spectral density can be a mere phenomenological model

Diabatic electronic gap:

The diabatic electronic gap probes the $\Delta E(t) = \Box$ - \Box fluctuation of the bath and might be obtained with classical trajectories $\Delta E(t) = \Delta + \lambda - \sum_{i=1}^{M} \omega_i^2 d_i q_i(t)$

The autocorrelation function of the diabatic gap gives a classical analogue to the system-bath correlation function :

Tensor train decomposition

Realistic chemical systems might exhibit large system bath coupling and the values of the indices n_1, n_2, \dots, n_K can be very high to converge HEOM set of equations: $n_{HEOM} = \max[\sum_{k=1}^{K} n_k] \gg 1$

As suggested by Q. Shi (2018) and later R.Borrelli (2019), for these high dimensional cases, one can resort to tensor train decomposition (also known as MPS (Matrix Product State) in the physics community):

Why such decomposition is interesting?

As a (non-realistic) test case, let's consider a tensor decomposition with the same number n_k and the same ranks r, for d dimensions:

 $n \times r \times 2 + n \times r^2 \times (d-2)$ elements

Linear increase with the tensor dimension Storage does not grow exponentially if ranks are low.

Tensor train decomposition HEOM

For the HEOM set of equations, we can decompose all the density matrices (system + auxiliary) as :



$$\dot{\rho}_{\mathbf{n}}^{\bar{\alpha}} = \mathcal{L}\rho_{\mathbf{n}}^{\bar{\alpha}}$$
 with a super Liouvillian operator: $\mathcal{L} = \mathcal{L}_S + \sum_{k'=1}^{K} \left(\mathcal{L}_{k'} + \mathcal{L}_{k'+} + \mathcal{L}_{k'-}\right)$

which can be « easily » defined in TT representation
