Additions to the corpus of the ‘heifer’ *aurei* (RIC Augustus I² 536–538)

(4 Figures)

I wish to publish here some corrections and additions to the article which I published with Alan Walker some years ago (Rambach – Walker 2012).¹

Amendments

Specimen 1.3: This example was bequeathed to the Paris Cabinet des Médailles in 1913 by Anne-Léontine Smith (1839–1912) who had inherited it from her brother Alexandre-Auguste Lesouëf (1829–1906). The coin had formerly belonged to the collection of count Albéric du Chastel de la Howardries (1842–1919) and had been sold in May 1889.² Lesouëf had probably acquired it in the 1902 auction of the collection of the notary Octave Trousselle.³

It is very noteworthy, considering how few examples there are of heifer *aurei*, that Count du Chastel owned two specimens (1.3 and 4.5).

Specimen 1.6: We had written that the E.S.R. collection, sold at Hess-Leu (auction XVII on 23 March 1961), was that of Erich Alex von Schulthess-Rechberg (1914–1986), but others raised the possibility that it was instead the collection of Sir Edward Stanley Robinson (1887–1976). Alan Walker and I stand by our original indication.

Specimen 1.7: The Geldmuseum in Utrecht has since closed, and the coin is now preserved in Amsterdam, Dutch National Numismatic Collection – De Nederlandsche Bank, with the same inventory no. 1929-0077.

Specimen 1.F: This coin in the British Museum, which is genuine, was mistakenly numbered “1.F” in the text, though its correct number is “1.11” (as shown on the plates).⁴

Specimen 2.1: This example that had been sold to Tradart (Michel-Max Bendenoun) at the 1989 N.F.A. auction, was bought by Spink in the Leu 1993 sale on behalf of Gerald Hoberman (1943–2013).⁵ The coin was since sold again, in September 2014.⁶

Specimen 3.2: This example belonged to Friedemann Heinrich Christian Ludwig Schelhaß von Schellersheim (1752–1836), and was described in Uhden 1800, p. 14. All of Schellersheim's gold coins were acquired for their weight of gold (cf. my forthcoming article) in May 1825 by the Rothschild family and inherited by Wilhelm Carl von Rothschild (1828–1901), whose daughter Adelheid presented them to the Paris coin cabinet in 1934 (archive no. MS 127).⁷

Specimen 4.2: The example in the British Museum was simply recorded as having been given in 1864 by Edward Wigan (1823–1871). An article by Jean-Baptiste Giard indicates in fact that Wigan had obtained it from Prosper Dupré (1771–1866),⁸ who had acquired it (probably directly) from Edouard Lelièvre de La Grange (1796–1876), who had bought 189 of the 196 *aurei* found during summer 1834 by a blacksmith in Ambeau (Normandy, France), who immediately had sold them to a local watchmaker.⁹ The coin was published in Madden 1865, p. 20 no. 21 and recently Johns 2011, p. 122.

Specimen 5.1: This example has since been illustrated in Pangerl 2017, p. 32 fig. 48, and p. 249 fig. 727.

Specimen 6.2: This example, which I had bought on behalf of George W. La Borde (b. 1944), was sold in May 2016.¹⁰ The coin had been previously published in Elberling 1863, p. 137 no. 1.

New examples

Specimen 1. forgery 2: A (fake) example was offered by Art Coins Roma in October 2014.¹¹ It is struck with the dies O.4 and R.5, measures 19 mm diameter, weighs 7.89 grams, and shows a 12:00 die-axis.

Specimen 1.13: This example was sold in May 1982 to a German dealer (Fig. 1),¹² and it reappeared at auction in October 1992.¹³ It is struck with the dies O.1 and R.2, its diameter and die-axis are unknown, and it weighs 7.93 grams.

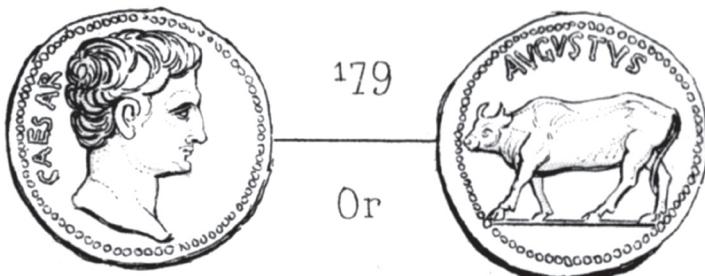


Fig. 2: Specimen 1.14

Specimen 1.14: This example, from the collection of Auguste de Belfort (1824–1907),¹⁴ was sold in February 1888.¹⁵ It is struck with the dies O.1 and possibly R.2, its diameter,

weight and die-axis are unknown.¹⁶ Its appearance is fortunately preserved by a precise engraving by Léon Dardel (Fig. 2).¹⁷

Specimen 1.15: This example was sold on 20 May 2015 (Fig. 3).¹⁸ It is struck with the dies O.2 and R.4, and weighs 7.96 grams.

Two auction references for the type I must be added: there was one specimen in the collection of the judge Gennaro Riccio (before 1836 – before 1874), auctioned in 1868,¹⁹ and there was one specimen in the collection of Adélaïde Edouard Le Lièvre, marquis de La Grange (1796–1876), auctioned in 1877.²⁰ Neither catalogues were illustrated, so they cannot be identified amongst (or in addition) to our known examples.²¹

Specimen 4.5: This example is preserved in Brussels, at the Cabinet des Médailles de la Bibliothèque royale de Belgique (cf. article von Mosch, Abb. 4). It comes from the collection of Count Albéric du Chastel de la Howardries (1842–1919) and was published in Callataÿ – van Heesch 1999, no. 367. It is struck with the dies O.6 and R.7, measures 18.5 mm diameter, weighs 7.98 grams, and shows a 12.00 die-axis.

Specimen 4.6: This example, from the collection of Prospero Sarti (1854–1904), was anonymously sold by Jacob Hirsch, Munich, in his auction VIII, 18 May 1903 and following days, lot 2138 (Fig. 4).²² It is struck with the dies O.6 and R.7, its diameter, weight and die-axis are unknown.

Finally, on the bronze statuette – preserved in the Paris cabinet and formerly found in Herculaneum – in which the count of Caylus wanted to recognize Myron's cow, I wish

reports them as provenance: once more a proof that the absence of known provenance is no proof of the absence of provenance.

to refer to the article by François Chamoux, who refuses to recognize Myron's cow even as a model, because the quality is too high to be a copy rather than a creation.²³ On the contrary, the large marble sculpture (185 cm wide and 99 cm high) preserved in Rome (Centrale Montemartini, inv. no. 921) since its discovery on the Esquiline, is presented by Brunella Germini and Jean-Charles Balty as undoubtedly a replica of Myron's original.²⁴
