22	Abstract
23	Malaria is a life-threatening tropical disease caused by parasites of the genus
24	Plasmodium, of which P. falciparum is the most lethal. Malaria parasites have a
25	complex life cycle, with stages occurring in both the Anopheles mosquito vector and
26	human host. Ring stages are the youngest form of the parasite in the intraerythrocytic
27	developmental cycle and are associated with evasion of spleen clearance, temporary
28	growth arrest, and drug resistance. This formidable ability to survive and develop into
29	mature, sexual, or growth-arrested forms demonstrates the inherent population
30	heterogeneity. This review highlights the role of the ring stage as a crossroads in
31	parasite development and as a reservoir of surviving cells in the human host via

temporary growth arrest survival mechanisms.

35 *Plasmodium falciparum* antimalarial drug resistance

Malaria is a major public health issue in tropical countries and a potentially fatal disease caused by protozoan parasites from the genus *Plasmodium* [1,2]. Among the six *Plasmodium spp.* that infect humans, *P. falciparum* is responsible for most severe cases. Globally, an estimated 247 million malaria cases were recorded in 2021, leading to 619,000 deaths, primarily in sub-Saharan Africa [2].

Efforts to eliminate malaria have been strengthened and intensified with the support
of the World Health Organization (WHO) [2]. Novel and complementary interventions
have been implemented, including the distribution of long-lasting insecticide-treated

44 nets, prompt diagnosis, and effective treatments such as artemisinin combination

45 therapies (ACTs). Currently, ACTs are important for controlling malaria morbidity and

46 mortality in endemic countries. However, progress has been stalled, and the number

47 of cases is estimated to have increased in recent years [2]. A major contributor is the

48 increasing resistance of malaria parasites to most available antimalarial drugs [2].49

50 This review aims to summarize our current knowledge of the classical mechanisms

51 of drug resistance based on genetic modification and to emphasise alternative

52 survival strategies relying on growth arrest phenotypes, especially in the parasite

53 ring stage.

55 Antimalarial drugs as weapons against P. falciparum malaria blood-stage parasites

56 Antimalarial treatments have been used for centuries mainly with natural plant 57 products. As a result of these scientific advances, chemical compounds with 58 antimalarial activity, such as quinine, were first used and then replaced with new 59 chemically synthesised compounds. Commonly used blood-stage antimalarial drugs 60 are shown in *Figure 1*.

The 4-aminoquinolines including chloroquine (CQ), amodiaquine (AQ), piperaquine (PPQ), and pyronaridine (PND), are active against the parasite erythrocytic stages, except for mature gametocytes. These molecules share a similar mode of action by acting exclusively against intraerythrocytic stages, during which the parasite actively degrades haemoglobin. Multiple studies have described these molecules as potent heme-crystallisation inhibitors [3-6]. Inhibition of heme crystallisation induces parasite death via accumulation of toxic heme following haemoglobin proteolysis in the food vacuole (FV). Additionally, chloroquine has been suggested displays the property to
interact with the DNA double strand and acts as an intercalant with cytotoxic effects
on cells by suppressing DNA replication [7].

73 Aryl-amino-alcohols (quinine QN, mefloquine MQ, and lumefantrine LUM) have less well understood mechanisms of action. They appear to partially interfere with 74 75 hemozoin formation and detoxification of haemoglobin degradation by-products, which is a secondary aspect of their mode of action. A recent in vitro study suggested that 76 77 MQ specifically targets the GTPase catalytic site located on the 80S ribosomal subunit of the parasite, thereby inhibiting protein biosynthesis [8]. However, this finding was 78 challenged by Sheridan et al., who reported that MQ had no effect on the 80S 79 ribosomal subunit in vitro in P. falciparum [9]. 80

Sulfadoxine (S) and pyrimethamine (P) are two antifolate compounds that were used in combination (SP) against CQ-resistant parasites from the 1960s to the 1980s [10]. S and P inhibit the activities of dihydrofolate reductase (DHFR) and dihydropteroate synthetase (DHPS), respectively, two key enzymes involved in the folate pathway responsible for nucleic acid biosynthesis [10,11]. This combination is currently recommended for malaria chemoprevention during pregnancy [10,11].

Atovaquone (ATV) is a ubiquinone analog that acts on parasite mitochondria. ATV selectively inhibits cytochrome *bc1* in the respiratory chain, thereby blocking ATP synthesis [12]. This inhibition causes a collapse of the mitochondrial membrane potential but also inhibits pyrimidine biosynthesis by depriving the parasite enzyme dihydroorotate dehydrogenase of its cofactor ubiquinone. ATV has no activity against female sexual stages but may be active against male gametocytes [13,14]. ATV has also been described as a potent inhibitor of ookinete formation [15].

Artemisinin (ART) and its derivatives (artesunate, dihydroartemisinin, artemether)
used in combination with partner drugs (AQ, LUM, MQ, PPQ, SP, or PND) are the
current global standards for the treatment of uncomplicated *P. falciparum* malaria
[16]. ART is a sesquiterpene lactone with an internal peroxide bridge, extracted from
the leaves of *Artemisia annua*. They are highly potent, short-lived, and fast-acting
antimalarial drugs capable of reducing *P. falciparum* biomass by up to 10 000-fold

- 103 per 48-hour asexual blood stage cycle [17]. Dihydroartemisinin (DHA), the major
- 104 active metabolite of all ARTs, is activated by the cleavage of its endoperoxide bridge
- 105 by free heme released during haemoglobin digestion and is responsible for
- 106 antimalarial activity [18]. Once cleaved, ART causes non-specific alkylation of
- 107 parasite biomolecules such as lipids, proteins, and DNA, leading to parasite death
- 108 [19,20]. ART is active against all parasite blood stages, including the ring and sexual
- 109 stages, except stage V gametocytes [21,22].
- 110 The first cases of ART partial resistance (ART-R) in *P. falciparum* were reported in
- 111 Southeast Asia in the 2000s [23,24], followed by reports in sub-Saharan Africa,
- notably Rwanda [25,26], Uganda [27,28], and Eritrea [29]. Clinically, ART-R is
- 113 defined as an increase in the parasite clearance half-life [1] or the persistence of
- microscopically detectable parasites on day 3 following the initiation of the 3-day
- ACT regimen) [2]. Further studies have concluded that ART-R is associated with
- 116 decreased susceptibility to ring stages [19,30]. The ring-stage survival assay (RSA),
- 117 which measures the susceptibility of 0–3 h post-invasion ring stages to a
- 118 pharmacologically relevant concentration (700 nM) of DHA for 6 h, showed a strong
- association between reduced clearance of clinical ART-R parasites and reduced *in*
- *vitro* killing of ring stages by DHA [30]. In contrast, *in vitro* RSA showed that the late
- rings and trophozoites remained susceptible to DHA. Subsequent genomic studies
- 122 confirmed a direct link between several mutations in the propeller domain of the
- 123 *Pfkelch13* gene and ART-R, with a limited subset of parasites able to survive short
- 124 ART exposures [31,32]. The 580C>Y mutation appears to be the most common
- 125 mutation in Cambodia, increasing parasite survival upon ART exposure by ~5 fold
- 126 compared to the wild type (WT) [33]. The ART-R parasite exhibits an uncommon
- 127 phenotype *in vitro*, consisting of a subset of ring stages that undergo transient
- 128 developmental arrest after DHA exposure and resume growth after drug removal
- 129 [34]. As the main ART-R biomarker, *Pfkelch13* has been extensively studied for its
- 130 functional characterization. However, the exact function of *Pfkelch13* remains
- 131 unclear. Different laboratories have associated ART-R with increased unfolded
- protein response [35,36], altered mitochondrial physiology [37], PI3K/PI3P/AKT [38],
- and PK4/eiF2 α [39] pathways, extended ring-stage development, followed by faster
- 134 progression to trophozoite stages [36,40]. Although not fully understood, [41] it is
- 135 currently thought that *Pfkelch13*-mediated ART-R consists of reduced activation of
- 136 ART through lower hemoglobin uptake, and mutations in the *Pfkelch13* gene

reduced protein levels and decreased hemoglobin endocytosis, thereby favouringring stage survival [42,43].

Primaguine, an 8-aminoquinoline derivative, is currently the only drug 140 141 recommended by the WHO as a gametocytocidal treatment for the prevention of P. 142 falciparum malaria transmission [93] and is the main treatment for the radical cure of 143 malaria caused by P. vivax and P. ovale hypnozoite liver stages [16]. Primaguine is a prodrug activated by cytochrome P45, an enzyme that produces hydroxylated active 144 145 metabolites that generate hydrogen peroxide (H₂O₂). Active metabolites cause significant oxidative stress in parasites and in human cells. Primaguine, when used 146 147 as a radical cure, is not recommended for glucose-6-phosphate dehydrogenasedeficient individuals, as they may develop acute hemolytic anaemia. The related 148 compound tafenoquine may be a future alternative to primaguine owing to its 149 150 improved safety profile [44].

152 Antimalarial drug resistance: The parasite's defence for survival

153 Malaria control and elimination efforts have made significant advances in the recent 154 decades. However, the emergence and spread of antimalarial drug resistance is a 155 major concern. *P. falciparum* has evolved resistance to almost all antimalarial drugs 156 [45]. Several resistance mechanisms have been identified, including active transport 157 of the drug away from its target and alteration of the parasite target, both of which are 158 mediated by nucleotide polymorphisms (SNPs) and copy number variations (CNVs) in 159 the genes encoding these proteins (Table 1). In addition, non-specific stress 160 response-based survival mechanisms, such as temporary growth arrest (TGA) phenotypes, have been shown to be linked to drug resistance and survival. 161

164 *P. falciparum* ring stages growth arrest and drug resistance, what do we not165 know?

166 P. falciparum ring stage: the most resilient and adaptable parasite stage

167 The ring stage is the first stage of the intraerythrocytic developmental cycle (IDC)

- 168 following merozoite invasion of erythrocytes. It establishes an intracellular niche, the
- 169 parasitophorous vacuole (PV), which is formed by invagination of the host cell
- membrane [46] and later modified through lipids addition by the parasite [47]. Over

- the next 20h, the parasite assumed a typical ring-shape. The ring stage parasite then
- begins to import haemoglobin by endocytosis with a cellular structure called the
- 173 cytostome to support its metabolism [48,49]. Nutrient transport channels, including
- 174 PSAC, EXP1 or hGLUT1 also provide key nutrients (isoleucine, glucose, and ions)
- 175 from the host serum and serve as possible entrances for drugs. Their expression at
- a relatively late stage during the ring stage could be a possible explanation for drug
- 177 resilience as reviewed elsewhere [50].
- To date, almost all available antimalarial treatments have been unable to specifically target the ring stage [51] (*Figure 1*). Current drugs mainly target FV and are most
- 180 effective against trophozoites and schizonts due to their high haemoglobin
- 181 consumption rate [51]. In contrast, metabolite inhibitors, such as SP or ATV, inhibit
- 182 parasite growth rather than specifically eliminating the ring stage [51]. Currently, ART
- is the only drug that has direct cytotoxic activity in the ring stage [17] although some
- 184 candidates such as cipargamin (KAE609) and BCH070 have shown promising
- results in killing ring stage parasites [52,53] . Among the intraerythrocytic cycles, the
- 186 ring stage appears to be the most adaptable and resilient: first through splenic
- 187 clearance evasion [54], second, through its ability to orchestrate a metabolic switch,
- including the shutdown of core metabolic functions accompanied by high RNA
- 189 expression in specific pathways, third, through its ability to modulate the immune
- 190 system through vesicle-mediated intracellular transport [36,55-57] and fourth, by
- adjusting cell cycle progression [58,59].
- 192 The cessation of *P. falciparum* parasite progression from the ring to the trophozoite
- in IDC, defined as ring stage TGA, has been reported in many biological situations.
- 194 Isoleucine deprivation, an essential amino acid that must be scavenged from the
- 195 extracellular medium, was directly associated with a reversible ring stage TGA
- 196 phenotype [60]. Furthermore, experiments with parasites exposed to extreme
- 197 temperatures ranging from +4°C to +40°C showed that only the ring stage resumed
- 198 growth and maintained cell viability when the temperature returned to physiological
- 199 conditions at +37°C [59,61]. TGA phenotypes of malaria parasites have been
- reported in other *Plasmodium* species (*Table 2*). This suggests that reversible G0
- 201 cell cycle arrest is a general strategy used by *P. falciparum* ring stage parasites to
- 202 cope with environmental stress, independent of drug resistance-causing mutations.203
- 204 Drug-induced ring stage TGA: a drug resistance strategy

205 TGA can be defined as a phenotype based on the cellular mechanisms by which a microorganism can reversibly halt its growth under adverse conditions (Box 1). In 206 207 Apicomplexa, this survival strategy has been well described in the bradyzoite stage of Toxoplasma gondii [62], hypnozoites of Plasmodium vivax [63], and multiple other 208 209 Plasmodium species (Table 2). Research on TGA in *P. falciparum* is still in its infancy. 210 P. falciparum blood stage TGA was firstly suggested by Nakazawa et al., who 211 observed parasite recrudescence following SP treatment without detecting any genetic 212 changes in the surviving population [64]. The TGA hypothesis was subsequently 213 validated in vitro, which showed delayed progression of ring stages following ART 214 exposure [30,34]. Pfkelch13 wild type (WT) and mutant ring stages were able to enter 215 growth arrest-mediated processes, but isogenic Pfkelch13 mutants shifted the 216 subpopulation distribution dramatically, allowing more ring stages to arrest and 217 resume growth after drug removal in vitro [30,31]. This has been microscopically 218 documented in ring stages, as evidenced by delayed ring stage progression and 219 unaltered morphology at 24h post-invasion, using a 24-hour DHA exposure at 700 nM 220 [30]. Nevertheless, the potential dose-response of the ring stage and TGA induction 221 when exposed to DHA should be tested, which could provide useful insight into the 222 biological mechanisms that govern TGA.

223 Other studies have also reported the recovery of TGA ring stages for up to several 224 weeks after a single pulse of ART [34,37,65-71]. These results differ significantly 225 from the TGA phenotype initially observed, with an immediate resumption of growth 226 after drug removal [30]. These conflicting results can be explained by the fact that 227 different experimental parameters were used to induce the TGA. However, it remains 228 unclear whether these phenotypes are biologically similar or distinct. From this 229 perspective, the use of a more general term such as TGA may better reflect the 230 observed phenotype and avoid confusion until the different biological mechanisms behind TGA are unveiled (Box 1). Nevertheless, one of the most concerning 231 232 conclusions drawn from these studies is that TGA could be a mechanism that 233 maintains a reservoir of recrudescent parasites in the human host, which lead to therapeutic failure [71]. 234

236 Consequently, many questions remain regarding the TGA. Why does only one 237 subpopulation undergo TGA in an isogenic population? What is the duration of the 238 TGA? However, a theoretical framework of three key steps can be suggested: i) the initial stress inducing TGA, ii) the maintenance in a growth-arrested state for a giventime, and iii) the resumption phase when the stress is removed.

241 Metabolic and transcriptomic studies of TGA rings at different times following stress 242 could provide useful data to understand the duration of this phenotype. The link 243 between TGA and *Pfkelch13*-mediated ART-R is unclear, but it could be hypothesised 244 that TGA is mediated by the haemoglobin consumption rate, which is altered in 245 Pfkelch13 mutant strains. Indeed, ART-R Pfkelch13 C580Y ring stage have lower haemoglobin uptake than the *Pfkelch13* WT strain [42,43], which limits the chemical 246 247 activation of ART by free heme, thus promoting ring stage survival. To overcome the reduced nutrient uptake through haemoglobin endocytosis, Pfkelch13 C580Y showed 248 249 nutritional compensatory mechanisms through the expression of EXP1, a parasite FV 250 transmembrane protein that imports amino acids from host serum [72]. Such a 251 mechanism may provide sustenance during the TGA. Lastly, Pfkelch13 mutation 252 appears to be particularly important for the ring stage development as an impaired 253 K13 protein results in a slower progression of the ring stage in vitro [42].

254 A recent metabolic study of the ART-sensitive and ART-R ring stages induced by a 255 single pulse of DHA suggested that arrested parasites rely on a different energy 256 metabolism than parasites growing under normal conditions [55]. In particular, the authors showed that the TGA ring stage is in a metabolically active state that relies on 257 258 alternative nutrient sources such as haemoglobin and glycolysis, and TGA and Pfkelch13-mediated ART-R may be distinct but complementary mechanisms that 259 260 promote survival in the population by reducing ART sensitivity. Additionally, another 261 key work provides new insights into the transcriptome of the TGA ring induced by ART, 262 with the parasite requiring 4-5 days to differentiate into the TGA ring, expressing signatures associated with DNA repair and repressed glycolysis [73]. More recently, 263 264 a study identified a novel gene (PF3D7 1136600, named MRST for Modulator of Ring Stage Translation) associated with changes in parasite translational metabolism 265 during ART drug response, with a possible link to parasite stress response 266 267 mechanisms, supporting its role as an essential modulator of ring stage translation 268 [74]. From this perspective, it could be relevant to study the involvement of MRST in the TGA molecular pathways. Strikingly, an *in vitro* study showed that pre-exposure to 269 270 low temperature (+4°C) prior to DHA exposure at a clinical dose of DHA (700 nM) resulted in a significant increase in the parasite survival expressed by the RSA in 271 272 Pfkelch13 WT (ART-S) and Pfkelch13 mutant ART-R ring stages [75], suggesting that TGA can be induced by low temperature and may be a potential *Pfkelch13*independent mechanism.

275 Collectively, these data suggest that TGA may be a generalist strategy not necessarily 276 based on genetic changes but rather an environmentally induced mechanism. This 277 hypothesis may explain why TGA was observed in a fraction of the ring stage 278 population under adverse conditions in a clonal population. As TGA has been reported 279 in *P. falciparum* ring stages under various stresses, it could be speculated that the 280 parasite is able to actively sense its environment (*Figure 2*), suggesting the possible 281 induction from the extracellular compartment.

283 Is TGA triggered externally? Individuals die, and the population survives

Is the TGA phenotype observed after ART exposure caused by the drug itself or by a 284 285 signal emitted by a stressed parasite population? Such a guestion is currently 286 unanswered, but it highlights the internal heterogeneity within a clonal parasite 287 population, as it implies that healthy, stressed, and dying parasites share the same 288 environment. This heterogeneity between growing and arrested parasites could be explained by environmental signals. A similar model has already been described for 289 290 Trypanosoma brucei, in which small oligopeptides from the extracellular medium are 291 used as communication signals to induce parasite differentiation from slender to 292 stumpy forms [76]. Despite the lack of direct evidence between TGA and 293 extracellular signalling, several in vitro studies have described the innate ability of P. 294 falciparum to sense and respond to its environment in different biological contexts. 295 The sexual maturation of *P. falciparum* has been linked to extracellular factors. 296 Xanthurenic acid (XA) is present in human serum and in mosquitoes, and XA 297 concentration has been linked to pH changes and temperature drops from the 298 human host to the mosquito, which is responsible for the maturation of the parasite 299 sexual stage [77]. Another example was found in vitro using the human host 300 compound lysophosphatidylcholine (LPC) as an environmental factor that drives sexual commitment in *P. falciparum* parasites during the blood stage [78]. A direct 301 302 relationship between LPC levels and parasite response was demonstrated in vitro, with the parasite maintaining its asexual growth when LPC is not limiting and 303 304 undergoing gametocyte differentiation upon LPC shortage, particularly in the host bone marrow where LPC levels are constitutively low. Following isoleucine 305 306 starvation, the parasite can carry out TGA until the environment becomes more

307 favourable [60], meaning that parasites are somehow able to sense when the extracellular medium becomes limiting for isoleucine in vitro. In response, the 308 parasite actively expresses the RNA polymerase III repressor Maf1 during amino 309 acid starvation induced TGA to stop RNA transcription, thereby limiting cellular 310 311 biological activity and promoting survival [79,80]. Quorum sensing (QS) is another 312 type of extracellular sensing. When cultured under optimal conditions, the parasite 313 population cannot reach 100% parasitemia before collapse. This collapse phenotype 314 was shown to be due to the specific expression of apoptotic genes in the population 315 [81,82], ruling out the involvement of nutrient deprivation, as the parasite was cultured under non-limiting nutrient conditions. It has been suggested that QS 316 317 between parasites that keeps the population under control is mediated by molecules 318 of the homoserine lactone family.

Interestingly, TGA appears to be modulated by ex vivo exposure to phytohormones 319 320 such as abscisic acid (ABA) and gibberellic acid (GA), as shown in a recent in vitro 321 study [83]. The addition of either ABA or GA accelerated the recovery time of ART-322 induced ring stage TGA compared to ART alone, whereas the plastid-targeting 323 herbicide fluridone had the opposite effect. This supports the idea that growth-324 arrested ring stages are still able to sense their environment, despite reduced 325 metabolic activity. It also identifies the apicoplast as an important player in TGA 326 regulation. ABA and GA have been described as stress hormones in plants, 327 particularly during abiotic stress [84]. However, their role in malaria infection, 328 particularly in TGA regulation, is unknown. Additional studies are needed to confirm 329 whether malaria parasites can produce and disseminate phytohormones in their 330 environment as a signal that promotes TGA. This hypothesis is supported by the 331 relatively close relationship between algae and the apicoplast, an organelle obtained 332 by primary endocytosis in Apicomplexa [85]. Another recent study showed that 333 cripowellins, a pesticide extracted from Crinum erubescens, induced reversible 334 inhibition of ring stage growth within 24 h of treatment while being cytotoxic in the trophozoite and schizont stages [86]. Whole transcriptome analysis confirmed that 335 336 cripowellin B could reversibly halt the ring stage transcriptional program required for trophozoite progression. 337 Extracellular vesicles (EVs) containing both host and parasite materials (proteins, 338

lipids and nucleic acids) have been found in the extracellular medium of malaria infected cells and have been shown to act on immune cells [56,57,87,88], suggesting

341 the existence of an intercellular communication network between the parasite and human host [88]. Additional studies have demonstrated the ability of *P. falciparum* 342 ring stage parasites to exchange genes via EVs. PfPTP2, which is involved in 343 molecular trafficking, is an important molecular factor that controls these processes 344 [57]. Finally, the parasite protein PfAB4 has been described as a potential 345 346 environmental sensor because of its ability to sense serum depletion, osmotic 347 changes, and cytokine concentrations in extracellular medium in vitro [89]. This sensing ability is mediated by multiple phosphorylation events that occur in the 348 349 proteins localised in the cytoplasm of infected erythrocytes. However, the association 350 between PfAB4 expression and TGA remains unclear.

Taken together, these data suggested the existence of an extracellular communication 352 network and environmental sensing in P. falciparum blood-stage parasites. The 353 354 molecules, their signalling pathways, and their potential involvement in TGA remain 355 elusive. However, the existence of such extracellular communication implies 356 heterogeneity within the parasite population; only parasites that receive signals respond accordingly. In the case of TGA, this implies that such a signal is produced 357 358 shortly after stress exposure to ensure that as many parasites as possible receive the 359 signal and enter TGA before they die, thereby making the signal concentration and 360 diffusion key parameters. As shown previously, the ring stage is exposed to many 361 extracellular factors (Figure 2) and can respond to TGA, sexual commitment, or 362 asexual growth. This makes the ring stage a true crossroad in the parasite's asexual 363 blood cycle (Figure 3).

366 Concluding remarks

The ring stage exhibits extreme plasticity under adverse conditions. CNVs and SNPs associated with antimalarial drug resistance are heritable and confer survival to almost all individuals exposed to the drug, whereas TGA, an innate and passive resistance to many stressors, ensures that a small proportion of individuals in the population can survive in the host under a wide range of sudden adverse conditions.

This suggests that TGA relies on environmental sensing (*Figure 2*), including temperature, small diffusible molecules (hormones or cytokines), nutrient availability, population density, drug exposure, and cell fate at the ring stage, which can be controlled by extracellular signals. The possible involvement of EVs in TGA regulation
requires further investigation (*see Outstanding Questions*). This makes the ring
stage a target of choice, as it is at the crossroads of the three known cell fates (*Figure 3*78 *3*).

Targeting the ring stage in TGA is critical and specific biomarkers of TGA need to be 380 381 identified. Metabolomic and single-cell RNA-seq approaches could be important tools 382 to unveil the biological mechanism(s) behind TGA phenotypes and shed new light on 383 this survival strategy by providing a much-needed molecular signature. Such biomarkers could provide new insights into the molecular regulatory pathways and 384 385 duration of TGA, as well as a better overview of the global parasite population in the human host, especially in asymptomatic patients. Therefore, new therapeutic tools that 386 specifically target the ring stage in TGA are required. 387

ACTs: Artemisinin-combined therapies. Three daily doses of a combination of artemisinin and partner drugs is the therapeutic approach. The goals of antimalarial treatment are to prevent drug resistance and to ensure parasite elimination. There are currently six ACTs in use: ASAQ (artesunate-amodiaquine), AL (artemetherlumefantrine), ASMQ (artesunate-mefloquine), DHA-PPQ (dihydroartemisininpiperaquine), AS-SP (artesunate-sulfadoxine-pyrimethamine), AS-PND (artesunatepyronaridine).

ART: Artemisinin. ART is the main antimalarial compound in ACTs. When the
parasite digests haemoglobin, it releases haem, which activates ART and causes
indiscriminate and lethal alkylation of cell biomolecules. One of the most important
areas of malaria research with immediate impact is the mechanism of drug
resistance to ART.

EVs: Extracellular vesicles. The infected red blood cell releases vesicles known as
EVs, which are composed of protein, lipids and nucleic acids in addition to parasite
material. In recent years, there has been growing interest in their roles, which include
modulating the host immune system and demonstrating the parasite's environmental
adaptability.

Pfkelch13: *Plasmodium falciparum kelch* gene (PF3D7_1343700). The parasite
K13 protein, which is involved in haemoglobin endocytosis, is encoded by a gene
located on chromosome 13. Over the past decade, scientific interest has increased
significantly due to the direct correlation between ART resistance and mutations in
the propeller domain of K13.

RSA: Ring stage Survival Assay. The RSA is an in vitro phenotypic test that can
be used to determine whether a particular strain of P. falciparum is resistant to ART.
The test is based on a synchronous 0-3 ring stage exposed to 700 nM DHA (an
active metabolite of all ARTs) or DMSO (vehicle) for 6 hours, followed by a 66 hour
recovery period. ART resistance is validated by a parasite survival rate (RSA)
greater than 1%.

TGA: Temporary Growth Arrest. TGA is any phenotype of cell growth arrest that
 occurs after exposure to unfavourable conditions. As a result, a wide range of
 phenotypes that may be dependent on many biological processes are covered by

- this broad description. The aim of such a definition is to bring clarity to a field where
- there are multiple names for the same observed phenotype. The TGA is intended to
- serve as a temporary definition until each growth arrest phenotype is fully
- understood and can be described more precisely with experimental data.

781 Box 1. Cell growth arrest: Several words for the same phenotype

782 The TGA phenotype has been described in many models as a reversible metabolic 783 growth arrest that occurs under adverse growth conditions. Various terms, such as 784 persister cells [122], quiescence [123], diapause [124], latency, and dormancy [125], have been used to describe this phenotype in a wide variety of organisms, including 785 786 plants, bacteria, and cancer cells, including *P. falciparum* (Table 2). Several phenotypes of growth arrest have been reported in *P. falciparum* in different biological 787 contexts. 'dormancy', 'persister', 'latency' and 'guiescent ring' are being used to 788 789 describe the subpopulation of ring stage that survive ART exposure [37,90] as well as 790 amino acid starvation [79]. In this context, the term 'hibernatory state' is used to define 791 growth-arrested parasites following isoleucine deprivation [60]. It is currently unclear whether these growth arrest phenotypes are based on similar or different biological 792 mechanisms. Therefore, the use of the term 'temporary growth arrest' may better 793 794 define these phenotypes and may be used as a consistent terminology for this family 795 of phenotypes, pending further data that may reveal the possible underlying biological mechanism(s). Thus, TGA can be defined as a phenotype of reversible growth arrest 796 797 following stress exposure. This flexible definition allows the various growth arrest phenotypes described above to be included until they can be properly characterized 798 799 and therefore given their own definition based on experimental data.

828 Figure 1. Cellular targets and timing of antimalarial drug action. Several 829 compounds have been used against P. falciparum blood stages to target a wide range 830 of cellular processes. Our current arsenal can effectively inhibit the haem 831 neutralization process, block the pyrimidine biosynthetic pathway, disrupt the 832 mitochondrial membrane potential or induce massive non-specific alkylation. The exact mechanisms of action of several drugs are not fully understood and require 833 834 further research. Most currently used molecules target mature blood stages, while only 835 ART and its derivatives have a spectrum of action that extends to the ring stage.

837 Figure 2. The ring stage develops and adapts to different signals in the 838 extracellular medium. The extracellular medium is a complex and diverse 839 environment to which the ring stage parasite must adapt. Some of the known components of the parasite extracellular medium are nutrients (glucose, hypoxanthine 840 and amino acids), secreted vesicles, host immune proteins (such as antibodies and 841 842 complements) and small soluble molecules. The extracellular medium is altered, particularly by the host's diet, which directly affects the availability of nutrients in the 843 844 peripheral circulation, which in turn affects the parasite's ability to grow. In addition, acute malaria infection leads to increased production of immune proteins. 845 hyperglycaemia, temperature elevation (fever) and possibly drug uptake by the host. 846 The parasite thus evolves in a rapidly changing environment that it must decipher to 847 848 survive.

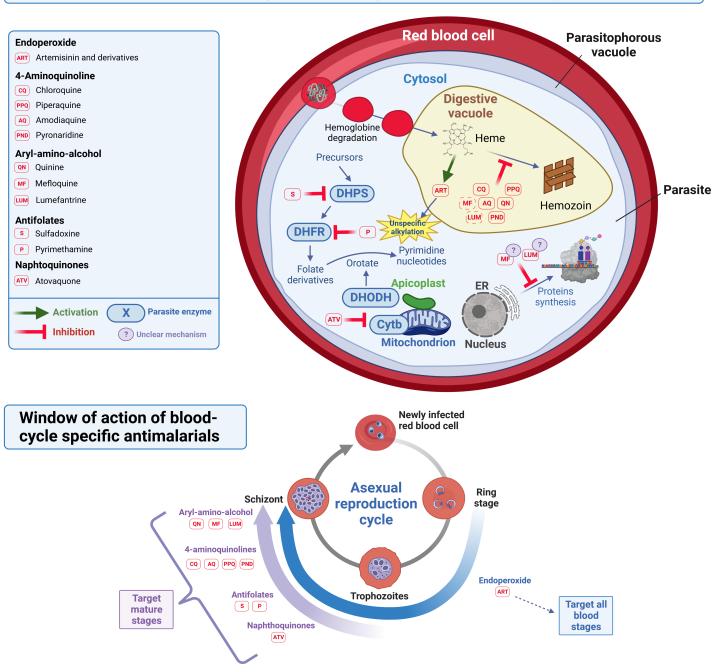

850 Figure 3. Plasticity of the ring stage during the intraerythrocytic developmental

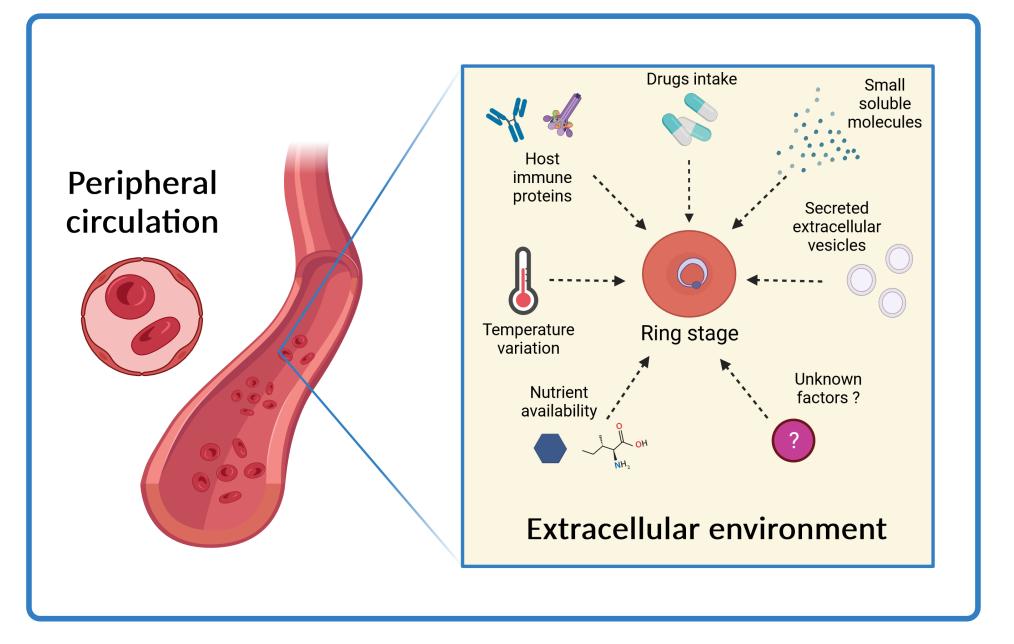

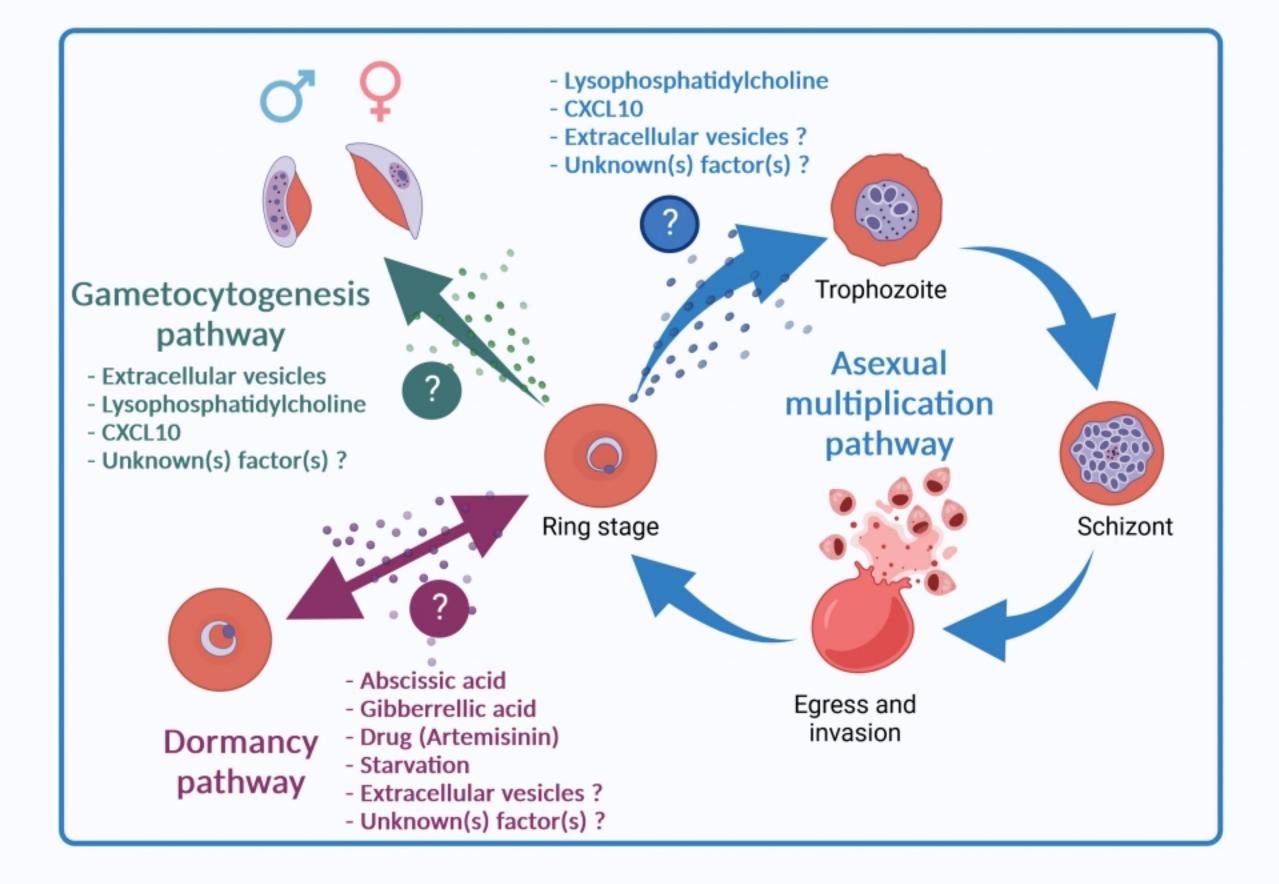

1 Highlights

P. falciparum has evolved resistance to almost all antimalarial drugs through
 genomic changes (SNPs and CNVs) and a non-specific stress response-based
 survival such as the ring-stage temporary growth arrest (TGA).

The ring-stage can develop into asexual or sexual stages or stop growing when
conditions are unfavourable.

The ring-stage shows extreme plasticity under adverse conditions, such as
artemisinin exposure. The ring-stage TGA stage is an innate and passive
resistance to many stressors, which ensures that some individuals in the population
can survive in the host.

- *P. falciparum* ring-stage TGA may rely on environmental sensing and extracellular
 communication between the parasites.
- 13 Ring-stages TGA may be an underestimated parasite reservoir, especially in
 14 asymptomatic individuals.
- 15 No treatment that specifically targets growth-arrested ring stages is currentlyavailable.
