# Output feedback control of discrete-time Lur'e systems through FIR Zames-Falb multipliers \*

Abstract: This paper is concerned with output feedback control of discrete-time Lur'e systems with slope bounded nonlinearities that can be non-odd. Using FIR (Finite Impulse Response) Zames-Falb multipliers of any given order, stability conditions based on positive realness are proposed in terms of linear matrix inequalities and linear constraints that assure the  $\ell_1$  norm bound for the multiplier. Importantly, the proposed approach does not require line searches. Applying a relaxation on the stability and exploiting the fact that the matrices of the system appear affinely in the conditions, an iterative method is constructed to search for the FIR Zames-Falb multiplier certifying stability. An extension to cope with the design of a control law is also presented, dealing with state or output feedback gains that may include a term proportional to the output of the nonlinear block. Numerical examples illustrate the advantages of the proposed approach, that can be numerically more efficient than other techniques from the literature.

*Keywords:* Discrete-time Lur'e systems, FIR Zames-Falb multipliers, Absolute stability, Output-feedback control, Linear matrix inequalities.

#### 1. INTRODUCTION

Lur'e systems are feedback interconnections between a linear time-invariant (LTI) plant with a static nonlinear function (Khalil, 2002, Chapter 7), as presented in Figure 1. Under assumptions on the nonlinearity, as sector and slope bounds, conditions for absolute stability can be formulated in time domain, where the stability certificates are Lyapunov functions (Gonzaga et al., 2012; Ahmad et al., 2015; Park, 1997, 2002; Bertolin et al., 2022a; Park et al., 2019), or in the frequency domain, where the stability certificates are LTI systems called multipliers (Khalil, 2002; Turner et al., 2009; Turner and Drummond, 2021; Ahmad et al., 2013; Ahmad and Carrasco, 2016; Haddad and Bernstein, 1994, 1993; Carrasco et al., 2012a, 2020, 2016; Safonov and Wyetzner, 1987; Carrasco et al., 2012b, 2014).

For slope-bounded nonlinearities, the Zames-Falb (ZF) multipliers (Zames and Falb, 1968; O'Shea, 1966, 1967; Turner, 2021) are the most effective method to assess stability. A positive realness condition must be verified for the overall system and the  $\ell_1$  norm of the impulse response of the multiplier must be bounded. For discrete-time Lur'e systems, the requirements on the bound of the  $\ell_1$  norm (called star norm) for infinite impulse response ZF multipliers (Ahmad et al., 2013) and positive realness conditions are expressed in terms of linear matrix inequalities (LMIs). These formulations consider a statespace realization of the multiplier. Although being effective to some extent, the  $\ell_1$  bound constraint can be conservative, and requires a scalar search. Moreover, the conditions apply only to odd nonlinearities. The *finite impulse response* (FIR) ZF multipliers (Wang et al., 2014; Carrasco et al., 2020) offer a simpler solution to bound the  $\ell_1$  norm of the impulse response and the positive realness condition is still expressed with an LMI constraint. Besides, FIR multipliers handle odd or nonodd nonlinearities, and can be causal, anti-causal or noncausal.

Regarding control design for discrete-time Lur'e systems, most of the existing works are based on Lur'e-Lyapunov functions (Bertolin et al., 2022a; Kim and Braatz, 2017; Louis et al., 2015b,a), with the exception of (Bertolin et al., 2022b) that used star-norm bounds for the  $\ell_1$  constraint and positive realness to derive synthesis conditions. In this paper, the aim is to propose a method for the output feedback control of discrete-time Lur'e systems based on FIR ZF multipliers. An iterative algorithm, where an LMI optimization problem is solved at each iteration, is first presented for absolute stability analysis and its extension to cope with control design is immediate. A control law using state or output feedback, that may also include the feedback of the output of the nonlinearity, can be designed jointly with the FIR ZF multiplier. Odd or non-odd nonlinearities, causal or anti-causal FIR multipliers of any given order can be considered. Numerical examples from the literature illustrate the performance of the proposed method.

**Notation:** For a symmetric matrix, A > 0 (A < 0) means that A is positive (negative) definite. For matrices or vectors ( $^{T}$ ) indicates the transpose,  $\text{He}(A) = A + A^{T}$  and  $diag(A_{1}, \ldots, A_{n})$  represents a block diagonal matrix formed by the square matrices (or elements)  $A_{1}, \ldots, A_{n}$ . The symbol  $\star$  represents a term induced by symmetry in a square matrix,  $\sim$  indicates a statespace realization of a transfer function and  $\text{Re}\{M(j\omega)\}$  means the real part of  $M(j\omega)$ . The identity and the zero matrices are denoted, respectively, by I and 0.  $\mathcal{B}_{\perp}$  represents a basis for the null space of  $\mathcal{B}$ , i.e.,  $\mathcal{BB}_{\perp} = 0$ . Throughout the text the dimensions of the matrices may be omitted for simplicity (being inferred from the context).

#### 2. PROBLEM DEFINITION

Consider the discrete-time nonlinear Lur'e system given by

$$\begin{cases} x(k+1) = Ax(k) + B_{\phi}\phi(z(k)) + B_{u}u(k) \\ z(k) = C_{z}x(k) + D_{z\phi}\phi(z(k)) \\ y(k) = C_{y}x(k) \end{cases}$$
(1)

where  $x \in \mathbb{R}^{n_x}$  is the state,  $u \in \mathbb{R}^{n_u}$  is the control input,  $z \in \mathbb{R}$ ,  $\phi : \mathbb{R} \to \mathbb{R}$ , and  $y \in \mathbb{R}^{n_y}$  is the measured output. Matrices  $A, B_{\phi}$ ,  $B_u, C_z, C_y$ , and  $D_{z\phi}$  are real and have appropriate dimensions. The nonlinearity  $\phi$  is a monotonic function (odd or non-odd), that verifies the slope bound

$$0 \le \frac{\phi(\hat{z}) - \phi(z)}{(\hat{z} - z)} \le \Lambda \tag{2}$$

for all  $z, \hat{z} \in \mathbb{R}, z \neq \hat{z}$ , and  $\phi(\hat{z}), \phi(z) \in [0, \Lambda]$  where  $\Lambda$  is a given positive scalar.

System (1) is assumed to be well-posed, that is, the algebraic loop involving z and  $\phi(z)$  has a unique solution. A sufficient condition for well-posedness is given by

$$1 + \Lambda D_{z\phi} > 0. \tag{3}$$

The main goal of this paper is to design a stabilizing static output-feedback controller for system (1). Considering the control law  $u = Ky + K_{\phi}\phi(z)$ , the state-space representation for the closed-loop system is given by

$$\begin{cases} x(k+1) = A_{cl}x(k) + B_{cl}\phi(z(k)) \\ z(k) = C_{z}x(k) + D_{z\phi}\phi(z(k)) \end{cases}$$
(4)

with  $A_{cl} = A + B_u K C_v$  and  $B_{cl} = B_{\phi} + B_u K_{\phi}$ .

As an important result that is used to derive the proposed conditions, the Finsler's Lemma (de Oliveira and Skelton, 2001) is reproduced below.

*Lemma 1.* (Finsler's lemma). Consider matrices  $Q \in \mathbb{R}^{\ell \times \ell}$  and  $\mathcal{B} \in \mathbb{R}^{m \times \ell}$ , with  $rank(\mathcal{B}) < \ell$  and  $\mathcal{BB}_{\perp} = 0$ . Then, the following conditions are equivalent:

i)  $\mathcal{B}_{\perp}^{T} \mathcal{Q} \mathcal{B}_{\perp} < 0;$ 

*ii*)  $\exists \hat{X} \in \mathbb{R}^{\ell \times m}$  such that  $Q + X\mathcal{B} + \mathcal{B}^T X^T < 0$ .

#### 2.1 Stability conditions

By performing a loop transformation, stability analysis of the closed-loop system (4) can be investigated through the existence of a ZF multiplier M(z) (Zames and Falb, 1968), such that

$$\operatorname{Re}\{M(e^{j\omega})\tilde{G}_{cl}(e^{j\omega})\} > 0, \,\forall \omega \in [0, 2\pi]$$
(5)

is verified, with  $\tilde{G}_{cl}(e^{j\omega}) = (1 + \Lambda G_{cl}(e^{j\omega}))$ . Consider, without loss of generality,  $M(z) \sim (A_m, B_m, C_m, 1)$ , with state space realization of  $M(z)\tilde{G}_{cl}(z)$  given by

$$A_{I} = \begin{bmatrix} A_{p} & 0\\ B_{m}C_{p} & A_{m} \end{bmatrix}, \quad B_{I} = \begin{bmatrix} B_{p}\\ B_{m}D_{p} \end{bmatrix}$$
$$C_{I} = \begin{bmatrix} C_{p} & C_{m} \end{bmatrix}, \quad D_{I} = D_{p},$$

where  $A_p = A_{cl}$ ,  $B_p = B_{cl}$ ,  $C_p = \Lambda C_z$  and  $D_p = (1 + \Lambda D_{z\phi})$ . Then condition (5) can be verified through the following lemma (Ahmad et al., 2013).

*Lemma 2.* System  $M(z)\tilde{G}_{cl}(z) \sim (A_I, B_I, C_I, D_I)$  is stable and positive real if there exists a positive definite matrix  $P = P^T$ , such that

$$\begin{bmatrix} A_I^T P A_I - P & A_I^T P B_I - C_I^T \\ \star & B_I^T P B_I - D_I^T - D_I \end{bmatrix} < 0.$$
(6)

#### 2.2 FIR multipliers

As presented in the previous subsection, besides the positive realness condition, M(z) must belong to the class of ZF multipliers to certify the absolute stability of the closed-loop Lur'e system (4). In this work, the following causal FIR multiplier is adopted

$$M(z) = \sum_{i=0}^{n_M} m_i z^{-i}$$
(7)

where  $n_M \ge 1$  is the multiplier order and  $m_0 = D_m = 1$ .

This particular structure for M(z) simplifies the constraint to bound the  $\ell_1$  norm M(z). As a matter of fact, such condition can be established in terms of linear programming involving the coefficients  $m_i$ , as presented in the next lemma for both odd and non-odd nonlinearities (Carrasco et al., 2020).

Lemma 3. M(z) given in (7) is a ZF multiplier if

i)

$$\sigma = \sum_{i=0}^{n_M} m_i \ge 0,\tag{8}$$

with  $m_i \leq 0$ , for  $i = 1, ..., n_M$  and  $m_0 = 1$  for non-odd nonlinearities.

ii)

$$\sigma = \sum_{i=0}^{n_M} m_i^+ + \sum_{i=0}^{n_M} m_i^- \le 2, \tag{9}$$

where  $m_i = m_i^+ - m_i^-$ , and  $m_i^+, m_i^- \ge 0$ , for  $i = 1, ..., n_M$ ,  $m_0^+ = 1$  and  $m_0^- = 0$  for odd nonlinearities.

In this paper, the search for  $M(z) \sim (A_m, B_m, C_m, 1)$  is simplified by adopting the following controllable canonical form

$$A_{m} = \begin{bmatrix} 0 & 1 & 0 & \cdots & 0 \\ 0 & 0 & 1 & \cdots & \vdots \\ \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & 0 & \cdots & 1 \\ 0 & 0 & 0 & \cdots & 0 \end{bmatrix}, \quad B_{m} = \begin{bmatrix} 0 \\ 0 \\ \vdots \\ 0 \\ 1 \end{bmatrix}, \quad C_{m} = \begin{bmatrix} m_{n_{M}} \\ m_{(n_{M}-1)} \\ \vdots \\ m_{1} \end{bmatrix}^{T} .$$
(10)

The search for anti-causal FIR ZF multipliers can be performed by transforming  $A_p$ ,  $B_p$ ,  $C_p$  and  $D_p$  as proposed in Carrasco et al. (2020). Although in Carrasco et al. (2020) a non-causal multiplier can be computed by solving a convex optimization problem, the resulting conditions are not easily extended for control design, which is the main purpose of this paper.

#### 3. MAIN RESULTS

As the main contribution of this work, the present section deals with the design of the static output-feedback gains K and  $K_{\phi}$  associated to the closed-loop system (4).

Theorem 1. Let the positive integer  $n_M$  and the matrices  $\overline{X}_i \in \mathbb{R}^{(n_x+n_M)\times(n_x+n_M)}$ ,  $i = 1, 3, 4, \overline{X}_2 \in \mathbb{R}^{(n_x+n_M)\times 1}$ , with  $\overline{X}_4$  of full rank, be given. If there exist  $X_i \in \mathbb{R}^{(n_x+n_M)\times(n_x+n_M)}$ , i = 1, 3, 4,  $X_2 \in \mathbb{R}^{1\times(n_x+n_M)}$ ,  $0 < P^T = P \in \mathbb{R}^{(n_x+n_M)\times(n_x+n_M)}$ ,  $K \in \mathbb{R}^{n_u \times n_y}$ ,  $K_\phi \in \mathbb{R}^{n_u \times 1}$  and  $C_m \in \mathbb{R}^{1\times n_M}$  such that

$$Q + \operatorname{He}\left(\underbrace{\begin{bmatrix} X_1\\X_2\\X_3\\X_4 \end{bmatrix}}_{\mathbf{X}} \underbrace{\left[\overline{X}_1 \ \overline{X}_2 \ \overline{X}_3 \ \overline{X}_4\right]}_{\overline{X}}\right) < 0, \tag{11}$$

where

$$Q = \begin{bmatrix} -P & -C_I^T & 0 & A_I^T \\ \star & -2D_I & 0 & B_I^T \\ \star & \star & P & -I \\ \star & \star & \star & 0 \end{bmatrix},$$

and the conditions of Lemma 3 ( $\phi$  odd or non-odd) are verified, then the gains K and  $K_{\phi}$  stabilize the closed-loop system (4) and M(z) given in (7) is a FIR ZF multiplier.

Proof. Consider

$$\mathcal{B}_{\perp} = \left[\frac{I}{-\overline{X}_4^{-1}\overline{X}_1 - \overline{X}_4^{-1}\overline{X}_2 - \overline{X}_4^{-1}\overline{X}_3}\right]$$

as basis for the null space of  $\overline{X}$ , that is,  $\overline{X}\mathcal{B}_{\perp} = 0$ . Invoking Lemma 1, condition (11) is equivalent to  $\mathcal{B}_{\perp}^T \mathcal{Q}\mathcal{B}_{\perp} < 0$ , that can be rewritten as

$$\begin{bmatrix} -P & -C_I^T & 0 \\ \star & -2D_I & 0 \\ \star & \star & P \end{bmatrix} + \operatorname{He} \left( \begin{bmatrix} (\overline{X}_4^{-1} \overline{X}_1)^T \\ (\overline{X}_4^{-1} \overline{X}_2)^T \\ (\overline{X}_4^{-1} \overline{X}_3)^T \end{bmatrix} \begin{bmatrix} A_I & B_I & -I \end{bmatrix} \right) < 0.$$
(12)

The above inequality is, again, in the form *ii*) of Lemma 1. Then, computing a basis for the null space of  $\begin{bmatrix} A_I & B_I & -I \end{bmatrix}$ , the following condition, equivalent to (6), can be obtained

$$\begin{bmatrix} A_I^T P A_I - P & A_I^T P B_I - C_I^T \\ B_I^T P A_I - C_I & B_I^T P B_I - 2D_I \end{bmatrix} < 0,$$
(13)

proving the positive realness of the interconnected system. The feasibility of (8) (non-odd) or (9) (odd) assures that M(z) is a ZF multiplier. As a consequence, the closed-loop system is stable.

The main advantage of Theorem 1 is that the variables P,  $C_m$  and the matrices of the system appear affinely in the conditions. Thus, the stabilizing gains can be directly computed, without resorting to change of variables or any other algebraic techniques, which in general are difficult to be applied for static output-feedback control, even for linear time-invariant systems. Moreover, the multiplier M(z) can be of any given order  $n_M \ge 1$ . However, note that inequality (11) is convex

because  $\overline{X}$  is a fixed matrix. Consequently, due to the lack of a general approach for choosing suitable matrices  $\overline{X}_i$ , i = 1, ..., 4, the results obtained through this sufficient condition may be conservative. A strategy to overcome this difficulty is the application of relaxations, as shown in the next theorem.

Theorem 2. Let  $\overline{X} = \begin{bmatrix} 0 & 0 & -\nu I \end{bmatrix}$ , where  $0 < \nu < 2(1 + \Lambda D_{z\phi})^{-1}$ and the change of variables  $\overline{M}(z) \sim (A_m, B_m, \overline{C}_m, 1)$ , for

$$\overline{C}_{m} = \left[ \overline{m}_{n_{M}} \ \overline{m}_{(n_{M}-1)} \ \cdots \ m_{1} \right] 
= \left[ (\rho^{(n_{M}-1)} m_{n_{M}}) \ (\rho^{(n_{M}-2)} m_{(n_{M}-1)}) \ \cdots \ m_{1} \right],$$
(14)

and

$$\overline{A}_{p} = \overline{A}_{cl} = \rho A + B_{u} \hat{K} C_{y}$$

$$\overline{B}_{p} = \overline{B}_{cl} = \rho B_{\phi} + B_{u} \hat{K}_{\phi}$$

$$\overline{C}_{p} = \rho C_{p}$$
(15)

with  $\rho > 0$ ,  $\hat{K} = \rho K$  and  $\hat{K}_{\phi} = \rho K_{\phi}$ . Then, the conditions of Theorem 1 always have a feasible solution with a sufficiently small value of  $\rho$ .

**Proof.** The ZF multiplier  $\overline{M}(z) \sim (A_m, B_m, \overline{C}_m, 1)$  can be equivalently rewritten as,

$$\overline{M}(z) = \overline{C}_m (zI - A_m)^{-1} B_m + 1$$
$$= C_m (zI - \rho A_m)^{-1} B_m + 1.$$
(16)

Then, by (16) and from the choices made in (15), one has

$$\overline{A}_{I} = \begin{bmatrix} \rho A + B_{u} \hat{K} C_{y} & 0\\ \rho B_{m} C_{p} & \rho A_{m} \end{bmatrix}, \ \overline{B}_{I} = \begin{bmatrix} \rho B_{\phi} + B_{u} \hat{K}_{\phi}\\ B_{m} (1 - \Lambda D_{\phi}) \end{bmatrix}$$
$$\overline{C}_{I} = \begin{bmatrix} \rho C_{p} & C_{m} \end{bmatrix}.$$

With  $\overline{A}_I$ ,  $\overline{B}_I$ ,  $\overline{C}_I$  in inequality (11), and fixing  $X_1 = X_2 = 0$  and  $X_3 = -vX_4 = 0.5I$ , one has

$$\begin{bmatrix} -P & -\overline{C}_I^T & 0 & \overline{A}_I^T \\ \star & -2D_I & 0 & \overline{B}_I^T \\ \star & \star & P - \nu I & 0 \\ \star & \star & \star & -\frac{1}{\nu}I \end{bmatrix} < 0.$$

With a sufficiently small value of  $\rho$ ,  $K = K_{\phi} = 0$  and  $C_m = 0$  (note that the conditions of Lemma 3 remain feasible), and applying a Schur complement, one has

$$\begin{bmatrix} P & 0 & 0 \\ \star & 2D_I - v\overline{B}_I^T \overline{B}_I & 0 \\ \star & \star & vI - P \end{bmatrix} > 0.$$

Blocks (1,1) and (3,3) of the above inequality are feasible with 0 < P < vI. Finally, block (2,2) is feasible with the choice  $0 < v < 2(1 + \Lambda D_{z\phi})^{-1}$ , because

$$2D_I - \nu \overline{B}_I^T \overline{B}_I = 2(1 + \Lambda D_{z\phi}) - \nu (1 + \Lambda D_{z\phi})^2 B_m^T B_m$$
$$= 2 - \nu (1 + \Lambda D_{z\phi}) > 0,$$

since  $(1 + \Lambda D_{z\phi}) > 0$  by assumption (3).

Note that, adopting the initialization proposed by Theorem 2, Theorem 1 always produces a feasible solution thanks to the parameter  $\rho$ , which is a relaxation factor in matrices  $A_p$ ,  $B_p$ ,  $C_p$ of the closed-loop system. With the proposed change of variables,  $\rho$  appears affinely in condition (11). This way,  $\rho$  can be maximized as an objective function to find the stabilizing gains K and  $K_{\phi}$  and also a valid multiplier  $\overline{M}(z)$  which certificates the stability of the original Lur'e system ( $\rho = 1$ ). While  $\rho < 1$ the resulting matrices  $X_i^T$ , i = 1, ..., 4 can be used as new values of  $\overline{X}_i$ , i = 1, ..., 4, thus generating a new feasible solution. This is possible because (11) is structured in the form *ii*) of Finsler's Lemma, i.e., Q+He(XB) < 0. Then, as He(XB) = He( $B^TX^T$ ), the choice  $B = X^T$  guarantees a feasible solution in a new test, ensuring that the value of  $\rho$  cannot decrease.

The iterative procedure is presented in Algorithm 1 (the index  $(\cdot)_{it}$  represents the value of the variable at iteration it). The input parameters are  $it_{max}$ , which defines a stopping criterion,  $n_M$ , multiplier order, and  $\overline{X}$ , the initial matrix required by Theorem 1. If  $\rho \ge 1$  at some iteration, then the stability of the closed-loop Lur'e system is certified. Unfortunately, although the sequence of values for  $\rho$  is non-decreasing, the convergence to a value greater than 1 cannot be assured.

Next theorem states that, if  $\rho > 1$  is obtained, then the controller gains and the FIR ZF multiplier M(z) for the original system ( $\rho = 1$ ) can be computed as a convex combination of the solutions of two consecutive iterations.

*Theorem 3.* Let  $\overline{A}_p$ ,  $\overline{B}_p$ ,  $\overline{C}_p$  and  $\overline{C}_m$  be as given in Theorem 2 and consider the existence of two consecutive solutions of conditions of Lemma 3 and (11) provided by Algorithm 1, respectively at iterations k and k+1, such that

$$Q_k + \text{He}(X_k X_{k-1}^T) < 0, \quad \rho_k < 1,$$
 (17)

$$Q_{k+1} + \text{He}(X_{k+1}X_k^I) < 0, \quad \rho_{k+1} > 1.$$
 (18)

Then, the controller gains *K* and  $K_{\phi}$  and the ZF multiplier M(z) for the original system (i.e., for  $\rho = 1$ ) are obtained from a convex combination of the solutions at iterations *k* and *k*+1.

**Proof.** Consider the nonnegative scalars  $\zeta_k$  and  $\zeta_{k+1}$  such that,

$$\zeta_k + \zeta_{k+1} = 1, \quad \zeta_k = \frac{\rho_{k+1} - 1}{\rho_{k+1} - \rho_k}, \ \zeta_{k+1} = \frac{1 - \rho_k}{\rho_{k+1} - \rho_k}.$$

Multiplying (17) by  $\zeta_k$  and (18) by  $\zeta_{k+1}$ , and summing up, one has

$$\begin{aligned} \zeta_k \left( Q_k + \operatorname{He}(X_k X_{k-1}^T) \right) + \zeta_{k+1} \left( Q_{k+1} + \operatorname{He}(X_{k+1} X_k^T) \right) \\ &= \zeta_k Q_k + \zeta_{k+1} Q_{k+1} + \operatorname{He}(\zeta_k X_k X_{k-1}^T + \zeta_{k+1} X_{k+1} X_k^T) < 0. \end{aligned}$$
(19)

Regarding the term  $\zeta_k Q_k + \zeta_{k+1} Q_{k+1}$ , one has for the block  $A_I$ 

$$\zeta_{k} \begin{bmatrix} \rho_{k}A_{p} + B_{u}\hat{K}_{k}C_{y} & 0\\ \rho_{k}B_{m}C_{p} & A_{m} \end{bmatrix} + \zeta_{k+1} \begin{bmatrix} \rho_{k+1}A_{p} + B_{u}\hat{K}_{k+1}C_{y} & 0\\ \rho_{k+1}B_{m}C_{p} & A_{m} \end{bmatrix}$$
$$= \begin{bmatrix} A_{p} + B_{u}(\zeta_{k}\hat{K}_{k} + \zeta_{k+1}\hat{K}_{k+1})C_{y} & 0\\ B_{m}C_{p} & A_{m} \end{bmatrix} = \begin{bmatrix} A_{p} + B_{u}\overline{K}C_{y} & 0\\ B_{m}C_{p} & A_{m} \end{bmatrix}$$

and similarly for  $B_I$  and  $C_I$ 

$$\begin{split} \zeta_{k} \begin{bmatrix} \rho_{k}B_{\phi} + B_{u}\hat{K}_{\phi,k} \\ B_{m}D_{p} \end{bmatrix} + \zeta_{k+1} \begin{bmatrix} \rho_{k+1}B_{\phi} + B_{u}\hat{K}_{\phi,k+1} \\ B_{m}D_{p} \end{bmatrix} \\ &= \begin{bmatrix} B_{\phi} + B_{u}(\zeta_{k}\hat{K}_{\phi,k} + \zeta_{k+1}\hat{K}_{\phi,k+1}) \\ B_{m}D_{p} \end{bmatrix} = \begin{bmatrix} B_{\phi} + B_{u}\overline{K}_{\phi} \\ B_{m}D_{p} \end{bmatrix}, \\ \zeta_{k} \begin{bmatrix} \rho_{k}C_{p} \ \overline{C}_{m,k} \end{bmatrix} + \zeta_{k+1} \begin{bmatrix} \rho_{k+1}C_{p} \ \overline{C}_{m,k+1} \end{bmatrix} \\ &= \begin{bmatrix} C_{p} \ (\zeta_{k}\overline{C}_{m,k} + \zeta_{k+1}\overline{C}_{m,k+1}) \end{bmatrix} = \begin{bmatrix} C_{p} \ \overline{C}_{m} \end{bmatrix}. \end{split}$$

Since (19) holds and the convex combination also preserves the positive realness condition, the ZF multiplier associated with  $\rho = 1$  given by  $M(z) \sim (A_m, B_m, \overline{C}_m, 1)$  assures closedloop stability with the gains  $K = \overline{K}$  and  $K_{\phi} = \overline{K}_{\phi}$ .

#### 4. EXAMPLES

In this section, numerical examples are presented to illustrate the performance of Algorithm 1 (named A1) in stability analysis (fix  $K = K_{\phi} = 0$ ), and in control design with state, namely with  $C_y = I$ , and output feedback. Both FIR multipliers for odd and non-odd nonlinearities are investigated. The initial choices proposed for A1 are  $it_{max} = 250$  and  $v = (1 + \Lambda D_{z\phi})^{-1}$ . Although the proposed method could deal with any given order for the ZF multipliers,  $n_M = 2$  has been fixed in all tests for simplicity.

In the experiments, A1 is compared with the method from Bertolin et al. (2022b) (B22), that performs a line search of parameter  $\alpha \in (0, 1)$  (related with a bound to the  $\ell_1$  norm of the ZF multiplier) as follows: *i*) A bisection is used to find the maximum value of  $\Lambda$ , considering 10 equally spaced points for  $\alpha \in (0,1)$ ; *ii*) For the value of  $\alpha$  that provided the best  $\Lambda$  in the previous step (defined by  $\alpha^*$ ), two new bisections are performed, first considering 10 equally spaced points in the interval  $\alpha \in [0.75\alpha^*, 1.25\alpha^*]$ , obtaining a new  $\alpha^*$  and then using 50 equally spaced points for  $\alpha \in [0.9\alpha^*, 1.1\alpha^*]$  (70 searches in total). The implementation was made in Matlab-2022 using the Yalmip parser (Löfberg (2004)) and the Mosek solver (Andersen and Andersen (2000)), on a computer with Windows 10 operating system and Core i7 processor.

#### Experiment 1 – Stability analysis

Seven Lur'e systems from the literature are investigated. Systems 1 to 6 are from Carrasco et al. (2020) and system 7 is from Bertolin et al. (2022b). The aim of the experiment is to search for the maximum value of  $\Lambda$  such that each system remains stable. For this purpose, the search for the maximum value is performed by a bisection procedure in  $\Lambda$  with precision given by  $10^{-3}$ . Using a transformation on the system matrices, A1 can provide ZF multipliers M(z) that are causal (c) or anticausal (ac). Table 1 shows the results obtained using algorithm A1, and also (for comparison) the results from Bertolin et al. (2022b) (B22) also considering second order ZF multipliers, and from Carrasco et al. (2020) (C20) — noncausal FIR ZF multipliers with  $n_f = n_b$ , i.e., same number of causal and anticausal terms, presented in parenthesis.

As can be noted in Table 1, C20 provides the best results for stability analysis, both in terms of larger values for  $\Lambda$  and smaller computational effort. Neither A1 nor B22 compete with C20 in terms of stability analysis but, differently from C20, both can be extended to cope with the problem of control design for discrete-time Lur'e systems, as presented next. In a

comparison between A1 and B22, one can note that A1 presents superior values of  $\Lambda$  on almost all systems for both causal and anti-causal ZF multipliers. Moreover, the computational time spent by A1 is substantially smaller (order of hundred times) than the one required by B22, due to the scalar search performed on  $\alpha \in (0, 1)$  by the method from B22.

#### Experiment 2 – Control design

Since the main objective of this work is the synthesis of output feedback control laws for discrete-time Lur'e systems, this experiment evaluates the performance of A1 for the control design of state (sf) and output (of) feedback gains. For that, matrices  $B_{\mu}$  are given by (as in Bertolin et al. (2022b))

$$(1,6,7) : B_u^T = \begin{bmatrix} 0 & 1 \end{bmatrix}, \quad (2,3) : B_u^T = \begin{bmatrix} 0 & 1 & 0 & 0 \end{bmatrix}$$
  
(4) :  $B_u^T = \begin{bmatrix} 0 & 1 & 0 & 0 & 0 \end{bmatrix}, \quad (5) : B_u^T = \begin{bmatrix} 0 & 1 & 0 & 0 \end{bmatrix},$ 

(4) .  $B_u = [0, 1, 0, 0, 0]$ ,  $(3) \cdot B_u = [0, 1, 0]$ , and  $C_y = C_z$ . As in the analysis experiment, the maximum value of  $\Lambda$  for each system is computed through a bisection procedure. In all the cases, A1 is first used with the conditions that ensure stability for non-odd nonlinearities. After convergence, the value of  $X^T$  obtained at the last iteration is used as  $\overline{X}$  to initialize the algorithm in the search for the largest  $\Lambda$ associated with odd nonlinearities. This strategy can always be used since the feasibility of (8) implies that (9) always admits a solution. Moreover, with this initialization, the values of  $\Lambda$ cannot be smaller than the ones previously obtained for nonodd nonlinearities, resulting in less computational effort for A1 when dealing with the odd case.

The results (maximum values of  $\Lambda$  and time demanded *t*, in seconds) are shown in Table 2. As can be noted, when compared with B22, A1 demands considerably lower computational times for all the cases, being also superior in terms of the achievable values of  $\Lambda$  for almost all the systems investigated. Moreover, A1 can deal with both odd and non-odd nonlinearities while B22 is restricted tohe case of odd nonlinear functions. It is worth to mention that other values of  $\Lambda$  (possibly greater) could be obtained by increasing the order  $n_M$  of the ZF multiplier.

#### 5. CONCLUSIONS

An LMI-based iterative method has been proposed for the stability analysis of discrete-time Lur'e systems through FIR ZF multipliers of any given order, with immediate extension to cope with static output and state feedback control. Both odd and non-odd nonlinearities are considered. Anti-causal multipliers can also be obtained with a transformation on the system matrices. Future work will investigate noncausal FIR ZF multipliers with arbitrary number of causal and anti-causal terms for both stability analysis and control design using integral quadratic constraints (IQC) based strategies.
