## Diagohexagons and diagohexagonal sequences

Let  $\mathcal{P}=A_1A_2A_3A_4A_5A_6$  be a strictly convex hexagon. The intersections of its nine diagonals which are interior to  $\mathcal{P}$  form a «constellation» of fifteen or possibly only thirteen distinct points. The «major» diagonals»  $(A_1A_4)$ ,  $(A_2A_5)$  and  $(A_3A_6)$  of  $\mathcal{P}$  intersect in the vertices of a triangle (possibly reduced to one point) which is here called the *diagonal triangle* of  $\mathcal{P}$ :  $T_1=(A_1A_4)\cap (A_2A_5)$ ,  $T_2=(A_2A_5)\cap (A_3A_6)$  and  $T_3=(A_3A_6)\cap (A_1A_4)$ . There are moreover two interesting subfamilies of diagonal intersections, both having the cardinal 6.

The convex envelope of the constellation is the strictly convex hexagon  $\mathfrak{D}_1$ , the vertices of which  $\left(D_k^{(1)}\right)_{1\leq k\leq 6}$  are defined (modulo 6) by  $D_k^{(1)}=(A_kA_{k+2})\cap(A_{k+1}A_{k+3})$ . It will be said that  $\mathfrak{D}_1$  is the *primary diagohexagon* of  $\mathcal{P}$  and that for every  $k\in [1;6]$ ,  $D_k^{(1)}$  is the vertex of  $\mathfrak{D}_1$  corresponding to  $A_k$ . And we will call *primary diagohexagonal sequence* of  $\mathcal{P}$  the sequence of strictly convex hexagons  $(\mathfrak{D}_n)_{n\in\mathbb{N}}$  obtained by the recurrent construction :

$$\begin{cases} \mathfrak{D}_0 = \mathcal{P} & (\forall \ k \in \llbracket 1; 6 \rrbracket, \ \ D_k{}^{(0)} = A_k) \\ \text{For every } n \in \mathbb{N}, \ \ \mathfrak{D}_{n+1} = \left(D_k{}^{(n+1)}\right)_{1 \leq k \leq 6} \ \ \text{is the primary diagohexagon of } \mathfrak{D}_n = \left(D_k{}^{(n)}\right)_{1 \leq k \leq 6} \end{cases}$$

For every  $n \in \mathbb{N}$ , the hexagon  $\mathfrak{D}_n$  will then be called the n-th order primary diagohexagon of  $\mathcal{P}$ .

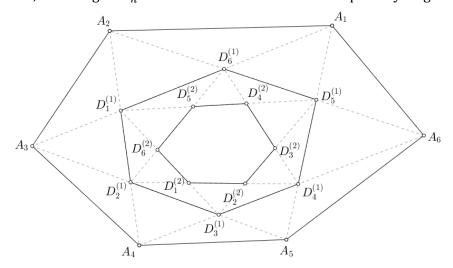


Figure 1: Three first terms of a primay diagohexagonal sequence

From the hexagon  $\mathcal P$  can also be obtained the strictly convex hexagon  $\mathcal H_1$ , the vertices of which are the points  $\left(H_k^{(1)}\right)_{1\leq k\leq 6}$  defined (modulo 6) by  $H_k^{(1)}=(A_kA_{k+3})\cap(A_{k+1}A_{k+5})$ .

It will here be said that  $\mathcal{H}_1$  is the *secondary diagohexagon* of  $\mathcal{P}$  and that for every  $k \in [1; 6]$ ,  $H_k^{(1)}$  is the vertex of  $\mathcal{H}_1$  corresponding to  $A_k$ . It is then possible to define recurrently the *secondary diagohexagonal sequence* of  $\mathcal{P}$ , as the sequence of strictly convex hexagons  $(\mathcal{H}_n)_{n \in \mathbb{N}}$  obtained by :

$$\begin{cases} \mathcal{H}_0 = \mathcal{P} & (\forall \ k \in \llbracket 1; 6 \rrbracket, \ \ H_k^{(0)} = A_k) \\ \text{For every } n \in \mathbb{N}, \ \ \mathcal{H}_{n+1} = \left( H_k^{(n+1)} \right)_{1 \leq k \leq 6} \ \ \text{is the secondary diagohexagon of } \mathcal{H}_n = \left( H_k^{(n)} \right)_{1 \leq k \leq 6} \end{cases}$$

For every  $n \in \mathbb{N}$ , the hexagon  $\mathcal{H}_n$  will be called the n-th order secondary diagonexagon of  $\mathcal{P}$ .

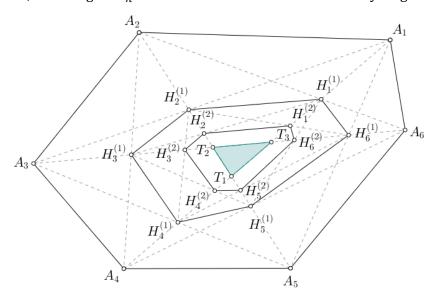


Figure 2: Three first terms of a secondary diagohexagonal sequence

The main results demonstrated in this paper by means of projective as well as algebraic and topological arguments, are the following ones:

#### Theorem 1

There exist a unique homography h such that  $h(A_k) = D_k^{(2)}$  for every  $k \in [1; 6]$ , hence such that  $h(\mathcal{P}) = \mathfrak{D}_2$ . More generally,  $h(\mathfrak{D}_n) = \mathfrak{D}_{n+2}$  for every  $n \in \mathbb{N}$ . h will be called the *diagohexagonal homography* of  $\mathcal{P}$ .

#### Theorem 2

The major diagonals of  $\mathcal{P}$  are concurrent if, and only if its first order primary diagohexagon is inscribable in a conic curve.

#### Theorem 3

The diagohexagonal homography h of  $\mathcal P$  has a unique fixed point  $\Omega$  interior to  $\mathcal P$  and the primary diagohexagonal sequence  $(\mathfrak D_n)_{n\in\mathbb N}$  of  $\mathcal P$  converges toward  $\Omega$ .  $\Omega$  will be called the *diagonal center* of  $\mathcal P$ .

#### Theorem 4

If  $\mathcal P$  is inscribable in a conic curve, then each of its successive secondary diagohexagons is inscribable in a conic curve.

#### Theorem 5

The secondary diagohexagonal sequence of  $\mathcal P$  converges toward the diagonal triangle of  $\mathcal P$ .
