





Questionnaire testing phase (N=10) - *December 2022*

Investigation phase – *January 2023 / August 2023*

A 5-part questionnaire

1. General characteristics of the farm
2. Crop protection practices
3. Work on the farm
4. Discrete Choice Experiment
5. The respondent's projections, perceptions and attitudes





On average for our sample (N=94) :

- 125 ha of UAA
- 97 dairy cows
- 9 016 L per dairy cows per year

- ❑ **The three work dimensions have an effect on the preferences of the farmers surveyed, but differently depending of their characteristics.**
- ❑ **2 levels to highlight :**
 - ✓ « Increase in the number of peaks without delegation or salaried employment »
 - ✓ « More mental workload »
