Complexity of multi-objective decision making for epidemics and

pandemics in a globalised world [Saker et al., 2004] [Bickley et al., 2021]

 \rightarrow current models for decision-making range from mathematical models [Brauer, 2008] to data-driven simulation models [Buczak et al., 2012]

 \rightarrow agent-based modelling as a flexible and generic modelling tool particularly suited for decision-making [Miksch et al., 2019] [Minoza et al., 2021]

 \rightarrow validation, exploration and sensitivity analysis of ABMs and other approaches not frequent in the literature [Baquela and Olivera, 2022][Wu et al., 2013]

 \rightarrow how can extensive model validation techniques be used for stylised models?

Research question

We build a stylised ABM for the spread of infectious disease which focuses on masking and vaccination and apply model validation methods, to investigate if lack of data and uncertainty can be compensated for through model validation.

- Realistic geographical context, with commuting of workers simulated through the day (1h tick) for 365 days
- Simple SIRV agent dynamics within places (public transport and workplace)
- 4 transportation modes and a stylised setup for company sizes
- *N* = 1500 agents randomly assigned, with less than 1% daily renewed (open world)

Model dynamics

Global variables: stylised contact rates for transport $c_{bus} = 40\%$, $c_{metro} = 35\%$, $c_{train} = 30\%$, $c_{walk} = 10\%$, $c_{car} = 10\%$ and companies $c_{Big} = 40\%$, $c_{Medium} = 35\%$, $c_{Small} = 30\%$

Agent variables: higher infection rate for cardio-vascular sick individuals [lelapi et al., 2020]

 \rightarrow predefined infection risk rates depending on agent characteristics: No mask & Cardio = 50% risk rate; Mask & Cardio = 45%; No mask & Cardio = 15%; Mask & No Cardio = 10%

Model parameters explored:

- Infectious period (2-4 weeks)
- Immunity period (9-11 months)
- Vaccination rate
- Social distancing level (3 levels, each reducing contact rate by 5%)

Model indicators: agents in each state, cumulated infections and vaccinations.

 \rightarrow model implemented in NetLogo (role of visualisation and interactivity in the model construction process)

 \rightarrow embedded into the OpenMOLE platform for model exploration and validation [Reuillon et al., 2013]



 \rightarrow 4 dimensions parameter space explored through numerical experiments

Statistical Distributions of Agents by the Model's Ouput Parameters

LHS sampling (10,000 points) to study statistical properties of model indicators: skewed distributions (Left), distributions of the proportion of agents in each state (Right)

Grid exploration





Grid exploration of 81 parameter points (125 stochastic repetitions for each): various amplitude of parameter influence (Left), confirmed with an OLS regression, and correlation matrix of model inputs and outputs (Right)

Importance of the Model Inputs

Random forest model surrogate trained on LHS simulation data (performance: MAE=0.001): feature importance of input parameters.

Multi-objective model optimisation



NSGA2 bi-objective optimisation to find compromise points between disease burden and vaccination (cost): Pareto front of proportion of sick vs. social distancing levels (Left), and corresponding points on other objectives (Right).



 \rightarrow proof-of-concept of how model exploration and validation can compensate for parameter uncertainty and the lack of data

 \rightarrow open question: transfer to policy scenarios, which practical validated insights from such hybrid approaches

 \rightarrow model can be refined in several ways (e.g. agent states, more characteristics)

 \rightarrow sensitivity to geography and to the company setup [Raimbault et al., 2019] to be explored



 \rightarrow a simple and stylised ABM based on SIRV accounting for geography and commuting

 \rightarrow systematic exploration and sensitivity analysis: prospects on how to design and optimise health policies in cases where data or modelling resources are lacking
