# **The pharmacological perturbation OPENof brain zinc impairs BDNFrelated signaling and the cognitive performances of young mice**

**Zinc (Zn<sup>2</sup><sup>+</sup>) is a pleiotropic modulator of the neuronal and brain activity. The disruption of intraneuronal Zn<sup>2</sup><sup>+</sup> levels triggers neurotoxic processes and afects neuronal functioning. In this study, we investigated how the pharmacological modulation of brain Zn2<sup>+</sup> afects synaptic plasticity and cognition in wild-type mice. To manipulate brain Zn2+ levels, we employed the Zn2<sup>+</sup> (and copper) chelator 5-chloro-7-iodo-8-hydroxyquinoline (clioquinol, CQ). CQ was administered for two weeks to 2.5-monthold (m.o.) mice, and efects studied on BDNF-related signaling, metalloproteinase activity as well as learning and memory performances. CQ treatment was found to negatively afect short- and longterm memory performances. The CQ-driven perturbation of brain Zn2<sup>+</sup> was found to reduce levels of BDNF, synaptic plasticity-related proteins and dendritic spine density** *in vivo***. Our study highlights the importance of choosing "when", "where", and "how much" in the modulation of brain Zn2<sup>+</sup> levels. Our fndings confrm the importance of targeting Zn2<sup>+</sup> as a therapeutic approach against neurodegenerative conditions but, at the same time, underscore the potential drawbacks of reducing brain Zn2<sup>+</sup> availability upon the early stages of development.**

The neurotrophin brain-derived neurotrophic factor (BDNF) critically modulates the plasticity of the Central Nervous System (CNS) with a broad spectrum of activities that spread from neuronal diferentiation and survival to synaptogenesis and activity-dependent synaptic plasticity<sup>1,2</sup>.

BDNF is synthesized as pre-pro-BDNF, further cleaved into pro-BDNF $3-5$  and into its mature counterpart (mBDNF) in the endoplasmic reticulum (ER) and the trans-Golgi apparatus<sup>6</sup>. mBDNF is released by an activity-dependent mechanism or frst extruded as pro-BDNF in the extracellular space and then processed to mBDNF by extracellular proteases, like plasmin or metalloproteinases (MMPs; and MMP-2 and 9 in particu- $\arctan(7-11)$ . The balance between pro-BDNF and mBDNF has significant biological implications as the immature and mature forms of the protein, by activating distinct class of receptors<sup>12,13</sup>, exert different actions on synaptic plasticity and neuronal survival14,15. mBDNF promotes neuroprotective activity in *in vitro* and *in vivo* preclinical models of neurodegeneration<sup>16-18</sup>. Preclinical findings are paralleled by evidence in human studies that indicate that high serum levels of mBDNF, as well as high *BDNF* gene expression, are associated with a reduced risk of dementia in elderly subjects and a milder disease course in dementia patients<sup>19-21</sup>. mBDNF and its preferred

receptor TrkB play a crucial role in the plasticity-related modifcations of spines by promoting spine pruning and enlargement. pro-BDNF and its receptor p75NTR exert pro-apoptotic activity and negatively afects the dendritic structure and spine density<sup>14,22</sup>. The regulation of spine morphology, a phenomenon defined as structural plasticity, is one of the molecular underpinnings of cognition and learning and memory in particular<sup>23</sup>.

The metalloproteinase, MMP-9, is highly enriched in the hippocampus, the cerebral cortex, and the cerebellum24, brain regions where the enzyme is localized in the extracellular matrix near the dendritic spines of excitatory synapses<sup>25</sup>. MMP-9 contributes to learning, memory and neuronal plasticity by promoting the spine remodelling and immobilization of ionotropic receptors that occur upon long-term potentiation (LTP) stimulation26,27. In preclinical models of Alzheimer's disease (AD), the functional overexpression of MMP-9 increases the brain levels of mBDNF and prevents the development of AD-related cognitive deficits<sup>28,29</sup>. MMP-9 is structurally characterized by a 3-histidine zinc-binding catalytic motif (His-Glu-Xaa-Xaa-His) and requires zinc  $(Zn^{2+})$  to exert its proteolytic activity $30$ .

 $Zn^{2+}$  is largely present in the CNS, stored within synaptic vesicles at several glutamatergic nerve terminals, and synaptically released upon neuronal activity<sup>31,32</sup>.  $\text{Zn}^{2+}$  affects neuronal processes as well as BDNF signaling<sup>33</sup>. The metal, through MMP activation, promotes the cleavage of pro-BDNF to mBDNF9,10. Zn<sup>2+</sup> also modulates BDNF signaling without affecting the MMP activity. This activity is achieved by direct transactivation of TrkB, the preferred and high-affinity BDNF receptor<sup>34</sup>. In addition, *in vivo* administration of Zn<sup>2+</sup> increases the cortical levels of the BDNF mRNA35, thereby indicating a pro-transcriptional activity of the cation.

In a preclinical transgenic AD model, we have previously shown that long-term dietary supplementation of  $Zn^{2+}$  promotes the activation of MMP-2 and MMP-9, increases the brain levels of mBDNF, and counteracts the development of AD-related pathology and memory deficits<sup>36</sup>.

In this study, we investigated how the pharmacological modulation of brain  $Zn^{2+}$  affects BDNF signaling, synaptic plasticity, and cognition in young mice. The rationale behind the experimental design and the choice of employing young animals is twofold. First, recent evidence indicate that deficiency in synaptic  $\rm Zn^{2+}$  affects brain development by impairing BDNF signaling<sup>10</sup>; second, we aimed at evaluating effects related to the perturbation of brain  $\text{Zn}^{2+}$  homeostasis in young mice, a setting that, on the contrary of aging- or degeneration driven models<sup>37</sup>, is devoid of signs of  $\text{Zn}^{2+}$  deregulation. To manipulate brain  $\text{Zn}^{2+}$  levels, we employed the  $\text{Zn}^{2+}$  (and copper) chelator 5-chloro-7-iodo-8-hydroxyquinoline (clioquinol, CQ) as previous studies have shown that the intraperitoneal administration of CQ promotes a rapid reduction in the brain pool of chelatable  $\rm Zn^{2+38-43}$ . CQ was administered for two weeks to 2.5-month-old (m.o.) mice and efects studied on BDNF-related signaling, MMP activity as well as learning and memory performances.

#### **Results**

**CQ administration impairs learning, short- and long-term memory performances in young mice.** Male C57Bl/6 mice were treated, for 2 weeks, with daily intraperitoneal (i.p.) injections of CQ (30mg/ kg). The rationale for choosing this concentration and route of administration was threefold: (1) this CQ concentration has been shown to be devoid of signifcant side efects in rodents including changes in body weight (Fig. 1B; 25.8  $\pm$  1.6 g in control vs 24.9  $\pm$  0.91 in CQ treated mice, p = 0.64); (2) the dose matches the one employed in clinical trials; (3) the i.p. route is highly effective in reducing the pool of chelatable  $\text{Zn}^{2+}$  in the brain and the hippocampus in particular<sup>38,44</sup>. In agreement with previous studies<sup>38-43</sup>, we obtained a significant decrease of hippocampal  $Zn^{2+}$  levels (Supplementary Fig. 1; normalized TSQ fluorescence in control: 1.00  $\pm$  0.08 vs  $0.49 \pm 0.04$  in CQ-treated mice,  $p < 0.001$ ).

The effects of CQ or vehicle on hippocampus-dependent spatial learning were assessed, at the end of the second week of treatment, with the Morris Water Maze (MWM) test, a widely employed task that evaluates memory performances in rodents<sup>45</sup> (Fig. 1A). Compared to vehicle-treated mice, CQ-treated animals displayed learning impairment. CQ-treated mice showed a statistically-signifcant increase in the time spent to reach the platform upon the first two training sessions (Fig. 1C; day 1 p < 0.01, day 2 p < 0.001). These learning deficits were transient and disappeared in the final two days of training (Fig. 1C; day 3 p=0.069, day 4 p=0.16). The analysis of memory performances revealed that, compared to vehicle-treated animals, CQ-treated mice performed signifcantly worse in Short- (1.5h) and Long-Term (24h) Memory (STM and LTM, respectively) skills. The CQ-treated group showed a decreased number of platform crosses (Fig. 1D; for STM:  $4.69 \pm 0.69$  in control vs  $2.15 \pm 0.54$  in CQ-treated mice,  $p = 0.008$ ; for LTM:  $4.3 \pm 0.9$  in control vs  $1.73 \pm 0.38$  in CQ-treated mice,  $p = 0.04$ ) and longer times to reach the platform location (Fig. 1E, escape latency for STM:  $8.84 \pm 1.5$  s in control vs  $26.38 \pm 5.6$  s in CQ-treated mice,  $p = 0.007$ ; escape latency for LTM:  $12.9 \pm 5$  s in control vs 29.58  $\pm$  5.9 s in CQ-treated mice,  $p=0.01$ ). No significant differences, between the two study groups, were observed as far as the time spent in the target or opposite quadrants (Fig. 1F,G, T-target, and T-opposite, respectively). Additional analysis showed no signifcant diferences between the two study groups regarding swimming speed or the total distance travelled upon the LTM probe trial (Fig. 1H,I;  $p = 0.43$  for the swimming speed and  $p = 0.71$  for the distance travelled), thereby indicating that the CQ-mediated efects were not driven by decreased motivational cues or impaired swimming abilities.

**CQ reduces BDNF signaling in treated mice.** Zn<sup>2+</sup> has been shown to promote pro-BDNF maturation *in vitro<sup>9</sup>*. Western blot (WB) analysis of brain samples revealed a significant decrease of BDNF levels in CQ-treated mice when compared to vehicle-treated animals (Fig. 2B; see Supplementary Table 1 for the statistics of the WB data). The reduction is region-specific and occurred in the hippocampus, cortex, and striatum but not in the cerebellum. Tese regional changes were matched by parallel decreased levels of the preferred BDNF receptor, TrkB (Fig. 2C). To assess whether BDNF and TrkB reductions afect BDNF-related signaling, we measured brain levels of the activated -phosphorylated- form of TrkB (pTrkB) and ERK5 (pERK5), a downstream effector of the BDNF-TrkB signaling cascade<sup>46</sup>. WB analysis showed no significant differences between CQ- and

vehicle-treated animals in the pTrkB/TrkB ratio (Fig. 2D) while CQ administration induced a signifcant decrease in pERK5 levels (Fig. 2F).

The neurotrophin BDNF, by activating mechanisms related to functional and structural plasticity, is a potent modulator of LTM47. We, therefore, investigated whether the CQ-driven reduction of BDNF and TrkB translates into changes in PSD95 levels, a marker of the post-synaptic integrity. Matching the CQ-related regional changes in BDNF, we found region-specifc decreases of PSD95 in the hippocampus, cortex, striatum, but not in the cerebellum (Fig. 2E).

**CQ promotes p75NTR signaling in treated mice.** Since pro-BDNF-p75NTR activation can modulate neurotoxic activities, we investigated whether the observed CQ-driven impairments of the BDNF-TrkB signaling axis are associated with changes in the pro-BDNF-p75NTR signaling cascade. WB analysis of these pathways showed that, compared to vehicle, CQ treatment promotes a region-specifc increase of p75NTR levels along with high levels of phosphorylated ERK<sub>1,2</sub> (pERK<sub>1,2</sub>; Fig. 2H,I). Surprisingly, the CQ-treatment was also found to decrease pro-BDNF levels in the same brain regions (Fig. 2G). The CQ-driven activation of the p75NTR signaling cascade did not produce overt signs of neurotoxicity *in vitro* and *in vivo* (Supplementary Fig. 2).

**CQ treatment does not afect the hippocampal BDNF mRNA levels.** Previous *in vivo* studies have shown that  $\text{Zn}^2$ + supplementation increases the mRNA expression of BDNF<sup>35</sup>. On the contrary, pharmacological manipulations aimed at reducing the brain  $Zn^{2+}$  levels negatively modulate the BDNF mRNA levels<sup>48</sup>. To address whether CQ-driven Zn<sup>2+</sup> chelation interferes with the *BDNF* expression, we evaluated mRNA levels in the hippocampi of CQ- and vehicle-treated mice. Quantitative Real-Time PCR (qRT-PCR) analysis showed that CQ administration did not affect the hippocampal *BDNF* gene expression (Fig. 2J;  $1.00 \pm 0.02$  in control vs  $1.12 \pm 0.17$  in CQ treated mice, p = 0.54).

**CQ treatment reduces dendritic spine density** *in vitro* **and** *ex vivo***.** As BDNF potently modulates synaptic plasticity<sup>34,49</sup>, we first assessed, in an *in vitro* setting, whether CQ treatment alters the number of dendritic spines and/or their morphology. To that aim, EGFP-transfected primary hippocampal neurons were exposed to CQ (10 µM for 3 days) or vehicle and spines evaluated with confocal microscopy. Confocal imaging analysis showed that, compared to vehicle-treated sister cultures, CQ-treated neurons underwent a signifcant reduction in dendritic spine density (Fig. 3A,B; spines per  $\mu$ m: 0.51  $\pm$  0.07 in control vs 0.22  $\pm$  0.02 in CQ-treated cultures,  $p = 0.020$ ). No differences were found, between the two study groups, regarding spine volumes, areas, diameters or lengths (Fig. 3C–F). To assess whether CQ also impairs spine pruning *in vivo*, we performed Golgi staining on brain slices of treated animals. Compared to vehicle-treated mice, the hippocampal CA1 pyramidal neurons of CQ-treated mice showed a significant decrease (≈−30%) in their dendritic spine density (Fig. 3G,H; spines per  $\mu$ m: 1.41  $\pm$  0.13 in control vs 0.96  $\pm$  0.1 in CQ-treated mice, p = 0.029).

**CQ reduces MMP activity** *in vitro***.** MMPs, and MMP-9 in particular, promote BDNF maturation through the proteolytic cleavage of pro-BDNF<sup>9</sup>. To address whether CQ interferes with MMP activity we performed a gelatin zymographic essay on MMPs isolated from the medium of cultured hippocampal neurons. Afer gel electrophoresis, the MMP developing buffer was supplemented with CQ (10  $\mu$ M) or the high-affinity Zn<sup>2+</sup> chelator TPEN (100µM, here employed as a positive control) and results compared with those of control gels. CQ almost completely abolished the MMP-9 and MMP-2 activity (Fig. 4; normalized MMP-9 activity:  $1.00 \pm 0.09$  in control vs 0.08  $\pm$  0.02 for CQ-treated gels, p < 0.001; normalized MMP-2 activity: 1.00  $\pm$  0.17 in control vs 0.02  $\pm$  0.01 for  $CQ$ -treated gels,  $p < 0.001$ ). Gel treatment with TPEN did not induce further MMP reduction, thereby supporting the notion of a maximal inhibitory activity exerted by  $CQ$  (Fig.  $4A,B$ ).

#### **Discussion**

In this study, we investigated the cognitive effects of  $\text{Zn}^{2+}$  chelation in young mice. Previous studies have shown that intraperitoneal CQ administration promotes a robust reduction of the pool of chelatable  $Zn^{2+}$  in rodents<sup>38–43</sup>. The main finding of the study is that a 2-week administration of CQ exerts adverse effects on learning and memory performances of treated mice. These results are in line with evidence supporting the critical role played by  $Zn^{2+}$  in the modulation of neuronal functioning<sup>32,43,50,51</sup>. The study also indicates that the CQ-dependent effects are mediated by the inhibition of the BDNF neurotrophic axis.

**CQ administration affects BDNF signaling, synaptic plasticity, and behaviour.**  $Zn^{2+}$  chelation profoundly afects mBDNF levels and the related signaling pathway. In CQ-treated animals, we observed a significant reduction in the total content of mBDNF. These changes were associated with a decrease of the total amount of the TrkB receptor. The decreased mBDNF levels that we observed were regionally restricted to the hippocampus, cortex, and striatum (Fig. 2). No efects were detected in the cerebellum, a fnding that is in line with the hypothesis that the CQ-driven activity on BDNF signaling is selectively mediated by  $\text{Zn}^{\bar{2}+}$  removal as the BDNF inhibition does not occur in a region, the cerebellum, that is devoid of pools of chelatable  $\text{Zn}^{2+52}$ . These results also parallel the behavioural fndings as the CQ-dependent cognitive efects are appreciated on a task, the MWM, that evaluates the hippocampus-related memory performances.

mBDNF exerts its neurotrophic action by binding to the TrkB receptor, and the study shows that CQ promotes a signifcant decrease in TrkB receptor levels. Unexpectedly, this result was not associated with a parallel reduction in the phosphorylated, activated, form of TrkB as we fnd that the pTrkB/TrkB ratio is unafected by the drug treatment. The design of our experimental setting may help to explain the discrepancy. In our model, the molecular efects of CQ administration were assessed at the end of the 2-week treatment period. Within this time frame, it is conceivable that the CQ-mediated decrease in mBDNF is sufficient to induce a significant spine remodelling and/or elimination. Tis notion is, indirectly, supported by the observed reduction in PSD95 levels and further confrmed by the *in vitro* and *ex vivo* decreases of spine density that we observed (Fig. 3). Tus, the CQ-driven reduction of dendritic spines may have led to a decrease in the spine-associated transmembrane proteins including TrkB, thereby producing a net reduction of the receptor levels without afecting the pTrkB/TrkB ratio. The idea of defective TrkB signaling is further corroborated by the observed CQ-driven decrease in pERK5 levels, a kinase that acts downstream of the BDNF-TrkB neurotrophic axis and is known to promote neurogenesis and neuronal survival $53,54$  but is also implicated in learning- and memory-related processes $55,56$ .

Our findings support a role for CQ-driven  $\text{Zn}^{2+}$  deprivation in the modulation of synaptic plasticity and dendritic spine pruning. CQ-treated hippocampal neurons show a reduced number of spines when compared with vehicle-treated sister cultures (Fig. 3). Our data are in line with the notion that mBDNF participates in structural plasticity by modulating the spine pruning and morphology<sup>57–59</sup>. These plasticity-related phenomena represent the biophysical underpinning of the processes controlling the experience-dependent information storage occurring within the brain circuitry. Tus, the CQ-driven reduction of mBDNF levels may serve as one of the molecular mechanisms underlying the behavioural impairments observed in our model.

In the study, we investigated the  $Zn^{2+}$ -dependent MMP activity with the aim of providing a mechanistic link between CQ-administration,  $Zn^{2+}$  chelation, and the reduction of mBDNF levels. Among MMPs, MMP-9 plays a permissive role in favouring structural plasticity and promote the dendritic spine expansion<sup>60</sup>. Experimental evidence indicates that LTP-induced increase in spine size requires MMPs proteolytic activity<sup>26</sup> and, conversely, inhibition of MMPs has been shown to impair spatial learning in adult animals<sup>61,62</sup>. In addition, recent findings have shown that MMP-9 participates, in a Zn<sup>2+</sup> dependent manner, to BDNF maturation<sup>9,10</sup>. In agreement with this notion, our *in gel* zymography experiments showed that CQ concentrations as low as 10 µM are sufficient to abolish the MMP gelatinolytic activity (Fig. 4). A further mechanistic link relies on the  $\text{Zn}^{2+}$ -dependent transactivation of TrkB<sup>34</sup>, an event that is likely occluded by CQ administration. While the mechanism is possible from a theoretical standpoint, it is unlikely to have occurred in our setting as we did not observe signifcant changes in TrkB phosphorylation and activation. In addition, a recent report has indicated that the receptor transactivation by Zn2<sup>+</sup> occurs in in *vitro* settings and only marginally *in vivo*49.

This  $Zn^{2+}$ -dependent modulation of the MMP activity is of particular relevance when considering the cation role in synaptic plasticity.  $\text{Zn}^{2+}$  is particularly enriched within synaptic vesicles of a subset of hippocampal glutamatergic terminals<sup>31,32,63</sup>. At these synapses,  $Zn^{2+}$  is released upon neuronal activity and plays a crucial role in the modulation of physiological and pathological processes<sup>32</sup>. Substantiating this critical activity on plasticity and cognition, transgenic mice devoid of the synaptic zinc transporter-3 (ZnT-3 KO mice), and therefore unable to release Zn2<sup>+</sup>, show behavioural and molecular defcits that closely resemble the ones observed in our CQ-treated mice. Further suggesting a commonality of activities between transgenically- or pharmacologically-driven  $\text{Zn}^{2+}$ deprivation, ZnT-3 KO mice, like CQ-treated animals, show alterations in the BDNF-related pathways and plasticity markers<sup>64</sup>.

In summary, CQ administration, by chelating  $Zn^{2+}$ , reduced the MMP activity that, in turn, decreased BDNF maturation and defective structural plasticity, thereby leading to impaired cognitive performances.

**CQ administration modulates neurotoxic pathways in a pro-BDNF-independent manner.** mBDNF is strongly related to its precursor form pro-BDNF. The decrease of mBDNF that we found was associated with the overexpression of the p75NTR receptor as well as with increased  $ERK_{1,2}$  signaling, a pathway that is activated by the pro-BDNF. Our WB data indicate that the treatment also produced decreased of pro-BDNF levels (Fig. 2G). These unexpected results prompted us to investigate whether CQ administration has affected the *BDNF* gene expression as previous studies have shown that changes in  $Zn^{2+}$  availability impinge on *BDNF* expression<sup>35,48</sup>. qRT-PCR experiments, aiming at investigating the issue, indicated that the drug treatment did not alter *BDNF* mRNA levels. The additional targets of MMPs offer a possible explanation for these results. In addition to BDNF, MMPs are known to promote the cleavage and maturation of other pro-neurotrophins, including pro-NGF, a process that activates a deleterious p75NTR-related signaling<sup>65</sup>. An additional, untested, possibility revolves around CQ effects on other intracellular  $\text{Zn}^{2+}$ -dependent proteases that are involved in the BDNF maturation<sup>10,66</sup>. Moreover, the reduction of mature neurotrophins, including mBDNF, can lead to a feed-forward increase of p75NTR expression and activation<sup>67</sup>. Given the fact that TrkB and p75NTR mediate opposite efects13,68, it is therefore conceivable that the mBDNF reduction unleashes a damaging increase in p75NTR levels (Fig. 4H). The hypothesis is unlikely in our setting as the enhanced p75NTR levels did not promote the activation of death pathways. The treatment did not result in increased neuronal toxicity, and the compound was found to be safe and well tolerated (Fig. 1B, and Supplementary Fig. 2). Our p75NTR results, instead ft with previous fndings showing that p75NTR-related signaling facilitates the activation of NMDAR-dependent long-term depression<sup>22,69</sup>, negatively modulates dendritic morphology and spine density in hippocampal pyramidal neurons<sup>4,70</sup>, and contributes to synaptic and memory deficits associated with neurodegenerative conditions<sup>71</sup>. Similarly, aberrant activation of  $ERK_{1,2}$  not only results in the activation of death-related pathways but has been recently implicated in memory impairment in a mouse model of autism<sup>72</sup>.

#### **Conclusions**

Our findings support the notion that  $Zn^{2+}$ , through the activation of the BDNF signaling cascade, is an important modulator of synaptic plasticity, neuronal functioning and cognitive processes. Impairment in the pro-BDNF/ mBDNF signaling cascade may have important clinical implications. Altered neurotrophin biosynthesis and processing has been indicated to be a common feature in several neurological conditions and afect complex human behaviors<sup>73-76</sup>. Pharmacological tools engineered to restore effective BDNF signaling can, therefore, have a great impact on development- aging- or disease-related physio-pathological settings.

CQ has been employed in preclinical models of neurodegenerative diseases (AD and Huntington's disease) with encouraging results $77-80$ . These robust preclinical findings were matched by positive effects in clinical trials exploring the use of CQ or other metal-protein-attenuating compounds (MPACs) in AD patients<sup>81–85</sup>. Our study underscores the importance of choosing "when", "where", and "how much" modulation has to be applied when dealing with brain  $Zn^{2+}$  levels. Our study indicates that in young animals, a model conceivably devoid of overt signs of  $\text{Zn}^{2+}$  dyshomeostasis, the CQ-driven deregulation of physiological brain levels of the cation (Supplementary Fig. 1) as well as the related impaired BDNF-signaling have strong functional and structural consequences. Conversely, when aging- and/or disease- related  $Zn^{2+}$  deregulation has occurred, the use of pharmacological tools, like CQ, to quench the neurotoxic effects of the metal is highly beneficial<sup>80,86,87</sup>, thereby supporting the idea that redistributing  $Zn^{2+}$  in these contexts may overrun potentially negative side-effects on synaptic plasticity and neurotrophic signaling<sup>37,51</sup>. Thus, our findings do not challenge the importance of targeting Zn<sup>2+</sup>, with CQ or similar MPACs, as a therapeutic approach against neurodegenerative conditions but at the same time highlights the potential drawbacks of reducing brain  $Zn^{2+}$  availability in the early stages of development.

#### **Materials and Methods**

**Animal model and treatment paradigm.** All the procedures involving the animal handling and their care were approved by the University G. d'Annunzio Institutional Ethics Committee (CEISA protocol no. AD-301). *In vivo* procedures were performed in compliance with institutional guidelines and in accordance with national and international laws and policies. Mice were bred in the CeSI-MeT animal facility, single-housed, maintained on a 12h light/dark cycle, and provided with*, ad libitum*, access to food and water. Behavioral tests were all performed during the early phases of light cycle (8 am–11 am). C57Bl6 male mice were enrolled at 2.5 months of age (m.o.a.) and randomly assigned to a 2-week CQ or vehicle (see below) administration. Animals were treated daily with an intraperitoneal injection of CQ (30mg/kg body weight) or vehicle. CQ was prepared by frst dissolving the drug in DMSO (80mg/ml) and then diluted in castor oil to a fnal concentration of 4mg/ ml (with a fnal 5% DMSO content).

Mice body weight was measured daily as a gross index of the overall safety of the treatment. A cohort of animals was employed for behavioural assessment, a second group which did not perform a behavioural evaluation, was employed for biochemical analysis.

**Neuronal cultures.** Primary hippocampal neuronal cultures were prepared as previously described<sup>56,88</sup>. Briefy, hippocampi were obtained from C57Bl6 fetuses at 15 or 16 embryonic days (E15-E16). Alternatively, some experiments were performed on hippocampi obtained from CD1 mice. Hippocampi were dissected on ice and transferred in a 0.25% trypsin/EDTA solution for 10 min at 37 °C, then pelleted by centrifugation, and dissociated with a fire-polished glass pipette. The neuronal suspension was then diluted in Neurobasal medium supplemented with 0.5 mM l-glutamine, 5% fetal bovine serum, 5% horse serum,  $1 \times B27$  and 0.2% penicillin/ streptomycin and plated onto pre-treated laminin/poly-dl-lysine coated tissue culture glass coverslips. Three days afer plating, non-neuronal cell growth was inhibited by adding 5 μM of cytosine arabinofuranoside, to obtain near-pure hippocampal cultures. 25% of the medium was replaced with fresh Neurobasal two times per week. Experiments were performed on cultures between 12 and 18 days *in vitro* (12–18 DIV).

Morris Water Maze. The Morris Water Maze (MWM) test was performed as previously described<sup>56,89,90</sup>. In brief, the MWM test was performed with a circular pool (Panlab; 1.2m diameter) filled with warm (22 $\pm$ 1 °C) water. The pool is placed in a room with several intra- and extra-maze visual cues for mice orientation. Mice were habituated to the testing room and placed on the platform 10 s before the frst training session to reduce task-related stress. Mice underwent four trials per day for 4 consecutive days. 1.5 and 24 h afer the end of the last training trial mice were tested for spatial memory performances. 1.5 and 24h probe tests consisted of a 60 s free swim in the pool without the submerged platform. Probe sessions were digitally recorded and analyzed. The following parameters were measured: time to reach the location where the platform used to be (escape latency), number of crosses over the platform location (crosses), time spent in the target (T-target) or opposite (T-opposite) quadrants, average speed (cm/s), and total distance travelled during the LTM session.

**Tissue collection and reagents employed.** Mice were euthanized afer the 2-week treatment and tissue samples collected for further analysis. Brains were halved into two hemispheres, snap frozen by liquid nitrogen, and kept at −80 °C until used. For Western blot (WB) analysis, each hemisphere was dissected into sub-regions (hippocampus, cortex, striatum, and cerebellum), snap frozen in liquid nitrogen, and stored at −80 °C until sampling. For quantitative Real-Time PCR (qRT-PCR) hippocampi obtained from CQ- and vehicle-treated mice were stored in RNA*later* solution (ThermoFisher Scientific) until RNA extraction. For Golgi staining hemispheres were rinsed in PBS and immediately transferred to Golgi-Cox solution following manufacturer instructions (see below). All standard chemicals and reagents were, unless otherwise specifed, purchased from Sigma-Aldrich.

**TSQ staining.** TSQ staining was performed as described by Frederickson *et al.* with slight modifications<sup>91</sup>. Briefy, 3h afer vehicle or CQ administration, mice were sacrifced, brains extracted, and cryosectioned without fxation. 6 µm thick slices were immediately stained with TSQ (100 µM; Santa Cruz Biotechnology) diluted in borate buffer [BB; containing (in mM): 100 boric acid, 25 sodium tetraborate, 75 NaCl, pH 9.5] for 90 s. Slices were then rinsed in PBS and put on coverslips. Images were acquired with a LSM 800 confocal microscope (Zeiss) by exciting the specimen with a 405 nm LED laser source. DRAQ5 (5 µM) was employed to counterstain the neuronal nuclei.

**Protein assay.** Protein concentration was assayed by employing the Pierce BCA Protein Assay kit (Thermo scientifc). Briefy, the assay is a detergent-compatible formulation based on bicinchoninic acid (BCA) for the colorimetric detection and quantitation of total protein. The method combines the reduction of  $Cu^{2+}$  to  $Cu^{+}$  ions by protein in alkaline medium (the biuret reaction) with the high sensitive and selective colorimetric detection of the cuprous cation by using a reagent containing BCA. The purple-colored reaction product of this assay is formed by the chelation of two molecules of BCA with one cuprous ion. This complex exhibits a strong absorbance at 562nm.

**Western blot analysis.** Brain regions were lysated in ice-cold RIPA buffer [pH 7.4 containing (in %): 0.5 sodium deoxycholate, 1 NP-40, 0.1 SDS, 1 protease and phosphatase inhibitor cocktails, and 5 mM EDTA]. Protein lysates (10µg) were separated by electrophoresis on 9–13% SDS–polyacrylamide gel and blotted onto polyvinyl difuoride (PVDF) membrane. Subsequently, membranes were blocked with 5% non-fat dry milk (Bio-Rad Laboratories) in Tris-bufered saline [TBS; containing (in mM): 20 Tris–HCl, 150 NaCl, pH 7.4] for at least 30min at room temperature (RT). Membranes were incubated overnight with primary antibodies diluted in TBS containing 0,1% Tween 20 (TBS-T) and 5% non-fat dry milk.

The antibodies and their final concentration used were: anti-pro-BDNF 1:500 (Millipore), rabbit anti-BDNF 1:1000 (Abcam), rabbit anti-TrkB 1:1000 (Abcam), anti-pTrkB (Abcam), rabbit anti-PSD95 1:1000 (Cell Signaling), mouse anti-pERK<sub>1</sub>, 1:500 (Santa Cruz), rabbit anti-p75NTR 1:20000 (Abcam), rabbit anti-pERK5 1:1000 (Millipore), and rabbit anti-actin 1:2000 (Sigma). Specie-specifc HRP conjugated IgG (1:10000; Vector Laboratories) were employed as secondary antibodies. The obtained chemiluminescent signals were visualized by ECL SuperSignal West Pico PLUS (Thermo scientific) and normalized to actin by using ImageJ software. Values are reported as relative units (R.U.) or phosphoprotein/total protein ratio calculated as: (phosphoprotein/loading control)/(total protein/loading control).

**Golgi staining.** Hemispheres from vehicle- and CQ-treated mice were stained with an enhanced Golgi-Cox staining system (superGolgi Kit, Bioenno Tech), following manufacturer instructions. Briefly, 150 µm thick brain sections were cut using a vibratome (Leica) and mounted on adhesive microscope slides. Air-dried sections were stained, cleared in xylene, coverslipped in Eukitt mounting medium, and stored in the dark until analyzed. Images from secondary dendrites of CA1 pyramidal neurons were acquired with a DMRD microscope (Leica) equipped with a DFC550 CCD camera (Leica) and a  $100 \times$  oil-immersion objective (1.3 NA; Leica). A trained experimenter blind to treatment manually counted the spines.

Gelatin zymography. Gelatin zymography was performed as previously described<sup>36</sup>. SDS-PAGE gels (7.5%) were prepared by incorporating 0.1% gelatin during acrylamide/bis-acrylamide polymerization. In all lanes, 10 µl of the supernatant, obtained from cultured hippocampi, was loaded. Gels were subjected to electrophoresis at 125V constant. Afer electrophoresis, SDS was removed by washing gels for 30min with a renaturating solution containing (in mM): 50 Tris-HCl, pH 7.4, and 2.5% Triton X-100. Gels were further washed with large volumes of ddH2O to remove residual Triton X-100. To assess MMPs activity gels were incubated overnight at 37 °C in an activation buffer containing (in mM): 50 Tris-HCI, pH 7.4, 120 NaCl, 5 CaCl<sub>2</sub>. Accordingly to the experimental setting, activation buffer was supplemented with  $CQ(10\mu)$ , TPEN (100 $\mu$ M), or vehicle (DMSO 1%). Gels were then incubated for 30 min with a developing solution containing (in %): 0.1 Coomassie blue, 40 methanol, 10 acetic acid, 50 ddH2O. Staining was stopped when clear gelatinolytic bands appeared. Gels were photographed with a Gel-Doc apparatus (Biorad) and bands quantifed by densitometry by using the Fiji distribution of ImageJ  $(v 1.51)^{92}$ .

**RNA extraction and qRT-PCR.** The NucleoSpin Tissue RNA isolation kit (Macherey-Nagel) was employed for total RNA extraction. One µg of RNA was retro-transcribed using the High Capacity RNA-to-cDNA Kit (ThermoFisher Scientific).  $qRT-PCR$  was performed in a total volume of 25  $\mu$ l containing 2  $\times$  Maxima SYBR Green/ROX qPCR Master Mix (ThermoFisher Scientific), 1 µL of cDNA and 0.3 µM of each primer on an Abi 7900HT Sequencing Detection System (ThermoFisher Scientific). *BDNF* relative expression was corrected against GAPDH and HPRT1 that were used as endogenous controls. Amplifcation conditions were: 2 minutes at 50°, 10minutes at 95 °C, followed by 40 cycles of 15 seconds at 95 °C and 1minute at 60 °C. A melting curve was run to assess the specificity of primers employed. Samples were run in triplicate. The genes relative fold changes were calculated by the  $\Delta\Delta$ Ct method.

The specific primers employed were: *BDNF* (F 5'-GAGACAAGAACACAGGAGGAAA-3', R 5'-GACTAGGG AAATGGGCTTAACA-3′), *GAPDH* (F 5′-AACAGCAACTCCCACTCTTC-3′, R 5′-GTGGTCCAGGGTTT CTTACTC-3′) and *HPRT1* (F 5′-GGCCAGACTTTGTTGGATTTG-3′, R 5′-CGCTCATCTTAGGCTTTGTA TTTG-3′).

**Neuronal viability assay.** To exclude a possible neurotoxic efect of the compound, we assessed cell viability *in vitro*. Primary hippocampal neurons were exposed for up to 3 days to CQ (10  $\mu$ M) or vehicle (DMSO). CQ toxicity was evaluated by lactate dehydrogenase (LDH) efflux assay as previously described<sup>93</sup>.

Neuronal viability was also indirectly evaluated in Golgi stained *ex vivo* brain slices. Briefy, 20× magnifcation images of hippocampal and cortical areas were acquired and the number of stained neurons per feld was counted and averaged.

*In vitro* **analysis of spine morphology.** Spine morphology analysis was performed by transfecting primary hippocampal neurons with an EGFP containing construct. Transfection was performed at 7 DIV with Lipofectamine 2000 (ThermoFisher) following manufacturer instructions. Transfected cultures were subsequently treated with CQ or vehicle for 3 days. Primary and secondary proximal dendritic processes of CQ- or vehicle-treated transfected neurons were imaged with a LSM 510 META confocal microscope (Zeiss) by exciting the specimen with a 488 nm Argon laser. z-stack imaging series were acquired and stored for further analysis. Dendrites were considered "proximal" when within 50 μm from the soma. Distances from the neuronal body were measured with the Zeiss proprietary ruler tool. 3-dimensional reconstructions were obtained from stacked images and analyzed with the Fiji 3D Object Counter<sup>94</sup> function. Once images were corrected for artifacts (i.e.: fuorescent particles unrelated to the analyzed neuron/region) and background subtracted, the plugin counted the number of the selected 3D particles present in the stack and automatically provided the volume and the surface area of each object. Spine lengths and diameters were, instead, evaluated with a semi-automated approach with the Reconstruct software<sup>95</sup>.

**Statistical analysis.** No methods were employed to predetermine sample size. Statistical analysis was performed by two-tailed Student's t-test. For gelatin zymography ANOVA following Bonferroni post-hoc test was employed. The level of significance was set at  $p < 0.05$ . Data were expressed as mean  $\pm$  SEM.
