Towards experimental confirmation of quarkonia melting in Quark Gluon Plasma: A review of recent measurements of quarkonia production in relativistic heavy-ion collisions

Abstract: The dissociation, or "melting", of heavy quarkonia states due to color charge screening 1 is a predicted signature of the Quark Gluon Plasma (QGP) formation, with a quarkonium state 2 predicted to dissociate when the temperature of the medium is higher than the binding energy of the 3 quarkonium state. A conclusive experimental observation of quarkonium melting coupled with a 4 detailed theoretical understanding of the melting mechanism would enable the use of quarkonia states 5 as temperature probes of the QGP, a long-sought goal in the field of relativistic heavy-ion collisions. However, the interpretation of quarkonia suppression measurements in heavy-ion collisions is complicated by numerous other cold nuclear matter effects which also result in the dissociation of 8 bound quarkonia states. A comprehensive understanding of these cold nuclear matter effects is therefore needed in order to correctly interpret quarkonia production measurements in heavy ion 10 collisions and to observe the melting of quarkonium states experimentally. In this review, recent 11 measurements of quarkonia production in pA and AA collisions and their state-of-the-art theoretical 12 interpretations will be discussed, as well as the future measurements needed to further the knowledge 13 of cold nuclear matter effects and realize a measurement of quarkonia melting in heavy ion collisions. 14

Keywords: quarkonia suppression; sequential suppression; cold nuclear matter effects

1. Introduction

Relativistic heavy-ion collisions provide the opportunity to study one of the rarest 17 forms of matter ever created - the quark-gluon plasma (QGP). Quarks and gluons, which 18 are normally tightly bound within hadronic bound states of protons and neutrons in nuclei, 19 can be liberated in high-energy collisions of heavy nuclei and result in the formation of the 20 dense partonic plasma phase [1]-[3]. The QGP is interesting for many reasons in addition 21 to being a novel state of QCD matter; it is predicted to have existed shortly after the Big 22 Bang, therefore studying it can provide insight into the early formation of the universe, and 23 it also behaves as a nearly perfect hydrodynamic fluid [4][5]. Understanding the formation, 24 dynamics, and behavior of the QGP, as with any unique state of matter, would result in 25 significantly improving our understanding of the fundamental physics of the strong nuclear 26 force and how it gives rise to the properties of nuclei. 27

A key property to understand the behavior of any medium is its temperature depen-28 dence. The idea to use heavy quarkonia, bound states of charm-anticharm ($c\bar{c}$, "charmonia") 29 or beauty-antibeauty (bb, "bottomonia") quarks, as temperature probes of the QGP came 30 from a landmark paper by T. Matsui and H. Satz [6]. In their paper, Matsui and Satz 31 proposed that quarkonia states would "melt", or be prevented from forming, in a hot 32 deconfined nuclear medium because the free QCD color charges would screen the poten-33 tial between the two heavy quarks in a mechanism analogous to Debye screening. The 34 screening was predicted to occur when the temperature of the medium exceeded that of 35 the binding energy of the quarkonium state [6]. Since different quarkonium states have 36 different binding energies, if one could experimentally observe the melting of quarkonia in 37

The possibility of experimentally measuring the temperature of the QGP has made the observation of the "melting", or dissociation of heavy quarkonia states due to color charge screening, a golden observable in the field of relativistic heavy-ion physics. The idea is that definitive experimental observation of quarkonia melting would enable the use of quarkonium states as temperature probes of the quark-gluon plasma.

The straightforward picture of quarkonia melting due to color-charge screening in 44 high-energy nucleus-nucleus ("AA") collisions has evolved over the years as experimental 45 and theoretical studies have revealed that quarkonia production in high-energy collisions 46 is much more complex than initially thought. From the theoretical side, quarkonium 47 production in *pp* collisions is still not yet completely understood theoretically [7]-[9], and 48 recent theoretical work revealing an imaginary component to the quarkonium potential 49 complicates the picture of color-charge screened quarkonium dynamics proposed by Matsui 50 and Satz [11]-[13]. From the experimental side, signatures previously thought to only 51 occur in the presence of QGP have been observed even in small collision systems [14], 52 raising questions about whether other QGP effects, including quarkonia melting, could 53 be taking place in small systems as well. Additionally, other effects besides the proposed 54 melting mechanism, commonly called Cold Nuclear Matter (CNM) effects, can cause the 55 dissociation of quarkonia states, and these effects must be fully understood and quantified 56 in order to isolate the signatures of quarkonia dissociation due to melting in the QGP 57 [7]. Therefore, there are a few requirements that must be met before concluding that 58 quarkonia melting has been experimentally observed. First, it must be proved that no other 59 mechanisms (such as CNM effects) are responsible for the quarkonium dissociation. Second, 60 it must be shown that the suppression depends on the binding energy of the measured 61 quarkonia. The first criterion remains much more difficult to satisfy than the second. 62 Disentangling dissociation by melting from dissociation due to other effects remains a 63 challenge. 64

In this review, recent measurements of quarkonia production in *p*A and AA collisions will be discussed to highlight the current state of our experimental knowledge of quarkonium suppression in nuclear systems. Photoproduction of quarkonia and the production of quarkonia from beauty hadron decays will not be discussed, as these production mechanisms are different than that for prompt quarkonia and are also not subject to the predicted melting effects. For details on quarkonium production in vacuum (*pp* collisions) and comprehensive theoretical introductions, the reader is referred to excellent reviews on these topics [7]-[9] [15]-[17]. In Section 2, experimental methods for the reconstruction of quarkonia states and the common observables measured to probe quarkonia suppression are briefly reviewed. The discussion of recent experimental results begins in Section 3 with recent results in nucleus-nucleus collisions, where the clearest observations of quarkonium suppression are observed. Then in Section 4 recent results from proton-nucleus collisions are reviewed, which tend to complicate the interpretation of the results in nucleus-nucleus collisions.

2. Experimental methods and observables

2.1. Reconstruction of quarkonia states

In order to measure the predicted sequential suppression mechanism discussed in the 81 previous section, one must measure both ground and excited states of the charmonia and 82 bottomonia resonances. For charmonia, the states most experimentally accessible in heavy 83 ion collisions are the $J/\psi(1S)$, $\chi_c(1P)$, and $\psi(2S)$. For bottomonia, the corresponding 84 most accessible states are the Y(1S), Y(2S), and Y(3S). With the exception of the χ_c , 85 the states are typically measured in the dielectron or dimuon decay channel, depending 86 on the experiment. The dilepton decay channels produce clean experimental signals, as 87 they produce two charged particle tracks in a detector which can be precisely measured. 88 Electrons and muons are identified experimentally with dedicated particle identification or 89 muon detectors, respectively. 90

Fewer experimental measurements exist for the χ_c and $\Upsilon(3S)$ states in heavy ion 91 collisions as these states are particularly challenging to measure experimentally. The χ_c 92 state is typically reconstructed in the radiative decay $\chi_{cn} \rightarrow J/\psi\gamma$, which suffers from 93 significant combinatorial background due to $\pi^0 \to \gamma \gamma$ decays. The Y(3S) state is extremely 94 heavy and therefore rarely produced. It is particularly difficult to measure in heavy ion 95 collisions as the 3S state is predicted to be most affected by dissociation due to cold and hot 96 nuclear matter effects. Therefore, large experimental luminosities are needed to precisely 97 measure the Y(3S) in nuclear collisions. 98

The production of quarkonia states can be "prompt", where the quarkonium state is qq produced directly in a hard QCD interaction, or "non-prompt", where the quarkonium is 100 produced in the decay of a beauty hadron. The production of a lower-energy quarkonium 101 state from the decay of a higher-energy quarkonium state is included within the definition 102 of prompt quarkonia, therefore the only production mechanism for bottomonia states is 103 prompt production. For the charmonia states, however, measuring prompt or nonprompt 104 production probes different physics [7]. Prompt charmonia are created directly in a hard 105 QCD interaction in the early stages of a collision, and in the case of heavy-ion collisions are 106 therefore thought to experience the full evolution of the QGP. Non-prompt charmonia are 107 produced in the decays of beauty hadrons, and in this production mechanism the charmonia 108 are believed to be produced outside the QGP medium [7]. In order to probe the dissociation 109 of quarkonia states due to the presence of a nuclear medium, prompt charmonia are 110 the preferred probes. Experimentally, quarkonia can be measured in inclusive, prompt, 111 or non-prompt production. In inclusive production measurements, all candidates for a 112 particular charmonium state in a particular decay channel are measured and no distinction 113 is made between candidates produced promptly and non-promptly. Prompt and non-114 prompt charmonia production measurements are performed experimentally by fitting 115 the pseudo-decay time distribution of the charmonia candidates in order to separate 116 candidates produced from *b*-hadrons, which have larger decay times, from promptly 117 produced charmonia. 118

2.2. Observables for quarkonia suppression

Measurements of quarkonia suppression begin by first measuring the cross section ¹²⁰ of a quarkonium state in pA, AA, or even pp collisions. Then, one must choose a baseline ¹²¹ for which the cross-section measurement will be compared against. Typically this baseline ¹²² is either the cross-section of the quarkonium state in pp collisions, or for the case of a ¹²³ higher-resonance quarkonium state, the cross-section of the ground or lower-resonance ¹²⁴ state measured in the same collision system. ¹²⁵

The classic observable for quarkonium suppression is the nuclear modification factor, ¹²⁶ defined as the ratio of the quarkonium production yield in a nuclear collision system (pA, ¹²⁷ AA) to the cross section in pp collisions scaled by the average nuclear overlap, $< T_{AA} >$, ¹²⁸ determined from a Glauber model analysis [18]: ¹²⁹

$$R_{AA} = \frac{dN/dx}{\langle T_{AA} \rangle \times d\sigma_{pp}/dx} \tag{1}$$

The nuclear modification factor is typically measured as a function of a variable x, where x is often a kinematic variable, such as the quarkonium transverse momentum p_T or rapidity y, or a variable describing the collision centrality, such as the number of participating nucleons in a collision, N_{part} .

Another observable used to probe suppression is the double ratio of quarkonia production in AA collisions relative to that in pp collisions. This ratio is sometimes denoted by ρ :

$$\rho = \frac{N_{\psi(2S)}^{AA} / N_{J/\psi}^{AA}}{N_{\psi(2S)}^{pp} / N_{J/\psi}^{pp}}$$

3. Recent results in Nucleus-Nucleus Collisions

state, it can be used to derive the excited state R_{AA} .

3.1. Bottomonia

The suppression of bottomonia states in PbPb collisions has been studied by ALICE, 144 ATLAS, and CMS [19]-[27]. Measurements of elliptic flow of Y mesons are beyond the scope 145 of this review but are included in the references for the interested reader [28][29]. The most 146 precise measurement of bottomonia state suppression in AA collisions comes from CMS, 147 which recently measured all three Y states in PbPb collisions at $\sqrt{s} = 5.02$ TeV [26]. The 148 measurements, shown in Figure 1, were performed as a function of centrality and p_T and 149 compared to several different theoretical models. A clear sequential suppression is observed 150 for the Y states, with the Y(3S) state the most suppressed, just barely more suppressed than 151 the Y(2S) state, and both the 2S and 3S states being significantly suppressed compared to 152 the Y(1S) state. The sequential suppression is observed to be stronger, with the higher Y 153 states being more suppressed, in central collisions. The suppression measured as a function 154 of p_T is constant within the experimental uncertainties [26]. 155

The double ratio of quarkonia production is not as powerful as the R_{AA} as it gives

only information on the relative suppression between the excited state and the ground

state, rather than the absolute suppression. However, it is easier to measure experimentally

as many factors cancel in the ratio, and combined with an R_{AA} measurement of the ground

The CMS data were compared to several theoretical models including a coupled 156 Boltzmann model [30], an open quantum system (OQS) model [31], the Heidelberg model 157 [32], the Comover Interaction Model (CIM) [33], and the TAMU transport model [34]. These 158 models represent a wide variety of approaches to describing the dissociation of quarkonia 159 states in nucleus-nucleus collisions and their key features will be briefly summarized here. 160 The coupled Boltzmann and TAMU models are both transport models which describe 161 the quarkonia production and dissociation in QGP using kinetic rate equations. Typically 162 starting from a space- and momentum-integrated Boltzmann equation, the rate equation 163 contains two transport coefficients that describe the quarkonia dynamics in a nuclear 164 medium [35]. The first coefficient is the quarkonia dissociation rate and the second is the 165 quarkonia yield in the equilibrium limit, which depends on the medium's evolution as 166 a function of temperature. Different transport model calculations vary in their approach 167 to obtaining the two transport coefficients and the medium temperature response. In 168 the TAMU model that is compared to the CMS data in Figure 2, a microscopic model 169 [36] is used to compute the modified quarkonium binding energies in the QGP, and a 170 lattice QCD Equation of State is used to compute the medium evolution as a function 171 of temperature [34]. Both transport models shown in Figure 2 include contributions 172 from uncorrelated bottomonium recombination, where a *b*- and *b*-quark pair produced 173 in different initial partonic hard scattering events could recombine to form an Y meson. 174 The coupled Boltzmann model instead uses two coupled Boltzmann equations, one for an 175 unbound QQ pair (Q denoting a heavy quark) and one for bound QQ quarkonium states 176 [30]. The coupled approach notably provides access to studying the effect of *correlated* 177 quarkonium regeneration, in which a *b*- and *b*-quark pair produced during the dissociation 178 of a bottomonium state could once again recombine to form a new bottomonium state [30]. 179 The Open Quantum System (OQS) approach treats the quarkonium as a quantum system 180 that interacts with its surrounding environment, in this case the QGP [31][37]-[39]. The 181 reduced density matrix of the quarkonium system is computed and its equation of motion, 182 the so-called "Master equation", is determined [9]. The OQS formalism provides a fully 183 quantum description of the quarkonium system, including its dynamics out of thermal 184 equilibrium with the QGP [31] [39] and accounting for quantum correlations between the 185 quarkonium system and the QGP medium [9]. The OQS model compared to the CMS 186 data in Figure 2 demonstrates a recent example of combining the OQS framework with 187 an effective field theory that describes the non-relativistic nature of quarkonium, in this 188 case potential non-relativistic QCD (NRQCD) [31] [39]. The Heidelberg model computes 189 the bottomonium wave functions by solving a temperature-dependent radial stationary Schrodinger equation with an effective potential that includes both real and imaginary components to account for the color screening and damping effects, respectively [32]. Finally, the Comover Interaction Model describes the dissociation of quarkonia states via their interactions with other "co-moving" particles with similar rapidities in a cold or hot nuclear medium [33]. A key parameter in this model is the comover density, which is obtained from measurements of the particle multiplicity as a function of rapidity [33].

The double ratio of the Y(3S) to the Y(2S) production yield in PbPb collisions to that 197 in *pp* collisions provides an excellent testing ground for the theoretical models [26][40]. An 198 example of this can be seen in Figure 2, where the measured double ratio and its theoretical 199 predictions are shown as a function of the collision centrality and the quarkonium p_T . All 200 models except for the Coupled Boltzmann model reasonably describe the data. The OQS 201 predictions are closest to the measured data points, being directly on top of them in several 202 cases. The Heidelberg model also does a good job but overpredicts the ratio at high p_T . The 203 TAMU and CIM models are consistently slightly below the data points, and the Coupled 204 Boltzmann model is significantly below the data. It would be interesting to see in the future 205 if perhaps adjustments of the relative yields of correlated and uncorrelated bottomonium 206 regeneration in the Coupled Boltzmann model could give a better agreement with the CMS 207 data. 208

The R_{AA} of Y states has also recently been measured at RHIC by STAR [41]. Figure 3 209 shows the STAR results as a function of centrality compared to results from CMS and to 210 two theoretical models already introduced above, the TAMU transport model [34] and the 211 open quantum system model using potential non-relativistic QCD [37]-[39]. It is interesting 212 to observe that the Y(1S) suppression at RHIC is consistent with that observed at the LHC, 213 despite the significantly different center of mass energies. In contrast with the Y(1S), the 214 Y(2S) appears to be slightly more suppressed at RHIC than at the LHC, but the STAR 215 measurement is still consistent with the CMS data within the experimental uncertainties. 216 The theoretical models agree well with the CMS data and the STAR Y(2S) data, however 217 both models predict a smaller Y(1S) suppression at RHIC than what is observed in the 218 data. These recent measurements in the bottomonia sector confirm a sequential suppression 219 pattern but do not yet single out a specific theoretical model that can describe the relative 220 excited state suppression and the suppression dynamics as a function of collision energy. 221

3.2. Charmonia

3.2.1. Ground state suppression

The ground state of the charmonia resonances, the J/ψ , has been studied extensively ²²⁴ in relativistic heavy-ion collisions. Measurements of J/ψ hadroproduction have been performed in PbPb collisions at $\sqrt{s} = 2.76$ TeV ([42]-[48]) and 5.02 TeV ([49] - [56], in XeXe collisions at $\sqrt{s} = 5.44$ TeV ([57]), in AuAu collisions at $\sqrt{s} = 200$ GeV ([58]-[62]), and in ²²⁷

CuCu collisions at $\sqrt{s} = 200 \text{ GeV}$ [59], to name the most recent measurements. Recent flow 228 [63]-[68] and polarization [69] measurements are beyond the scope of this review but are 229 included in the references for the interested reader. Several measurements in non-identical, 230 or AB, nucleus-nucleus collisions have also been recently performed, in ³HeAu collisions 231 by PHENIX [70] and in PbNe collisions by LHCb [71]. As previously mentioned in the 232 preceding sections, the discussion here will focus on measurements of prompt charmonia 233 production when available for the aforementioned datasets as prompt measurements are 234 most sensitive to probing dissociation effects due to the nuclear medium. The most recent 235 measurements from RHIC and the LHC, summarizing the current state of the art for J/ψ 236 suppression measurements, will be reviewed and discussed along with some of the most 237 common theoretical approaches used to interpret them. 238

The most recent measurement of prompt J/ψ production in high-energy nucleus-239 nucleus collisions was performed by ALICE in PbPb collisions at $\sqrt{s_{NN}} = 5.02$ TeV [56], 240 where the ALICE results were also compared to measurements by CMS and ATLAS in 241 PbPb collisions at the same collision energy [51] [52]. The R_{AA} results as a function of J/ψ 242 p_T at midrapidity for three different centrality bins are shown in Figure 4. The ATLAS 243 and CMS results span the high- p_T region, while the ALICE results cover the low- p_T region 244 down to 1.5 GeV/c. All three measurements are consistent in the p_T range where they 245 overlap, resulting in a continuous description of the $J/\psi R_{AA}$ from low to high p_T . At 246 low p_T , the R_{AA} rises dramatically, particularly in the most central collisions where it is 247 even larger than one. In the next centrality bin from 10-30%, the central values in the two 248 lowest p_T bins are slightly lower than in the 0-10% centrality bin but are still consistent 249 with the first centrality bin within the uncertainties. The most noticeable difference is in the 250 p_T range between 5-10 GeV/c, where the suppression in 10-30% centrality is slightly less 251 than that seen in the 0-10% bin, consistent with previous measurements that found the J/ψ 252 meson suppression to be strongest in the most central collisions. In the final centrality bin, 253 interestingly the J/ψ suppression at low p_T is consistent within the uncertainties with the 254 suppression observed by ATLAS and CMS at high p_T . 255

Moving to other collision systems besides PbPb, the inclusive $J/\psi R_{AA}$ has also been 256 recently measured in XeXe collisions by ALICE [57] and in AuAu collisions by STAR 257 [62]. Figure 5 shows the $J/\psi R_{AA}$ measured as a function of centrality in XeXe and PbPb 258 collisions. The XeXe data set has much larger uncertainties and fewer measurement bins 259 than the PbPb data due to the smaller integrated luminosity available. However, it is 260 still interesting to see that the J/ψ suppression in XeXe is largely consistent with that 261 observed in PbPb, despite the fact that the XeXe system is a much lighter collision system 262 $(A_{Xe} = 129 \text{ and } A_{Pb} = 208)$. The data is compared to the TAMU transport model [72] 263 [73] which was previously introduced for the Y states in Section 3.1. The transport model 264 predictions describe the XeXe data more accurately than the PbPb data, which they slightly 265 underpredict for the mid-centrality range. 266

In AuAu collisions, the most recent measurement of J/ψ suppression was performed 267 by the STAR collaboration, which measured the $J/\psi R_{AA}$ as a function of p_T and centrality 268 [62]. The results shown as a function of p_T and binned in five different centrality ranges 269 are shown in Figure 6 and compared to previous results from RHIC and LHC experiments. 270 The J/ψ R_{AA} measured at RHIC is relatively constant as a function of p_T within the 271 experimental uncertainties. The difference between the RHIC and LHC results is most 272 prominent at low p_T , where the ALICE R_{AA} value is much larger than that measured by 273 STAR. When comparing to the CMS measurements, the RHIC R_{AA} measurement is slightly 274 above the CMS measurement for p_T between 8-10 GeV/c but is also consistent with the 275 CMS result within the uncertainties. Comparisons with several theoretical models are 276 presented. The Tsinghua [75] [76] and TAMU [72]-[74] models are both transport models 277 employing a kinetic rate equation approach to describe the charmonium dissociation and 278 regeneration. The transport models tend to agree with each other at low p_T , then diverge 279 at high p_T but both are consistent with the data. The remaining collisional dissociation 280 models are only shown in the most central AuAu bin (0-20%), and are based on NRQCD 281 calculations computed with two different values of the charmonium formation time (" t_{max} " 282 and " t_{min} ") [77]. The precision of the experimental data cannot yet distinguish between 283 the two formation time scenarios, but this might be possible in the future [78]. All of the 284 models also include cold nuclear matter effects on the J/ψ production. 285

The enhancement of the $J/\psi R_{AA}$ at low p_T has been attributed to the production of 286 J/ψ mesons from the recombination of c and \bar{c} pairs in the extremely hot nuclear medium 287 formed at the LHC [7][9]. At high p_T , the exact origin of the J/ψ suppression is not yet 288 understood as multiple dissociation mechanisms could be involved, as will be discussed. 299 The picture becomes murkier when moving away from very central collisions towards more 291 with other CNM effects is relatively unknown. The ATLAS and ALICE measurements of 292

the $J/\psi R_{AA}$ were compared to several theoretical predictions, shown in Figures 7 and 293 8. The ALICE measurements were compared to three different models: the Statistical 294 Hadronization Model with charm quarks (SHMc) [79], the Boltzmann transport model 295 (BT) [80][81] and a charmonium dissociation model [82] [83]. The Boltzmann transport 296 model has already been described in the previous section. In the SHMc model, the charm 297 quarks are assumed to thermalize in the QGP medium and the yields of the charm hadrons 298 are computed with statistical mechanics using a grand canonical partition function [79] 299 [84]. A key component of the SHMc model is that quarkonia states are only formed during 300 hadronization at the phase transition of the QGP (at the chemical freeze-out temperature 301 T_{CF} [84][85]. This approach differs from the other models shown in Figure 7, which assume 302 that at least some quarkonia bound states remain intact and can interact with the QGP 303 medium despite the existence of color screening effects [80]-[83]. The dissociation model 304 shown in Figure 7 specifically focuses on describing the dynamics of high- $p_T J/\psi$ s in a 305 QGP, and includes J/ψ dissociation contributions from the expected color-charge screening 306 and from collisions of the J/ψ with the medium constituents [82]. Despite the significantly 307 different physical pictures described by the two models, both the Boltzmann transport 308 model and the SHMc model describe the low p_T ALICE data particularly well, while at 309 high p_T the dissociation model agrees extremely well with the ALICE data in very central 310 collisions. In semi-central collisions, neither the Boltzmann transport or SHMc models can 311 fully describe the trend of the data. 312

The ATLAS measurements were compared to color-screening models [82][86] and 313 models involving J/ψ suppression via parton energy loss [87][88]. The first color-screening 314 model is the same model that is referred to as the "Dissociation" model in the ALICE 315 plot in Figure 7, which accounts for I/ψ dissociation due to color screening and collisions 316 in the medium [82]. The second color-screening model that is compared to the ATLAS 317 data focuses particularly on dissociation due to color-exchanges between the QQ state 318 and the QGP medium, which the authors describe as a nuclear absorption-like effect, in 319 addition to the expected melting from color-charge screening [86]. Therefore, it is important 320 to clarify that the "color-screening" models compared to the ATLAS data do not only 321 include quarkonia dissocation due to color-screening, but they also include dissociation 322 due to non-melting effects as well. The first energy loss model referred to in the ATLAS 323

figure describes the quarkonia suppression in AA collisions as being predominantly due 324 to radiative energy loss of the charmonia in the QGP [87]. The radiative energy loss 325 model is based on the idea that quarkonia suppression in QGP could have the same 326 underlying origin as the phenomenon of jet "quenching", in which jets, high-energy sprays 327 of particles produced from the hadronization of a single quark or gluon, are suppressed or 328 "quenched" in the QGP compared to pp collisions [87]. Phenomenologically, the quenching 329 (or suppression) depends on the original p_T of the quark or gluon (or charmonium state) 330 and an effective color factor that accounts for the different radiation patterns between 331 quarks and gluons [87]. It is indeed interesting that this quenching model gives almost 332 identical predictions as the first color-screening model, despite the very different underlying 333 theoretical mechanisms, and both are in very good agreement with the experimental data. 334 The second energy loss model compared to the ATLAS data shares the idea that radiative 335 energy loss is the dominant mechanism explaining the J/ψ suppression, but rather than 336 comparing the J/ψ suppression with the quenching of jets, in this approach it is instead 337 compared with the suppression of individual hadrons [88]. It is also found in this model 338 that the I/ψ suppression and hadron suppression can be described by the same underlying 339 mechanism. One caveat to the energy loss models is that they are expected to be most 340 relevant at high p_T (> \approx 10 GeV), therefore they are not expected to describe the observed 341 J/ψ suppression at low p_T where melting could be playing an important role. However, it 342 is certainly interestingly to observe that the ATLAS data at high p_T are consistent with both 343 dissociation due to color screening and suppression due to energy loss, and that no single 344 model in Figures 7 and 8 can describe the suppression over the full measurement range. 345

3.2.2. Excited state suppression

There are far fewer measurements of the charmonia excited states in relativistic heavyion collisions. Several measurements exist for the $\psi(2S)$ in PbPb collisions at $\sqrt{s_{NN}} = 2.76$ TeV [45][48], and 5.02 TeV ([49][51][52][89]). The χ_c state has never been measured in any nucleus-nucleus collision.

The most recent measurement comparing the suppression of $\psi(2S)$ to J/ψ mesons 351 was performed by the ALICE collaboration at $\sqrt{s_{NN}} = 5.02$ TeV [89]. The suppression 352 factor R_{AA} was measured as a function of p_T and centrality and compared to CMS results 353 measured at the same center of mass energy [52]. Figure 9 shows the R_{AA} of J/ψ and $\psi(2S)$ 354 mesons measured by ALICE and CMS as a function of the quarkonia transverse momentum 355 p_T . Note that the ALICE results are for inclusive J/ψ and $\psi(2S)$, while the CMS results are 356 for prompt J/ψ and $\psi(2S)$. The ALICE and CMS results nicely complement each other, 357 with the ALICE results covering the extremely low p_T region and the CMS results spanning 358

the high p_T region up to $p_T = 30$ GeV/c. The data clearly shows that the $\psi(2S)$ has a lower R_{AA} across the entire p_T range measured compared to the J/ψ , indicating that the $\psi(2S)$ is indeed more suppressed than the J/ψ in PbPb collisions. The data are compared to theoretical predictions based on the TAMU transport model, which was previously introduced in Section 3.1. The model calculations describe the data quite well, in particular accurately capturing the rise at low p_T attributed to charmonium recombination.

The R_{AA} of prompt J/ψ and $\psi(2S)$ has also been measured as a function of the collision 365 centrality by both ALICE and CMS [52][89]. The measured R_{AA} distributions are shown 366 in Figure 10, with the CMS measurement shown on the left and the ALICE measurement 367 shown on the right. When comparing the two measurements as a function of centrality, it is 368 important to note that the experiments probe different charmonia p_T regions. This explains 369 why the two measurements are consistent with each other when integrated over centrality 370 and plotted as a function of p_T , but appear to disagree when integrated over p_T and plotted 371 as a function of centrality. Nevertheless, although the absolute value of R_{AA} for a given 372 value of N_{part} cannot be directly compared between the two measurements, the trends are 373 still interesting. The ALICE measurement, which has a lower charmonia p_T range than the 374 CMS measurement, flattens out towards the most central (highest $< N_{part} >$) collisions. 375 The CMS results, however, show a generally decreasing trend of the R_{AA} towards the most 376 central collisions for prompt J/ψ . The $\psi(2S)$ results in the CMS measurement have larger 377 uncertainties, so the trend with centrality is not as clear, but they could hint at a possible 378 decrease with centrality as well. 379

The double ratio of $\psi(2S)$ to J/ψ yields in PbPb collisions to the ratio in *pp* collisions 380 has been measured by ALICE, ATLAS, and CMS at $\sqrt{s} = 5.02$ TeV [49][51][89]. The ALICE 381 measurements of the double ratio as a function of p_T indicate that the $\psi(2S)$ is suppressed 382 by roughly a factor of 40-50% in PbPb collisions compared to pp collisions [89]. The CMS 383 measurement hints at a slightly larger suppression at midrapidity, but in the most forward 384 rapidity bin probed, 1.6 < |y| < 2.4 the suppression is consistent with that observed by 385 ALICE [49][89]. ATLAS measured the double ratio as a function of centrality for both 386 prompt and non-prompt charmonia. The double ratio for the non-prompt charmonia was 387 observed to be consistent with one, supporting the interpretation that the non-prompt 388 charmonia, which originate from *b*-hadron decays, hadronize outside the medium and are 389 therefore unaffected by the suppression mechanisms responsible for dissociating prompt 390 charmonia in the medium [51]. 391

A key missing component in the picture of sequential charmonium suppression in AA collisions is the $\chi_c(1P)$ state. With a binding energy in between that of the J/ψ and 393

the $\psi(2S)$, a measurement of its suppression is needed to fully confirm the sequential suppression of charmonia states. As with the Y states, no single model can fully describe all of the experimental data on the charmonia, which likely indicates, as the variety of available models also suggests, that multiple mechanisms contribute simultaneously to charmonia dissociation in the QGP.

4. Recent results in *p*A collisions

4.1. Bottomonia

Bottomonia production in *p*A collisions has been predominantly studied at the LHC, 401 with measurements reported by all LHC experiments in *p*Pb collisions [90]-[95]. The most 402 recent measurement of the nuclear modification of bottomonia states at the LHC was 403 performed by CMS [95]. Figure 11 shows the R_{pPb} for the Y(1S), Y(2S), and Y(3S) states 404 measured as a function of rapidity for $p_T < 30$ GeV/c. A sequential suppression of the 405 upsilon states is observed with the Y(3S) being more suppressed than the Y(2S), which is 406 more suppressed than the Y(1S). The sequential suppression is flat within the experimental 407 uncertainties as a function of the quarkonia p_T and y. The data in Figure 11 are compared 408 to predictions from the Comover Interaction Model (CIM) [33] using two different sets of 409 nuclear Parton Distribution Functions (nPDFs), nCTEQ15 [96] and EPS09 at leading order 410 (LO) [97]. The CIM was previously introduced in Section 3.1 and describes the quarkonia 411 dissociation via collisions with co-moving particles at similar rapidities as the quarkonium 412 [33]. The use of different nPDFs is to test different descriptions of the initial nuclear state. 413 Obtained from fits to a wide variety of data, nPDFs quantify the difference in the partonic 414 structure of a bound nucleus compared to a hypothesis of the partonic structure in A 415 non-interacting protons and neutrons, where A is the atomic mass number. If a bound 416 nucleus were simply a superposition of non-interacting protons and neutrons, the nPDFs 417 would not show significant modification relative to the A-scaled proton PDFs. However, 418 indeed studies of vast amounts of experimental data have revealed that nuclei are not 419 simple superpositions of non-interacting hadrons and have their own complex structure of 420 which little is understood on a partonic level [96]. One such example of this structure is the 421 existence of nuclear "shadowing", in which the nuclear PDF is observed to be suppressed 422

in certain partonic kinematic regions compared to the same regions in a proton PDF, for 423 reasons not yet fully understood. Recent progress on nPDF interpretation and fitting is 424 described in the excellent review in [98]. Both nPDF sets used in conjunction with the CIM 425 model are fitted to Deep Inelastic Scattering and Drell-Yan data measured with nuclear 426 targets, and also include inclusive π^0 production data measured in *d*Au collisions at RHIC 427 [96][97]. The nCTEQ15 nPDFs are fitted to fewer data points than the EPS09 nPDFs and the 428 determination of the uncertainty approaches also varies between the two collaborations 429 [96]. The CIM model with either nPDF set does a good job of describing the CMS Y data, 430 with perhaps the only exception being a slight discrepancy with the Y(3S) data at negative 431 rapidity. 432

The Y(1S) R_{pPb} data were also compared to predictions involving an energy loss 433 mechanism [99] as well as predictions that only included nuclear shadowing effects using 434 the EPS09 nPDFs computed at next-to-leading-order [97][100] shown in Figure 12. The 435 energy loss model depicted here specifically accounts for the fully coherent energy loss 436 (FCEL) mechanism that occurs due to the interference of gluon emission amplitudes before 437 and after a partonic hard scattering event [101][102]. The data are consistent with all of 438 the compared theory models, indicating that the observed Y suppression is consistent 439 with being produced as a result of CNM effects, but the exact effects responsible for the 440 suppression remain unknown. 441

Recent measurements of Y production in $\sqrt{s} = 8.16$ TeV pPb collisions were also 442 performed by the ALICE experiment [94]. Figure 13 shows the ALICE and LHCb measure-443 ments of the Y(1S) R_{nPh} compared to several theoretical models. The first is a model using 444 the EPS09NLO nPDFs to describe the nuclear shadowing effects combined with the Color 445 Evaporation Model (CEM) to describe the Y production [100]. In the CEM, the mass of a 446 QQ pair is restricted to be less than the open heavy flavor meson threshold, and the total 447 cross section for a quarkonium state given this mass constraint is computed from a fraction 448 F of the total QQ pairs satisfying this criteria [100]. The next models were previously 449 introduced during the discussion of Figure 12 and include fully coherent energy loss model 450 predictions [103] with and without the additional inclusion of nuclear shadowing effects 451 with the EPS09 nPDFs [104]. The EPPS16 reweighted and nCTEQ15 reweighted predictions 452 are, respectively, the EPPS16 [105] and nCTEQ15 [96] nPDF sets reweighted with heavy 453 flavor hadron production data from the LHC to study the effect of the heavy flavor data on 454 constraining the gluon nuclear PDF [106]. The final model shown is the Comover model 455

with nCTEQ15 nPDFs for shadowing contributions [33]. As seen with the CMS results, the data from ALICE and LHCb are consistent with models involving several different CNM effects. The Comover model is particularly promising in that it can describe the suppression of all three Y states and it appears to do a slightly better job of describing the data at negative rapidity than the other models.

4.2. Charmonia

4.2.1. Ground state suppression

Following the strong suppression of I/ψ mesons observed in AA collisions, it is 463 natural to ask what we currently know about J/ψ suppression in pA collisions. At the 464 LHC, measurements of the $J/\psi R_{pPb}$ have been performed at $\sqrt{s} = 5.02$ TeV and 8.16 TeV 465 [93] [109]-[117]. As with the AA results, measurements of prompt J/ψ production will be 466 highlighted here as these are most sensitive to probing I/ψ dissociation mechanisms. The 467 LHC measurements will be briefly introduced and then their theoretical comparisons will 468 be discussed, since the data are compared to many of the same theoretical models. Figure 469 14 shows the most recent prompt $J/\psi R_{vPb}$ results from ALICE [117], compared to previous 470 LHC measurements at midrapidity as well as several theory predictions and plotted as a 471 function of the $J/\psi p_T$. While one rapidity bin of the CMS measurement is shown in Figure 472 14, the measurement was also performed in multiple rapidity bins to probe the nuclear 473 effects on J/ψ production as a function of both p_T and rapidity, as shown in Figure 15. 474 Due to its forward kinematic acceptance, LHCb has measured the prompt $J/\psi R_{nPb}$ in a 475 complementary rapidity range to that of the midrapidity LHC experiments, probing more 476 positive and negative rapidity values in the center of mass frame [110]. The LHCb R_{nPh} 477 results are shown as a function of p_T for two different rapidity bins in Figure 16. The LHCb 478 and ALICE R_{pPb} measurements are shown as a function of the center of mass rapidity in 479 Figure 17. 480

All of the R_{pPb} results in Figures 14-17 are compared to theoretical predictions, most 481 of which incorporate different cold nuclear matter effects. Several of the nuclear PDFs 482 used in the models in Figures 14-17 have already been previously introduced, such as the 483 EPS09 at LO and NLO [105] and the nCTEQ15 [96] and EPPS16 [105] nPDFs with a re-484 weighting to include the impact of LHC heavy flavor data [106][107]. A new addition is the nCTEQ15HQ set [118], which included open heavy flavor and quarkonium measurements 486 in pPb data from the LHC in a global nPDF analysis (the "HQ" in the name stands for 487 Heavy Quark). The HELAC-Onia models compared to the LHCb data in Figure 16 are 488 based on the HELAC-Onia package which computes the matrix elements involved in 489 collinear NRQCD factorisation predictions of quarkonia production [119][120]. A Color 490 Glass Condensate (CGC) approach is also introduced as a model comparison to the J/ψ 491 R_{pPb} data [121]-[123]. The CGC model is an effective field theory applicable when the 492

saturation scale, the scale at which the gluon density in a nucleus "saturates" and reaches its maximum limit, is much larger than the energy scale associated with nonperturbative QCD, denoted by Λ_{QCD} [121]. The $c\bar{c}$ pair is produced from the radiation of a "probe" parton, and the pair proceeds to interact with the dense gluonic system in the target nucleus [122][124]. In contrast to the rest of the models, the transport model predictions [108] in Figure 14 involve a hot nuclear medium and the treatment of the quarkonia production and dissociation using a rate equation approach as described in Section 3.1.

Several interesting features can be noted from comparing the midrapidity results in 500 Figures 14-15 with the forward and backward rapidity results in Figure 16. At midrapidity 501 and high p_T , the R_{nPh} is slightly larger than one. This can be most clearly see in the CMS 502 results shown in Figure 15, in which the R_{pPb} is observed to be larger than one in most 503 of the measured p_T bins in -0.9 < y_{CM} < -1.93. It is when approaching the more forward 504 rapidities that the value of R_{pPb} begins to drop below one, consistent with what is observed 505 in the LHCb data. The R_{pPb} is smaller than one for almost the entire p_T range probed in 506 the forward region, and for $p_T < 3$ GeV at midrapidity. The R_{pPb} plotted as a function of 507 rapidity shows a decreasing trend from negative to positive rapidity, as shown in Figure 17. 508 Another observation is that the data cannot be described by a single nuclear PDF set, as can 509 be seen most clearly with the LHCb data. The data are consistent with the models, which 510 seem to suggest that nPDF modifications at a minimum are needed to describe the data but 511 that other CNM effects such as energy loss or saturation effects could also be at play. 512

RHIC data is also extremely valuable for studying cold nuclear matter effects, as 513 quarkonia measurements in many nuclear systems, collision energies, and phase space 514 are needed to begin to disentangle the different effects and understand their underlying 515 mechanisms. An example of this can be seen in the recent measurement from PHENIX 516 of the $J/\psi R_{pAl}$, R_{pAu} , and R_{HeAu} [70]. The R_{AB} results from PHENIX are shown for 517 each collision system as a function of p_T in Figure 18 and as a function of rapidity in 518 Figure 19. The theoretical models, which have already been discussed previously, include 519 different parameterizations of nuclear shadowing effects via the EPPS16 nPDFs [100][105], 520 the EPS09 nPDFs [105], and the reweighted EPPS16 and nCTEQ15 nPDFs [106][107], and a 521 transport model that includes hot medium effects on the charmonia production [74][108]. 522 Contrary to the LHC results, the PHENIX results shown here begin to differentiate between 523 theoretical models, as can be seen for the observed values of the R_{AB} at negative rapidity 524 in p+Au and ³He+Au, which do not agree with the EPPS16 predictions from Vogt and 525 Shao. These predictions did not include nuclear absorption effects, which is expected to be 526 significant at RHIC energies [125]. When adding a nuclear absorption model [126] to the 527

same calculations (predictions labeled with "+ Abs" in the figure), the agreement between the data and predictions is greatly improved. This study presents a nice example of how a specific cold nuclear matter effect can begin to be isolated, or at least identified as the dominant effect, in different nuclear systems in order to better understand its underlying mechanism.

The STAR collaboration has also recently measured the $J/\psi R_{pAu}$, as can be seen in 533 Figure 20 [127]. The STAR *p*+Au results are compared to the $J/\psi R_{AA}$ measurement by 534 STAR in Au+Au collisions, to *d*+Au results measured by PHENIX, and to several theoretical 535 calculations. The p+Au and d+Au results are consistent with each other over the entire 536 measured p_T range, which suggests that the measured nuclear modification is primarily 537 due to nuclear effects associated with the Au nucleus. There are several similarities between 538 the R_{pAu} measured at midrapidity and the R_{pPb} measured at midrapidity. For both cases, 539 the nuclear modification factor is consistent with one starting around 3 GeV/c. The small 540 enhancement above one at high p_T that was observed in the ATLAS and CMS data is not 541 observed in the ALICE or STAR data, possibly due to the larger statistical uncertainty for 542 the latter results. The theoretical comparisons include effects due to nuclear shadowing 543 [97][106][107][119][120], a CGC model [128][129], a transport model including a hot nuclear 544 medium effect [73][108], an energy loss model [130], and a comover model [131]. Notably, 545 the STAR data are consistent with predictions involving cold nuclear matter effects and the 546 TAMU transport model which involves the formation of a QGP medium. The Comover 547 model predictions seem to do particularly well at describing the data at low p_T , but the 548 other models do a better job of describing the data over the entire measured p_T range. It is 549 worth mentioning that particularly for the I/ψ results discussed in this section, the data can 550 be described by many models that describe individual CNM effects, usually in combination 551 with nuclear shadowing. However it is likely the case that multiple CNM effects occurring 552 simultaneously are responsible for the observed J/ψ dissociation. Understanding the 553 relative contributions of various CNM effects to the observed suppression remains a 554 challenging but important goal. 555

4.2.2. Excited state suppression

Proton-nucleus systems are ideal for studying excited-state charmonium production as these states are generally statistically-limited in nucleus-nucleus collisions. Recent measurements in *p*A collisions have studied χ_c production, which is particularly interesting as it has never been studied in AA collisions. As previously discussed in Section 2, the prompt J/ψ yield measured experimentally includes J/ψ production via the decays of

higher charmonium states, including the χ_c . LHCb measured for the first time at the LHC the fraction of J/ψ mesons produced from χ_c decays [132], where the total χ_c yield included the χ_{c1} and χ_{c2} states. The result is shown in Figure 21 as a function of the $J/\psi p_T$. The *p*Pb measurement is consistent with the fraction measured in *pp* collisions except in the lowest p_T bins at negative rapidity, however the increased fraction in these bins is compatible with the observed $\psi(2S)$ suppression in *p*Pb collisions [132].

The production of $\psi(2S)$ mesons in *p*Pb collisions has been measured by all four LHC 568 experiments [93], [133]-[139]. Figure 22 shows the $\psi(2S) R_{pPb}$ measured by CMS as a 569 function of y in three different p_T bins [136]. The $\psi(2S)$ suppression is most evident in the 570 lowest p_T bin probed, from 4 to 6.5 GeV/c, where the $\psi(2S)$ is significantly suppressed 571 with respect to the J/ψ particularly at negative rapidity. In the middle p_T bin, from 6.5 to 572 10 GeV/c, the $\psi(2S)$ appears significantly suppressed at negative rapidity but is consistent 573 with the J/ψ , and no suppression, for $\psi > 1$. In the highest p_T bin probed, the $\psi(2S)$ 574 suppression is consistent with one although it is systematically lower than the $J/\psi R_{pPb}$ 575 values. It is interesting that the R_{pPb} values for the J/ψ are consistently slightly larger than 576 one, while the values for the $\psi(2S)$ tend to be smaller than one except in the highest p_T bin. 577

LHCb has also measured the prompt $\psi(2S) R_{pPb}$ and compared it to several theoretical 578 models [134]. The LHCb measurement as a function of rapidity is shown in Figure 23. The 579 LHCb results clearly show that the $\psi(2S)$ is more suppressed than the J/ψ at negative 580 rapidity than at positive rapidity, which is also consistent with the trend observed by 581 CMS in the p_T bins where the measurements overlap. The LHCb data are compared to 582 models involving shadowing via the EPS09 PDFs at LO [140][141] and NLO [142], and 583 to energy loss predictions with and without nuclear shadowing effects included [103]. 584 Interestingly, while the J/ψ suppression can be described by the theoretical models, none 585 of them successfully describe the $\psi(2S)$ suppression. The same difficulty of theoretical 586 models to describe both the J/ψ and $\psi(2S)$ suppression was observed by ALICE when they 587 measured the inclusive $\psi(2S) R_{pPb}$ [137]. Figure 24(a) shows the ALICE measurements 588 compared to several theoretical models, employing some of the same cold nuclear matter 589 effects as were included in the models compared to the LHCb data. The models include 590 shadowing effects [106][142], CGC models [123][143], an energy loss model [99] and the 591 Comover model [131]. The Comover model compared to the data in Figure 24(b) appears 592

to be the only model able to describe both the J/ψ and $\psi(2S)$ suppression, at least getting the approximate order of magnitude for the $\psi(2S)$ suppression correct.

Recent studies of $\psi(2S)$ suppression have also been performed at RHIC by PHENIX in 595 *p*+Al and *p*+Au collisions [144]. The PHENIX results also show a significant $\psi(2S)$ suppres-596 sion at negative rapidity that cannot be explained by models using different nuclear PDFs, 597 specifically the reweighted EPPS16 and nCTEQ15 nPDFS [106][107] as shown in Figure 598 25. The authors note that nuclear absorption cannot explain the observed suppression as 599 the initial-state CNM effects should be similar for the J/ψ and $\psi(2S)$. It would however 600 still be interesting to confirm this by comparing to models including a nuclear absorption 601 component, as was done in [70]. It would also be interesting to see if the Comover model 602 can reproduce the observed $\psi(2S)$ suppression in the backward region, as it appears to 603 be able to do for the ALICE data shown in Figure 24, which could also not be described 604 by shadowing alone. The PHENIX nuclear modification factor measurements were also 605 compared to recent measurements from ALICE [115] as a function of centrality and trans-606 port model predictions [108], which are shown in Figure 26. Note that in Figure 26, the 607 ALICE nuclear modification factor as a function of centrality is denoted by Q_{vPb} due to 608 potential biases in the determination of centrality in *p*Pb collisions. The transport model 609 predictions describe the data better in the forward rapidity region than in the backward 610 rapidity region, although the backward predictions are still consistent with the data points 611 within the large uncertainties. It is important to note here that the ALICE data shown in 612 Figure 26 were also well described by Comover model predictions, again showing that the 613 observed suppression is consistent with predictions involving hot or cold nuclear matter 614 effects. 615

5. Conclusions

Significant progress has been made both experimentally and theoretically to better 617 understand quarkonium production and modification in nuclear systems. The measure-618 ments presented here show that the production of guarkonia in nuclear systems are indeed 619 suppressed with respect to pp collisions, and the suppression in nucleus-nucleus collisions 620 where QGP is expected to be present is indeed stronger than that observed in smaller 621 proton-nucleus systems. There is experimental evidence of the sequential suppression 622 of quarkonia states as a function of their binding energy for both the bottomonia and 623 charmonia systems. However, the experimental measurements and theoretical descriptions 624
