# 1 Importance and roles of arbuscular mycorrhizal fungi in New Caledonian 2 ultramafic soils

13 Abstract

14

15 Our knowledge about New Caledonian serpentine ecosystems has increased greatly during the past 16 half-century, mainly thanks to Jaffré's group. However, research on soil microflora and plant 17 symbionts started only in the nineties and was mainly published during the last two decades. We aimed to synthesize these studies, focusing particularly on arbuscular mycorrhizal fungi (AMF). 18 19 Research on AMF consisted firstly of a global and inventory approach aiming to produce basic but 20 essential lacking knowledge. These studies showed that AMF are abundant in ultramafic soils and 21 concerned nearly all plant species of these ecosystems. Even Ni-hyperaccumulator plants and 22 sedges, generally considered non-mycorrhizal, were found to be functionally colonized by AMF in 23 New Caledonian ultramafic soils. The adaptation of AMF communities to the extreme conditions of 24 these soils led to high levels of metal tolerance (particularly to Ni) and noticeable originality of the 25 taxa. The influence of these symbionts on plant growth and adaptation was assessed in greenhouse and field conditions. An accurate selection of AMF isolates that improve plant growth, and plant 26 27 metal tolerance was performed. It was demonstrated that combinations of AMF isolates with 28 complementary functional traits showed high synergistic effects on plant development. Finally, a 29 partnership with a biotechnological company led to the production of an efficient commercial 30 inoculant now used in the ecological restoration of mine-degraded areas. Today studies are focused 31 mainly on the additive effects of AMF and mycorrhiza-helper bacteria.

# 37 Introduction

38

39 Arbuscular mycorrhiza is among the most frequent plant-microbe mutualistic symbiosis, established 40 with 80% of vascular plants (Wang and Qiu 2006; Smith and Read 2008; Strullu-Derrien et al. 2017). This symbiosis is also one of the most ancient, initiated probably when plants have colonized 41 42 terrestrial areas more than 400 million years ago (Karatygin et al. 2006; Humphreys et al. 2010; 43 Strullu-Derrien et al. 2014). Arbuscular mycorrhizal fungi (AMF) act fundamentally on different 44 mechanisms of plant development, including mineral nutrition, drought resistance and toxic metal 45 tolerance (Smith and Smith 2011; Amir et al. 2014; Augé et al. 2015; Ferrol et al. 2016). Their use 46 in environmental remediation and ecological restoration is then particularly appropriate (Göhre and 47 Paszkowski 2006; Amir et al. 2019; Valliere et al. 2020). Moreover, these targeted environmental 48 applications are among the most advanced for large-scale mycorrhizal inoculation practices today 49 (Hart et al. 2017).

50 Serpentine ecosystems developed in ultramafic soils are generally characterized by extreme 51 conditions: macronutrient deficiency, unbalanced Ca/Mg ratio, metal toxicity and frequent drought 52 stress. These conditions have contributed to promoting original flora (Brooks 1987; Proctor 2003; 53 Jaffré and L'Huillier 2010; Isnard et al 2016). It is particularly the case in New Caledonia, a Pacific 54 island biodiversity hot spot (Myers et al. 2000, Marchese 2015), characterized by endemism of 96.7 55 % of the ultramafic obligate flora (Isnard et al. 2016). This precious biodiversity is threatened by 56 mining activities, fires, and other anthropogenic influences (Jaffré et al. 1998; L'Huillier et al. 57 2010).

58 The origin and pedological classification of new Caledonian ultramafic soils and their 59 physicochemical features have been subject of many studies from the seventies (Jaffré et al. 1971; Jaffré and Latham 1974; Latham 1975; Latham et al. 1978; Jaffré and L'Huillier 2010). Metal 60 61 concentrations and their bioavailability in these soils were also investigated in relation to their potential toxicity on plants (L'Huillier and Edighoffer 1996, Quantin et al. 1997; L'Huillier et al 62 63 1998). However, their microbiology has not been investigated until the nineties, and this was also 64 true for other countries, with rare exceptions (Lebedeva et al. 1978). In particular, AMF survival 65 and activity, and their relationships with plants in these extreme conditions, with very low phosphorus availability (Dubus and Becquer 2001; Jaffré and L'Huillier 2010) and high potentially
 toxic metal concentrations constituted an original unexplored research subject.

68 The first study on mycorrhizal associations in ultramafic soils worldwide concerned AMF 69 spore densities and mycorrhizal colonization of 13 endemic plant species in different New 70 Caledonian sites (Amir et al. 1997). From the year 2000, several publications showed the high 71 interest of these extreme soils to investigate the role of mycorrhizal symbiosis in the adaptation to edaphic and environmental stresses of plants (Boulet et al. 2005; Jourand et al. 2010a; Lagrange et 72 73 al. 2011; Orlowska et al. 2011; Amir et al. 2013). The adaptive traits of fungal symbionts were also 74 highlighted (Turnau and Mesjasz-Przybylowics 2003; Amir et al. 2008; Jourand et al. 2010b; 75 Branco and Ree 2010; Majorel et al. 2012).

76 Studies on ectomycorrhizas (EM) in New Caledonian ultramafic ecosystems were not detailed 77 here. EM are important particularly in forests (Carriconde et al. 2019) and in maquis dominated by 78 Tristaniopsis and Sannantha (Myrtaceae) species or Acacia spirorbis (Fabaceae) (Pillon et al. 79 2021). They are present on trees belonging to Myrtaceae, Fabaceae, Casuarinaceae and 80 Nothofagaceae families (Perrier 2005; Amir and Ducousso 2010; Carriconde et al. 2019). A recent 81 list of EM plants was reported in Pillon et al. (2021). Their role is then complementary with AMF, 82 root system of some plants (Tristaniopsis and Nothofagus (Nothofagaceae) species for example) 83 being simultaneously colonized by the two symbiont groups (Perrier et al. 2006). EM have also a good potential for their use in ecological restoration of mined areas (Houlès et al. 2022). 84

85 In New Caledonia, studies on AMF were taken over mainly by the University of New 86 Caledonia. This review synthesizes those focused on ultramafic soils, particularly the ecological 87 aspects and their practical consequences for the ecological restoration of mine-degraded areas. Are 88 these symbionts able to maintain their spores and colonize root systems in these extreme soils, and 89 how AMF diversity is shaped by these conditions? Are the most frequent plants in ultramafic 90 maquis, particularly those used in restoration programs, arbuscular mycorrhizal? What are the main 91 functions of AMF in plant nutrition, and how could they participate to plant adaptation to highly 92 stressed conditions? These questions are relevant not only for science, but also for their potential 93 use in ecological restoration of mined areas.

# 95 **Exploration and inventory studies**

96

When research on ultramafic soil microbiology started in New Caledonia, the abiotic
characterization of these subtracts in relation to ecosystem functions was relatively advanced (Jaffré

99 et al. 1971; Jaffré and Latham 1974; Lee et al. 1977; Becquer et al. 1995). Microbiological studies 100 were then focused first on a global approach that can help to explain some ecological specificities of 101 the studied ecosystems. Quantitative and qualitative analyses of soil microbiota and its activity in 102 relation with plants and soil metal concentrations were assessed (Amir and Pineau 1998; Saintpierre 103 2001; Amir and Pineau 2003a, 2003b). These publications showed different specificities of 104 ultramafic soil microbiology, with low level of activity but high metal tolerance of the microbiota, 105 part of which being responsible of the release of different metals, including Ni and Co. Frankia 106 symbiosis with Casuarinaceae is frequent in New Caledonian ultramafic ecosystems (Navarro et al. 107 1999; Gauthier et al. 1999) and may play an important role in nitrogen enrichment of these soils. A 108 global approach on plant growth promoting rhizobacteria was initiated (Mercky 1999). More 109 recently, it was shown that ultramafic soil properties do not limit their microbiodiversity (Bordez et 110 al. 2016; Carriconde et al. 2019). However, this rich diversity showed wide variations in relation to 111 environmental conditions (Bordez et al. 2016; Gourmelon et al. 2016). The vegetation cover, 112 particularly its density, seemed to play a major role. Among soil properties, pH, nitrogen and 113 calcium influenced the distribution patterns of microbial communities.

114 After exploratory works on mycorrhizas (Amir et Pineau 1997; Perrier 2005; Perrier et al. 115 2006), it was clear that AMF are abundant in New Caledonian ultramafic soils. Most of the plant species tested were found to be arbuscular mycorrhizal, and AMF spore densities were globally 116 117 similar to those of non-ultramafic soils (Perrier et al. 2006; Amir and Ducousso 2010). If AMF root 118 colonization does not generally induce changes in root morphology, Duhoux et al. (2001) showed 119 that Gymnostoma trees (Casuarinaceae) produce small root nodules called myconodules, colonized 120 by AMF related to Glomus. Similar small nodules rich in AMF structures were found in roots of 121 Podocarpus trees (Podocarpaceae) in New Zealand (Russel et al. 2002), and were confirmed to be 122 present with the same characteristics in Araucaria trees in New Caledonia (Amir, unpublished 123 data). A correlation between AMF spore abundance and soil global activity was detected (Perrier et al. 2006) probably due to negative effect on AMF development of high phosphorus deficiency of 124 125 the poorest soils (Lagrange et al. 2013; Amir et al. 2021). A list of over 60-studied plant species, 126 particularly those used in ecological restoration, presenting their affinity with AMF or ectomycorrhizal fungi was then published (Amir and Ducousso 2010). 127

# 128 Adaptation of arbuscular mycorrhizal symbiosis to ultramafic soils

129

In the past, Ni-hyperaccumulating plants were generally assumed to be non-mycorrhizal (Leyval etal. 1997; Pawlowska et al. 2000). Amir et al. (2007) tested nine Ni-accumulating New Caledonian

plants ranging from weak accumulators to hypernickelophore species. All species were more or less mycorrhized, but mycorrhizal colonization was reduced by high levels of Ni-hyperaccumulation (Figure 1). Indeed, for the same species, the level of mycorrhizal colonization was negatively correlated with Ni-concentration in plant leaves. The main reason for classically considering Nihyperaccumulators as non-mycorrhizal was that the plant species generally studied for this property in Europe and USA belonged to non-mycorrhizal plant families (Brassicaceae, Caryophyllaceae).

Some studies on metal-polluted soils have revealed the high tolerance to Zn and Cd of AMF isolated from this environment (Weissenhorn et al. 1994; Tullio et al. 2003). When tested for Ni tolerance, AMF from ultramafic soils were more tolerant than those from other origins (Amir et al. 147 2008). Moreover, isolates from roots of Ni-hyperaccumulating plants tolerated the highest Ni 148 concentrations (Amir et al. 2007; 2008). This last study also reported that Ni-tolerance of AMF 149 isolates could be inducted by the presence of this metal in the substrate solution during host plant 150 growth.

In New Caledonian ultramafic areas, the herbaceous stratum is mainly represented by 151 152 Cyperaceae (sedges), a family generally considered non-mycorrhizal (Brundrett, 2009). However, several endemic Cyperaceae species highly adapted to ultramafic soils were colonized at low levels 153 154 by AMF (Perrier et al. 2006; Lagrange et al. 2011). Tested in greenhouse conditions and field experiment, Tetraria comosa, one of the most frequent and pioneer sedge species in New 155 Caledonian maquis, was shown to be functionally mycorrhizal, even at low levels of root 156 colonization, with positive effects on plant survival rate and plant growth (Lagrange et al. 2011; 157 158 2013).

# 160 Importance and role of AMF on plant adaptation to ultramafic soils

161

162 AMF are obligate symbionts so their cultivation needs a host plant. Isolates from New Caledonian 163 ultramafic soils were obtained in a greenhouse in association with sorghum. This grass was chosen 164 not only because it has a good affinity with AMF, but also because it can grow in difficult conditions with a relatively high rate, contrary to native species that grow slowly. The effects of 165 166 AMF isolates on plant development have then been tested with sorghum and two endemic shrubs, 167 Alphitonia neocaledonica (Rhamnaceae) and Cloezia artensis (Myrtaceae), currently used in restoration programs (Amir et al. 2013). The study showed that AMF not only stimulated the 168 169 growth and phosphorus nutrition of these plants, but also reduced nickel absorption and its toxicity 170 (Figure 2). Similar but less important effects were obtained on *T. comosa* (Lagrange et al. 2011).

178 Ultramafic soils are often highly deficient in phosphorus (P), this element being moreover strongly adsorbed to iron oxides (Dubus and Becquer 2001; Jaffré and L'Huillier 2010). It is well 179 180 known that an optimal level of available P in soil generally reduces AMF root colonization (Marschner 1995; Smith and Read 2008), but the effects of high P deficiency has received less 181 182 attention (Abbott et al. 1984; Lambers et al. 2009). Lagrange et al. (2011) suggested that P 183 deficiency could explain low levels of AMF root colonization in New Caledonian ultramafic soils. 184 A field experiment with T. comosa in an ultramafic area confirmed this hypothesis: it showed that 185 AMF root colonization and arbuscules' density of non-inoculated plants were clearly enhanced by phosphorus supply, with correlatively a better mineral nutrition (Lagrange et al. 2013). 186

In the latter cited study, plants were not inoculated with AMF. More recently, a field experiment with *Metrosideros laurifolia* (Myrtaceae) plants inoculated in greenhouse with a mix of three AMF isolates was assessed in an ultramafic area in Goro (south of New Caledonia). Stored topsoil spread in this area a few years before, and characterized by a low density of AMF spores, was amended or not with sewage sludge and planted with *M. laurifolia* plantlets (Amir et al. 2019). After 528 days, the aerial dry biomass of AMF-inoculated plants was four times greater than the

193 control ones (Figure 3). Mycorrhizal colonization was increased by sewage sludge inducing a 194 complementary effect with AMF inoculation. This resulted in better plant growth and mineral 195 nutrition, with plant biomass 7.7 times greater than control ones. Ca/Mg ratio was also enhanced by 196 AMF inoculation, and the translocation to aerial parts of potentially toxic metals (particularly Mn, 197 Ni, and Co) was strongly reduced. The analysis of AMF diversity in M. laurifolia roots showed a 198 higher number of operational taxonomic units (OTU) in AMF-inoculated plants grown on non-199 amended plots compared to non-inoculated control. However, the introduced AMF isolates 200 constituted at most, only 9% of the detected OTUs. These results were explained by the strong increase in plant biomass of AMF-inoculated plants. This increase allowed more carbon allocation 201 202 to AMF in roots, the competition between AMF communities, then inducing a relative reduction of 203 inoculated isolates. However, the relative decrease of the introduced isolates did not weaken the 204 positive effects of mycorrhizal inoculation on plant nutrition and growth, even after 3.5 years (Amir 205 et al. 2019). This latter point is interesting for AMF biotechnologies, knowing that inoculum 206 reduction after a few months to a few years is one of the drawbacks of this practice (Pellegrino et al. 2012; Janoušková et al. 2013). 207

Studies on AMF diversity of New Caledonian soils, quite recently initiated, revealed the originality and high richness of AMF communities of ultramafic soils (Gensous 2014; Amir et al. 2015; Cavaloc and Amir 2019). A comparison between AMF communities associated with roots of *Psychotria* (Rubiaceae) and *Phyllanthus* (Phyllanthaceae) species from tropical rain forests 220 developed on ultramafic and volcano-sedimentary soils, in four regions, was performed (Gensous 221 2014). AMF diversity richness did not differ significantly between the two types of forests, but community composition was different. Ultramafic plants were associated mostly with the genera 222 223 Rhizophagus, Glomus, Diversispora and Archaeospora, whereas plants from volcano-sedimentary soils were associated more frequently with Acaulospora, Claroideoglomus, and an unknown 224 225 Glomeraceae. Moreover, in ultramafic forest, AMF community composition differed significantly 226 between Ni-hyperaccumulating and non-accumulating plants. Cavaloc and Amir (2019) analyzed 227 the diversity of AMF in soils of 4 ultramafic open, dense and bushy maguis in south New 228 Caledonia. They reported total number of 188 Amplicon Sequence Variants (ASVs), varying from 229 72 to 104 ASVs per type of maquis, increasing with the vegetation density. Each analyzed plot 230 contained about 10 to 30 ASVs. Shannon-Wiener AMF diversity index varied from 1.5 to 3.5. Amir 231 et al. (2015) estimated AMF diversity inside roots of 4 endemic plant species collected from a dense 232 maquis in Goro (south New Caledonia). They detected 427 sequences corresponding to 54 233 Operational Taxonomic Units (OTUs), varying from 13 to 20 per plant species. These AMF 234 communities were dominated by Glomeraceae family, the genera Rhizophagus and Glomus 235 generally constituting more than 60% of the sequences (Gensous 2014; Amir et al. 2019; Cavaloc 236 and Amir 2019). The other most detected genera were Sclerocystis, Acaulospora, Scutellospora, 237 Claroideoglomus, Diversispora, Redeckera, and Paraglomus. Five AMF new species were 238 published (Blaszkowski et al. 2017; Crossay et al. 2018).

239 This diversity has also been the object of functional experiments. With a larger collection of 240 fungal isolates, greenhouse studies on the effects of different AMF mixes using the endemic plant 241 *M. laurifolia* grown on ultramafic soil were assessed, assuming synergistic effects would be found. 242 Indeed, combinations of co-inoculated isolates belonging to different families and having different 243 functional traits were more efficient than single ones (Crossay et al. 2019). The best mix improved 244 not only mineral nutrition with better absorption of major elements, particularly P and K, compared 245 to single isolates, but also increased Ca/Mg ratio and reduced Ni and Co translocation more clearly. 246 These effects resulted in a great growth improvement, with an aerial dry biomass 21.6 times bigger 247 than the non-inoculated plants. In contrast, the best single isolate induced a 12-fold increase of this biomass. These results comfort the hypothesis stating that synergistic effects of AMF on plant 248 249 development are optimal when the phylogenetic distance between the mixed isolates is maximized 250 (Maherali and Klironomos, 2007), thus complementing biological niches and reducing functional 251 redundancy. Mathematical modeling of these AMF synergistic effects was produced (Crossay et al. 2019) explaining the experimental results with a high concordance ( $R^2 = 0.90$ , p < 0.00001). 252

# 254 AMF and mycorrhiza helper bacteria

#### 255

256 Studies on bacteria and their communities in New Caledonian ultramafic soils have received less 257 attention then fungal symbionts (Héry et al. 2003; Herrera et al. 2007; Bordez et al. 2016; 258 Gourmelon et al. 2016). A few articles reported some of their growth promoting effects on plants 259 (Mercky 1999; Gonin et al. 2013; Bourles et al. 2019; Bourles et al. 2020a). Complementary effects 260 between bacteria and AMF have been addressed only recently (Bourles et al. 2020b). The latter studied the strain BE isolated from the rhizosphere of *Tetraria* plants and screened by Gonin et al. 261 262 (2013) for its metal tolerance and plant growth promotion properties : phosphorus solubilization, and production of indole acetic acid (IAA), siderophores, ammonium and 1-aminocyclopropane-1-263 264 carboxylate deaminase (ACC deaminase). This bacterium belonging to the species Curtobacterium 265 *citreum* was able to form biofilm and produce an exopolysaccharide inducing Ni adsorption and 266 inactivation capacities (Bourles 2019; Bourles et al. 2019). The strain reduced Ni, Co and Cr absorption by sorghum plants (Bourles et al. 2019) and strongly enhanced mycorrhizal colonization 267 268 (Bourles et al. 2020b). The latter study reported complementary effects on the growth and nutrition parameters of T. comosa plants when the bacterium was co-inoculated with AMF in greenhouse 269 270 conditions. A field experiment testing these effects is underway.

271

## 272 AMF and ecological restoration of ultramafic degraded areas

273

274 A part of AMF studies in New Caledonia concerned directly the ecological restoration of ultramafic 275 mine-degraded areas. It was shown that AMF communities of revegetated subsoils on mine-276 degraded areas are different and functionally non-equivalent with AMF communities of non-277 degraded related ecosystems (Cavaloc et al. unpublished data). AMF diversity seemed to adapt to 278 the new conditions of the restored ecosystem. The reuse of topsoil, generally not recuperated by 279 mine companies until the nineties, was strongly recommended (Amir et al. 2003; Bordez et al. 280 2018), but in practice, this substrate was generally stored for years before being spread for 281 revegetation. Studies showed that topsoil storage not only reduces seed bank, soil activity and 282 nutrients' reserve, but also AMF spore density and AMF diversity (Amir et al. 2015; Amir et al. 283 2022). It was then recommended to reuse the topsoil for the revegetation as soon as possible, 284 preferably not more than 6 months after its stripping (Bordez et al. 2018; Amir et al. 2022).

285 Considering the important role of AMF in plant development on ultramafic areas, a company 286 partner of the University of New Caledonia developed recently a commercial inoculum, containing 287 synergistic isolates, based on Crossay et al. (2019) results, after innovation of an aseptic method for 288 AMF culture. Today, this inoculum is used to enhance growth and adaptation of plants for the 289 revegetation of mined areas in ecological restoration perspective. It is also envisaged to develop 290 inoculants with isolates that are specific to particular lateritic soils to avoid reduction of native 291 AMF biodiversity.

On-going greenhouse and field experiments aim to adapt the inoculation technic to seeding methods, by incorporating AMF inoculum into seed balls. These experiments also test the coinoculation of AMF and MHB. Three to ten seeds of different native species, depending on their size, are incorporated with AMF powder inoculum into 8 mm balls. The balls made with a mix of clay and organic matter are then sowed and followed-up for seed germination, plant growth, mycorrhizal colonization and inoculum behavior.

## 299 **Conclusion**

300

Research on mycorrhizas' role in New Caledonian ultramafic soils during the last two decades followed a progression dictated by the local context. The protection of the biodiversity of valuable ecosystems geared the studies toward the ecological restoration perspective. Yet, the originality of ultramafic environment and the absence of knowledge worldwide on AMF symbiosis of these soils have made this subject particularly attractive to investigate plant adaptation in extreme environments.

The abundance and importance of these symbionts in New Caledonian ultramafic ecosystems were shown, and their diversity and relative originality in relation to the high plant endemism of this environment was then highlighted. The ability of AMF to improve plant mineral nutrition and metal tolerance in harsh conditions pointed out the central role of these symbionts in plant adaptation to multi-stress environments. Greenhouse and field experiments then revealed practical perspectives.

313 If an efficient AMF inoculant adapted to ultramafic mined areas is commercialized today, more 314 research on microbial ecology are needed to improve restoration technics in such extreme 315 conditions. New microbe consortia containing AMF and bacteria constitute particularly an 316 interesting target for deeper investigations. 317
