25	Abstract – The objetive of this work was to purify a small (705 Da) and hydrophilic
26	antimicrobial peptide (Arg-Asp-Arg-Phe-Leu) from RuBisCO protein hydrolysate and to
27	evaluate its effect on the microbiological and oxidative stability of minced beef meat during
28	refrigeration. The TBARS values were significantly affected by the storage period and the
29	concentration of bioactive peptide. The antioxidant effect was similar to that of the BHT used
30	as control. The counts of all determined microbiological indicators were significantly affected
31	by the addition of the Arg-Asp-Arg-Phe-Leu. Arg-Asp-Arg-Phe-Leu can be effectively
32	utilized as food ingredients in meat for enhancing their shelf life and oxidative stability.

Introduction

Fresh products as minced meat contains adequate amount of water and abundance of 51 proteins and essential nutrients with favorable pH for supporting microbial growth. Meat is 52 highly perishable products and requires appropriate preservation (Domínguez et al. 2018). 53 Therefore, several synthetic additives have long been directly applied as food additives or 54 used as processing aids with primary intention of prolonging shelf life and preserving quality 55 56 of meat and meat products (Munekata et al., 2020). The application of chemical preservatives such as butylated hydroxytoluene (BHT) and propyl gallate (PG) has been questioned because 57 of the potential toxic and carcinogenic effects (Hashemi et al. 2017). Not only pressure of the 58 59 consumer health concerns, but also a trend towards natural food additives so called "cleanlabeling" has driven exploring of natural antimicrobial compounds as an alternative to 60 synthetic food additives (Domínguez et al. 2019; Lorenzo et al. 2018). Advancement in 61 62 bioactive peptide research has showed that the peptides derived from food proteins could be natural potential candidates to replace the synthetic compounds (Chakrabarti et al., 2018; 63 Wang et al., 2015). Indeed, antimicrobial peptides of industrial waste could be used as 64 preservatives (Lafarga & Hayes, 2014). To date, several animal peptides such as lysozyme, 65 lactoferrin, and nisin are approved for application in meat and meat products (Silveira et al., 66 2021). 67

Recently, the food industries have taken interest to peptides derived from agroindustrial waste. Green juice derived from bio-refinery of Alfalfa (*Medicago sativa*), is often considered as a source of pollution, but it is an excellent protein-rich source and has become an alternative for peptides generation with great interest for food formulation (Hadidi et al., 2019). Ribulose-1,5-bisphosphate carboxylase oxygenase, most commonly known by the shorter name RuBisCO. It's the most abundant plant protein and possesses unique characteristics, a favorable nutritional profile, beneficial bioactivities, and desirable physical

attributes, making it a promising candidate for use in food applications (Grácio et al., 2023). 75 76 Several studies showed that RuBisCO have been reported to contain several bioactive peptides compared to commonly consumed food proteins, except milk proteins (Corrêa et al., 77 2023). In recent previous studies antibacterial and antioxidant peptides derived from the 78 enzymatic hydrolysis of Alfalfa RuBisCO were isolated and identified (Kobbi et al., 2015; 79 Kobbi et al., 2017). The antibacterial peptide (Arg-Asp-Arg-Phe-Leu) was previously 80 identified from protein hydrolysates of Alfalfa RuBisCO prepared with pepsin[®] (Kobbi et al., 81 2015). Arg-Asp-Arg-Phe-Leu a small (705 Da) peptide with one positive charges at pH 7 82 belongs to the great subunit of the RuBisCO, which has a large antibacterial spectrum as 83 84 against Gram positive and Gram-negative bacteria (Kobbi et al., 2015). This bioactive peptide has several attractive properties and attributes that make it a potential promising candidate for 85 application as preservative in the storage and distribution of various meat products. The 86 objetive of this work was to purify a small (705 Da) and hydrophilic antimicrobial peptide 87 (Arg-Asp-Arg-Phe-Leu) from RuBisCO protein hydrolysate and to evaluate its effect on the 88 microbiological and oxidative stability of minced beef meat during refrigeration. 89

Materials and methods

All common chemicals and solvents were of analytical grade from commercial sources: Sigma-Aldrich (Saint-Quentin Fallavier, France) or Flandres Chimie (Villeneuve d'Ascq, France). Synthetic peptide was obtained from GeneCust Europe (Biotechnology Laboratory of Luxembourg S.A). The beef meat was obtained from a local purveyor.

The purification of RuBisCO was realized by a simple method based on pH and solvent effect, according to the method described by Kobbi et al., (2017). Primary purification of an interest protein from a crude medium is specifically to eliminate impurities depending on the solubility and chemical properties of RuBisCO, as its overall charge, solubility or pHi. In order to isolate a soluble fraction, 100 g of green juice was solubilized in 1 L of distilled

water or 1 L of ammonia (NH4OH) at 0.1 M and pH 11. Suspensions were centrifuged at 100 101 10,000 g for 20 min at 4°C to eliminate the green protein and all debris. The RuBisCO containing base 1 at pH 10 was repurified to retrieve the second supernatant 2. Base 2 was 102 103 repurified again to recover supernatant 3. After three successive centrifugations at pH 10, all insoluble fractions were removed, and, hence, three supernatants were summed up to recover 104 all RuBisCO. Proteins were then precipitated by the acidification of the medium at pH 3 using 105 10 mM of formic acid. This was followed by a last centrifugation step at 10,000 g at 4 °C for 106 20 min. The precipitate was washed by ultrapure water and RuBisCO was then lyophilized. 107

A 10% (w/v) aqueous solution of the lyophilized RuBisCO was adjusted to pH 10 and then 108 109 centrifuged at 10,000 g for 5 min. The supernatant was adjusted to optimal pH (pH 3.0) and temperature (37°C) for pepsin[®]. The hydrolysis reaction was started by the addition of the 110 enzyme at a 1:100 (U/mg) enzyme/ protein ratio. The enzymatic reaction was conducted at 37 111 112 °C and pH 3 for 24 h. The hydrolysis reactions are stopped after 24 h by increasing the pH to 10 with 1 M NaOH and then stored at -20 °C for further use. The proportion of none 113 hydrolyzed RuBisCO and then hydrolyzed RuBisCO was deduced from the peak areas by 114 HPLC. 115

The degree of hydrolysis (DH) is defined as the ratio of the number of peptide bonds cleaved 116 to the total number of peptide bonds of protein substrate. DH is determinate by the OPA 117 (o-phthaldialdehyde) method using leucine as standard (Nielsen et al., 2001). A fresh OPA 118 solution was prepared extemporaneously with 25 mL of 100 mM sodium tetrahydroborate, 5 119 mL of 10% SDS solution (w/v), 80 mg of OPA (dissolved in 1 mL of methanol) and 0.01 mL 120 of β -mercaptoethanol were adjusted to a final volume of 50 ml with distilled water. To assay 121 proteolysis with RuBisCO protein as substrates, an aliquot (usually 0.01–0.05 ml containing 122 5–100 mg proteins) was added to 1.0 ml of OPA reagent in a 1.5 ml quartz cuvette. The 123

solutions were mixed briefly and incubated for 2 min at room temperature, and then theabsorbance at 340 nm was measured.

The RuBisCO hydrolysis was analyzed by RP-HPLC on a C4 column according to the 126 process previously described with slight modifications (Trovalset et al., 2007). The liquid 127 chromatographic system consisted of a Waters 600E automated gradient controller pump 128 module, a Waters Wisp 717 automatic sampling device and a Waters 996 photodiode array 129 130 detector. Spectral and chromatographic data were stored on a NEC Image 466 Image 466 computer. Millennium software was used to plot, acquire, and analyze chromatographic data. 131 Chromatographic processes were performed with a VydacC4 column (250 mm×10 mm). The 132 133 mobile phase composed of water/trifluoroacetic acid (1000:1, v/v) was used as eluent A, while acetonitrile/trifluoroacetic acid (1000:1, v/v) was used as eluent B. The flow rate was 134 0,6 ml/min. Samples were filtered through 0.22mm filters and then injected. The gradient 135 applied was 0-10 min, 100% A; 25-95min, 21- 81% B; 96-110min, 100- 0% B; and the HPLC 136 system were equilibrated for 10 min with 100% A. On-line UV absorbance scans were 137 performed between 215 and 325 nm at a rate of one spectrum per second with a resolution of 138 1.2 nm. Chromatographic analyzes were completed with Millennium software. 139

The RuBisCO hydrolysate was adjusted to pH 7.5 and NaCl was added to a fixed volume to 140 reach a final concentration of 2.0 M of salt (Adoui et al., 2013). The solution was stirred for 141 30 min at room temperature before being centrifuged at 10,000 g for 10 min at 4°C. The pellet 142 was washed twice by centrifugation with phosphate buffer (5 mM, pH 7.5) to remove soluble 143 proteins, and then resuspended in phosphate buffer (5 mM, pH 7.5, 100 mM NaCl) to 20 144 times the original hydrolysate volume. The final pH of the peptide hydrolysate was adjusted 145 between 1.5 to 2. After one hour stirring at 7 °C, the pellet was centrifuged (10,000 g, 10 146 min), and the supernatant was recovered. The solution was stored at -20°C until performing 147 the antibacterial assay and analysis by RP-HPLC. 148

The molecular mass and peptide sequencing were done in positive ion mode using 149 150 Electrospray ionisation-mass spectrometry (ESI-MS) and the tandem mass spectrometry (MS/MS), respectively. ESI mass spectrometry was performed using a triple quadrupole 151 instrument Applied Biosystems API 3000 (PE Sciex, Toronto, Canada) equipped with an 152 electrospray ion source. The system is controlled by the Analyst Software 1.4, allowing the 153 control of the spectrometer, the analysis and the processing data. Interpretations of spectra 154 MS-MS were made with the Bioanalyst software. The freeze-dried samples from RP-HPLC 155 were dissolved in acetonitrile/water (20/80; v/v) containing 0.1% formic acid for the positive 156 mode. The solution was injected (nebulised) uninterrupted, by a pump (Model 22, Harward 157 158 Apparatus, South Natick, USA) with a flow rate of 5 µl/min. The potential of ionisation was of 5000 V in positive mode. At the time of the recording of the spectrum, 30 scans on average 159 were added (MCA mode) for each spectrum. The gases used (nitrogen and air) were pure (up 160 161 to 99%) and produced by a compressor Jun-Air 4000-40M and a nitrogen generator Whatman model 75-72 (Whatman Inc, Haverhill, MA the USA). The polypropylene glycol (PPG) was 162 used for the calibration and the optimisation of the machine. The peptide sequence was 163 determined from the CID spectrum of the protonated analyse [M+H]⁺ by MS/MS 164 experiments. Peptide sequences were done using the bioanalyst software (Applied 165 Biosystems, USA). 166

The antimicrobial peptide (Arg-Asp-Arg-Phe–Leu) was chemically synthesized by the conventional method: Fmoc solid phase synthesis, according to the method described by Fields and Noble (1990). Arg-Asp-Arg-Phe–Leu peptide was synthesized on a Fmoc-Arg (Pbf)-WangTentagel® S resin (0.25 mmol/g from Iris Biotech, 50 µmol scale) using an Intavis peptide synthesizer (Proteigene) and standard Fmoc/tert-butyl. Activation of the amino acids (10 eq) was performed separately prior to the coupling step using a mixture of TBTU/HOBt/DIEA: 10 eq/10 eq/30 eq in DMF. A capping step was performed after each coupling with a mixture of Ac2O/NMM/DMF: 5/10/75 v/v/v. At the end of the synthesis, the Fmoc protecting group was removed using 20% piperidine in DMF. The resin was washed with DMF (4 × 2 min) and CH2Cl2 (4 × 2 min) and dried in vaccuo. Deprotection and cleavage of the peptide from the resin was performed with a mixture of TFA/TIS/H2O: at room temperature. The mixture was precipitated in cold diethyl ether. The peptide was collected by centrifugation, dissolved in deionized water and lyophilized. Arg-Asp-Arg-Phe– Leu was purified by RP-HPLC.

The hemolytic activity of the Arg-Asp-Arg-Phe-Leu peptide was determined by methods of 181 Dathe et al. (1996), slightly modified. Five milliliters of bovine blood were centrifuged at 182 3500 rpm for 10 min to isolate erythrocytes, which were then washed three times with 10mM 183 sodium phosphate, pH 7.5, containing NaCl 9 g/L (NaCl/Pi). The cell concentration stock 184 suspension was adjusted to 109 cellules /mL. The cell suspension (12 mL) along with varying 185 186 amounts of peptide stock solution and the buffer were pipetted into Eppendorf tubes to give a final volume of 50 mL. The Eppendorf tubes with 2.5 108 cells/mL were then incubated at 37 187 °C during 40 min. After centrifugation (5000 rpm, 5 min), 30 mL of supernatant was diluted 188 in 500 mL water. The absorbance of the diluted solution was measured at 420 nm. The 189 absorbance obtained after treating erythrocytes with only NaCl/Pi and SDS (0.2%) was taken 190 as 0 and 100%, respectively. The test was carried out in triplicate. 191

The beef patties were composed with commercial beef containing 0.28% (w/w) of salt, 14% (w/w) of fat and about 18% of proteins. Salt (70% NaCl and 30% KCl) was added at a rate of 1.5% to the minced meat. The sample was subdivided into four treatments: a negative control, the meat without additive, a positive control, the meat with two different BHT concentrations (0.1 and 0.5% (w/w)) and the meat with two different Arg-Asp-Arg-Phe–Leu peptide concentrations (0.1 % and 0.5% (w/w)). The meat sample preparation was realized under strong aseptic conditions to avoid contaminations. Patties of 10 g were placed in plastic foam meat trays, wrapped with film polyethylene and kept at 4 °C for fourteen days. Four samples were taken from each treatment at fixed day in order to evaluate their oxidation and the potential microbial contamination. A strict sanitation procedure was followed during the preparation of meat samples to avoid microbial contamination.

Lipid oxidation was evaluated using the thiobarbituric acid-reactive substance (TBARS) as 203 previously described by Witte et al., (1970). For each prepared formula five grams of minced 204 meat were added to 12.5 mL of solution containing trichloroacetic acid (20% w/v) and 205 phosphoric acid (2 M). The mixture was then adjusted to 25 mL of ultrapure water, shaken 206 and filtered using Buchner funnel through Whatman paper. After that, 5 mL of the filtrate was 207 208 then transferred into a glass test tube and an equal volume of 2-thiobarbituric acid (5 mM) was added. The test tube was then well shaken and incubated at room temperature for 17 h. 209 The absorbance of the mixture was measured at 520 nm and the results were expressed as 210 211 malondialdehyde equivalents per meat kilogram (mg MDA/kg meat).

Microbial count was carried out at days 0, 1, 3, 6, 9, and 11 of storage at 4°C according to the 212 following procedure. 45 mL sterilized peptone solution (0.1% w/v) was added to each five 213 grams of beef patty in a sterile stomacher bag, then homogenized. Decimal dilutions up to 105 214 prepared from the initial concentration (100 mg/mL) and 100 µL of the appropriate dilutions 215 were spread out on different selective media. Total viable counts were determined using plate 216 count agar (PCA), potato dextrose agar (PDA) for yeasts and molds counts, Man, Rogosa and 217 Sharpe (MRS) agar for lactic acid bacteria and violet, red bile lactose (VRBL) agar for 218 coliform counts were used after incubation at 37 °C for 24h. Microbiological count was 219 expressed as the log10 of colony-forming units per gram of patty (log10 CFU/g). 220

All data were submitted to Analysis of Variance (ANOVA) and differences between means were evaluated by Duncan's Multiple Range Test. The data were analyzed using the

Statistical Package for the Social Sciences (SPSS) version 10.0 (Chicago, Illinois, USA).
Differences were considered significant at p<0.05.

Results and Discussion

Figure 1 shows the RP-HPLC chromatogram from the peptic RuBisCO proteins purified from 226 green juice of Alafalfa. Generated hydrolysate (DH = 18%) was mainly intermediate peptides 227 (produced from the beginning of hydrolysis and disappearing gradually as hydrolysis 228 229 advance) (Abou-Diab et al., 2021). This standard condition following hydrolysis process led to a complex hydrolysate containing many peptides, intermediate or final, with various 230 characteristics (Kleekayai & FitzGerald, 2022). The chromatographic profile (Figure 2A) 231 232 showed the peptide population with retention times between 10 and 50 min which corresponding to antimicrobial peptides. According to the mass spectrometry analyses (Figure 233 2B), one antimicrobial pentapeptide was identified: Arg-Asp-Arg-Phe-Leu. The MIC of the 234 235 purified peptide varied between 2.17 ± 0.1 mM (for Listeria innocua and Bacillus subtilis) and 2.83 ± 0.2 mM (for *Escherichia coli* and *Micrococcus luteus*). Peptides showed an 236 237 outstanding antibacterial activity against both Gram positive and Gram-negative bacteria by damaging the cell membrane integrity (Bi et al., 2020; Tu et al., 2019; Medeiros et al., 2018). 238

Arg-Asp-Arg-Phe–Leu peptide did not cause hemolysis. The hemolytic activity of the peptide against human erythrocytes was determined as an indication of its toxicity towards mammalian cells. The highest concentration tested corresponding to this concentration of peptide. No hemolysis was observed up to a peptide concentration corresponding to five times the MIC. The positively charged residues can significantly reduce the toxicity of the peptides towards the mammalian cells, so with the increasing positive charges, the hemolytic activity of the peptides reduced reasonably (Lohan et al., 2023; Sengkhui et al., 2023).

Significant changes in TBARS occurred over the sampling period when Arg-Asp-Arg-PheLeu peptide was added to chilled minced beef meat. Analysis of variance of the TBARS

values was determined between the different samples. The result showed that the TBARS 248 values increased throughout the eleven days experiment. This fact was clearly marked for the 249 control sample (without additives) which highest TBARS values value than all tested 250 251 conditions by the end of storage (It goes from value 0.56 ± 0.07 mg MDA for day 1 to a value of 2.31 ± 0.18 mg MDA for day 11). While the TBARS values of the meat supplemented with 252 either 0.5% or 0.1% (w/w) Arg-Asp-Arg-Phe-Leu peptide, were significantly lower (p <253 0.05) than the meat without additives, used as control. Moreover, the efficiency in ground 254 meat preservation increased proportionally with peptide concentration. But this difference was 255 clear from day 6 (Figure 3) because no significant effect between the four treated groups has 256 257 been observed during the first three days of the experiment, but their TBARS values were significantly lower than the control (Figure 3). From day 6, the power antioxidant of Arg-258 Asp-Arg-Phe–Leu at 0.5% (w/w) was higher (0.83 \pm 0.04 mg MDA/kg) than the other two 259 260 treated groups (peptide at 0.1% and BHT at 0.1%) with an average value of 1.75 ± 0.31 mg MDA and 1.25 ± 0.13 mg MDA respectively. Thus, the peptide at 0.5% (w/v) can protect beef 261 meat against lipid oxidation and extend their storage time. The TBARS values of the meat 262 supplemented with either peptide 0.5% or BHT 0.5% (w/v), used as reference, have no 263 significant difference and were similar after 9 days of storage at 4 °C of an average value 264 TBARS of 0.91 \pm 0.21 mg MDA that is two timeless the control (2.145 \pm 0.36 mg MDA) 265 (Figure 3). Consequently, the BHT at 0.5% (w/v) and Arg-Asp-Arg-Phe–Leu at 0.5% (w/w) 266 reduced the lipid oxidation on meat of 60% (Figure 3) compared to the control. This tendency 267 continued until 11 days. At the end of the experiment, the BHT at 0.5 (w/w) and Arg-Asp-268 Arg-Phe–Leu 0.5% (w/w) had no significant difference to protect against the phenomenon of 269 lipid oxidation with a TBARS-value about of 0.96 mg MDA/kg meat. The results of the 270 present study show that adding the Arg-Asp-Arg-Phe-Leu' peptide derived from protein 271 hydrolysates of Alfalfa RuBisCO at 0.5% (w/w) protects beef patties against lipid oxidation. 272

The work confirms the results obtained by Kobbi et al. (2017) which revealed that the Alfalfa 273 RuBisCO hydrolysate (DH = 18.8 %) exhibited strong antioxidant abilities, including the 274 prevention of linoleic acid oxidation, reduction of ferric ion, and stability of ABTS*. 275 Therefore, green juice derived from bio-refinery of Alfalfa offers a promising source of 276 antioxidant peptides of interest for various functional food applications. The antioxidant 277 activity of this peptide was probably due to its low molecular weight (705 Da) and the 278 presence of aromatic residue Phenylalanine (Phe) which can quench free radicals by direct 279 electron transfer to act as an antioxidant (Geng et al., 2023; Jeampakdee et al., 2020; Chi et 280 al., 2015). Peptides with highly potent inhibitory activity have hydrophobic amino acids as 281 282 leucine (Leu), at the N-terminal position in the sequences (Shi et al., 2022; Nwachukwu et al., 2019). The microbial count increased proportionally with the storage time and reached the 283 highest values at the end of chill period. Among the experimental groups, the negative control 284 group showed the most rapid increase in the number of total microorganisms (from $4.29 \pm$ 285 0.04 to 8.14 \pm 0.31 log CFU/g), followed by samples treated with Arg-Asp-Arg-Phe-Leu 286 peptide and BHT (Figure 4a). Arg-Asp-Arg-Phe-Leu peptide efficiency on bacterial growth 287 inhibition was tested using 0.1%, and 0.5 % concentrations. In general, the microbial growth 288 decreased significantly with the addition of Arg-Asp-Arg-Phe-Leu peptide and with the 289 290 highest concentrations of this compound during the storage period (Figure 4a). Nevertheless, the group with a 0.5% (w/w) of Arg-Asp-Arg-Phe-Leu peptide showed the slowest increase in 291 the number of total viable colonies until the eleventh day (7.12 \pm 0.12 log CFU/g). The 292 coliform count on a VRBL medium shows that no significant difference (p > 0.05) has been 293 observed between the four treated groups with additives during the first three days (Figure 294 4b). But beyond this day, the group with Arg-Asp-Arg-Phe-Leu peptide at 0.5% (w/w) 295 showed efficiency more important and comparable to that of BHT 0.5% (w/w) with the 296 coliform counts of $4.73 \pm 0.04 \log \text{CFU/g}$, at day 11. Therefore, this peptide can reduce by 297

32% the number of total coliforms in meat compared to the control. For the yeasts and molds, 298 299 the most effective additives were the Arg-Asp-Arg-Phe-Leu at 0.5% (w/w) and BHT 0.5% (w/w), with the yeasts and molds counts of 5.64 \pm 0.25 and 5.63 \pm 0.06 log CFU/g, 300 respectively, at day 11 (Figure 4c). These effects were similar to BHT 0.5% (w/w) (no 301 significant difference). On the other hand, the groups treated with BHT 0.1% (w/w) and Arg-302 Asp-Arg-Phe-Leu at 0.1% (w/w) are less effective and they were presented no significant 303 difference with the yeasts and molds counts 6.28 \pm 0.25 and 6.19 \pm 0.25 log CFU/g 304 respectively, at day 11, compared to group without additive with $7.11 \pm 0.62 \log \text{CFU/g}$. At 305 last, for the growth of lactic acid bacteria (Figure 4d), during the first three days no bacterial 306 307 proliferation has been observed for the four treated groups with additives (from 6.01 ± 0.42 to $6.35 \pm 0.12 \log \text{CFU/g}$, except for the untreated group, the number of lactic acid bacteria was 308 increased from $2.23 \pm 0.81 \log \text{CFU/g}$ at day 0 to $3.53 \pm 0.12 \log \text{CFU/g}$ at day 3. After 6 309 310 days, three treated groups (with peptide 0.5%, BHT 0.1% and BHT 0.5%) showed a significant difference with the negative control group (Figure 4d). Once again, the most 311 effective group were Arg-Asp-Arg-Phe-Leu at 0.5% (w/w) and BHT 0.5% (w/w). At this 312 time, the microbial counts were of $4.67 \pm 0.83 \log \text{CFU/g}$ for the untreated group and $3.24 \pm$ 313 0.18 log CFU/g for the group treated with the Arg-Asp-Arg-Phe-Leu peptide at 0.5% (w/w). 314 Many studies have reported the impact of antimicrobial peptides on meat and its products 315 (Zagorec & Champomier-Verges, 2017). Antimicrobial peptide can potentially be used to 316 extend the quality of highly perishable foods during storage (Gogliettino et al., 2020). 317 Antimicrobial peptides have unique structural characteristics. The length of amino acids and 318 the composition of antimicrobial peptides that have already been studied are extremely 319 diverse. Their tendency to adapt to various structural changes when they come into contact 320 with membranes is exclusive (Torres et al., 2019). The cationic peptides exert antibacterial 321 activity by interacting with negatively charged bacterial membrane to increase membrane 322

323	permeability and lead to cell membrane lysis and cell content release. Upon approaching the
324	cytoplasmic membrane through electrostatic interaction with the microbial membrane,
325	antimicrobial peptides bind to the microbial membrane and interact with the anionic
326	components of the plasma membrane (Rajagopal & Walker, 2017; Baek et al., 2016).
327	Conclusion
328 329	1. A small antibacterial peptide from RuBisCO was isolated and purified.
330	2. Improvement of oxidative stability of minced beef meat during refrigeration.
331	3. The peptide reduced the lipid oxidation about 60% to delay meat rancidity.
332	4. Inhibition of the microbial growths under refrigeration during 14 days.
333	5. The peptide can be effectively utilized as food ingredients in meat products.
