# Access to Enantioenriched $\beta\textsc{-Hydroxy}\ \textit{gem-Difluorinated}$ Heterocyclic and Acyclic Derivatives through Rh(III)-Catalyzed Asymmetric Transfer Hydrogenation

Abstract. We report here a rapid, efficient, and easy to handle process to access a variety of enantioenriched αgem-difluorinated alcohols. Α Rh(III)-catalyzed hydrogenation asymmetric transfer method developed in yields up to 98% and enantiomeric excesses up to >99%. The reduction proceeds under mild conditions with a range of difluorinated molecules including 3,3-difluorochromanone, difluorothiochromanone, 3,3-difluoro-dihydroquinolinone and α-difluorinated β-ketosulfone derivatives efficiently provide the desired enantioenriched difluorinated alcohols which are valuable novel fluorinated building blocks.

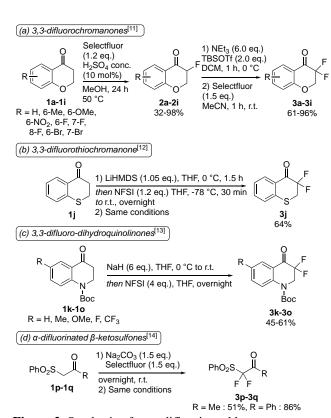

Because of the distinctive characteristics of fluorine, the targeted incorporation of fluorine atom(s) or fluorine-containing groups into organic compounds frequently results in profound changes to their stability, hydrophobicity, accessibility to biological systems, and biological potency influencing the administration and processing of pharmaceuticals in the body.<sup>[1]</sup> Consequently, fluorine is emphasized as second most commonly employed heteroelement, [2] following nitrogen, in research oriented toward the life sciences.<sup>[3]</sup> More specifically, the geminal difluoromethylated moiety can function as a bioisostere of ether oxygen, [4] leading to potential conformational shifts.<sup>[5]</sup> Additionally, in proximity to oxygen, two fluorine atoms significantly alter the fundamental properties of basicity and hydrogen bonding in alcohols.<sup>[6]</sup> Because of its significant interest in bioisosteric design,<sup>[7]</sup> the CF<sub>2</sub> moiety has the potential to influence physicochemical and pharmacological characteristics of a compound (Figure 1).<sup>[8]</sup>

Considering the significant characteristics of the pattern outlined earlier, and in line with our ongoing focused on generating valuable efforts enantioenriched fluorinated compounds, [9] we hereby report the synthesis of a new range of β-hydroxy gem-difluorinated heterocyclic and non-cyclic derivatives through an asymmetric transfer hydrogenation (ATH)<sup>[10]</sup> process. Our investigations started with the preparation of a variety of a-gemdifluorinated ketones 3a-3q including difluorochromanones 3a-3i bearing diverse electrondonating or electron-withdrawing groups on the aryl ring as well as 3,3-difluorothiochromanone 3j, 3,3difluoro-dihydroquinolinones 3k-30 and difluorinated β-ketosulfone **3p-3q** derivatives. For the 3,3-difluorochromanone series, the products 3a-3i were synthesized through a two-step sequence involving first the  $\alpha$ -monofluorination of the ketones 1a-1i using Selectfluor in the presence of H<sub>2</sub>SO<sub>4</sub> in MeOH to deliver 2a-2i in 32-98% yield. The second fluorination reaction was performed on corresponding silyl enol ether to afford the desired products **3a-3i** in 61 to 96% yield (Figure 2a). [11] The

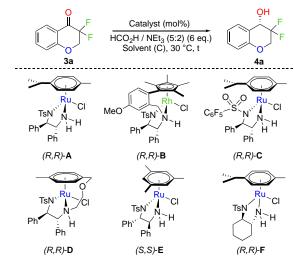
3,3-difluorothiochromanone derivative **3j** was prepared in 64% yield by using NFSI as the fluorinating agent through sequential fluorination of thiochroman 4-one **1j** with LiHMDS as a base. <sup>[12]</sup> On the other hand, the 3,3-difluoro-dihydroquinolinone derivatives **3k-3o** were obtained in a single step in 45-61% yield using 6 equivalents of NaH and 4 equivalents of NFSI. <sup>[13]</sup> Finally,  $\alpha$ -difluorinated phenylsulfonyl derivatives **3p** and **3q** were formed by sequential fluorination of the  $\beta$ -keto sulfones **1p-1q**, using sodium carbonate and Selectfluor at room temperature in 51% (**3p**, R = Me) and 86% (**3q**, R = Ph) yield over 2 steps. <sup>[14]</sup>

Having those substrates in hand, we next investigated the enantioselective reduction of 3,3difluorochroman-4-one 3a as a model substrate by evaluating the catalytic properties of a series of commercially available ruthenium catalysts such as (R,R)-A, (R,R)-C, (R,R)-D or a Rh-based catalyst (R,R)-**B** previously developed in our group, <sup>[15]</sup> using dichloromethane as a solvent at a concentration of 0.3 M and a mixture of formic acid/triethylamine (5:2) as the hydrogen donor at 30 °C (Table, entries 1-4). All screened led the complexes high enantioselectivities (>99% ee). However, because the rhodium-based complex allowed a full conversion with a reaction rate much shorter than the other catalysts, the optimization of the reaction parameters was performed with (R,R)-B. Thus, switching from dichloromethane to 2-MeTHF as a solvent or decreasing the catalyst loading to 0.5 mol% showed no significant impact on the yield and ee although the kinetics of the reaction was slightly improved (Table, entries 5 and 6). Using the ruthenium complexes (S,S)-E and (R,R)-F under the above conditions failed to afford complete conversion even with prolonged reaction time (Table, entries 7 and 8).

Interestingly, the reaction could be performed in an open flask with no effect on the catalytic performances as compared to those observed for the

reaction carried out under argon atmosphere (Table, entries 9 vs 6). Varying the ratio of the formic acid/triethylamine mixture from 5:2 to 1:1 furnished **4a** in a slightly lower yield of 90% (Table, entry 10) whereas reducing the catalyst loading to 0.1 mol% had a detrimental impact on the enantioselectivity of the reduction either in solution or neat (97% and 96% ee, respectively, Table, entries 11 and 12). Other solvents such as acetonitrile or ethyl acetate were tested, giving similar results as 2-MeTHF in terms of reaction time, yield and enantioselectivity (Table, entries 13 and 14). However, because it is considered a greener solvent, we chose to work with 2-MeTHF and the optimized reaction conditions were set as follows: 2-MeTHF at a 0.3 M concentration, in a mixture of formic acid/triethylamine (5:2) at 30 °C for 1 hour, with the rhodium-based catalyst at a 0.5 mol% catalyst loading. To further assess the scope of the reduction with these optimized conditions in hand, we next investigated the Rh-catalyzed ATH of the α*gem*-difluorinated ketones 3a-3q (Scheme Variously substituted 3,3-difluorochroman-4-ones 3a-3i were subjected to the asymmetric hydrogen transfer and successfully reduced in high yields (92-96%) and enantioinductions ranging from 75% to >99% ee. The lowest ee was observed for the ATH of substrate 3d having the nitro electron-withdrawing group on the phenyl ring (75% ee for 4d) whereas those bearing halogen atoms (4e-4i) or electrondonating groups such as a methyl or methoxy (4b, 4c) gave high enantioselectivities. Satisfyingly, 3,3difluorothiochroman-4-ol 4j was obtained (94%) comparable yield and enantioselectivity of 99% as those observed for the derivatives. chroman-4-ol The 3.3-difluorodihydroquinolinones were also submitted to the ATH under the optimized reaction conditions and delivered the corresponding alcohols 4k-4o in high yield (85-96%) and excellent enantioselectivities (98-99%). Finally, we turned our attention to acyclic difluorinated ketones. To this end, the ATH process was applied the 1,1-difluoro-1to (phenylsulfonyl)propan-2-one derivative **3p**, leading to 4p with an excellent 98% yield and >99% ee but a decreased ee of 52% was observed for the reduction of the parent compound 2,2-difluoro-1-phenyl-2-(phenylsulfonyl)ethan-1-one 3q. We hypothesized that the enantioselectivity observed for the reduction of the methyl ketone 3p arises from a stabilizing  $C(sp^3)$ –H/F interaction that leads to the (R)-alcohol **4p**. The lower enantioselectivity observed for the ATH of phenyl ketone 3q could be explained by a competitive  $C(sp^3)$ – $H/\pi$  interaction which would favor the (S)-alcohol (see Supporting Information). The absolute configuration of alcohol 4h was unambiguously determined as (S) through X-ray crystallographic investigation. Based on this result,

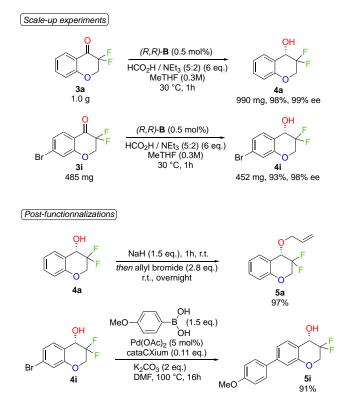
we postulated that the remaining ATH heterocyclic products followed the same pattern.

On the other hand, the absolute configuration of the  $\beta$ -hydroxy sulfone **4p** was assigned through X-ray crystallographic analysis of the corresponding *p*-nitro benzoyl ester **4p'** whereas the configuration of alcohol **4q** was attributed by comparison of the

optical rotation value with reported literature data. [16] Of note, the enantiomers of the enantioenriched Bhydroxy gem-difluorinated heterocyclic and acyclic compounds would be readily prepared by using the complex (S,S)-**B** instead of the (R,R)-isomer. For instance, the asymmetric reduction of 3k using the rhodium complex (S,S)-B furnished the desired alcohol (R)-4k with similar yield and ee value as expected. The effectiveness of this asymmetric transfer hydrogenation process was supported by two scale-up experiments conducted under the defined standard conditions using 3,3-difluorochroman-4-one 7-bromo-3,3-difluorochroman-4-one and (Scheme 2). The yields observed were slightly higher (up to 98% yield) than the ones obtained on smaller scale whereas the enantioselectivities remained unchanged. Furthermore, post-functionalization on 3,3-difluorochroman-4-ol 4a using NaH as a base and allyl bromide as the electrophile allowed the formation of the desired O-allylated product 5a in an of 97%. excellent vield Additionally, functionalization (S)-7-bromo-3,3of difluorochroman-4-ol 4i was performed using a Suzuki-Miyaura coupling with Pd(OAc)<sub>2</sub>, cataCXium A as a ligand, K2CO3 as a base, and 4methoxyphenylboronic acid as a coupling partner. This procedure provided access to the biaryl derivative 5i, with a yield of 91%.

In conclusion, we have developed a simple, robust and easy-to-handle method of rhodium-catalyzed asymmetric transfer hydrogenation preparation of a variety of enantiomerically enriched α-gem-difluorinated alcohols that are potential key building blocks. Interestingly, the reaction proceeds in an open flask, in the eco-friendly 2-MeTHF solvent at 30 °C using a low catalyst loading of 0.5 mol%, with a Rh(III) complex synthesized in our with a mixture laboratory and of acid/triethylamine (5:2) as the hydrogen donor source. High yields ranging from 85% to 98% alongside enantioselectivities up to >99% ee were obtained affording α-gem-difluorinated alcohols tolerating diverse electron-rich or electron-poor substituents in various positions on the aryl ring. Thus, Rh(III)catalyzed ATH enables to efficiently access under mild conditions a variety of enantioenriched βhydroxy gem-difluorinated heterocyclic and acyclic compounds which represent novel fluorinated building blocks of crucial importance in chemistry. Moreover, the ability of the ATH to proceed at scalable conditions without any adverse impact shows promises for future applications. Finally, the resulting compounds can act as valuable frameworks that can undergo subsequent functionalization on either the hydroxyl functional group or the halogenbearing phenyl ring.

## **Experimental Section**

## General procedure for the asymmetric transfer hydrogenation

A round-bottom tube was charged with the corresponding *gem*-difluorinated ketone (0.43 mmol, 1.0 eq.) under air. 1.65 mL (2  $\mu$ mol, 0.005 eq.) of a solution of (*R*,*R*)-**B** (1 mg/mL in 2-MeTHF) was then introduced. The mixture was stirred for one minute before adding by syringe the necessary volume of formic acid/triethylamine (5:2) mixture (218  $\mu$ L, 2.61 mmol, 6.0 eq.). The reaction was stirred at 30 °C with an oil bath for 1 h and the solvent was evaporated under reduced pressure. The remaining oil was diluted in CH<sub>2</sub>Cl<sub>2</sub>, filtered over a short pad of silica gel and concentrated under vacuum. The enantiomeric excess was determined by SFC or HPLC analysis.
