THE SAITO CRITERION AND SOME AVATARS

Abstract: Let k be a field of characteristic zero and $R = k[x_1, \ldots, x_n]$ be a graded commutative ring. To any set of $1 \le s \le n-1$ algebraically independent polynomials

$$f_1,\ldots,f_s\in R$$

one associates a rank-(n+1-s) *R*-module $\text{Der}(f_1, \ldots, f_s)$ of logarithmic derivations; these logarithmic derivations $\delta \in \text{Der}(f_1, \ldots, f_s)$ verify

$$\frac{\delta(f_1)}{f_1} = \dots = \frac{\delta(f_s)}{f_s} \in R.$$

The aim of this note is to extend the Saito criterion, which characterizes freeness of the module $\operatorname{Der}(f)$ of tangent vector fields along a reduced divisor V(f), to the module $\operatorname{Der}(f_1,\ldots,f_s)$. More precisely, let δ_i be (n+1-s) independent derivations in $\operatorname{Der}(f_1,\ldots,f_s)$ and $U \subset \operatorname{Der}(f_1,\ldots,f_s)$ the sub-module generated by the δ_i . We prove that $U = \operatorname{Der}(f_1,\ldots,f_s)$ if and only if $\operatorname{codim}_{k^n} V(\bigwedge^{n+1-s} U) > 1$ when s > 1or $V(\bigwedge^n U) = V(f_1)$ when s = 1.

1. INTRODUCTION

Let $R = k[x_1, \ldots, x_n]$ be a graded commutative ring over a field k of characteristic zero. The partial derivatives $\frac{\partial}{\partial x_i}$ are denoted ∂_i . The *R*-module Der_R of polynomial derivations is a free rank n module:

$$\operatorname{Der}_R \simeq \oplus_{1 \leq i \leq n} R \partial_i.$$

To a square-free polynomial $f \in R$, one associates its module of tangent derivations (or module of tangent vector fields):

$$\operatorname{Der}(f) = \{ \delta \in \operatorname{Der}_R \, | \, \delta(f) \in (f) \},\$$

where (f) is the principal ideal generated by f. The module Der(f) is a rank n reflexive R-module (see [Sai80, Cor. 1.7]) that could also be defined by the canonical exact sequence

$$0 \longrightarrow \operatorname{Der}(f) \longrightarrow \operatorname{Der}(R) \simeq R^n \longrightarrow R/(f)$$

where the last map is

$$\operatorname{Der}(R) \simeq R^n \longrightarrow R/(f), \ \delta \mapsto \delta(f) \operatorname{mod}(f).$$

Remark 1.1. When V(f) is a normal crossing divisor (NCD for short) then Der(f) is locally free (see [Del70] for instance). However, the converse is not true.

Remark 1.2. The map $\operatorname{Der}(R) \simeq R^n \longrightarrow R/(f)$ is the composition of $R^n \longrightarrow R$ sending δ on $\delta(f)$ and the quotient map $R \longrightarrow R/(f)$ sending a polynomial on its reduction modulo f. The image of the first map is the Jacobian ideal $J \subset R$ generated by the partial derivatives $\partial_i f$. Its reduction modulo (f) is $\frac{J+(f)}{(f)}$; when f is homogeneous, J + (f) = J. It defines a subscheme in V(f) supported by the singular locus of V(f). This locus lives in codimension > 1 since f is square free.

Remark 1.3. If f is homogeneous then

$$\delta_E := \sum_i x_i \partial_i \in \operatorname{Der}(f).$$

The derivation δ_E is known as Euler derivation. This induces a splitting

$$\operatorname{Der}(f) = R\delta_E \oplus \operatorname{Der}_0(f)$$
 where $\operatorname{Der}_0(f) = \{\delta \in \operatorname{Der}(R) \mid \delta(f) = 0\};$

to be precise, if f is homogeneous and $\delta \in \text{Der}(f)$ then $\delta - \frac{1}{\deg(f)} \frac{\delta(f)}{f} \delta_E \in \text{Der}_0(f)$. The module $\text{Der}_0(f)$ is the Syzygy module of $\nabla f = (\partial_1 f, \dots, \partial_n f)$,

$$0 \longrightarrow \operatorname{Der}_0(f) \longrightarrow R^n \xrightarrow{\nabla f} R$$

Remark 1.4. Der(f) being reflexive, it must be locally free on the affine plane \mathbb{A}^2 (resp. \mathbb{P}^2).

Remark 1.5. When V(f) is an hyperplane arrangement in \mathbb{P}^n , that is $V(f) = \bigcup_i H_i$ is a union of N + 1 distinct hyperplanes in \mathbb{P}^n then $\mathcal{T}_f = Der(f)$ is the dual of a Steiner sheaf, more precisely it arises as the kernel of a matrix of linear forms that could be described by the linear relations between the H_i (see [DK93], [FV14], [Arr10], [AO01], etc.):

$$0 \longrightarrow \mathcal{T}_f \longrightarrow \mathscr{O}(-1)^{N-1} \longrightarrow \mathscr{O}^{N-n-1}.$$

As first pointed out by Saito in [Sai80], there are divisors V(f) not NCD such that Der(f) is a free *R*-module (meaning that $Der(f) \simeq R^n$). In the same paper Saito gave a determinantal characterization of freeness, commonly called Saito criterion. The aim of this note is to prove again this criterion (see Theorem 3.3) with basic algebraic arguments in order to generalize it to non reduced divisor (see Theorem 4.1) and overall to finite families of polynomials (see Theorem 6.1). All these avatars of Saito criterion are direct consequences of a elementary statement about reflexive module which is explained in the next section 2.

Except when it is specified, the polynomials considered in this text are not necessarily homogeneous.

2. Algebraic prelude: key proposition

We begin by a elementary proposition concerning reflexive modules. This proposition will be the key argument in the next proofs of Saito criterion and its generalization. **Proposition 2.1.** Let M be a rank $s \leq n$ reflexive R-module and Φ a monomorphism $M \hookrightarrow R^n$. Let $N = \sum_{1 \leq i \leq s} Re_i$ be a free sub-module of M and $\iota : N \hookrightarrow M$ be the inclusion map. Then

$$\bigwedge^{s}(e_{1},\ldots,e_{s})=\bigwedge^{s}\Phi\circ\iota=\det(\iota)\bigwedge^{s}\Phi.$$

In particular, the following statements are equivalent:

- (1) M = N(2) $\det(\iota) \in k^*$
- (3) $V(\bigwedge^{s}(\Phi \circ \iota)) = V(\bigwedge^{s} \Phi)$

Proof. This is a consequence of the commutative square:

Indeed, N and M being reflexive modules of rank $s, \bigwedge^s N \simeq \bigwedge^s N^{\vee \vee}$ and $\bigwedge^s M \simeq \bigwedge^s M^{\vee \vee}$ are reflexive module of rank one that is free modules and there is a commutative square

showing that

$$\bigwedge^{s}(e_{1},\ldots,e_{s})=\bigwedge^{s}(\Phi\circ\iota)=\det(\iota)\bigwedge^{s}\Phi$$

This proves our proposition. Let us point out that if s = n then $det(\Phi) \mid det(e_1 \dots, e_s)$. \Box

3. Free divisors: Saito Criterion

Definition 3.1. The module Der(f) is free of rank n if and only if there exist n derivations

$$\delta_i = \sum_{1 \le j \le n} P_{ij} \partial_j \in \operatorname{Der}(f)$$

such that

$$\operatorname{Der}(f) = \oplus_i R\delta_i.$$

Let us first point out the following crucial fact (see [Sai80, 1.5]):

Lemma 3.2. Let $\delta_i \in \text{Der}(f)$ be n independent derivations tangent to V(f). Then,

$$f \mid \det(\delta_1,\ldots,\delta_n).$$

Proof. Since δ_i are *n* independent derivations tangent to V(f) the *R*-module $\oplus R\delta_i$ is a free sub-module of rank *n* of Der(*f*). Calling $N = \oplus R\delta_i$ and M = Der(f) we have, according to Remark 1.2, det(Φ) = *f* and according to Proposition 2.1,

$$\det(\Phi) = f \mid \det(\Psi) = \det(\delta_1, \dots, \delta_n)$$

As direct consequence we get the classical Saito criterion (see [Sai80, Theorem (ii), page 270]):


Theorem 3.3. Der $(f) = \bigoplus_i R\delta_i$ if and only if det $(\delta_1, \ldots, \delta_n) = uf$, $u \in k^*$.

3.1. First proof of Theorem 3.3.

Proof. Denoting $N = \oplus R\delta_i$ and M = Der(f) we have, according to Proposition 2.1, M = N if and only if $\det(\iota) = u \in k^*$.

3.2. Second proof of Theorem 3.3.

Proof. Let $U = \bigoplus_{j=1,...,n} R\delta_j$ be a free sub-module of Der(f). We get a commutative diagram:



where the singular locus of the cokernel K is defined by $V(\bigwedge^n U) = V(\det(\delta_i))$.

Since $\operatorname{Der}(f)$ is reflexive, U is free and $\operatorname{rk}(\operatorname{Der}(f)) = \operatorname{rk}(U)$, then $\operatorname{Der}(f)/U = 0$ when $\operatorname{Der}(f) = U$ or $\operatorname{Der}(f)/U$ is a torsion sheaf when $\operatorname{Der}(f) \neq U$.

— If U = Der(f) then it is is free and $K = \frac{J+(f)}{(f)}$ by the snake lemma. This proves that the singular locus $V(\bigwedge^n U)$ of K is exactly V(f). Actually, this proves more. It proves that the Jacobian ideal J modulo f coincide with the first Fitting ideal defined by $V(\bigwedge^{n-1} U)$.

— If $Der(f) \neq U$ then Der(f)/U is a torsion sheaf. By the snake lemma we get

$$0 \longrightarrow \operatorname{Der}(f)/U \longrightarrow K \longrightarrow \frac{J + (f)}{(f)} \longrightarrow 0$$

proving that the singular locus of K defined by $V(\det(\delta_i))$ differs from V(f).

4. Multiderivations

The previous material can be extend to non reduced divisors and their associated modules of multiderivations. Indeed a multiple polynomial $f = f_1^{m_1} \cdots f_r^{m_r}$ where f_i are square free polynomials of degree $r_i \ge 1$ being given one can define the following sub-module of Der(R) (see [Zie89]):

$$\operatorname{Der}_{\mathbf{m}}(f) := \{ \delta \in \operatorname{Der}_R \, | \, \delta(f_i) \in (f_i^{m_i}) \, 1 \le i \le r \}$$

This R module which is also reflexive, can be defined in by the canonical exact sequence

$$0 \longrightarrow \operatorname{Der}_{\mathbf{m}}(f) \longrightarrow \operatorname{Der}(R) \simeq R^n \longrightarrow R/(f)$$

where the last map is

$$\operatorname{Der}(R) \simeq R^n \longrightarrow R/(f), \ \delta \mapsto \delta(\prod_i f_i) \operatorname{mod}\left(\prod_i f_i^{m_i}\right))$$

In particular this shows that its rank is n. Moreover, there is a natural inclusion

$$\operatorname{Der}_{\mathbf{m}}(f) \subset \operatorname{Der}(\prod_{i} f_i).$$

Saito's criterion is still pertinent for this module, as this is noted in [Zie89]:

Theorem 4.1. Der_{**m**}(f) = $\oplus_i R\delta_i$ if and only if det[$\delta_1, \ldots, \delta_n$] = uf, $u \in k^*$.

Proof. Same proof than Theorem 3.3.

4.1. **Points in** \mathbb{P}^1 . Assume now that the polynomials $f_i \in k[x, y]$ are linear forms (i.e. homogeneous of degree 1). Then V(f) consists in r distinct points p_1, \ldots, p_r with multiplicity m_1, \ldots, m_r .

Lemma 4.2. $Der(f_1 \cdots f_r) = R[-1] \oplus R[1-r].$

Proof. The Euler derivation and the Koszul derivation $\partial_y f \partial_x - \partial_x f \partial_y$ define a free submodule in $\text{Der}(f_1 \cdots f_r)$. By Theorem 3.3 this sub-module is the whole $\text{Der}(f_1 \cdots f_r)$. \Box

Since $\operatorname{Der}_{\mathbf{m}}(f)$ is reflexive it must be free on R = k[x, y]. Then there are two integers $0 \le a \le b$ such that $\operatorname{Der}_{\mathbf{m}}(f) = R[-a] \oplus R[-b]$ and $a + b = \sum_i m_i$.

Since $\operatorname{Der}_{\mathbf{m}}(f) \subset \operatorname{Der}(f_1 \cdots f_r)$ we have an exact sequence:

$$0 \longrightarrow R[-a] \oplus R[-b] \longrightarrow R[-1] \oplus R[1-r] \longrightarrow \oplus_i R/(f_i^{m_i-1})$$

5. Examples of applications

We give here two kinds of applications, some in the homogeneous (or projective) case and some in the non homogeneous case (or affine). The first case is in some sense easier since the degree of the derivations are or are not the good ones, separating the free from the non free divisors. In the affine case, the criterion appears to be stronger since the degrees are not enough to distinguish which set of derivations is a basis or not.

Example 5.1. The arrangement of 3n + 3 lines (the reflection arrangement denoted by $\mathcal{A}_{3}^{3}(n)$ in [OT92]) on \mathbb{P}^{2} defined by the equation

$$f(x, y, z) := xyz(x^n - y^n)(x^n - z^n)(y^n - z^n) = 0$$

is free with exponents (n+1, 2n+1). Indeed the derivations

$$\delta_1 = x^{n+1}\partial_x + y^{n+1}\partial_y + z^{n+1}\partial_z$$
 and $\delta_2 = x^{2n+1}\partial_x + y^{2n+1}\partial_y + z^{2n+1}\partial_z$

belong to Der(f) and

$$\det \begin{bmatrix} x & x^{n+1} & x^{2n+1} \\ y & y^{n+1} & y^{2n+1} \\ z & z^{n+1} & z^{2n+1} \end{bmatrix} = xyz \det \begin{bmatrix} 1 & x^n & x^{2n} \\ 1 & y^n & y^{2n} \\ 1 & z^n & z^{2n} \end{bmatrix} = xyz(x^n - y^n)(x^n - z^n)(y^n - z^n).$$

Let us give two examples now of smooth conics in the affine plane having a basis consisting in polynomials of degree 2 for the first one and of degree one for the other.

Example 5.2. This exemple is due to Yohan Genzmer. He shows that even if Der(f) contains a derivation of minimal degree this derivation is not necessarily a generator of Der(f). Let $f(x,y) = x^2 + y^2 + x$. Then the derivation $2y\partial_x + (2x+1)\partial_y \in Der(f)$ in particular it belongs to $Der_0(f)$ but a basis of Der(f) is given by

$$\begin{cases} \delta_1 = 2y(2x+1)\partial_x + (4y^2-1)\partial_y \\ \delta_2 = x(x+1)\partial_x + (\frac{y}{2}+yx)\partial_y \end{cases}$$

Indeed $\delta_1(f) = 2yf$, $\delta_2(f) = (2x+1)f$ and $\det(\delta_1, \delta_2) = f$. Actually the curve $V(f) \subset \mathbb{A}_2$ is free but the curve $V(x^2 + y^2 + xz) \subset \mathbb{P}^2$ is not free.

Example 5.3. The curve $C \cup L = \{z(x^2 + yz) = 0\}$ union of a smooth conic and one tangent line in \mathbb{P}^2 is free with exponents (1,1). Indeed two derivations in $\text{Der}_0(C \cup L)$ are $z\partial_x - 2x\partial_y$ and $x\partial_x + 4y\partial_y - 2z\partial_z$. and

$$\det \begin{pmatrix} x & z & x \\ y & -2x & 4y \\ z & 0 & -2z \end{pmatrix} = 6z(x^2 + yz).$$

Removing the line $L = \{z = 0\}$ we get

$$0 \longrightarrow \mathcal{T}_{C \cup L} = \mathscr{O}_{\mathbb{P}^2}(-1)^2 \longrightarrow \mathcal{T}_C \longrightarrow \mathscr{O}_L(\alpha) \longrightarrow 0,$$

for some integer α . Then on the affine space $\mathbb{P}^2 \setminus L$, the curve becomes $\{y + x^2 = 0\}$ which is free with two derivations of degree 1:

$$\begin{cases} \delta_1 = \partial_x - 2x\partial_y \\ \delta_2 = \frac{x}{2}\partial_x + y\partial_y \end{cases}$$

verifying $det(\delta_1, \delta_2) = y + x^2$.

6. SAITO CRITERION FOR SEVERAL POLYNOMIALS

Let $S = V(f_1, \ldots, f_s)$ be a locally complete intersection of $1 < s \leq n-1$ reduced hypersurfaces. We denote by $I_S = (f_1, \ldots, f_s)$ the ideal defining S. The module of logarithmic derivations associated to S, say Der(S), consists in derivations δ such that $\delta(g) \in I_S$ for all $g \in Der(S)$. This is a rank n module; one can verify easily that it contains $Der(\prod_i f_i)$.

In this section we are interested in the module:

$$\operatorname{Der}(f_1, \dots, f_s) = \{ \delta \in \operatorname{Der}(R) = R^n \mid f_j \delta(f_i) = f_i \delta(f_j), \ 1 \le i < j \le s \}.$$

We remark first that this module depends on the choice of the polynomials generating I_S .

Theorem 6.1. Let $f_1, \ldots, f_s \in R$ be $1 < s \le n-1$ algebraically independent polynomials. Then,

- (1) $Der(f_1, \ldots, f_s)$ is a reflexive module of rank n s + 1.
- (2) Let $\delta_1, \ldots, \delta_{n+1-s}$ be independent derivations in $\text{Der}(f_1, \ldots, f_s)$. Then,

$$\operatorname{Der}(f_1,\ldots,f_s) = \bigoplus_{j=1,\ldots,n+1-s} R\delta_j \Leftrightarrow \operatorname{codim}_{k^n} V\left(\bigwedge^{n+1-s} [\delta_1,\ldots,\delta_{n+1-s}]\right) > 1.$$

Proof. Let us consider the *R*-module map:

$$\operatorname{Der} R = R^n \longrightarrow R^{s-1}, \ \mu \mapsto (f_i \mu(f_1) - f_1 \mu(f_i))_{2 \le i \le s}.$$

The image of this map, let say K, being a sub-module of a free module is torsion free. Since the f_i are algebraically independent this map is of maximal rank. Being a map between two free modules, its kernel is reflexive. Moreover, the kernel of this map is the module $\text{Der}(f_1, \ldots, f_s)$ since it coincides with the kernel of the map

$$\operatorname{Der} R = R^n \longrightarrow R^{\binom{o}{2}}, \ \mu \mapsto (f_i \mu(f_j) - f_j \mu(f_i))_{1 \le i < j \le s}.$$

This proves (1).

Considering now the free sub-module $U = \bigoplus_{j=1,\dots,n+1-s} R\delta_j$ of $Der(f_1,\dots,f_s)$ we obtain a commutative diagram:

Since K is torsion free this implies that

$$\operatorname{codim}_{k^n} V\left(\bigwedge^{n+1-s}\Phi\right) > 1.$$

Moreover, by Proposition 2.1, $\bigwedge^{n-s+1} \Psi = \det(\iota) \bigwedge^{n-s+1} \Phi$ proving that

$$U = \operatorname{Der}(f_1, \dots, f_s) \Leftrightarrow \operatorname{det}(\iota) \in k^* \Leftrightarrow \operatorname{codim}_{k^n} V \left(\bigwedge^{n+1-s} \Psi\right) > 1.$$

Example 6.2. Let us give an example in \mathbb{A}_3 . Let $f(x, y, z) = x^2 - y^2$ and $g(x, y, z) = z^3 + 1$. The image of the map

$$R^3 \longrightarrow R, \ \mu \mapsto f\mu(g) - g\mu(f)$$

is the ideal $(x(z^3 + 1), y(z^3 + 1), z^2(x^2 - y^2))$. The derivations

$$\left\{ \begin{array}{rcl} \delta_1 &=& y\partial_x + x\partial_y \\ \delta_2 &=& xz^2\partial_x + yz^2\partial_y - (z^3 - 1)\partial_z \end{array} \right.$$

belong to Der(f,g) (actually $\delta_i(f) = \delta_i(g) = 0$). Since $\text{codim}V(\bigwedge^2(\delta_1, \delta_2)) > 1$, the module Der(f,g) is free, more precisely, $\text{Der}(f,g) = R\delta_1 \oplus R\delta_2$.

Example 6.3. The previous example comes from the simple example in \mathbb{P}^3 given by the two equations:

$$f = x_0^2 - x_1^2, \ g = x_2^3 + x_3^3$$

Since the syzygies of the Jacobian ideal are generated by $(x_1, x_0, 0, 0)$ and $(0, 0, x_3^2, -x_2^2)$ the sheaf $\mathcal{T}_{(f,g)} = \mathscr{O}(-1) \oplus \mathscr{O}(-2)$.

If we take, instead of g, another cubic in the ideal (f,g) for instance $g' = g + x_0 f$ then $\mathcal{T}_{(f,g')}$ is no more free because there is no syzygy of degree 1. If we take $g'' = g + x_2 f$ then it is still free and verifies also $\mathcal{T}_{(f,g)} = \mathcal{O}(-1) \oplus \mathcal{O}(-2)$.
