5 — Abstract

⁶ We study the equational theory of Kleene algebra with complement w.r.t. languages. While the ⁷ equational theory w.r.t. languages coincides with the language equivalence (under the standard ⁸ language valuation) for terms of Kleene algebra, this coincidence is broken if we extend the terms with ⁹ complement. In this paper, we present *a finite relational semantics*, which completely characterizes ¹⁰ the equational theory above. As applications, we show that the equational theory is (1) undecidable ¹¹ and Π_1^0 -complete for full terms; (2) decidable and PSPACE-complete if the complement only applies ¹² to variables or constants.

17 **1** Introduction

Kleene algebra (KA) [12, 7] is an algebraic system for regular expressions consisting of union 18 (\cup) , composition (\cdot) , Kleene-star $(_^*)$, empty (\bot) , and identity (I). In this paper, we consider 19 the equational theory w.r.t. languages for extended KA terms. We write LANG $\models t = s$ if 20 t = s holds on all models of languages, i.e., for any sets X, when each letter maps to any 21 languages over X, the two expressions, t and s, have the same language. By the completeness 22 of KA, for (non-extended) KA terms, the equational theory w.r.t. languages coincides¹ with 23 the language equivalence under the standard language valuation (i.e., each x maps to the 24 singleton language $\{x\}$: for all KA terms t, s, we have 25

where [u] denotes the language of an expression u under the standard language valuation.

The equivalence above is broken in general if we extend KA terms with some operators. The equational theory w.r.t. languages for KA terms with some operators was studied, e.g., with reverse [3], with tests [14] (where languages are of guarded strings, not words), with intersection (\cap) [2], with universality (\top) [28, 21], with variable complements (\bar{x}) [19], and combinations of some of them [4, 5]. For example, for (variable) complements, Equation (\dagger -KA) fails, e.g., by the following counter-example [19]:²

LANG is more compatible with equational reasoning, in that valid equations in LANG are preserved under substitution (by definition), while those under the language equivalence are not: $[\overline{x}] = \{x\} \neq \{xx\} = [\overline{x} \cdot \overline{x}].$

Extending with full complement significantly enhances the expressive power. For example, we can define \top and \cap using complement: $\top = \overline{\bot}$ and $t \cap s = \overline{\overline{t} \cup \overline{s}}$. Moreover, we can encode quantifier-free formulas (including hypotheses as Horn formulas) by equations (Sect. 4).

 $[\]overline{x}^{2} = \mathbf{V}^{*} \setminus \{x\} = [\overline{x} \cdot \overline{x}]$ where \mathbf{V} is the alphabet. For $\mathsf{LANG} \not\models \overline{x} = \overline{x} \cdot \overline{x}$: By the valuation $x \mapsto \mathbf{V}^{*} \setminus \{x\}$.

In this paper, we present a finite relational semantics for KA with complement w.r.t. languages: relational subword models RSUB (Sect. 3), which ease us to study the equational theory w.r.t. languages, relationally. Our relational semantics can more robustly characterize the equational theory than known relational semantics, e.g., for KAs (REL) [22, third page] and for KAs with \top (GREL) [28, 21] (Remark 3.11). As applications, by transforming the techniques in [18] from relational models REL to RSUB, we have the following complexity results: the equational theory w.r.t. languages is

51 2. PSPACE-complete for KA terms with variable and constant complements (Thm. 6.10).

The first result gives a natural example that the equational theory w.r.t. languages is undecidable, while the standard language equivalence is decidable (by a standard automata construction). The second result positively settles the open problem posed in [19].

This paper is structured as follows. In Sect. 2, we give basic definitions. In Sect. 3, we give RSUB and show that the quantifier-free theory of LANG coincides with that of RSUB. In Sect. 4, we give a reduction from the quantifier-free theory into the equational theory and show that the equational theory is Π_1^0 -complete for KA terms with full complement. In Sect. 5, by using RSUB, we give a graph characterization for KA terms with variable and constant complements. In Sect. 6, we show that the equational theory for KA terms with variable and constant complements is PSPACE-complete. In Sect. 7, we conclude this paper.

62 **2** Preliminaries

For a set X (of *letters*), we write X^* for the set of *words* over X. We write I for the empty word. We write wv for the concatenation of words w and v. A *language* over X is a subset of X^* . We use w, v to denote words and use L, K to denote languages, respectively. For languages $L, K \subseteq X^*$, the *concatenation* $L \cdot K$ and the *Kleene star* L^* is defined by:

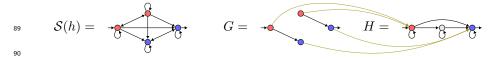
A (2-pointed) graph G over a set A is a tuple $\langle |G|, \{a^G\}_{a \in A}, 1^G, 2^G \rangle$, where |G| is a 71 non-empty set (of vertices), each $a^G \subseteq |G|^2$ is a binary relation, and $\mathbf{1}^G, \mathbf{2}^G \in |G|$ are 72 vertices. Let G, H be graphs over a set A. For a map $f: |G| \to |H|$, we say that f is a graph 73 *homomorphism* from G to H, written $f: G \longrightarrow H$ if for all x, y, and a, $\langle x, y \rangle \in a^G$ implies 74 $\langle f(x), f(y) \rangle \in a^H, f(1^G) = 1^H, \text{ and } f(2^G) = 2^H.$ We say that f is a graph isomorphism from 75 G to H if f is bijective and for all x, y, and a, $\langle x, y \rangle \in a^G$ iff $\langle f(x), f(y) \rangle \in a^H$, $f(1^G) = 1^H$, 76 and $h(2^G) = 2^H$. We say that H is an *edge-extension* of G if |H| = |G|, $a^H \supseteq a^G$ for all a, 77 $1^H = 1^G$, and $2^H = 2^G$. For a set $\{1^G, 2^G\} \subseteq X \subseteq |G|$, the *induced subgraph* of G on X is the 78 graph $\langle X, \{a^G \cap (X \times X)\}_{a \in A}, 1^G, 2^G \rangle$. For an equivalence relation E, the *quotient graph* of G 79 w.r.t. E is the graph $G/E \triangleq \langle |G|/E, \{\langle X, Y \rangle \mid \exists x \in X, y \in Y, \langle x, y \rangle \in a^G \}_{a \in A}, [1^G]_E, [2^G]_E \rangle$ 80 where X/E denotes the set of equivalence classes of X by E and $[x]_E$ denotes the equivalence 81 class of x. Additionally, we use the following operation: 82

▶ Definition 2.1. For a graph homomorphism $h: G \longrightarrow H$ (G, H over a set A), the edgesaturation of G w.r.t. h is the graph $S(h) \triangleq \langle |G|, \{\{\langle x, y \rangle \mid \langle h(x), h(y) \rangle \in a^H\}\}_{a \in A}, 1^G, 2^G \rangle$.

Example 2.2. Let $h: G \longrightarrow H$ be the graph homomorphism indicated by green colored arrows and also by vertices' colors (graphs are written as unlabelled graphs for simplicity).

Then the edge-saturation $\mathcal{S}(h)$ is the following graph, which is an edge-extension of G where

the extended edges are derived from edges of H:



⁹¹ 2.1 Syntax: terms of KA with complement

We consider *terms* over the signature $S \triangleq \{I_{(0)}, \bot_{(0)}, \cdot_{(2)}, \bigcup_{(2)}, _^*_{(1)}, _^-_{(1)}\}$. Let **V** be a set of *variables*. For a term t over S, let \overline{t} be s if $t = s^-$ for some s and be t^- otherwise. We use the abbreviations:

For $X \subseteq \{\overline{x}, \overline{l}, \top, \cap, -\}$, let KA_X be the minimal subset A of the set of terms over S satisfying the following:

An equation t = s is a pair of terms. An inequation $t \leq s$ abbreviates the equation $t \cup s = s$. The set of quantifier-free formulas of KA_X is defined by the following grammar:

2.2 Semantics: language models

An *S*-algebra \mathcal{A} is a tuple $\langle |\mathcal{A}|, \{f^{\mathcal{A}}\}_{f_{(k)} \in S} \rangle$, where $|\mathcal{A}|$ is a non-empty set and $f^{\mathcal{A}} : |\mathcal{A}|^k \to |\mathcal{A}|$ is a *k*-ary map for each $f_{(k)} \in S$. A valuation \mathfrak{v} of an *S*-algebra \mathcal{A} is a map $\mathfrak{v} : \mathbf{V} \to |\mathcal{A}|$. For a valuation \mathfrak{v} , we write $\hat{\mathfrak{v}} : \mathrm{KA}_{\{-\}} \to |\mathcal{A}|$ for the unique homomorphism extending \mathfrak{v} . Moreover, for a quantifier-free formula φ , we define $\hat{\mathfrak{v}}(\varphi) \in \{\mathsf{true}, \mathsf{false}\}$ by:

$$\hat{\mathfrak{v}}(t=s) \Leftrightarrow (\hat{\mathfrak{v}}(t)=\hat{\mathfrak{v}}(s)) \qquad \hat{\mathfrak{v}}(\varphi \wedge \psi) \Leftrightarrow (\hat{\mathfrak{v}}(\varphi) \text{ and } \hat{\mathfrak{v}}(\psi)) \qquad \hat{\mathfrak{v}}(\neg \varphi) \Leftrightarrow (\operatorname{not} \hat{\mathfrak{v}}(\varphi)).$$

For a quantifier-free formula φ and a class of valuations (of S-algebra) \mathcal{C}^3 , we write

 $\underset{117}{\overset{116}{\longrightarrow}} \qquad \mathcal{C} \models \varphi \quad \Leftrightarrow \quad \hat{\mathfrak{g}}(\varphi) \text{ holds for all valuations } \mathfrak{v} \in \mathcal{C}.$

We abbreviate $\{v\} \models \varphi$ to $v \models \varphi$. The *equational theory of* C is the set of all equations t = ssuch that $C \models t = s$. The *quantifier-free theory of* C is the set of all quantifier-free formulas φ such that $C \models \varphi$.

The *language model* \mathcal{A} over a set X, written lang_X , is the *S*-algebra defined by $|\mathcal{A}| = \varphi(X^*)$, $|\mathcal{A} = \{l\}$, $\perp^{\mathcal{A}} = \emptyset$, and for all $L, K \subseteq X^*$,

We write LANG_X for the class of all valuations of lang_X and write LANG for $\bigcup_X \mathsf{LANG}_X$.

The *language* $[t] \subseteq \mathbf{V}^*$ of a term t is $\hat{\mathfrak{v}}_{st}(t)$ where \mathfrak{v}_{st} is the valuation on the language model over the set \mathbf{V} defined by $\mathfrak{v}_{st}(x) = \{x\}$ for $x \in \mathbf{V}$. Since $\mathfrak{v}_{st} \in \mathsf{LANG}$, we have

The converse direction fails, as in the introduction. In the sequel, we consider the equational
 theory w.r.t. languages.

133 2.3 (Generalized) relational models

We write \triangle_A for the identity relation on a set A: $\triangle_A \triangleq \{\langle x, x \rangle \mid x \in A\}$. For binary relations R, S on a set B, the composition $R \cdot S$, the *n*-th iteration R^n (where $n \in \mathbb{N}$), and the reflexive transitive closure R^* are defined by:

$$\underset{137}{} R \cdot S \triangleq \{ \langle x, z \rangle \mid \exists y, \langle x, y \rangle \in R \land \langle y, z \rangle \in S \} \quad R^n \triangleq \begin{cases} R \cdot R^{n-1} (n \ge 1) \\ \triangle_B \quad (n = 0) \end{cases} \quad R^* \triangleq \bigcup_{n \in \mathbb{N}} R^n \cdot R^n \in \mathbb{N} \end{cases}$$

Let U be a binary relation on a non-empty set B. A generalized relational model⁴ \mathcal{A} on U is an S-algebra such that $|\mathcal{A}| \subseteq \wp(U)$, $|^{\mathcal{A}} = \bigtriangleup_B$, $\bot^{\mathcal{A}} = \emptyset$, and for all $R, S \subseteq U$,

¹⁴⁵ **3** Finite relational models for language models

In this section, we present the finite relational semantics RSUB for LANG. Sect. 3.1 introduces
the class SUB, which is intuitively an intermediate class between LANG and RSUB, and show
that the quantifier-free theory of LANG coincides with that of SUB. Sect. 3.2 introduces
RSUB and show that the quantifier-free theory of LANG coincides with that of RSUB.

150 **3.1** SUB: subword models

For the standard language valuation (v_{st}) , the membership $w \in \hat{v}_{st}(t)$ can determined from $w' \in \hat{v}_{st}(t')$ where w' ranges over *subwords* of w (and t' ranges over subterms of t). This situation is the same also for any valuations $v \in LANG$, To reflect this property to LANG, we define the following class: subword models SUB. These models are language models where the universe is bounded to the set of subwords of a word $\ell_0 \dots \ell_{n-1}$.

¹⁵⁶ ► **Definition 3.1.** Let $n \in \mathbb{N}$ and let $\ell_0, \ldots, \ell_{n-1}$ be pairwise distinct letters. Let $U = \{\ell_i \ldots \ell_{j-1} \mid 0 \le i \le j \le n\}$. The subword language model \mathcal{A} of length n, written SUB_n , is ¹⁵⁸ the S-algebra defined by: $|\mathcal{A}| = \wp(U)$, $\mathsf{I}^{\mathcal{A}} = \{\mathsf{I}\}$, $\bot^{\mathcal{A}} = \emptyset$, and for all $L, K \subseteq U$,

$$L \cdot^{\mathcal{A}} K = (L \cdot K) \cap U \qquad L \cup^{\mathcal{A}} K = L \cup K \qquad L^{*^{\mathcal{A}}} = L^* \cap U \qquad L^{-^{\mathcal{A}}} = U \setminus L.$$

- We write SUB_n for the class of all valuations of sub_n and write SUB for $\bigcup_{n \in \mathbb{N}} SUB_n$. 161
- We use the following transformation of valuations from LANG into SUB. 162

▶ Definition 3.2 (letters-to-letters valuations; cf. words-to-letters valuations [19]). Let X be a 163 set and let $\mathfrak{v} \in \mathsf{LANG}_X$. Let $n \in \mathbb{N}$ and let a_0, \ldots, a_{n-1} be (possibly not pairwise distinct) 164 letters over X. Then we define $\mathfrak{v}^{(a_0,\ldots,a_{n-1})}$ as the following valuation in SUB_n : 165

$$\mathfrak{v}^{\langle a_0,\ldots,a_{n-1}\rangle}(x) \triangleq \{\ell_i\ldots\ell_{j-1} \mid 0 \le i \le j \le n \land a_i\ldots a_{j-1} \in \mathfrak{v}(x)\}.$$

► Example 3.3. If $\mathfrak{v}(x) = \{aba, a, bb\}$, then $\mathfrak{v}^{\langle a, b, a \rangle}(x) = \{\ell_0 \ell_1 \ell_2, \ell_0, \ell_2\}$. Note that $\mathfrak{v}^{\langle a, b, a \rangle}$ 167 only reflects w.r.t. subwords of aba. 168

Using this, we can embed the membership in LANG into that in SUB. 169

▶ Lemma 3.4. Let X be a set and let $v \in \mathsf{LANG}_X$. Let $n \in \mathbb{N}$ and let a_0, \ldots, a_{n-1} be letters 170 over X. For all terms t and $0 \leq i \leq j \leq n$, $\ell_i \dots \ell_{j-1} \in \hat{\mathfrak{v}}^{\langle a_0, \dots, a_{n-1} \rangle}(t)$ iff $a_i \dots a_{j-1} \in \hat{\mathfrak{v}}(t)$. 171

- **Proof.** By easy induction on t, cf. [19, Lem. 23] (see Appendix D, for detailed proof).⁶ 172
- Moreover, this transformation is a surjective map to SUB, as follows: 173

▶ **Proposition 3.5.** Let $n \in \mathbb{N}$ and let $v' \in SUB_n$. Let $v \in LANG_{\{\ell_0,...,\ell_{n-1}\}}$ be the valuation 174 defined by $\mathfrak{v}(x) = \mathfrak{v}'(x)$. Then $\mathfrak{v}^{\langle \ell_0, \dots, \ell_{n-1} \rangle} = \mathfrak{v}'$. 175

Proof. By Def. 3.2, $\ell_i \dots \ell_{j-1} \in \mathfrak{v}^{\langle \ell_0, \dots, \ell_{n-1} \rangle}(x)$ iff $\ell_i \dots \ell_{j-1} \in \mathfrak{v}(x)$ iff $\ell_i \dots \ell_{j-1} \in \mathfrak{v}'(x)$. 176

- From them, we have that the quantifier-free theory of LANG coincides with that of SUB. 177
- ▶ Lemma 3.6. For all quantifier-free formulas φ , we have: LANG $\models \varphi \Leftrightarrow$ SUB $\models \varphi$. 178

Proof. By $\mathfrak{v} \models t = s \leftrightarrow (t \leq s \land s \leq t)$ and $\mathfrak{v} \models t \leq s \leftrightarrow t \cap s^- \leq \bot$ for $\mathfrak{v} \in \mathsf{LANG} \cup \mathsf{SUB}$, 179 without loss of generality, we can assume that each equation in φ is of the form $u \leq \bot$. 180 By taking the conjunctive normal form, it suffices to show when φ is of the form $(\bigvee_k t_k \leq$ 181 \perp) \vee ($\bigvee_k \neg s_k \leq \perp$). By $\mathfrak{v} \models (t \leq \perp \land s \leq \perp) \leftrightarrow t \cup s \leq \perp$ for $\mathfrak{v} \in \mathsf{LANG} \cup \mathsf{SUB}$, it suffices to show when φ is of the form ($\bigvee_{k=1}^m t_k \leq \perp$) \vee ($\neg s \leq \perp$). Then, we have: 182 183

This equivalence holds thanks to that a_i, \ldots, a_{j-1} are letters not words. For words-to-letters valuations, the direction \Rightarrow of Lem. 3.4 only holds [19, Lem. 23].

- ¹⁹² Next, we introduce RSUB, the relational version of SUB.
- ▶ Definition 3.7. Let $n \in \mathbb{N}$. The relational subword language model \mathcal{A} of length n, written rsub_n, is the generalized relational model on the set $U = \{\langle i, j \rangle \in [0, n] \times [0, n] \mid i \leq j\}$ s.t.

¹⁹⁵ $|\mathcal{A}| = \{ R \in \wp(U) \mid R \supseteq \bigtriangleup_{[0,n]} \lor U \setminus R \supseteq \bigtriangleup_{[0,n]} \}.$

We write RSUB_n for the class of all valuations of rsub_n and write RSUB for $\bigcup_{n \in \mathbb{N}} \mathsf{RSUB}_n$.

▶ **Proposition 3.8.** For each $n \in \mathbb{N}$, sub_n is isomorphic to rsub_n.

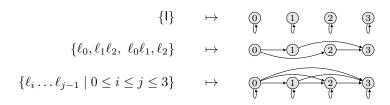


Figure 1 Illustrative instances of the bijective map from sub_n to $rsub_n$ when n = 3 (Prop. 3.8). 198 examples of this map (we display binary relations as graphs in a standard way). 199 ▶ **Theorem 3.9.** For all quantifier-free formulas φ , we have: LANG $\models \varphi \Leftrightarrow \mathsf{RSUB} \models \varphi$. 200 **Proof.** By Lem. 3.6 and Prop. 3.8. 4 201 ▶ Corollary 3.10. The quantifier-free theory w.r.t. languages is in Π_1^0 for KA_{-} terms. 202 **Proof.** By the finite model property of RSUB (the universe $|\mathsf{rsub}_n|$ is finite for each n). 203 ▶ Remark 3.11 (RSUB and GREL). For $KA_{\{T\}}$, the equational theory of LANG coincides with 204 that of GREL [21, REL' in Sect. 5][28]. However for $KA_{\{-\}}$, this coincidence is broken, e.g.,⁹ 205 $\mathsf{LANG} \models ab \cap cd \le a \top d \cup b \top c \qquad \mathsf{GREL} \not\models ab \cap cd \le a \top d \cup b \top c \qquad \diamondsuit^a \xrightarrow{a \to \bigtriangledown b}_{c \to \circ} \xrightarrow{b}_{d \to \circ} b \to c$ 206 $(\mathsf{G})\mathsf{REL} \not\models a \leq \overline{b}a\overline{b} \cup bab$ $\mathsf{LANG} \models a < \overline{b}a\overline{b} \cup bab$ $\circ a \rightarrow \circ$ 207 208 (Each right figure denotes a valuation for $(G)REL \not\models$ where some edges are omitted.) 209 ▶ Remark 3.12 (the subclass of RSUB for the standard language valuation). Let 210 $\bigcup_{a \in \mathbf{V}} \mathfrak{v}(a) = \{ \langle i - 1, i \rangle \mid i \in [1, n] \}$ <u>лтт (</u>

Proof. By the bijective⁷ map $f: L \mapsto \{\langle i, j \rangle \mid \ell_i \dots \ell_{j-1} \in L\}$.⁸ Fig. 1 presents illustrative

By an analogy of Thm. 3.9, we have that [t] = [s] iff $\mathsf{RSUB}_{st} \models t = s$ (Appendix A).

In Fig. 2, we summarize the equational theories for $KA_{\{-\}}$ terms above where the inclusions are shown by $REL \subseteq GREL \supseteq RSUB \supseteq RSUB_{st}$ and Thm. 3.9 and the noninclusions are shown by counter-examples.¹⁰

²¹⁶ **4** From quantifier-free formulas to equations

Using SUB/RSUB, we give a reduction from the quantifier-free theory into the equational theory of LANG. For $n \in \mathbb{N}$, $\mathfrak{v} \in SUB_n$, and i, j s.t. $0 \le i \le j \le n$, we define $\mathfrak{v}, i, j \models \varphi$ as

$$\begin{aligned} & \mathfrak{v}, i, j \models t = s \Leftrightarrow (\ell_i \dots \ell_{j-1} \in \hat{\mathfrak{v}}(t) \text{ iff } \ell_i \dots \ell_{j-1} \in \hat{\mathfrak{v}}(s)) \\ & \mathfrak{v}, i, j \models \varphi \land \psi \Leftrightarrow (\mathfrak{v}, i, j \models \varphi \text{ and } \mathfrak{v}, i, j \models \psi) \\ \end{aligned}$$

The following shows that to check $SUB \models t = s$, it suffices to check about the pairs of the left-most and right-most vertices.

▶ Lemma 4.1. For all terms t, s, $SUB \models t = s \Leftrightarrow \forall n \in \mathbb{N}, \forall \mathfrak{v} \in SUB_n, \mathfrak{v}, 0, n \models t = s$.

Proof. Because $t = s \leftrightarrow (t \le s \land s \le t)$ and $t \le s \leftrightarrow t \cap s^- \le \bot$ hold for "RSUB \models _" and " $\mathfrak{v}, 0, n \models$ _", it suffices to show when the equation is of the form $t \le \bot$. We then have

SUB $\not\models t \leq \bot$

 $\exists \mathfrak{v} \in \mathsf{LANG}, n \in \mathbb{N}, i, j \text{ s.t. } 0 \leq i \leq j \leq n, \ \ell_i \dots \ell_{j-1} \in \hat{\mathfrak{v}}^{\langle \ell_0, \dots, \ell_{n-1} \rangle}(t)$ \Rightarrow (Prop. 3.5)228 $\exists \mathfrak{v} \in \mathsf{LANG}, n \in \mathbb{N}, i, j \text{ s.t. } 0 \leq i \leq j \leq n, \ \ell_i \dots \ell_{j-1} \in \hat{\mathfrak{v}}(t)$ (Lem. 3.4)229 $\exists \mathfrak{v} \in \mathsf{LANG}, n \in \mathbb{N}, i, j \text{ s.t. } 0 \le i \le j \le n, \ \ell_0 \dots \ell_{j-i-1} \in \hat{\mathfrak{v}}^{\langle \ell_i, \dots, \ell_{j-1} \rangle}(t) \quad (\text{Lem. 3.4})$ \Rightarrow 230 $\exists n \in \mathbb{N}, \mathfrak{v} \in \mathsf{SUB}_n, \ \ell_0 \dots \ell_{n-1} \in \hat{\mathfrak{v}}(t) \qquad (\text{Let } n \triangleq j - i \text{ as } \mathfrak{v}^{\langle \ell_i, \dots, \ell_{j-1} \rangle} \in \mathsf{SUB}_{j-i})$ 231 \Rightarrow $\mathsf{SUB} \not\models t \leq \bot$. (Trivial) \Rightarrow 232 233

(The second line from the bottom is equivalent to $\exists n \in \mathbb{N}, \mathfrak{v} \in \mathsf{SUB}_n, \mathfrak{v}, 0, n \not\models t \leq \bot$.)

Lem. 4.1 fails for quantifier-free formulas, e.g., $a \leq \perp \lor \overline{a} \leq \perp$ only holds in the right-hand side. We consider replacing each inequation $u \leq \perp$ with $\top u \top \leq \perp$. Then we have that $\mathfrak{v} \models u \leq \perp$ iff $\mathfrak{v}, 0, n \models \top u \top \leq \perp$, where $n \in \mathbb{N}$ and $\mathfrak{v} \in \mathsf{SUB}_n$ (see Lem. 4.2). More generally, for a quantifier-free formula φ , let $\operatorname{Tr}(\varphi)$ be the term defined by:¹¹

$$\operatorname{Tr}(t=s) \triangleq \top ((t \cap s^{-}) \cup (t^{-} \cap s)) \top \quad \operatorname{Tr}(\varphi \land \psi) \triangleq \operatorname{Tr}(\varphi) \cup \operatorname{Tr}(\psi) \quad \operatorname{Tr}(\neg \varphi) \triangleq \operatorname{Tr}(\varphi)^{-}.$$

¹⁰Note that EqT(LANG) = EqT(GREL) for $KA_{\{\top\}}$ and $EqT(\{\mathfrak{v}_{st}\}) = EqT(GREL)$ for KA [28, 21].

¹¹ Tr(t = s) can be simplified for specific cases, e.g., Tr $(t \le s) = \top (t \cap s^{-}) \top$ and Tr $(t \le \bot) = \top t \top$.

▶ Lemma 4.2. Let $n \in \mathbb{N}$ and $\mathfrak{v} \in SUB_n$. Let φ be a quantifier-free formula. Then,

$$\mathfrak{v} \models \varphi \quad \Leftrightarrow \quad \mathfrak{v}, 0, n \models \operatorname{Tr}(\varphi) \leq \bot.$$

Proof. By easy induction on φ . Case $\varphi = (t = s)$: Let $u = (t \cap s^-) \cup (t^- \cap s)$. Then $\mathfrak{v} \models t = s$ iff $\hat{\mathfrak{v}}(u) = \emptyset$ iff $\ell_0 \dots \ell_{n-1} \notin \hat{\mathfrak{v}}(\top u^{\top})$ iff $\mathfrak{v}, 0, n \models \top u^{\top} \leq \bot$ iff $\mathfrak{v}, 0, n \models \operatorname{Tr}(t = s)$. For \wedge : By $\mathfrak{v}, 0, n \models ((t \leq \bot) \land (s \leq \bot)) \leftrightarrow (t \cup s \leq \bot)$. For \neg : By $\mathfrak{v}, 0, n \models (\neg (t \leq \bot)) \leftrightarrow (t^- \leq \bot)$.

▶ **Theorem 4.3** (cf. Schröder-Tarski translation [27]). There is a polynomial-time reduction from the quantifier-free theory of LANG into the equational theory of LANG.

Proof. By Lems. 4.1 and 4.2, $\mathsf{SUB} \models \varphi$ iff $\mathsf{SUB} \models \mathrm{Tr}(\varphi) \leq \bot$. Thus by Thm. 3.9.

Corollary 4.4 (Hoare hypotheses elimination). For all terms t, s, u,

LANG
$$\models u \leq \bot \rightarrow t \leq s \quad \Leftrightarrow \quad \mathsf{LANG} \models t \leq s \cup \top u \top.$$

²⁵² **Proof.** By set-theoretic equivalences, we have

$$\begin{array}{cccc} \text{SUB} \models u \leq \bot \to t \leq s & \Leftrightarrow & \text{SUB} \models \top (t \cap s^{-}) \top \leq \top u \top & (\text{By Thm. 4.3}) \\ \text{SUB} \models t \cap s^{-} \leq \top u \top & (\Rightarrow: \text{By } \mathsf{I} \leq \top \iff \mathsf{By } \top \top \leq \top) \\ \Leftrightarrow & \text{SUB} \models t \leq s \cup \top u \top & (\Rightarrow: \mathsf{By } \mathsf{I} \leq \top \iff \mathsf{By } \top \top \leq \top) \\ \end{array}$$

▶ Remark 4.5. Note that LANG $\not\models (\neg u \leq \bot) \leftrightarrow \top \leq \top u\top$, cf. Schröder-Tarski translation [27, XXXII.] for REL. If $\hat{\mathfrak{v}}(u) = \{w\}$ where $\mathfrak{v} \in \mathsf{LANG}_X$ and $w \neq \mathsf{I}$, then $\hat{\mathfrak{v}}(\top) = [X^*] \not\subseteq$ [X^*wX^*] = $\hat{\mathfrak{v}}(\top u\top)$. This is why we go via " $\mathfrak{v}, 0, n \models _$ " (Lems. 4.1 and 4.2). Similarly for Cor. 4.4, LANG $\not\models (u \leq \bot \to t \leq s) \leftrightarrow (t \leq s \cup \top u\top)$, e.g., when $t = \top$ and $s = \bot$.

4.1 Undecidability via the Hoare hypotheses elimination

- Thm. 4.3/Cor. 4.4 implies the undecidability of the equational theory of LANG for full terms. A context-free grammar (CFG) \mathfrak{C} over a finite set A is a tuple $\langle X, \mathcal{R}, \mathsf{s} \rangle$, where
- $_{264}$ \blacksquare X is a finite set of non-terminal labels s.t. $A \cap X = \emptyset$;
- 265 \mathcal{R} is a finite set of rewriting rules $x \leftarrow w$ of $x \in X$ and $w \in (A \cup X)^*$;
- 266 **s** $\in X$ is the start label.

²⁶⁷ We write $[\mathfrak{C}]$ for the *language* of \mathfrak{C} . It is well-known that the *universality problem* for CFGs—

given a CFG \mathfrak{C} , does $[\mathfrak{C}] = A^*$ hold?—is Π_1^0 -complete. We can naturally encode this problem by the quantifier-free theory of LANG, as follows (cf. [18, Lem. 47]).

Lemma 4.6. Let $\mathfrak{C} = \langle X, \mathcal{R}, \mathsf{s} \rangle$ be a CFG over a finite set A. Then,

$$_{271} \qquad [\mathfrak{C}] = A^* \quad \Leftrightarrow \quad \mathsf{LANG} \models (\bigwedge_{(x \leftarrow w) \in \mathcal{R}} w \leq x) \to (A^* \leq \mathsf{s}).$$

Here, A denotes the term $(a_1 \cup \cdots \cup a_n)$ in the right-hand side where $A = \{a_1, \ldots, a_n\}$.

Proof Sketch. By an analogy of [18, Lem. 47] (for REL). The relational models used in [18]
are of the form of RSUB. See Appendix E for a detail.

Theorem 4.7. The equational theory w.r.t. languages is Π_1^0 -complete for $KA_{\{\overline{x}, \ldots\}}$.

Proof. (in Π_1^0): By Cor. 3.10. (Hardness): Let $\mathfrak{C} = \langle X, \{x_i \leftarrow w_i \mid i \in [1,n]\}, \mathfrak{s} \rangle$ be a CFG over a finite set A. By Lem. 4.6 and by Cor. 4.4 with $\mathsf{LANG} \models (\bigwedge_{i \in [1,n]} w_i \leq x_i) \leftrightarrow (\bigcup_{i \in [1,n]} w_i \cap \overline{x}_i) \leq \bot$, we have: $[\mathfrak{C}] = A^*$ iff $\mathsf{LANG} \models A^* \leq \mathfrak{s} \cup \top (\bigcup_{i \in [1,n]} w_i \cap \overline{x}_i) \top$. Hence, we can give a reduction from the universality problem of CFGs.

- ▶ Corollary 4.8. The equational theory w.r.t. languages is Π_1^0 -complete for KA_{-}. 280
- **Proof.** By Cor. 3.10 and Thm. 4.7. 281
- Moreover, we also have the following, as $\mathsf{LANG} \models \overline{\mathsf{I}} = A \top \to A^* = \top$ holds (see Appendix E). 282 283
- ▶ Lemma 4.9. Let $\mathfrak{C} = \langle X, \mathcal{R}, \mathsf{s} \rangle$ be a CFG over a finite set A. Then, 284

$$[\mathfrak{C}] = A^* \quad \Leftrightarrow \quad \mathsf{LANG} \models (\bar{\mathsf{I}} = A \top \land \bigwedge_{(x \leftarrow w) \in \mathcal{R}} w \le x) \to (\top \le \mathsf{s}).$$

Hence, the undecidability still holds even without Kleene star. 286

▶ Theorem 4.10. The equational theory w.r.t. languages is Π_1^0 -complete for KA_{-} without 287 Kleene star. 288

Proof. In the same way as Thm. 4.7 (by using Lem. 4.9 instead of Lem. 4.6). 289

Graph characterization for $KA_{\{\overline{x},\overline{J},\top,\cap\}}$ terms 5 290

In Sects. 5 and 6, we consider the decidability of $KA_{\{\overline{x},\overline{\mathfrak{l}},\top\}}$. We recall Sect. 2 for graphs. In 291 this section, we give a graph characterization of the equational theory of RSUB for $KA_{\{\overline{x},\overline{i},\top,\cap\}}$, 292 by generalizing the graph characterization of REL [18, Thm. 18]. 293

5.1 Graph languages for $KA_{\{\overline{x},\overline{l},\top,\cap\}}$ 294

Let $\tilde{\mathbf{V}} \triangleq \{x, \overline{x} \mid x \in \mathbf{V}\} \cup \{\overline{\mathbf{I}}, \top\}$ and $\tilde{\mathbf{V}}_{\mathbf{I}} \triangleq \tilde{\mathbf{V}} \cup \{\mathbf{I}\}$. For a $\mathrm{KA}_{\{\overline{x}, \overline{\mathbf{I}}, \top, \cap\}}$ term t, the graph 295 language $\mathcal{G}(t)$ is a set of graphs over $\tilde{\mathbf{V}}_{\mathbf{I}}$ defined by:¹²

(We use *series-composition* for (\cdot) and *parallel-composition* for (\cap) .) 301

For a valuation $\mathfrak{v} \in \mathsf{GREL}$ on a binary relation on a set B and $\langle x, y \rangle \in \hat{\mathfrak{v}}(\top)$, let $\mathsf{G}(\mathfrak{v}, x, y)$ 302 be the graph defined by: 303

$$\mathsf{G}(\mathfrak{v}, x, y) \triangleq \langle B, \{\hat{\mathfrak{v}}(a)\}_{a \in \tilde{\mathbf{V}}_{1}}, x, y \rangle$$

For a class $\mathcal{C} \subseteq \mathsf{GREL}$, let $\mathrm{GR}_{\mathcal{C}}$ be the graph language $\{\mathsf{G}(\mathfrak{v}, x, y) \mid \mathfrak{v} \in \mathcal{C} \text{ and } \langle x, y \rangle \in \hat{\mathfrak{v}}(\top)\}$. 305 We say that a graph language \mathcal{G} is *induced subgraph-closed* if every induced subgraph of 306 every $G \in \mathcal{G}$ is isomorphic to a member of \mathcal{G} . We say that a class $\mathcal{C} \subseteq \mathsf{GREL}$ is induced 307 subgraph-closed if $GR_{\mathcal{C}}$ is induced subgraph-closed. By the form of rsub_n , RSUB is induced 308 subgraph-closed. 309

We recall edge-saturations $\mathcal{S}(h)$ of Def. 2.1. For a graph G and graph language \mathcal{G} , let

$$\mathcal{S}_{\mathcal{C}}(G) \triangleq \{\mathcal{S}(h) \mid \exists H \in \mathrm{GR}_{\mathcal{C}}, h \colon G \longrightarrow H\} \qquad \mathcal{S}_{\mathcal{C}}(\mathcal{G}) \triangleq \bigcup_{H \in \mathcal{G}} \mathcal{S}_{\mathcal{C}}(H).$$

310

¹²We introduce \top -labelled edges, cf. [18, Def. 6], because \top is not fixed to the full relation.

Example 5.1. The following is an instance of $S_{\mathsf{RSUB}}(G)$ where $\mathbf{V} = \{a\}$:

$$\mathcal{S}_{\mathsf{RSUB}}(\rightarrow 0 - a \rightarrow 0 - \overline{a} \rightarrow 0 \rightarrow) = \begin{cases} \neg (1, \top \rightarrow 0, \overline{a}, \overline{i}, \overline{1} \rightarrow 0 \rightarrow \overline{a}, \overline{i}, \overline{1} \rightarrow \overline{0} \rightarrow \overline{0}$$

- (In the sequel, we often omit \top or \overline{I} -labelled edges for simplicity.) 315
- By the form of GR_{RSUB} , each H, where $H \in \mathcal{S}_{RSUB}(H')$ for some H', satisfies 316
- \top^{H} is a total preorder; 317

 $a^H \supseteq I^H$ or $\overline{a}^H \supseteq I^H$ holds for each $a \in \mathbf{V}$. 318

Additionally, let $H^{\mathcal{Q}} \triangleq H/(\mathsf{I}^H)^=$ and $\mathcal{G}^{\mathcal{Q}} \triangleq \{H^{\mathcal{Q}} \mid H \in \mathcal{G}\}$ where $R^=$ denotes the 319 equivalence closure of R. We then have the following graph language characterization. This 320 is an analogy of [18, Theorem 18], but is generalized for including RSUB. 321

▶ Theorem 5.2. Let $C \subseteq \text{GREL}$ be induced subgraph-closed. For all $\text{KA}_{\{\overline{x},\overline{l},\top,\cap\}}$ terms t,s,322

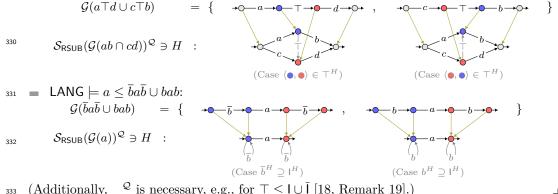
$$\mathcal{C} \models t \leq s \quad \Leftrightarrow \quad \forall H \in \mathcal{S}_{\mathcal{C}}(\mathcal{G}(t))^{\mathcal{Q}}, \exists G \in \mathcal{G}(s), G \longrightarrow H$$

Proof. As with [18, Theorem 18]. See Sect. 5.3 for a detailed proof. 324

By Thm. 5.2, we can show inequations by graph homomorphisms, e.g., as follows. 325

Example 5.3. We recall the inequations in Remark 3.11. Gray-colored edges are extended 326 by edge-saturations S_{RSUB} . We omit unimportant edges. 327

LANG $\models ab \cap cd \leq a \top d \cup c \top b$: For each graph $H \in \mathcal{S}_{\mathsf{RSUB}}(\mathcal{G}(ab \cap cd))^{\mathcal{Q}}$, we can give a 328 graph homomorphism from some graph in $\mathcal{G}(a \top d \cup c \top b)$ as follows: 329



(Additionally, $__{\mathcal{Q}}$ is necessary, e.g., for $\top \leq \mathsf{I} \cup \bar{\mathsf{I}}$ [18, Remark 19].) 333

5.2 Word languages for $KA_{\{\overline{x},\overline{l},\top\}}$ 334

Particularly for $KA_{\{\bar{x},\bar{1},\top\}}$, Thm. 5.2 can be rephrased by word languages. 335

For a word $w = a_1 \dots a_n$ over $\tilde{\mathbf{V}}$, let $\mathsf{G}(w)$ be the following graph where $|\mathsf{G}(w)| = [0, n]$: 336

$$337 \qquad \rightarrow 0 - a_0 \rightarrow 1 - a_1 \rightarrow 2 - \cdots - a_n \rightarrow n \rightarrow$$

G(w) is the unique graph in $\mathcal{G}(w)$ up to graph isomorphisms. 338

For a $\operatorname{KA}_{\{\overline{x},\overline{\mathfrak{l}},\top\}}$ term t, we write $[t]_{\tilde{\mathbf{V}}}$ for the word language [t] over $\tilde{\mathbf{V}}$ where $\overline{x},\overline{\mathfrak{l}},\top$ 339 are also viewed as letters; e.g., $[\overline{x}]_{\tilde{\mathbf{V}}} = \{\overline{x}\}$ and $[\overline{x}] = \mathbf{V}^* \setminus \{x\}$ for $x \in \mathbf{V}$. Note that 340 $\mathcal{G}(t) = \{ \mathsf{G}(w) \mid w \in [t]_{\tilde{\mathbf{V}}} \}$. Hence, graph languages are expressible by word languages for 341 $KA_{\{\overline{x},\overline{l},\top\}}$ terms. 342

Additionally, we introduce nondeterministic finite word automata with epsilon transitions (NFAs). NFAs are (2-pointed) graphs over $\tilde{\mathbf{V}}_{\mathbf{I}}$ where the source and target vertices denote the initial and (single) accepting states, respectively, and I-labelled edges denote epsilon transitions. For a graph H and a word $w = a_1 \dots a_n$, we write δ_w^H for the binary relation (\mathbf{I}^H)* $\cdot a_1^H \cdot (\mathbf{I}^H)^* \cdots \cdot a_n^H \cdot (\mathbf{I}^H)^*$. For $q \in |H|$, we let $\delta_w^H(q) \triangleq \{q' \mid \langle q, q' \rangle \in \delta_w^H\}$. For $Q \subseteq |H|$, we let $\delta_w^H(Q) \triangleq \bigcup_{q \in Q} \delta_w^H(q)$. The word language $[H]_{\tilde{\mathbf{V}}}$ is defined as $\{w \in \tilde{\mathbf{V}}^* \mid \langle 1^H, 2^H \rangle \in \delta_w^H\}$. Note that $[H]_{\tilde{\mathbf{V}}} = \{w \in \tilde{\mathbf{V}}^* \mid \mathsf{G}(w) \longrightarrow H^Q\}$ if \mathbf{I}^H is an equivalence relation. Then we have the following:

Proof. (\subseteq): Because, for any $J \in \mathcal{S}_{\mathcal{C}}(H)$, we have $J \longrightarrow J^{\mathcal{Q}}$ by $H \longrightarrow J$ and $J \longrightarrow J^{\mathcal{Q}}$. (\supseteq): 163 Let $h: H \longrightarrow \mathsf{G}(\mathfrak{v}, x, y)$. Then $\mathcal{S}(h) \longrightarrow \mathsf{G}(\mathfrak{v}, x, y)$. Because $\mathsf{I}^{\mathsf{G}(\mathfrak{v}, x, y)}$ is the identity relation, 164 $\mathcal{S}(h)^{\mathcal{Q}} \longrightarrow \mathsf{G}(\mathfrak{v}, x, y)$. Hence $\hat{\mathfrak{v}}(\mathcal{S}_{\mathcal{C}}(H)^{\mathcal{Q}}) \supseteq \hat{\mathfrak{v}}(H)$.

6 **PSPACE** decidability for $KA_{\{\overline{x},\overline{l},\top\}}$ terms 382

In this section, we show that the equational theory w.r.t. languages for $KA_{\{\bar{x},\bar{l},\top\}}$ is decidable 383 and PSPACE-complete. We consider graphs over $\tilde{\mathbf{V}}_{\mathsf{I}}$ / NFAs, instead of KA_{{ $\bar{x},\bar{\mathsf{I}},\top$ }} terms / 384 regular expressions over the alphabet $\tilde{\mathbf{V}}$. Relying on the graph characterization (Cor. 5.4), 385 we consider that, given an NFA J (corresponding to the term s in Cor. 5.4), we give an NFA 386 recognizing the following word language: 387

$$\mathsf{L}_J \triangleq \{ w \in \tilde{\mathbf{V}}^* \mid \exists H \in \mathcal{S}_{\mathsf{RSUB}}(\mathsf{G}(w)), [J]_{\tilde{\mathbf{V}}} \cap [H]_{\tilde{\mathbf{V}}} = \emptyset \}.$$

Note that $\mathsf{RSUB} \models t \leq s \Leftrightarrow [t]_{\tilde{\mathbf{V}}} \cap \mathsf{L}_J = \emptyset$ when $[s]_{\tilde{\mathbf{V}}} = [J]_{\tilde{\mathbf{V}}}$. We first give an equivalent 389 notion of " $w \in L_J$ " in Sect. 6.1, and then we give an NFA construction in Sect. 6.2. 390

6.1 Saturable paths for RSUB 391

- We first give an equivalent notion of $[J]_{\tilde{\mathbf{V}}} \cap [H]_{\tilde{\mathbf{V}}} = \emptyset$, compatible with edge-saturations. 392
- ▶ Definition 6.1. Let J and H be graphs. A map $U: |H| \rightarrow \wp(|J|)$ is an emptiness-witness 393 for $[J]_{\tilde{\mathbf{V}}} \cap [H]_{\tilde{\mathbf{V}}} = \emptyset$ if the following hold where $U_x \triangleq U(x)$: 394 $= 1^J \in U_{1^H} \text{ and } \forall a \in \tilde{\mathbf{V}}_{\mathsf{I}}, \forall \langle x, y \rangle \in a^H, \ \delta_a^J(U_x) \subseteq U_y;$ 395
- \square $2^J \notin U_{2^H}$. 396

Intuitively, the first condition denotes that U is a cover of the reachable states from the pair 397 " $1^J \in U_{1^H}$ ". If the second condition holds, we can see that the pair " $2^J \in U_{2^H}$ " is unreachable. 398 As expected, we have the following (see Appendix B, for a proof). 399

▶ Proposition 6.2. Let J and H be graphs where I^H is reflexive. Then 400

 $[J]_{\tilde{\mathbf{V}}} \cap [H]_{\tilde{\mathbf{V}}} = \emptyset \quad \Leftrightarrow \quad \exists U \colon |H| \to \wp(|J|), \ U \ is \ an \ emptiness-witness \ for \ [J]_{\tilde{\mathbf{V}}} \cap [H]_{\tilde{\mathbf{V}}} = \emptyset.$ 401

Example 6.3. We consider the following graphs. J denotes the NFA s.t. $[J]_{\tilde{\mathbf{V}}} = \{w \in \mathcal{V}\}$ 402 $\{a,\overline{a}\}^* \mid \exists n \in \mathbb{N}, \overline{a} \text{ occurs } 3n+2 \text{ times in } w\}$. *H* is a graph in $\mathcal{S}_{\mathsf{RSUB}}(\mathsf{G}(a\overline{a}a))$ where \top - or 403 I-labelled edges are omitted. By the form of H, one can see that $[J]_{\tilde{\mathbf{V}}} \cap [H]_{\tilde{\mathbf{V}}} = \emptyset$. 404

If $U_0 = U_1 = \{\mathbf{0}\}$ and $U_2 = U_3 = \{\mathbf{0}, \mathbf{0}\}$, then this U is an emptiness-witness; e.g., for 407 $\langle 1,2\rangle \in \overline{a}^H, \delta_{\overline{a}}^J(U_1) = \delta_{\overline{a}}^J(\{\bullet\}) = \{\bullet\} \subseteq U_2.$ Besides this, if $U_0 = U_1 = \{\bullet\}$ and $U_2 = U_3 = \{\bullet\}$, 408 this U is also an emptiness-witness. These witnesses also show $[J]_{\tilde{\mathbf{V}}} \cap [H]_{\tilde{\mathbf{V}}} = \emptyset$. 409

Next, we give an equivalent notion of " $w \in L_J$ ". In the following, we abstract saturated 410 edges (gray-colored edges in Example 6.3) using U, as U implies the existence of edge-411 saturations. 412

▶ Definition 6.4. Let J be a graph and w be a word. A pair $P = \langle H, U \rangle$ is a saturable path 413 for $w \in L_J$ if the following hold: 414

(P-Ext) H is an edge-extension of G(w) such that¹³ 415

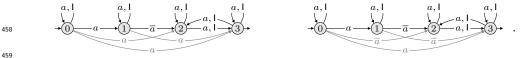

For extended 448 edges from H, it is shown by the construction of H' (for the last case of the four cases above, 449 by $U_y \not\subseteq \delta_a^J(U_x)$ and (P-Sat), we have $U_y \subseteq \delta_a^J(U_x)$). Hence, this completes the proof. 450 ▶ **Example 6.6.** We recall the graphs J and $H \in S_{\mathsf{RSUB}}(\mathsf{G}(a\overline{a}a))$ in Example 6.3. The 451

following P is a saturable path for $a\overline{a}a \in L_J$ where \top - or \overline{I} -labelled edges are omitted:

$$P = \begin{pmatrix} a, l & a, l & a, l & a, l & a, l \\ \downarrow & \downarrow & \downarrow & \downarrow \\ \rightarrow \textcircled{0} a \longrightarrow \textcircled{1} a \longrightarrow \textcircled{2} a, l \longrightarrow \textcircled{3} \\ \lbrace \bullet \rbrace & \lbrace \bullet \rbrace & \lbrace \bullet, \bullet \rbrace & \lbrace \bullet, \bullet \rbrace \end{pmatrix}.$$

(P is of the form of a path graph by taking the quotient graph w.r.t. I-labelled edges.) P is an 454 abstraction of edge-saturated graphs. From P, we can construct a graph $H \in \mathcal{S}_{\mathsf{RSUB}}(\mathsf{G}(a\overline{a}a))$ 455 s.t. $[J]_{\tilde{\mathbf{V}}} \cap [H]_{\tilde{\mathbf{V}}} = \emptyset$. Because both $\delta_{\overline{a}}^{J}(\{\bullet\}) \subseteq \{\bullet, \bullet\}$ and $\delta_{\overline{a}}^{J}(\{\bullet\}) \subseteq \{\bullet, \bullet\}$ hold, in addition 456 to the graph H in Example 6.3, for instance, the following are also possible: 457



Thanks to saturable paths, we can replace the existence of such gray-colored edges connecting 460 distant vertices with a locally defined witness U. 461

Moreover, we can replace (P-Sat)—a condition between distant vertices—with a local 462 condition. Let $\varphi^J(\mathcal{U}, U) \triangleq \forall a \in \mathbf{V}, \forall \langle u, u' \rangle \in \mathcal{U}, \delta^J_a(u) \subseteq U \lor \delta^J_{\overline{a}}(u') \subseteq U$. 463

▶ **Proposition 6.7.** Let J and H be graphs. Let $i \in |H|$. Then we have:

$$(\forall a \in \mathbf{V}, \forall j \ s.t. \ \langle j, i \rangle \in \bar{\mathsf{I}}^H, \delta_a^J(U_j) \subseteq U_i \lor \delta_{\bar{a}}^J(U_j) \subseteq U_i) \quad \Leftrightarrow \quad \varphi^J(\bigcup_{j; \langle j, i \rangle \in \bar{\mathsf{I}}^H} U_j \times U_j, U_i).$$

509 7 Future directions

We leave open the axiomatizability of the equational theory of $\text{KA}_{\{\overline{x}\}}/\text{KA}_{\{\overline{l}\}}/\text{KA}_{\{\overline{x},\overline{l}\}}$ w.r.t. languages. Note that the equational theory of $\text{KA}_{\{-\}}$ (without Kleene star) w.r.t. languages is not finitely axiomatizable because it is Π_1^0 -complete (Thms. 4.7 and 4.10).

A natural interest is to consider variants or fragments of $KA_{\{-\}}$, e.g., with reverse [3], with tests [14] (by considering guarded strings) or with (anti-)domain [8]. Also, the combination of variables and letters (variables under standard valuations) would be interesting in the context of regular expressions.

Additionally, this paper did not so deal with the expressive power w.r.t. languages. A 517 weak tool is $(\dagger \text{-KA}_{\{-\}})$: $[t] \neq [s] \Rightarrow \text{LANG} \not\models t = s$; we can separate the expressive powers 518 w.r.t. languages of given two term sets if their language classes are not equivalent. However, 519 this cannot show e.g., the expressive power difference between $KA_{\{\bar{x}\}}$ and KA, while this 520 difference is an immediate consequence of the counter-example in the introduction and the 521 completeness theorem of KA. To obtain a more useful tool, it is possibly interesting to modify 522 existing arguments about the standard relational structures (REL), e.g., [25, 24, 26, 11, 17] 523 (including finite model theoretical studies such as Ehrenfeucht-Fraïssé games [9, 10]) for 524 RSUB. 525
