15 Abstract

Archaeal NurA protein plays a key role in producing 3'-single stranded DNA
used for homologous recombination repair, together with HerA, Mre11, and Rad50.
Herein, we describe biochemical characteristics and roles of key amino acid residues
of the NurA protein from the hyperthermophilic euryarchaeon Thermococcus
barophilus Ch5 (Tba-NurA). Tba-NurA possesses 5'-3' exonuclease activity for
degrading DNA, displaying maximum efficiency at 45°C ~ 65°C and at pH 8.0 in the
presence of Mn <sup>2+</sup> . The thermostable Tba-NurA also possesses endonuclease activity
capable of nicking plasmid DNA and circular ssDNA. Mutational data demonstrate
that residue D49 is essential for exonuclease activity and is involved in binding
ssDNA since the D19A mutant lacked exonuclease activity and reduced ssDNA
binding. No detectable dsDNA binding of the R96A and R129A mutants suggests that
residues R96 and R129 are important for binding dsDNA. Since the D120A mutant
had no degradation activity and reduced dsDNA binding, residue D120 is essential for
degradation activities, and dsDNA binding. Additionally, residues Y392 and H400 are
important for exonuclease activity since the mutations lead to exonuclease activity
loss. To our knowledge, it is the first report on biochemical characterization and
mutational analysis of the NurA protein from <i>Thermococcus</i> .

#### 1. Introduction

Double-strand breaks (DSBs) are extremely severe DNA lesions that are not only caused by endogenous errors during replication and recombination, but also are created by exogenous agents such as ionizing radiation and oxygen radicals [1]. If not repaired, DSBs would lead to chromosome losses, deletions, and translocations [2-4], thus posing severe damage to cells. Therefore, DSBs must be rapidly and accurately repaired to maintain genome integrity and cell viability once they have been produced. Homologous recombination (HR) is one of the most efficient DSB repair pathways, which utilizes a homologous template to repair DNA breaks in an error-free way [5-6]. DNA ends are resected to form 3'-single-stranded DNA (ssDNA) overhangs, which is an essential initiation step for loading recombinases during HR. Various organisms utilize helicase and exonuclease to process DNA ends to initiate HR. In bacteria, RecBCD/AddAB is the helicase-nuclease complex that unwinds and degrades both DNA ends to produce 3'-ssDNA overhangs [7-10]. Besides, 5'-3' exonuclease RecJ and helicase RecQ are also responsible for generating 3'-ssDNA overhangs [11-12]. In eukaryotes, DSBs are initially recognized and processed by the Mre11-Rad50-Nbs1 (in humans) or Mre11-Rad50-Xrs2 (in budding yeast) complex [13-14]. Exo1 nuclease, Sgs1 helicase, and Dna2 nuclease are further recruited to generate 3'-ssDNA overhangs [15]. In Archaea, eukaryotic-like Mre11-Rad50 complex initiates 5'-strand resection. However, Archaea lack eukaryotic Exo1, Dna2

and Sgs1 homologs, but possess 5'-3' exonuclease NurA and bidirectional DNA

helicase HerA that can produce 3'-ssDNA overhangs in addition to Mre11 and Rad50 [16-19]. Genomic analyses show that archaeal NurA, HerA, Mre11, and Rad50 share an operon, thus suggesting that these four proteins are involved in DNA end resection during archaeal HR [20-21].

NurA protein is widespread in Archaea and a small group of Bacteria. Since Sulfolobus acidocaldarius NurA was firstly reported [16], five NurA homologs have been characterized from Archaea to varying degrees: Saccharolobus solfataricus [18], Saccharolobus islandicus [19], Saccharolobus tokodaii [22], Pyrococcus furiosus [20], and Thermococcus kodakaraensis [23]. In Bacteria, the genomes of Deinococcus and Thermus phyla also encode NurA protein, likely resulting from the gene transfer from Archaea and Bacteria [24]. Notably, the activities of NurA proteins from Archaea and Bacteria vary. While S. acidocaldarius NurA possesses endonuclease activity on ssDNA and 5'-3' exonuclease activity on ssDNA and dsDNA [16], P. furiosus NurA (Pfu-NurA) has weak 5'-3' exonuclease activity, but no endonuclease activity [20, 25]. S. solfataricus NurA, the high homology with S. acidocaldarius NurA, possesses 5'-3' exonuclease activity on ssDNA and dsDNA and its exonuclease activity can be modulated by HerA [26]. Additionally, genetic data show that S. islandicus NurA is essential for cell viability [19]; however, Thermus thermophilus NurA is not essential for cell viability [27]. Furthermore, the nurA gene knock-out T. kodakaraensis cells are difficult to grow when exposed to DNA damaging agents [23]. Thus, distinct roles of the *nurA* genes in archaeal and bacterial cells vary with source.

Currently, the biochemically characterized archaeal NurA proteins have

originated from Crenarchaea, especially from *Sulfolobus* species. Although cellular function of *T. kodakaraensis* NurA protein was reported, no biochemical function of NurA protein has been reported from *Thermococcus*. *Thermococcus barophilus* Ch5 is a hyperthermophilic euryarchaeon isolated from deep-sea, capable of growing optimally at 88°C and 40 MPa pressure [28]. The genomic DNA of *T. barophilus* Ch5 encodes a putative NurA protein [29]. In this work, we revealed for the first time the biochemical characteristics of degrading DNA by Tba-NurA. The roles of the conserved residues in DNA degradation by Tba-NurA were also dissected by mutational analyses.

#### 2. Materials and methods

#### 2.1 DNA substrate

The Hex-labeled oligonucleotide was synthesized at Sangon Biotech Company, China. The sequence of the synthesized oligonucleotide is 5'-Hex- CGA ACT GCC TGG AAT CCT GAC GAC ATG TAG CGA ACG ATC ACC TCA -3' and the sequence of its complementary strand is 5'-TGA GGT GAT CGT TCG CTA CAT GTC GTC AGG ATT CCA GGC AGT TCG -3'. The Hex-labeled DNA duplex was prepared by annealing the synthesized oligonucleotide with its complementary strand as described previously [30].

#### 2.2 Cloning, expression, and purification of Tba-NurA

Using High-fidelity PCR Mix (Vazyme, Nanjing, China), the Tba-NurA gene was amplified from the genomic DNA of *T. barophilus* Ch5 in the presence of the forward and reverse primers containing the restriction sites of *Bam*HI and *Xho*I (Table

1). The PCR cycling program was followed as described in manual instruction of this

Kit. The PCR product and pET-28at-plus vector were cleaved by *Bam*HI and *Xho*I

and ligated by T4 DNA ligase to produce the recombinant plasmid harboring

Tba-NurA gene. The recombinant plasmid was transformed into the competent *E. coli*BL21 (DE3) pLysS cells to express Tba-NurA protein after verification by sequencing.

The expression strain was cultured in LB medium containing 34  $\mu$ g/ml chloramphenicol and 100  $\mu$ g/ml kanamycin at 37°C. 0.1 mM isopropyl thiogalactoside (IPTG) was added to the culture when the OD<sub>600</sub> value reached around 0.6. The culture continued to be shaken at room temperature for 12 hrs for protein expression.

The cells were collected by centrifuge (6000g, 20 min), and the pellets were resuspended with buffer A containing 20 mM Tris–HCl pH 8.0, 1 mM dithiothreitol (DTT), 500 mM NaCl, 50 mM imidazole, and 10% glycerol. The cells were disrupted by sonication. After centrifuge, the resulting supernatant was heated at 70°C for 20 min to denature the *E. coli* proteins. After centrifuge, the supernatant was filtered and loaded onto a HisTrap FF column (GE Healthcare, Uppsala, Sweden) in NCG<sup>TM</sup> Chromatography System (Bio-Rad, CA, USA). The Tba-NurA protein was eluted with a gradient of imidazole (50 mM ~ 500 mM) in buffer B containing 20 mM Tris–HCl pH 8.0, 1 mM DTT, 500 mM NaCl, 500 mM imidazole, and 10% glycerol. The fractions containing Tba-NurA protein were combined and dialyzed in a storage buffer containing 20 mM Tris–HCl pH 8.0, 50 mM NaCl, 1 mM DTT, and 50%

glycerol after the protein purity was verified by electrophoresis in 10% SDS-PAGE. The purified Tba-NurA protein was kept at -80°C after dialysis. Based on its molar extinction coefficient (30,160 M<sup>-1</sup> cm<sup>-1</sup>), the Tba-NurA protein concentration was calculated by measuring its absorbance at 280 nM.

# 2.3 Modeling structure of Tba-NurA-ssDNA complex

AlphaFold2 was used to model the Tba-NurA protein structure on the local machine using its primary sequence [31]. The ssDNA was added to the model structure by using the software Coot [32], based on the reported crystal structure of *Thermotoga maritima* EndoV in complex with DNA (PDB ID code 2W36). And then the conformations of the side chains of the residues in the modeled Tba-NurA-ssDNA complex structure were slightly adjusted manually by using the software Coot [32]. The dimeric form of Tba-NurA was built through superposing onto the dimeric structure of Pfu-NurA (PDB code: 3TAZ) [25]. Further any modification on the original Alphafold2-prediction structure was checked, regularized and validated. The quality of the final structure was evaluated in Fig. S1 and Table S1 using MolProbity [33]. The structural figures of the Tba-NurA-ssDNA complex model were finally prepared with the Pymol software (http://www.pymol.org).

### 2.4 Construction, overexpression, and purification of the Tba-NurA mutants

Based on the wild-type (WT) plasmid containing Tba-NurA gene, the D49A, R96A, D120A, R129A, Y392A and H400A mutants were constructed by employing Site-directed Mutagenesis Kit (Transgen, China). The sequences of the mutagenic primers for constructing these mutants are summarized in Table 1. The desired

mutations were confirmed by sequencing and then the Tba-NurA mutant proteins were expressed and purified following the methods as described for the WT protein.

#### 2.5 Exonuclease activity assays

In a standard exonuclease reaction (10 µL), 100 nM 5'-Hex-labeled DNA or 3'-Hex-labeled DNA was incubated with 400 nM Tba-NurA in the buffer containing 20 mM Tris–HCl pH 8.0, 1 mM DTT, 8% glycerol, and 1 mM Mn<sup>2+</sup> at 65°C for 30 min, unless stated. 98% formamide and 20 mM EDTA were added to the mixture to stop the reaction. After heated at 95°C for 5 min, samples were separated by electrophoresis in a denaturing 12% polyacrylamide gel with 8 M urea. The bands in the gels were scanned and visualized with a molecular image analyzer (PharosFx System, BioRad), and quantitated with ImageQuant software. The exonuclease activity assays were replicated three times. Note that the reaction conditions distinct from the standard reaction condition were shown in each figure legend.

#### 2.6 Endonuclease activity assays

In an endonuclease reaction (10  $\mu$ L), 100 ng plasmid DNA or M13mp18 circular ssDNA was incubated with Tba-NurA with varying concentrations in the buffer containing 20 mM Tris–HCl pH 8.0, 1 mM DTT, 8% glycerol, and 1 mM Mn<sup>2+</sup> at 65°C for 30 min. The endonuclease reaction was terminated with the addition of 98% formamide and 20 mM EDTA. Samples were separated by electrophoresis in a denaturing 0.7% agarose gel. The bands in the gels were scanned and visualized with a molecular image analyzer.

#### 2.7 DNA binding assays

100 nM 5'-Hex-labeled ssDNA or dsDNA was incubated with the WT/mutant Tba-NurA with varying concentrations in the buffer containing 20 mM Tris-HCl pH 8.0, 1 mM DTT, and 8% glycerol at room temperature for 10 min. Samples were analyzed by electrophoresis in a native 4% polyacrylamide gel with 0.1 x TBE. The gels were treated as described above. The DNA binding assays were replicated three times.

**3. Results** 

#### 3.1 Tba-NurA is a putative 5'-3' exonuclease

Sequence alignment of Tba-NurA and other characterized NurA proteins shows that Tba-NurA possesses three conserved motifs: Motif I (AxDG), Motif II (xxxDGx), and Motif III (GYxxPLxxxH), where x represents any amino acid residue (Fig. 1). Tba-NurA and other NurA proteins from Euryarchaea harbor a M domain. However, this M domain is absent in the NurA proteins from Crenarchaea and Bacteria. Tba-NurA displays more amino acid similarity to *T. kodakaraensis* NurA (58%) than Pfu-NurA (38%). These observations suggest that Tba-NurA should degrade DNA in the 5′–3′ direction since it possesses the conserved motifs that associates with 5′–3′ exonuclease activity. On the other hand, 17% ~ 20% amino acid similarity is observed between Tba-NurA and the NurA homologues from *D. radiodurans*, *S. islandicus*, *S. acidocaldarius*, *S. solfataricus* and *S. tokodaii*, which suggests that Tba-NurA might harbor distinct biochemical characteristics from other NurA proteins.

To probe biochemical characteristics of Tba-NurA, we cloned its gene, expressed and purified this protein (Fig. 2). The recombinant Tba-NurA gene was successfully

induced for expression as a ~ 51 kDa protein containing a 6 x His-tag at its N-terminus (Fig. 2). Through the following purification steps including sonication, heat treatment (70°C for 20 min), and Ni column affinity chromatography, the recombinant Tba-NurA protein was finally purified (Fig. 2).

# 3.2 Tba-NurA possesses 5'-3' exonuclease activity

After successfully purifying the Tba-NurA protein, we first determined whether this protein can degrade DNA by performing exonuclease reactions using 3'-Hex-labeled or 5'-Hex-labeled ssDNA and dsDNA as substrates. 3'-Hex-labeled ssDNA substrate was gradually degraded by Tba-NurA as the enzyme concentrations increased at 65°C (Fig. 3A). Specifically, above 90% of the substrate was degraded by 400 nM enzyme. Similar degradation results were observed for 3'-Hex-labeled dsDNA (Fig. 3B). However, the enzyme displayed the lower efficiency for degrading 3'-Hex-labeled dsDNA than that for degrading 3'-Hex-labeled ssDNA at 100 nM or 200 nM Tba-NurA. Moreover, we also found that the enzyme exhibited similar degradation efficiencies for 5'-Hex-labeled ssDNA and dsDNA as observed for 3'-Hex-labeled ssDNA and dsDNA (Figs. 3C and 3D), respectively. While only one band appeared in the 5'-Hex-labeled ssDNA cleavage reactions (Fig. 3C), several bands were observed for degrading 3'-Hex-labeled ssDNA (Fig. 3A), thus confirming that this protein possesses 5'-3' exonuclease activity. Therefore, Tba-NurA is a 5'-3' exonuclease, capable of not only efficiently degrading ssDNA, but also degrading dsDNA with the relatively reduced efficiency.

#### 3.3 Tba-NurA possesses endonuclease activity

S. solfataricus NurA possesses endonuclease activity [18], which prompted us to investigate whether Tba-NurA has endonuclease activity. We employed plasmid cccDNA and circular ssDNA as substrates to perform endonuclease activity reactions of Tba-NurA, respectively. Compared with the control reaction (CK1) without the heating treatment (Fig. 4A), slight ocDNA (open circular, ocDNA) was produced from the cccDNA (covalent closed circular DNA) substrate by the incubation at 65°C for 30 min (CK2), demonstrating that most of cccDNA is stable when kept at 65°C for 30 min. On the other hand, more ocDNA and linear DNA were created by Tba-NurA, demonstrating that the enzyme possesses endonuclease activity that can nick cccDNA.

To further confirm endonuclease activity of Tba-NurA, we investigated whether this enzyme can nick circular ssDNA. As shown in Fig.4B, the circular ssDNA substrate is stable after incubated at 65°C for 30 min since no band intensity change was observed in the CK2 with heating treatment and CK1 without heating treatment. Interestingly, the circular ssDNA substrate was degraded to be short DNA fragments by Tba-NurA at the tested enzyme concentrations. The circular ssDNA was first cleaved by Tba-NurA's endonuclease activity to form linear ssDNA and then this ssDNA product was further degraded by its exonuclease activity to generate smear DNA fragments. Thus, these observations demonstrate that Tba-NurA harbors endonuclease activity that nicks plasmid DNA and circular ssDNA in addition to 5′–3′ exonuclease activity.

#### 3.4 Biochemical characteristics of Tba-NurA

Since Tba-NurA can efficiently degrade ssDNA in the direction of 5′–3′, we used the 5′-labeled ssDNA as substrate to determine its biochemical characteristics. Firstly, we examined the degradation efficiency of the enzyme at various temperatures, and found that Tba-NurA can degrade this ssDNA substrate at the tested temperatures ranging from 35°C to 95°C with different cleavage efficiencies (Fig. 5A). At 45°C ~ 65°C, the enzyme displayed maximum degradation efficiency, demonstrating that 45°C ~ 65°C is its optimal temperature for cleaving ssDNA.

The thermo-tolerance of the Tba-NurA protein was assayed by determining the heated enzyme activity. Tba-NurA retained above 90% degradation activity after heated at 75°C and 80°C for 20 min (Fig. 5B), which is similar to that of the control reaction performed by the non-heated enzyme. As the heating temperature increased from 85°C to 95°C, the enzyme displayed reduced degradation efficiency. Specifically, the enzyme still possessed 34% degradation percentage even after a 20 min treatment at 95°C, suggesting that the enzyme is quite thermostable.

We also examined the effect of pH on the Tba-NurA activity. Various degradation efficiencies were observed at pH 7.0 to 9.0 (Fig. 5C). Maximum degradation efficiency of the enzyme was observed at pH 8.0. By comparison, no ssDNA substrate was degraded by the enzyme at pH 10.0 and 11.0. Additionally, this substrate was slightly degraded by Tba-NurA at pH 7.0. Thus, these observations show that the optimal pH of Tba-NurA activity is 8.0.

Previous studies show that Mn<sup>2+</sup> is needed for the NurA activity [34], which prompted us to investigate whether a divalent ion is required for Tba-NurA to degrade

ssDNA. In the first control reaction without the addition of any divalent metal ion, no ssDNA substrate was degraded by the enzyme (Fig. 5D). In the second control reaction with the addition of 10 mM EDTA, no DNA substrate was still degraded, suggesting that a divalent metal ion is needed for Tba-NurA to degrade ssDNA. As expected, Tba-NurA displayed maximum degradation efficiency with 1 mM Mn<sup>2+</sup>. By comparison, the enzyme had no activity with Ca<sup>2+</sup>, Cu<sup>2+</sup>, Zn<sup>2+</sup> or Ni<sup>2+</sup>. Additionally, the enzyme exhibited weak activity with Mg<sup>2+</sup>. Therefore, these observations show that Tba-NurA is Mn<sup>2+</sup>-dependent.

#### 3.5 Homology structure of the Tba-NurA-ssDNA complex

The model structure of Tba-NurA-ssDNA complex was constructed by using AlphaFold2 (Fig. 6A), possessing three conserved motifs present in other reported NurA proteins. We compared our structural model with the two reported crystal structures of the archaeal NurA proteins from *P. furiousus* (PDB code: 3TAZ) and *S. solfataricus* (PDB code: 2YGK) [25, 35]. The M domains in the middle of the structures show significant conformational difference between Pfu-NurA and Tba-NurA (Fig. 5B). In the above two structures, the M-domain forms a peak and the other part forms a base of a pyramid [25]. Our model shows a symmetric peak whereas Pfu-NurA displays a twisted asymmetric peak (Fig. 6B). In contrast, NurA from *S. solfataricus* lacks the M domain (Fig. 6C). Additionally the structure shows the H5 helix is much shorter than the other two structures.

The motif I in Tba-NurA contains "AxDG", among which residue D49 is highly conserved among the NurA proteins except *T. thermophilus* NurA protein.

Additionally, residue D120 of the conserved "DG" in motif II of the enzyme is invariable among all the reported NurA proteins. Furthermore, residues Y392 and H400 of the GYxxPLxxAH in motif III of Tba-NurA are highly conserved. Although residues R96 and R129 of Tba-NurA are not conserved, they are close to ssDNA substrate, suggesting that they might play a role in cleaving DNA.

To clarify the roles of these six conserved residues of Tba-NurA in degrading DNA and binding DNA, we needed to characterize the Tba-NurA D49A, R96A, D120A, R129A, Y392A and H400A mutants biochemically. By using the WT plasmid harboring the Tba-NurA gene as the template, the mutant plasmids were successfully constructed via site-directed mutagenesis. The Tba-NurA mutant proteins were also successfully expressed and purified as described for the WT protein (Fig. S2).

#### 3.6 DNA degradation of the Tba-NurA mutants

Under the optimized DNA degradation reaction condition as described above, we determined the degradation efficiencies of the Tba-NurA D49A, R96A, D120A, R129A, Y392A and H400A mutants using various DNA substrates. Compared with the WT protein, the D49A, D120A, Y392A, and H400A mutants almost completely abolished the degradation activity when using 5'-Hex-labeled ssDNA as substrate (Fig. 7A), thereby demonstrating that residues D49, D120, Y392, and H400 are essential for degrading ssDNA. Furthermore, the R96A and R129A mutants displayed 39% and 32% degradation, thus showing that residues R96 and R129 have partial contribution to degrading ssDNA. Similar degradation results of all Tba-NurA mutants were

observed for 3'-Hex-labeled ssDNA (Fig. S3). Moreover, we also found that all Tba-NurA mutants had no detectable exonuclease activity for 3'-Hex-labeled and 5'-Hex-labeled dsDNA (Figs. 7B and S4), demonstrating that these tested six residues are important for degrading dsDNA.

Using plasmid cccDNA and circular ssDNA as substrates, we also investigated endonuclease activities of Tba-NurA mutants. We found that the D49A, Y392A and H400A mutants had the WT protein activity (Fig. 7C), indicating that residues D49, Y392 and H400 is not involve in nicking plasmid cccDNA. However, compared with the WT protein, the R96A, D120A and R129A mutants possessed the reduced nicking activity. On the other hand, we found that all Tba-NurA mutants displayed weak endonuclease activity for circular ssDNA since slight ssDNA substrate was degraded by these mutants (Fig. 7D).

#### 3.7 DNA binding of the Tba-NurA mutants

Since Tba-NurA can degrade ssDNA with high efficiency, we tested whether this exonuclease can bind DNA. We found that the ssDNA substrate was gradually bound by Tba-NurA as the enzyme concentrations increased (Fig. 8A). At 2000 nM, the ssDNA substrate was almost completely bound by Tba-NurA. Furthermore, Tba-NurA can bind dsDNA substrate with almost same efficiency at 2000 nM enzyme as observed for binding ssDNA substrate (Fig. 8A). However, compared with the binding ssDNA, the enzyme displayed the reduced efficiency for binding dsDNA when 500 nM and 1000 nM Tba-NurA concentrations were used. Thus, our observations show that Tba-NurA can not only bind ssDNA, but also bind dsDNA

with reduced efficiency.

To probe the roles of these six conserved residues in binding ssDNA, we also investigated the binding efficiency of the Tba-NurA mutants. As shown in Fig. 8B, the R96A, D120A, R129A, Y392A and H400A mutants displayed the WT protein binding efficiency, thus suggesting that residues R96, D120, R129, Y392 and H400 are not essential for binding ssDNA. However, the D49A mutant retained the reduced binding efficiency relative to the WT protein, demonstrating that residue D49 is involved in binding ssDNA.

On the other hand, we found that the D49A mutant retained the WT protein efficiency for binding dsDNA (Fig. 8C), suggesting that residue D49 is not essential for binding dsDNA. The Y392A and H44A mutants displayed increased efficiency for binding dsDNA relative to the WT protein, which indicates that residues Y392 and H44 are not involved in binding dsDNA. By contrast, the R96A, D120A and R129 mutants abolished the ability to bind dsDNA, suggesting that residues R96, D120, and R129 are responsible for binding dsDNA.

337 4. Discussion

# 4.1 Tba-NurA possesses 5'-3' exonuclease and endonuclease activities

Archaeal NurA proteins are widespread in Crenarchaea and Euryarchaea, but most studies focus on crenarchaeal NurA proteins, especially from *Saccharolobus*. In this work, we report that the NurA protein from *T. barophilus* Ch5 can degrade ssDNA and dsDNA in the 5′–3′ direction, and also nick plasmid DNA and circular ssDNA as well, demonstrating that the enzyme possesses 5′–3′ exonuclease and

endonuclease activities.

Although the enzyme is more homologous with Pfu-NurA than the NurA proteins from *S. acidocaldarius* and *S. tokodaii*, Tba-NurA resembles the NurA proteins from *S. acidocaldarius* and *S. tokodaii* in terms of activities [16, 22], but contrasts with the Pfu-NurA [20, 25]. Comparison of biochemical characteristics of these two NurA proteins is summarized in Table 2. *S. tokodaii* NurA (Sto-NurA) is a well characterized protein [22, 34-35], possessing endonuclease and 5′–3′ exonuclease activities as observed for Tba-NurA. Tba-NurA displays the same optimal temperature (80°C) as observed for Sto-NurA [34]. However, Tba-NurA retains 81% activity while Sto-NurA exhibits 25% activity after heated 90°C for 20 min [35], demonstrating that the former is more thermostable than the latter. Additionally, both Tba-NurA and Sto-NurA are Mn<sup>2+</sup>-dependent and display the same optimal pH.

### 4.2 The roles of conserved residues of Tba-NurA

In this work, we systemically revealed exonuclease and endonuclease activities, and DNA binding of the Tba-NurA D49A, R96A, D120A, R129A, Y392A and H400A mutants to clarify the roles these six residues (Table 3). Residue D49 in motif I of Tba-NurA is highly conserved in the characterized NurA proteins except *T. thermophilus* NurA (Fig. 1). Our mutational data confirm that residue D49 of Tba-NurA is essential for exonuclease activity. The crystal structure of the Pfu-NurA-dAMP-Mn<sup>2+</sup> complex shows that the first Mn<sup>2+</sup> site is coordinated by residue D51 (residue D49 in Tba-NurA) [25], suggesting that the activity loss of the D49A mutant might be due to the disruption of coordination with Mn<sup>2+</sup>. Similar

results were observed for the Sto-NurA D49A, *D. radiodurans* NurA D53A, *S. solfataricus* NurA D58A mutants [22, 24, 26]. Additionally, we found that residue D49 is involved in binding ssDNA and nicking circular ssDNA as well). Overall, the highly conserved Asp in motif I of NurA proteins plays a role in degrading DNA, but provide evidence that it is responsible for ssDNA binding.

Like residue D51, residue D126 of Pfu-NurA coordinates with the first Mn<sup>2+</sup> in the Pfu-NurA-dAMP-Mn<sup>2+</sup> complex [25], which indicates that residue D126 might be also another catalytic residue. We found that residue D120 of Tba-NurA (residue D51 in Pfu-NurA) is essential for degrading DNA since the loss activity of the D120A mutant might be caused by this disruption of coordination with Mn<sup>2+</sup>. Similar roles are observed for Sto-NurA D131 [22], *D. radiodurans* NurA D184 [24], and *S. solfataricus* NurA D133 [26]. However, residue D120 is important for binding dsDNA rather than for binding ssDNA (Fig. 8).

The structure of the Pfu-NurA-dAMP-Mn<sup>2+</sup> complex demonstrates that Y403 is one of the key residues that associate with DNA substrate [25]. Mutational analysis shows that residue Y403 is responsible for DNA binding [25]. By comparison, our binding data show that residue Y392 of Tba-NurA (residue Y403 of Pfu-NurA) is not essential for DNA binding (Fig. 7). Furthermore, our mutational data show that the Y392A mutant completely abolished the degradation activity, which could be because the Y392A mutation might disrupt the contact between residue Y392 and residue D120. This hypothesis can be supported by this observation that residue Y298 of *S. solfataricus* NurA (residue Y392 in Tba-NurA) contacts residue D133 (residue D120

in Tba-NurA) by its side chain towards the active site [26]. Interestingly, destabilize a reaction intermediate preventing the reaction from proceeding. However, the Sto-NurA Y291A still retains partial activity relative to the WT protein [22]. Thus, the function of the conserved Tyr in the motif III of NurA varies with its source.

Residue H411 of Pfu-NurA is one of the key residues that coordinate with a second Mn<sup>2+</sup> [25], suggesting that residue H411 might be another catalytic residue. In this work, we found that residue H400 of Tba-NurA (residue H411 of Pfu-NurA) is necessary to degrade DNA (Fig. 8). Similar role are observed for the corresponding residue H299 of Sto-NurA [22]. However, residue H400 of Tba-NurA is not involved in binding DNA (Fig. 8).

Residue R96 of Tba-NurA is conserved in NurA proteins from Euryarchaea and *D. radiodurans* NurA, but not in NurA proteins from Crenarchaea and *T. thermophilus* NurA. The structure of the Pfu-NurA-dAMP-Mn<sup>2+</sup> complex displays that residue R98 (residue of R96 of Tba-NurA) might stabilize the substrate or reaction intermediate [25]. In this work, we revealed that residue R96 is involved in degrading DNA. This mutation destabilized a reaction intermediate preventing the reaction from proceeding. Interestingly, residue R96 is important for dsDNA binding rather than for ssDNA binidng (Fig. 7). To our knowledge, it is the first report on the role of the conserved arginine in euryarchaeal NurA proteins.

Like residue R98, residue R135 of Pfu-NurA stabilizes the substrate or reaction intermediate [25]. Likewise, residue R135 of Pfu-NurA is conserved in euryarchaeal NurA proteins, *S. acidocaldarius* NurA and *D. radiodurans* NurA. In this work, we

found that residue R129 of Tba-NurA (residue R135 of Pfu-NurA) is involved in degrading DNA. Like residue R96, residue 129 is important for dsDNA binding rather than for ssDNA binidng (Fig. 7). This is also the first report on the role of the conserved arginine in eurychaeal NurA proteins.

#### 4.3 Possible physiological role of Tba-NurA

Like other Archaea, the genome of the *T. barophilus* Ch5 encodes HerA (NCBI: ALM75038), Mre11 (NCBI: ALM75037) and Rad50 (NCBI: ALM75036) proteins in addition to NurA [29]. Although the genomic organization of these four genes in T. barophilus is nurA, rad50, mre11 and herA (Fig. S5), which is same as that of T. kodakarensis but is distinct from that of other Archaea. These four proteins share an operon, which suggests that a combination of these four proteins is responsible for generating ssDNA 3'-overhang used for HR although the HerA, Mre11 and Rad50 proteins have not been characterized. In this work, our biochemical data have confirmed the 5'-3' ssDNA and dsDNA degradation activity of Tba-NurA protein, thereby indicating that this protein might play a role in producing ssDNA for HR. The structures of the archaeal NurA proteins from P. furiousus [25] and S. solfataricus were solved [26, 36], possessing an argonaute-, endoV nuclease- and RNase-like domain, which are similar to the structure of the bacterial NurA protein from D. radiodurans [37]. The P. furiousus NurA structure is folded in a pyramid-shaped dimer harboring a central channel. The central channel of the NurA dimer is too narrow to accommodate for dsDNA but well for ssDNA or one strand of an unwound duplex. Our biochemical data demonstrate that Tba-NurA possesses

reduced dsDNA degradation activity relative to ssDNA degradation activity, which provides well support for structural characteristic. Additionally, reduced dsDNA degradation activity and strong ssDNA degradation activity of Tba-NurA suggests that Tba-HerA might be needed to associate with this enzyme to complete DSB repair in vivo. We are characterizing Tba-HerA to probe DSB repair by HR in this archaeon. It would be interesting to investigate *in vivo* interaction between NurA and HerA in this organism to determine whether NurA is essential for viability in *T. barophilus*.

**5. Conclusion** 

In summary, we report biochemical characteristics of Tba-NurA and the roles of its six conserved residues in DNA degradation. Tba-NurA can degrade ssDNA and dsDNA in the direction of 5′–3′ at high temperature, displaying higher degradation efficiency for ssDNA than that for dsDNA. The enzyme also possesses endonuclease activity capable of nicking plasmid cccDNA and circular ssDNA. Furthermore, the enzyme displays several biochemical characteristics distinct from the reported NurA proteins. Mutational data demonstrate that residue D49 is essential for exonuclease activity and ssDNA binding, residues R96 and R129 are important for binding dsDNA, residue D120 is essential for exonuclease and endonuclease activities, and dsDNA binding, and residues Y392 and H400 are important for exonuclease activity.
