# KERNEL THEOREMS FOR OPERATORS ON CO-ORBIT SPACES ASSOCIATED WITH LOCALISED FRAMES 

DIMITRI BYTCHENKOFF, MICHAEL SPECKBACHER, AND PETER BALAZS


#### Abstract

Kernel theorems, in general, provide a convenient representation of bounded linear operators. For the operator acting on a concrete function space, this means that its action on any element of the space can be expressed as a generalised integral operator, in a way reminiscent of the matrix representation of linear operators acting on finite dimensional vector spaces. We prove kernel theorems for bounded linear operators acting on co-orbit spaces associated with localised frames. Our two main results consist in characterising the spaces of operators whose generalised integral kernels belong to the co-orbit spaces of test functions and distribtutions associated with the tensor product of the localised frames respectively. Moreover, using a version of Schur's test, we establish a characterisation of the bounded linear operators between some specific co-orbit spaces.

## 1. Introduction

This paper is concerned with co-orbit spaces, which were originally introduced in the late 1980's by Feichtinger and Gröchenig [19-21], and the bounded linear operators that act on those spaces. Co-orbit spaces, such as modulation [17] and Besov spaces [5], are defined as Banach spaces of functions or distributions whose membership is determined by integrability conditions imposed on their generalised wavelet transform. Co-orbit theory provides a convenient way of analysing and synthesising spaces of functions or distributions. The original definition of coorbit spaces relied on an integrable representation of a locally compact group on a Hilbert space. In the early 2000's, Gröchenig and Fornasier showed how localised frames can be used to introduce a novel class of co-orbit spaces and guarantee their stable decomposition [23, 29, 30]. In this report, we prove kernel theorems for bounded linear operators acting on co-orbit spaces associated with localised frames.

The main purpose of any kernel theorem is to express a given operator as a generalised integral operator. The original kernel theorem, proved by Laurent Schwartz in 1952, states that for any continuous linear operator $O$ mapping the Schwartz space $S\left(\mathbb{R}^{n}\right)$ on the space of tempered distributions $S^{\prime}\left(\mathbb{R}^{n}\right)$ there is a unique tempered distribution $K \in S^{\prime}\left(\mathbb{R}^{2 n}\right)$, called the kernel, that satisfies

for any $f_{1}, f_{2} \in S\left(\mathbb{R}^{n}\right)$. Furthermore, if $K$ happens to be a locally integrable function, then

and so the operator $O$ is indeed expressed as an integral operator. Other classical kernel theorems were established, for example, for the continuous operators mapping $\mathcal{D}\left(\mathbb{R}^{d}\right)$ on $\mathcal{D}^{\prime}\left(\mathbb{R}^{d}\right)$ [32, Theorem 5.2], and for operators mapping GelfandShilov spaces on their distribution spaces [27].

In 1980, Feichtinger proved a kernel theorem for bounded linear operators mapping the modulation spaces $M^{1}\left(\mathbb{R}^{n}\right)$ to $M^{\infty}\left(\mathbb{R}^{n}\right)$ [16], the spaces of choice in time-frequency analysis [17]. Using a version of Schur's test, Cordero and Nicola characterised the kernel of operators mapping $M^{1}\left(\mathbb{R}^{n}\right)$ on $M^{p}\left(\mathbb{R}^{n}\right)$ as well as those mapping $M^{p}\left(\mathbb{R}^{n}\right)$ on $M^{\infty}\left(\mathbb{R}^{n}\right)$ [14]. Finally, Balazs, Gröchenig and Speckbacher took a more abstract approach to prove their kernel theorem [4] for operators acting on co-orbit spaces associated with integrable representations of locally compact groups. Indeed, they considered irreducible unitary integrable representations $\pi_{n}: G_{n} \rightarrow \mathcal{H}_{n}, n=1,2$, of locally compact groups $G_{n}$ that generate two scales of co-orbit spaces and showed a one-to-one correspondence between bounded linear operators mapping $\operatorname{Co}^{1}\left(G_{1}\right)$ to $\operatorname{Co}^{\infty}\left(G_{2}\right)$ and their kernel belonging to the co-orbit space $\operatorname{Co} L^{\infty}\left(G_{1} \times G_{2}\right)$ generated by the tensor product representation $\pi_{1} \otimes \pi_{2}: G_{1} \times G_{2} \rightarrow \mathcal{H}_{1} \otimes \mathcal{H}_{2}$.

In this paper, we go even further and prove a kernel theorem for bounded linear operators acting on co-orbit spaces generated by localised frames $[23,24]$ and, by doing so, show that the group structure and the corresponding representation theory are an unnecessary, albeit very elegant setup for proving the kernel theorem. Here is the essence of our main results. See Sections 2 and 3 for the definitions of the involved co-orbit spaces and Section 4 for detailed statements and proofs of the subsequent results.

Theorem. (Outer kernel theorem) Let $\Psi_{n}$ be $\mathcal{A}_{n}$-localised frames, $n=1,2$. $A$ linear operator $O$ from $\mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right)$ on $\mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right)$ is bounded if and only if there exists a unique kernel $K \in \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ such that

for all $f_{1} \in \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right)$ and $f_{2} \in \mathcal{H}_{w_{2}}^{1}\left(\Psi_{2}\right)$.
Theorem. (Inner Kernel Theorem) Let $\Psi_{n} \subset \mathcal{H}_{n}$ be an $\mathcal{A}_{n}$-localised frame, and $w_{n}$ an $\mathcal{A}_{n}$-admissible weight for $n=1,2$. There is an isomorphism between kernels in $\mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$ and the space

The terminology of outer and inner kernel theorems [22] originates in the fact that the corresponding kernels belong, respectively, to the outer- and innermost
spaces on the scale of co-orbit spaces, as can be seen in the following chain of topological inclusions
$\mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right) \subset \mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Psi_{1} \otimes \Psi_{2}\right) \subset \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, p}\left(\Psi_{1} \otimes \Psi_{2}\right) \subset \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$, for weights $w_{1}, w_{2} \geq 1$, and $p \in(1, \infty)$.

Following the ideas developed in [14], we apply a version of Schur's test to characterise the kernels of the bounded operators mapping $\mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right)$ to $\mathcal{H}_{w_{2}}^{p}\left(\Psi_{2}\right)$ and those mapping $\mathcal{H}_{w_{1}}^{p}\left(\Psi_{1}\right)$ to $\mathcal{H}_{w_{2}}^{\infty}\left(\Psi_{2}\right)$, see Theorem 4.4.

A few words about what motivated us to undertake this whole investigation. There is every reason to use specifically localised frames here. Firstly, localised frames allow for essentially sparse atomic decompositions of the elements of their associated co-orbit spaces. Secondly, the Gram matrices of localised frames, by their definition, are essentially sparesely populated. Therefore, using localised frames, together with Galerkin's method $[1,26]$, can be expected to produce sparse matrices that represent the bounded linear operators that act on co-orbit spaces [25]. This in itself can, as highlighted in [1,3], be very useful for solving corresponding operator equations numerically. Moreover, as we shall show in this paper, the kernel of any bounded linear operator mapping one co-orbit space on the other can be synthesised from the matrix that represents the operator, therefore leading to a sparse decomposition of the kernel.

This paper is organised as follows. In Section 2 we provide the necessary frame theoretical background, namely the basics of the theory of localised frames. In Section 3 we show that co-orbit spaces generated by tensor products of localised frames share some properties with those generated by localised frames. Section 4 is then devoted to the proofs of our main results.

Some of the results of this paper were outlined in a greatly simplified way and mostly without providing any proof in [9].

## 2. BACKGROUND INFORMATION AND NOTATION

Throughout this paper we will write $A \lesssim B$ if there exists $C \geq 1$ such that $A \leq C B$ and $A \asymp B$ if $C^{-1} B \leq A \leq C B$. Moreover, $\mathcal{H}, \mathcal{H}_{1}, \mathcal{H}_{2}$ will always denote separable Hilbert spaces. We shall use brackets $\langle\cdot, \cdot\rangle_{\mathcal{H}}$ for the scalar product in the Hilbert space and $\langle\cdot, \cdot\rangle_{X, X^{*}}$ for the scalar product of the element of the Banach space $X$ and that of its dual $X^{*}$. Furthermore, we denote the space of bounded operators between normed spaces $X, Y$ by $B(X, Y)$ and write $\|\cdot\|_{X \rightarrow Y}$ for the operator norm.
2.1. Tensor products and Hilbert-Schmidt operators. Tensor products and simple tensors are the essential objects to understand kernel theorems for operators. See [38] for an overview of the subject. In this paper, we use the following convention to define the simple tensor of $f_{1} \in \mathcal{H}_{1}$ and $f_{2} \in \mathcal{H}_{2}: f_{1} \otimes f_{2}$ will be understood as the rank one operator mapping $\mathcal{H}_{1}$ on $\mathcal{H}_{2}$ according to

Note that this tensor is homogeneous in the following sense: $\alpha\left(f_{1} \otimes f_{2}\right)=\left(\bar{\alpha} f_{1}\right) \otimes$ $f_{2}=f_{1} \otimes\left(\alpha f_{2}\right)$. The tensor product $\mathcal{H}_{1} \otimes \mathcal{H}_{2}$ is then defined as the completion
of the linear span of all simple tensors with respect to the metric induced by the inner product

We note here that the tensor product $\mathcal{H}_{1} \otimes \mathcal{H}_{2}$ can be identified with the space of Hilbert-Schmidt operators $\mathcal{H S}\left(\mathcal{H}_{1}, \mathcal{H}_{2}\right)$, which is defined as the space of bounded linear operators mapping $\mathcal{H}_{1}$ on $\mathcal{H}_{2}$ and equipped with the inner product

where $\left\{e_{i}\right\}_{i \in \mathbb{N}}$ is any orthonormal basis of the Hilbert space $\mathcal{H}_{1}$. We also note that this identification constitutes a non-trivial kernel theorem [13]. If $O \in$ $\mathcal{H S}\left(\mathcal{H}_{1}, \mathcal{H}_{2}\right), f_{1} \in \mathcal{H}_{1}$ and $f_{2} \in \mathcal{H}_{2}$, then

2.2. Frame theory. Throughout this work we use frames to decompose or synthesise functions and operators. See $[11,12]$ for an overview of frame theory. Let us recollect the definition of a frame originally given in [15].
Definition 2.1. A countable set $\Psi:=\left\{\psi_{i}\right\}_{i \in I} \subset \mathcal{H}$ is called a frame for $\mathcal{H}$ if there are positive numbers $A_{\Psi}$ and $B_{\Psi}$, called lower and upper frame bounds, such that, for any $f \in \mathcal{H}$

Let us list a few implications of this definition that we shall make use of later. The analysis operator

C_{\Psi}: \mathcal{H} \rightarrow \ell^{2}(I), \quad f \mapsto\left\{\left\langle f, \psi_{i}\right\rangle_{\mathcal{H}}\right\}_{i \in I}

is bounded and injective and has a closed range. The synthesis operator

D_{\Psi}: \ell^{2}(I) \rightarrow \mathcal{H}, \quad\left\{c_{i}\right\}_{i \in I} \mapsto \sum_{i \in I} c_{i} \psi_{i}
$$

is bounded and surjective. The Gram operator

$$

G_{\Psi}: \ell^{2}(I) \rightarrow \ell^{2}(I), \quad\left\{c_{i}\right\}_{i \in I} \mapsto \sum_{i^{\prime} \in I}\left\langle\psi_{i^{\prime}}, \psi_{i}\right\rangle_{\mathcal{H}} c_{i^{\prime}}=\sum_{i^{\prime} \in I} G_{i, i^{\prime}} c_{i^{\prime}}=C_{\Psi} D_{\Psi} c, \tag{2.4}
\end{equation*}

with the Gram matrix given by

G_{\Psi}:=\left(G_{i, i^{\prime}}\right)_{\left(i, i^{\prime}\right) \in I^{2}}:=\left(\left\langle\psi_{i^{\prime}}, \psi_{i}\right\rangle_{\mathcal{H}}\right)_{\left(i, i^{\prime}\right) \in I^{2}}, \tag{2.5}

is bounded. There exists at least one other frame $\Psi^{\mathrm{d}}:=\left\{\psi_{i}^{d}\right\}_{i \in I}$ for $\mathcal{H}$, called a dual frame, that, together with $\Psi$, satisfies

f=\sum_{i \in I}\left\langle f, \psi_{i}\right\rangle_{\mathcal{H}} \psi_{i}^{d}=D_{\Psi^{\mathrm{d}}} C_{\Psi} f=\sum_{i \in I}\left\langle f, \psi_{i}^{d}\right\rangle_{\mathcal{H}} \psi_{i}=D_{\Psi} C_{\Psi^{\mathrm{d}}} f . \tag{2.6}

Finally the frame operator

$$
S_{\Psi}: \mathcal{H} \rightarrow \mathcal{H}, \quad f \mapsto \sum_{i \in I}\left\langle f, \psi_{i}\right\rangle_{\mathcal{H}} \psi_{i}
$$

is bounded, self-adjoint and invertible for any frame $\Psi$ and the sequence $\widetilde{\Psi}=$ $\left\{\widetilde{\psi}_{i}\right\}_{i \in I}=\left\{S_{\Psi}^{-1} \psi_{i}\right\}_{i \in I}$, known as the canonical dual frame, is a dual frame for $\Psi$.

There is also a similar concept of the frame for Banach spaces [28].
2.3. Localised frames and their co-orbit spaces. One of the major advantages of frames over bases is that the former allow much more freedom in their construction and so can often be designed in a way that allows sparse decompositions of the functions of a given class. Any element of a Hilbert space can be expressed as a linear combination of the elements of a frame, see (2.6). To guarantee this reconstruction property in a Banach space, a more refined notion of frames has to be used, namely that of a Banach frame [28]. In order to construct a Banach frame that achieves a sparse decomposition of a concrete Banach space, say, a specific decomposition space [18], the theory of structured Banach frames $[6,36,37,41]$ can be employed and indeed proved very useful $[7,8]$. The Banach frames of choice for more abstract co-orbit spaces are the so-called localised frames.

Let us start with an intuitive notion of localisation [29] that should serve as an inspiration for the general concept of $\mathcal{A}$-localisation. For a given a metric $\rho$ on the indexing set $I$ that satisfies

the frame is called localised if the absolute values of the elements of the Gram matrix $G_{\Psi}$ decay polynomially as they deviate from the main diagonal of the matrix [29], i.e., if

\left|\left(G_{\Psi}\right)_{i, i^{\prime}}\right|=\left|\left\langle\psi_{i}, \psi_{i^{\prime}}\right\rangle_{\mathcal{H}}\right| \lesssim\left(1+\rho\left(i, i^{\prime}\right)\right)^{-n}, \quad i, i^{\prime} \in I \tag{2.7}
\end{equation*}

for some $n>n_{0}$. The matrices whose elements satisfy (2.7) belong to a spectral matrix algebra. This allows the generalization of the notion of localisation [30].
Definition 2.2. An involutive Banach algebra $\mathcal{A}$ of infinite matrices with norm $\|\cdot\|_{\mathcal{A}}$ is called a spectral matrix algebra if
(i) every $A \in \mathcal{A}$ defines a bounded operator on $\ell^{2}(I)$, i.e. $\mathcal{A} \subset B\left(\ell^{2}(I)\right)$,
(ii) $\mathcal{A}$ is inverse-closed in $B\left(\ell^{2}(I)\right)$, i.e. if $A \in \mathcal{A}$ is invertible on $B\left(\ell^{2}(I)\right)$, then $A^{-1} \in \mathcal{A}$, and
(iii) $\mathcal{A}$ is solid, i.e. if $A \in \mathcal{A}$ and $\left|b_{i, j}\right| \leqslant\left|a_{i, j}\right|$ for any $i, j \in I$, then $B \in \mathcal{A}$ and $\|B\|_{\mathcal{A}} \leqslant\|A\|_{\mathcal{A}}$.

Examples of solid spectral matrix algebras include, among others, the Jaffard class [33] (which corresponds to (2.7) if $\rho$ is the standard Euclidean metric), the Schur class [31] and the Sjöstrand class [39].

Definition 2.3. Let $I$ be a countable index set. A frame $\Psi=\left\{\psi_{i}\right\}_{i \in I} \subset \mathcal{H}$ is said to be $\mathcal{A}$-intrinsically localised, or $\mathcal{A}$-self-localised, or simply $\mathcal{A}$-localised, if its Gram matrix $G_{\Psi}:=\left(\left\langle\psi_{i}, \psi_{i^{\prime}}\right\rangle_{\mathcal{H}}\right)_{\left(i,, i^{\prime}\right) \in I^{2}}$ belongs to a spectral matrix algebra $\mathcal{A}$.

Having a localised frame $\Psi$ for a Hilbert space $\mathcal{H}$ allows to build a full range of so-called co-orbit spaces. To do so, we use a weight $w=\left\{w_{i}\right\}_{i \in I}, w_{i}>0$,
and define the weighted $\ell_{w}^{p}(I)$-spaces as the space of sequences on $I$ for which $\|c\|_{\ell_{w}^{p}(I)}=\|c \cdot w\|_{\ell_{p}(I)}<\infty, 1 \leq p \leq \infty$.
Definition 2.4. Let $\mathcal{A}$ be a spectral matrix algebra indexed by $I \times I$. A weight sequence $w:=\left\{w_{i}\right\}_{i \in I} \subset \mathbb{R}^{+}$is called $\mathcal{A}$-admissible if every $A \in \mathcal{A}$ defines a bounded operator on $\ell_{w}^{p}(I)$ for every $1 \leqslant p \leqslant \infty$.
Definition 2.5. Let $\mathcal{A}$ be a spectral matrix algebra, $\Psi:=\left\{\psi_{i}\right\}_{i \in I} \subset \mathcal{H}$ be an $\mathcal{A}$-localised frame, $\widetilde{\Psi}:=\left\{\widetilde{\psi}_{i}\right\}_{i \in I} \subset \mathcal{H}$ its canonical dual frame, $w:=\left\{w_{i}\right\}_{i \in I}$ an $\mathcal{A}$-admissible weight and

\mathcal{H}_{00}(\Psi)=\left\{\sum_{i \in I} c_{i} \psi_{i}:\left\{c_{i}\right\}_{i \in I} \in c_{00}\right\} \tag{2.8}
\end{equation*}
$$

where $c_{00}$ denotes the space of complex sequences with finitely many non-zero terms. For $1 \leqslant p<\infty$, the co-orbit space $\mathcal{H}_{w}^{p}(\Psi)$ is defined as the norm completion of $\mathcal{H}_{00}(\Psi)$ with respect to the norm $\|f\|_{\mathcal{H}_{w}^{p}(\Psi)}:=\left\|C_{\widetilde{\Psi}} f\right\|_{\ell_{w}^{p}}$, while for $p=\infty$, $\mathcal{H}_{w}^{\infty}(\Psi)$ is defined as the completion of $\mathcal{H}_{00}(\Psi)$ with respect to the $\sigma\left(\mathcal{H}, \mathcal{H}_{00}(\Psi)\right)$ topology. If $w \equiv 1$ we write $\mathcal{H}^{p}(\Psi)=\mathcal{H}_{1}^{p}(\Psi)$.
Remark 2.6. More specifically, $\mathcal{H}_{w}^{\infty}(\Psi)$ is defined as a set of equivalence classes of sequences from $\mathcal{H}$, see [3, Definition 3]. We do not provide any details for the moment, but shall do so when we consider co-orbit spaces generated by tensor products of localised frames in Section 3.

Also note that, while in [3, 23] one may use any dual frame $\Psi^{\mathrm{d}}$ to define the coorbit norms, we restrict ourselves to the canonical dual for the sake of simplicity.

In the following proposition, we summarise the main properties of co-orbit spaces that we shall need. See $[3,23]$ for the corresponding original statements.

Proposition 2.7. Let $\Psi$ and $\Phi$ be two $\mathcal{A}$-localised frames for a Hilbert space $\mathcal{H}$, $w$ be an $\mathcal{A}$-admissible weight, and $1 \leqslant p \leqslant \infty$. Then the following statements hold:
(i) $D_{\Psi}: \ell_{w}^{p}(I) \rightarrow \mathcal{H}_{w}^{p}(\Psi)$ is continuous;
(ii) $\mathcal{H}=\mathcal{H}_{1}^{2}(\Psi)$;
(iii) duality: for $1 \leqslant p<\infty$, and $q$ satisfying $1 / p+1 / q=1$, one has $\left(\mathcal{H}_{w}^{p}(\Psi)\right)^{*}=$ $\mathcal{H}_{1 / w}^{q}(\Psi)$, where the duality is defined by

$$
\langle f, g\rangle_{\mathcal{H}_{w}^{p}(\Psi), \mathcal{H}_{1 / w}^{q}(\Psi)}=\left\langle C_{\widetilde{\Psi}} f, C_{\Psi} g\right\rangle_{\ell_{w}^{p}(I) \ell_{1 / w}^{q}(I)}
$$

(iv) inclusions: $\mathcal{H}_{w_{1}}^{p_{1}}(\Psi) \subset \mathcal{H}_{w_{2}}^{p_{2}}(\Psi)$ for $w_{1} \geqslant w_{2}$, and $1 \leqslant p_{1}<p_{2} \leqslant \infty$;
(v) $G_{\widetilde{\Psi}} \in \mathcal{A}$ and $G_{\widetilde{\Psi}, \Psi} \in \mathcal{A}$, i.e., the canonical dual frame $\widetilde{\Psi}$ is also $\mathcal{A}$-localised;
(vi) independence of $\Psi$ : if $G_{\Psi, \widetilde{\Phi}} \in \mathcal{A}$ and $G_{\widetilde{\Psi}, \Phi} \in \mathcal{A}$, then $\mathcal{H}_{w}^{p}(\Psi)=\mathcal{H}_{w}^{p}(\Phi)$ with equivalent norms; in particular, $\mathcal{H}_{w}^{p}(\Psi)=\mathcal{H}_{w}^{p}(\widetilde{\Psi})$.

The following lemma sets an upper bound of the $\mathcal{H}_{w}^{1}(\Psi)$-norm of the elements of $\Psi$ and $\widetilde{\Psi}$.

Lemma 2.8. Let $1 \leq p<\infty, \Psi$ be an $\mathcal{A}$-localised frame for $\mathcal{H}$, and $w$ an $\mathcal{A}$ admissible weight. Then

\left\|\psi_{i}\right\|_{\mathcal{H}_{w(\Psi)}^{p}} \lesssim w_{i}, \quad \text { and } \quad\left\|\widetilde{\psi}_{i}\right\|_{\mathcal{H}_{w}^{p}(\Psi)} \lesssim w_{i}, \quad i \in I \tag{2.9}
\end{equation*}
$$

Proof. Remember that the Gram matrix $G_{\widetilde{\Psi}}$ of $\widetilde{\Psi}$ as well as the so-called cross Gram matrix

G_{\Psi, \widetilde{\Psi}}=\left\{\left\langle\psi_{i^{\prime}}, \widetilde{\psi}_{i}\right\rangle\right\}_{\left(i, i^{\prime}\right) \in I^{2}} \tag{2.10}

of $\Psi$ and $\widetilde{\Psi}$ are bounded operators on $\ell_{w}^{p}(I)$ for $p \in[1, \infty]$, as $\Psi$ and $\widetilde{\Psi}$ are $\mathcal{A}$ localised by assumption and Proposition 2.7 (v), and $w$ is $\mathcal{A}$-admissible. Therefore,

$$
\begin{aligned}
\left\|\widetilde{\psi}_{i}\right\|_{\mathcal{H}_{w(\Psi)}^{p}(\Psi)}^{p} & =\sum_{k \in I}\left|\left\langle\widetilde{\psi}_{i}, \widetilde{\psi}_{k}\right\rangle_{\mathcal{H}}\right|^{p} w_{k}^{p}=\sum_{k \in I}\left|\left(G_{\widetilde{\Psi}}\right)_{k, i}\right|^{p} w_{k}^{p} \\
& =\sum_{k \in I}\left|\left(G_{\widetilde{\Psi}} e_{i}\right)_{k}\right|^{p} w_{k}^{p}=\left\|G_{\widetilde{\Psi}} e_{i}\right\|_{\ell_{w}^{p}(I)}^{p} \lesssim\left\|e_{i}\right\|_{\ell_{w}^{p}(I)}^{p}=w_{i}^{p},
\end{aligned}
$$

where $e_{i}$ stands for the $i$-th vector of the standard basis of $\ell_{w}^{1}(I)$. The upper bound of $\left\|\psi_{i}\right\|_{\mathcal{H}_{w}^{p}(\Psi)}$ follows from a similar argument, replacing $G_{\widetilde{\Psi}}$ by $G_{\widetilde{\Psi}, \Psi}$.

Finally, we recollect a result from [23] concerning the representation of elements of $\mathcal{H}_{w}^{1}(\Psi)$ as a series expansion.
Proposition 2.9. Let $\Psi$ be an $\mathcal{A}$-localised frame for $\mathcal{H}$ and $w$ be an $\mathcal{A}$-admissible weight. For any $f \in \mathcal{H}_{w}^{1}(\Psi)$ there is a sequence of numbers $c:=\left\{c_{i}\right\}_{i \in I} \in \ell_{w}^{1}(I)$ such that

$$
f=\sum_{i \in I} c_{i} \psi_{i},
$$

where the series converges absolutely and $\|c\|_{\ell_{w}^{1}(I)} \asymp\|f\|_{\mathcal{H}_{w}^{1}(\Psi)}$.

## 3. Tensor products of localised frames

If we consider the tensor product $\Psi_{1} \otimes \Psi_{2}=\left\{\psi_{1, i} \otimes \psi_{2, j}\right\}_{(i, j) \in I \times J}$ of two frames $\Psi_{1}:=\left\{\psi_{1, i}\right\}_{i \in I} \subset \mathcal{H}_{1}$ and $\Psi_{2}:=\left\{\psi_{2, j}\right\}_{j \in J} \subset \mathcal{H}_{2}$, then it is straightforward to show [2] that $\Psi_{1} \otimes \Psi_{2}$ forms a frame for the tensor product $\mathcal{H}_{1} \otimes \mathcal{H}_{2}$ and that the canonical dual frame is given by $\widetilde{\Psi_{1} \otimes \Psi_{2}}=\widetilde{\Psi}_{1} \otimes \widetilde{\Psi}_{2}$. If both frames are localised with respect to a solid spectral matrix algebra, then it is possible to also define co-orbit spaces. For the sake of completeness, we provide here all necessary definitions. Let us first define the mixed-norm sequence spaces

\ell_{w}^{p, q}(I \times J):=\left\{c: I \times J \rightarrow \mathbb{C}: \sum_{j \in J}\left(\sum_{i \in I}\left|c_{i, j}\right|^{p} w_{i, j}^{p}\right)^{q / p}<\infty\right\}

for $1 \leqslant p, q \leqslant \infty$, with the usual adaptations if $p=\infty$, or $q=\infty$. Since the order of summation matters if $p \neq q$, we also introduce the spaces

\mathfrak{l}_{w}^{p, q}(I \times J):=\left\{c: I \times J \rightarrow \mathbb{C}: \quad \sum_{i \in I}\left(\sum_{j \in J}\left|c_{i, j}\right|^{p} w_{i, j}^{p}\right)^{q / p}<\infty\right\} .
$$

Let

$$
\mathcal{H}_{00}\left(\Psi_{1} \otimes \Psi_{2}\right)=\left\{\sum_{(i, j) \in I \times J} c_{i, j} \psi_{1, i} \otimes \psi_{2, j}:\left\{c_{i, j}\right\}_{(i, j) \in I \times J} \in c_{00}\right\},
$$

and $p, q \in[1, \infty)$. The co-orbit spaces $\mathcal{H}_{w}^{p, q}\left(\Psi_{1} \otimes \Psi_{2}\right)$ are defined as the completion of $\mathcal{H}_{00}\left(\Psi_{1} \otimes \Psi_{2}\right)$ with respect to the norm $\|F\|_{\mathcal{H}_{w}^{p, q}\left(\Psi_{1} \otimes \Psi_{2}\right)}:=\left\|C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F\right\|_{\ell_{w}^{p, q}(I \times J)}$, and $\mathfrak{H}_{w}^{p, q}\left(\Psi_{1} \otimes \Psi_{2}\right)$ as the completion of $\mathcal{H}_{00}\left(\Psi_{1} \otimes \Psi_{2}\right)$ with respect to the norm
$\|F\|_{\mathfrak{H}_{w}^{p, q}\left(\Psi_{1} \otimes \Psi_{2}\right)}:=\left\|C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F\right\|_{p_{w}^{p, q}(I \times J)}$. If $w \equiv 1$, we write $\mathcal{H}^{p, q}\left(\Psi_{1} \otimes \Psi_{2}\right)=$ $\mathcal{H}_{1}^{p, q}\left(\Psi_{1} \otimes \Psi_{2}\right)$, and $\mathfrak{H}^{p, q}\left(\Psi_{1} \otimes \Psi_{2}\right)=\mathfrak{H}_{1}^{p, q}\left(\Psi_{1} \otimes \Psi_{2}\right)$. We shall primarily consider the case where $p=q$, but $p \neq q$ will make an appearance in Theorem 4.4.

As mentioned in [23], dealing with $\mathcal{H}_{w}^{\infty}(\Psi)$ for a localised frame $\Psi$ is technically rather tricky; a detailed exposition of the construction can be found in [3]. Here we have to grapple with this issue again as now the tensor product frame cannot be assumed to be localised. The major obstacle to simply applying established theory to the tensor product of an $\mathcal{A}_{1}$-localised frame and an $\mathcal{A}_{2}$-localised frame is the fact that the natural candidate for a tensor product algebra, the projective tensor product $\mathcal{A}_{1} \widehat{\otimes}_{\pi} \mathcal{A}_{2}$, is in general neither solid nor inverse-closed.

In order to properly define the co-orbit spaces where one of the indices or both of them are $\infty$, we need the following notion. We call two sequences $\left\{F_{n}\right\}_{n \in \mathbb{N}}$, $\left\{F_{n}^{\prime}\right\}_{n \in \mathbb{N}} \subset \mathcal{H}_{1} \otimes \mathcal{H}_{2} \quad$ equivalent if

$$
\lim _{n \rightarrow \infty}\left\langle F_{n}-F_{n}^{\prime}, \widetilde{\psi}_{1, i} \otimes \widetilde{\psi}_{2, j}\right\rangle_{\mathcal{H}_{1} \otimes \mathcal{H}_{2}}=0
$$

for all $(i, j) \in I \times J$.
Definition 3.1. Let $1 \leqslant p<\infty, n=1,2$, and $w_{n}$ be $\mathcal{A}_{n}$-admissible weights. We define the spaces $\mathcal{H}_{w_{1} \otimes w_{2}}^{r, s}\left(\Psi_{1} \otimes \Psi_{2}\right)$ and $\mathfrak{H}_{w_{1} \otimes w_{2}}^{r, s}\left(\Psi_{1} \otimes \Psi_{2}\right)$ where $(r, s) \in\{(p, \infty)$, $(\infty, p),(\infty, \infty)\}$, as the spaces of equivalence classes $F=\left[\left\{F_{n}\right\}_{n \in \mathbb{N}}\right]$ with $\left\{F_{n}\right\}_{n \in \mathbb{N}}$ $\subset \mathcal{H}_{1} \otimes \mathcal{H}_{2}$ such that

$$
\begin{equation*}
\lim _{n \rightarrow \infty}\left\langle F_{n}, \widetilde{\psi}_{1, i} \otimes \widetilde{\psi}_{2, j}\right\rangle_{\mathcal{H}_{1} \otimes \mathcal{H}_{2}}=: k_{i, j} \tag{3.1}
\end{equation*}
$$

exists for all $(i, j) \in I \times J$ and

$$
\sup _{n}\left\|C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F_{n}\right\|_{\ell_{w_{1} \otimes w_{2}}^{r, s}(I \times J)}<\infty, \quad \text { and } \quad \sup _{n}\left\|C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F_{n}\right\|_{r_{w_{1} \otimes w_{2}}^{r, s}(I \times J)}<\infty
$$

respectively. Furthermore we define $\left(C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F\right)_{i, j}:=k_{i, j},(i, j) \in I \times J$, and

$$
\begin{equation*}
\|F\|_{\mathcal{H}_{w_{1} \otimes w_{2}}^{r, s}\left(\Psi_{1} \otimes \Psi_{2}\right)}:=\left\|C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F\right\|_{\ell_{w_{1} \otimes w_{2}}^{r, s}(I \times J)}, \tag{3.2}
\end{equation*}
$$

as well as

$$
\begin{equation*}
\|F\|_{\mathfrak{S}_{w_{1} \otimes w_{2}}^{r, s}\left(\Psi_{1} \otimes \Psi_{2}\right)}:=\left\|C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F\right\|_{\mathfrak{r}_{w_{1} \otimes w_{2}}^{r, s}(I \times J)} . \tag{3.3}
\end{equation*}
$$

It is clear that $\|\cdot\|_{\mathcal{H}_{w_{1} \otimes w_{2}}^{r_{2}, s}\left(\Psi_{1} \otimes \Psi_{2}\right)}$ is a seminorm. Moreover, $\|F\|_{\mathcal{H}_{w_{1} \otimes w_{2}}^{r, s}\left(\Psi_{1} \otimes \Psi_{2}\right)}=$ 0 implies that all limits in (3.1) equal zero for any sequence $\left\{F_{n}\right\}_{n \in \mathbb{N}}$ representing $F$. In other words, all such sequences $\left\{F_{n}\right\}_{n \in \mathbb{N}}$ are equivalent to the sequence of zeros in $\mathcal{H}_{1} \otimes \mathcal{H}_{2}$ and so $F=0$. Consequently, $\|\cdot\|_{\mathcal{H}_{w_{1} \otimes w_{2}}^{r_{1} s}\left(\Psi_{1} \otimes \Psi_{2}\right)}$ is indeed a norm. The same reasoning shows that $\|\cdot\|_{\mathscr{H}_{w_{1}}, \boldsymbol{s}, w_{2}}\left(\Psi_{1} \otimes \Psi_{2}\right)$ is a norm.

The spaces $\mathcal{H}_{w_{1}, w_{2}}^{p, p}\left(\Psi_{1} \otimes \Psi_{2}\right)$ are structurally very similar to the co-orbit spaces of Section 2 and results analoguous to Propositions 2.7 and 2.9 hold. These results however are not a direct consequence of the existing theory as, e.g., Propositions 2.7 and 2.9 assume the localisation of the frame with respect to a solid spectral algebra. We conjecture that $\Psi_{1} \otimes \Psi_{2}$ would be $\mathcal{A}_{1} \widehat{\otimes}_{\pi} \mathcal{A}_{2}$-localised given that $\Psi_{1}$ and $\Psi_{2}$ are $\mathcal{A}_{1}$ - and $\mathcal{A}_{2}$-localised respectively. This would allow us to directly apply existing theory. This is however not a simple matter and is the subject of an ongoing project of ours. Fortunately, the assumption that both $\Psi_{1}$ and $\Psi_{2}$ are localised suffices to prove all the statements that we need here.

Proposition 3.2. Let $\Psi_{n}, \Phi_{n} \subset \mathcal{H}_{n}$ be $\mathcal{A}_{n}$-localised frames, and $w_{n}$ be $\mathcal{A}_{n}$ admissible weights, $n=1,2$, and $1 \leqslant p \leqslant \infty$. Then the following statements hold:
(i) if $G_{\Psi_{n}, \Phi_{n}} \in \mathcal{A}_{n}, n=1,2$, then the cross Gram matrix $G_{\Psi_{1} \otimes \Psi_{2}, \Phi_{1} \otimes \Phi_{2}}$ defines a bounded operator on $\ell_{w_{1} \otimes w_{2}}^{p, p}(I \times J)$;
(ii) independence of $\Psi_{1} \otimes \Psi_{2}:$ if $G_{\Psi_{n}, \widetilde{\Phi}_{n}} \in \mathcal{A}_{n}$ and $G_{\Phi_{n}, \widetilde{\Psi}_{n}} \in \mathcal{A}_{n}, n=1,2$, then

$$
\mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Psi_{1} \otimes \Psi_{2}\right)=\mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Phi_{1} \otimes \Phi_{2}\right)
$$

with equivalent norms. In particular,

$$
\mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Psi_{1} \otimes \Psi_{2}\right)=\mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\widetilde{\Psi}_{1} \otimes \widetilde{\Psi}_{2}\right) ;
$$

(iii) $D_{\Psi_{1} \otimes \Psi_{2}}: \ell_{w_{1} \otimes w_{2}}^{p, p}(I \times J) \rightarrow \mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Psi_{1} \otimes \Psi_{2}\right)$ is bounded and the expansion converges absolutely for $p<\infty$, and weak-* unconditionally for $p=\infty$;
(iv) for any $F \in \mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$, there exists a sequence $c \in \ell_{w_{1} \otimes w_{2}}^{1,1}(I \times J)$ such that $F=D_{\Psi_{1} \otimes \Psi_{2}} c$ and $\|F\|_{\mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)} \asymp\|c\|_{\ell_{w_{1} \otimes w_{2}}^{1,1}(I \times J)}$;
(v) duality: for $1 \leq p<\infty$ and $q$ satisfying $1 / p+1 / q=1$,

$$
\left(\mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Psi_{1} \otimes \Psi_{2}\right)\right)^{*} \cong \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{q, q}\left(\Psi_{1} \otimes \Psi_{2}\right)
$$

with the scalar product defined by

$$
\begin{aligned}
&\langle F, G\rangle_{\mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}}\left(\Psi_{1} \otimes \Psi_{2}\right), \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{q, q}\left(\Psi_{1} \otimes \Psi_{2}\right) \\
&:=\left\langle C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F, C_{\Psi_{1} \otimes \Psi_{2}} G\right\rangle_{\ell_{w_{1} \otimes w_{2}}^{p, p}}(I \times J), \ell_{1 /\left(w_{1} \otimes w_{2}\right)}(I \times J)
\end{aligned} .
$$

Proof. Ad (i): As the weight functions $w_{n}$ are $\mathcal{A}_{n}$-admissible, it follows that the cross Gram matrix $G_{\Psi_{n}, \Phi_{n}}$ defines a bounded operator on $\ell_{w_{n}}^{p}\left(I_{n}\right)$ [3]. Therefore, for $1 \leqslant p<\infty$, and $c \in \ell_{w_{1} \otimes w_{2}}^{p, p}(I \times J)$, we obtain from (2.2) that

$$
\begin{aligned}
\left\|G_{\Psi_{1} \otimes \Psi_{2}, \Phi_{1} \otimes \Phi_{2}} c\right\|_{\ell_{w_{1} \otimes w_{2}}^{p, p}(I \times J)}^{p} & =\sum_{j \in J} \sum_{i \in I}\left|\sum_{\left(i^{\prime}, j^{\prime}\right) \in I \times J} \overline{\left(G_{\Psi_{1}, \Phi_{1}}\right)_{i, i^{\prime}}}\left(G_{\Psi_{2}, \Phi_{2}}\right)_{j, j^{\prime}} c_{i^{\prime}, j^{\prime}}\right|^{p} w_{1, i}^{p} w_{2, j}^{p} \\
& \lesssim \sum_{j \in J} \sum_{i \in I}\left|\sum_{j^{\prime} \in J}\left(G_{\Psi_{2}, \Phi_{2}}\right)_{j, j^{\prime}} c_{i, j^{\prime}}\right|^{p} w_{1, i}^{p} w_{2, j}^{p} \\
& \lesssim \sum_{j \in J} \sum_{i \in I}\left|c_{i, j}\right|^{p} w_{1, i}^{p} w_{2, j}^{p}=\|c\|_{\ell_{w_{1}}^{p, p} \otimes w_{2}}^{p}(I \times J)
\end{aligned}
$$

A similar argument can be used to prove the statement in the case where $p=\infty$. This concludes the proof of (i).

Ad (ii): Since $F=D_{\Psi_{1} \otimes \Psi_{2}} C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F$, we see that the frame coefficients with respect to $\widetilde{\Phi}_{1} \otimes \widetilde{\Phi_{2}}$ are given by

& =\|F\|_{\mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}}\left(\Psi_{1} \otimes \Psi_{2}\right) .
\end{aligned}

Therefore, $\mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Psi_{1} \otimes \Psi_{2}\right) \subseteq \mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Phi_{1} \otimes \Phi_{2}\right)$. Exchanging the roles of $\Psi_{1} \otimes$ $\Psi_{2}$ and $\Phi_{1} \otimes \Phi_{2}$ results in $\mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Phi_{1} \otimes \Phi_{2}\right) \subseteq \mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Psi_{1} \otimes \Psi_{2}\right)$ and the norm equivalence.

Ad (iii): The proofs of (iii) and (iv) follow closely the arguments of [23, Proposition 2.4] and [3, Lemmas 2 and 7] respectively. First, let $c \in \ell_{w_{1} \otimes w_{2}}^{p, p}(I \times J)$ and set $F=D_{\Psi_{1} \otimes \Psi_{2}} c$. Then

where we used (i), and Proposition 2.7 (v). The absolute convergence for $p<\infty$ follows immediately from Lemma 2.8.

The proof of the unconditional weak-* convergence for $p=\infty$ is postponed until the end of the proof of this proposition.
$\operatorname{Ad}(i v)$ : Let $F$ be an element of $\mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$. Being convergent, $\left\{F_{k}\right\}_{k \in \mathbb{N}}$ is a Cauchy sequence in $\mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$. From this and the first equality in (3.4) we infer that $\left\{C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F_{k}\right\}_{k \in \mathbb{N}}$ is a Cauchy sequence in $\ell_{w_{1} \otimes w_{2}}^{1,1}(I \times J)$ converging to $c=C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} F \in \ell_{w_{1} \otimes w_{2}}^{1,1}(I \times J)$. Let $F^{\prime}:=D_{\Psi_{1} \otimes \Psi_{2}} c$. From the (iii) we infer that $F^{\prime} \in \mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$. Using the fact that

Therefore $F^{\prime}=F=D_{\Psi_{1} \otimes \Psi_{2}} c$ and we have proved that $D_{\Psi_{1} \otimes \Psi_{2}}$ is surjective. Finally, $D_{\Psi_{1} \otimes \Psi_{2}}$ is a bijective operator mapping $\ell_{w_{1} \otimes w_{2}}^{1,1}(I \times J) / \operatorname{ker}\left(D_{\Psi_{1} \otimes \Psi_{2}}\right)$ on $\mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$, which shows that there exists $c \in \ell_{w_{1} \otimes w_{2}}^{1,1}(I \times J)$ such that $D_{\Psi_{1} \otimes \Psi_{2}} c=F$ and

Therefore $\left\{H\left(\psi_{1, i} \otimes \psi_{2, j}\right)\right\}_{(i, j) \in I \times J} \in \ell_{1 /\left(w_{1} \otimes w_{2}\right)}^{q, q}(I \times J)$ [13]. If we define the mapping $\mathcal{V}$ : $\left(\mathcal{H}_{w_{1} \otimes w_{2}}^{p, p}\left(\Psi_{1} \otimes \Psi_{2}\right)\right)^{*} \rightarrow \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{q, q}\left(\Psi_{1} \otimes \Psi_{2}\right)$ by

where the change of the order of summations, taking scalar products and application of $H$ is justified by the unconditional convergence of the series involved, the continuity of $H$, and a density argument. By density of $\mathcal{H}_{00}\left(\Psi_{1} \otimes \Psi_{2}\right)$ in $\mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$, the chain of inequalities also holds for any $H \in \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$, showing that $D_{\Psi_{1} \otimes \Psi_{2}} c$ converges weak-* absolutely and in particular weak-* unconditionally.

Remark 3.3. It is unclear to us whether the statements of Proposition 3.2 apply to the co-orbit spaces $\mathcal{H}_{w_{1} \otimes w_{2}}^{p_{1}, p_{2}}\left(\Psi_{1} \otimes \Psi_{2}\right)$ if $p_{1} \neq p_{2}$. The main problem is that the argument used in proving (i) does not apply to mixed $\ell^{p, q}$-spaces. In particular, the cross Gram matrix $G_{\Psi_{1} \otimes \Psi_{2}, \Phi_{1} \otimes \Phi_{2}}$ is not necessarily a bounded operator on the spaces $\ell_{w_{1} \otimes w_{2}}^{p_{1}, p_{1}}(I \times J)$ when $p_{1} \neq p_{2}$. The proofs of the statements (ii)-(v) rely crucially on (i). As a consequence of one of our kernel theorems, we shall however show in Corollary 4.5 that some mixed-norm co-orbit spaces are indeed independent of the specific frames defining them as long as the individual cross Gram matrices belong to $\mathcal{A}_{n}, n=1,2$.

In the following we establish the reconstruction formula on $\mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ and a necessary and sufficient condition for $k \in \ell_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}(I \times J)$ to be the generalised wavelet transform of a vector $F \in \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ - which, following the tradition of $[19,23]$, can be called the 'correspondence principle'.

Lemma 3.4. Let $\Psi_{n}, \Phi_{n} \subset \mathcal{H}_{n}$ be $\mathcal{A}_{n}$-localised frames, and $w_{n}$ be $\mathcal{A}_{n}$-admissible weights for $n=1$, 2. If $F \in \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$, then

To prove the second statement, let $k \in \ell_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}(I \times J)$ satisfy (3.8) and let $\left\{I_{n}\right\}_{n \in \mathbb{N}}$ and $\left\{J_{n}\right\}_{n \in \mathbb{N}}$ be sequences of finite subsets of $I$ and $J$ respectively such that $I_{n} \subset I_{n+1} \subseteq I$, and $J_{n} \subset J_{n+1} \subseteq J$ for any $n \in \mathbb{N}, \cup_{n \in \mathbb{N}} I_{n}=I$ and $\cup_{n \in \mathbb{N}} J_{n}=J$. Therefore $F=\left[F_{n}\right] \in \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ satisfies (3.7) and is, as an equivalence class, uniquely defined by $k$ via (3.7).

Conversely, let $k \in \ell_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}(I \times J)$ and $F \in \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ be such that (3.7) is satisfied. Proposition 3.2 (iii) indicates that $D_{\Psi_{1} \otimes \Psi_{2}}$ is a bounded operator mapping $\ell_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}(I \times J)$ to $\mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$. Applying $C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} D_{\Psi_{1} \otimes \Psi_{2}}$ to both sides of (3.7) and using (3.6) results in

## 4. Kernel Theorems

We are now ready to state and prove our main results. To prove the outer kernel theorem, we essentially follow the proof strategy of [4], but use somewhat more involved arguments in those steps where we cannot rely on either the group structure or submultiplicativity of the weight function. The basic idea is to represent
the operator by its Galerkin matrix and to derive the kernel of the operator from this representation.

Theorem 4.1. (Outer Kernel Theorem) Let $\Psi_{n} \subset \mathcal{H}_{n}$ be an $\mathcal{A}_{n}$-localised frame, and $w_{n}$ an $\mathcal{A}_{n}$-admissible weight for $n=1,2$.

To any element of $K \in \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ corresponds a unique bounded linear operator $O: \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right)$ by means of

Conversely, to any bounded linear operator $O: \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right)$ corresponds a unique $K \in \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$, called the kernel of $O$, that satisfies (4.1) for every $f_{1} \in \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right)$ and $f_{2} \in \mathcal{H}_{w_{2}}^{1}\left(\Psi_{2}\right)$.

Proof. Step 1. Note that $f_{1} \otimes f_{2} \in \mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$ as long as $f_{1} \in \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right)$ and $f_{2} \in \mathcal{H}_{w_{2}}^{1}\left(\Psi_{2}\right)$. & \leqslant\left\|C_{\Psi_{1} \otimes \Psi_{2}} K\right\|_{\ell_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}(I \times J)}\left\|C_{\Psi_{1} \otimes \Psi_{2}}\left(f_{1} \otimes f_{2}\right)\right\|_{\ell_{w_{1} \otimes w_{2}}^{1,1}(I \times J)} \\
& \asymp\|K\|_{\mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty}\left(\Psi_{1} \otimes \Psi_{2}\right)}\left\|f_{1} \otimes f_{2}\right\|_{\mathcal{H}_{w_{1} \otimes, 1}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)} \\

Subsequently, we show that $k$ satisfies (3.8), which, according to Lemma 3.4, implies that there is a unique $K \in \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$
that satisfies $C_{\widetilde{\Psi_{1} \otimes \Psi_{2}}} K=k$. Indeed, for any $(i, j) \in I \times J$,

The so-called tensor product property, discovered by Feichtinger [17, Theorem 7D] (see also [34]), was generalised for co-orbit spaces associated with integrable group representations [4]. In what follows, we shall obtain a similar result for co-orbit spaces associated with $\mathcal{A}$-localised frames. &=\left\langle\sum_{s \in S} h_{s} \otimes k_{s}, f_{1} \otimes f_{2}\right\rangle_{\left.\mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right), \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty}\right)\left(\Psi_{1} \otimes \Psi_{2}\right)}
\end{aligned}
$$

Changing the order of inner products and summation yields

$$
\begin{align*}
& \sum_{r \in R}\left\langle f_{1}, f_{r}\right\rangle_{\mathcal{H}_{1 / w_{1}}^{\infty}\left(\Psi_{1}\right), \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right)}\left\langle g_{r}, f_{2}\right\rangle_{\mathcal{H}_{w_{2}}^{1}\left(\Psi_{2}\right), \mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right)}  \tag{4.7}\\
&=\sum_{s \in S}\left\langle f_{1}, h_{s}\right\rangle_{\mathcal{H}_{1 / w_{1}}^{\infty}}\left(\Psi_{1}\right), \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right)
\end{align*}\left\langle k_{s}, f_{2}\right\rangle_{\mathcal{H}_{w_{2}}^{1}\left(\Psi_{2}\right), \mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right)}, ~(4.7),
$$

from which we infer that $\mathcal{I}\left(\sum_{r \in R} f_{r} \otimes g_{r}\right)=\mathcal{I}\left(\sum_{s \in S} h_{s} \otimes k_{s}\right)$.
It is easy to see that $\mathcal{I}$ is surjective and it therefore remains to prove that is also injective. Let $H_{1}=\sum_{r \in R} f_{r} \otimes g_{r}$ and $H_{2}=\sum_{s \in S} h_{s} \otimes k_{s} \in \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \widehat{\otimes}_{\pi} \mathcal{H}_{w_{2}}^{1}\left(\Psi_{2}\right)$ be such that $\mathcal{I}\left(H_{1}\right)=\mathcal{I}\left(H_{2}\right)$. In other words, (4.7) holds for any $f_{1} \in \mathcal{H}_{1 / w_{1}}^{\infty}\left(\Psi_{1}\right)$ and any $f_{2} \in \mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right)$. From this and (4.6), which holds for any element of $\mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \widehat{\otimes}_{\pi} \mathcal{H}_{w_{2}}^{1}\left(\Psi_{2}\right)$, we deduce that

$$
\begin{aligned}
\left\langle H_{1}, f_{1} \otimes f_{2}\right\rangle_{\mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}}\left(\Psi_{1} \otimes \Psi_{2}\right), \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty}\left(\Psi_{1} \otimes \Psi_{2}\right)
\end{aligned} \quad \begin{aligned}
& \quad \\
& \quad\left\langle H_{2}, f_{1} \otimes f_{2}\right\rangle_{\mathcal{H}_{w_{1}}^{1,1} \otimes w_{2}}\left(\Psi_{1} \otimes \Psi_{2}\right), \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right) .
\end{aligned}
$$

Since $D_{\Psi_{1} \otimes \Psi_{2}}: \ell_{1 /\left(w_{1} \otimes w_{2}\right.}^{\infty, \infty}(I \times J) \rightarrow \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right.}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ is surjective (Lemma 3.4) and converges weak-* unconditionally (Proposition 3.2 (iii)) we may consider linear combinations of $f_{1} \otimes f_{2}=\psi_{1, i} \otimes \psi_{2, j}$ to show that $H_{1}=H_{2}$ in $\mathcal{H}_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$. According to Theorem 4.2, this equality also holds in $\mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \widehat{\otimes}_{\pi} \mathcal{H}_{w_{2}}^{1}\left(\Psi_{2}\right)$, which concludes the proof.

Now that we established the correspondence between operators and kernels, we investigate whether it is possible to characterise certain classes of operators via the properties of their kernels, in particular in terms of certain mixed-norm co-orbit spaces. The arguments crucially rely on a version of Schur's test (see,
for example, [40, Propositions 5.2 and 5.4] and [35]) and the representation of an operator by its Galerkin matrix defined in (4.3) by

k_{i, j}:=\left\langle O \widetilde{\psi}_{1, i}, \widetilde{\psi}_{2, j}\right\rangle_{\mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right), \mathcal{H}_{w_{2}}^{1}\left(\Psi_{2}\right)}
$$

We note that the characterisation given by this matrix was established in [3, Proposition 6]. What is new here is that we relate the Galerkin matrix representing an operator to its kernel.

Theorem 4.4. Let $1 \leqslant p, q \leqslant \infty, \frac{1}{p}+\frac{1}{q}=1, \Psi_{n} \subset \mathcal{H}_{n}$ be an $\mathcal{A}_{n}$-localised frame, and $w_{n}$ be an $\mathcal{A}_{n}$-admissible weight for $n=1,2$. Then
(i) A linear operator $O: \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{1 / w_{2}}^{p}\left(\Psi_{2}\right)$ is bounded if and only if its kernel $K$ is contained in $\mathfrak{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ or, alternatively, if and only if $k \in \mathfrak{l}_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}(I \times J)$; and in that case

$$
\begin{equation*}
\|O\|_{\mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{1 / w_{2}}^{p}\left(\Psi_{2}\right)} \asymp\|K\|_{\mathfrak{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)}=\|k\|_{1_{1}^{p, \infty}\left(w_{1} \otimes w_{2}\right)}(I \times J), \tag{4.8}
\end{equation*}
$$

(ii) A linear operator $O: \mathcal{H}_{w_{1}}^{p}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right)$ is bounded if and only if its kernel $K$ is contained in $\mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{q, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ or, alternatively, if and only if $k \in \ell_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}(I \times J)$; and in that case

$$
\begin{equation*}
\|O\|_{\mathcal{H}_{w_{1}}^{p}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{w_{2}}^{\infty}\left(\Psi_{2}\right)} \asymp\|K\|_{\mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{q, \infty}}\left(\Psi_{1} \otimes \Psi_{2}\right)=\|k\|_{\ell_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}(I \times J)} . \tag{4.9}
\end{equation*}
$$

Proof. Ad (i): The fact that $O: \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{1 / w_{2}}^{p}\left(\Psi_{2}\right)$ is bounded if and only if $k \in \mathfrak{l}_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}(I \times J)$ was established in [3, Proposition 6, eq. (24)]. To show the second equivalence, we first observe that if $O: \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{1 / w_{2}}^{p}\left(\Psi_{2}\right)$ is bounded, then

$$
\|O f\|_{\mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right)} \leqslant\|O f\|_{\mathcal{H}_{1 / w_{2}}^{p}\left(\Psi_{2}\right)} \lesssim\|f\|_{\mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right)} .
$$

According to Theorem 3.4, there exists a unique kernel $K \in \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ that satisfies (3.7). In particular,
$\left\langle K, \widetilde{\psi}_{1, i} \otimes \widetilde{\psi}_{2, j}\right\rangle_{H_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right), H_{w_{1} \otimes w_{2}}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)}=\left\langle O \widetilde{\psi}_{1, i}, \widetilde{\psi}_{2, j}\right\rangle_{\mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right), \mathcal{H}_{w_{2}}^{1}\left(\Psi_{2}\right)}=k_{i, j}$, which shows that $\|K\|_{\mathfrak{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)}=\|k\|_{\mathfrak{l}_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}(I \times J)}<\infty$ if $O$ is bounded.

If, on the other hand, $K \in \mathfrak{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right) \subset \mathcal{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$, then from Theorem 3.4 we infer that there exists a bounded operator $O: \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \rightarrow$ $\mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right)$ satisfying (3.7). Therefore, we conclude that $\|K\|_{\mathfrak{H}_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}}\left(\Psi_{1} \otimes \Psi_{2}\right)=$ $\|k\|_{\mathfrak{L}_{1 /\left(w_{1} \otimes w_{2}\right)}^{p, \infty}}(I \times J)$ which implies the boundedness of $O: \mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{1 / w_{2}}^{p}\left(\Psi_{2}\right)$.

Ad (ii): The equivalence of the boundedness of the operator and the property of its Galerkin matrix is not explicitly stated in [3, Proposition 6]. This can however be done by essentially using the same arguments as those used in [3, Proposition 6] and applying [40, Proposition 2.4]. The workings of the rest of the proof are similar to those developed in (i) with the only difference that here we can make use the inequalities

$$
\|O f\|_{\mathcal{H}_{1 / w_{2}}^{\infty}\left(\Psi_{2}\right)} \lesssim\|f\|_{\mathcal{H}_{w_{1}}^{p}\left(\Psi_{1}\right)} \leqslant\|f\|_{\mathcal{H}_{w_{1}}^{1}\left(\Psi_{1}\right)}
$$

which ensures the existence of a kernel $K$.

This result allows us to prove that the co-orbit spaces associated with certain mixed norm spaces do not depend on the particular tensor product of localised frames as long as all involved cross-Gram matrices belong to $\mathcal{A}_{n}$.
Corollary 4.5. Let $1 \leqslant p \leqslant \infty, \Psi_{n}, \Phi_{n} \subset \mathcal{H}_{n}$ be $\mathcal{A}_{n}$-localised frames, and $w_{n}$ an $\mathcal{A}_{n}$-admissible weight $n=1,2$. If $G_{\Phi_{n}, \widetilde{\Psi}_{n}} \in \mathcal{A}_{n}$ and $G_{\Psi_{n}, \widetilde{\Phi}_{n}} \in \mathcal{A}_{n}$, $n=1,2$, then $\mathcal{H}_{w_{1} \otimes w_{2}}^{p, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)=\mathcal{H}_{w_{1} \otimes w_{2}}^{p, \infty}\left(\Phi_{1} \otimes \Phi_{2}\right)$ and $\mathfrak{H}_{w_{1} \otimes w_{2}}^{p, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)=$ $\mathfrak{H}_{w_{1} \otimes w_{2}}^{p, \infty}\left(\Phi_{1} \otimes \Phi_{2}\right)$, with their norms being equivalent.

Proof. We shall only prove the former identity as the latter follows from a similar argument. Let $K_{\Psi} \in \mathcal{H}_{w_{1} \otimes w_{2}}^{p, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)$ and $O: \mathcal{H}_{1 / w_{1}}^{p}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{w_{2}}^{\infty}\left(\Psi_{2}\right)$ be the corresponding bounded operator according to Theorem 4.4 (ii). From Proposition 2.7 (ii) we know that $O$ is also a bounded operator mapping $\mathcal{H}_{1 / w_{1}}^{p}\left(\Phi_{1}\right)$ on $\mathcal{H}_{1 / w_{2}}^{\infty}\left(\Phi_{2}\right)$ with equivalent operator norm. Applying Theorem 4.4 (ii) again, we find an element $K_{\Phi} \in \mathcal{H}_{w_{1} \otimes w_{2}}^{p, \infty}\left(\Phi_{1} \otimes \Phi_{2}\right)$ such that

$$
\begin{aligned}
\left\|K_{\Psi}\right\|_{\mathcal{H}_{w_{1} \otimes w_{2}}^{p, \infty}}\left(\Psi_{1} \otimes \Psi_{2}\right) & \asymp\|O\|_{\mathcal{H}_{w_{1}}^{p}\left(\Psi_{1}\right) \rightarrow \mathcal{H}_{w_{2}}^{\infty}\left(\Psi_{2}\right)} \\
& \asymp\|O\|_{\mathcal{H}_{w_{1}}^{p}\left(\Phi_{1}\right) \rightarrow \mathcal{H}_{w_{2}}^{\infty}\left(\Phi_{2}\right)} \asymp\left\|K_{\Phi}\right\|_{\mathcal{H}_{w_{1} \otimes w_{2}}^{p, \infty}\left(\Phi_{1} \otimes \Phi_{2}\right)} .
\end{aligned}
$$

It remains to show that $K_{\Psi}=K_{\Phi}$. This, however, follows from the uniqueness of the kernel in Theorem 4.1 ( $O$ is also bounded as an operator mapping $\mathcal{H}_{1 / w_{1}}^{1}\left(\Phi_{1}\right)$ on $\mathcal{H}_{w_{2}}^{\infty}\left(\Phi_{2}\right)$ and $\mathcal{H}_{w_{1} \otimes w_{2}}^{\infty, \infty}\left(\Psi_{1} \otimes \Psi_{2}\right)=\mathcal{H}_{w_{1} \otimes w_{2}}^{\infty, \infty}\left(\Phi_{1} \otimes \Phi_{2}\right)$ as long as the cross-Gram matrices of $\Psi_{1}$ and $\Phi_{1}$, on the one hand, and $\Psi_{2}$ and $\Phi_{2}$, on the other hand, are contained in $\mathcal{A}_{1}$ and $\mathcal{A}_{2}$ respectively.

Finally, we give a sufficient condition on the kernel to ensure that the corresponding operator is contained in the Schatten- $p$ class.

Proposition 4.6. Let $\mathcal{S}_{p}\left(\mathcal{H}_{1}, \mathcal{H}_{2}\right)$ be the Schatten-p class of operators mapping $\mathcal{H}_{1}$ to $\mathcal{H}_{2}, 1 \leqslant p \leqslant 2$, $\Psi_{n}$ be $\mathcal{A}_{n}$-localised frames for $\mathcal{H}_{n}$ for $n=1,2$, and $O: \mathcal{H}_{1} \rightarrow \mathcal{H}_{2}$ a bounded operator with a kernel $K$. If $K \in \mathfrak{H}^{2, p}\left(\Psi_{1} \otimes \Psi_{2}\right)$, then $O \in \mathcal{S}_{p}\left(\mathcal{H}_{1}, \mathcal{H}_{2}\right)$. In particular, if $K \in \mathcal{H}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)$, then $O$ is a trace class operator.

Proof. From [10, Theorem 17] we know that, if $\left\{\left\|O f_{i}\right\|_{\mathcal{H}_{2}}\right\}_{i \in I} \in \ell^{p}(I)$ for some frame $\left\{f_{i}\right\}_{i \in I} \subset \mathcal{H}_{1}$, then $O \in \mathcal{S}_{p}\left(\mathcal{H}_{1}, \mathcal{H}_{2}\right)$. Using $\Psi_{1}$ as such a frame results in

$$
\begin{aligned}
\sum_{i \in I}\left\|O \tilde{\psi}_{1, i}\right\|_{\mathcal{H}_{2}}^{p} & \asymp \sum_{i \in I}\left(\sum_{j \in J}\left|\left\langle O \tilde{\psi}_{1, i}, \widetilde{\psi}_{2, j}\right\rangle_{\mathcal{H}_{2}}\right|^{2}\right)^{p / 2} \\
& =\sum_{i \in I}\left(\sum_{j \in J}\left|\left\langle K, \widetilde{\psi}_{1, i} \otimes \widetilde{\psi}_{2, j}\right\rangle_{\mathcal{H}_{1} \otimes \mathcal{H}_{2}}\right|^{2}\right)^{p / 2}=\|K\|_{\mathfrak{H}^{2,1}\left(\Psi_{1} \otimes \Psi_{2}\right)}
\end{aligned}
$$

The second statement follows once we set $p=1$ and observe that $\|K\|_{\mathfrak{H}^{2,1}\left(\Psi_{1} \otimes \Psi_{2}\right)} \leqslant$ $\|K\|_{\mathcal{H}^{1,1}\left(\Psi_{1} \otimes \Psi_{2}\right)}$.
