






# Abstracts clustering used in this report

#### The Role of Drought in Index-Based Insurance Demand

Our research on the puzzling low uptake of non-subsidized index-based insurance in developing countries highlights a paradox: increased exposure to drought risk does not always lead to higher demand for insurance among farmers. Our investigation reveals that higher drought frequency can actually reduce demand for index insurance. Through an expected utility model and a field experiment in Burkina Faso involving 205 farmers, we discovered that the demand for insurance exhibits an inverted U-function in relation to drought frequency, and that downside basis risk decreases insurance demand under frequent drought conditions. This finding addresses the scientific and economic challenge of designing effective risk management tools for farmers facing climate variability.


#### Impact of Inventory Credit on Food Security and Agricultural Investment
