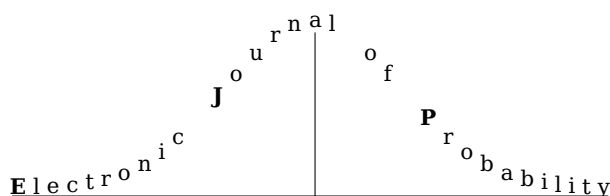

On the asymptotic of the maximal weighted increment of a random walk with regularly varying jumps: the boundary case

Abstract

Let $(X_i)_{i \geq 1}$ be i.i.d. random variables with $E X_1 = 0$, regularly varying with exponent $a > 2$ and $t^a P(|X_1| > t) \sim L(t)$ slowly varying as $t \rightarrow \infty$. We give the limit distribution of $T_n(\gamma) = \max_{0 \leq j < k \leq n} |X_{j+1} + \dots + X_k| (k-j)^{-\gamma}$ in the threshold case $\gamma_a := 1/2 - 1/a$ which separates the Brownian phase corresponding to $0 \leq \gamma < \gamma_a$ where the limit of $T_n(\gamma)$ is $\sigma T(\gamma)$, with $\sigma^2 = E X_1^2$, $T(\gamma)$ is the γ -Hölder norm of a standard Brownian motion and the Fréchet phase corresponding to $\gamma_a < \gamma < 1$ where the limit of $T_n(\gamma)$ is Y_a with Fréchet distribution $P(Y_a \leq x) = \exp(-x^{-a})$, $x > 0$. We prove that $c_n^{-1}(T_n(\gamma_a) - \mu_n)$, converges in distribution to some random variable Z if and only if L has a limit $\tau^a \in [0, \infty]$ at infinity. In such case, there are $A > 0$, $B \in \mathbb{R}$ such that $Z = AV_{a,\sigma,\tau} + B$ in distribution, where for $0 < \tau < \infty$, $V_{a,\sigma,\tau} := \max(\sigma T(\gamma_a), \tau Y_a)$ with $T(\gamma_a)$ and Y_a independent and $V_{a,\sigma,0} := \sigma T(\gamma_a)$, $V_{a,\sigma,\infty} := Y_a$. When $\tau < \infty$, a possible choice for the normalization is $c_n = n^{-1/a}$ and $\mu_n = 0$, with $Z = V_{a,\sigma,\tau}$. We also build an example where L has no limit at infinity and $(T_n(\gamma))_{n \geq 1}$ has for each $\tau \in [0, \infty]$ a subsequence converging after normalization to $V_{a,\sigma,\tau}$.

1 Introduction

Consider a sequence of independent identically distributed (i.i.d.) zero mean random variables $(X_k, k \geq 1)$ and the associated partial sums

$$S_0 = 0, \quad S_n = X_1 + \dots + X_n, \quad n \geq 1.$$

1 Asymptotic properties of various extremal statistics based on the random walk $(S_k, k \geq 0)$ 1
 2 and the random field $(S_k - S_j, 0 \leq j < k \leq n, n \geq 1)$ of its increments are important 2
 3 from both theoretical and practical points of view and have been widely discussed 3
 4 in the literature. We refer to Darling, Erdős [6], Einmahl [8], Bertoin [3], Révész [21] 4
 5 Csörgő and Révész [5], Shao [22], Kabluchko [13], Račkauskas and Suquet[17], and the 5
 6 references therein for a comprehensive information on the subject. 6

7 The main object of this paper is the maximal weighted increment of the random walk 7
 8 $(S_n, n \geq 0)$ defined by 8

$$9 \quad T_n(\gamma) := \max_{0 \leq j < k \leq n} \frac{|S_k - S_j|}{(k - j)^\gamma}, \quad \gamma \in [0, 1]. \quad 9$$

10 Throughout, we denote by X a generic random variable which is identically distributed 10
 11 with each X_k and we assume that X is regularly varying with index $a > 0$, denoted 11
 12 $X \in RV_a$, in the sense that the tail balance condition 12
 13 14

$$15 \quad P(X > x) \sim px^{-a}L(x) \text{ and } P(X \leq -x) \sim qx^{-a}L(x), \text{ as } x \rightarrow \infty, \quad (1.1) \quad 15$$

16 is satisfied, where L is a slowly varying function, and $p, q \in (0, 1), p+q = 1$. We refer to [4] 16
 17 for an encyclopedic treatment of regular and slow variation. For reader's convenience, 17
 18 we gathered in Appendix A.4 the basics on slow variation used in this paper. In what 18
 19 follows, we denote 19
 20

$$21 \quad X \in RV_a(\tau) \text{ if (1.1) holds with } L(x) \xrightarrow{x \rightarrow \infty} \tau^a, \quad 0 \leq \tau \leq \infty. \quad 21$$

22 Condition (1.1) imposes a priori two requirements on the choice of L . First, $x^{-a}L(x)$ has 22
 23 to be equivalent to a nonincreasing function with limit 0 at infinity, which is automatically 23
 24 satisfied, see Cor.A.12. Next, $x^{-a}L(x)$ has to be equivalent to a left continuous function, 24
 25 which discards none slowly varying L since L is always equivalent to a C^∞ function [4, 25
 26 Th.1.3.3]. As L has not necessarily a limit at infinity, see the example built in the proof of 26
 27 Th.2.5, it is clear that 27
 28

$$29 \quad \bigcup_{0 \leq \tau \leq \infty} RV_a(\tau) \subsetneq RV_a. \quad 29$$

30 It is known that the limit distribution of $T_n(\gamma)$ has a threshold at $\gamma = \gamma_a := 1/2 - 1/a$ 30
 31 for $a > 2$, separating two phases named Fréchet and Brownian in the space of parameters 31

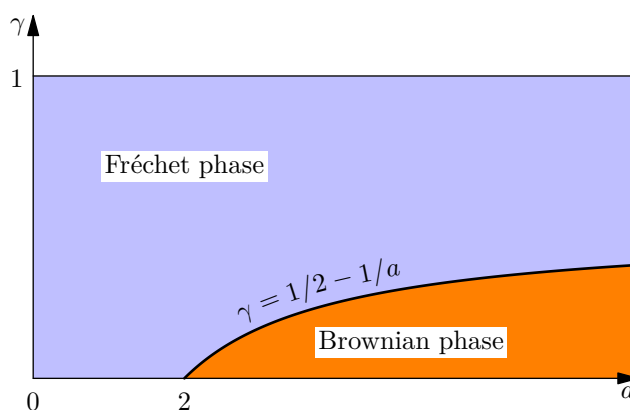


Figure 1: Fréchet and Brownian phases

 32 $\{(a, \gamma); a > 0, 0 < \gamma < 1\}$, see Figure 1. In the Fréchet phase $\gamma \in (\max(1/2 - 1/a, 0), 1]$ 32
 33 and denoting by $\xrightarrow[n \rightarrow \infty]{\mathcal{D}}$ the convergence in distribution, 33
 34

$$35 \quad a_n^{-1}T_n(\gamma) \xrightarrow[n \rightarrow \infty]{\mathcal{D}} Y_a, \quad (1.2) \quad 35$$

36 where Y_a has the standard Fréchet distribution with parameter a , that is 36
 37

$$38 \quad P(Y_a \leq x) = \exp(-x^{-a}), \quad x > 0, \quad (1.3) \quad 38$$

39 and a_n denotes the $1/n$ quantile of $|X|$, that is 39
 40

$$41 \quad a_n := \inf\{x \in \mathbb{R} : P(|X| \leq x) \geq 1 - 1/n\}. \quad (1.4) \quad 41$$

42 This result has been proved in [15]. In the Brownian phase, $0 \leq \gamma < 1/2 - 1/a$ and 42
 43

$$44 \quad n^{-1/2+\gamma}T_n(\gamma) \xrightarrow[n \rightarrow \infty]{\mathcal{D}} \sigma T(\gamma) := \sigma \max_{0 < |t-s| \leq 1} \frac{|W(t) - W(s)|}{|t - s|^\gamma}, \quad (1.5) \quad 44$$

45 where $W = (W(t), t \in [0, 1])$ is a standard Brownian motion and $\sigma^2 = EX^2$. This follows 45
 46 obviously from the Hölderian weak invariance principle proved in [16]. On the threshold 46
 47 $\gamma = \gamma_a$, the limit distribution of $T_n(\gamma_a)$ depends on the slowly varying function $L(x)$ in 47
 48 (1.1) and the following holds: 48
 49
 50
 51
 52

- if $X \in RV_a(\infty)$, the convergence (1.2) holds like in Fréchet phase [12, Th.5(b)];
- if $X \in RV_a(0)$, the convergence (1.5) occurs like in Brownian phase [16].

Our main result for the case where $X \in RV_a(\tau)$, $a > 2$, $0 < \tau < \infty$, Theorem 2.4 below, establishes the convergence

$$n^{-1/a} T_n(\gamma_a) \xrightarrow[n \rightarrow \infty]{\mathcal{D}} V_{a,\sigma,\tau} := \max\{\sigma T(\gamma_a), \tau Y_a, \}, \tag{1.6}$$

where the random variables Y_a and $T(\gamma_a)$ are independent. To unify the notations, we define also

$$V_{a,\sigma,0} := \sigma T(\gamma_a), \quad V_{a,\sigma,\infty} := Y_a. \tag{1.7}$$

Up to now, no analytic formula seems to be known for the distribution of $T(\gamma)$. Fatalov [9] obtained the following exact asymptotic equivalent for the tail:

$$P(T(\gamma) > x) \sim \frac{1}{x} \exp\left(-\frac{x^2}{2}\right) \frac{8\sqrt{2}}{\sqrt{\pi}} \left(\frac{1-\gamma}{1-2\gamma}\right)^2, \quad x \rightarrow \infty, \quad 0 \leq \gamma < 1/2. \tag{1.8}$$

This shows that $V_{a,\sigma,0}$ is subgaussian (hence with light tail).

Baldi and Roynette [1, Th.4.4] have the small ball estimate

$$\lim_{\varepsilon \rightarrow 0} \varepsilon^{2/(1-2\gamma)} \log P(T(\gamma) \leq \varepsilon) = -k(\gamma), \quad 0 < \gamma < 1/2,$$

for some positive constant $k(\gamma)$.

By independence of $T(\gamma_a)$ and Y_a , the distribution function of $V_{a,\sigma,\tau}$ in (1.6) verifies

$$P(V_{a,\sigma,\tau} \leq x) = P(\max\{\sigma T(\gamma_a), \tau Y_a, \} \leq x) = P(\sigma T(\gamma_a) \leq x) \exp(-\tau^a x^{-a}). \tag{1.9}$$

In view of (1.8), this gives for $0 < \tau < \infty$,

$$\begin{aligned} P(V_{a,\sigma,\tau} > x) &= 1 - \exp(-\tau^a x^{-a}) + P(\sigma T(\gamma_a) > x) \exp(-\tau^a x^{-a}) \\ &= \tau^a x^{-a} + O(x^{-2a}), \quad x \rightarrow \infty. \end{aligned} \tag{1.10}$$

Hence $V_{a,\sigma,\tau}$ has a heavy tail asymptotically equivalent to the tail of τY_a .

In the neighborhood of zero we have

$$\lim_{\varepsilon \rightarrow 0} \varepsilon^a \log P(V_{a,\sigma,\tau} \leq \varepsilon) = -\sigma^a k(\gamma_a) - \tau^a.$$

1 Roughly speaking for $0 < \tau < \infty$, $V_{a,\sigma,\tau}$ “interpolates” (in distribution) between $V_{a,\sigma,0}$ 1
 2 and $V_{a,\sigma,\infty}$. In this spirit, one may remark that 2

$$3 \quad P(V_{a,\sigma,\tau} \leq \sigma y) = P(T(\gamma_a) \leq y) \exp\left(\frac{-\tau^a}{\sigma^a y^a}\right) 3$$

$$4 \quad P(V_{a,\sigma,\tau} \leq \tau y) = P\left(T(\gamma_a) \leq \frac{\tau y}{\sigma}\right) \exp(-y^{-a}), 4$$

5 whence 5

$$6 \quad \sigma^{-1}V_{a,\sigma,\tau} \xrightarrow[\tau\sigma^{-1} \rightarrow 0]{\mathcal{D}} T(\gamma_a) \quad \text{and} \quad \tau^{-1}V_{a,\sigma,\tau} \xrightarrow[\tau\sigma^{-1} \rightarrow \infty]{\mathcal{D}} Y_a. 6$$

7 To sum up the case where $X \in \bigcup_{\tau \in [0, \infty]} \text{RV}_a(\tau)$, we have the convergence 7

$$8 \quad b_n^{-1}T_n(\gamma_a) \xrightarrow[n \rightarrow \infty]{\mathcal{D}} V_{a,\sigma,\tau}, \quad \text{with} \quad b_n := \begin{cases} n^{1/a} & \text{if } \tau < \infty, \\ a_n & \text{if } \tau = \infty. \end{cases} \quad (1.11) 8$$

9 Now it is natural to ask what happens if $X \in \text{RV}_a$ but in none $\text{RV}_a(\tau)$. A first answer is 9
 10 provided by Th.2.5 where we build an RV_a distribution for X such that $(b_n^{-1}T_n(\gamma_a))_{n \geq 1}$ 10
 11 does not converge in distribution but has for each $\tau \in [0, \infty]$ a subsequence converging 11
 12 to $V_{a,\sigma,\tau}$. 12

13 Finally, we complete the picture by proving in Th.2.6 that if for some increasing 13
 14 positive sequence $(c_n)_{n \geq 1}$ and a sequence of reals $(\mu_n)_{n \geq 1}$, $c_n^{-1}(T_n(\gamma_a) - \mu_n)$ converges 14
 15 in distribution to some random variable Z then L has a limit $\tau^a \in [0, \infty]$ at infinity, hence 15
 16 $X \in \text{RV}_a(\tau)$, and $Z = AV_{a,\sigma,\tau} + B$ in distribution for some $A > 0, B \in \mathbb{R}$. 16

17 Section 2 contains the statements of our results. Theorem 2.1, Corollary 2.2 and 17
 18 Theorem 2.3, dealing with truncated versions of $T_n(\gamma_a)$ with respect to the length ℓ of 18
 19 increments $S_{k+\ell} - S_k$, are preparatory for Theorem 2.4. 19

20 The proofs are presented in Section 3. Auxiliary material and results are shifted in 20
 21 the Appendix section in the hope to keep a tolerable size of the proofs. 21

22 **2 Statement of results** 22

23 Throughout the paper we will need to split the range of length ℓ of increments 23
 24 $S_{k+\ell} - S_k$ in two or three consecutive intervals. This leads us to introduce the following 24
 25 generic notation for the induced blocs of weighted increments in $T_n(\gamma)$. We set for any 25
 26 real numbers u, v such that $0 \leq u < v \leq n$, 26

$$27 \quad T_n^{u,v}(\gamma) := \max_{u < \ell \leq v} \max_{0 \leq k \leq n-\ell} \frac{|S_{k+\ell} - S_k|}{\ell^\gamma}. \quad (2.1) 27$$

28 As $\gamma = \gamma_a$ almost everywhere in the sequel, we will abbreviate $T_n^{u,v}(\gamma_a)$ as $T_n^{u,v}$. 28

29 From the weak invariance principle in $C[0, 1]$ it follows that for any fixed $0 < \theta < 1$, 29

$$30 \quad n^{-1/a} \sigma^{-1} T_n^{\theta n, n} \xrightarrow[n \rightarrow \infty]{\mathcal{D}} T^{(\theta)}(\gamma) := \max_{\theta < |t-s| \leq 1} \frac{|W(t) - W(s)|}{|t-s|^{\gamma_a}}, \quad (2.2) 30$$

31 see Appendix A.2 for a proof. It is proved in [15] (see Lemma 2.4 there) that for any fixed 31
 32 $d \geq 1$, 32

$$33 \quad n^{-1/a} T_n^{0,d} \xrightarrow[n \rightarrow \infty]{\mathcal{D}} \tau Y_a. \quad (2.3) 33$$

34 Corollary 2.2 and Th. 2.3 below extend (2.2) and (2.3) to the cases where $\theta = \theta_n \rightarrow 0$ 34
 35 and $d = d_n \rightarrow \infty$ as $n \rightarrow \infty$ respectively. 35

36 Theorem 2.1 is used in the paper only through Corollary 2.2 but the more general 36
 37 formulation given here may have its own interest beyond the RV_a setting. 37

Maximal weighted increment asymptotic

Theorem 2.1. Let X be a non degenerate mean zero random variable such that

$$E |X|^b < \infty, \quad \text{for some } b > 2. \tag{2.4}$$

Put $\sigma^2 := E X^2$, $\sigma > 0$. Then for every $0 < \gamma < 1/2$,

$$n^{-1/2+\gamma} T_n^{d_n, n} \xrightarrow[n \rightarrow \infty]{\mathcal{D}} \sigma T(\gamma), \tag{2.5}$$

provided that with $\beta := \min(b, 3)$,

$$\frac{d_n}{n} \xrightarrow[n \rightarrow \infty]{} 0 \quad \text{and} \quad \frac{n^{1-\beta/2} \log^{\beta-1} n}{\left(\frac{d_n}{n}\right)^{\beta\gamma}} \xrightarrow[n \rightarrow \infty]{} 0. \tag{2.6}$$

In particular, the convergences (2.6) are satisfied with $d_n = n^\alpha \lambda(n)$ where λ is slowly varying and $\max\{0; (1 - (1/2 - \gamma)\beta)/(\beta\gamma)\} < \alpha < 1$.

Corollary 2.2. Let X be a non degenerate mean zero random variable whose tail function $P(|X| > x)$ is regularly varying with index $-a$, $a > 2$. Then

$$n^{-1/a} T_n^{d_n, n} \xrightarrow[n \rightarrow \infty]{\mathcal{D}} \sigma T(\gamma_a), \tag{2.7}$$

provided

$$\frac{d_n}{n} \xrightarrow[n \rightarrow \infty]{} 0 \quad \text{and} \quad n^{1-(2+\delta)/a} d_n^{(2+\delta)(1/a-1/2)} \log^{1+\delta} n \rightarrow 0 \quad \text{as } n \rightarrow \infty, \tag{2.8}$$

with $0 < \delta < a - 2$, if $a \leq 3$ and $\delta = 1$ if $a > 3$.

If $d_n = cn^\kappa$ for $n \geq n_0$, then the convergence (2.7) holds if $\kappa \in \left(\frac{2(a-2-\delta)}{(2+\delta)(a-2)}, 1\right)$. The above assumption of regular variation of the tail is obviously satisfied when $X \in \text{RV}_a$ but is more general since we do not require here the tail balance property.

Theorem 2.3. Let $a > 2$ and $0 < \tau < \infty$. Assume that $X \in \text{RV}_a(\tau)$, $E X = 0$ and

$$d_n \rightarrow \infty, \quad \frac{d_n}{n} \rightarrow 0 \quad \text{as } n \rightarrow \infty. \tag{2.9}$$

Then

$$n^{-1/a} T_n^{0, d_n} \xrightarrow[n \rightarrow \infty]{\mathcal{D}} \tau Y_a. \tag{2.10}$$

Theorem 2.4. Let $a > 2$ and $0 < \tau < \infty$. Assume that $X \in \text{RV}_a(\tau)$, $E X = 0$. Then

$$n^{-1/a} T_n(\gamma_a) \xrightarrow[n \rightarrow \infty]{\mathcal{D}} \max\{\sigma T(\gamma_a), \tau Y_a\}, \tag{2.11}$$

where Y_a and $T(\gamma_a)$ are independent random variables, Y_a has Fréchet distribution with parameter a and $T(\gamma_a)$ is defined by (1.5).

Theorem 2.5. There exists a random variable $X \in \text{RV}_a \setminus \bigcup_{\tau \in [0, \infty]} \text{RV}_a(\tau)$ such that the following convergences hold, with limits $V_{a, \sigma, \tau}$ as in (1.6) and (1.7).

i) There is an increasing sequence of integers $(n_i)_{i \geq 1}$ such that

$$n_i^{-1/a} T_{n_i}(\gamma_a) \xrightarrow[i \rightarrow \infty]{\mathcal{D}} \sigma T(\gamma_a) = V_{a, \sigma, 0}. \tag{2.12}$$

ii) For every $\tau \in (0, \infty)$, there is an increasing sequence of integers $(n_i)_{i \geq 1}$ such that

$$n_i^{-1/a} T_{n_i}(\gamma_a) \xrightarrow[i \rightarrow \infty]{\mathcal{D}} \max\{\sigma T(\gamma_a), \tau Y_a\} = V_{a, \sigma, \tau}. \tag{2.13}$$

iii) There is an increasing sequence of integers $(n_i)_{i \geq 1}$ such that $n_i^{-1/a} T_{n_i}(\gamma_a)$ is not stochastically bounded and denoting by a_{n_i} the $1/n_i$ quantile of $|X|$,

$$a_{n_i}^{-1} T_{n_i}(\gamma_a) \xrightarrow{i \rightarrow \infty} Y_a = V_{a,\sigma,\infty}. \tag{2.14}$$

Theorem 2.6. Assume that $X \in RV_a$ with $a > 2$ and $EX = 0$ and there exists an increasing positive sequence $(c_n)_{n \geq 1}$ and a sequence of reals $(\mu_n)_{n \geq 1}$ such that

$$c_n^{-1} (T_n(\gamma_a) - \mu_n) \xrightarrow{n \rightarrow \infty} Z, \tag{2.15}$$

where Z is non degenerate random variable. Then the function L from (1.1) has a limit $\tau^a \in [0, \infty]$ at infinity and there are constants $A > 0, B \in \mathbb{R}$ such that

$$Z \stackrel{d}{=} AV_{a,\sigma,\tau} + B. \tag{2.16}$$

3 Proofs

3.1 Proof of Theorem 2.1

Write

$$T_n^{d_n,n} = \sup_{\ell,k \in I_n} \left| \sum_{j=1}^n X_j \delta_j(\ell, k) \right|,$$

where $I_n = \{(\ell, k) : d_n \leq \ell \leq n, 0 \leq k \leq n - \ell\}$, and

$$\delta_j(\ell, k) := \begin{cases} \ell^{-\gamma}, & \text{if } k + 1 \leq j \leq k + \ell \\ 0 & \text{otherwise.} \end{cases}$$

In what follows, we denote by k_n the number of elements of I_n . It is easily seen that $2k_n = (n - [d_n])(n - [d_n] + 1)$, so $k_n < n^2/2$. Let us choose and fix some enumeration of I_n . Then we introduce for $j = 1, \dots, n$, the random vector

$$X_{n,j} = n^{-1/2+\gamma} (X_j \delta_j(\ell, k), (\ell, k) \in I_n),$$

viewed as a random vector in \mathbb{R}^{k_n} . This leads to the representation

$$n^{-1/2+\gamma} T_n^{d_n,n} = \left\| \sum_{j=1}^{k_n} X_{n,j} \right\|_{\infty},$$

where $\|x\|_{\infty} = \max_{1 \leq i \leq k_n} |x_i|, x = (x_k) \in \mathbb{R}^{k_n}$ and dimension $k_n \leq n^2$.

Let $Y, Y_k, k \geq 1$, be i.i.d. Gaussian random variables, such that $EY = 0, EY^2 = EX^2$. Following Lindeberg method, we substitute step by step each $X_{n,j}$ by $Y_{n,j}$ where $Y_{n,j} = n^{-1/2+\gamma} (Y_j \delta_j(\ell, k), (\ell, k) \in I_n) \in \mathbb{R}^{k_n}$, in order to compare the distribution of $T_n^{d_n,n}$ with that of

$$\widehat{T}_n^{d_n,n} := \max_{d_n < \ell \leq n} \ell^{-\gamma} \max_{0 \leq k \leq n-\ell} |Y_{k+1} + \dots + Y_{k+\ell}| = \left\| \sum_{j=1}^n Y_{n,j} \right\|_{\infty}.$$

To this aim we consider for each $r > 0$ and $\varepsilon > 0$ the function $f_{r,\varepsilon} : \mathbb{R}^{k_n} \rightarrow \mathbb{R}$ which enjoys the following two properties:

(i) for each $x \in \mathbb{R}^{k_n}$,

$$\mathbb{1}\{\|x\|_{\infty} \leq r\} \leq f_{r,\varepsilon}(x) \leq \mathbb{1}\{\|x\|_{\infty} \leq r + \varepsilon\};$$

Maximal weighted increment asymptotic

(ii) the function $f_{r,\varepsilon}$ is three times differentiable and for each $m = 1, 2, 3$, there exists an absolute constant $c_m > 0$ such that, recalling that $k_n + 1 < n^2$,

$$\|f_{r,\varepsilon}^{(m)}\| := \sup\{|f_{r,\varepsilon}^{(m)}(x)(h)^m| : x, h \in \mathbb{R}^{k_n}, \|h\|_\infty \leq 1\} \leq c_m \varepsilon^{-m} \log^{m-1} n.$$

Here $f_{r,\varepsilon}^{(m)}$ denotes the m^{th} derivative of the function $f_{r,\varepsilon}$ and $f_{r,\varepsilon}^{(m)}(x)(h)^m$ the corresponding differential. Such functions are constructed in Bentkus [2].

By using (i), we have

$$\begin{aligned} P(n^{-1/2+\gamma} T_n^{d_n,n} \leq r) &= P\left(\left\|\sum_{j=1}^n X_{n,j}\right\|_\infty \leq r\right) \leq \mathbb{E} f_{r,\varepsilon}\left(\sum_{i=1}^n X_{n,i}\right) \\ &= \Delta(n, \varepsilon) + \mathbb{E} f_{r,\varepsilon}\left(\sum_{i=1}^n Y_{n,i}\right) \\ &\leq \Delta(n, \varepsilon) + P(n^{-1/2+\gamma} \widehat{T}_n^{(d_n)} \leq r + \varepsilon), \end{aligned} \tag{3.1}$$

where

$$\Delta(n, \varepsilon) := \mathbb{E} f_{r,\varepsilon}\left(\sum_{i=1}^n X_{n,i}\right) - \mathbb{E} f_{r,\varepsilon}\left(\sum_{i=1}^n Y_{n,i}\right).$$

Now, we introduce the hybrid sums $Z_{n,j}$ with hole at index j ,

$$Z_{n,j} := \sum_{1 \leq i < j} X_{n,i} + \sum_{j < i \leq n} Y_{n,i}, \quad j = 0, \dots, n, n+1,$$

with the convention $\sum_{i \in \emptyset} := 0$. In particular $\sum_{i=1}^n X_{n,i} = Z_{n,n+1}$ and $\sum_{i=1}^n Y_{n,i} = Z_{n,0}$. Defining $X_{n,0} := 0$ and $Y_{n,n+1} := 0$, we notice also that

$$Z_{n,j} + Y_{n,j} = Z_{n,j-1} + X_{n,j-1}, \quad j = 1, \dots, n+1.$$

With these notations, we can describe the progressive substitution of the $X_{n,j}$'s by the $Y_{n,j}$'s as

$$\begin{aligned} f_{r,\varepsilon}\left(\sum_{i=1}^n X_{n,i}\right) - f_{r,\varepsilon}\left(\sum_{i=1}^n Y_{n,i}\right) &= f_{r,\varepsilon}(Z_{n,n+1}) - f_{r,\varepsilon}(Z_{n,0}) \\ &= \sum_{j=1}^n (f_{r,\varepsilon}(Z_{n,j} + X_{n,j}) - f_{r,\varepsilon}(Z_{n,j-1} + X_{n,j-1})) \\ &= \sum_{j=1}^n (f_{r,\varepsilon}(Z_{n,j} + X_{n,j}) - f_{r,\varepsilon}(Z_{n,j} + Y_{n,j})). \end{aligned} \tag{3.2}$$

whence

$$\Delta(n, \varepsilon) = \sum_{j=1}^n (\mathbb{E} f_{r,\varepsilon}(Z_{n,j} + X_{n,j}) - \mathbb{E} f_{r,\varepsilon}(Z_{n,j} + Y_{n,j})). \tag{3.3}$$

Next we shall use Taylor's expansion

$$f_{r,\varepsilon}(x+h) = f_{r,\varepsilon}(x) + f'_{r,\varepsilon}(x)(h) + 2^{-1} f''_{r,\varepsilon}(x)(h,h) + R \tag{3.4}$$

with interpolated remainder, see Lemma A.1 in Appendix A.1,

$$|R| \leq 6^{2-\beta} \|f''_{r,\varepsilon}\|^{3-\beta} \|f'''_{r,\varepsilon}\|^{\beta-2} \|h\|_\infty^\beta \leq 6^{2-\beta} c_2^{3-\beta} c_3^{\beta-2} \varepsilon^{-\beta} \|h\|_\infty^\beta \log^{\beta-1} n, \tag{3.5}$$

Maximal weighted increment asymptotic

valid for any $2 < \beta \leq 3$. Recalling that $E|X_j|^b < \infty$ for some $b > 2$, we choose from now on $\beta = \min(b, 3)$. For each $j = 1, \dots, n$, the random vectors $Z_{n,j}$ and $X_{n,j}$ of \mathbb{R}^{k_n} are independent and the same holds for $Z_{n,j}$ and $Y_{n,j}$. By Lemma A.2 in Appendix A.1, this implies $E f'_{r,\varepsilon}(Z_{n,j})(X_{n,j}) = (E(f'_{r,\varepsilon}(Z_{n,j}))(E X_{n,j}))$ and similarly with $Y_{n,j}$ instead of $X_{n,j}$. As $X_{n,j}$ and $Y_{n,j}$ have null expectation, this gives

$$E f'_{r,\varepsilon}(Z_{n,j})(X_{n,j}) = E f'_{r,\varepsilon}(Z_{n,j})(Y_{n,j}) = 0. \tag{3.6}$$

As moreover $X_{n,j}$ and $Y_{n,j}$ have the same covariance matrix, Lemma A.3 gives also

$$E f''_{r,\varepsilon}(Z_{n,j})(X_{n,j}, X_{n,j}) = E f''_{r,\varepsilon}(Z_{n,j})(Y_{n,j}, Y_{n,j}). \tag{3.7}$$

Now applying Taylor's formula (3.4) to each term in (3.3) and accounting (3.5) gives

$$|\Delta(n, \varepsilon)| \leq (6^{2-\beta} c_2^{3-\beta} c_3^{\beta-2}) \varepsilon^{-\beta} (\log^{\beta-1} n) \sum_{j=1}^n [E \|X_{n,j}\|_\infty^\beta + E \|Y_{n,j}\|_\infty^\beta].$$

Noticing that $X_{n,j}$ is the product of the (scalar) real random variable X_j by the deterministic vector $(n^{-1/2+\gamma} \delta_j(\ell, k), (\ell, k) \in I_n)$ of \mathbb{R}^{k_n} , it is clear that

$$\|X_{n,j}\|_\infty = n^{-1/2+\gamma} \max_{(\ell,k) \in I_n} \delta_j(\ell, k) |X_j| = n^{-1/2+\gamma} d_n^{-\gamma} |X_j|, \tag{3.8}$$

whence,

$$E \|X_{n,j}\|_\infty^\beta = n^{(-1/2+\gamma)\beta} d_n^{-\beta\gamma} E |X_j|^\beta, \quad E \|Y_{n,j}\|_\infty^\beta = n^{(-1/2+\gamma)\beta} d_n^{-\beta\gamma} E |Y_j|^\beta.$$

Therefore, putting $C_\beta := 6^{2-\beta} c_2^{3-\beta} c_3^{\beta-2} (E |X|^\beta + E |Y|^\beta)$,

$$|\Delta(n, \varepsilon)| \leq C_\beta \varepsilon^{-\beta} n^{1+(-1/2+\gamma)\beta} d_n^{-\beta\gamma} \log^{\beta-1} n = C_\beta \varepsilon^{-\beta} \frac{n^{1-\beta/2} \log^{\beta-1} n}{(\frac{d_n}{n})^{\beta\gamma}}.$$

By condition (2.6), $\Delta(n, \varepsilon) \rightarrow 0$ as $n \rightarrow \infty$ and we find from (3.1), for each $\varepsilon > 0$,

$$\limsup_{n \rightarrow \infty} P(n^{-1/2+\gamma} T_n^{d_n, n} \leq r) \leq \limsup_{n \rightarrow \infty} P(n^{-1/2+\gamma} \widehat{T}_n^{d_n, n} \leq r + \varepsilon). \tag{3.9}$$

From weak invariance principle in Hölder spaces, see [16] and Appendix A.2 below,

$$n^{-1/2+\gamma} \widehat{T}_n^{d_n, n}(\gamma) \xrightarrow[n \rightarrow \infty]{\mathcal{D}} T(\gamma), \tag{3.10}$$

for any sequence d_n such that $d_n/n \rightarrow 0$ as $n \rightarrow \infty$. Since the distribution function of $T(\gamma)$ is continuous, the lim sup in the right-hand side of (3.9) is a true limit equal to $P(T(\gamma) \leq r + \varepsilon)$ and we obtain

$$\limsup_{n \rightarrow \infty} P(n^{-1/2+\gamma} T_n^{d_n, n} \leq r) \leq P(T(\gamma) \leq r + \varepsilon). \tag{3.11}$$

To find a lower bound for $\liminf_{n \rightarrow \infty} P(n^{-1/2+\gamma} T_n^{d_n, n} \leq r)$, we consider $\varepsilon > 0$ such that $0 < \varepsilon < r$ and the function $f_{r-\varepsilon, \varepsilon}$, which gives

$$\begin{aligned} P(n^{-1/2+\gamma} T_n^{d_n, n} \leq r) &= P\left(\left\| \sum_{j=1}^n X_{n,j} \right\|_\infty \leq r\right) \geq E f_{r-\varepsilon, \varepsilon}\left(\sum_{i=1}^n X_{n,i}\right) \\ &= \Delta'(n, \varepsilon) + E f_{r-\varepsilon, \varepsilon}\left(\sum_{i=1}^n Y_{n,i}\right) \\ &\geq -|\Delta'(n, \varepsilon)| + P(n^{-1/2+\gamma} \widehat{T}_n^{d_n, n} \leq r + \varepsilon), \end{aligned}$$

Maximal weighted increment asymptotic

1 where

$$\Delta'(n, \varepsilon) := E f_{r-\varepsilon, \varepsilon} \left(\sum_{i=1}^n X_{n,i} \right) - E f_{r-\varepsilon, \varepsilon} \left(\sum_{i=1}^n Y_{n,i} \right).$$

2
3
4 Acting as above we estimate

$$|\Delta'(n, \varepsilon)| \leq C_\beta \varepsilon^{-\beta} n^{1+(-1/2+\gamma)\beta} d_n^{-\beta\gamma} \log^{\beta-1} n,$$

5
6
7 which gives

$$\liminf_{n \rightarrow \infty} P(n^{-1/2+\gamma} T_n^{d_n, n} \leq r) \geq \liminf_{n \rightarrow \infty} P(n^{-1/2+\gamma} \widehat{T}_n^{d_n, n} \leq r - \varepsilon) = P(T(\gamma) \leq r - \varepsilon).$$

8
9
10 Combining with (3.11) we have

$$\begin{aligned} P(T(\gamma) \leq r - \varepsilon) &\leq \liminf_{n \rightarrow \infty} P(n^{-1/2+\gamma} T_n^{d_n, n} \leq r) \\ &\leq \limsup_{n \rightarrow \infty} P(n^{-1/2+\gamma} T_n^{d_n, n} \leq r) \leq P(T(\gamma) \leq r + \varepsilon). \end{aligned} \tag{3.12}$$

17 Since the distribution function of $T(\gamma)$ is continuous, see the Appendix A.3, the proof is completed by letting $\varepsilon \rightarrow 0$ in (3.12).

21 *Proof of Corollary 2.2.* If the tail function of $|X|$ is regularly varying with index $-a$, $a > 2$, then $E|X|^b < \infty$ for any $0 \leq b < a$. As $a > 2$, we can choose $2 < b < a$ and apply Th.2.2 with $\beta = \min(3, b) = 2 + \delta$ which gives the result. \square

25 **3.2 On L -subsequences**

26 Before presenting the proof of theorems 2.3 and 2.4, it seems convenient to make some remarks on the use of subsequences in this paper. In the first part of our contribution, i.e. until Th. 2.4, we obtain the limiting behavior of $T_n(\gamma_a)$ for $X \in \bigcup_{0 \leq \tau \leq \infty} RV_a(\tau)$. Next we investigate the complementary case where L has no limit at all at infinity. Our main tool is then the exploitation of some L -subsequences versions of all the convergence theorems leading to Th.4, see for instance the subsequence version of Hölderian invariance principle, A.2–Th.A.4. By L -subsequence we mean a subsequence indexed by an infinite subset I of \mathbb{N} , whose construction depends on the asymptotic behavior of L . Our main example is I such that

$$L(n^{1/a}) \xrightarrow[n \rightarrow \infty, n \in I]{} \tau^a, \quad \text{for some } \tau \in [0, \infty]. \tag{3.13}$$

38 The convergence of $(n^{-1/a} T_n(\gamma_a))_{n \in I}$ cannot be inherited from the whole sequence since (3.13) is weaker in general than $X \in RV_a(\tau)$. This announces the tedious task of a careful rereading of the proofs of Th.2.1 to Th.2.4 and also of the convergences results for the special cases $\tau = 0$, $\tau = \infty$ to check if an adaptation to some L -subsequence is possible. In order to minimize such a burden, we will write the forthcoming proofs of the Theorems 2.3 and 2.4 for a generic subsequence indexed by an infinite subset I of \mathbb{N} , replacing the hypothesis $L(x) \rightarrow \tau^a$ by (3.13). Then the proof of the theorem will just be the special case where $I = \mathbb{N}$, where (3.13) is automatically satisfied when $X \in RV_a(\tau)$. The reader interested by the proof of Th. 2.4 only, can ignore the mention $n \in I$ everywhere in the proof. To have minor modifications in the typesetting we adopt the notation $\xrightarrow[n \rightarrow \infty, n \in I]$ which avoids double indexing by n_i .

50 Before proceeding, let us remark that Th.2.1 and Cor.2.2 remain valid for any L -subsequence because they are established under the hypothesis $E|X|^b < \infty$ for some $2 < b < a$ which does not involve L at all.

3.3 Proof of Theorem 2.3

The following auxiliary results are used in the proof.

Lemma 3.1. *Let (Y_i) be a sequence of i.i.d. random variables. Then, for any $b > 0$, $\gamma \geq 0$, $h \geq 1$ and $H \leq n$,*

$$P\left(\max_{h \leq \ell \leq H} \ell^{-\gamma} \max_{0 \leq k \leq n-\ell} \left| \sum_{j=k+1}^{k+\ell} Y_j \right| > b\right) \leq 2 \sum_{n/H \leq 2^j \leq n/h} Q_j,$$

$$Q_j := 2^j P\left(\max_{1 \leq k \leq 2n2^{-j}} \left| \sum_{j=1}^k Y_j \right| > b(n2^{-j})^\gamma\right).$$

This lemma is proved in [15], see Lemma 3.3 therein. The next one extends and completes Lemma 2.4 in [19]. In view of its role in this current work, we provide a detailed proof below.

Lemma 3.2. *Assume that X satisfies for some $a > 1$ and some slowly varying L ,*

$$G(x) := P(|X| > x) \sim x^{-a}L(x), \quad x \rightarrow \infty. \tag{3.14}$$

Denote by a_n the $1 - 1/n$ quantile defined by (1.4) and by $(c_n)_{n \geq 1}$ a nondecreasing sequence of positive reals such that

$$P(|X| > c_n) \sim n^{-1}, \quad n \rightarrow \infty. \tag{3.15}$$

i) *For any $0 < s < a$,*

$$E|X|^s \mathbf{1}_{\{|X| > yc_n\}} \leq \frac{2a}{a-s} c_n^s n^{-1} y^{s-a}, \tag{3.16}$$

for n large enough, uniformly in $y \in [1, \infty)$.

ii) *For any $s > a$,*

$$E|X|^s \mathbf{1}_{\{|X| \leq yc_n\}} \leq \frac{2a}{s-a} c_n^s n^{-1} y^{s-a}, \tag{3.17}$$

for n large enough, uniformly in $y \in [1, \infty)$.

iii) *The inequalities (3.16) and (3.17) remain valid if we replace c_n by $b_n \sim a_n$. Moreover if $(c_n)_{n \geq 1}$ satisfies (3.15), then $c_n \sim a_n$ as $n \rightarrow \infty$.*

iv) *$a_n = n^{1/a}l(n)$ where l is a slowly varying function.*

Proof. By (3.14), $\tilde{L}(x) := x^a G(x) \sim L(x)$ hence \tilde{L} is slowly varying and $G(x) = x^{-a} \tilde{L}(x)$ is regularly varying with exponent $-a$.

To prove i), a Fubini argument gives with the notations G_s and G_s^* defined by (A.19),

$$\begin{aligned} E|X|^s \mathbf{1}_{\{|X| > yc_n\}} &= (yc_n)^s P(|X| > yc_n) + s \int_{yc_n}^\infty t^{s-1} P(|X| > t) dt \\ &= (yc_n)^s G(yc_n) + s G_{s-1}^*(yc_n). \end{aligned} \tag{3.18}$$

By Karamata theorem, see (A.20) in A.4-Th.A.13 with $\lambda = -(s-1-a+1) = a-s > 0$,

$$\frac{G_{s-1}^*(yc_n)}{(yc_n)^s G(yc_n)} \xrightarrow{n \rightarrow \infty} \frac{1}{\lambda} = \frac{1}{a-s}.$$

For $y \geq 1$, $c_n y \geq c_n \rightarrow \infty$, so the above convergence is obviously uniform in $y \in [1, \infty)$. Hence when n tends to infinity,

$$E|X|^s \mathbf{1}_{\{|X| > yc_n\}} \sim \frac{a}{a-s} (yc_n)^s G(yc_n),$$

Maximal weighted increment asymptotic

1 uniformly in $y \in [1, \infty)$. Now since G has regular variation with exponent $-a < 0$,
 2 $G(y c_n) \sim y^{-a} G(c_n)$, uniformly in $y \in [1, \infty)$, see e.g. Th.1.5.2 in [4]. Accounting (3.15),

$$4 \quad \mathbb{E} |X|^s \mathbf{1}_{\{|X| > y c_n\}} \sim \frac{a}{a-s} c_n^s G(c_n) y^{s-a} \sim \frac{a}{a-s} c_n^s n^{-1} y^{s-a}, \quad (3.19)$$

5
 6 uniformly in $y \in [1, \infty)$. Introducing the extra factor 2 to replace this equivalence by an
 7 inequality gives (3.16) valid for n large enough uniformly in $y \in [1, \infty)$.

8 The proof of ii) is completely similar and will be omitted.

9 To prove iii), we note first that an obvious choice is $c_n = a_n$. If we replace c_n by
 10 b_n in the proof of i), everything works identically until the first equivalence in (3.19),
 11 noting that the equivalence $a_n \sim b_n$ implies that b_n tends to infinity. To obtain the second
 12 equivalence in (3.19) leading to (3.16), we note that $L(a_n) \sim L(b_n)$ by A.4-Cor.A.10 ii),

 18 Indeed if F and F_n are the distribution functions of $|X|$ and $\max_{1 \leq k \leq n} |X_k|$, $F_n = F^n$ and
 19 with some function $u(x) \rightarrow 1$ at infinity and for any fixed $x > 0$,

$$20 \quad F_n(c_n x) = (1 - u(c_n x) (c_n x)^{-a} L(c_n x))^n = \exp \left(n \log \left(1 - u(c_n x) \frac{L(c_n x)}{c_n^a x^a} \right) \right).$$

 24 As $n \rightarrow \infty$, $u(c_n x) c_n^{-a} x^{-a} L(c_n x) \sim c_n^{-a} x^{-a} L(c_n) \sim x^{-a} P(|X| > c_n) \sim x^{-a} n^{-1}$, whence
 25 $\lim_{n \rightarrow \infty} F_n(c_n x) = \exp(-x^{-a}) = P(Y_a \leq x)$. Now the weak convergence (3.20) works
 26 with the two sequences of normalizing constants $(c_n)_{n \geq 1}$ and $(a_n)_{n \geq 1}$, so by the conver-
 27 gence of types, see [11, Th.1, 2, p.40–42] or [20, Prop.0.2], there is a constant $A > 0$
 28 such that c_n/a_n converges to 1 and $P(Y_a \leq x) = P(Y_a \leq Ax)$, so $A = 1$, that is $c_n \sim a_n$.

29 To prove iv), we first recall that the left continuous inverse of a non decreasing
 30 function $H(x)$ is $H^{\leftarrow}(y) := \inf\{x : H(x) \geq y\}$. In particular it is easily seen that $a_n =$
 31 $(1/G)^{\leftarrow}(n)$, noticing that the slowly varying L in (3.14) is positive on some neighborhood
 32 of infinity which forbid G to vanish at some real x . Now $1/G(x) = x^a/\tilde{L}(x)$, so $1/G$ varies

$$49 \quad Q_n(h, \varepsilon) := P \left(\max_{h \leq \ell \leq d_n} \ell^{-\gamma_a} \max_{0 \leq k \leq n-\ell} |S_{k+\ell} - S_k| > \varepsilon n^{1/a} \right).$$

1 Until the end of the proof, n belongs to I . Consider the truncated random variables

$$2 \quad X'_i = X_i \mathbb{1}\{|X_i| \leq \tau h^{\gamma_a} n^{1/a}\}, \quad \tilde{X}_i = X'_i - \mathbb{E}(X'_i), \quad i = 1, \dots, n, \quad n \in I$$

3 and the corresponding partial sums

$$4 \quad S'_k = \sum_{i=1}^k X'_i \quad \text{and} \quad \tilde{S}_k = \sum_{i=1}^k \tilde{X}_i, \quad k \geq 1,$$

5 with $S'_0 = \tilde{S}_0 = 0$. From Lemma 3.1, we conclude

$$6 \quad Q_n(h, \varepsilon) \leq P\left(\max_{1 \leq k \leq n} |X_k| \geq \tau h^{\gamma_a} n^{1/a}\right) + P\left(\max_{h \leq \ell \leq d_n} \ell^{-\gamma_a} \max_{0 \leq k \leq n-\ell} |S'_{k+\ell} - S'_k| > \varepsilon n^{1/a}\right)$$

$$7 \quad \leq P\left(\max_{1 \leq k \leq n} |X_k| \geq \tau h^{\gamma_a} n^{1/a}\right) + 2 \sum_{n/d_n \leq 2^j \leq n/h} 2^j Q_{n,j}(h, \varepsilon),$$

8 where

$$9 \quad Q_{n,j}(h, \varepsilon) := P\left(\max_{1 \leq k \leq 2n2^{-j}} |S'_k| > \varepsilon (n2^{-j})^{\gamma_a} n^{1/a}\right).$$

10 Since

$$11 \quad \lim_{n \rightarrow \infty, n \in I} P\left(\max_{1 \leq k \leq n} |X_k| > \tau h^{\gamma_a} n^{1/a}\right) = 1 - \exp(-h^{-\gamma_a}) \xrightarrow{h \rightarrow \infty} 0,$$

12 the proof of (3.22) reduces to

$$13 \quad \lim_{h \rightarrow \infty} \limsup_{n \rightarrow \infty, n \in I} \sum_{n/d_n \leq 2^j \leq n/h} 2^j Q_{n,j}(h, \varepsilon) = 0. \tag{3.23}$$

14 By Lemma 3.2 (i) applied with $c_n = \tau n^{1/a}$, $n \in I$ and noticing that because $\mathbb{E} X = 0$,

$$15 \quad \mathbb{E} X' = \mathbb{E}(X - X \mathbb{1}\{|X| > \tau h^{\gamma_a} n^{1/a}\}) = -\mathbb{E}(X \mathbb{1}\{|X| > \tau h^{\gamma_a} n^{1/a}\}),$$

20 Moreover as $j \leq \log_2(n/h)$, we have $2^{-j} \leq 1 \leq (n2^{-j})^{\gamma_a}$ since $\gamma_a \geq 0$. Hence for h large enough and uniformly in $j \leq \log_2(n/h)$,

Maximal weighted increment asymptotic

1 By Rosenthal inequality,

$$7 \quad = C_p \left(\frac{2}{\varepsilon} \right)^p \left[\sigma^p n^{-p/a} (n2^{-j})^{-\gamma_a p + p/2} + \frac{2a\tau^p}{p-a} n^{-1} h^{\gamma_a(p-a)} (n2^{-j})^{-\gamma_a p + 1} \right],$$

8 where $C_p := (1 - 1/p)^{-p} c_p$ and $\sigma^2 = E X^2$. Hence, recalling that $\gamma_a = 1/2 - 1/a$ and $p > a$, we obtain

$$11 \quad \leq C_p \left(\frac{2}{\varepsilon} \right)^p \left[\frac{2^{p/a}}{2^{p/a} - 2} \sigma^p K_n + \frac{2^{p/2+1} a \tau^p}{(p-a)(2^{p/2} - 2^{p/a})} h^{1-a/2} \right],$$

12 where

$$13 \quad K_n := \sum_{n/d_n \leq 2^j \leq n/h} 2^{-(p/a-1)j}.$$

14 This completes the proof of (3.23) since $K_n \rightarrow 0$ as $n \rightarrow \infty$, $n \in I$, since $d_n/n \rightarrow 0$. \square

15 **3.4 Proof of Theorem 2.4**

16 We proceed as in the proof of Th.2.3 by proving the convergence (2.11) for $X \in RV_a$ and a subsequence indexed by I verifying (3.21). Again, $a_n \sim \tau n^{1/a}$ when $n \rightarrow \infty$, $n \in I$. Throughout the proof, n belongs to I .

17 Choose $d_n = cn^\kappa$ for $n \geq n_0$, with $\kappa \in \left(\frac{2(a-2-\delta)}{(2+\delta)(a-2)}, 1 \right)$ and $0 < \delta < a - 2$ if $a \leq 3$, $\delta = 1$ if $a > 3$. Then $d_n \rightarrow \infty$, $d_n/n \rightarrow 0$ as $n \rightarrow \infty$, $n \in I$ and (2.8) is satisfied. For $1 < h < d_n < n$, recalling the notation (2.1), $T_n(\gamma_a)$ can be expressed as

19 We will use the abbreviations

21 With our choice of d_n , (3.22) is satisfied, see the proof of Th.2.3, hence for any $\varepsilon > 0$,

23 This will enable us to show that $n^{-1/a} T_n(\gamma_a)$ and $n^{-1/a} \max\{T'_n, T''_n\}$ have the same limiting distribution. For the moment, we just note for ulterior use the related inequalities (3.25) and (3.26) below. First we notice that for any $r > 0$,

15 Now we analyse $\max\{T'_n, T''_n\}$. To this aim, introducing the random vectors of \mathbb{R}^h

44 In what follows we use the functions $f_{r,\varepsilon}$ and the random vectors $X_{n,i}, Y_{n,i}, Z_{n,i}$ introduced in the proof of Th. 2.2. We have

$$12 \quad P_{n2}(r, \varepsilon) = \sum_{j=1}^n \mathbb{E} [\mathbb{1}\{N_n(B_r^c) = 0\} - \mathbb{1}\{N_n^{(j)}(B_r^c) = 0\}] [f(Z_{n,j} + X_{n,j}) - f(Z_{n,j} + Y_{n,j})],$$

 24 & \leq C'_\delta \varepsilon^{-2-\delta} d_n^{-\gamma_a} n^{-(2+\delta)/a} (|X_j|^{2+\delta} + |Y_j|^{2+\delta}), \quad m = 1, 2. \\

27 As $\mathbb{1}\{N_n^{(j)}(B^c(x)) = 0\}$ and $X_{n,j}$ are independent, $\mathbb{1}\{N_n^{(j)}(B^c(r)) = 0\}f'(Z_{n,j})$ and $\mathbb{1}\{N_n^{(j)}(B^c(r)) = 0\}f''(Z_{n,j})$ are respectively a random linear form on \mathbb{R}^k and a random bilinear symmetric form on $\mathbb{R}^k \times \mathbb{R}^k$, both independent of $X_{n,j}$. By lemmas A.2 and A.3 in Appendix, recalling that $X_{n,j}$ and $Y_{n,j}$ have the same (null) expectation and covariance matrix, one sees that

 &\leq 3\tau^a (2\mathbb{E} |X_1| r^{-a} + ar^{1-a}) h^{2+a} n^{1/a}, \tag{3.31}

recalling that $a > 2$ and using (i) of Lemma 3.2 with $c_n = \tau n^{1/a}$, $n \in I$. Now (3.29), (3.30) and (3.31) yield

$$\limsup_{n \rightarrow \infty, n \in I} |P_{n2}(r, \varepsilon)| = 0. \tag{3.32}$$

Since the sequences $(X_k)_{k \geq 1}$ and $(Y_k)_{k \geq 1}$ are independent,

$$P_{n3}(r, \varepsilon) = P(N_n(B_r^c) = 0) \mathbb{E} f_{r,\varepsilon} \left(\sum_{i=1}^n Y_{n,i} \right),$$

hence recalling that our choice of d_n enables us to apply the versions of Cor.2.2 and Th.2.3 for the subsequence indexed by I verifying (3.21), we obtain

$$\limsup_{n \rightarrow \infty, n \in I} P_{n3}(r, \varepsilon) = P(\tau Y_a \leq r) P(\sigma T(\gamma_a) \leq r + \varepsilon). \tag{3.33}$$

Collecting (3.27), (3.28), (3.32) and (3.33), we find for any $r > 0$ and $\varepsilon > 0$,

$$\limsup_{n \rightarrow \infty, n \in I} P(n^{-1/a} \max\{T'_n, T''_n\} \leq r) \leq P(\tau Y_a \leq r) P(\sigma T(\gamma_a) \leq r + \varepsilon).$$

Accounting (3.25), this implies for any $r > 0$ and $\varepsilon > 0$,

$$\limsup_{n \rightarrow \infty, n \in I} P(n^{-1/a} T_n^{(\gamma_a)} \leq r) \leq P(\tau Y_a \leq r) P(\sigma T(\gamma_a) \leq r + \varepsilon). \tag{3.34}$$

In a similar way we prove for any $r > 0$ and $0 < \varepsilon < r/2$,

$$\liminf_{n \rightarrow \infty, n \in I} P(n^{-1/a} \max\{T'_n, T''_n\} \leq r - \varepsilon) \geq P(\tau Y_a \leq r - \varepsilon) P(\sigma T(\gamma_a) \leq r - 2\varepsilon).$$

Accounting (3.26), this implies for any $h > 1$, $r > 0$ and $0 < \varepsilon < r/2$,

$$\begin{aligned}
 \liminf_{n \rightarrow \infty, n \in I} P(n^{-1/a} T_n(\gamma_a) \leq r) &\geq P(\tau Y_a \leq r - \varepsilon) P(\sigma T(\gamma_a) \leq r - 2\varepsilon) \\
 &\quad - \limsup_{n \rightarrow \infty, n \in I} P(n^{-1/a} T_n^{h,d_n} > \varepsilon).
 \end{aligned}$$

In this inequality, only the lim sup term depends on h . So letting h tend to infinity we obtain by (3.24)

$$\liminf_{n \rightarrow \infty, n \in I} P(n^{-1/a} T_n(\gamma_a) \leq r) \geq P(\tau Y_a \leq r - \varepsilon) P(\sigma T(\gamma_a) \leq r - 2\varepsilon). \tag{3.35}$$

Finally, gathering (3.34) and (3.35) and using the continuity of the distributions functions of Y_a and $T(\gamma_a)$, we complete the proof by letting $\varepsilon \rightarrow 0$.

1 **3.5 Proof of Theorem 2.5**

2 As a preliminary, we construct a sequence of reals $(m_i)_{i \geq 0}$ increasing to infinity and
 3 a slowly varying function $L = L_a$ such that

4 $\alpha)$ for every $a > 2$, $x^{-a} L_a(x)$ decreases from 1 to 0 on $[m_0, \infty)$;

5 $\beta)$ $L_a(m_{2i})_{i \geq 1}$ increases to infinity and $L_a(m_{2i+1})_{i \geq 0}$ decreases to zero.

6 We start with an arbitrary sequence $(m_i) \uparrow \infty$ on which we will progressively put
 7 some constraints. Choosing $m_0 \geq e^{1/2}$, we define the function $i : [m_0, \infty) \rightarrow \mathbb{N}$ by
 8 $i := \mathbb{1}_{\{m_0\}} + \sum_{i=1}^{\infty} i \mathbb{1}_{(m_{i-1}, m_i]}$, that is

9
$$i(m_0) = 1, \quad i(u) = i \quad \text{if } m_{i-1} < u \leq m_i, \quad i \geq 1.$$

10 Now we define L_a on $[m_0, \infty)$ by

11
$$L_a(x) := m_0^a \exp \left(\int_{m_0}^x \frac{(-1)^{i(u)}}{\log u} \frac{du}{u} \right).$$

12 By A.4-Th.A.11 below, L is clearly a slowly varying function. We can already check $\alpha)$
 13 without additional conditions on $(m_i)_{i \geq 1}$. Obviously $m_0^{-a} L_a(m_0) = 1$. Writing

14
$$x^{-a} = m_0^{-a} \exp \left(\int_{m_0}^x -a \frac{du}{u} \right), \quad x \geq m_0,$$

15 gives

16
$$x^{-a} L_a(x) = \exp \left(\int_{m_0}^x \left(-a + \frac{(-1)^{i(u)}}{\log u} \right) \frac{du}{u} \right).$$

17 For $u \geq e^{1/2}$, $-a + (-1)^{i(u)}/\log u \leq -a + 2 < 0$ which implies the decreasingness of
 18 $x^{-a} L_a(x)$ on $[m_0, \infty)$ and its convergence to 0 at infinity.

19 To find conditions on m_i implying $\beta)$, we note that for $i \geq 2$,

20
$$L_a(m_i) = m_0^a \exp \left(\int_{m_0}^{m_{i-2}} \frac{(-1)^{i(u)}}{\log u} \frac{du}{u} + \int_{m_{i-2}}^{m_{i-1}} \frac{(-1)^{i(u)}}{\log u} \frac{du}{u} + \int_{m_{i-1}}^{m_i} \frac{(-1)^{i(u)}}{\log u} \frac{du}{u} \right)$$

 21
$$= L_a(m_{i-2}) \exp \left((-1)^{i-1} \log \left(\frac{\log m_{i-1}}{\log m_{i-2}} \right) + (-1)^i \left(\frac{\log m_i}{\log m_{i-1}} \right) \right).$$

22 Therefore

23
$$\frac{L_a(m_i)}{L_a(m_{i-2})} = \begin{cases} \frac{\log m_{i-2} \log m_i}{(\log m_{i-1})^2} & \text{if } i \text{ is even,} \\ \frac{(\log m_{i-1})^2}{\log m_{i-2} \log m_i} & \text{if } i \text{ is odd.} \end{cases}$$

24 Hence the increasingness of $L_a(m_{2i})_{i \geq 1}$ as well as the decreasingness of $L_a(m_{2i+1})_{i \geq 0}$
 25 require that $(m_i)_{i \geq 2}$ satisfies the condition

26
$$\frac{\log m_{i-2} \log m_i}{(\log m_{i-1})^2} > 1.$$

27 This means that the sequence $(\log \log m_i)_{i \geq 0}$ has to be strictly convex. A simple choice
 28 satisfying this condition is $\log \log m_i = i^b$, with $b > 1$. In particular with $b = 2$, $m_i =$
 29 $\exp(\exp(i^2))$, since $i^2 + (i - 2)^2 - 2(i - 1)^2 = 2$, we find

30
$$\frac{\log m_{i-2} \log m_i}{(\log m_{i-1})^2} = e^2.$$

Maximal weighted increment asymptotic

1 In this case, $L_a(m_{2i}) \uparrow \infty$, $L_a(m_{2i+1}) \downarrow 0$. The same holds (with less explicit formulas) for
 2 $b \neq 2$ since $i^b + (i-2)^b - 2(i-1)^b = b(b-1) + o(1)$. From now on, we fix $m_i := \exp(\exp(i^2))$,
 3 $i \geq 0$.

4 Next, we choose the distribution of X symmetric such that

$$P(|X| > x) = \begin{cases} 1 & \text{if } x < e, \\ x^{-a} L_a(x) & \text{if } x \geq e. \end{cases}$$

5 Clearly, $X \in \text{RV}_a \setminus \bigcup_{\tau \in [0, \infty]} \text{RV}(\tau)$, $\mathbb{E} X = 0$ and as $a > 2$, $\sigma^2 = \mathbb{E} X^2 < \infty$.

6 To prove i), let us recall that $L_a(m_{2i-1}) \rightarrow 0$ as $i \rightarrow \infty$. Now choose $n_i := \lceil m_{2i-1}^a \rceil$. It
 7 is clear that $n_i^{1/a} \sim m_{2i-1}$ and by A.4–Cor.A.10 ii), one checks that $L_a(n_i^{1/a}) \sim L_a(m_{2i-1})$,
 8 whence $L_a(n_i^{1/a}) \rightarrow 0$ as $i \rightarrow \infty$. Then the convergence (2.12) follows by a continuous
 9 mapping argument from A.2–Th.A.4.

10 To prove ii), we can build the sequence $n_i = n_i(a, \tau)$ as follows. First we note that for
 11 $t \in [m_{2i-1}, m_{2i}]$,

$$L_a(t) = L_a(m_{2i-1}) \exp\left(\int_{m_{2i-1}}^t \frac{1}{\log u} \frac{du}{u}\right)$$

12 whence

$$L_a(t) = \frac{L_a(m_{2i-1})}{\log m_{2i-1}} \log t, \quad t \in [m_{2i-1}, m_{2i}]. \tag{3.36}$$

13 Recalling that $m_i = \exp(\exp(i^2))$, we note also that

$$\frac{m_{2i}}{m_{2i-1}^a} = \exp\left(\exp(4i^2)(1 - a \exp(-4i + 1))\right) > 1, \quad i > \frac{1 + \log a}{4}. \tag{3.37}$$

14 So for $i > (1 + \log a)/4$, $m_{2i-1} < m_{2i-1}^a < m_{2i}$, whence by (3.36),

$$L_a(m_{2i-1}^a) = \frac{L_a(m_{2i-1})}{\log m_{2i-1}} \log(m_{2i-1}^a) = a L_a(m_{2i-1}).$$

15 Therefore $L_a(m_{2i-1}^a)$ tends to 0 as i tends to infinity. As moreover $L_a(m_{2i})$ tends to infinity,
 16 $L_a(m_{2i-1}^a) < \tau^a < L_a(m_{2i})$ for i large enough. Then by increasingness and continuity of
 17 L_a in $[m_{2i-1}^a, m_{2i}]$ there is a unique t_i in (m_{2i-1}^a, m_{2i}) such that $L_a(t_i) = a\tau^a$. Furthermore,
 18 since $t_i > m_{2i-1}^a$, $t_i^{1/a} \in [m_{2i-1}, m_{2i}]$, so by (3.36), $L_a(t_i^{1/a}) = \tau^a$. Now putting $n_i := \lceil t_i \rceil$,
 19 we get by A.4–Cor.A.10 ii) that $\lim_{i \rightarrow \infty} L_a(n_i^{1/a}) = \tau^a$ that is L_a satisfies (3.21). Then we
 20 can apply the subsequence version established in the proof of Th. 2.4 which gives the
 21 convergence in distribution of $n_i^{-1/a} T_{n_i}(\gamma_a)$ to $\max\{\sigma T(\gamma_a), \tau Y_a, \}$.

22 To prove iii), we choose $n_i = \lceil m_{2i} \rceil$. Let us first recall that by [12, Th.10], the sequence
 23 $(n^{-1/a} T_n(\gamma_a))_{n \geq 1}$ is stochastically bounded if and only if $\sup_{t > 0} t^a P(|X| > t)$ is finite.

24 We will adapt the argument given in the proof to prove that $(n_i^{-1/a} T_{n_i}(\gamma_a))_{i \geq 0}$ is not
 25 stochastically bounded. Beforehand, we recall that for $i > (1 + \log a)/4$, $m_{2i}^{1/a} > m_{2i-1}$,
 26 so by (3.36), $L_a(m_{2i}^{1/a}) = a^{-1} L_a(m_{2i})$. This together with the slow variation of L_a and
 27 A.4–Cor.A.10 ii) gives for every $r > 0$

$$L_a(r n_i^{1/a}) \sim L_a(n_i^{1/a}) \sim L_a(m_{2i}^{1/a}) = a^{-1} L_a(m_{2i}) \xrightarrow{i \rightarrow \infty} \infty. \tag{3.38}$$

28 Now assume that $(n_i^{-1/a} T_{n_i}(\gamma_a))_{i \geq 0}$ is stochastically bounded. This implies the stochas-
 29 tic boundedness of $(n_i^{-1/a} \max_{1 \leq k \leq n_i} |X_k|)_{i \geq 0}$, that is

$$\lim_{r \rightarrow \infty} \sup_{i \geq 0} P\left(n_i^{-1/a} \max_{1 \leq k \leq n_i} |X_k| > r\right) = 0. \tag{3.39}$$

Maximal weighted increment asymptotic

1 By independence and identical distribution of the X_k 's and (3.38), for every $r > 0$,

$$\begin{aligned}
 2 \quad P\left(n_i^{-1/a} \max_{1 \leq k \leq n_i} |X_k| > r\right) &= 1 - \left(1 - \frac{L_a(r n_i^{1/a})}{r^a n_i}\right)^{n_i} \\
 3 \quad &= 1 - (1 + o(1)) \exp\left(\frac{-L_a(r n_i^{1/a})}{r^a}\right) \xrightarrow{i \rightarrow \infty} 1,
 \end{aligned}$$

4 whence

$$\sup_{i \geq 0} P\left(n_i^{-1/a} \max_{1 \leq k \leq n_i} |X_k| > r\right) = 1, \quad r > 0,$$

5 which contradicts (3.39). Hence $(n_i^{-1/a} T_{n_i}(\gamma_a))_{i \geq 0}$ is not stochastically bounded.

6 Now let us turn on the proof of the convergence of $a_{n_i}^{-1} T_{n_i}(\gamma_a)$. By A.4-Cor.A.10 ii), $L_a(n_i) \sim L_a(m_{2i})$ which tends to infinity. In [12], Th. 5b) states that if $X \in RV_a(\infty)$, $a_n^{-1} T_n(\gamma_a)$ converges in distribution to Y_a . So we have only to check the adaptation of this theorem for the subsequence indexed by n_i under the weaker assumption $L_a(n_i) \rightarrow \infty$ instead of $L_a(x) \rightarrow \infty$ as $x \rightarrow \infty$. In fact in the original proof of [12, Th. 5b)], including the 3 preliminary lemmas, everything is written under the more general assumption $X \in RV_a$, except the last paragraph starting by "We see that when $a > 2$, (35) and (36) are valid provided that $\lim_{n \rightarrow \infty} a_n^{-1} n^{1/a} = 0 \dots$ ". Therefore everything works when substituting n by n_i until this last paragraph and it remains only to justify the convergence $\lim_{i \rightarrow \infty} a_{n_i}^{-1} n_i^{1/a} = 0$.

7 By (3.37), $m_{2i}^{1/a}/m_{2i-1} \rightarrow \infty$ whence $n_i^{1/a} \in (m_{2i-1}, m_{2i})$ for i large enough and $L_a(n_i^{1/a}) = \frac{1}{a} L_a(n_i)$. Hence

$$n_i P(|X| > n_i^{1/a}) = \frac{1}{a} L_a(n_i) \xrightarrow{i \rightarrow \infty} \infty.$$

8 On the other hand, as $x^{-a} L_a(x)$ is continuous and decreasing on $[m_0, \infty)$,

$$n_i P(|X| > a_{n_i}) = 1.$$

9 Therefore for i large enough $P(|X| > n_i^{1/a}) > P(|X| > a_{n_i})$, whence $n_i^{1/a} < a_{n_i}$. In particular,

$$\lambda := \limsup \frac{n_i^{1/a}}{a_{n_i}} \leq 1.$$

10 Suppose that λ is positive. Then there exists a subsequence (n_{i_j}) of (n_i) such that $n_{i_j}^{1/a}/a_{n_{i_j}} > \lambda/2$, whence

$$1 = n_{i_j} P(|X| > a_{n_{i_j}}) > n_{i_j} P\left(|X| > \frac{2}{\lambda} n_{i_j}^{1/a}\right) \sim \frac{\lambda^a}{a 2^a} L_a(m_{2i_j}) \xrightarrow{j \rightarrow \infty} \infty,$$

11 which is contradictory. Therefore $\lambda = 0$ and the proof of iii) is complete.

12 **3.6 Proof of Theorem 2.6**

13 Assume that $L(x)$ as no limit as $x \rightarrow \infty$. Then

$$\theta^a := \liminf_{x \rightarrow \infty} L(x) < \theta'^a := \limsup_{x \rightarrow \infty} L(x) \tag{3.40}$$

14 and there are two sequences of reals $(t_i)_{i \geq 1}$ and $(t'_i)_{i \geq 1}$ increasing to infinity such that

$$L(t_i) \xrightarrow{i \rightarrow \infty} \theta^a, \quad L(t'_i) \xrightarrow{i \rightarrow \infty} \theta'^a.$$

Maximal weighted increment asymptotic

Now putting $n_i := [t_i^a]$, we note that $n_i^{1/a} \sim t_i$ and by A.4-Cor.A.10 ii),

$$L(n_i^{1/a}) \sim L(t_i) \xrightarrow{i \rightarrow \infty} \theta^a.$$

In the case where $\theta = 0$, then $n_i^{-1/a} T_{n_i}(\gamma_a)$ converges in distribution to $\sigma T(\gamma_a)$ by Th.A.4 and continuous mapping. If $0 < \theta < \infty$, as (3.21) is satisfied by $(n_i)_{i \geq 1}$, the corresponding subsequence version of Th.2.4 gives the weak convergence of $n_i^{-1/a} T_{n_i}(\gamma_a)$ to $V_{a,\sigma,\theta}$. When $\theta' < \infty$, the same argument applied with $n'_i := [t_i^{a'}]$ gives the weak convergence of $n_i^{-1/a} T_{n'_i}(\gamma_a)$ to $V_{a,\sigma,\theta'}$. In the special case where $\theta' = \infty$ we have to modify the definition of n'_i in the following way. As the quantile sequence $(a_n)_{n \geq 1}$ is nondecreasing and tends to infinity, we set $n'_i := \max\{k \geq 1 : a_k \leq t'_i\}$. As $(t'_i)_{i \geq 1}$ is increasing, $(a_{n'_i})_{i \geq 1}$ is nondecreasing and verifies $a_{n'_i} \leq t'_i < a_{1+n'_i}$. As by Lemma 3.2 iv), $a_n = n^{1/a} l(n)$ with l slowly varying, this implies

$$1 \leq \frac{t'_i}{a_{n'_i}} \leq \left(\frac{1+n'_i}{n'_i} \right)^{1/a} \frac{l(1+n'_i)}{l(n'_i)} \xrightarrow{i \rightarrow \infty} 1,$$

so $a_{n'_i} \sim t'_i$ and $L(a_{n'_i}) \rightarrow \infty$. To deduce from this that $a_{n'_i}^{-1} T_{n'_i}(\gamma_a)$ converges to $V_{a,\sigma,\infty}$ it remains only (see the proof of Th. 2.5 iii) to check that $n_i^{1/a} = o(a_{n'_i})$. This follows from $P(|X| > a_{n'_i}) \sim 1/n'_i$ and $P(|X| > a_{n'_i}) \sim L(a_{n'_i}) a_{n'_i}^{-a}$ which give

$$\frac{a_{n'_i}^a}{n'_i} \sim L(a_{n'_i}) \xrightarrow{i \rightarrow \infty} \infty.$$

So we found two nondecreasing sequences of integers $(n_i)_{i \geq 1}$ and $(n'_i)_{i \geq 1}$ such that

$$n_i^{-1/a} T_{n_i}(\gamma_a) \xrightarrow{i \rightarrow \infty} V_{a,\sigma,\theta} \quad \text{and} \quad c_{n_i}^{-1} (T_{n_i}(\gamma_a) - \mu_{n_i}) \xrightarrow{i \rightarrow \infty} Z, \tag{3.41}$$

$$b_{n'_i}^{-1} T_{n'_i}(\gamma_a) \xrightarrow{i \rightarrow \infty} V_{a,\sigma,\theta'} \quad \text{and} \quad c_{n'_i}^{-1} (T_{n'_i}(\gamma_a) - \mu_{n'_i}) \xrightarrow{i \rightarrow \infty} Z, \tag{3.42}$$

where $b_{n'_i} = n_i^{1/a}$ if $\theta' < \infty$, $b_{n'_i} = a_{n'_i}$, the $1 - 1/n'_i$ quantile of X if $\theta' = \infty$. Applying twice the convergence of types theorem, see [11, Th.1, 2,p.40-42] or [20, Prop.0.2], we deduce from (3.41) and (3.42) that there exist constants $\alpha > 0$ and $\beta \in \mathbb{R}$ such that

$$V_{a,\sigma,\theta} \stackrel{d}{=} \alpha V_{a,\sigma,\theta'} + \beta. \tag{3.43}$$

As $P(V_{a,\sigma,\theta} \leq \varepsilon) > 0$ for every $\varepsilon > 0$, see Appendix A.3, it is easily seen that necessarily $\beta = 0$ in (3.43), so we are left with

$$V_{a,\sigma,\theta} \stackrel{d}{=} \alpha V_{a,\sigma,\theta'}. \tag{3.44}$$

Now we check the impossibility of the inequality in (3.40) by examining the following cases.

- $\theta = 0 < \theta' \leq \infty$. Then (3.44) is impossible because $V_{a,\sigma,0}$ has a subgaussian tail by (1.8), while $\alpha V_{a,\sigma,\theta'}$ has an heavy tail equivalent to $(\alpha\theta')^a x^{-a}$ when $0 < \theta' < \infty$ by (1.10) or to $\alpha^a x^{-a}$ when $\theta' = \infty$.
- $0 < \theta < \theta' < \infty$. Looking again at the tails we see by (1.10) that necessarily $\theta = \alpha\theta'$, which reformulates (3.44) as

$$V_{a,\sigma,\theta} \stackrel{d}{=} \frac{\theta}{\theta'} V_{a,\sigma,\theta'}. \tag{3.45}$$

Maximal weighted increment asymptotic

Noticing that for every $x > 0$,

$$\begin{aligned} P\left(\frac{\theta}{\theta'} V_{a,\sigma,\theta'} \leq x\right) &= P\left(\frac{\theta}{\theta'} \max(\sigma T(\gamma_a), \theta' Y_a) \leq x\right) \\ &= P\left(\sigma \frac{\theta}{\theta'} T(\gamma_a) \leq x\right) P(\theta Y_a \leq x), \end{aligned}$$

we see by comparison with (1.9) that necessarily,

$$\frac{\theta}{\theta'} T(\gamma_a) \stackrel{d}{=} T(\gamma_a).$$

It is elementary to check that if a non negative random variable T non degenerated to 0 has the same distribution as cT for some constant c then $c = 1$. Therefore when $0 < \theta < \theta'$, (3.44) is impossible.

- $0 < \theta < \infty = \theta'$. Then (3.44) is equivalent to

$$P(\sigma T(\gamma_a) \leq x) P(\theta Y_a \leq x) = P(\alpha Y_a \leq x), \quad x > 0,$$

which we can rewrite as

$$P(\sigma T(\gamma_a) \leq x) = \exp\left(\frac{\theta^a - \alpha^a}{x^a}\right) =: G(x), \quad x > 0. \tag{3.46}$$

Now if $\theta > \alpha$, G is not a distribution function. If $\theta = \alpha$, $G(x) = 1$ for every $x > 0$ which is clearly not true for the left-hand side of (3.46). If $\theta < \alpha$, G is the distribution function of a Fréchet distribution with scale parameter $(\alpha^a - \theta^a)^{1/a}$ hence heavy tailed while the d.f. in the left-hand side of (3.46) is subgaussian, so (3.46) is false. Finally in this third case (3.44) cannot be true.

To conclude we have proved that $\theta = \theta'$, i.e. that $L(x)$ has a limit $\tau^a \in [0, \infty]$ when x tends to infinity. By [16], [12, Th.5b)] and Th.2.4, $b_n^{-1} T_n(\gamma_a)$ converges in distribution to $V_{a,\sigma,\tau}$ where b_n is defined as in (3.42). By the convergence of types theorem applied to the whole sequence we obtain that $c_n \sim A b_n$ for some positive constant A . This shows that the only possible limits in distribution of $T_n(\gamma_a)$ under affine normalisation are the random variables $Z = AV_{a,\sigma,\tau} + B$, $A > 0$, $B \in \mathbb{R}$.

A Appendix

A.1 Taylor expansions and Lindeberg method

The following special Taylor expansion is useful when applied to functions of random variables having moments of order $r \in [2, 3)$. We applied it in the proofs of Th. 2.2 and Th. 2.4 to the functions $f = f_{r,\varepsilon}$ constructed by Bentkus, denoted φ in [2, Th.2], which are C^∞ .

Lemma A.1. *Let E be a Banach space and $f : E \rightarrow \mathbb{R}$ be a C^3 map with bounded Fréchet second and third derivatives in the sense that*

$$\|f^{(m)}\| := \sup\{\|f^{(m)}(x)\| : x \in E\} < \infty, \quad m = 2, 3,$$

where $\|f^{(m)}(x)\|$ is the operator norm of the m -linear form $f^{(m)}(x) : E^m \rightarrow \mathbb{R}$, that is

$$\|f^{(m)}(x)\| := \sup\{|f^{(m)}(x)(h_1, \dots, h_m)| : \|h_i\|_E \leq 1, i = 1, \dots, m\}.$$

Then for any $x, h \in E$,

$$f(x+h) = f(x) + f'(x)(h) + \frac{1}{2} f''(x)(h, h) + R, \tag{A.1}$$

where the remainder term $R = R(f, x, h)$ satisfies for $2 < \beta \leq 3$,

$$|R| \leq 6^{2-\beta} \|f''\|^{3-\beta} \|f'''\| \|\beta-2\| \|h\|_E^\beta. \tag{A.2}$$

1 *Proof.* By Taylor formula at the order 2 with integral remainder, 1

$$2 \quad f(x+h) = f(x) + f'(x)(h) + \frac{1}{2}f''(x)(h,h) + \int_0^1 \frac{(1-t)^2}{2} f'''(x+th)(h,h,h) dt, \quad 2$$

3 whence $R := f(x+h) - f(x) - f'(x)(h) - \frac{1}{2}f''(x)(h,h)$ is bounded by 3

$$4 \quad |R| \leq \frac{1}{6} \|f'''\| \|h\|_E^3. \quad 4$$

5 The Taylor formula at the order 1 with integral remainder provides another bound for R . 5
 6 Indeed 6

$$7 \quad f(x+h) = f(x) + f'(x)(h) + \int_0^1 (1-t)f''(x+th)(h,h) dt \quad 7$$

$$8 \quad = f(x) + f'(x)(h) + \frac{1}{2}f''(x)(h,h) + \int_0^1 (1-t)(f''(x+th) - f''(x))(h,h) dt, \quad 8$$

9 which leads to 9

$$10 \quad |R| \leq \|f''\| \|h\|_E^2. \quad 10$$

11 The bound (A.3) seems preferable for “small” values of $\|h\|_E$, while (A.4) can be privileged for “large” values of $\|h\|_E$. More formally, for an arbitrary parameter $t > 0$ to be 11
 12 precised later and $2 < \beta \leq 3$, we get the bound 12

$$13 \quad |R| \leq \begin{cases} \frac{1}{6} \|f'''\| \|h\|_E^\beta t^{3-\beta} & \text{if } \|h\|_E \leq t, \\ \|f''\| \|h\|_E^\beta t^{2-\beta} & \text{if } \|h\|_E > t. \end{cases} \quad 13$$

14 To unify these two bounds, we remark that for $a, b > 0$, $at^{3-\beta} = bt^{2-\beta}$ for $t = b/a$. With 14
 15 $a = \frac{1}{6} \|f'''\|$ and $b = \|f''\|$, this choice of t gives (A.2). \square 15

16 Before providing the justifications of (3.6) and (3.7), we need to introduce some 16
 17 notations. For $m \geq 1$, we denote by $\mathcal{L}_m(\mathbb{R}^k, \mathbb{R})$ the space of m -linear forms on $(\mathbb{R}^k)^m$. A 17
 18 norm $\|x\|$ being choosen in \mathbb{R}^k , we denote by $\|g\|_m^*$ the corresponding operator norm of 18
 19 $g \in \mathcal{L}_m(\mathbb{R}^k, \mathbb{R})$, that is 19

$$20 \quad \|g\|_m^* := \sup\{|g(x_1, \dots, x_m)| : x_i \in \mathbb{R}^k, \|x_i\| \leq 1, i = 1, \dots, m\}. \quad 20$$

21 As we work with finite dimensional spaces, Pettis and Bochner integrals coincide and we 21
 22 say that a random element in \mathbb{R}^k or in $\mathcal{L}_m(\mathbb{R}^k, \mathbb{R})$ is integrable if its norm is an integrable 22
 23 random variable in the usual sense. 23

24 **Lemma A.2.** Let f' be a measurable map from \mathbb{R}^k into its dual $\mathcal{L}_1(\mathbb{R}^k, \mathbb{R})$ and X and 24
 25 Z be two independent random vectors in \mathbb{R}^k . Assume moreover that X and $f'(Z)$ are 25
 26 integrable. Then $f'(Z)(X)$ is an integrable real random variable and 26

$$27 \quad E(f'(Z)(X)) = (E f'(Z))(E X). \quad 27$$

28 According to its order of apparition in (A.5), the expectation symbol E denotes 28
 29 successively the expectation of a real valued random variable, of a random linear form 29
 30 on \mathbb{R}^k (or random element in $\mathcal{L}_1(\mathbb{R}^k, \mathbb{R})$) and of a random vector in \mathbb{R}^k . 30

31 *Proof.* Denote by $P_{(Z,X)}$, P_X and P_Z the respective distributions of (Z, X) , X and Z . By 31
 32 independence of Z and X , $P_{(Z,X)}$ is the product measure $P_Z \otimes P_X$. The real valued 32
 33 random variable $f'(Z)(X)$ is integrable since 33

$$34 \quad E|f'(Z)(X)| \leq E(\|f'(Z)\|_1^* \|X\|) = E\|f'(Z)\|_1^* E\|X\| < \infty, \quad 34$$

1 by independence and integrability of X and $f'(Z)$. This legitimates the use of Fubini 1
 2 theorem to obtain 2

$$\begin{aligned}
 3 \quad \mathbb{E}(f'(Z)(X)) &= \int_{\mathbb{R}^k \times \mathbb{R}^k} f'(z)(x) \, dP_{(Z,X)}(z, x) = \int_{\mathbb{R}^k \times \mathbb{R}^k} f'(z)(x) \, dP_Z \otimes P_X(z, x) & 3 \\
 4 &= \int_{\mathbb{R}^k} \int_{\mathbb{R}^k} f'(z)(x) \, dP_X(x) \, dP_Z(z) & 4 \\
 5 &= \int_{\mathbb{R}^k} \mathbb{E}(f'(z)(X)) \, dP_Z(z) & 5 \\
 6 &= \int_{\mathbb{R}^k} f'(z)(\mathbb{E} X) \, dP_Z(z) & 6 \\
 7 &= (\mathbb{E} f'(Z))(\mathbb{E} X), & 7 \\
 8 & & 8 \\

14 recalling that if $g = f'(z)$ is a linear form on \mathbb{R}^k and $\mathbb{E} \|X\| < \infty$, $g(X)$ is integrable and 14
 15 $\mathbb{E} g(X) = g(\mathbb{E} X)$. So (A.5) is established. \square 15

16 **Lemma A.3.** Let f'' be a measurable map from \mathbb{R}^k into $\mathcal{L}_2(\mathbb{R}^k, \mathbb{R})$ and X, Y and Z are 16
 17 random vectors in \mathbb{R}^k such that 17

- 18 a) X and Y are square integrable ($\mathbb{E} \|X\|^2, \mathbb{E} \|Y\|^2 < \infty$), $\mathbb{E} X = \mathbb{E} Y = 0$; 18
- 19 b) X and Y have the same covariance matrix; 19
- 20 c) X and Z are independent, Y and Z are independent; 20
- 21 d) $f''(Z)$ is integrable ($\mathbb{E} \|f''(Z)\|_2^* < \infty$). 21

22 Then 22

$$23 \quad \mathbb{E}(f''(Z)(X, X)) = \mathbb{E}(f''(Z)(Y, Y)). \tag{A.6} 23$$

24 *Proof.* As $f''(z)$ is a bilinear form on \mathbb{R}^k for each $z \in \mathbb{R}^k$, it admits the representation 24
 25

$$26 \quad f''(z)(x, y) = \sum_{i,j=1}^k a_{i,j}(z) x_i y_j, \quad x = (x_1, \dots, x_k), \quad y = (y_1, \dots, y_k) 26$$

27 and the integrability of $f''(Z)$ implies the integrability of the k^2 random variables $a_{i,j}(Z)$ 27
 28 because $a_{i,j}(Z) = f''(Z)(e_i, e_j)$ where e_1, \dots, e_k denotes the canonical basis of \mathbb{R}^k . Writ- 28
 29 ing $X = (X_1, \dots, X_k)$ and $Y = (Y_1, \dots, Y_k)$, we see that 29

$$30 \quad \mathbb{E}(f''(Z)(X, X)) = \mathbb{E} \left(\sum_{i,j=1}^k a_{i,j}(Z) X_i X_j \right) = \sum_{i,j=1}^k (\mathbb{E} a_{i,j}(Z)) (\mathbb{E} X_i X_j), 30$$

31 where the last equality uses the square integrability of X which gives the integrability of 31
 32 $X_i X_j$, the integrability of $a_{i,j}(Z)$ and the independence of X and Z . Obviously the same 32
 33 equality holds substituting X by Y and we conclude by b). \square 33

34 **A.2 On the use of invariance principles** 34

35 *Proof of (2.2).* We introduce first some notations. 35

 36 \quad D_\theta &:= \{(s, u) \in [0, 1]^2; 0 \leq s < s + u \leq 1, \theta < u \leq 1\}, & 36 \\
 37 \quad \overline{D}_\theta &:= \{(s, u) \in [0, 1]^2; 0 \leq s < s + u \leq 1, \theta \leq u \leq 1\}, & 37 \\
 38 \quad D_{n,\theta} &:= \left\{ \left(\frac{k}{n}, \frac{\ell}{n} \right) \in D_\theta; k, \ell \in \mathbb{N} \right\}, \quad n \geq 1. & 38 \\
 39 & & 39 \\

3 and define the functionals g and $g_n, C[0, 1] \rightarrow \mathbb{R}_+$ by

$$4 \quad g(x) := \sup_{(s,u) \in D_\theta} \tilde{x}(s, u), \quad g_n(x) := \sup_{(s,u) \in D_{n,\theta}} \tilde{x}(s, u).$$

5 We note that g is Lipschitzian hence continuous on $C[0, 1]$ because it satisfies the inequalities $g(x+y) \leq g(x) + g(y)$, and $0 \leq g(x) \leq 2\theta^{-\gamma_a} \|x\|_\infty, x, y \in C[0, 1]$.

6 Finally we denote by ξ_n the Donsker Prohorov polygonal partial sums processes, that is the random polygonal line $\{\xi_n(t), t \in [0, 1]\}$ with vertices the points $(k/n, S_k)$, with $S_0 := 0$. The weak invariance principle in $C[0, 1]$ states that $n^{-1/2}\sigma^{-1}\xi_n$ converges in distribution to the standard Brownian motion W in the space $C[0, 1]$. By continuous mapping, this implies

$$7 \quad g(n^{-1/2}\sigma^{-1}\xi_n) \xrightarrow[n \rightarrow \infty]{\mathcal{D}} g(W) = T^{(\theta)}(\gamma) = \max_{\theta < |t-s| \leq 1} \frac{|W(t) - W(s)|}{|t-s|^{\gamma_a}}. \quad (A.7)$$

8 Recalling that $\gamma_a = 1/2 - 1/a$, we notice that

$$9 \quad n^{-1/a}\sigma^{-1}T_n^{n\theta,n} = g_n(n^{-1/2}\sigma^{-1}\xi_n), \quad (A.8)$$

10 so the weak convergence of $n^{-1/a}\sigma^{-1}T_n^{n\theta,n}$ to $T^{(\theta)}(\gamma)$ will follow from (A.7) if we prove that $g(n^{-1/2}\sigma^{-1}\xi_n) - g_n(n^{-1/2}\sigma^{-1}\xi_n)$ converges to zero in probability.

11 In what follows, it is convenient to endow $[0, 1]^2$ with the distance

$$12 \quad d((s, u), (s', u')) =: \max(|s - s'|, |u - u'|).$$

13 By continuity of \tilde{x} on $\overline{D_\theta}$ and density of D_θ in $\overline{D_\theta}$, $\sup_{D_\theta} \tilde{x} = \sup_{\overline{D_\theta}} \tilde{x}$ and by compactness of $\overline{D_\theta}$ this supremum is reached at some $(s_0, u_0) \in \overline{D_\theta}$. Hence

$$14 \quad g(x) = \tilde{x}(s_0, u_0).$$

15 It is easily checked that for the distance $d, D_{n,\theta}$ is a $1/n$ net in $\overline{D_\theta}$ in the sense that for any point $(s, u) \in \overline{D_\theta}$ there is a point of $D_{n,\theta}$ at a d distance at most $1/n$ of (s, u) . So we can construct a sequence $((s_n, u_n))_{n \geq 1}$ such that

$$16 \quad (s_n, u_n) \in D_{n,\theta} \quad \text{and} \quad d((s_n, u_n), (s_0, u_0)) \leq \frac{1}{n}, \quad n \geq 1.$$

17 Denoting by $\omega(x, \delta) := \sup\{|x(t) - x(s)|; |t - s| \leq \delta, s, t \in [0, 1]\}$, the modulus of uniform continuity of x , we get the following estimates valid for any $x \in C[0, 1]$.

$$18 \quad \begin{aligned} \tilde{x}(s_0, u_0) &\leq \frac{1}{u_0^{\gamma_a}} \left(|x(s_n + u_n) - x(s_n)| + 2\omega\left(x, \frac{2}{n}\right) \right) \\ &\leq \frac{|x(s_n + u_n) - x(s_n)|}{u_0^{\gamma_a}} + 2\theta^{-\gamma_a}\omega\left(x, \frac{2}{n}\right) \\ &= \left(\frac{u_n}{u_0}\right)^{\gamma_a} \frac{|x(s_n + u_n) - x(s_n)|}{u_n^{\gamma_a}} + 2\theta^{-\gamma_a}\omega\left(x, \frac{2}{n}\right) \\ &\leq \left(1 + \frac{1}{nu_0}\right)^{\gamma_a} g_n(x) + 2\theta^{-\gamma_a}\omega\left(x, \frac{2}{n}\right) \\ &\leq \left(1 + \frac{1}{n\theta}\right)^{\gamma_a} g_n(x) + 2\theta^{-\gamma_a}\omega\left(x, \frac{2}{n}\right), \end{aligned}$$

Maximal weighted increment asymptotic

1 Applied with any path of the random element $n^{-1/2}\sigma^{-1}\xi_n$ in $C[0, 1]$ and recalling that
 2 $g_n(x) \leq g(x)$, this gives

$$\begin{aligned}
 3 \quad 0 \leq g(n^{-1/2}\sigma^{-1}\xi_n) - g_n(n^{-1/2}\sigma^{-1}\xi_n) &\leq \left(\left(1 + \frac{1}{n\theta}\right)^\gamma - 1 \right) g(n^{-1/2}\sigma^{-1}\xi_n) \\
 4 &+ 2\theta^{-\gamma a} \omega\left(n^{-1/2}\sigma^{-1}\xi_n, \frac{2}{n}\right)
 \end{aligned}$$

8 As the sequence $(n^{-1/2}\sigma^{-1}\xi_n)_{n \geq 1}$ is tight on $C[0, 1]$, its image by the continuous functional
 9 g is tight on \mathbb{R}_+ , that is $g(n^{-1/2}\sigma^{-1}\xi_n)$ is bounded in probability. Moreover the tightness
 10 of $(n^{-1/2}\sigma^{-1}\xi_n)_{n \geq 1}$ implies the convergence in probability to 0 of $\sup_{n \geq 1} \omega(n^{-1/2}\sigma^{-1}\xi_n, \delta)$
 11 as δ tends to 0. This implies that $\omega(n^{-1/2}\sigma^{-1}\xi_n, 2/n)$ tends to 0 in probability as n tends
 12 to infinity. All this gives

$$13 \quad g_n(n^{-1/2}\sigma^{-1}\xi_n) = g(n^{-1/2}\sigma^{-1}\xi_n) + o_P(1).$$

15 Recalling (A.7) and (A.8), this proves the convergence in distribution of $n^{-1/a}\sigma^{-1}T_n^{\theta n, n}$
 16 to $T^{(\theta)}(\gamma_a)$. □

18 *Proof of (3.10).* We use the Hölderian functional central limit theorem (or Hölderian
 19 weak invariance principle) in the space $\mathcal{H}_\gamma^\circ[0, 1]$ which is defined for any $0 < \gamma < 1$ as
 20 follows. We denote by $\mathcal{H}_\gamma^\circ[0, 1]$ the space of continuous functions x on $[0, 1]$ such that

$$22 \quad \omega_\gamma(x, \delta) := \sup_{\substack{0 < t-s \leq \delta \\ s, t \in [0, 1]}} \frac{|x(t) - x(s)|}{(t-s)^\gamma} \xrightarrow{\delta \rightarrow 0} 0.$$

25 Endowed with the norm $\|x\|_\gamma := |x(0)| + \omega_\gamma(x, 1)$, $\mathcal{H}_\gamma^\circ[0, 1]$ is a separable Banach space.

26 Let $(Y_k)_{k \geq 1}$ be the Gaussian i.i.d. sequence introduced in the proof of Th.2.2. Putting
 27 $\widehat{S}_j := \sum_{i=1}^j Y_i$ with the convention $\widehat{S}_0 := 0$, we denote by $\widehat{\xi}_n$ the associated polygonal
 28 partial sums process, that is the random polygonal line $\{\widehat{\xi}_n(t), t \in [0, 1]\}$ with vertices
 29 the points $(k/n, \widehat{S}_k)$, $k = 0, 1, \dots, n$. As Y_1 has finite moments of all orders, it follows
 30 from the functional central limit theorem proved in [16] that $n^{-1/2}\sigma^{-1}\widehat{\xi}_n$ converges in
 31 distribution in $\mathcal{H}_\gamma^\circ[0, 1]$ to the standard Brownian motion W for every $0 < \gamma < 1/2$. In
 32 particular it converges in $\mathcal{H}_{\gamma_a}^\circ[0, 1]$. It seems worth noticing here that $n^{-1/2}\sigma^{-1}\xi_n$, the
 33 polygonal partial sums process built on the sequence $(X_k)_{k \geq 1}$, does not converge in
 34 $\mathcal{H}_{\gamma_a}^\circ[0, 1]$. Indeed this convergence requires that $\lim_{t \rightarrow \infty} t^a P(|X_1| > t) = 0$, while in the
 35 setting of Th. 2.2, this limit is $\tau^a > 0$.

36 As the γ -Hölder norm of a polygonal line is reached at two vertices, see e.g. Lemma
 37 3 in [14], we obtain by continuous mapping,

$$38 \quad \|n^{-1/2}\sigma^{-1}\widehat{\xi}_n\|_{\gamma_a} = n^{-1/a}\sigma^{-1}\widehat{T}_n^{0, n}(\gamma_a) \xrightarrow[n \rightarrow \infty]{\mathcal{D}} T(\gamma_a). \tag{A.9}$$

41 So to prove (3.10), it suffices to prove that $n^{-1/a}\sigma^{-1}(\widehat{T}_n^{0, n}(\gamma_a) - \widehat{T}_n^{d_n, n}(\gamma_a))$ converges to
 42 0 in probability if d_n/n tends to 0. To this aim we remark that

$$\begin{aligned}
 43 \quad 0 \leq n^{-1/a}\sigma^{-1}(\widehat{T}_n^{0, n}(\gamma_a) - \widehat{T}_n^{d_n, n}(\gamma_a)) &\leq n^{-1/a}\sigma^{-1} \max_{\substack{0 < \ell \leq d_n \\ 0 \leq k \leq n-\ell}} \frac{|\widehat{S}_{k+\ell} - \widehat{S}_k|}{\left(\frac{\ell}{n}\right)^{\gamma_a}} \\
 44 &\leq \omega_{\gamma_a}\left(n^{-1/a}\sigma^{-1}\widehat{\xi}_n, \frac{d_n}{n}\right). \tag{A.10}
 \end{aligned}$$

48 By Th.13 b) in [23], the tightness in $\mathcal{H}_{\gamma_a}^\circ[0, 1]$ of $(n^{-1/a}\sigma^{-1}\widehat{\xi}_n)_{n \geq 1}$, which results from its
 49 convergence in distribution in this space, implies for every positive ε that

$$51 \quad \lim_{\delta \rightarrow 0} \sup_{n \geq 1} P(\omega_{\gamma_a}(n^{-1/a}\sigma^{-1}\widehat{\xi}_n, \delta) > \varepsilon) = 0.$$

1 This in turn, implies when $d_n/n \rightarrow 0$, that

$$2 \quad \omega_{\gamma_a} \left(n^{-1/a} \sigma^{-1} \widehat{\xi}_n, \frac{d_n}{n} \right) \xrightarrow[n \rightarrow \infty]{P} 0, \quad 3$$

4 which accounting (A.9) and (A.10), completes the proof. □ 5

6 **Theorem A.4.** Let $(X_k)_{k \geq 1}$ be i.i.d. with

$$7 \quad P(|X_1| > x) = x^{-a} L(x), \quad x > 0, \quad 8 \quad (A.11)$$

9 with $a > 2$ and L slowly varying, $E X_1 = 0$, $\sigma^2 = E X_1^2$. Let ξ_n be the polygonal process
10 built on the partial sums of $(X_k)_{k \geq 1}$. Assume that for some increasing sequence of
11 integers $(n_i)_{i \geq 1}$,

$$12 \quad L(n_i^{1/a}) \xrightarrow[i \rightarrow \infty]{} 0. \quad 13 \quad (A.12)$$

14 Then $n_i^{-1/2} \xi_{n_i}$ converges weakly to σW in the Hölder space $\mathcal{H}_{\gamma_a}^o$, where $\gamma_a = 1/2 - 1/a$. 15

16 *Proof.* We refer to [16] where the Lamperti invariance principle is proved for the whole
17 sequence $n^{-1/2} \xi_n$ under the assumption $\lim_{x \rightarrow \infty} x^a P(|X_1| > x) = 0$, that is in our
18 notations $\lim_{x \rightarrow \infty} L(x) = 0$. 19

20 The convergence of finite dimensional distributions follows from the assumption $a > 2$
21 and does not involve L . Before looking at the tightness, we note that

$$22 \quad \forall t > 0, \quad n_i P(|X_1| > t n_i^{1/a}) \xrightarrow[i \rightarrow \infty]{} 0. \quad 23 \quad (A.13)$$

24 Indeed, putting $x = t n_i^{1/a}$ in (A.11) gives $n_i P(|X_1| > t n_i^{1/a}) = t^{-a} L(t n_i^{1/a})$ and as L is
25 slowly varying, $L(t n_i^{1/a}) \sim L(n_i^{1/a})$ which tends to zero by assumption (A.12). 26

27 Now for the tightness, following step by step the proof exposed in [16], with the same
28 notations, we obtain first

$$29 \quad P_2(n_i, \varepsilon) \leq n_i P\left(|X_1| \geq \frac{\varepsilon}{2} n_i^{1/a}\right). \quad 30$$

31 This upper bound tends to 0 by (A.13). The same works for

$$32 \quad P_{1,2}(J, n_i, \varepsilon) \leq n_i P\left(|X_1| \geq \frac{\varepsilon}{6} n_i^{1/a}\right). \quad 33$$

34 The hard part of the proof is the treatment of $P_{1,1}(J, n_i, \varepsilon)$ where the X_k are truncated
35 at the level $\delta n_i^{1/a}$. Everything around the use of Rosenthal inequality works replacing
36 n by n_i , except maybe the control of the moments of the truncated variables $\widetilde{X}_k =$
37 $X_k \mathbb{1}\{|X_k| \leq \delta n_i^{1/a}\}$ which can be achieved by the following adaptations. 38

39 Since $E X_1 = 0$, $E \widetilde{X}_1 = -E X_1 \mathbb{1}\{|X_1| > \delta n_i^{1/a}\}$. By a Fubini argument,
40

$$41 \quad E\left(|X_1| \mathbb{1}\{|X_1| > \delta n_i^{1/a}\}\right) = \delta n_i^{1/a} P(|X_1| > \delta n_i^{1/a}) + \int_{\delta n_i^{1/a}}^{\infty} P(|X_1| > s) ds. \quad 42$$

43 The first term in the right-hand side above tends to 0 by (A.13). To treat the second term,
44 we cannot use here $\sup_{s>0} s^a P(|X_1| > s) < \infty$ like in [16], but we can exploit the slow
45 variation of L (which was not supposed in [16]). Indeed by Karamata A.4-Th.A.13,
46

$$47 \quad \int_{\delta n_i^{1/a}}^{\infty} s^{-a} L(s) ds \sim \frac{1}{a-1} \delta n_i^{1/a} (\delta n_i^{1/a})^{-a} L(\delta n_i^{1/a}) \sim \frac{1}{a-1} \delta^{1-a} n_i^{1/a-1} L(n_i^{1/a}). \quad 48$$

49 Since $L(n_i^{1/a}) \rightarrow 0$, there is a constant c such that $E|\widetilde{X}_k| \leq c \delta^{-a+1} n_i^{-1+1/a}$, like in [16].
50

Maximal weighted increment asymptotic

The other truncated moment we have to take care of is $E|\widetilde{X}_k^q|$, for $q > a$. We use again Karamata theorem and slow variation of L as follows.

$$\begin{aligned} E|\widetilde{X}_k^q| &\leq \int_0^{\delta n_i^{1/a}} u^{q-1} P(|X_1| > u) du = \int_0^{\delta n_i^{1/a}} u^{q-a-1} L(u) du \\ &\sim \frac{1}{q-a} \delta n_i^{1/a} (\delta n_i^{1/a})^{q-a-1} L(\delta n_i^{1/a}) \\ &\sim \frac{1}{q-a} \delta^{q-a} n_i^{q/a-1} L(n_i^{1/a}). \end{aligned}$$

As $L(n_i^{1/a})$ tends to zero, one can again find a constant c such that $E|\widetilde{X}_k^q| \leq c\delta^{q-a} n_i^{q/a-1}$ like in [16].

There is no other modification to do in the proof presented in [16]. □

A.3 Continuity of the distribution function of $T(\gamma)$

Here we justify the continuity of the distribution function $F(r) = P(\|W\|_\gamma \leq r)$ for $0 < \gamma < 1/2$.

Let us check first the continuity at $r = 0$. Since obviously $F(r) = 0$ for $r < 0$ and F is right continuous everywhere, this continuity is equivalent to $F(0) = 0$. As $\omega_\gamma(x, 1) = 0$ implies that $x(1) = x(0)$,

$$F(0) = P(\|W\|_\gamma = 0) \leq P(W(1) - W(0) = 0) = 0,$$

since $W(1) - W(0)$ is standard normal distributed.

Next we claim that $F(r) > 0$ for every $r > 0$. To see this, it may be convenient to use the equivalent Ciesielski's sequential norm $\|W\|_\gamma^{\text{seq}}$ built on the weighted dyadic second differences of W , see e.g. [18]. In particular, for $0 < \gamma < 1/2$, there is a positive constant c_γ such that $\|W\|_\gamma^{\text{seq}} \geq c_\gamma \|W\|_\gamma$. By [18, Th.4.1], the distribution function of $\|W\|_\gamma^{\text{seq}}$ is

$$G(t) := P(\|W\|_\gamma^{\text{seq}} \leq t) = \text{erf}(2^{-1/2}t) \prod_{j=1}^{\infty} \{\text{erf}(2^{j(1/2-\gamma)}t)\}^{2^{j-1}}, \quad t > 0, \tag{A.14}$$

where $\text{erf } t := \frac{2}{\sqrt{\pi}} \int_0^t \exp(-s^2) ds$ and the support of the distribution of $\|W\|_\gamma^{\text{seq}}$ is $[0, \infty)$ because $\lim_{j \rightarrow \infty} j^{1/2} 2^{j(\gamma-1/2)} = 0$. In particular $G(t) > 0$ for every $t > 0$. Applying this with $t = c_\gamma r$, $r > 0$, we obtain

$$0 < P(\|W\|_\gamma^{\text{seq}} \leq c_\gamma r) \leq P(\|W\|_\gamma \leq r),$$

that is $F(r) > 0$ for every $r > 0$.

To establish the continuity of F on $(0, \infty)$, we use the following Ehrhard's theorem.

Theorem A.5 ([7, Th.3.3]). *Let (E, μ) be a Gauss space: E is a locally convex Hausdorff space and μ a Gaussian Radon measure on E ; for any A, B convex Borelian subsets of E and every $u \in (0, 1)$, it holds*

$$(\Phi^{-1} \circ \mu)(uA + (1-u)B) \geq u(\Phi^{-1} \circ \mu)(A) + (1-u)(\Phi^{-1} \circ \mu)(B), \tag{A.15}$$

where $\Phi^{-1} : (0, 1) \rightarrow \mathbb{R}$ is the inverse map of $\Phi : t \mapsto \Phi(t) := \frac{1}{\sqrt{2\pi}} \int_{-\infty}^t \exp(-s^2/2) ds$.

Applying (A.15) to A and B closed balls with center 0 in $\mathcal{H}_\gamma^c[0, 1]$ gives the concavity of the function $\Phi^{-1}(F(r))$ on $(F^{\leftarrow}(0), \infty)$ where $F^{\leftarrow}(0) := \inf\{r \in \mathbb{R} : F(r) > 0\}$. As seen above, $F^{\leftarrow}(0) = 0$, so this concavity implies the continuity of $\Phi^{-1} \circ F$ hence also of F on the open interval $(0, \infty)$. As moreover F is continuous at 0, the continuity of F on \mathbb{R} is established.

A.4 Slow variation

We gathered here some properties of slow variation used in the paper.

Definition A.6. Let L be a positive measurable function, defined in some neighborhood $[A, \infty)$ of infinity and satisfying

$$\lim_{x \rightarrow \infty} \frac{L(cx)}{L(x)} = 1, \quad \forall c > 0. \tag{A.16}$$

Then L is said to be slowly varying.

Remark A.7. Every measurable function equivalent to a slowly varying function when x tends to infinity is itself slowly varying on some $[B, \infty)$.

Proposition A.8 (Prop.1.3.6 in [4]). *i) If L varies slowly, so does $(L(x))^a$ for every $a \in \mathbb{R}$.*

ii) If L varies slowly and $a > 0$, then $L(x^a)$ varies slowly.

iii) If L_1, L_2 , vary slowly, so do $L_1 + L_2, L_1L_2$ and $\frac{L_1}{L_2}$.

iv) If L_1, \dots, L_k , vary slowly and $R(x_1, \dots, x_k)$ is a rational fraction with positive coefficients, $R(L_1(x), \dots, L_k(x))$ varies slowly.

Theorem A.9 (uniform convergence theorem [4, Th.1.2.1]). *If L varies slowly, then for every compact subset K of $(0, \infty)$,*

$$\frac{L(cx)}{L(x)} \xrightarrow{x \rightarrow \infty} 1, \quad \text{uniformly in } c \in K. \tag{A.17}$$

Corollary A.10. *i) If L_1 and L_2 vary slowly and $\lim_{x \rightarrow \infty} L_2(x) = \infty$, then $L_1 \circ L_2$ varies slowly.*

ii) If L varies slowly and f verifies $\inf_{x \geq B} f(x) > 0, \sup_{x \geq B} f(x) < \infty$, then $L(xf(x)) \sim L(x)$ and varies slowly.

Theorem A.11 (representation theorem [4, Th.1.3.1]). *The function L is slowly varying if and only if it may be written in the form*

$$L(x) = c(x) \exp \left\{ \int_A^x \frac{\varepsilon(u)}{u} du \right\}, \quad x \geq A, \tag{A.18}$$

for some $A > 0$, where c, ε are measurable functions with c positive, $c(x) \rightarrow C \in (0, \infty)$, $\varepsilon(u)/u$ is locally integrable on $[A, \infty)$ and $\varepsilon(x) \rightarrow 0$ as $x \rightarrow \infty$.

Corollary A.12. *If L varies slowly, then for every positive real $a, x^a L(x)$ is equivalent to a function which increases ultimately to infinity and $x^{-a} L(x)$ equivalent to a function which decreases ultimately to 0.*

A positive measurable function G defined on some neighborhood $[A, \infty)$ ($A \geq 0$) of infinity and satisfying for some real p and every $y > 0$,

$$\frac{G(xy)}{G(x)} \xrightarrow{x \rightarrow \infty} y^p,$$

is said regularly varying (at infinity) with exponent p . In the special case where $p = 0, G$ is slowly varying. It is easily seen that each regularly varying function G with exponent p can be written as $G(x) = x^p L(x)$ where L is slowly varying.

Assuming for notational simplicity that $A = 0$ and that G is locally bounded and regularly varying with exponent p , let us define for r real,

$$G_r(x) = \int_0^x y^r G(y) dy, \quad G_r^*(x) = \int_x^\infty y^r G(y) dy. \tag{A.19}$$

Maximal weighted increment asymptotic

Theorem A.13 (Karamata [10, Th.1, p.281]). For G regularly varying with exponent p ,

i) if $G_r^*(x)$ is finite (for some and then for every positive x),

$$\frac{x^{r+1}G(x)}{G_r^*(x)} \xrightarrow{x \rightarrow \infty} \lambda = -(r + p + 1) \geq 0; \tag{A.20}$$

ii) if $r \geq -p - 1$, then

$$\frac{x^{r+1}G(x)}{G_r(x)} \xrightarrow{x \rightarrow \infty} \lambda = r + p + 1. \tag{A.21}$$
