1 **Thermoregulation and thermal sensation during whole-body water immersion at**
2 **different water temperatures in healthy individuals: A scoping review.**

Abstract

15 **Background**

16 Severe thermal discomfort may increase risk of drowning due to hypothermia or
17 hyperthermia from prolonged exposure to noxious water temperatures. The
18 importance of using a behavioral thermoregulation model with thermal sensation may
19 predict the thermal load that the human body receives when exposed to various
20 immersive water conditions. However, there is no thermal sensation "gold standard"
21 model specific for water immersion. This scoping review aims to present a
22 comprehensive overview regarding human physiological and behavioral
23 thermoregulation during whole-body water immersion and explore the feasibility for
24 an accepted defined sensation scale for cold and hot water immersion.

26 **Methods**

27 A standard literary search was performed on PubMed, Google Scholar, and SCOPUS.
28 The words "Water Immersion," "Thermoregulation," "Cardiovascular responses"
29 were used either as independent searched terms and MeSH terms (Medical Subject
30 Headings) or in combination with other text words. The inclusion criteria for clinical
31 trials terms to thermoregulatory measurements (core or skin temperature), whole-body
32 immersion, 18-60 years old and healthy individuals. The prementioned data were
33 analyzed narratively to achieve the overall study objective.

35 **Results**

36 Twenty-three published articles fulfilled the review inclusion/exclusion criteria (with
37 nine measured behavioral responses). Our outcomes illustrated a homogenous thermal
38 sensation in a variety of water temperatures ranges, that was strongly associated with
39 thermal balance, and observed different thermoregulatory responses. This scoping
40 review highlights the impact of water immersion duration on human thermoneutral
41 zone, thermal comfort zone, and thermal sensation.

43 Conclusion

44 Our findings enlighten the significance of thermal sensation as a health indicator for
45 establishing a behavioral thermal model applicable for water immersion. This scoping
46 review provides insight for the needed development of subjective thermal model of
47 thermal sensation in relation to human thermal physiology specific to immersive
48 water temperature ranges within and outside the thermal neural and comfort zone.

53 1. Introduction

54 Extreme environmental conditions during whole-body water immersion increases
55 the risk of dangerously high and low body temperatures, in which thermosensation
56 and feelings of euphoria/dysphoria are important indicators of thermal load for
57 physicians since early times (Galen, *De Sanitate Tuenda*; Calthrop 1928). Thermal
58 injuries occur in extreme ranges of water conditions, that are dependent on water
59 temperature and immersion duration, that can cause injuries such as frostbites, burns,
60 and drowning (Kappel et al., 1997; Fujishima, 1986; Nimmo, 2004; An et al., 2019;
61 Tipton et al., 2017). The first defense against maintaining normal body temperature
62 and preventing thermal injuries from the external environment is behavioral
63 thermoregulation via skin thermoreceptors and perceptual feelings, that signal the
64 brain to behaviorally thermoregulate. These behaviors include moving environmental
65 location such as escaping from a hot or cold pool or changing clothes, increasing fluid
66 intake, and self-selecting intensity of swimming work rate (Flouris and Schlader,
67 2015; Guéritée et al., 2014). *Thermal perception* is defined as the mental state of how

68 a person experiences ambient temperature and is composed of two basic elements:
69 thermal sensation and thermal comfort (Lv et al., 2017; Flouris and Schlader, 2015).
70 The thermal sensation is the conscious state of distinguishing hot and cold stimuli,
71 while thermal comfort is the mental state related to ambient temperature satisfaction
72 (Aizawa, 2019; Chatonnet and Cabanac, 1965; Olausson et al., 2005; Lv et al., 2017;
73 Flouris and Schlader, 2015). Therefore, a major emphasis should be given to thermal
74 perception as a dominant behavioral driver for health and aquatic safety because it
75 could be used to prevent the dangerous thermal loads that a human body receives in a
76 variety of environmental conditions (Hayasaka et al., 2010). However, the current
77 models of thermal sensation and comfort relate to ambient conditions. There is a
78 current gap in knowledge on how these relate to immersion in hot or cold water
79 temperatures.

80 The thermal subjective evaluation involves a common neurophysiological
81 mechanism. While current understanding of whether transient receptor potential ion
82 channels (TRP) are thermostats or thermosensors, it is widely accepted that TRPs play
83 a key role in thermoregulation for humans and other mammals (Kobayashi, 2015; Li,
84 2017, Romanovsky, 2007; Tan and Knight, 2018; Wang and Siemens, 2015). In
85 general, the heat signal transduction through skin TRPs to specific brain regions
86 controls many physiological and cognitive functions (Flouris and Schlader, 2015;
87 Romanovsky, 2007; Wang and Siemens, 2015). Some of the TRPs are implicated in
88 temperature sensation, thermoregulation, and metabolism, in which body and skin
89 temperature are the primary inputs to mediate cutaneous vasodilation and
90 vasoconstriction. In the case of TRPM8 ion channels, their reaction depends either on
91 the initial vascular tone or on the release of vasopressor or vasorelaxant transmitters
92 such as norepinephrine, neuropeptide Y, and nitric oxide (NO) (either from sensory
93 neurons or endothelial cells) (Charkoudian, 2010; Johnson et al., 2009; Pan et al.,
94 2018).

95 Specifically, water immersion triggers both thermal and tactile sensation, in a
96 unique manner, altering the tone and electrical activity of the somatosensory cortex, in
97 which its action is to recognize the quality of thermal stress (Aizawa, 2019; Lv et al.,
98 2017; Nimmo, 2004). However, it remains unknown how thermal perception in water
99 is similar or different to over large variations of air temperature spectrums.

100 Under steady-state ambient conditions, it is well understood that thermal comfort
101 zone (TCZ) (ASHRAE 55, 2013), defined as the perception and state of mind that

102 expresses satisfaction within the thermal environment, is within a temperature range
103 known as the thermoneutral zone (TNZ) (Glossary of terms for thermal physiology,
104 1987). However, an increased functional metabolic rate higher than basal rate or an
105 exposure in a non-uniform environment may alter the broadening of the TCZ (Zhang
106 et al, 2010; Kingma et al., 2014, 2017). The TNZ is the zone described as the
107 temperatures where heat is lost without regulatory changes in basal metabolic heat
108 production or evaporative heat loss; this zone is deemed equal to heat gain in respect
109 to the basic law of thermodynamics (Eq. 1) (Pallubinsky et al., 2019; Shapiro and
110 Epstein, 1984; Epstein and Moran, 2006). Notably, TCZ and TNZ share the same goal
111 for preserving body temperature, where skin and core temperature dictate the ranges,
112 but behavioral regulation is modified outside the TCZ, and autonomic regulation is
113 active outside the TNZ. (Kingma et al., 2014). Moreover, the upper and lower limits
114 of TNZ are affected by complex interactions of vasomotor, metabolic rate, body
115 insulation, sex, acclimatization, and microclimate (Pallubinsky et al., 2019; Kingma et
116 al., 2014; Scweiker et al., 2018). The TCZ for ambient air temperatures has been
117 described to be between 28 and 30°C and the TNZ are between 28 and 32 °C for a
118 naked person (Hardy and Dubois, 1938). It is important to highlight that most of the
119 literature on the TCZ and TNZ has been studied in various ambient air conditions.
120 Only one study has reported a very narrow range in TNZ during 60 min of immersion
121 in water temperature between 35.0 and 35.5 °C (Craig and Dvorak, 1968).

124 **Eq. 1** reflects the mathematical expression that describes the rate of change of body
125 heat (gain or loss) (S) of the human body based on the First Law of Thermodynamics.
126 Expressed in watts [W]. M = metabolic rate; W = mechanical work rate; K =
127 conductive heat transfer; R = radiant heat exchange; C = convective heat transfer.
128 Respiratory heat dissipation is determined by (C_{res} – E_{res}) expressing the water loss
129 form respiratory tract where C_{res} = dry respiration heat loss; E_{res} = latent respiratory
130 heat loss; E = heat loss by evaporation of sweat.

132 During exposure to water immersion, only the lower critical temperature limit
133 (LCT), and not the upper critical temperature limit (UPL), is utilized for the critical
134 water temperature (CWT), and also derived from the critical air temperature as
135 mentioned in the Scholander's classical theory of TNZ (Wakabayashi et al., 2008;

136 Rennie et al., 1962). CWT reflects a water temperature between 28-34°C, in which a
137 nude man can tolerate a 3hr prolonged water immersion without appearing shivering-
138 thermogenesis (Rennie et al., 1962). According to Yermakova's biophysical model,
139 this neutral spot is in view with a 35°C mean skin temperature and agrees with other
140 related articles (Shapiro and Epstein, 1984; Fanger, 1970; Tipton et al., 2017). Due to
141 the 25 times higher thermal conductivity of water, the thermoneutral point for water
142 has been reported to be near ~34°C; however for ambient air, it is ~30°C (Dogaru and
143 Radulescu, 2015; Yermakova et al., 2013; Nadel et al., 1971; Kingma et al., 2017).
144 Hence, the thermoneutral aquatic equilibrium may differ among different concepts of
145 thermoneutrality (CWT vs Biophysical model). However, based on the data available,
146 the thermoneutral zone for water is unknown, as UPL remains unspecified, and may
147 also differ from immersion duration and ambient air TNZ. Additionally, most data on
148 the TNZ are based on small animals' physiological responses; however, few studies
149 have examined both human physiological (i.e., core and shell temperature) and
150 behavioral parameters (i.e., thermal perception) (Pallubinsky et al., 2019; Kingma et
151 al., 2014; Schweiker et al., 2018), but more understanding is needed in the context of
152 water exposure.

153 A common practice for assessing subjective perception is using thermal scales
154 (Lee et al., 2010; Lundgren et al., 2014; Schweiker et al., 2017). Many challenges
155 regarding the constructions and use of such a scale need to be addressed including the
156 unit change of scale and vocabulary selection may be influenced by language and
157 culture (Auliciems, 1981; Lee et al., 2009, 2010; Tochiara et al., 2012; Pantavou,
158 2020; Schweiker et al., 2017). In general, people are unable to recognize more than
159 seven levels of sensations without error (Miller, 1967). Therefore, ASHRAE 55
160 (2013) incorporates a seven-point thermal sensation scale and a four-point thermal
161 comfort scale as introduced by Gagge (1967). Another overlooked barrier is that the
162 central thermal sensation descriptors located below or above thermoneutral mark may
163 cause confusion by users (Peña Fernández et al., 2019; Schweiker et al., 2017). Thus,
164 semantics and connotations, which characterize a thermal scale or thermal concept,
165 may "lead" to errors in interpretation of specific words or phrases with the same
166 meaning, and likelihood to make invalid logical assumptions (Auliciems, 1981;
167 Cabanac 1988, 2020; Schweiker et al., 2020). These errors may reduce the accuracy
168 of using thermal comfort models as they relate to body and skin temperatures (Jacquot
169 et al., 2014; Cheng et al., 2012; Zhao et al., 2021).

170 The major question is if *the criteria are objectively or subjectively set to define the*
171 *water temperature as cold or warm and are they related to the thermoregulation of*
172 *the human body during whole-body immersion in healthy individuals?* Water
173 temperature classifications have numerous landmarks (climatology, human
174 physiology), in which the body temperature is the primary benchmark in the domain
175 of Medical Hydrology – Balneology (see Table 1) (Castany, 1963; Pentecost et al.,
176 2003, 2005; Thurner, 1967; Kappelmeyer and Haenel, 1974; Messina et al., 1999;
177 Varga, 2010). A similar attempt was made by spa specialists, who vaguely
178 synthesized a more complex thermal classification based on thermal subjective
179 judgment (Table 2), whose practicality recommended exclusively for educational
180 purposes in the domain of Balneology and Hydrotherapy (Ledo, 1996). No “gold
181 standard” thermal sensation scale exists to correlate with water and body
182 temperatures. Most importantly, no water temperature scale has considered that
183 thermosensitivity and thermal perception are time-dependent variables.

184 The main purpose of this study was to provide an overview of thermoregulation
185 and thermal feelings during whole-body water immersion, taking into account the
186 current state of knowledge of human thermoregulatory (skin temperature, core
187 temperature, sweating, shivering thermogenesis, cardiovascular system) and
188 neurocognitive responses (thermosensitivity, thermal sensation). We attempted to
189 clarify the thermal dose effect of hydrotherapy, and evaluated the literature on water
190 duration immersion water temperatures. We chose the scoping review as the most
191 suitable method for a deeper understanding of the logic behind thermal sensation and
192 physiological homeostasis with the aim of examining the feasibility of determining
193 scales related to water as cold or warm (Auliciems, 2014).

194

195 **2. Methods**

196 The approach was a mixed method scoping literature review as referred by Arksey
197 and O'Malley (2005). The central research inquiry was human thermoregulatory
198 responses (e.g., core temperature, skin temperature, thermal subjective assessment)
199 during whole-body water immersion. The main outcome was to outline thermal
200 sensation scales, in a variety of water temperatures and reviewing references
201 temperatures for colder or warmer air and water temperatures. PRISMA-ScR
202 checklist was completed (Table 3).

203 **2.1 Inclusion & exclusion criteria**

204 The target sample included healthy individuals between 18-60 years old. The
205 inclusion criteria for clinical trials in relation to thermoregulatory variables (core or
206 skin temperature), tap water immersion from the diaphragm level up to the xiphoid
207 sternum in normal-weighted subjects with total fat percentage 20-30% or body mass
208 index 18.5-24.99kg/m², and 40-60% relative humidity (*Rh*). To investigate the range
209 of thermal feeling in water, we summarized a variety of water chemical compositions
210 such as carbonated baths. We exclude studies that used visual analog scales, partial
211 water immersion, water-perfused suit, or referred to animal studies, case reports,
212 conference papers, posters, dissertations, and editorials. Lastly, we performed a
213 review to the literature for relevant articles that were identified to meet articles within
214 the inclusion criteria.

215 **2.2 Search Strategy and screening**

216 The literary search was reviewed through Medline/PubMed, Google Scholar, and
217 SCOPUS. There was no restriction on language and date. The key terms “Water
218 Immersion,” “Thermoregulation,” “Thermosensing physiology,” “Cardiovascular
219 responses” were used either as sole searched terms and MeSH terms (Medical Subject
220 Headings) or in combination with other text words (Table 4). We repeated the search
221 strategy to all databases. The articles were screened according to title and abstract,
222 and then the duplicates were removed through Zotero. The final selected articles were
223 read in full-text.

224 **2.3 Data extraction and analysis**

225 Data extraction methods range based on the type of study and data displayed. The first
226 author MN extracted and charted the following thermoregulatory data from each
227 article: author(s), year of publication, country, total size of sample, modalities, core
228 and skin temperature, thermal descriptors, and water duration immersion. Experienced
229 exercise physiologist specializing in biochemical and physiological outcomes BD
230 assessed and reviewed the water immersion protocols reported in each study. The
231 articles were not blinded during the extraction and charting process. Formal analysis
232 applied by the thermal physiologist ER with the aim of examination heat balance
233 during immersion using the available raw data from Craig and Dvorak (1968). The
234 prementioned data were analyzed narratively to achieve the overall study objective.

235

236 **3. Results**

237 Fig. 1 represents the flowchart of the scoping review (PRISMA flow diagram), and
238 Table 5 characterized the in vivo studies relating to thermoregulatory responses in
239 water. In total, 23 articles were included after the removal of the duplicates and
240 screened selection from a total of 411 articles (Craig and Dvorak, 1968; Lee et al.,
241 1997; Wakabayashi et al., 2008; Becker et al., 2009; Kappel et al., 1997; Maeda et al.,
242 2001; Watanabe et al., 2006; Sato et al., 2004; Sato et al., 2009; Nishimura et al.,
243 2002; Nakamura et al., 1996; Rodrigues et al., 2020; Kojima et al., 2018; Fujisima,
244 1986; Allison and Reger, 1992; O'Brien et al. 2000; Stephens et al. 2014; Solianik et
245 al. 2014; Mansfield et al. 2021; Hohenauer et al., 2020; Rivas et al., 2016; Hashiguchi
246 et al., 2002; Tochiara et al., 1998). Ten articles came from Japan, 7 articles from
247 USA, 2 articles from Australia, 1 article from Lithuania, 1 article from United
248 Kingdom, 1 article from Switzerland, and 1 article from Denmark. A schematic
249 example of human heat balance and thermoneutral zone is presented in Fig. 2 after 30
250 min of immersion with thermal sensation based on retrieved data.

251 **3.1 Summary of thermoregulatory responses during water immersion**

252 In water temperature of 20-36°C, the skin temperature approached that of water
253 temperature with a deviation of ~0.5°C (Craig and Dvorak, 1968; O'Brien et al.,
254 2000; Lee et al., 1997; Wakabayashi et al., 2008; Becker et al., 2009; Kappel et al.,
255 1997; Sato et al., 2009; Nishimura et al., 2002; Montgomery, 1974). However, the
256 core temperature responded differently between 20-31.3°C and 32-36°C. At 20-
257 31.3°C, the internal temperature decreased steadily over time (O'Brien et al., 2000;
258 Lee et al., 1997; Wakabayashi et al., 2008; Becker et al., 2009; Lee et al., 1997). The
259 rate of change differed between two extreme thermal ranges. At 24°C, there was a
260 significant drop of 0.3°C from the initial value in the first 30 min, followed by a
261 steady downward trend. After two hours of immersion, the core temperature dropped
262 ~1°C (Lee et al., 1997; Wakabayashi et al., 2008). In contrast at 31.3°C, esophageal
263 temperature inclined 0.3°C in the first 12 minutes, and thereafter it decreased
264 gradually (Becker et al., 2009). In 32-37°C water temperature ranges, no changes
265 were observed in core temperature even after 2 hours (Keppel et al., 1997; Weston et
266 al., 1987). However, in water temperature of 38-42°C, the non-immersed neck skin
267 surface temperature increased to 35.5°C rapidly within the first 10 minutes, while the

268 surface skin temperature of immersed body parts fell 1°C below of water temperature
269 (Cannon and Keatinge, 1960; Hayward and Keatinge, 1981; Rodrigues et al., 2020;
270 Mansfield, 2021; Stephens et al., 2014). Water over 40°C significantly increased the
271 core temperature after the first 30 minutes reaching 38.3°C, and in two hours of
272 immersion, it continued to increase up to 39.5°C (Allison and Refer, 1992; Kojima et
273 al., 2018; Weston et al., 1987; Fujishima, 1986; Miwa et al., 1994; Mansfield, 2021;
274 Rivas et al., 2016). These data reflect the thermal responses in normal-weighted
275 subject.

276 Several shifts in thermal responses occurred in cold water temperature <20°C
277 (O'Brien et al., 2000; Solianik et al., 2014). At a water temperature of 15-18°C, the
278 core temperature remained stable for the first half-hour before decreasing ~ 0.5°C
279 (Cooper et al., 1976; Hayward and Keatinge, 1981; O'Brien et al., 2000; Kaupinen,
280 1989; Lee et al., 1997; Tarlochan and Ramesh, 2005; Tikuisis et al., 1988, 2000;
281 Solianik et al., 2014). The surface skin temperature rapidly reached the water
282 temperature within the first ten minutes at 15-20°C (O'Brien et al., 2000; Bradford,
283 Gerrard, and Cotter, 2019; Hayward and Keatinge, 1981; Tikuisis et al., 1988;
284 Yermakova et al., 2013). In colder water (<10°C) skin temperature of the immersive
285 parts increased up to ~5°C above water temperature (Hohenauer et al., 2020; Hayward
286 and Eckerson, 1984), but Cannon and Keatinge (1960) found out that skin was just
287 within about 1°C of water temperature – probably different instruments (ibutton vs
288 wirable thermistors) and the use or not of a waterproof taping may explain this
289 discrepancy of temperature data. According to Tipton and colleagues (2017),
290 immersion in cold water 10-15°C cause many changes, and is dependent on duration
291 and is characterized as 1) in the first three minutes, the surface of the skin cooled, 2)
292 in 3-30 minutes, neuromuscular cooling provoked, 3) for more than 30 minutes the
293 phenomenon of hypothermia appeared, and 4) death coincides with core temperature
294 at ~28°C and 5) the lower the temperature and the longer the immersion duration are,
295 the greater is the risk of frostbite.

296 **3.2 Summary of thermal sensation relating to water temperature ranges**

297 Only 9 out of 23 included articles evaluated thermal sensation (TS) along with water
298 immersion duration (see Table 5), though none of the experimental trials occurred in
299 water <18°C. The ASHRAE 7-point scale was utilized by two Japanese research
300 groups (Sato et al., 2004; Nishimura et al., 2002), a 13-point scale was chosen only by

301 Wakabayasi et al. (2008), a 9-point scale according to ISO 10551 was preferred by
302 one Swiss, two Australian, and two Japanese research groups (Rodrigues et al., 2020;
303 Stephens et al., 2014; Mansfield et al., 2021; Hashiguchi et al., 2002; Tochihara et al,
304 1998), while a 13 point McGinnis perception scale, which contained sensation and
305 comfort descriptors, preferred by one American research group (Rivas et al., 2016).
306 This discrepancy of thermal scales may limit the interpretation around thermal
307 perception due to a potential bias error (Schweiker et al., 2017; Lee et al., 2009).

308 In table 5, specific thermal characterizations were highlighted by the
309 researchers, for example water ranges between 5-26°C was determined as cold (Craig
310 and Dvorak 1968; Lee et al., 1997; Wakabayashi et al., 2008; O'Brien et al., 2000;
311 Stephens et al., 2014; Solianik et al., 2014; Hohenauer et al., 2020), while at 27°C
312 water was characterized as hot only by the Craig and Dvorak (1968). In the study of
313 Wakabayashi et al. (2008) thermal sensation was measured every 5 minutes during a
314 60 min immersion at 26°C water, in which the volunteers felt cool for the first 10
315 minutes, cold in the 35th minute, and severe cold in the 60th minute. Becker et al.
316 (2009) referred water temperature of 31°C as cool. In addition, in the research of
317 Nakamura et al. (1996) participants perceived the water at 30°C to be slightly cool
318 within 10 minutes of immersion. The neutral “range” of thermal sensation was
319 predefined between 34-36°C by the majority of authors (Becker et al., 2009; Kappel et
320 al., 1997; Sato et al., 2009; Nishimura et al., 2002; Kojima et al., 2018), except by
321 Stephens et al. (2014) that described it as warm. However, all volunteers of the
322 included papers experienced neutral sensation in the water temperature between 34-35
323 °C within 20 minutes of water immersion (Sato et al., 2009; Nishimura et al., 2002;
324 Stephens et al., 2014). Some researchers described the water at 39 °C as warm (Craig
325 and Dvorak 1968; Becker et al., 2009), while some others as hot (Kappel et al., 1997;
326 Watanabe et al., 2006; Rivas et al., 2016); nonetheless, the participants felt warm
327 within the first 30 minutes of immersion between 38-42°C (Nakamura et al., 1996;
328 Rodrigues et al., 2020; Mansfield et al., 2020; Rivas et al., 2016). Notably, contrary to
329 the actual data of thermal sensation, a common arbitrary definition of water
330 temperatures >40°C has been reported as hot among researchers. (Nakamura et al.,
331 1996; Rodrigues et al., 2020; Mansfield et al., 2020; Rivas et al., 2016).

332 Most importantly, there are gaps in knowledge in understanding thermal
333 sensation at different water temperatures in relation to ambient air environment

334 temperatures outside of the TNZ. During warm water immersion (>38°C) in a room
335 temperature ranged from 5-30°C, whole-body thermal sensation was “warm”, but at
336 35°C air temperature the thermal sensation was characterized as “hot” (Hashiguchi et
337 al., 2002; Mansfield et al., 2020; Miwa et al., 2021; Rivas et al., 2016; Rodriques et
338 al., 2020; Tochihara et al., 1998). To our knowledge, no data are available for thermal
339 sensation responses at colder water temperatures in different ambient conditions.

340 **3.3 Summary of thermoregulatory responses at different water temperature** 341 **ranges during CO₂ water immersion**

342 The literature findings showed that CO₂ water immersion at 35°C caused a
343 statistically significant drop in core temperature with parallel elevation of skin blood
344 flow, while core temperature increased in a water >39°C. (Nishimura et al., 2002;
345 Sato et al., 2009). The core temperature significantly increased above 38°C water-due
346 to enormously evaporative loss and increased blood flow in CO₂ water compared to
347 exposure in tap water at the same temperature (Watanabe et al., 2006; Sato et al.,
348 2004). It has been reported that CO₂ water modified thermal sensation after an acute
349 whole-body immersion expressed by a “slightly warm” feeling at 35°C, while a cooler
350 sensation was felt when exposed in tap water (Nishimura et al., 2002; Sato et al.,
351 2009).

352 **4. Discussion**

353 The main objective of this review was to present a comprehensive overview regarding
354 human physiological and behavioral thermoregulation during whole-body water
355 immersion. In Table 5, the vivo studies relating to thermoregulatory responses were
356 reviewed (Craig and Dvorak, 1968; Lee et al., 1997; Wakabayashi et al., 2008; Becker
357 et al., 2009; Kappel et al., 1997; Maeda et al., 2001; Watanabe et al., 2006; Sato et al.,
358 2004; Sato et al., 2009; Nishimura et al., 2002; Nakamura et al., 1996; Rodriques et
359 al., 2020; Kojima et al., 2018; Fujisima, 1986; Allison and Reger, 1992; O’Brien et
360 al., 2000; Stephens et al., 2014; Solianik et al., 2014; Mansfield et al., 2021;
361 Hohenauer et al., 2020; Rivas et al., 2016; Hashiguchi et al., 2002; Tochihara et al.,
362 1998). In Fig. 2 the characterization of a thermal balance, thermoneutral zone, and
363 thermal sensation at different water temperatures are described. The results illustrated
364 1) that the responses of thermoregulation and thermal sensation among various water
365 temperature varied and differed from ambient air temperatures and 2) different

366 thermoregulatory and thermal sensation responses between tap and CO₂ water
367 immersion. The most important issue in this scoping review was the gaps in
368 knowledge on water immersion duration on human TNZ and TCZ, and thermal
369 feeling.

370

371 **4.1 Nature of thermal sensation: subjectivity vs objectivity**

372 Currently there are no common accepted definition for cold and hot water
373 temperatures (Tipton & Bradford, 2014). Difficulty in the interpretation was identified
374 for the meaning of sensation and perception. There is a need to use objective criteria
375 that can separate physical responses from conscious interpretation that is strongly
376 dependent on personal and environmental circumstances (Auliciems, 1981).
377 Additional issues may be from a deterministic approach, in the case of thermal
378 sensation, which can be biased by psychology and physiology perspectives
379 (Auliciems, 1981). Behavioral thermoregulation development will require reliable
380 thermal scale with higher correlation coefficient in the field and laboratory studies
381 than the usual Bedford and ASHRAE scales (Auliciems, 1981; Gagge et al., 1967;
382 Schweiker et al., 2017).

383 Gagge (1967) sought to understand the nature of thermal sensation through the
384 Aristotelian work *Little Physical Treatises*, in which only five senses were identified
385 (sight, hearing, smell, taste and touch) (Hicks, 1907). However, Gagge disregarded
386 the quotes 423b29-32, 424a10-11 from *On the Soul/De anima*, in which the
387 philosopher stated that thermal sensation was a property of touch dominated by the
388 body. Gagge suggested that Galen was the first person to have recognized the
389 relationship of touch and thermal feeling; however according to Aristoteles (*On the*
390 *soul*, frag. 427b27-428b17), he was the first to describe each sensation (thermal
391 sensation) that comes from its own aesthetic organ (unknown at the time, temperature
392 sensors - TRPs) suggests a true feeling with a minimum degree of error, while
393 sensations that may be derived from recalling a prior memory or guessing a feeling
394 without applying the physiological stimuli (temperature) suggests a fantastic pseudo-
395 feeling with the most part false (Hicks, 1907).

396 Indeed, Aristoteles' scope of view agrees with the results of this review
397 regarding thermal sensation, as we observed same thermal expressions between

398 bathers-participants during a period of time but not always among observants for
399 various water temperature ranges. The key component is the criterion of time and
400 quality of feeling (real vs imaginary) for investigating the nature of thermosensitivity.
401 Similar verbal anchors were used by other researchers and participants, for example
402 the 42°C water immersion was characterized hot not only by authors, but also by
403 subjects at the 45th min of immersion (Rodrigues et al., 2020; Rivas et al., 2016). The
404 subjective nature of thermal sensation is also different between researcher's reference
405 point. Also, the subjectivity coexists in participants' expression, as leading question,
406 number of categories on the scale, and words that describe the units may affect
407 thermal choice, for example there may be a difficulty for choosing between slightly
408 cool or neutral (Schweiker et al., 2017; Peña Fernández et al., 2019). However, the
409 objective support for thermal sensation is using the subjective thermal scales in
410 relation to water immersion temperature, ambient air exposure, and skin and core
411 temperatures, and heat balance status (Sato et al., 2009; Stephens et al., 2014;
412 Nakamura et al., 1996; Nishimura et al., 2002; Rodrigues et al., 2020; Mansfield et
413 al., 2020; Rivas et al., 2016). Most importantly, the change in magnitude of skin and
414 core temperature and thermal heat loss or gain status (heat balance), and efferent and
415 afferent inputs to the hypothalamus would affect thermal sensation responses (Craig,
416 2002; Vanos et al., 2010; Tikuisis et al., 1998).

417 **4.2 Neutral zone, and thermal sensation during water immersion**

418 The concept of TNZ is essential for improving gaps in knowledge about behavior
419 thermoregulation within the concept of whole-body water immersion (Kingma et al.,
420 2017). Indeed, neutral sensation coincided with a comfortable feeling and thermal
421 balance (Auliciems, 1981; Calthrop, 1928; Chatonnet and Cabanac, 1965; Gagge et
422 al., 1967; Kingma et al., 2017). Specifically, heat gain is balanced with heat loss
423 during thermal neutral sensations (Gagge et al., 1967; Kingma et al., 2017;
424 Montgomery, 1974). Heat balance during immersion of different water temperatures
425 diverge at distinct time points govern thermal sensation. More specifically, we noticed
426 that TNZ during 30 minutes of immersion varied from 30-36°C (Fig. 2), but for longer
427 immersion duration limits it varied from 35.5-36.0°C (Craig and Dvorak, 1968). This
428 means that thermoneutral feeling was apparent within TNZ, mainly in its center, as
429 can be seen in Table 5 (Kingma et al., 2017). Non-shivering thermogenesis was
430 aligned with a cool sensation and shivering thermogenesis with a cold sensation, both

431 of which have been reported below LCT (Tikuisis et al., 1998; Montgomery et al.,
432 1974; Wakabayashi et al., 2008; Rennie et al., 1962). Warm sensation was apparent
433 above UCT that represented the increased heat metabolic rate accompanied by
434 cardiovascular changes (Gagge et al., 1967; Kingma et al., 2017; Rivas et al., 2016).
435 According to CO₂ water studies, TNZ may vary compared to tap water, since CO₂
436 provokes vasodilation to limbs rising blood flow; and therefore influences the body
437 core and skin temperatures.

438 **4.3 Initial thermal status determines the thermal sensation**

439 Clinical research has shown that thermal perception was sometimes correlated with
440 skin temperature and other's with core temperature (Aizawa, 2019; Calthrop, 1928;
441 Chatonnet and Cabanac, 1965; Enescu, 2019; Nielsen and Nielsen, 1984; Rodrigues et
442 al., 2020; Wakabayashi et al., 2008; O'Brien et al., 2000). In general, both the
443 environmental conditions and the individual's initial thermal state temperature may
444 influence the thermal perception (Goto et al., 2006; Oi et al., 2017). When the
445 individual was already at rest, thermosensitivity was positively correlated with skin
446 temperature and ambient temperature (in ambient air, water immersion) (Aryal and
447 Becerik-Gerber, 2019; Craig and Dvorak, 1968; Nielsen and Nielsen, 1984; Stephens
448 et al., 2014). The initial thermal status may explain discrepancies of thermal sensation
449 from several physiological thermoregulatory inputs. Hyperthermia activates brain
450 centers and other neural pathways between the hypothalamus, the cortical sensory
451 cortex that may prevail after passive heating and activate the endogenous opioid
452 system that is responsible for exercise-induced analgesia (Oi et al., 2017; Yuan et al.,
453 2016; Fujimoto et al., 2021).

454 Whole-body thermal sensation during exercise in hot air temperatures is deemed
455 to be blunted, however local skin thermal sensation was not affected by the dynamic
456 changes of core temperature (Flouris and Schlader, 2015; Fujimoto et al., 2021). It is
457 unknown if exercising in water (swimming) has similar responses for thermal
458 sensation and requires more research. Thermal sensation may become a practical tool
459 for assessing the thermal stress, and a crucial factor for designing an applicable life-
460 support system. In addition, thermal modeling revealed that the most critical body
461 regions for heat loss are head and extremities (Montgomery, 1974; Yermakova et al.,
462 2013). Further research is needed to investigate which part of the human body is the

463 most sensitive to local skin thermal perception for a variety of water immersion
464 duration and metabolic conditions (e.g., rest, swimming).

465

466 **4.5 Concerns about thermal scales**

467 From a methodological point of view, we should be cautious in the interpretation of
468 sensation as scale's validity uncertainty exists whether thermal sensation or thermal
469 guessing is measured. Contrary to Schweiker et al. (2017), we strongly believe that
470 number of categories should not be underestimated as they may contain bias. The end
471 and middle-scale effect can confuse the participants (Boateng et al., 2018; Lantz,
472 2013). For example, when someone takes a little more time to decide which thermal
473 category fits to his state best, we should be aware about the validity of his answer,
474 whether it reflects explicit his sensation or thought. Evaluation process of thermal
475 sensation triggers, except from the concrete underlying neural network for decoding
476 warm or cold stimulus, the right fronto-parietal and anterior insula, which constitute
477 the neural network attention (Nagashima et al., 2022). However, the kind of thermal
478 scale (Likert-scale or visual analog scale) could influence the activity of the
479 prementioned regions leading to another answer.

480 **5. Limitations**

481 The thermal conductivity is a crucial factor not only for thermal balance, but also for
482 thermal sensation. In thermal carbonated mineral baths, human experienced water
483 hotter than noncarbonated mineral water (Dogaru and Radulescu, 2015; Gutenbrunner
484 et al., 2010), while seawater baths alternated osmolality that caused sweating
485 evaporation and following producing a cooler sense compared to tap water (Tsuchiya
486 et al., 2003). The quality of the thermal and non-thermal afferent may enable specific
487 cascade pathways from TRPs determining sequentially thermal homeostasis and,
488 behavioral thermoregulation (Olausson et al., 2005; Wang and Siemens, 2015;
489 Weyer-Menkhoff et al., 2019; Zimmermann et al., 2011). Activation of these TRP ion
490 channels can be derived from temperature, pH, and chemicals, e.g., CO₂, H₂S, H₂O₂
491 (contained in some thermal springs) (Dogaru and Radulescu, 2015; Gutenbrunner et
492 al., 2010; Mori et al., 2017; Varga, 2010; Wang and Siemens, 2015). As mentioned
493 previously, the time and temperature may influence the rate of temperature change for

494 skin and core during water immersion and therefore may influence the TNZ and TCZ
495 and thermal perception due to the heat gain or loss.

5. Conclusions

498 This scoping review explores the nature of thermal sensation and the criteria for
499 thermal classification. To date, attention has been directed to assess thermal comfort,
500 especially in cold water, because of its links with detrimental incidents such as loss of
501 consciousness, frostbite, and drowning (An et al., 2019; Tipton et al., 2017; Bradford,
502 Gerrard, and Cotter, 2019). The thermal sensation variability can be explained, by the
503 belief that water temperature assessment is a deep internal cognitive and experienced
504 personal matter of interpretation (Calthrop, 1928; Chatonnet, and Cabanac, 1965a;
505 Guéritée et al., 2015; Tipton and Bradford, 2014). New knowledge about TRPs
506 function within the concept of TNZ and TCZ has provided an integrated physiological
507 and psychological understanding of how thermoreceptors modify our thermal
508 sensation and that are influenced by both the mind and body (Oi et al., 2017; Lv and
509 Liu, 2007; Li, 2017; Wang and Siemens, 2015; Weyer-Menkhoff et al., 2019).

510 For the first time to our knowledge, is reviewed the support of literature on
511 thermal sensation during whole-body water immersion and in the context of
512 homogenous sensation and body thermoregulation parameters. The findings provide
513 the importance of thermal sensation as an indicator for health and aquatic safety and
514 as a principal factor for establishing a more complex predictive thermal comfort
515 model applicable for water immersion (Cheng et al., 2012; Montgomery, 1974;
516 Morishima et al., 2020; Streblow, 2011; Yermakova et al., 2013; Wissler, 2012).
517 Further research is needed to construct an accurate thermal sensation scale for
518 estimating both water temperature and thermal stress during water exposure in
519 addition to how it is compared to ambient air temperatures.

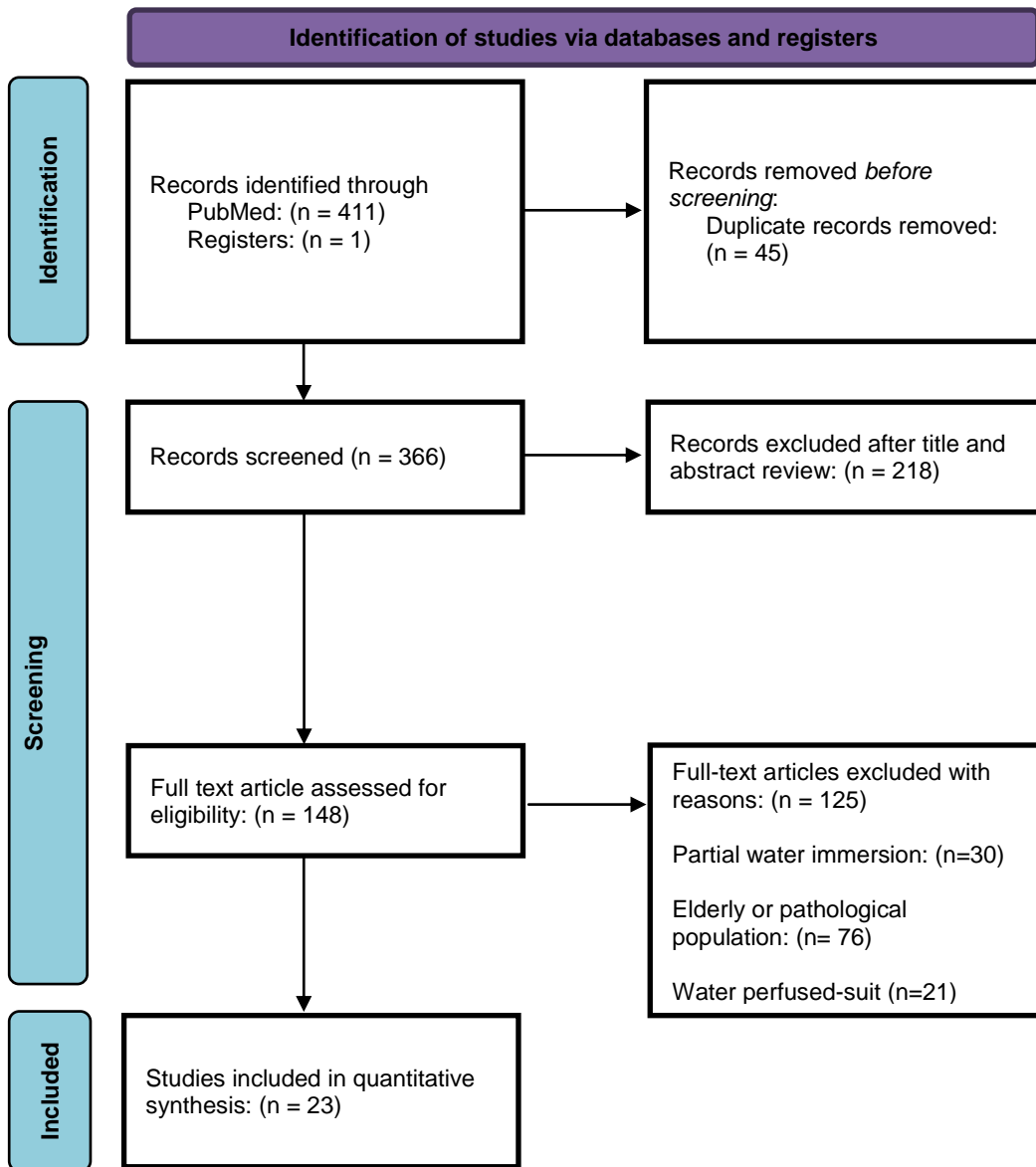

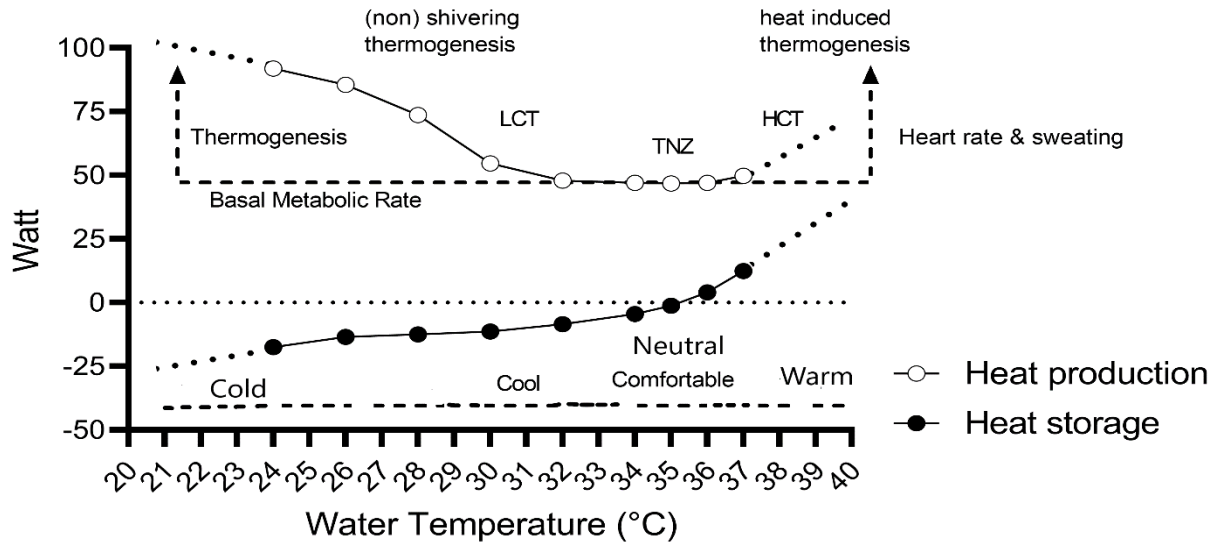

Fig. 2 depicts the relationship between thermal balance, thermoneutral zone, and thermal sensation after 30min of water immersion (Modified Table 2 from Craig and Dvorak, 1966). Thermoneutral zone (TNZ) is the range of water temperatures associated with basal metabolic rate required to support minimal life functions, and water loss. Below the lower critical temperature (LCT), metabolic rate increases to maintain body core temperature. Above the upper critical temperature (UCT), water loss increases due to cardiovascular regulatory blood volume distribution to skin and sweating and may coincide with heat-induced thermogenesis (e.g., Q10 effect: metabolic rate scales with tissue temperature according to Arrhenius law).
