# Quasilinear problems involving a perturbation with quadratic growth in the gradient and a non coercive zeroth order term

#### Abstract

In this paper we consider the problem $$
\left\{\begin{array}{l} u \in H_{0}^{1}(\Omega), \\ -\operatorname{div}(A(x) D u)=H(x, u, D u)+f(x)+a_{0}(x) u \quad \text { in } \mathcal{D}^{\prime}(\Omega), \end{array}\right.
$$


where $\Omega$ is an open bounded set of $\mathbb{R}^{N}, N \geq 3, A(x)$ is a coercive matrix with coefficients in $L^{\infty}(\Omega), H(x, s, \xi)$ is a Carathéodory function which satisfies

-c_{0} A(x) \xi \xi \leq H(x, s, \xi) \operatorname{sign}(s) \leq \gamma A(x) \xi \xi, \quad \text { a.e. } \quad x \in \Omega, \quad \forall s \in \mathbb{R}, \quad \forall \xi \in \mathbb{R}^{N},
$$

$f \in L^{N / 2}(\Omega)$, and $a_{0} \in L^{q}(\Omega), q>N / 2, a_{0} \geq 0$. For $f$ and $a_{0}$ sufficiently small, we prove the existence of at least one solution $u$ of this problem which is moreover such that $e^{\delta_{0}|u|}-1 \in H_{0}^{1}(\Omega)$ for some $\delta_{0} \geq \gamma$.

## Résumé

Dans cet article nous étudions le problème

où $\Omega$ est un ouvert borné de $\mathbb{R}^{N}, N \geq 3, A(x)$ est une matrice coercive à coefficients $L^{\infty}(\Omega)$, $H(x, s, \xi)$ est une fonction de Carathédory qui satisfait

$f \in L^{N / 2}(\Omega)$, et $a_{0} \in L^{q}(\Omega), q>N / 2, a_{0} \geq 0$. Pour $f$ et $a_{0}$ suffisamment petits, nous démontrons qu'il existe au moins une solution $u$ de ce problème qui est de plus telle que $e^{\delta_{0}|u|}-1 \in H_{0}^{1}(\Omega)$ pour un certain $\delta_{0} \geq \gamma$.

## 1 Introduction

In this paper, we consider the quasilinear problem

$$
\left\{\begin{array}{l}
u \in H_{0}^{1}(\Omega)  \tag{1.1}\\
-\operatorname{div}(A(x) D u)=H(x, u, D u)+f(x)+a_{0}(x) u \quad \text { in } \mathcal{D}^{\prime}(\Omega)
\end{array}\right.
$$

where $\Omega$ is a bounded open set of $\mathbb{R}^{\mathbb{N}}, N \geq 3$, where $A$ is a coercive matrix with bounded measurable coefficients, where $H(x, s, \xi)$ is a Carathéodory function wich has quadratic growth in $\xi$, and more precisely which satisfies for some $\gamma>0$ and $c_{0} \geq 0$

-c_{0} A(x) \xi \xi \leq H(x, s, \xi) \operatorname{sign}(s) \leq \gamma A(x) \xi \xi, \quad \text { a.e. } \quad x \in \Omega, \quad \forall s \in \mathbb{R}, \quad \forall \xi \in \mathbb{R}^{N} \tag{1.2}
\end{equation*}
$$

where $f \in L^{N / 2}(\Omega)$, and where $a_{0} \in L^{q}(\Omega), q>\frac{N}{2}$, with

a_{0} \geq 0, \quad \text { with } \quad a_{0} \neq 0 \tag{1.3}
\end{equation*}
$$

When $f$ and $a_{0}$ are sufficiently small (and more precisely when $f$ and $a_{0}$ satisfy the two smallness conditions (2.14) and (2.15)), we prove in the present paper that problem (1.1) has a least one solution, which is moreover such that

e^{\delta_{0}|u|}-1 \in H_{0}^{1}(\Omega) \tag{1.4}
\end{equation*}

with

\left\|\frac{e^{\delta_{0}|u|}-1}{\delta_{0}}\right\|_{H_{0}^{1}(\Omega)} \leq Z_{\delta_{0}} \tag{1.5}
\end{equation*}
$$

where $\delta_{0} \geq \gamma$ and $Z_{\delta_{0}}$ are two constants which depend only on the data of the problem (see (6.15), (6.16), (6.17)) for the definitions of $\delta_{0}$ and $Z_{\delta_{0}}$ ).

The main originality of our result is the fact that we assume that $a_{0}$ satisfies (1.3), namely that $a_{0}$ is a non negative function.

Let us begin with some review of the literature.
Problem (1.1) has been studied in many papers in the case where $a_{0} \leq 0$. Among these papers is a series of papers [8], [9], [10] and [11] by L. Boccardo, F. Murat and J.-P. Puel (see also the paper [23] by J.-M. Rokotoson), which are concerned with the case where

In these papers (which also consider nonlinear monotone operators and not only the linear operator $-\operatorname{div} A((x) D u))$, the authors prove that when $a_{0}$ satisfies (1.6) and when $f$ belongs to $L^{q}(\Omega), q>\frac{N}{2}$, then there exists at least one solution of (1.1) which moreover belongs to $L^{\infty}(\Omega)$ and which satisfies some a priori estimates. The uniqueness of such a solution has been proved, under some further structure assumptions, by G. Barles and F. Murat in [4], by G. Barles, A.-P. Blanc, C. Georgelin and M. Kobylanski in [3] and by G. Barles and A. Porretta in [5].

The case where

was considered, among others, by A. Alvino, P.-L. Lions and G. Trombetti in [1], by C. Maderna, C. Pagani and S. Salsa in [21], by V. Ferone and M.-R. Posteraro in [16], and by N. Grenon-Isselkou and J. Mossino in [17]. In these papers (which also consider nonlinear monotone operators), the authors prove that when $a_{0}$ satisfies (1.7) and when $f$ belongs to $L^{q}(\Omega), q>\frac{N}{2}$, with $\|f\|_{L^{q}(\Omega)}$ sufficiently small, then there exists at least one solution of (1.1) which moreover belongs to $L^{\infty}(\Omega)$ and which satisfies some a priori estimates.

The case where $a_{0}$ satisfies (1.7) but where $f$ only belongs to $L^{N / 2}(\Omega)$ for $N \geq 3$ (and no more to $L^{q}(\Omega)$ with $q>\frac{N}{2}$ ) was considered by V. Ferone and F. Murat in [13] (and in [14] in the nonlinear monotone case). These authors proved that when $\|f\|_{L^{N / 2}(\Omega)}$ is sufficiently small, there exists at least one solution of (1.1) which is moreover such that $e^{\delta|u|}-1 \in H_{0}^{1}(\Omega)$ for some $\delta>\gamma$ and which satisfies some a priori estimates. Similar results were obtained in the case where $f \in L^{N / 2}(\Omega)$ by A. Dall'Aglio, D. Giachetti and J.-P. Puel in [12] when $a_{0}$ satisfies (1.6) and in the recent paper [15] by V. Ferone and F. Murat when $a_{0}$ satisfies $a_{0} \leq 0$.

To finish with the case where $a_{0}$ satisfies $a_{0} \leq 0$, let us quote the paper [22] by A. Porretta, where the author studies the asymptotic behaviour of the solution $u$ of (1.1) when $a_{0}$ is a strictly positive constant which tends to zero, and proves that an ergodic constant appears at the limit $a_{0}=0$. Let us also mention the case where the nonlinearity $H(x, s, \xi)$ has the "good sign property", namely satisfies

\end{equation*}

In this case, when $a_{0} \leq 0$ and when $f$ just belongs to $H^{-1}(\Omega)$, L. Boccardo, F. Murat and J.-P. Puel in [7] and A. Bensoussan, L. Boccardo and F. Murat in [6] proved the existence of least one solution of (1.1) which belongs to $H_{0}^{1}(\Omega)$.

In contrast with the cases (1.6) and (1.7), the present paper is concerned with the case (1.3) where $a_{0} \geq 0$.

In this setting we are only aware of three papers. In [20], L. Jeanjean and B. Sirakov proved the existence of at least two solutions of (1.1) (which moreover belong to $L^{\infty}(\Omega)$ ) when $A(x)=I d$, $H(x, s, \xi)=\mu|\xi|^{2}, \mu>0, f \in L^{q}(\Omega), q>\frac{N}{2}, f \geq 0$, and $a_{0} \in L^{q}(\Omega), a_{0} \geq 0$, with $\|f\|_{L^{q}(\Omega)}$ and $\left\|a_{0}\right\|_{L^{q}(\Omega)}$ sufficiently small. In the recent preprint [2], D. Arcoya, C. De Coster, L. Jeanjean and K. Tanaka proved the existence of a continuum $(u, \lambda)$ of solutions (with $u$ which moreover belong to $\left.L^{\infty}(\Omega)\right)$ when $A(x)=I d, H(x, s, \xi)=\mu(x)|\xi|^{2}$, with $\mu \in L^{\infty}(\Omega), \mu(x) \geq \mu>0, f \in L^{q}(\Omega)$, $q>\frac{N}{2}, f \geq 0, f \neq 0$ and $a_{0}(x)=\lambda a_{0}^{\star}(x)$ with $a_{0}^{\star} \in L^{q}(\Omega), a_{0}^{\star} \geq 0$ and $a_{0}^{\star} \neq 0$; moreover, under some further conditions on $f$, these authors proved that this continuum is defined for $\lambda \in]-\infty, \lambda_{0}$ ] with $\lambda_{0}>0$ and that there are at least two non negative solutions of (1.1) when $\lambda>0$ is sufficiently small. Finally, in the recent preprint [19], L. Jeanjean and H. Ramos Quoirin proved the existence of two positive solutions (which moreover belong to $L^{\infty}(\Omega)$ ) when $A(x)=I d, H(x, s, \xi)=\mu|\xi|^{2}$, $\mu>0, f \in L^{q}(\Omega), q>\frac{N}{2}, f \geq 0, f \neq 0$, and $a_{0} \in C(\bar{\Omega})$ which can change sign with $a_{0}^{+} \neq 0$ and which satisfies the so called "thick zero set condition", and when the first eigenvalue of the operator $-\Delta-\left(a_{0}+\mu f\right)$ in $H_{0}^{1}(\Omega)$ is positive.

With respect to the results obtained in the three latest papers, we prove in the present paper, as said above, the existence of (only) one solution of (1.1) in the case (1.3) ( $\left.a_{0} \geq 0\right)$ when $a_{0}$ and $f$ satisfy the two smallness conditions (2.14) and (2.15), but our result is obtained in the general case of a nonlinearity $H(x, s, \xi)$ which satisfies only (1.2), for $f \in L^{N / 2}(\Omega)$ and for $a_{0} \in L^{q}(\Omega)$, $q>\frac{N}{2}$. Moreover, the method which allows us to prove this result continues mutatis mutandis to

work in the nonlinear monotone case where the linear operator $-\operatorname{div}((A(x) D u))$ is replaced by a Leray-Lions operator $-\operatorname{div}(a(x, u, D u))$ working in $W_{0}^{1, p}(\Omega)$, for some $1<p<N$, and where the quasilinear term $H(x, u, D u)$ has $p$-growth in $|D u|$.

Let us now describe the contents of the present paper.
The precise statement of our result is given in Section 2 (Theorem 2.1), as well as the precise assumptions under which we are able to prove it. These conditions include the two smallness conditions (2.14) and (2.15).

Our method for proving Theorem 2.1 is based on an equivalence result (see Theorem 3.5) that we state in Section 3 once we have introduced the functions $K_{\delta}(x, s, \zeta)$ and $g_{\delta}(s)$ (see (3.6) and (3.7)) and made some technical remarks on them. This result is very close to the equivalence result given in the paper [14] by V. Ferone and F. Murat.

This equivalence result implies that in order to prove the existence of a solution $u$ of (1.1) which satisfies (1.4) and (1.5), it is equivalent to prove (see Theorem 3.8) the existence of a function $w$ with (see (3.31))

\end{equation*}
$$

which satisfies (see (3.33))

$$
\left\{\begin{array}{l}
w \in H_{0}^{1}(\Omega)  \tag{1.10}\\
-\operatorname{div}(A(x) D w)+K_{\delta_{0}}(x, w, D w) \operatorname{sign}(w)= \\
=\left(1+\delta_{0}|w|\right) f(x)+a_{0}(x) w+a_{0}(x) g_{\delta_{0}}(w) \operatorname{sign}(w) \quad \text { in } \quad \mathcal{D}^{\prime}(\Omega)
\end{array}\right.
$$

and the estimate (see (3.34))

$$
\begin{equation*}
\|w\|_{H_{0}^{1}(\Omega)} \leq Z_{\delta_{0}} \tag{1.11}
\end{equation*}
$$

which is nothing but (1.5).
Our goal thus becomes to prove Theorem 3.8, namely to prove the existence of a solution $w$ which satisfies (1.10) and (1.11).

Problem (1.10) is very similar to problem (1.1), since it involves a term $-K_{\delta_{0}}(x, w, D w) \operatorname{sign}(w)$ which has quadratic growth in $D w$, as well as a zeroth orther term $\delta_{0}|w| f(x)+$ $+a_{0}(x) w+a_{0}(x) g_{\delta_{0}}(w) \operatorname{sign}(w)$. But this problem is also very different from (1.1), since the term $-K_{\delta_{0}}(x, w, D w) \operatorname{sign}(w)$ with quadratic growth has now the "good sign property" (see (1.8)), since $K_{\delta_{0}}(x, s, \xi)$ satisfies

$$
K_{\delta_{0}}(x, s, \xi) \geq 0
$$

while the zeroth order term is now no more a linear one but a semilinear term with $|s|^{1+\theta}$ growth (see (6.19)) due to presence of the term $a_{0}(x) g_{\delta_{0}}(w) \operatorname{sign}(w)$.

We will prove Theorem 3.8 essentially by applying Schauder's fixed point theorem. But there are some difficulties to do it directly, since the term with quadratic growth $K_{\delta_{0}}(x, w, D w) \operatorname{sign}(w)$ only belongs to $L^{1}(\Omega)$ in general. We therefore begin by defining an approximate problem (see (4.1)) where $K_{\delta}(x, w, D w)$ is remplaced by its truncation at height $k$, namely $T_{k}\left(K_{\delta}(x, w, D w)\right)$,
and we prove (see Theorem 4.1) that if $f$ and $a_{0}$ satisfy the two smallness conditions (2.14) and (2.15), this approximate problem has at least one solution $w_{k}$ which satisfies the a priori estimate

$$
\begin{equation*}
\left\|w_{k}\right\|_{H_{0}^{1}(\Omega)} \leq Z_{\delta_{0}} \tag{1.12}
\end{equation*}
$$

This result, which is proved in Section 4, is obtained by applying Schauder's fixed point theorem in a classical way.

We then pass to the limit as $k$ tends to infinity and we prove in Section 5 that (for a subsequence of $k$ ) $w_{k}$ tend to some $w^{\star}$ strongly in $H_{0}^{1}(\Omega)$ (see Lemma 5.2) and that this $w^{\star}$ is a solution of (1.10) which satisfies (1.11) (see End of the proof of Theorem 3.8).

This completes the proof of Theorem 3.8, and therefore proves Theorem 2.1, as announced.

This proof follows along the lines of the proof used by V. Ferone and F. Murat in [13] in the case where $a_{0}=0$. As mentionned above, this method can be applied mutatis mutandis to the nonlinear case where the linear operator $-\operatorname{div}(A(x) D u)$ is replaced by a Leray-Lions operator $-\operatorname{div}(a(x, u, D u))$ working in $W_{0}^{1}(\Omega)$ for some $1<p<N$, and where the quasilinear term $H(x, u, D u)$ has $p$-growth in $|D u|$, as it was done in [14] by V. Ferone and F. Murat in this non linear case when $a_{0}=0$. This will be the goal of our next paper [18].

## 2 Main result

In this paper we consider the following quasilinear problem

-\operatorname{div}(A(x) D u)=H(x, u, D u)+a_{0}(x) u+f(x) \quad \text { in } \quad \mathcal{D}^{\prime}(\Omega)
\end{array}\right.
$$

where the set $\Omega$ satisfies (note that no regularity is assumed on the boundary of $\Omega$ )

$$
\begin{equation*}
\Omega \quad \text { is a bounded open subset of } \mathbb{R}^{N}, N \geq 3 \tag{2.2}
\end{equation*}
$$

where the matrix $A$ is a coercive matrix with bounded measurable coefficients, i.e.

$$
\left\{\begin{array}{l}
A \in\left(L^{\infty}(\Omega)\right)^{N \times N}  \tag{2.3}\\
\exists \alpha>0, \quad A(x) \xi \xi \geq \alpha|\xi|^{2} \quad \text { a.e. } \quad x \in \Omega, \quad \forall \xi \in \mathbb{R}^{N}
\end{array}\right.
$$

where the function $H(x, s, \xi)$ is a Carathéodory function with quadratic growth in $\xi$, and more precisely satisfies

$$
\left\{\begin{array}{l}
H: \Omega \times \mathbb{R} \times \mathbb{R}^{\mathbb{N}} \rightarrow \mathbb{R} \text { is a Carathéodory function }  \tag{2.4}\\
-c_{0} A(x) \xi \xi \leq H(x, s, \xi) \operatorname{sign}(s) \leq \gamma A(x) \xi \xi, \quad \text { a.e. } \quad x \in \Omega, \quad \forall s \in \mathbb{R}, \quad \forall \xi \in \mathbb{R}^{N}, \\
\text { where } \gamma>0 \text { and } c_{0} \geq 0
\end{array}\right.
$$

where sign : $\mathbb{R} \rightarrow \mathbb{R}$ denotes the function defined by

\operatorname{sign}(s)=\left\{\begin{array}{cl}
+1 & \text { if } \quad s>0  \tag{2.5}\\
0 & \text { if } \quad s=0 \\
-1 & \text { if } \quad s<0
\end{array}\right.
$$

where the coefficient $a_{0}$ satisfies

$$

a_{0} \in L^{q}(\Omega) \quad \text { for some } \quad q>\frac{N}{2}, \quad a_{0} \geq 0, \quad a_{0} \neq 0 \tag{2.6}
\end{equation*}
$$

as well as the technical assumption (which can be made without loss generality with respect to (2.6), since $\frac{N}{2}<\frac{2 N}{6-N}$ when $3 \leq N \leq 6$ )

$$
\begin{equation*}
\frac{N}{2}<q<\frac{2 N}{6-N} \quad \text { when } \quad 3 \leq N \leq 6 \tag{2.7}
\end{equation*}
$$

and finally where

f \in L^{N / 2}(\Omega), \quad f \neq 0 \tag{2.8}
\end{equation*}
$$

(note that $L^{N / 2}(\Omega) \subset H^{-1}(\Omega)$ since $N \geq 3$ and since $\Omega$ is bounded; note also that if $f=0$, then $u=0$ is a solution of (2.1) so that the results of the present paper become trivial).

Let $2^{*}$ be the Sobolev's exponent defined by

and let $C_{N}$ be the Sobolev's constant defined as the best constant such that

\end{equation*}

We claim that one has

where $q^{\prime}$ the Hölder's conjugate of the exponent $q$ which appears in (2.6), (2.7), i.e.

indeed easy computations show that

0<\frac{2^{*}}{q^{\prime}}-2 \Longleftrightarrow q>\frac{N}{2} \\
\frac{2^{*}}{q^{\prime}}-2<1 \quad \Longleftrightarrow \frac{1}{q}>\frac{6-N}{2 N}
\end{gathered}
$$

the latest inequality is satisfied when $N \geq 6$ and is equivalent to $q<\frac{2 N}{6-N}$ when $N \leq 6$.
We now define the number $\theta$ by

In view of (2.10) we have

Since $\Omega$ is bounded, we equip the space $H_{0}^{1}(\Omega)$ with the norm

\end{equation*}

We finally assume that $f$ and $a_{0}$ are sufficiently small (see Remark 2.2), and more precisely that

\|f\|_{H^{-1}(\Omega)} \leq \frac{\theta}{1+\theta} \frac{\left(\alpha-C_{N}^{2}\left\|a_{0}\right\|_{N / 2}-\gamma C_{N}^{2}\|f\|_{N / 2}\right)^{(1+\theta) / \theta}}{\left((1+\theta) G C_{N}^{2+\theta}\left\|a_{0}\right\|_{q}\right)^{1 / \theta}} \tag{2.15}
\end{gather*}
$$

where the constant $G$ is defined by (6.13). Observe that in place of (2.14) we could as well have assumed that

\alpha-C_{N}^{2}\left\|a_{0}\right\|_{N / 2}-\gamma C_{N}^{2}\|f\|_{N / 2} \geq 0
$$

but that when equality takes places in the latest inequality, inequality (2.15) implies that $f=0$, and then $u=0$ is a solution of (2.1), so that the result of Theorem 2.1 be comes trivial.

Our main result is the following Theorem.

Theorem 2.1 Assume that (2.2), (2.3), (2.4), (2.6), (2.7) and (2.8) hold true. Assume moreover that (2.14) and (2.15) hold true.

Then there exist a constant $\delta_{0}$ with $\delta_{0} \geq \gamma$, and a constant $Z_{\delta_{0}}$, which are defined in Lemma 6.2 (see (6.15), (6.16)) and (6.17)), such that there exists at least one solution $u$ of (2.1) which further satisfies

Our proof of Theorem 2.1 is based on an equivalence result (Theorem 3.5) which will be stated and proved in Section 3. This equivalence Theorem will allows us replace proving Theorem 2.1 by proving Theorem 3.8 which is equivalent to Theorem 2.1.

Remark 2.2 In this Remark, we consider that the open set $\Omega$, the matrix $A$ and the function $H$ are fixed (and therefore in particular that the constants $\alpha>0$ and $\gamma>0$ are fixed), and we consider the functions $a_{0}$ and $f$ as parameters.

Our first assumption on these parameters (see assumptions (2.6) and (2.7)) is that $a_{0}$ belongs to $L^{q}(\Omega)$ with $q>\frac{N}{2}$ and $q<\frac{2 N}{N-6}$ when $N \geq 6$; this is essential to ensure (see (2.10)) that
the exponent $\theta$ defined by (2.11) satisfies $0<\theta<1$ (see (2.12)). We also assume $a_{0} \geq 0$ and $a_{0} \neq 0$.
Our second set of assumptions on these parameters are the two smallness assumptions (2.14) and (2.15).

Indeed, if, for example, $a_{0}$ is sufficiently small and satisfies

then (2.14) and (2.15) are satisfied if $\|f\|_{N / 2}$ (and therefore $\|f\|_{H^{-1}(\Omega)}$, since $L^{N / 2}(\Omega) \subset H^{-1}(\Omega)$ ) is sufficiently small.

Similarly, if, for example, $f$ is sufficiently small and satisfies

then (2.14) and (2.15) are satisfied if $\left\|a_{0}\right\|_{q}$ (and therefore $\left\|a_{0}\right\|_{N / 2}$, since $\left.L^{q}(\Omega) \subset L^{(N / 2}(\Omega)\right)$ is sufficiently small, since $\left\|a_{0}\right\|_{q}$ appears in the denominator of the right-hand side of (2.15).

Remark 2.3 The definitions of the two constants $\delta_{0}$ and $Z_{\delta_{0}}$ which appear in Theorem 2.1 are given in (the technical) Appendix 6 (see Lemma 6.2): these definitions are based on the properties of the function $\Phi_{\delta}$ (see (6.12)) which looks like a parabola (see Figure 2): the constant $\delta_{0}$ is the value of the parameter $\delta$ such that the function $\Phi_{\delta_{0}}$ has a double zero, and $Z_{\delta_{0}}$ is the value of this double zero. The two smallness conditions (2.14) and (2.15) ensure that $\delta_{0}$ satisfies $\delta_{0} \leq \gamma$, a condition which is essential in our proof.

In Remark 3.9 we try to explain where the two smallness conditions (2.14) and (2.15) come from.

In Remark 3.10, we explain why we have chosen to state Theorem 3.8 with $\delta=\delta_{0}$ rather than with a fixed $\delta$ with $\gamma \leq \delta \leq \delta_{0}$.

## 3 An equivalence result

The main results of this Section are Theorems 3.5 and 3.8. Remarks 3.1, 3.2 and 3.4 and Lemma 3.3 can be considered as technical results.

Indeed, as said before, the proof of Theorem 2.1 is based on the equivalence result of Theorem 3.5 that we state and prove in this Section. This equivalence Theorem in particular implies that Theorem 3.8, which we state at the end of this Section, is equivalent to Theorem 2.1. Theorem 3.8 will be proved in Sections 4 and 5. This Section also includes Remark 3.9 in which we try to explain where the two smallness conditions (2.14) and (2.15) come from, and Remark 3.10 where we explain why we have chosen to state Theorem 3.8 for $\delta=\delta_{0}$.

In this Section we always assume that

Let us first proceed with a formal computation. If $u$ is a solution of

-\operatorname{div}\left(A(x) D w_{\delta}\right)=-\delta e^{\delta|u|} A(x) D u D u \operatorname{sign}(u)-e^{\delta|u|}(\operatorname{div}(A(x) D u))
\end{array}\right.
$$

and therefore $w_{\delta}$ is, at least formally, a solution of

+\left(1+\delta\left|w_{\delta}\right|\right) f(x)+a_{0}(x) w_{\delta}+a_{0}(x) g_{\delta}\left(w_{\delta}\right) \operatorname{sign}\left(w_{\delta}\right) \text { in } \Omega, \\
w_{\delta}=0 \text { on } \partial \Omega
\end{array}\right.

where the functions $K_{\delta}: \Omega \times \mathbb{R} \times \mathbb{R}^{N} \rightarrow \mathbb{R}$ and $g_{\delta}: \mathbb{R} \rightarrow \mathbb{R}$ are defined by the formulas

The first goal of this Section is to transform this formal equivalence into a mathematical result, namely Theorem 3.5. We begin with three remarks on the functions $K_{\delta}$ and $g_{\delta}$, namely Remarks 3.1, 3.2 and 3.4.

Remark 3.1 Observe that, because of inequality (2.4) on the function $H$, and because of the coercivity (2.3) of the matrix $A$, one has

Remark 3.2 In this technical Remark we prove that the functions $K_{\delta}(x, w, D w)$ and $K_{\delta}(x, w, D w) \operatorname{sign}(w)$ are correctly defined measurable functions when $w \in H^{1}(\Omega)$, and we prove their continuity with respect to the almost everywhere convergence of $w$ and $D w$ (see Lemma 3.3).

Note that the function $K_{\delta}(x, s, \zeta)$ defined by (3.6) and the function $K_{\delta}(x, s, \zeta) \operatorname{sign}(s)$ are not Carathéodory functions, because their definitions involve the function $\operatorname{sign}(s)$, which it is not a Carathéodory function since is not continuous at $s=0$. This lack of continuity in $s=0$ is however the only obstruction for the functions $K_{\delta}(x, s, \zeta)$ and $K_{\delta}(x, s, \zeta) \operatorname{sign}(s)$ to be Carathéodory functions, and

+\chi_{\{s<0\}}(s)(1+\delta|s|) H\left(x,-\frac{1}{\delta} \log (1+\delta|s|), \frac{\zeta}{1+\delta|s|}\right)-\chi_{\{s=0\}}(s) 0+ \\
-\chi_{\{s>0\}}(s)(1+\delta|s|) H\left(x, \frac{1}{\delta} \log (1+\delta|s|), \frac{\zeta}{1+\delta|s|}\right), \\

Even if we do not know anything about the (almost everywhere) convergence of the functions $\chi_{\left\{w_{n}<0\right\}}\left(w_{n}(x)\right)$, and $\chi_{\left\{w_{n}>0\right\}}\left(w_{n}(x)\right)$ in the set $\{y \in \Omega: w(y)=0\}$, this fact and formulas (3.13) and (3.14) prove that

Remark 3.4 Observe that the function $g_{\delta}(s) \operatorname{sign}(s)$ is a Carathéodory function since in view of (6.4) this function is continuous at $s=0$. This allows one to define $g_{\delta}(w) \operatorname{sign}(w)$ as a measurable function for every $w \in H^{1}(\Omega)$.

The main result of this Section is the following equivalence Theorem.
Theorem 3.5 Assume that (2.2), (2.3), (2.4), (2.6), (2.7) and (2.8) hold true, and let $\delta>0$ be fixed. Let the functions $K_{\delta}$ and $g_{\delta}$ be defined by (3.6) and (3.7) .

\end{array}\right.

Conversely, if $w_{\delta}$ is any solution of (3.27), then the function $u$ defined by (3.4), namely by

Remark 3.6 Every term of the equation in (3.27) makes sense as a measurable function (see Remarks 3.2 and 3.4): actually the second term of the left-hand side of the equation in (3.27) belongs to $L^{1}(\Omega)$ in view of (3.10), while the three terms of the right-hand side of (3.27)can be proved to belong to $\left(L^{2^{\star}}(\Omega)\right)^{\prime}$ (and therefore to $H^{-1}(\Omega)$, see e.g. the proof of (3.40) in Remark 3.9 and the proof of (4.8) in the proof of Lemma 4.2).

Remark 3.7 Observe that the equivalence Theorem 3.5 holds true without assuming the two smallness conditions (2.14) and (2.15); moreover one could even have removed in (2.3) the hypothesis that the matrix $A$ is coercive, and still obtain this equivalence result.

Note however that Theorem 3.5 is an equivalence result which does not proves neither the existence of a solution of (2.1) nor the existence of a solution of (3.27), but which assumes as an hypothesis either the existence of a solution of (2.1) which also satisfies (3.26), or the existence of a solution of (3.27).

Proof of Theorem 3.5 Define the function $\hat{f}$ by

=\left(1+\delta\left|w_{\delta}\right|\right)\left(f(x)+a_{0}(x) \frac{1}{\delta} \log \left(1+\delta\left|w_{\delta}\right|\right) \operatorname{sign}\left(w_{\delta}\right)\right)= \\
=\left(1+\delta\left|w_{\delta}\right|\right)\left(f(x)+a_{0}(x) u(x)\right)=\left(1+\delta\left|w_{\delta}\right|\right) \hat{f}(x)
\end{array}\right.
$$

Then Theorem 3.5 becomes an immediate application of Proposition 1.8 of [13], once one observes that

\hat{f} \in L^{N / 2}(\Omega) \tag{3.30}
\end{equation*}

such is the case in the setting of Theorem 3.5: indeed $\hat{f}=f+a_{0} u$, where $f$ belongs to $L^{N / 2}(\Omega)$ by hypothesis (2.8), and where $a_{0} u$ also belongs to $L^{N / 2}(\Omega)$, since $a_{0}$ is assumed to belong to $L^{q}(\Omega), q>\frac{N}{2}$ (see hypothesis (2.6)), while $u$ belongs to $L^{r}(\Omega)$ for every $r<+\infty$, since by (3.26) $\left(e^{\delta|u|}-1\right)$ is assumed to belong to $H_{0}^{1}(\Omega)$, hence in particular to $L^{1}(\Omega)$, which implies that $e^{\delta|u|}$ belongs to $L^{1}(\Omega)$. The first part of Theorem 3.5 is therefore proved.

To prove the converse, observe that when $\hat{f}$ is defined by (3.29), then $\hat{f}$ is also given by (3.28), where $u$ belongs to $L^{r}(\Omega)$ for every $r<+\infty$. Theorem 3.5 is proved.

From the equivalence Theorem 3.5 one immediately deduces, setting

that Theorem 2.1 is equivalent to the following Theorem.
Theorem 3.8 Assume that (2.2), (2.3), (2.4), (2.6), (2.7) and (2.8) hold true. Assume moreover that (2.14) and (2.15) hold true.

Then there exist a constant $\delta_{0}$ with $\delta_{0} \geq \gamma$, and a constant $Z_{\delta_{0}}$, which are defined in Lemma 6.2 (see (6.15), (6.16) and (6.17)), such that there exists at least one solution $w$ of

which satisfies

\|w\|_{H_{0}^{1}(\Omega)} \leq Z_{\delta_{0}} \tag{3.34}
\end{equation*}
$$

The rest of this paper will therefore be devoted to prove Theorem 3.8. This will be done in Section 4 (where the existence of a solution satisfying (3.34) of a problem which approximates (3.33) will be proved, see Theorem 4.1), and in Section 5 (where we will pass to the limit in this approximate problem and prove that the limit satisfies (3.33) and (3.34)).

Remark 3.9 In this Remark we assume that (2.2), (2.3), (2.4), (2.6), (2.7) and (2.8) hold true. We also assume that the two smallness conditions (2.14) and (2.15) hold true, and we try to explain how these two conditions come from an "a priori estimate" that one can obtain on the solutions of (3.27).

If $w_{\delta}$ is any solution of $(3.27)$, using $T_{k}\left(w_{\delta}\right) \in H_{0}^{1}(\Omega) \cap L^{\infty}(\Omega)$ as test function, where $T_{k}: \mathbb{R} \rightarrow \mathbb{R}$ is the usual truncation at height $k$ defined by

one has

=\int_{\Omega} f(x) T_{k}\left(w_{\delta}\right)+\int_{\Omega} \delta f(x)\left|w_{\delta}\right| T_{k}\left(w_{\delta}\right)+\int_{\Omega} a_{0}(x) w_{\delta} T_{k}\left(w_{\delta}\right)+ \\
\quad+\int_{\Omega} a_{0}(x) g_{\delta}\left(w_{\delta}\right)\left|T_{k}\left(w_{\delta}\right)\right|
\end{array}\right.
$$

From now we assume in this Remark that $\delta$ satisfies

where $\delta_{1}$ is defined by (6.11) (note that $\gamma<\delta_{1}$ results from (2.14), see (6.22)). Since $\delta \geq \gamma$ by (3.37), we deduce from (3.11) that $K_{\delta}(x, s, \zeta) \geq 0$, and therefore that the second term of the left-hand side of (3.36) is nonnegative. We then use the fact that the matrix $A$ is coercive (see $(2.3))$ in the first term of the left-hand side of (3.36), the fact that $f \in L^{N / 2}(\Omega)$ (see (2.8)), which implies that $f \in H^{-1}(\Omega)$, in the first term of the right-hand of (3.36), Hölder's inequality with

in the second and in the third terms of the right-hand side of (3.36), and finally the fact that using (6.18), namely

\end{array}\right.
$$

(note that in view of (3.38), inequality (3.39) is a strict inequality). Using Sobolev's inequality (2.9) and dividing by $\left\|D w_{\delta}\right\|_{2}$ this implies that (even in the case where $w_{\delta}=0$ )

In view of the definition (6.12) of the function $\Phi_{\delta}$ (see also Figure 2), we have proved that if $w_{\delta}$ is any solution of (3.27), one has

and therefore inequality (3.41) does not imply anything on $\left\|D w_{\delta}\right\|_{2}$ when $\delta$ satisfies $\delta_{0}<\delta \leq \delta_{1}$. In contrast, when $\delta<\delta_{0}$, the strict inequality (3.41) implies that

where $Y_{\delta}^{-}<Y_{\delta}^{+}$are the two zeros of the function $\Phi_{\delta}$ (see Remark 2.4 and Figure 2), and when $\delta=\delta_{0}$, the strict inequality (3.41) implies that

Inequalities (3.42) and (3.43) are not really a priori estimates, since they do not imply any bound on $\left\|D w_{\delta}\right\|_{2}$. Nevertheless these inequalities exclude the closed interval $\left[Y_{\delta}^{-}, Y_{\delta}^{+}\right]$or the point $Z_{\delta_{0}}$ for $\left\|D w_{\delta}\right\|_{2}$, and they give the hope to prove the existence of a fixed point in the set $\left\|D w_{\delta}\right\|_{2} \leq Y_{\delta}^{-}$, when $\delta<\delta_{0}$, or in the set $\left\|D w_{\delta_{0}}\right\|_{2} \leq Z_{\delta_{0}}$, when $\delta=\delta_{0}$.

These inequalities also explain where the two smallness conditions (2.14) and (2.15) come from, since we claim that these two conditions imply that the value $\delta_{0}$ of $\delta$ for which $\Phi_{\delta}$ has a double zero satisfies $\delta_{0} \geq \gamma$, which is the case where hope is allowed: indeed (2.14) ensures that (and actually is equivalent to the fact that) the minimum on $X \geq 0$ of $\Phi_{\gamma}(X)$ is attained for some $X=Z_{\gamma}>0$, and (2.15) then ensures that (and actually is equivalent to the fact that) $\Phi_{\gamma}\left(Z_{\gamma}\right) \leq 0$.

Remark 3.10 In the present paper, we have chosen to prove the existence of a function $w$ which is solution of (3.33) (or equivalently of a function $w=w_{\delta_{0}}$ which is solution of (3.27) with $\delta=\delta_{0}$ ) which satisfies $\|w\|_{H_{0}^{1}(\Omega)} \leq Z_{\delta_{0}}$ (see (3.34)). We could as well have chosen to prove that for any fixed $\delta$ with $\gamma \leq \delta \leq \delta_{0}$, there exists a function $\hat{w}_{\delta}$ which is solution of (3.27) and which satisfies $\left\|\hat{w}_{\delta}\right\|_{H_{0}^{1}(\Omega)} \leq Y_{\delta}^{-}$, where $Y_{\delta}^{-}$is the smallest zero of the function $\Phi_{\delta}$ (see Remark 6.4 and Figure 2): indeed the proofs made in Sections 4 and 5 continue to work in this framework.

In this framework, defining $\hat{u}_{\delta}$ by

(compare with the definition (3.32) of $u$ where $\delta=\delta_{0}$ ), the existence of $\hat{w}_{\delta}$ which is solution of (3.27) and which satisfies $\left\|\hat{w}_{\delta}\right\|_{H_{0}^{1}(\Omega)} \leq Y_{\delta}^{-}$proves (see the equivalence Theorem 3.5) that $\hat{u}_{\delta}$ defined by (3.44) is solution of (2.1) and satisfies (see (3.4))

But the function $u$ which is defined by (3.32) from the function $w$ given by Theorem 3.8 satisfies (2.1) (by the equivalence Theorem 3.5 with $\delta=\delta_{0}$ ) and (see (3.4) again)

When $\delta<\delta_{0}$, we therefore have

and therefore $e^{\delta|u|}-1 \in H_{0}^{1}(\Omega)$. By the equivalence Theorem 3.5, the function $\bar{w}_{\delta}$ defined from $u$ by

is solution of (3.27). Moreover, since $D \bar{w}_{\delta}=e^{\delta|u|} D u$ and since $Z_{\delta_{0}}<Y_{\delta}^{+}$for $\delta<\delta_{0}$ (see (6.26)), one has in particular

Therefore the result of Theorem 3.8 (which is concerned with the case $\delta=\delta_{0}$ ) provides us with a function $w$, and then with a function $u$ defined by (3.32), and finally with a function $\bar{w}_{\delta}$ defined by (3.45) which is solution of (3.27) and which satisfies (3.46). So this function $\bar{w}_{\delta}$ is a solution $\hat{w}_{\delta}$ of (3.27) which satisfies $\left\|\hat{w}_{\delta}\right\|_{H_{0}^{1}(\Omega)} \leq Y_{\delta}^{-}$. Therefore the result of Theorem 3.8 (where $\delta=\delta_{0}$ ) provides us with a solution for every $\delta$ with $\gamma \leq \delta \leq \delta_{0}$ of the problem posed in the second paragraph of this Remark .

## 4 Existence of a solution for an approximate problem

In this Section we introduce an approximation of problem (3.33) (see (4.1)). Under the two smallness assumptions (2.14) and (2.15), we prove by applying Schauder's fixed point theorem that this approximate problem has a solution which satisfies the estimate (3.34).

Let $\delta_{0}$ be defined by (6.15), (6.16) and (6.17). For any $k>0$, we consider the approximate problem of finding a solution $w_{k}$ of (compare with (3.33))

=\left(1+\delta_{0}\left|w_{k}\right|\right) f(x)+a_{0}(x) w_{k}+a_{0}(x) g_{\delta_{0}}\left(w_{k}\right) \operatorname{sign}\left(w_{k}\right) \quad \text { in } \mathcal{D}^{\prime}(\Omega)
\end{array}\right.
$$

where $T_{k}$ is the usual truncation at height $k$ defined by (3.35) and where $\operatorname{sign}_{k}: \mathbb{R} \rightarrow \mathbb{R}$ is the approximation of the function sign which is defined by

Theorem 4.1 Assume that (2.2), (2.3), (2.4), (2.6), (2.7) and (2.8) hold true. Assume moreover that (2.14) and (2.15) hold true. Let $\delta_{0}$ be defined in Lemma 6.2 (see (6.15) and (6.16)), and let $k>0$ be fixed.

Then there exists at least one solution of (4.1) such that

\left\|w_{k}\right\|_{H_{0}^{1}(\Omega)} \leq Z_{\delta_{0}} \tag{4.3}
\end{equation*}
$$

where $Z_{\delta_{0}}$ is defined in Lemma 6.2 (see (6.15), (6.16) and (6.17)).
The proof of Theorem 4.1 consists in applying Schauder's fixed point theorem. First we prove the two following lemmas.

Lemma 4.2 Assume that (2.2), (2.3), (2.4), (2.6), (2.7) and (2.8) hold true. Let $k>0$ be fixed.
Then, for any $w \in H_{0}^{1}(\Omega)$, there exists a unique solution $W$ of the following semilinear problem

\end{equation*}
$$

where $C_{N}$ and $G$ are the constants given by (2.8) and (6.13).

Proof Problem (4.4) is of the form

where $\hat{b}(x)$ and $\hat{F}(x)$ are given. Since $\hat{b}(x)=T_{k}\left(K_{\delta_{0}}(x, w, D w)\right)$ belongs to $L^{\infty}(\Omega)$ and is nonnegative in view of (3.11) and of $\delta_{0} \geq \gamma$, since the function $\operatorname{sign}_{k}$ is continuous and non decreasing, and since $\widehat{F}$ belong to $H^{-1}(\Omega)$ (see e.g. the computation which allows one to obtain (4.8) below), this problem has a unique solution.

Since $W \in H_{0}^{1}(\Omega)$, the use of $W$ as a test function in (4.4) is licit. Since $T_{k}\left(K_{\delta}(x, s, \zeta)\right)$ is nonnegative, this gives

As in the computation made in Remark 3.9 to obtain the "a priori estimate" (3.39), we use in (4.7) the coercivity $(2.3)$ of the matrix $A$, Hölder's inequality with $\frac{1}{\frac{N}{2}}+\frac{2}{2^{\star}}=1$, inequality (6.19) on $g_{\delta_{0}}$, $\frac{1}{q}+\frac{1+\theta}{2^{\star}}+\frac{1}{2^{\star}}=1$ (which results from the definition (2.11) of $\theta$ ), and finally Sobolev's inequality (2.9). We obtain

\leq \mid f\left\|_{H^{-1}(\Omega)}\right\| D W\left\|_{2}+\delta_{0} C_{N}^{2}\right\| f\left\|_{N / 2}\right\| D w\left\|_{2}\right\| D W\left\|_{2}+C_{N}^{2}\right\| a_{0}\left\|_{N / 2}\right\| D w\left\|_{2}\right\| D W \|_{2}+ \\
+G C_{N}^{2+\theta}\left\|a_{0}\right\|_{q}\|D w\|_{2}^{1+\theta}\|D W\|_{2}

which immediately implies (4.5).

Assume moreover that for some $W^{\star} \in H_{0}^{1}(\Omega), W_{n}$ satisfies

Proof Since $W_{n}-W^{\star} \in H_{0}^{1}(\Omega)$, the use of $\left(W_{n}-W^{\star}\right)$ as test function in (4.10) is licit. This gives

+\int_{\Omega}\left(1+\delta_{0}\left|w_{n}\right|\right) f(x)\left(W_{n}-W^{\star}\right) d x+\int_{\Omega} a_{0}(x) w_{n}\left(W_{n}-W^{\star}\right) d x+ \\
+\int_{\Omega} a_{0}(x) g_{\delta_{0}}\left(w_{n}\right) \operatorname{sign}\left(w_{n}\right)\left(W_{n}-W^{\star}\right) d x
\end{array}\right.
$$

We claim that every term of the right-hand of (4.13) tends to zero as $n$ tends to infinity.
For the first term, we just use the fact that $W_{n}-W^{\star}$ tends to zero in $H_{0}^{1}(\Omega)$ weakly.
For the second term, we use the fact $T_{k}\left(K_{\delta_{0}}\left(x, w_{n}, D w_{n}\right)\right) \operatorname{sign}_{k}\left(W_{n}\right)$ is bounded in $L^{\infty}(\Omega)$, since $k$ is fixed, while $W_{n}-W^{\star}$ tends to zero in $L^{1}(\Omega)$ strongly.

For the last three terms we observe that, in view of (4.9) and (4.11), we have

We will now prove that each of the three sequences which appear in (4.14) are equiintegrable. Together with (4.14), this will imply that these sequences converge to zero in $L^{1}(\Omega)$ strongly, and this will prove that the three last terms of the right-hand side of (4.13) tend to zero as $n$ tends to infinity.

In order to prove that the sequence $\left(1+\delta_{0}\left|w_{n}\right|\right) f(x)\left(W_{n}-W^{\star}\right)$ is uniformly equiintegrable, we use Hölder's inequality with $\frac{1}{\frac{N}{2}}+\frac{2}{2^{\star}}=1$. For any measurable set $E, E \subset \Omega$, we have

Proving that the sequence $a_{0}(x) w_{n}\left(W_{n}-W^{\star}\right)$ is uniformly equiintegrable is similar, since for any measurable set $E, E \subset \Omega$, we have

Finally, in order to prove that the sequence $a_{0}(x) g_{\delta_{0}}\left(w_{n}\right) \operatorname{sign}\left(w_{n}\right)\left(W_{n}-W^{\star}\right)$ is uniformly equiintegrable, we use as in (4.8) inequality (6.19) and Hölder's inequality with $\frac{1}{q}+\frac{1+\theta}{2^{\star}}+\frac{1}{2^{\star}}=1$; for any measurable set $E, E \subset \Omega$, we have

We have proved that the right-hand side of (4.13) tends to zero. Since the matrix $A$ is coercive (see (2.3)), this proves that $W_{n}$ tends to $W^{\star}$ in $H_{0}^{1}(\Omega)$ strongly. Lemma 4.3 is proved.

Proof of Theorem 4.1 Recall that $k>0$ is fixed.
Consider the ball $B$ of $H_{0}^{1}(\Omega)$ defined by

First step In this step we prove that $S$ maps $B$ into itself.
Indeed by Lemma $4.2, W=S(w)$ satisfies (4.5); therefore, when $\|D w\|_{2} \leq Z_{\delta_{0}}$, one has, in view of the definition (6.12) the function $\Phi_{\delta}$ and of the property (6.16) of $Z_{\delta_{0}}$,

\leq\|f\|_{H^{-1}(\Omega)}+\delta_{0} C_{N}^{2}\|f\|_{N / 2} Z_{\delta_{0}}+C_{N}^{2}\left\|a_{0}\right\|_{N / 2} Z_{\delta_{0}}+G C_{N}^{2+\theta}\left\|a_{0}\right\|_{q} Z_{\delta_{0}}^{1+\theta}= \\
=\alpha Z_{\delta_{0}}+\Phi_{\delta_{0}}\left(Z_{\delta_{0}}\right)=\alpha Z_{\delta_{0}}
\end{array}\right.
$$

i.e. $\|D W\|_{2} \leq Z_{\delta_{0}}$, or in other terms $W \in B$, which proves that $S(B) \subset B$.

Second step In this step we prove that $S$ is continuous from $H_{0}^{1}(\Omega)$ strongly into $H_{0}^{1}(\Omega)$ strongly. For this we consider a sequence such that

The functions $w_{n}$ belong to $B$, and therefore the functions $W_{n}$ belong to $B$ in view of the First step. We can therefore extract a subsequence, still denoted by $n$, such that for some $W^{\star} \in H_{0}^{1}(\Omega)$,

We now pass to the limit in equation (4.10) as $n$ tends to infinity by using the fact that $\operatorname{sign}_{k}(s)$ and $g_{\delta_{0}}(s) \operatorname{sign}(s)$ are Carathéodory functions, and the first result of (3.17) as far as $T_{k}\left(K_{\delta_{0}}\left(x, w_{n}, D w_{n}\right)\right)$ is concerned (this point is the only part of the proof where the hypothesis of strong $H_{0}^{1}(\Omega)$ convergence in (4.18) is used). This proves that $W^{\star}$ is a solution of (4.4). Since the solution of (4.4) is unique, one has $W^{\star}=S(w)$.

In view of the fact that $W^{\star}$ is uniquely determined, we conclude that it was not necessary to extract a subsequence in (4.19) and that the whole sequence $W_{n}=S\left(w_{n}\right)$ converges in $H_{0}^{1}(\Omega)$ strongly to $W^{\star}=S(w)$. This proves the continuity of the application $S$.

Third step In this step we prove that $S(B)$ is precompact in $H_{0}^{1}(\Omega)$.
For this we consider a sequence $w_{n} \in B$ and we define $W_{n}$ as $W_{n}=S\left(w_{n}\right)$; in other terms $W_{n}$ is the solution of (4.10). Since $w_{n}$ and $W_{n}$ belong to $B$, they are bounded in $H_{0}^{1}(\Omega)$, and we can extract a subsequence, still denoted by $n$, such that

End of the proof of Theorem 4.1 We have proved that the application $S$ and the ball $B$ satisfy the assumptions of Schauder's fixed point theorem. Therefore there exists at least one $w_{k} \in B$ such that $S\left(w_{k}\right)=w_{k}$. This proves Theorem 4.1.

## 5 Proof of Theorem 3.8

Theorem 4.1 asserts that for for every $k>0$ fixed there exists at least a solution $w_{k}$ of (4.1) which satisfies (4.3). We can therefore extract a subsequence, still denoted by $k$, such that for some $w^{\star} \in H_{0}^{1}(\Omega)$

For $n>0$, we define $G_{n}: \mathbb{R} \rightarrow \mathbb{R}$ as the remainder of the truncation at height $n$, namely

\end{array}\right.

Using the coercivity (2.3) of the matrix $A$, we have for the first term of (5.6)

\text { in } L^{1}(\Omega) \text { strongly, }
\end{array}\right.

since the functions in the left-hand side of (5.9) converge almost everywhere in $\Omega$ and are equiintegrable.

Together with (5.6), the three results (5.7), (5.8) and (5.9) imply that

indeed since $\operatorname{sign}(s)$ and $\operatorname{sign}_{k}(s)$ have the same sign, it is equivalent to prove (5.20) or to prove that

=-\int_{\left\{\left|w_{k}\right| \leq n\right\}}\left(c_{0}+\delta_{0}\right)\left|\psi\left(z_{k}\right)\right| A(x)\left(D z_{k}+D T_{n}\left(w^{\star}\right)\right)\left(D z_{k}+D T_{n}\left(w^{\star}\right)\right) d x \geq \\

\leq-\int_{\Omega} A(x) D T_{n}\left(w^{\star}\right) D z_{k} \psi^{\prime}\left(z_{k}\right) d x-\int_{\Omega} A(x) D G_{n}\left(w_{k}\right) D z_{k} \psi^{\prime}\left(z_{k}\right) d x+  \tag{5.24}\\
+\int_{\Omega}\left(c_{0}+\delta_{0}\right)\left|\psi\left(z_{k}\right)\right| \\
\quad\left(A(x) D T_{n}\left(w^{\star}\right) D z_{k}+A(x) D z_{k} D T_{n}\left(w^{\star}\right)+A(x) D T_{n}\left(w^{\star}\right) D T_{n}\left(w^{\star}\right)\right) d x+ \\
+\int_{\Omega}\left(\left(1+\delta_{0}\left|w_{k}\right|\right) f(x)+a_{0}(x) w_{k}+a_{0}(x) g_{\delta_{0}}\left(w_{k}\right) \operatorname{sign}\left(w_{k}\right)\right) \psi\left(z_{k}\right) d x

Second step We claim that each term of the right-hand side of (5.24) tends to zero as $k$ tends to infinity. Since $\psi^{\prime}\left(z_{k}\right)-\left(c_{0}+\delta\right)\left|\psi\left(z_{k}\right)\right| \geq 1 / 2$ by (5.14), and since the matrix $A$ is coercive (see (2.3)), this will imply that

while $D G_{n}\left(w_{k}\right)$ tends to $D G_{n}\left(w^{\star}\right)$ weakly in $L^{2}(\Omega)^{N}$. Since $A(x) D G_{n}\left(w^{\star}\right) D T_{n}\left(w^{\star}\right)=0$ almost everywhere, the second term of the right-hand side of (5.24) tends to zero.

For the third term of the right-hand side of (5.24), we observe that

by Lebesgue's dominated convergence theorem, since $\psi\left(z_{k}\right)$ is bounded in $L^{\infty}(\Omega)$ and since $\psi\left(z_{k}\right)$ tends almost everywhere to zero because $\psi(0)=0$. Since $D z_{k}$ is bounded in $\left(L^{2}(\Omega)\right)^{N}$, this implies that the first part of this third term tends to zero. A similar proof holds true for the two others parts of this third term.

Finally the fourth term of the right-hand side of (5.24) tends to zero by a proof which is similar to the one that we used in the proof of Lemma 4.3, since the integrand converges almost everywhere to zero and is equiintegrable.

The claim made at the beginning of the second term is proved. This completes the proof of Lemma 5.2.

Second step Let us now pass to the limit in (4.1) as $k$ tends to infinity. This is easy for the first term of the left-hand side of (4.1) as well as for the three terms of the right-hand side of (4.1), which pass to the limit in $\left(L^{2^{\star}}(\Omega)\right)^{\prime}$ strongly by a proof which is similar to the one that we used in the proof of Lemma 4.3.

It remains to pass to the limit in the second term of the left-hand side of (4.1), namely in

$$

which implies that the functions $T_{k}\left(K_{\delta_{0}}\left(x, w_{k}, D w_{k}\right)\right) \operatorname{sign}_{k}\left(w_{k}\right)$ are equiintegrable since $D w_{k}$ converges strongly to $D w^{\star}$ in $L^{2}(\Omega)^{N}$.

Extracting if necessary a subsequence, still denoted by $k$, such that

The equiintegrability and the almost everywhere convergence of $T_{k}\left(K_{\delta_{0}}\left(x, w_{k}, D w_{k}\right)\right) \operatorname{sign}_{k}\left(w_{k}\right)$ then imply that

## 6 Appendix

In this Appendix, we give an estimate on the function $g_{\delta}$ defined by (3.7) (see Lemma 6.1), and the definitions of the constants $\delta_{0}$ and $Z_{\delta_{0}}$ which appear in Theorem 2.1 (see Lemma 6.2 ).

### 6.1 An estimate for the function $\mathrm{g}_{\delta}$

Lemma 6.1 For $\delta>0$, let $g_{\delta}: \mathbb{R} \rightarrow \mathbb{R}$ be the function defined by (3.7), i.e. by

0 \leq g_{\delta}(s) \leq \delta_{\star}^{\lambda} C(\lambda)|s|^{1+\lambda}, \quad \forall s \in \mathbb{R}, \quad \forall \delta, \quad 0<\delta \leq \delta_{\star} \tag{6.4}
\end{equation*}
$$

Moreover

0 \leq g_{\delta}(s)<\delta_{\star}^{\lambda} C(\lambda)|s|^{1+\lambda}, \quad \forall s \in \mathbb{R}, \quad s \neq 0, \quad \forall \delta, \quad 0<\delta \leq \delta_{\star} \tag{6.5}
\end{equation*}
$$

Proof Let $g: \mathbb{R}^{+} \rightarrow \mathbb{R}$ be the function defined by

g(t)=-t+(1+t) \log (1+t), \quad \forall t \geq 0
$$

Since $g(0)=0$ and $g^{\prime}(t) \geq 0$, one has

On the other hand, since $\log (1+t)<t$ for $t>0$, one has $g(t)<t^{2} \leq t^{1-\lambda} t^{1+\lambda}$ for $t>0$, and therefore for $0<\lambda<1$ and for every $m>0$

But the function $\frac{\log (1+t)}{(1+t)^{\lambda}}$ reaches its maximum for $t_{0}$ defined by $\left(1+t_{0}\right)=e^{1 / \lambda}$, hence

or in other terms that for every $\lambda, 0<\lambda<1$,

0 \leq g(t)<C(\lambda) t^{1+\lambda}, \quad \forall t>0 \tag{6.10}
\end{equation*}

for some $C(\lambda)$, with (take $m=1$ )

0<C(\lambda) \leq \sup \left\{1, \frac{2^{1+\lambda}}{\lambda e}\right\}
$$

which is nothing but (6.3).
Since

one deduces from (6.10) that $g_{\delta}$ satisfies

which proves $(6.4)$ and (6.5) with a constant $C(\lambda)$ which satisfies (6.3).

### 6.2 Definition of $\delta_{0}$ and $Z_{\delta_{0}}$

The goal of this Subsection is to define the constants $\delta_{0}$ and $Z_{\delta_{0}}$ which appear in Theorem 2.1. We will prove the following result.

Lemma 6.2 Assume that (2.2), (2.3), (2.4), (2.6), (2.7) and (2.8) hold true. Assume moreover that (2.14) and (2.15) hold true.

Let $\delta_{1}$ be the number defined by

Note that $\delta_{1}>0$ since $\alpha-C_{N}^{2}\left\|a_{0}\right\|_{N / 2}>0$ in view of (2.14).

For $\delta \geq 0$, let $\Phi_{\delta}: \mathbb{R}^{+} \rightarrow \mathbb{R}$ (see Figure 2) be the function defined by

\end{equation*}

where $\theta$ is defined by (2.11) and where $G$ is the constant defined by

G=\left(\frac{\alpha-C_{N}^{2}\left\|a_{0}\right\|_{N / 2}}{C_{N}^{2}\|f\|_{N / 2}}\right)^{\theta} C(\theta), \tag{6.13}
\end{equation*}
$$

with $C_{N}$ the best constant in the Sobolev's inequality (2.9) and $C(\theta)$ the constant which appears in (6.4) (see also (6.3)).

Then, for $0 \leq \delta \leq \delta_{1}$, the function $\Phi_{\delta}$ has a unique minimizing point $Z_{\delta}$ on $\mathbb{R}^{+}$, which is given by

\end{equation*}
$$

Moreover, there exists a unique number $\delta_{0}$ such that

\gamma \leq \delta_{0}<\delta_{1} \tag{6.15}
\end{equation*}
$$

and

$$
\begin{equation*}
\Phi_{\delta_{0}}\left(Z_{\delta_{0}}\right)=0 \tag{6.16}
\end{equation*}
$$

This number is the number $\delta_{0}$ which appear in Theorem 2.1, and $Z_{\delta_{0}}$ is then defined from $\delta_{0}$ through formula (6.14), namely by

\end{equation*}
$$

Remark 6.3 In the present paper we use Lemma 6.1 with $\lambda=\theta$ defined by (2.11) (note that $0<\theta<1$ in view of (2.12)) and with $\delta_{\star}=\delta_{1}$ defined by (6.11). Using the fact that $G$ defined by (6.13) is nothing but $G=\delta_{1}^{\theta} C(\theta)$, inequalities (6.4) and (6.5) imply that

$$
\begin{cases}0 \leq g_{\delta}(s) \leq \delta_{1}^{\theta} C(\theta)|s|^{1+\theta}=G|s|^{1+\theta}, & \forall s \in \mathbb{R}, \quad \forall \delta, 0<\delta \leq \delta_{1}  \tag{6.18}\\ 0 \leq g_{\delta}(s)<\delta_{1}^{\theta} C(\theta)|s|^{1+\theta}=G|s|^{1+\theta}, & \forall s \in \mathbb{R}, \quad s \neq 0, \quad \forall \delta, 0<\delta \leq \delta_{1}\end{cases}
$$

In particular for $\delta=\delta_{0}$ defined by (6.15) and (6.16) we have

$$
\begin{equation*}
0 \leq g_{\delta_{0}}(s) \leq G|s|^{1+\theta}, \quad \forall s \in \mathbb{R} \tag{6.19}
\end{equation*}
$$

Proof of Lemma 6.2 For $\delta \geq 0$, let $L_{\delta}$ be the constant defined by (see Figure 1)

$$
\begin{equation*}
L_{\delta}=\alpha-C_{N}^{2}\left\|a_{0}\right\|_{N / 2}-\delta C_{N}^{2}\|f\|_{N / 2} \tag{6.20}
\end{equation*}
$$

where $C_{N}$ is the best constant in the Sobolev's inequality (2.9). Note that $L_{\delta}$ is decreasing with respect to $\delta$.

Since $\delta_{1}$ is defined by (6.11), one has

$$
\begin{equation*}
L_{\delta_{1}}=0 \tag{6.21}
\end{equation*}
$$

On the other hand, hypothesis (2.14) is nothing but $L_{\gamma}>0$. Since $L_{\delta}$ is decreasing in $\delta$, we have

$$
\begin{equation*}
\gamma<\delta_{1} \tag{6.22}
\end{equation*}
$$

Let us now study the function $\Phi_{\delta}: \mathbb{R}^{+} \rightarrow \mathbb{R}$ defined by (6.12), i.e., in view of the definition (6.20) of $L_{\delta}$, by

$$
\begin{equation*}
\Phi_{\delta}(X)=G C_{N}^{2+\theta}\left\|a_{0}\right\|_{q} X^{1+\theta}-L_{\delta} X+\|f\|_{H^{-1}(\Omega)}, \quad \forall X \geq 0 \tag{6.23}
\end{equation*}
$$

(see Figure 2).
Since $a_{0} \neq 0$ (see (2.6)), the function $\Phi_{\delta}$ looks like a parabola. Observe that the function $\Phi_{\delta}$ is a decreasing family of functions for $0 \leq \delta \leq \delta_{1}$.

When $0 \leq \delta \leq \delta_{1}$, one has $L_{\delta} \geq 0$, and the function $\Phi_{\delta}$ has a unique minimizing point $Z_{\delta}$. A simple computation shows that $Z_{\delta}$ is given by

$$
\begin{equation*}
Z_{\delta}=\left(\frac{L_{\delta}}{(1+\theta) G C_{N}^{2+\theta}\left\|a_{0}\right\|_{q}}\right)^{1 / \theta}=\left(\frac{\alpha-C_{N}^{2}\left\|a_{0}\right\|_{N / 2}-\delta C_{N}^{2}\|f\|_{N / 2}}{(1+\theta) G C_{N}^{2+\theta}\left\|a_{0}\right\|_{q}}\right)^{1 / \theta} \tag{6.24}
\end{equation*}
$$

i.e (6.14), and that the minimum value $\Phi_{\delta}\left(Z_{\delta}\right)$ of $\Phi_{\delta}$ is given by

$$
\left\{\begin{array}{l}
\Phi_{\delta}\left(Z_{\delta}\right)=\|f\|_{H^{-1}(\Omega)}-\frac{\theta}{1+\theta} \frac{L_{\delta}^{(1+\theta) / \theta}}{\left((1+\theta) G C_{N}^{2+\theta}\left\|a_{0}\right\|_{q}\right)^{1 / \theta}}=  \tag{6.25}\\
=\|f\|_{H^{-1}(\Omega)}-\frac{\theta}{1+\theta} \frac{\left(\alpha-C_{N}^{2}\left\|a_{0}\right\|_{N / 2}-\delta C_{N}^{2}\|f\|_{N / 2}\right)^{(1+\theta) / \theta}}{\left((1+\theta) G C_{N}^{2+\theta}\left\|a_{0}\right\|_{q}\right)^{1 / \theta}}
\end{array}\right.
$$

When $0 \leq \delta \leq \delta_{1}$, the function $L_{\delta}$ is nonegative, continuous and decreasing with respect to $\delta$. Therefore $Z_{\delta}$ is continuous and decreasing with respect to $\delta$, while $\Phi_{\delta}\left(Z_{\delta}\right)$ is continuous and increasing with respect to $\delta$.

When $\delta=\delta_{1}$, one has $L_{\delta_{1}}=0$, the function $\Phi_{\delta_{1}}$ attains its minimum in $Z_{\delta_{1}}=0$ and $\Phi_{\delta_{1}}\left(Z_{\delta_{1}}\right)=$ $=\|f\|_{H^{-1}(\Omega)}>0$, while hypothesis (2.15) is nothing but $\Phi_{\gamma}\left(Z_{\gamma}\right) \leq 0$. Therefore there exists a unique $\delta_{0}$ with $\gamma \leq \delta_{0}<\delta_{1}$ such that $\Phi_{\delta_{0}}\left(Z_{\delta_{0}}\right)=0$. This is the definition of $\delta_{0}$ given by (6.15) and (6.16) in Lemma 6.2.

Lemma 6.2 is proved.

Remark 6.4 The case where equality takes places in inequality (2.15) corresponds to the case where $\delta_{0}=\gamma$.

On the other hand, we have $\delta_{0}<\gamma$ when (2.15) is a strict inequality, and for $\delta$ with $\delta_{0}<\delta \leq \gamma$, the function $\Phi_{\delta}$ has two zeros $Y_{\delta}^{-}$and $Y_{\delta}^{+}$with $0<Y_{\delta}^{-}<Y_{\delta}^{+}$. Since the family of functions $\Phi_{\delta}$ is a decreasing family of functions, one has

$$
\begin{equation*}
0<Y_{\delta}^{-}<Z_{\delta_{0}}<Y_{\delta}^{+} \quad \text { if } \quad \delta_{0}<\delta \leq \gamma \tag{6.26}
\end{equation*}
$$
