13	Abstract: The industrial hazardous waste (IHW) regulation has been highlighted by the Basel
14	Convention, and the South Korean government has announced a plan for the great transition to
15	resource circulation in 2020 to strengthen waste management. Accordingly, South Korea is faced with
16	the challenge of efficiently managing IHW at the national level. For this, research to understand
17	national IHW generation characteristics considering economic activities should be prioritized, but
18	there have been few studies on this. As a first try, this paper aimed to compile the waste extended
19	input-output table for IHW in South Korea for a systematic evaluation of waste generation from the
20	supply and demand perspectives across all economic sectors. This study developed the waste extended
21	input-output table using the 2018 monetary input-output table and industrial sectorial IHW generation.
22	From a supply perspective, considering direct and indirect generation, 'Electronic and electrical
23	equipment', 'Chemical', and 'Basic metals' industries were identified as the top three key sectors in
24	direct IHW generation, with the contribution to more than half of the total amount. Meanwhile, from a
25	demand perspective, considering domestic consumption, investment and exports, domestic
26	consumption contributed more than 48% to the IHW generation. In comparison, net exports
27	contributed about 15%, despite the total output from net exports being only about 6%, implying that
28	scientific regulations and improvements in IHW management from the demand perspective are also
29	required. The results provide insightful policy recommendations for establishing IHW management

30 reflecting the characteristics of industrial waste generation in the national economic system.

## 37 **1. Introduction**

Waste generation is increasing at a similar rate to economic growth, and it is urgent to reduce the 38 environmental load because it leads to environmental, social, and health problems (Moradi Hanifi et 39 al., 2019; Ojha, 2020; Soliman and Moustafa, 2020). To manage waste generation, which is one of the 40 41 important environmental loads, various national waste management policies are being implemented 42 worldwide. In line with this, the Basel Convention was adopted to prevent the movement of industrial hazardous wastes (IHW) between countries to protect the environment of the less developed countries 43 that do not have sufficient IHW treatment and management capabilities, and to minimize the 44 production of IHW (Khan, 2020; Liang et al., 2021; Rummel-Bulska and Basavaraj-Schroth, 1994). It 45 means that the world faces a significant challenge in transitioning to a circular economy through 46 efficient IHW management within their own countries. 47

48 To strengthen waste management, South Korea announced a plan for the great transition to

resource circulation in 2020 (MOE, 2020). A consensus exists on the vital role of waste and resource management in achieving the transition from a linear economic model to a circular one. The value of materials and resources is maintained in the supply chain. This plan includes policies in all waste fields and sets the primary goal of reducing waste generated during the industrial production stage. As the first step in this challenge, understanding the qualitative and quantitative characteristics of IHW generation by all industrial sectors is necessary to design a rational policy related to waste and resources in detail.

56 To address environmental issues closely related to industrial activities in the economic system, it 57 is necessary to adopt a methodology that simultaneously considers production and consumption activities across all economic sectors. There are many matured methods in the industrial ecology 58 toolbox that meet these needs to track environmental loads and resource flows within the economy, 59 e.g., input-output analysis (IOA), material flow analysis, and life cycle assessment (Camana et al., 60 2021; Jin et al., 2021; L. Liu et al., 2021; Malik et al., 2021; Ng and Phan, 2021; Omolayo et al., 2021). 61 IOA is a methodology that tracks the financial transaction, understands the interaction between 62 63 industrial sectors, producers, and consumers within an economy, and simultaneously considers 64 environmental loads by inter-industry transaction activities. Unlike LCA and MFA, where the process can be limited and analyzed due to truncation errors on the system boundaries, IOA aggregates and 65 analyzes data within a relatively wide range of economic boundaries, consuming less time for data 66 67 collection. Also, using IOA, objective analysis is possible for more complex processes than LCA and 68 MFA (Fang et al., 2021; Gao et al., 2022; Lase et al., 2021; Z. Liu et al., 2021).

As an extended input-output model, the environmentally extended input-output (EEIO) model represents the interdependence between the flows of goods and environmental loads. Many studies through the EEIO model have been conducted on energy, water, waste, and greenhouse gases, including CO<sub>2</sub>, etc. (Cheng et al., 2021; Huang and Eckelman, 2021; Lase et al., 2021; Z. Liu et al., 2021; Ohno et al., 2021; Peters et al., 2021; Rama et al., 2021; Tabatabaie and Murthy, 2021; Xu et al., 2021; Zhang et al., 2021). However, most of the studies are on energy or CO<sub>2</sub>, and there are still very few studies on waste. 76 The waste extended input-output (WEIO) model is one type of EEIO model in which waste 77 generation is added as a satellite account to an input-output table (IOT). In the WEIO model, the only 78 link between economic activities and waste flows is established by adding waste generation by industrial sectors to the money flows in industrial sectors and final demand (Towa et al., 2020). Some 79 of the few studies using the WEIO model include: Read and Muth (2021) evaluated the costs and 80 potential benefits of food waste reduction intervention in the United States. Meyer et al. (2020) 81 82 modeled the United States EEIO, including commercial enterprises from 386 industrial sectors of the economy and solid waste generation, and identified industries as potential areas to continue to pursue 83 innovations in material use. Reutter et al. (2017) applied EEIO analysis to estimate environmental and 84 economic factors embodied in Australian food waste. Reynolds et al. (2015) quantified the tonnages, 85 86 costs, and environmental impact of food rescued and compared food rescue to other food waste disposal methods of composting and landfill using the EEIO model on waste. 87

As shown above, the EEIO model has been applied to waste research in the United States and 88 mainly in Australia. However, the application to IHW was rather limited. Especially, there were few 89 90 studies on the generation of IHW in both supply and demand aspects, which this research contributes. 91 Moreover, to our best knowledge, the South Korea application had not been reported yet. Therefore, this study formulated the first version of the South Korean WEIO model of 20 industry sectors for 92 93 2018. We use this WEIO table to calculate the direct, total, and indirect IHW generation coefficients 94 by industry from a production perspective and IHW generation inducement coefficients from a 95 demand perspective, respectively.

The organization of this paper is as this. After this introduction section, section 2 presents the methods and data, section 3 shows the results and discusses the key findings and section 4 draws the conclusions and policies implications.

## 100 2. Methodology and Data

## 101 **2.1. Waste Extended Input-Output Analysis**

In this study, the basic structure of the WEIO table, which links the amount of IHW generation in physical units to the IOT indicated in the monetary units, is shown in Table. 1. Using this WEIO table, we can analyze the direct and indirect coefficients of IHW generation from industrial activities and the impacts of final demand.

109 The calculation through the WEIO table is conducted based on the IOA concept. In IOA, the total 110 output of an economy, X, can be expressed as the sum of intermediate consumption by industry,  $A \cdot X$ , 111 and final demand Y, as shown in Eq. (1).

114 Where *A* is the technical coefficients matrix  $(a_{ij} = x_{ij}/X_j)$ , *X* is the vector of total output and 115 *Y* is the vector of final demand. Matrix *A* is a square table with elements of  $x_{ij}$ , representing the 116 amount of input *i* required per unit of output *j*. Column of the matrix *A* presents the inputs needed 117 for the production of a specific output. Therefore, matrix A is a constellation of techniques and can be 118 considered a technical matrix. Eq. (1) can be rewritten as Eq. (2) with the expression for X.

121 In Eq. (2), *I* is the identity matrix and  $(I - A)^{-1}$  is Leontief inverse matrix, represents the 122 effects of one unit of final demand on each industry's total production to include the direct and indirect 123 effects within the supply chain.

We can calculate the direct IHW generation coefficients (*L<sub>direct</sub>*) by dividing the total amount of
IHW generation by sector (*W*) by total output (*X*), as Eq. (3).

128 The total IHW generation coefficients  $(L_{total})$  can be computed by multiplying the diagonal 129 matrix of the direct IHW generation coefficients  $(L_{direct} = \hat{L})$  by the Leontief matrix, as Eq. (4). It 130 also includes the concept of an IHW generation inducement coefficient to meet one unit of demand.

The indirect IHW generation coefficients ( $L_{indirect}$ ) can be obtained as the difference between the total IHW generation coefficients ( $L_{total}$ ) and the direct IHW generation coefficients ( $L_{direct}$ ), as Eq. (5).

138 In terms of demand perspective, the final demand *Y* is an exogenous sector and consists of 139 domestic consumption, investment, and net export. This study is analyzed by dividing it into 140 consumption, investment, and net export, as shown in Eq. (6).

143 It is defined,  $Y_C$  as a vector of consumption, including private consumption and government 144 consumption,  $Y_I$  a vector of investment including private fixed capital formation, gross fixed capital 145 formation, changes in inventories, and net acquisition of valuables,  $Y_E$  as a vector of export, M as a 146 vector of import, and  $Y_N$  as a vector of net export ( $Y_E - M$ ).

147 The IHW generation inducement coefficients are computed as Eq. (7), Eq. (8), and Eq. (9) by 148 multiplying direct IHW generation coefficients by the ratio of the final demand sector, i.e., the ratio of 149 consumption, investment, and net exports to final demand.

152 Where,  $L_C$ ,  $L_I$ , and  $L_N$  are the IHW generation inducement coefficients by consumption, 153 investment, and net export, respectively.

154

In this research, the scope for direct and indirect waste generation was defined differently from

155 other researches. (Ruiz-Peñalver et al., 2019; Ruiz Peñalver et al., 2014; Salemdeeb et al., 2016) 156 looked at waste generation by direct and indirect suppliers by distinguishing those who directly supply 157 the industry, called direct suppliers, and those that do not directly supply the industry but are suppliers 158 to the industry's suppliers referred to as indirect suppliers. However, this assumption makes the error 159 that the waste generated directly is counted as more than the actual amount because even the waste 160 from the primary supplier is included in the direct waste generation. Therefore, in this paper, we 161 defined direct waste as the waste generated by an industry's on-site production process and indirect 162 waste as the waste generated throughout the production processes of all industries in that supply chain underpinning the production of this final product. Table. 2 briefly shows the explanation and example 163 164 of direct, indirect, and total waste generation.

### 168 **2.2. Data Sources**

Among the three data sources, data on IHW generation consisting of 32 industry sectors in South Korea was obtained from the (Korea Ministry of Environment, 2018). The input-output table (IOT) of South Korea, is a comprehensive statistical table that records interrelationships between industries for all goods and services produced during the year (Bank of Korea, 2018). Unlike the IHW data, there is 173 33 industry sector in IOT, so in this study, the sectors were reclassified in 20 sectors according their

174 common trait as shown in Table. 3 and Appendix 1.

### 178 **3. Results and discussion**

## 179 **3.1. Overview of industrial hazardous waste generation**

The industrial hazardous waste (IHW) generation from 2008 to 2018 is shown in Fig. 1. With the economic growth, the amount of IHW has increased from 3,411 Mt/year in 2008 to 5,379 Mt/year in 2018 at 57.68%. The amount of IHW generation in 2009 decreased compared to 2008 due to the economic crisis in 2008, but has been steadily increasing since 2009. In particular, there has been a significant increase in 2012.

189 The IHW are composed of waste acid, waste alkali, waste oil, waste organic solvent, waste 190 synthetic polymeric compound, dust, sludge, and others. More than 60% of the IHW generation

consists of waste organic solvent, waste oil, and waste acid with 21.96% (3,236 tonnes/day), 21.06% 191

192 (3,103 tonnes/day), and 18.55% (2,734 tones/day), respectively in 2018 as shown in Fig. 2.

#### 197 **3.2.** Total output and industrial hazardous waste generation by industry

198 According to Fig. 3, South Korea's total output in 2018 was 4,337 trillion KRW, and the amount 199 of IHW generated was 5,379 Mt. 'Agriculture', the primary industry, has a total output of 63 trillion 200 KRW. Still, there is no IHW generated in this industry. The total output of the manufacturing industries, 201 the secondary industry, is 2,267 trillion KRW, accounting for 52.27%, while IHW generated is 3,984 202 Mt, accounting for 74.08%. In particular, 'Electronic and electrical equipment', 'Chemical', and 'Basic metal' industries contribute significantly to the IHW generation compared to the total output. 203 IHW generation accounts are 19.53%, 18.48%, and 15.98%, respectively, indicating that they account 204 for more than 50% of the total IHW generation, while the total outputs are 10.01%, 6.60%, and 3.36%, 205

respectively. In addition, the service industries, the tertiary industry, that account for 46.29% of the total output with 2,007 trillion KRW, accounts for 25.92% of the IHW generation with 1,394 Mt. As such, it is seen that the characteristics of IHW generation and economic contribution are very different for each industry.

More than half of South Korea's industrial total output comes from the secondary industry. Since the secondary industry is made up of manufacturing industries, it generates a lot of IHW due to the characteristics of the manufacturing industry, contributing as much as four-thirds to the generation of IHW in South Korea. However, according to Lee et al. (2021), South Korea's industry is showing a shift towards the service industry. The tertiary industry that corresponds to the service industry accounts for almost another half of the total industrial output of South Korea, showing that it has a large share of the South Korean industry. But because of the characteristic of the service industry, the IHW generation is only about a quarter. It shows the inclusive characteristics of the nexus between South Korean industry and IHW generation that the total output is not proportional to the amount of IHW generation. In particular, three major industries in the secondary industry contribute more to the IHW generation than total output.

### 228 **3.3.** Industrial hazardous waste generation coefficients from a supply perspective

The direct, indirect, and total IHW generation coefficients, one of the IHW generation 229 characteristics in 2018, were calculated by industry according to Eq. 4, 5, and 6 and summarized in 230 231 Fig. 4. And the amounts of the direct, indirect, and total IHW generation are shown in Appendix 2. The 232 average of direct IHW generation coefficient is 1.26, and seven industries out of twenty industries are above average. 'Basic metal' showed the highest direct IHW generation coefficient with 5.90, 233 234 followed by 'Chemical (3.47)', 'Non-metallic mineral (2.50)', 'Electronic and electrical equipment (2.42)', 'Mining (1.62)', 'Fabricated metal (1.49)', and 'Textile (1.41)'. The total IHW generation 235 236 averages 3.79, and seven industries have higher values than the average, slightly different from the direct IHW generation coefficient. The industry with the highest total IHW generation coefficient is 237 'Base metal', has a coefficient of 11.42, and then 'Chemical (6.88)', 'Electronic and electrical 238 equipment (5.64)', 'Fabricated metal (5.50)', 'Non-metallic mineral (5.10)', 'Transport equipment 239 (5.04)', and 'Textile (4.29)' are followed. The average of the indirect IHW generation coefficient is 240 241 2.52, and the 'Basic metal' shows the highest coefficient of 5.51. And 'Transport equipment (4.12)', 'Fabricated metal (4.02)', 'Machinery equipment (3.46)', 'Chemical (3.41)', 'Electronic and electrical 242 equipment (3.22)', 'Textile (2.88)', 'Construction (2.69)', and 'Non-metallic mineral (2.59)' are the 243 244 following most significant contributors.

249 These results show that in all industries except for 'Mining', 'Chemical', and 'Basic metal', the 250 indirect IHW generation coefficients are larger than the direct IHW generation coefficients. In 251 particular, in 'Food', 'Machinery equipment', 'Wholesale and retail trade', and 'Education, health and social work' sector, indirect IHW generation coefficients are 8.66, 10.56, 11.29, and 16.80 times larger 252 253 than direct IHW generation coefficients, respectively. Even in the 'Agriculture' sector, there is no 254 direct IHW generation, only indirect IHW generation. It means that IHW generated during the production and use of raw materials and components used in the industry has more influence on the 255 entire IHW generation than IHW generated by the industry itself. Moreover, the total, direct, and 256 257 indirect IHW generation coefficients of 'Textile', 'Chemical', 'Non-metallic mineral', 'Basic metal', 258 'Fabricated metal', and 'Electronic and electrical equipment' are above average, indicating that it is 259 essential to consider the IHW generation characteristic of these six industry sectors when establishing 260 waste management policies.

From an overall point of view, the average value of the indirect IHW generation coefficient is almost twice that of the direct IHW generation coefficient, which means that two times the amount of direct IHW are potentially generated as indirect IHW through the supply chain. This result shows that it is highly necessary to make scientific IHW management policy considering the direct and indirect IHW generation together. 266

## 3.4. Industrial hazardous waste inducement from a demand perspective

From the supply perspective, the previous step identified the direct, total, and indirect IHW generation coefficients. However, since the supply of products and services is derived by the final demand, analysis from a demand perspective is also necessary. Therefore, in this step, we calculated the contribution of IHW generation induced by intermediate and final demand, such as domestic consumption, investment, and net export, to understand the effects of total demand on the IHW generation in the economic system.

274 As shown in Table. 4, the contribution of IHW induced from intermediate and final demand are 64.05% and 35.95%, respectively. Among the final demand, the contribution of consumption, 275 276 investment, and net export are 2,592 Mt (48.18%), 1,961 Mt (36.46%), and 826 Mt (15.35%), 277 respectively. However, the total output from consumption, investment, and net export are 2,606 trillion KRW (60.09%), 1,460 trillion KRW (33.66%), and 271 trillion KRW (6.25%), respectively. It can be 278 279 confirmed that almost half of the IHW generation inducement is due to consumption, which implies 280 that consumption must also be considered when managing IHW generation. Also, we confirmed that a 281 large amount of IHW is generated compared to the total output generated by net exports. While the 282 total output by net exports is only 6.25%, the amount of IHW induced by net exports is 15.35%.

In addition, the IHW generation inducement coefficients from consumption, investment, and net exports, which were calculated by Eq. 7, 8, 9, were 1.38, 1.05, and 0.44, respectively. This means that 1.38 kg, 1.05 kg, and 0.44 kg of IHW were induced per one million KRW of final demand for domestic consumption, investment, and exports. Fig. 5 shows the IHW generation inducement coefficients by industry.

295 It was found that the IHW generation inducement coefficient by consumption, which has the 296 greatest impact on IHW generation among the final demand sectors, was significantly affected in the order of 'Other services (0.52)', 'Chemical (0.26)', 'Electronic and electrical equipment (0.14)', and 297 'Basic metal (0.10)'. Among them, consumption of 'Other services' seems to have an 298 overwhelmingly high impact on IHW generation. The contribution of IHW generation induced by 299 300 investment is the largest from 'Basic metal (0.24)', followed by 'Other services (0.18)', 'Electronic 301 and electrical equipment (0.15), and 'Chemical (0.14). The IHW generation induced by net exports has the largest contribution by 'Electronic and electrical equipment (0.26)', followed by 'Chemical 302 (0.12)', and 'Base metal (0.12). Whereas, the IHW generation inducement coefficient of 'Other 303 services (-0.01)' is a negative value. It means that an increase in exports of 'Other service' affected 304

305 waste reduction, unlike other industries.

These results identify the characteristics of IHW generation in consideration of the demand and supply side. This implies that improving clean production and resource efficiency is necessary from a supply perspective. Furthermore, from the demand perspective, classic policy instruments (regulatory, economic, and informational) and incentives on the consumer behavioral approach are needed to reduce IHW generation.

## 312 **4. Conclusions and future work**

Even though the world has reached a point in which IHW management needs to be more systematized due to the Basel Convention and the transition to a circular economy, South Korea's waste management policies have not yet been made based on objective and rational evidence. So we need to focus on developing a methodology to support establishing effective policies by quantifying the characteristics of IHW generation, considering the relationship between economic activities and waste generation.

This paper aims to formulate the first version of the South Korean WEIO model of IHW. Through the first version of the WEIO model of IHW, we calculated the direct, indirect, and total IHW generation coefficients from the supply perspective, and the contribution of IHW generation from the demand perspective of consumption, investment, and net export.

323 The results can be summarized on the supply side and the demand side. First, in terms of a supply-side point of view, it was found that more than 50% of direct IHW generation is from 324 325 'Chemical', 'Basic metal', and 'Electronic and electrical equipment'. And the direct, total, and indirect IHW generation coefficients of these three sectors are above average, indicating that the main point 326 would be to consider and reflect the characteristics of IHW generation in those three sectors when the 327 328 South Korean government plans waste management policies innovation. Also, it showed that the 329 average value of the indirect IHW generation coefficient is almost twice that of the direct IHW generation coefficient, which must be reflected in the waste policies establishment. To plan the 330

reduction of IHW generation, it is necessary to consider the direct IHW generated by each industry and the indirect IHW generated from the industry's supply chain as well. To this end, it can be said that waste management policies should be established to improve the resource efficiency and cleaner production of all industries in the supply chain, not just one industry.

From the demand side, the contribution of IHW generation induced from consumption, 335 investment, and net export are 48.18%, 36.46%, and 15.35%, respectively. It shows that not only the 336 337 supply side but also the demand side, especially consumption, is a factor that must be carefully 338 addressed in the IHW reduction strategy to achieve a sustainable economy. In other words, it is as 339 urgent to establish policy instruments and incentives to improve the consumer behavioral approach as much as the technological and environmental policies. The results obtained from this research imply 340 that this first South Korean WEIO model can be used to identify IHW hotspots in industrial activity 341 and quantify the contribution of direct and indirect IHW generation, contributing to the establishment 342 343 of waste policy strategies.

344 However, we have to admit some limitations of the first version of the South Korean WEIO table. First, the different sector classifications of waste data and IOT forced us to reclassify industry sectors, 345 346 merging several industries into one. Especially the service sector is simplified in the waste data but more granular in the IOT. Due to the simplification of waste data, it is unfortunate that detailed 347 analysis could not be done in the service sector, a tertiary industry. Second, the current version does 348 not provide any additional information about residues generated from the waste treatment process. 349 350 This limitation is expected to be addressed in the next version of the waste input-output (WIO) table to reflect waste treatment activities. Despite these limitations, introducing the first version of the South 351 352 Korean WIO table is the first step toward better understanding the characteristics of the IHW generation. For in-depth study in the future, a more refined WIO model needs to be developed and 353 354 applied.
