# NON-LOCALLY DISCRETE ACTIONS ON THE CIRCLE WITH AT MOST $N$ FIXED POINTS

#### Abstract

A subgroup of Homeo $+\left(\mathbb{S}^{1}\right)$ is Möbius-like if every element is conjugate to an element of $\operatorname{PSL}(2, \mathbb{R})$. In general, a Möbius-like subgroup of $\mathrm{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ is not necessarily (semi-)conjugate to a subgroup of $\operatorname{PSL}(2, \mathbb{R})$, as discovered by N. Kovačević [Trans. Amer. Math. Soc. 351 (1999), 48234835]. Here we determine simple dynamical criteria for the existence of such a (semi-)conjugacy. We show that Möbius-like subgroups of Homeo $\left(\mathbb{S}^{1}\right)$ which are elementary (namely, preserving a Borel probability measure), are semi-conjugate to subgroups of $\operatorname{PSL}(2, \mathbb{R})$. On the other hand, we provide an example of elementary subgroup of Diff $+\left(\mathbb{S}^{1}\right)$ satisfying that every non-trivial element fixes at most 2 points, which is not isomorphic to any subgroup of PSL( $2, \mathbb{R}$ ). Finally, we show that non-elementary, non-locally discrete subgroups acting with at most $N$ fixed points are conjugate to a dense subgroup of some finite central extension of $\operatorname{PSL}(2, \mathbb{R})$.

## 1. Introduction

Let $X$ be a topological space, and $G \leq \operatorname{Homeo}(X)$ a subgroup of homeomorphisms of $X$. Given $N \in \mathbb{N}$, we say that $G$ has at most $N$ fixed points if every non-trivial element of $G$ has at most $N$ fixed points. When $N=0$, this means that the action of $G$ on $X$ is free. A natural problem is to characterize actions with at most $N$ fixed points:
Question 1.1. Given $N \in \mathbb{N}$, which subgroups of $\operatorname{Homeo}(X)$ have at most $N$ fixed points?
Here we will address this problem for the case when $X=\mathbb{S}^{1}$ is the circle (the case $N=2$ and $X=\mathbb{R}$ has been discussed by the second author in [5], extending classical work of Hölder and Solodov). To simplify the discussion, we will rather consider subgroups of Homeo+ $\left(\mathbb{S}^{1}\right)$, the group of order-preserving homeomorphisms of the circle, which is of index 2 in Homeo $\left(\mathbb{S}^{1}\right)$. The classical group $\operatorname{PSL}(2, \mathbb{R})$ of Möbius transformations acts on the circle with at most 2 fixed points. This group may be seen in two ways:

- it is the group of projective transformations of the projective line $\mathbb{R P}^{1}$;
- it is also the group of isometries of the hyperbolic disc $\mathbb{D}$, which acts on its circle at infinity. For any integer $k \geq 1$, the $k$-fold central extension

$$
1 \rightarrow \mathbb{Z}_{k} \rightarrow \operatorname{PSL}^{(k)}(2, \mathbb{R}) \rightarrow \operatorname{PSL}(2, \mathbb{R})
$$

also acts on the circle (which is homeomorphic to its $k$-fold covering), and it gives a natural example of group acting with at most $2 k$ fixed points. Somehow we want to understand to what extent groups with at most $2 k$ fixed points are comparable to subgroups of $\operatorname{PSL}^{(k)}(2, \mathbb{R})$. The case $k=1$ is already interesting on its own. For this, we say that a group $G$ is Möbius-like if every element is individually conjugate to an element in $\operatorname{PSL}(2, \mathbb{R})$. In practice, this means that any element in $G$ is either conjugate to a rotation (elliptic), or it admits exactly one fixed point (parabolic), or it admits exactly two fixed points, one attracting and one repelling (hyperbolic). On the other hand, a basic example of subgroup of Homeo $\left(\mathbb{S}^{1}\right)$ with at most 2 fixed points but not Möbius-like,

[^0]is the cyclic subgroup generated by a homeomorphism with exactly two fixed points, but which is not (topologically) hyperbolic: in this case both fixed points are (topologically) parabolic, namely repelling on one side and attracting on the other.

Several works have exhibited conditions under which Möbius-like groups are conjugate to subgroups of PSL $(2, \mathbb{R})$. Notably, a major result in this context has been obtained by Tukia [20] (in the torsion-free case), and then independently extended by Gabai [8] and Casson and Jungreis [6], after which subgroups of $\operatorname{PSL}(2, \mathbb{R})$ are dynamical determined through the notion of convergence groups. Let us also mention the more recent work of Baik [3], describing a characterization of subgroups of $\operatorname{PSL}(2, \mathbb{R})$ in terms of invariant laminations on the circle. In [15], Kovačević proved that a Möbiuslike subgroup of Homeo $\left(\mathbb{S}^{1}\right)$ with a global fixed point is always semi-conjugate to a subgroup of $\operatorname{PSL}(2, \mathbb{R})$. We extend this result to elementary subgroups, that is, subgroups of Homeo ${ }_{+}\left(\mathbb{S}^{1}\right)$ preserving a Borel probability measure on $\mathbb{S}^{1}$. Concretely, a subgroup $G \leq$ Homeo $\left(\mathbb{S}^{1}\right)$ is elementary if either it admits a finite orbit or it is (continuously) semi-conjugate to a subgroup of rotations (see the discussion in §3.1, or Ghys [9, Proposition 6.17]).

Remark 1.2. This terminology is coherent with the usual notion of elementary subgroup of PSL $(2, \mathbb{R})$, which is a subgroup whose action on $\overline{\mathbb{D}}$ has a finite orbit. Concretely, an elementary subgroup of $\operatorname{PSL}(2, \mathbb{R})$ is either conjugate in $\operatorname{PSL}(2, \mathbb{R})$ to a subgroup of rotations, or has a finite orbit on the circle at infinity (which has to be either a fixed point or a periodic orbit of order 2); see Kim, Koberda, and Mj [13, Proposition 2.1].

In practice, compared to the work of Kovačević, we also consider the case of periodic orbit of order 2 , which is a bit harder than the other cases.
Theorem A. If $G<\operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ is an elementary, Möbius-like subgroup, then $G$ is continuously semi-conjugate to an elementary subgroup of $\operatorname{PSL}(2, \mathbb{R})$ and, moreover, the corresponding morphism $G \rightarrow \operatorname{PSL}(2, \mathbb{R})$ is injective.

Our proof is a modern revised version of that from [15], which is somehow difficult to digest as Kovačević needs to prove Solodov's theorem along way. Originally presented in [19, Theorem 3.21], this is now a classical result in the subject (see Ghys [9, Theorem 6.12] and Farb-Franks [7, Theorems 1.3 and 1.4]). For further reference, it is more convenient to add a first item to its usual statement, which is a direct consequence of Hölder's theorem [9, Theorem 6.10].

Theorem 1.3 (Solodov). Let $G<$ Homeo $_{+}(\mathbb{R})$ be a subgroup with at most 1 fixed point. Then

- either the action of $G$ admits a unique fixed point $p$, in which case the restriction of the action of $G$ to $(-\infty, p)$ (respectively, to $(p,+\infty)$ ) is continuously semi-conjugate to an action by translations, and the corresponding morphism $G \rightarrow \mathbb{R}$ is injective, or
- the action of $G$ is continuously semi-conjugate to an action by affine transformations, and the corresponding morphism $G \rightarrow \mathrm{Aff}_{+}(\mathbb{R})$ is injective.

In the opposite direction, Kovačević [14] showed that the above result fails for general Möbius-like groups.

Theorem 1.4 (Kovačević). There exist finitely generated (even finitely presented) Möbius-like subgroups of Homeo ${ }_{+}\left(\mathbb{S}^{1}\right)$ whose action is minimal (every orbit is dense) but not conjugate into $\operatorname{PSL}(2, \mathbb{R})$.

When a subgroup of Homeo $\left(\mathbb{S}^{1}\right)$ has at most 2 fixed points but is not semi-conjugate into $\operatorname{PSL}(2, \mathbb{R})$ (or not even Möbius-like), one may still wonder whether it is abstractly isomorphic to a subgroup of $\operatorname{PSL}(2, \mathbb{R})$. Building on the proof of Theorem A, we settle this problem for the negative.

Theorem B. There exists a finitely generated, elementary group of smooth ( $C^{\infty}$ ) circle diffeomorphisms, with at most 2 fixed points, and which is not isomorphic to any subgroup of $\operatorname{PSL}(2, \mathbb{R})$.

For the next main result, we will consider the following topological condition (inspired by work of Rebelo [18] in the real-analytic setting). To state it, recall (see [9, Proposition 5.6]) that any subgroup $G \leq$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ admits a non-empty $G$-invariant compact subset $\Lambda \subset \mathbb{S}^{1}$ which is minimal with respect to inclusion, called a minimal invariant subset; moreover, if $G$ does not have any periodic orbit, the minimal invariant subset is always unique, and it is either the whole circle or a Cantor set. In particular, when $G \leq$ Homeo $\left(\mathbb{S}^{1}\right)$ is a non-elementary subgroup, we can refer to the minimal invariant subset of $G$. We also say that a non-empty interval $I \subset \mathbb{S}^{1}$ is wandering (for $G$ ) if $\Lambda \cap I=\varnothing$.

Definition 1.5. A non-elementary subgroup $G \leq \operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ of circle homeomorphisms is locally discrete if for every non-wandering interval $I \subset \mathbb{S}^{1}$, the identity is isolated among the collection of restrictions $\left\{\left.g\right|_{I}: g \in G\right\} \subset C^{0}\left(I ; \mathbb{S}^{1}\right)$, with respect to the $C^{0}$ topology.

It is clear that if a subgroup is locally discrete, then it is discrete in the usual sense. In fact, we will see that in the $C^{0}$ topology, the two properties are equivalent (Lemma 4.5), whereas in the real-analytic setting of Rebelo [18], the equivalence is an open problem (see the discussion in Alvarez et al. [1, Remark 1.9]). The condition of considering non-wandering intervals only in the definition sounds technical, but it is actually the appropriate one (see Proposition 4.2). For non-locally discrete groups with at most $N$ fixed points, we prove the following.
Theorem C. Let $G<\operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ be a non-elementary, non-locally discrete subgroup with at most $N$ fixed points. Then, there exists $k \geq 1$ such that $G$ is conjugate to a dense subgroup of $\operatorname{PSL}^{(k)}(2, \mathbb{R})$.
Remark 1.6. The degree of the extension $k$ is given by half of the largest number of fixed points for non-trivial elements in $G$ (which is thus necessarily even).
Corollary D. Let $G<$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ be a non-elementary, non-locally discrete subgroup with at most 2 fixed points. Then, $G$ is conjugate to a dense subgroup of $\operatorname{PSL}(2, \mathbb{R})$.
Remark 1.7. Another consequence of Theorem C is that, if moreover the group $G$ is finitely generated, it necessarily contains elements with irrational number (see Kim, Koberda, and Mj [13, Lemma $2.24]$ ). Actually, a key step of the proof (see Lemma 4.10) is to show that the closure $\bar{G}$ contains an element with irrational rotation number. Let us also comment that when considering finitely generated subgroups $G \leq \operatorname{Diff}_{+}^{1}\left(\mathbb{S}^{1}\right)$ which are non-locally discrete with respect to the $C^{1}$ topology, the analogue conclusion is still open, even in real-analytic regularity (see Matsuda [17]).

Let us describe the structure of the paper. After introducing the main terminology in Section 2, we discuss Theorems A and B in Section 3. The last section is devoted to the proof of Theorem C. Let us give a quick outline of the proof. First of all, we remark that the action of $G$ is minimal (Lemma 4.5). The next step is to understand which elements belong to the $C^{0}$ closure $\bar{G}$ : we prove that $\bar{G}$ has also at most $N$ fixed points (Lemma 4.7) and, up to conjugacy, it contains the group of rotations $\mathrm{SO}(2)$ (Lemma 4.10). We then conclude by using the classification by Giblin and Markovic [10] (see Theorem 4.11) of closed subgroups of Homeo $+\left(\mathbb{S}^{1}\right)$ acting transitively and containing a non-constant continuous path.

## 2. Preliminaries

2.1. Topology of the circle and of the group of circle homeomorphisms. In what follows, we let Homeo $\left(\mathbb{S}^{1}\right)$ be the group of orientation-preserving homeomorphisms of the circle. Here, the circle $\mathbb{S}^{1}$ will be considered as the one-dimensional torus $\mathbb{R} / \mathbb{Z}$, with its normalized Lebesgue measure. Given a Borel subset $A \subset \mathbb{S}^{1}$, we denote by $|A|$ its Lebesgue measure. Any $f \in \operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ lifts to a homeomorphism $F: \mathbb{R} \rightarrow \mathbb{R}$ commuting with integer translations, and this lift is defined uniquely, up to integer translations. This allows to identify the universal cover of Homeo $\left(\mathbb{S}^{1}\right)$ with the group $\mathrm{Homeo}_{\mathbb{Z}}(\mathbb{R})$ of homeomorphisms of the line commuting with integer translations.

If $x, y \in \mathbb{S}^{1}$ are two distinct points, we denote by $(x, y)$ the (open) interval of points $z \in \mathbb{S}^{1}$ such that the triple $(x, z, y)$ is positively ordered. When $x=y,(x, x)$ is by convention, just the empty set. Similarly we denote other kind of intervals $[x, y],[x, y),(x, y]$. We can then define the distance $d(x, y)=\min \{|(x, y)|,|(y, x)|\}$. When $d(x, y)<1 / 2$, this is the usual distance between points in any Euclidean chart containing $x, y$, so that we can write (with slight abuse of notation) $|x-y|$ instead of $d(x, y)$. We want to consider the $C^{0}$ topology on Homeo $\left.+\mathbb{S}^{1}\right)$, and in order to quantify this, we consider the distance $d_{\infty}(f, g):=\sup _{x \in \mathbb{S}^{1}} d(f(x), g(x))$. It is well-known that the distance $d_{\infty}$ on $\mathrm{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ is not complete, and for this reason we will also consider the additional distance $d_{\mathcal{C}^{0}}(f, g):=d_{\infty}(f, g)+d_{\infty}\left(f^{-1}, g^{-1}\right)$, which makes Homeo ${ }_{+}\left(\mathbb{S}^{1}\right)$ complete. When $d_{\infty}(f, g)<1 / 2$, we can take any lifts $\widetilde{f}, \widetilde{g} \in \operatorname{Homeo}_{\mathbb{Z}}(\mathbb{R})$ of $f$ and $g$, respectively, such that $|\widetilde{f}(0)-\widetilde{g}(0)|<1$, and we have $d_{\infty}(f, g)=\|\tilde{f}-\widetilde{g}\|$, where $\|\cdot\|$ is the usual uniform norm on continuous functions. Because of this, when $d_{\infty}(f, g)<1 / 2$, we will also write $\|f-g\|$ for the distance $d_{\infty}(f, g)$, and tacitly make computations in a local Euclidean chart. This also justifies the following definition.
Definition 2.1. Let $f \in \operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ be a circle homeomorphism such that $d_{\infty}(f, \mathrm{id})<1 / 2$. We say that $f$ is positive if for every $x \in \mathbb{S}^{1}$, we have $f(x) \in\left(x, x+\frac{1}{2}\right)$. When $f^{-1}$ is positive, we say that $f$ is negative. Given an interval $I \subset \mathbb{S}^{1}$, we say that $f$ is positive (respectively, negative) on $I$ if the previous conditions hold simply for any $x \in I$.

Remark 2.2. Observe that the definition above implies that a positive (respectively, negative) homeomorphism does not have any fixed point. Moreover, when $f, g \in \operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ are positive, the composition $f g$ is also positive, provided that $d_{\infty}(f, \mathrm{id})+d_{\infty}(g, \mathrm{id})<1 / 2$.

As we work with homeomorphisms having a prescribed bound on the number of fixed points, it is fundamental to have in mind that if $f, g \in \operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ and $x \in \mathbb{S}^{1}$ are such that $f(x)=g(x)$, then $g^{-1} f(x)=x$. When this occurs, we say that $f$ and $g$ cross. More specifically, $I \subset \mathbb{S}^{1}$, we say that $f$ and $g$ cross in $I$ if there exists $x \in I$ such that $f(x)=g(x)$. More specifically, we say that $f$ and $g$ cross hyperbolically at $x$, if $x$ is a (topologically) hyperbolic fixed point (either attracting, or repelling) for the composition $\mathrm{fg}^{-1}$ : equivalently, one has

$$
(f(x-\eta)-g(x-\eta))(f(x+\eta)-g(x+\eta))<0
$$

for any sufficiently small $\eta>0$. We will also say that $f$ and $g$ cross weakly hyperbolically in an interval $I$ if there exists an interval $J=[x, y] \subset I$ (possibly, $x=y$ ) such that $\left.f\right|_{J}=\left.g\right|_{J}$ and

$$
(f(x-\eta)-g(x-\eta))(f(y+\eta)-g(y+\eta))<0
$$

for any sufficiently small $\eta>0$.
Remark 2.3. Having a weakly hyperbolically crossing in some open interval $I$ is stable under sufficiently small $C^{0}$ perturbations.

We will be interested in counting the number of points for which $f(x)=g(x)$, so that we will say that $f$ and $g$ cross once, twice, 3 times, and so on.
2.2. Semi-conjugacy of group actions on the circle. A group action on a topological space $X$ is semi-conjugate to an action of the group on a topological space $Y$ if there exists a continuous equivariant map from $X$ to $Y$. This classical notion of semi-conjugacy in dynamical systems can be slightly modified to get an equivalence relation on group actions on the line and the circle. For a detailed discussion, we refer to the monograph by Kim, Koberda, and Mj [13], from which we borrow some terminology.

Let $G$ be a group, and $\varphi, \psi: G \rightarrow$ Homeo $_{+}(\mathbb{R})$ two homomorphisms. We say that $\varphi$ and $\psi$ are conjugate if there exists $h \in$ Homeo $_{+}(\mathbb{R})$ which is $(\varphi, \psi)$-equivariant: $h(\varphi(g)(x))=\psi(g)(h(x))$ for any $g \in G$ and $x \in \mathbb{R}$. We say that $\varphi$ and $\psi$ are semi-conjugate if there exists a non-decreasing map $h: \mathbb{R} \rightarrow \mathbb{R}$ such that $|h(x)| \rightarrow \infty$ as $|x| \rightarrow \infty$, and which is $(\varphi, \psi)$-equivariant. When the map $h$ is continuous, we recover the usual notion of continuous semi-conjugacy from $\varphi$ to $\psi$.

Similarly, when $\varphi, \psi: G \rightarrow$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$, we say that $\varphi$ and $\psi$ are conjugate if there exists a $(\varphi, \psi)$-equivariant circle homeomorphism. However, for extending the notion of semi-conjugacy to this situation, we have to pass through actions on the line: using the cyclic central extension

$$
1 \rightarrow \mathbb{Z} \rightarrow \text { Homeo }_{\mathbb{Z}}(\mathbb{R}) \rightarrow \text { Homeo }_{+}\left(\mathbb{S}^{1}\right) \rightarrow 1
$$

we say that $\varphi, \psi: G \rightarrow$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ are semi-conjugate if we can find a cyclic central extension

$$
1 \rightarrow \mathbb{Z} \rightarrow \widetilde{G} \rightarrow G \rightarrow 1
$$

and semi-conjugate homomorphisms $\widetilde{\varphi}, \widetilde{\psi}: \widetilde{G} \rightarrow \operatorname{Homeo}_{\mathbb{Z}}(\mathbb{R})$ (in the previous sense), which send any integer $n \in \mathbb{Z} \subset \widetilde{G}$ to the translation by $n$, and lift the homomorphisms $\varphi$ and $\psi$, respectively: in short, the following diagram must commute


When $\tilde{\varphi}$ is continuously semi-conjugate to $\tilde{\psi}$, we say that $\varphi$ is continuously semi-conjugate to $\psi$. Note that this does not coincide with usual notion in dynamical systems, as we only allow continuous semi-conjugacies through degree-1 maps of the circle.

With abuse of terminology, we will also say that the subgroups $\varphi(G), \psi(G)$ are (continuously) (semi-)conjugate, and more generally, we say that two subgroups of homeomorphisms $G_{1}$ and $G_{2}$ are (continuously) (semi-)conjugate, if there exist a group $G$ and surjective homomorphisms $\varphi_{i}: G \rightarrow G_{i}$ (for $i \in\{1,2\}$ ) which are (continuously) (semi-)conjugate.

## 3. Elementary groups

3.1. Basic results. Recall from the introduction that a subgroup $G$ of $\mathrm{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ is elementary if its action preserves a Borel probability measure. Recall from the introduction that an elementary subgroup $G<\operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$, either admits a finite orbit or is semi-conjugate to a subgroup of rotations. We assume that the reader is familiar with the notion of rotation number for circle homeomorphisms. It is well-known that given a circle homeomorphism $g \in \operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$, we can compute its rotation number $\operatorname{rot}(g) \in \mathbb{R} / \mathbb{Z} \cong \mathbb{S}^{1}$ by taking any $g$-invariant Borel probability measure $\mu$ and point $x \in \mathbb{S}^{1}$, and measure how much $x$ is displaced: $\operatorname{rot}(g)=\mu[x, g(x))$. Therefore, if $G<$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ is an elementary subgroup, with invariant Borel probability measure $\mu$, then one has

$$
\operatorname{rot}(f g)=\mu[x, f g(x))=\mu[x, g(x))+\mu[g(x), f g(x))=\operatorname{rot}(g)+\operatorname{rot}(f),
$$

which means that the restriction to $G$ of the function rotation number defines a homomorphism. More precisely, it gives a homomorphism $\rho_{G}: G \rightarrow \mathrm{SO}(2)$ defined by $g \mapsto R_{\mathrm{rot}(g)}$ (which does not depend on the choice of the invariant measure $\mu$ ), and the actions of $G$ and $\rho_{G}(G)$ are semi-conjugate (according to the terminology introduced in the previous section). Moreover, if the action of $G$ has no finite orbit, then $G$ is continuously semi-conjugate to $\rho_{G}(G)$ (see Ghys [9, Proposition 6.17]). We have the following basic result.

Lemma 3.1. Let $G<$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ be a subgroup with an invariant Borel probability measure $\mu$ on $\mathbb{S}^{1}$. Then, the kernel of the homomorphism $\rho_{G}: G \rightarrow \mathrm{SO}(2)$ fixes $\operatorname{supp}(\mu)$ pointwise.

Proof. Take $x \in \operatorname{supp}(\mu)$. If $g \in G$ is such that $g(x) \neq x$, then $\mu[x, g(x)) \neq 0$ and thus $\operatorname{rot}(g) \neq 0$.
Let us give a straightforward application in the case when the elementary subgroup has at most $N$ fixed points.

Lemma 3.2. Let $G<$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ be a subgroup with at most $N$ fixed points, preserving a Borel probability measure $\mu$ on $\mathbb{S}^{1}$, whose support contains at least $N+1$ points. Then, the homomorphism $\rho_{G}: G \rightarrow \mathrm{SO}(2)$ is injective, and $G$ is continuously semi-conjugate to $\rho_{G}(G)$.

In particular, $G$ is isomorphic to a subgroup of $\mathrm{SO}(2)$, and thus abelian.
Proof. If there was an element in the kernel, by Lemma 3.1, it would fix the support of $\mu$, and thus at least $N+1$ points. As we are assuming that $G$ acts with at most $N$ fixed points, this gives that the kernel is trivial. Moreover, if the action of $G$ has a finite orbit, then the image $\rho_{G}(G)$ is finite, and so is $G$. In this case, we have that $G$ is conjugate to $\rho_{G}(G)$ (see e.g. Herman [11, §II.6]). If the action of $G$ has not finite orbit, then by [9, Proposition 6.17] we get that $G$ is continuously semi-conjugate to $\rho_{G}(G)$.
3.2. Möbius-like elementary groups. Here we discuss the first result, namely Theorem A, which states that elementary, Möbius-like subgroups of $\mathrm{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ are continuously semi-conjugate to subgroups of $\operatorname{PSL}(2, \mathbb{R})$.
Proof of Theorem A. Let $\nu$ be a Borel probability measure preserved by the action of $G$ on the circle. If $\operatorname{supp}(\nu)$ contains at least 3 points, then Lemma 3.2 gives that $G$ is continuously semi-conjugate to the subgroup of rotations $\rho_{G}(G) \leq \mathrm{SO}(2)<\mathrm{PSL}(2, \mathbb{R})$, and actually isomorphic.

Thus, from now on, we can assume that the action of $G$ has a finite orbit, which is either a fixed point or a pair of points. Assume first that there is a unique global fixed point for $G$. Then, by Solodov's theorem (Theorem 1.3), $G$ is continuously semi-conjugate to a subgroup of affine transformations, and the corresponding morphism $G \rightarrow \operatorname{Aff}_{+}(\mathbb{R})<\operatorname{PSL}(2, \mathbb{R})$ is injective. Assume next that $G$ has two global fixed points $p, q \in \mathbb{S}^{1}$. After Hölder's theorem (Theorem 1.3), the restrictions of the actions of $G$ to the two connected components of $\mathbb{S}^{1} \backslash\{p, q\}$ are both continuously semi-conjugate to actions by translations, and moreover the corresponding induced homomorphisms $G \rightarrow \mathbb{R}$ and $G \rightarrow \mathbb{R}$ are injective. Therefore, after a continuous global semi-conjugacy (sending $p$ and $q$ to the points 0 and $\infty$ of $\mathbb{R} P^{1}=\mathbb{R} \cup\{\infty\}$ ), we can identify $G$ with a Möbius-like subgroup $\Gamma$ of the group $\Lambda \cong \mathbb{R}^{2}$ of homeomorphisms $f: \mathbb{R} \mathrm{P}^{1} \rightarrow \mathbb{R} \mathrm{P}^{1}$ for which there exist $\alpha=\alpha(f), \beta=\beta(f) \in \mathbb{R}$ such that

$$
f(x)= \begin{cases}e^{\alpha} x & \text { for } x \in[0, \infty], \\ e^{\beta} x & \text { for } x \in[\infty, 0]\end{cases}
$$

From now on, we will work with $\Gamma$ instead of $G$. Take a non-trivial element $f \in \Gamma$, and replacing $f$ by $f^{-1}$ if necessary, we assume $\alpha(f), \beta(f)>0$. Up to replace $\Gamma$ by the subgroup of $\Lambda$ obtained by conjugating $\Gamma$ by the homeomorphism

$$
h(x)= \begin{cases}x^{1 / \alpha(f)} & \text { for } x \in[0, \infty], \\ -(-x)^{1 / \beta(f)} & \text { for } x \in[\infty, 0],\end{cases}
$$

we can assume that $\alpha(f)=\beta(f)=1$.
We claim that also for every other $g \in \Gamma$, we have $\alpha(g)=\beta(g)$. Indeed, if for some $g \in \Gamma, \alpha=\alpha(g)$ and $\beta=\beta(g)$ satisfy $\alpha-\beta \neq 0$, then there exists an integer $N \in \mathbb{Z}$ such that $N(\alpha-\beta)>1$ and so, there exists a second integer $M \in \mathbb{Z}$ such that $N \alpha>M>N \beta$. Therefore, $N \alpha-M>0$ and $N \beta-M<0$ and so for the element $\gamma=g^{N} f^{-M} \in \Gamma$ one has $\alpha(\gamma)>0$ and $\beta(\gamma)<0$. This contradicts the assumption that $\Gamma$ is Möbius-like. Now, since the subgroup of elements $g \in \Lambda$ with $\alpha(g)=\beta(g)$ is a subgroup of $\operatorname{PSL}(2, \mathbb{R})$ (it is the stabilizer of the points 0 and $\infty$ ), we conclude that $\Gamma$ is in $\operatorname{PSL}(2, \mathbb{R})$.

For the last case, we will assume that $G$ has a finite orbit of order 2 , and denote by $\nu$ the corresponding invariant probability measure. After Lemma 3.1, we have a short exact sequence

$$
1 \rightarrow G_{0} \rightarrow G \rightarrow \mathbb{Z}_{2} \rightarrow 1,
$$

where we write $G_{0}=\operatorname{ker}\left(\rho_{G}\right)$. By the previous case (two global fixed points), $G_{0}$ is isomorphic and continuously semi-conjugate to a subgroup of the stabilizer of 0 and $\infty$ in $\operatorname{PSL}(2, \mathbb{R})$, which is
isomorphic to $\mathbb{R}$. By continuity of the rotation number, the closure $\bar{G}$ in $\mathrm{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ also fits a short exact sequence

$$
1 \rightarrow \overline{G_{0}} \rightarrow \bar{G} \rightarrow \mathbb{Z}_{2} \rightarrow 1
$$

and acts on the circle fixing the same two fixed points as $G_{0}$. In particular, it is left-orderable, and actually order-isomorphic to either $\mathbb{Z}$ or $\mathbb{R}$, with the standard order (or the reflected one). Let $a \in G$ be an element of the group with $\operatorname{rot}(a)=1 / 2$. Observe that if $a^{2} \neq \mathrm{id}$ then $a^{2}$ fixes the 2 atoms of $\nu$ and no further point, so they are both parabolic fixed points. This contradicts the Möbius-like assumption. Thus, we must have $a^{2}=\mathrm{id}$. Therefore the exact sequence splits, so that $\bar{G} \cong \overline{G_{0}} \rtimes_{A} \mathbb{Z}_{2}$, where $A$ is the involution of $\operatorname{Aut}\left(\overline{G_{0}}\right)$ defined by the conjugacy by $a$ (clearly this also gives the isomorphism $G \cong G_{0} \rtimes_{A} \mathbb{Z}_{2}$, where we keep denoting by $A$ the restriction of the involution to $\left.G_{0}\right)$. We denote by $-\operatorname{id} \in \operatorname{Aut}\left(G_{0}\right)$ the involution that sends any element to its inverse.
Claim 1. We have $A=-\mathrm{id}$, thus $G \cong G_{0} \rtimes_{-\mathrm{id}} \mathbb{Z}_{2}$.
Proof of claim. Note that $A$ acts as an order-automorphism of order 2 on $\overline{G_{0}}$, which is isomorphic to either $\mathbb{Z}$ or $\mathbb{R}$. Hence it must be $A \in\{i d,-\mathrm{id}\}$. However, if $A=\mathrm{id}$, then any non-trivial element of $G_{0}$ is centralized by $a$, and therefore its two fixed points should have the same dynamical nature (both parabolic), contradicting the Möbius-like assumption. We conclude that $a g a^{-1}=g^{-1}$ for any element of $\overline{G_{0}}$.

Let us now see that $G$ is continuously semi-conjugate to a subgroup of $\operatorname{PSL}(2, \mathbb{R})$. Let $p, q=a(p) \in$ $\mathbb{S}^{1}$ be the finite orbit, and take a $G_{0}$-invariant atomless Radon measure $\mu$ on $(p, q)$ (coming from Hölder's theorem). When $y<x$, we will use the convention $\mu[x, y)=-\mu(y, x]$. With such notation, we have that for any $f \in G_{0}$, there exists a constant $\alpha(f) \in \mathbb{R}$ such that $\mu\left[x_{0}, f(x)\right)=\mu\left[x_{0}, x\right)+\alpha(f)$ for any choice of $x_{0}, x \in(p, q)$. The function $\alpha: G_{0} \rightarrow \mathbb{R}$ is an injective homomorphism, and it actually corresponds, up to a scalar multiple, to the $\alpha(f)$ previously considered. Now, fix a point $x_{0} \in(p, q)$, and consider the function $h: \mathbb{S}^{1} \rightarrow \mathbb{R} \mathrm{P}^{1}$ defined by

$$
h(x)=\left\{\begin{array}{lr}
0 & \text { if } x=p \\
e^{\mu\left[x_{0}, x\right)} & \text { if } x \in(p, q) \\
\infty & \text { if } x=q, \\
-e^{-\mu\left[x_{0}, a(x)\right)} & \text { if } x \in(q, p)
\end{array}\right.
$$

The function $h$ is continuous and of degree 1 . Let us check that it defines a semi-conjugacy from $G$ to the subgroup of $\operatorname{PSL}(2, \mathbb{R})$, generated by the maps

$$
A_{f}(t)=e^{\alpha(f)} t \quad\left(\text { for } f \in G_{0}\right),
$$

and $I(t)=-1 / t$. Indeed, if $x \in(p, q)$, then we have

$$
h(a(x))=-e^{-\mu\left[x_{0}, a(a(x))\right)}=-1 / e^{\mu\left[x_{0}, x\right)}=-1 / h(x)=I(h(x)),
$$

and for $f \in G_{0}$,

$$
h(f(x))=e^{\mu\left[x_{0}, f(x)\right)}=e^{\mu\left[x_{0}, x\right)+\alpha(f)}=e^{\alpha(f)} h(x)=A_{f}(h(x)) .
$$

When $x \in(q, p)$, then we have

$$
h(a(x))=-e^{\mu\left[x_{0}, a(x)\right)}=-1 /\left(-e^{-\mu\left[x_{0}, x\right)}\right)=-1 / h(x)=I(h(x)),
$$

and for $f \in G_{0}$,

$$
h(f(x))=-e^{-\mu\left[x_{0}, a f(x)\right)}=-e^{-\mu\left[x_{0}, f^{-1} a(x)\right)}=-e^{-\mu\left[x_{0}, a(x)\right)-\alpha\left(f^{-1}\right)}=e^{\alpha(f)} h(x)=A_{f}(h(x)) .
$$

This concludes the proof.

### 3.3. A group of smooth diffeomorphisms which is not isomorphic to any Möbius group.

 Here we give an example of group of $C^{\infty}$ circle diffeomorphisms, with at most 2 fixed points, but which is not isomorphic to any subgroup of $\operatorname{PSL}(2, \mathbb{R})$.Proof of Theorem B. For the construction of this example we will consider the following maps with respect to the projective coordinates of the circle: fix $\lambda, \mu>1$ such that $\log \lambda$ and $\log \mu$ are linearly independent over $\mathbb{Q}$, and set

$$
f(x)= \begin{cases}\lambda x & \text { for } x \in[0, \infty], \\ \mu x & \text { for } x \in[\infty, 0] .\end{cases}
$$

For convenience, set $g=R_{\frac{1}{2}} f R_{\frac{1}{2}}$. It is clear that $f$ and $g$ generate a rank 2 abelian free group. Moreover, conjugation by the rotation $R_{\frac{1}{2}}$ defines an action of $\mathbb{Z}_{2}$ on such $\mathbb{Z}^{2}$ given by the matrix

$$
A=\left(\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right)
$$

(with respect to the basis $f, g$ ). In other terms, the group $G=\left\langle f, R_{\frac{1}{2}}\right\rangle$ is isomorphic to the semidirect product $\mathbb{Z}^{2} \rtimes_{A} \mathbb{Z}_{2}$. By construction, one can observe that $G$ acts with at most 2 fixed points.

Claim. The group $G$ is not isomorphic to any subgroup of $\operatorname{PSL}(2, \mathbb{R})$.
Proof of claim. By contradiction, let us assume $G$ is isomorphic to some subgroup $H \leq \operatorname{PSL}(2, \mathbb{R})$. Then $H \cong \mathbb{Z}^{2} \rtimes_{A} \mathbb{Z}_{2}$ is virtually abelian, and therefore its action on $\mathbb{S}^{1}$ preserves a Borel probability measure. We conclude that $H$ is elementary and Möbius-like. In particular, it satisfies the assumptions of Theorem A. Let us go through the cases discussed in its proof. If $H$ preserves an atomless Borel probability measure, that it must be abelian by Lemma 3.2, but this is a contradiction. In the case $H$ has fixed points, then by Solodov's theorem, $H$ is isomorphic to a subgroup of Aff $+(\mathbb{R})$, and therefore torsion free. This is again a contradiction. Therefore we are left with the case of order-2 orbit, so by Claim 1, we have

$$
\begin{equation*}
H \cong \mathbb{Z}^{2} \rtimes_{\text {-id }} \mathbb{Z}_{2}=\left\langle f, g, a \mid[f, g]=\mathrm{id}, a^{2}=\mathrm{id}, a f a^{-1}=f^{-1}, a g a^{-1}=g^{-1}\right\rangle \tag{3.1}
\end{equation*}
$$

However, this contradicts the fact that

$$
\begin{equation*}
H \cong \mathbb{Z}^{2} \rtimes_{A} \mathbb{Z}_{2}=\left\langle f, g, a \mid[f, g]=\mathrm{id}, a^{2}=\mathrm{id}, a f a^{-1}=g\right\rangle \tag{3.2}
\end{equation*}
$$

because the the semi-direct products at lines (3.1) and (3.2) have different abelianizations (as one easily checks from the presentations: (3.1) gives $\left(\mathbb{Z}_{2}\right)^{3}$, while (3.2) gives $\left.\mathbb{Z} \times \mathbb{Z}_{2}\right)$. This ends the proof of the claim.

Finally, conjugating $G$ by a suitable $C^{\infty}$ homeomorphism which is infinitely flat at 0 and $\infty$, we can embed $G$ into $\operatorname{Diff}{ }^{\infty}\left(\mathbb{S}^{1}\right)$. This proves Theorem B.

Remark 3.3. An example of a minimal finitely generated group of circle homeomorphisms, with at most 2 fixed points, and which is not isomorphic to any subgroup of $\operatorname{PSL}(2, \mathbb{R})$, can be built by taking a free product of the group $G$ from Theorem B with itself, obtained by blowing-up a free orbit. This kind of construction is inspired by Kovačević's work [14], and it is detailed in the second author's PhD thesis: indeed, let $G_{1}$ and $G_{2}$ be two copies of the group $G$, considered as acting on distinct circles $\Gamma_{1}$ and $\Gamma_{2}$, and choose any two points $x \in \Gamma_{1}$ and $y \in \Gamma_{2}$ with trivial stabilizer in $G_{1}$ and $G_{2}$, respectively. Then, [4, Theorem D] gives that the amalgamated product $\left(G_{1}, x\right) \star\left(G_{2}, y\right)$ (properly defined after [4, Theorem 4.7]; note that in this case it is simply a free product) is a subgroup of $\mathrm{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ acting minimally, and with at most 2 fixed points.

## 4. NON-LOCALLY DISCRETE GROUPS WITH AT MOST $N$ fiXED POINTS

In this section we discuss Theorem C, about non-locally discrete groups with at most $N$ fixed points. We start this section with an example that justifies our definition of non-local discreteness (Definition 1.5).

We first need a result that can be seen as a consequence of the "Projective Baumslag Lemma" [13, Lemma 3.4].

Lemma 4.1. Let $A \leq \operatorname{PSL}(2, \mathbb{R})$ be a countable subgroup. Then, there exists a countable set $D \subset \mathrm{SO}(2)$ such that for every rotation $R_{\rho} \in \mathrm{SO}(2) \backslash D$, the subgroup $\left\langle A, R_{\rho}\right\rangle$ is isomorphic to the free product $A *\left\langle R_{\rho}\right\rangle$.
Proof. The subgroup $\mathrm{SO}(2)$ is a maximal abelian subgroup of $\operatorname{PSL}(2, \mathbb{R})$, acting without fixed points. Let

$$
w=\left(k, g_{1}, \ldots, g_{k}, m_{1}, \ldots, m_{k}\right)
$$

be a choice of an integer $k \geq 1$, non-trivial elements $g_{1}, \ldots, g_{k} \in A$, and finitely many integers $m_{1}, \ldots, m_{k} \in \mathbb{Z} \backslash\{0\}$ (so, there are countably many such choices). By [13, Lemma 3.4], for any such $w$, there exists a finite subset $D_{w} \subset \mathrm{SO}(2)$ such that for any $R_{\rho} \in \mathrm{SO}(2) \backslash D_{w}$ the composition

$$
\phi(w)=g_{1} R_{\rho}^{m_{1}} \cdots g_{k} R_{\rho}^{m_{k}}
$$

is non-trivial (more precisely, the square of its trace is different from 4). We can then take $D=$ $\bigcup_{w} D_{w}$, which is a countable union of finite subsets, and hence countable.
Proposition 4.2. There exists a finitely generated non-elementary subgroup $G<\operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ with at most 2 fixed points, which is not Möbius-like, and for which there exists a wandering interval $I \subset \mathbb{S}^{1}$ such that the image of $\operatorname{Stab}(G, I)$ is non-discrete in $\mathrm{Homeo}_{+}(I)$.

Proof. First, we will construct a non-elementary subgroup of $\operatorname{PSL}(2, \mathbb{R})$ with the stabilizer of a point $p \in \mathbb{S}^{1}$ being parabolic and isomorphic to $\mathbb{Z}^{2}$. For this, let $T_{\alpha}, T_{\beta}$ be two parabolic elements of $\operatorname{PSL}(2, \mathbb{R})$ fixing the same point $p \in \mathbb{S}^{1}$, such that the subgroup $T=\left\langle T_{\alpha}, T_{\beta}\right\rangle$ is free abelian of rank 2. After Lemma 4.1, we can find an irrational rotation $R_{\rho} \in \mathrm{SO}(2)$ such that $F=\left\langle T, R_{\rho}\right\rangle$ is isomorphic to the free product $T *\left\langle R_{\rho}\right\rangle \cong \mathbb{Z}^{2} * \mathbb{Z}$. Observe that the stabilizer of the point $p$ has not changed, that is $\operatorname{Stab}(F, p)=\operatorname{Stab}(T, p)=T$. Indeed, for every element $g \in \operatorname{PSL}(2, \mathbb{R})$ that fixes the point $p$, we have that the parabolic element $g T_{\alpha} g^{-1}$ fixes $p$ and so it commutes with $T_{\alpha}$; so if $\operatorname{Stab}(F, p) \neq T$, we could then find an element $g \in F \backslash T$ such that $\left[g T_{\alpha} g^{-1}, T_{\alpha}\right]=\mathrm{id}$. This is not possible after our choice of $R_{\rho}$. Finally, note that $F$ is a non-elementary subgroup of PSL $(2, \mathbb{R})$ with a parabolic stabilizer $T$ of the point $p$ isomorphic to $\mathbb{Z}^{2}$.

For the second step of the construction, we blow-up the action of $F$ at the orbit of $p$ (see for instance Kim and Koberda [12]), in such a way that the action of the stabilizer $T$ on the interval $I$ inserted at $p$ is conjugate to the original action of $T$ on $\mathbb{S}^{1} \backslash\{p\} \cong \mathbb{R}$ (which is a minimal action by translations). Choosing the good orientation for this $T$-action on $I$, we have that any non-trivial element of $T$ acts on the new circle with 2 parabolic fixed points. We call $G$ the resulting subgroup of Homeo $\left(\mathbb{S}^{1}\right)$, which is abstractly isomorphic to $F \cong \mathbb{Z}^{2} * \mathbb{Z}$. It is not difficult to verify that any non-trivial element of $G$ has at most 2 fixed points (we do not have changed the action on the complement of the $F$-orbit of $p$, and conjugates of $T$ are now acting with at most 2 fixed points). Therefore, $G$ is a non-elementary group of circle homeomorphisms, with at most 2 fixed points. The subgroup $\operatorname{Stab}(G, I) \cong T$ acts on $I$ minimally by translations, and thus its image in $\mathrm{Homeo}_{+}(I)$ is non-discrete.

It turns out that non-discreteness and non-local discreteness are equivalent for non-elementary subgroups. To see this, we need a fundamental structural result for non-elementary subgroups. To state it, we say that the action of a subgroup $G \leq \operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ is proximal if for every non-empty open intervals $I, J \subset \mathbb{S}^{1}$, there exists an element $g \in G$ such that $g(I) \subset J$. Note that if the
action is proximal, then it is automatically minimal, and $G$ non-elementary. Being proximal is not invariant under semi-conjugacy, since if $J$ is a wandering interval and $I$ is not, there is no way we can send $I$ inside $J$. For this reason, we also say that the action of a non-elementary subgroup $G$ is proximal in restriction to the minimal invariant subset if the previous statement holds only for intervals $J \subset \mathbb{S}^{1}$ which are non-wandering (that is, intersecting the minimal invariant subset). This property is preserved under semi-conjugacy, and when the action is minimal, we recover the usual notion of proximal action. In particular, any non-elementary subgroup $G$ which is proximal in restriction to the minimal invariant subset is (continuously) semi-conjugate to a proximal action. As a consequence, if $G$ is proximal in restriction to the minimal invariant subset, then it is automatically non-elementary. The following fundamental result can be deduced from the work of Antonov [2], although it has been unknown to experts for a long time (see e.g. Ghys [9, §5.2]). Our statement is very close to that appearing in the work of Malyutin [16, Theorem 1].
Theorem 4.3 (Antonov). Let $G \leq H_{0 m e o}^{+}\left(\mathbb{S}^{1}\right)$ be a non-elementary subgroup. Then there exists a finite order element $\gamma \in$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ which commutes with every $g \in G$, and such that the induced action of $G$ on the quotient $\mathbb{S}^{1} /\langle\gamma\rangle$ is proximal in restriction to the minimal invariant subset.
Remark 4.4. In the setting of Theorem 4.3, several dynamical properties are equivalent for the actions of $G$ on $\mathbb{S}^{1}$ and $\mathbb{S}^{1} /\langle\gamma\rangle$ :

- (local) discreteness,
- minimality,
- all non-trivial elements have a uniformly bounded number of fixed points (because if $\gamma$ is of order $d$, and an element $g \in G$ acts on $\mathbb{S}^{1} /\langle\gamma\rangle$ with $k$ fixed points, then $g^{d}$ acts on $\mathbb{S}^{1}$ with $d k$ fixed points).
In particular, the last argument gives that if an element $g \in G$ acts on $\mathbb{S}^{1} /\langle\gamma\rangle$ without fixed points, then it also acts without fixed points on $\mathbb{S}^{1}$.

We will use this correspondence several times in the rest of the section to work under the more convenient assumption that the action of $G$ on $\mathbb{S}^{1}$ is proximal in restriction to the minimal set.
Lemma 4.5. If $G \leq$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ is a non-elementary, non-locally discrete subgroup, then $G$ is non-discrete.

Moreover, if $G$ has at most $N$ fixed points, its action on the circle is minimal.
Proof. Because of the principle in Remark 4.4, we can assume that the action of $G$ on $\mathbb{S}^{1}$ is proximal in restriction to the minimal invariant subset. Since $G$ is non-locally discrete, there exists a nonwandering open interval $I \subset \mathbb{S}^{1}$, and a sequence of non-trivial elements $\left(g_{n}\right)_{n \in \mathbb{N}} \subset G$, such that $\left.\left.g_{n}\right|_{I} \rightarrow \mathrm{id}\right|_{I}$. If $\bar{I}=\mathbb{S}^{1}$, we immediately get that $G$ is non-discrete. Otherwise, fix $\eta \in\left(0, \frac{1}{2}\right)$, and a non-wandering open interval $J=(a, b) \subset \mathbb{S}^{1}$ with $|J|<\frac{\eta}{2}$. By proximality in restriction to the minimal invariant subset, we can find an element $f \in G$ such that $f\left(\mathbb{S}^{1} \backslash \bar{I}\right) \subset J$. By continuity of composition, we have that the sequence of conjugates $h_{n}:=f g_{n} f^{-1}$ converges to the identity in restriction to $f(I)$. In particular, we can fix $n \in \mathbb{N}$ such that $\left|h_{n}(x)-x\right|<\frac{\eta}{2}$ for every $x \in f(I)$. On the other hand, if $x \in J=(a, b)$, as $a, b \in f(I)$, we have

$$
a-\frac{\eta}{2} \leq h_{n}(a) \leq h_{n}(x) \leq h_{n}(b) \leq b+\frac{\eta}{2}
$$

and since $|J|<\frac{\eta}{2}$, this gives

$$
-\eta<(a-x)-\frac{\eta}{2} \leq h_{n}(x)-x \leq(b-x)+\frac{\eta}{2}<\eta .
$$

As $\mathbb{S}^{1}=f(I) \cup J$, we conclude that $\left|h_{n}(x)-x\right|<\eta$ for any $x \in \mathbb{S}^{1}$, as wanted.
For the second part of the statement, assume the action admits an invariant Cantor set $\Lambda \subset \mathbb{S}^{1}$. For any given $\varepsilon>0$, every element $g \in G$ which is $\varepsilon$-close to the identity must fix every gap of $\Lambda$ (that is, any connected component of the complement of $\Lambda$ ) whose size exceeds $\varepsilon$. For sufficiently small $\varepsilon$, this gives that $g$ fixes more than $N$ points, and thus $g=\mathrm{id}$.

Lemma 4.6. Let $G<$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ be a non-elementary, non-discrete subgroup with at most $N$ fixed points. Then, there exists a sequence of fixed-point-free elements in $G$ converging to the identity.
Proof. After Lemma 4.5, we know that the action of $G$ on $\mathbb{S}^{1}$ is minimal. Using again the correspondence in Remark 4.4, we can assume that $G$ is proximal. Under this additional assumption, we can take a sequence of non-trivial elements converging to the identity whose fixed points are all contained in an arbitrarily small interval:

Claim 1. For every interval $J \subset \mathbb{S}^{1}$ and every $\varepsilon>0$, there exists an element $g \in G$ which is $\varepsilon$-close to the identity and has no fixed points in the interval $J$.

Proof of claim. Let $\left(g_{n}\right)_{n \in \mathbb{N}} \subset G$ be a sequence of non-trivial elements such that $g_{n} \rightarrow$ id. If $\left(g_{n}\right)_{n \in \mathbb{N}} \subset G$ contains a subsequence without fixed points, there is nothing to do. Otherwise, by taking a subsequence, we can assume that the fixed points of $g_{n}$ are converging to points $p_{1}, \ldots, p_{M} \in$ $\mathbb{S}^{1}$, for some $M \leq N$. Let $J \subset \mathbb{S}^{1}$ be any closed interval. By proximality of $G$, there exists an element $k \in G$ which sends $p_{1}, \ldots, p_{M}$ to the complement of $J$. Now, by choosing $g_{n}$ close enough to the identity, we can assume that $k g_{n} k^{-1} \in G$ is $\varepsilon$-close to the identity, and that this element only fixes points which are in the complement of the interval $J$.

Throughout the rest of the proof, we use the distance $d_{\infty}$ on $\mathrm{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ to quantify how close elements are. Recall that this can be locally computed by using the uniform norm $\|\cdot\|$. We assume by contradiction that for a fixed (small) $\varepsilon>0$, every element $\varepsilon$-close to the identity has fixed points. After Claim 1, we can define recursively a sequence of nested intervals $\left(J_{n}\right) \subset \mathbb{S}^{1}$ with the following properties.
(1) The sequence $\left(J_{n}\right)$ is shrinking to a point $p \in \mathbb{S}^{1}$, namely $\bigcap_{n} J_{n}=\{p\}$.
(2) For any $n \in \mathbb{N}$, there exists an element $g_{n} \in G$ such that $\left\|g_{n}-\mathrm{id}\right\| \leq \frac{\varepsilon}{2}$ and $g_{n}$ is positive on the complement of $J_{n}$, with $g_{n}\left(J_{n}\right)=J_{n}$.
Claim 2. For any $n \in \mathbb{N}$ such that $\left|J_{n}\right|<1-\frac{\varepsilon}{2}$, there exists $m \in \mathbb{N}$ such that $\frac{\varepsilon}{4}<\left\|g_{n}^{m}-\mathrm{id}\right\| \leq \frac{\varepsilon}{2}$.
Proof of claim. Indeed, if we assume that $g_{n}$ is $\frac{\varepsilon}{4}$-close to the identity (otherwise $m=1$ works), since $g_{n}$ has fixed points only in $J_{n}$, for a sufficiently large power $m \in \mathbb{N}$, the distance of $g_{n}^{m}$ to the identity will be larger than $\frac{\varepsilon}{2}$. Therefore, there exists $m_{0} \in \mathbb{N}$ such that $g_{n}^{m_{0}}$ is not $\frac{\varepsilon}{2}$-close to the identity, but $g_{n}^{m}$ is $\frac{\varepsilon}{2}$-close to the identity for every $0 \leq m<m_{0}$. The point is that $g_{n}^{m_{0}-1}$ is $\frac{\varepsilon}{2}$-close to the identity, but it is not $\frac{\varepsilon}{4}$-close: indeed, there exists $x \in \mathbb{S}^{1}$ such that

$$
\frac{\varepsilon}{2}<\left|g_{n}^{m_{0}}(x)-x\right|<\left|g_{n}\left(g_{n}^{m_{0}-1}(x)\right)-g_{n}^{m_{0}-1}(x)\right|+\left|g_{n}^{m_{0}-1}(x)-x\right|<\frac{\varepsilon}{4}+\left|g_{n}^{m_{0}-1}(x)-x\right|
$$

This proves the claim.
From now on, after Claim 2, we can and will assume that $\frac{\varepsilon}{4}<\left\|g_{n}-\mathrm{id}\right\| \leq \frac{\varepsilon}{2}$. Hence, when $n$ is sufficiently large so that $\left|J_{n}\right|<\frac{\varepsilon}{4}$, we can find a point $x_{n} \in \mathbb{S}^{1} \backslash J_{n}$ such that $g_{n}\left(x_{n}\right)>x_{n}+\frac{\varepsilon}{4}$. Consider the interval $I_{n} \subset \mathbb{S}^{1}$ defined by $I_{n}:=\left(x_{n}+\frac{\varepsilon}{12}, x_{n}+\frac{\varepsilon}{6}\right)$. After passing to a subsequence, we can assume that $x_{n}$ converges to a point $x \in \mathbb{S}^{1}$, and for $n_{0} \in \mathbb{N}$ large enough we have that $I:=\bigcap_{n \geq n_{0}} I_{n}$ is a non-trivial interval. With such choices, for every $y \in I$ and $n \geq n_{0}$ we have $x_{n}+\frac{\varepsilon}{6}>y$ and

$$
\begin{equation*}
g_{n}(y)>g_{n}\left(x_{n}\right)>x_{n}+\frac{\varepsilon}{4}>y+\frac{\varepsilon}{12} \tag{4.1}
\end{equation*}
$$

On the other hand, for every $n \in \mathbb{N}$, the interval $J_{n}$ is disjoint from the interval $\left[x_{n}, x_{n}+\frac{\varepsilon}{4}\right]$, so that by choosing $n_{1} \geq n_{0}$ such that $\left|x_{n}-x\right|<\frac{\varepsilon}{48}$ for any $n \geq n_{1}$, we have that the intervals $I$ and $J_{n}$ are at least $\frac{\varepsilon}{24}$-apart for any such $n$. We deduce that the union $J:=\bigcup_{n \geq n_{1}} J_{n}$ and $I$ are at least $\frac{\varepsilon}{24}$-apart. After Claim 1, we can take an element $f \in G$ which is $\frac{\varepsilon}{2}$-close to the identity, and negative on the complement of $I$. As $J$ and $I$ are separated, we can find $\delta>0$ such that $f(y)<y-\delta$ for every $y \in J$.

Take $m>n_{1}$ sufficiently large such that $\left|J_{m}\right|<\delta$; we claim that the element $f^{-1} g_{m} \in G$ is $\varepsilon$-close to the identity and it has no fixed points in the circle. Indeed, since $f$ is negative on the complement of $I$ and $g_{m}$ is positive on the complement of $J_{m}$, it is clear that $g_{m}$ does not cross $f$ in the complement of $J_{m} \cup I$. Now, we have $|I| \leq\left|I_{m}\right|=\frac{\varepsilon}{12}$, so that from the inequality (4.1) we deduce that $g_{m}$ does not cross $f$ in $I$. Similarly, the size of the interval $J_{m}$ is smaller than $\delta$ and $f(y)<y-\delta$ for every $y \in J \supset J_{m}$, which implies that $g_{m}$ does not cross $f$ in $J_{m}$. Therefore, $g_{m}$ does not cross $f$ in the whole circle $\mathbb{S}^{1}$, which implies that the element $f^{-1} g_{m}$ has no fixed points in $\mathbb{S}^{1}$. Finally, as $f^{-1} g_{m}$ is the composition of two elements $\frac{\varepsilon}{2}$-close to the identity, this element is $\varepsilon$-close to the identity, as desired.

Given a subgroup $G \leq$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$, we denote by $\bar{G}$ its closure in Homeo $\left(\mathbb{S}^{1}\right)$ with respect to the $C^{0}$ topology, which is still a subgroup of $\operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$.
Lemma 4.7. Let $G<\operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ be a non-elementary, non-discrete subgroup with at most $N$ fixed points. Then, its closure $\bar{G}$ has at most $N$ fixed points.

Proof. As before, we use the correspondence in Remark 4.4 to work under the additional assumption that $G$ is proximal. We then remark that any $f \in \bar{G}$ has at most $\left\lfloor\frac{N}{2}\right\rfloor$ components $I$ of $\operatorname{supp}(f):=$ $\mathbb{S}^{1} \backslash \operatorname{Fix}(f)$ for which $f(x)>x$ for every $x \in I$. Indeed, arguing by contradiction, by Lemma 4.6, we can take an element $g \in G$, sufficiently close to the identity and without fixed points, so that $g$ crosses weakly hyperbolically the element $f$ at least $2\left(\left\lfloor\frac{N}{2}\right\rfloor+1\right) \geq N+1$ times. After Remark 2.3, we can find an element $f_{0} \in G$ sufficiently close to $f$, which also crosses hyperbolically $g$ at least $N+1$ times. This contradicts the assumption that $G$ have at most $N$ fixed points. Repeating the $\operatorname{argument}$ for $f^{-1}$, we deduce that $\operatorname{supp}(f)$ has at most $2\left\lfloor\frac{N}{2}\right\rfloor \leq N$ connected components, and so does $\operatorname{Fix}(f)$.

Assume now that $\bar{G}$ contains a non-trivial element $f$ such that $\operatorname{Fix}(f)$ contains a non-empty open interval $I$. Let us choose such an element $f \in \bar{G}$ such that the number $C$ of connected components of $\operatorname{supp}(f)$ is maximal. As we are assuming that $G$ be proximal, we can find an element $h \in G$ such that $\overline{h(\operatorname{supp}(f))} \subset I$. Then the element $f^{\prime}=f h f h^{-1} \in \bar{G}$ is such that $\operatorname{supp}\left(f^{\prime}\right)$ has $2 C>C$ connected components, contradicting maximality.

The next result we need is very general (and classical).
Lemma 4.8. Let $f \in$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ be a circle homeomorphism of order $q \geq 2$, with rotation number $\operatorname{rot}(f)=\frac{p}{q}$, where $p \geq 1$ is a natural number. Then, for every $\varepsilon>0$ there exists $\delta \in(0,1 / 2)$ such that for every circle homeomorphism $g \in \operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ which is positive and $\delta$-close to the identity, one has

$$
d_{\mathcal{C}^{0}}(f, g f)<\varepsilon \quad \text { and } \quad \operatorname{rot}(g f) \in\left(\frac{p}{q}, \frac{p}{q}+\frac{1}{q^{3}}\right]
$$

Proof. Note that the homeomorphism $f$ is conjugate in Homeo $\left(\mathbb{S}^{1}\right)$ to the rotation $R_{p / q}$ (see Herman $[11, \S I I .6]$ ) Since $\operatorname{Homeo}_{+}\left(\mathbb{S}^{1}\right)$ is a topological group (so composition, and thus conjugacy, are continuous), and since the function rotation number is continuous on Homeo ${ }_{+}\left(\mathbb{S}^{1}\right)$, and conjugacyinvariant, we can assume $f=R_{p / q}$, and fix $\varepsilon>0$ and $\delta>0$ such that

$$
\begin{equation*}
d_{\mathcal{C}^{0}}\left(R_{p / q}, g R_{p / q}\right)<\varepsilon \quad \text { and } \quad \operatorname{rot}\left(g R_{p / q}\right) \in\left(\frac{p}{q}-\frac{1}{q^{3}}, \frac{p}{q}+\frac{1}{q^{3}}\right] \tag{4.2}
\end{equation*}
$$

for every circle homeomorphism $g \in$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ which is $\delta$-close to the identity.
Let us next make the basic observation that if $h, k \in \operatorname{Homeo}_{+}(\mathbb{R})$ are two homeomorphisms of the real line such that $h \leq k$ (meaning that $h(x) \leq k(x)$ for any $x \in \mathbb{R}$ ), then for any integer $n \geq 0$, one has $h^{n} \leq k^{n}$. This can be easily checked by induction:

$$
h^{n}(x)=h\left(h^{n-1}(x)\right) \leq h\left(k^{n-1}(x)\right) \leq k\left(k^{n-1}(x)\right)=k^{n}(x)
$$

For homeomorphisms $h \in \operatorname{Homeo}_{\mathbb{Z}}(\mathbb{R})$ of the real line commuting with integer translations, the translation number $\tau(h)$ is defined as

$$
\tau(h)=\lim _{n \rightarrow \infty} \frac{h^{n}(x)}{n}
$$

and this limit does not depend on the choice $x \in \mathbb{R}$. Consequently, if $h, k \in \operatorname{Homeo}_{\mathbb{Z}}(\mathbb{R})$ are such that $h \leq k$, then $\tau(h) \leq \tau(k)$. The rotation number $\operatorname{rot}(f)$ of a homeomorphism $f \in$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ is classically defined by taking any lift $\tilde{f} \in \operatorname{Homeo}_{\mathbb{Z}}(\mathbb{R})$ and setting $\operatorname{rot}(f)=\tau(\tilde{f})(\bmod \mathbb{Z})$.

For what follows, we denote by $T_{\alpha}$ the translation by $a \in \mathbb{R}$. Lift $f=R_{p / q}$ to the translation $T_{p / q}$. If $g \in$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ is positive and $\delta$-close to the identity, we can find some $\lambda \in(0, \delta)$ and a lift $\widetilde{g} \in \operatorname{Homeo}_{\mathbb{Z}}(\mathbb{R})$ such that $T_{p / q}<T_{p / q+\lambda} \leq \widetilde{g} T_{p / q} \leq T_{p / q+\delta}$. Taking translation numbers, we get

$$
p / q+\lambda \leq \tau\left(\widetilde{g} R_{p / q}\right) \leq p / q+\delta
$$

so that passing to rotation numbers, and considering condition (4.2), we get

$$
\operatorname{rot}\left(g R_{p / q}\right) \in\left[\frac{p}{q}+\lambda, \frac{p}{q}+\frac{1}{q^{3}}\right],
$$

as desired.
Lemma 4.9. Let $G<$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ be a non-elementary, non-discrete subgroup with at most $N$ fixed points. Then, $\bar{G}$ contains an element with irrational rotation number.
Proof. If the subgroup $G<$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ has an element with irrational rotation number there is nothing to prove, because $G \subset \bar{G}$. Therefore, we will suppose that $G$ has no element with irrational rotation number. We want to construct a converging sequence $\left(h_{n}\right)_{n \in \mathbb{N}} \subset G$ whose limit $h \in \bar{G}$ has irrational rotation number.

We start by choosing a sequence of elements $\left(f_{n}\right)_{n \in \mathbb{N}} \subset G$ without fixed points and converging to the identity, whose existence is ensured by Lemma 4.6. After changing $f_{n}$ for $f_{n}^{-1}$ when necessary and taking a subsequence, we can assume that $\left(f_{n}\right)_{n \in \mathbb{N}}$ is a sequence of positive circle homeomorphisms whose distance to the identity decreases. Let us fix also a sequence $\left(\varepsilon_{n}\right)_{n \in \mathbb{N}}$ of positive numbers such that $\sum \varepsilon_{n}<1 / 2$. We choose $h_{0} \in G$ to be the first element $f_{m_{0}}$ such that $d_{\mathcal{C}^{0}}\left(f_{m_{0}}\right.$, id $)<\varepsilon_{0}$. We write $\operatorname{rot}\left(h_{0}\right)=p_{0} / q_{0}$, where $p_{0}, q_{0} \geq 1$ are natural numbers with $\operatorname{gcd}\left(p_{0}, q_{0}\right)=1$.

Now, let us assume by induction that $h_{n} \in G$ is a positive circle homeomorphism such that $d_{\mathcal{C}^{0}}\left(h_{n}, \mathrm{id}\right)<\sum_{k=0}^{n} \varepsilon_{k}$ and of rational rotation number

$$
\operatorname{rot}\left(h_{n}\right)=\frac{p_{n}}{q_{n}} \in\left(\frac{p_{n-1}}{q_{n-1}}, \frac{p_{n-1}}{q_{n-1}}+\frac{1}{q_{n-1}^{3}}\right],
$$

where $p_{n}, q_{n} \geq 1$ are natural numbers with $\operatorname{gcd}\left(p_{n}, q_{n}\right)=1$. As $G$ has at most $N$ fixed points, whenever $q_{n}>N$ (this condition is satisfied for any sufficiently large $n \in \mathbb{N}$ ), we must have $h_{n}^{q_{n}}=\mathrm{id}$. By Lemma 4.8, there exists $\delta_{n}>0$ such that for every positive circle homeomorphism $g \in$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ which is $\delta_{n}$-close to the identity, we have that $d_{\mathcal{C}^{0}}\left(h_{n}, g h_{n}\right)<\varepsilon_{n+1}$ and $\operatorname{rot}\left(g h_{n}\right) \in$ $\left(\frac{p_{n}}{q_{n}}, \frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{3}}\right]$. Then, we define $h_{n+1}$ as $f_{m_{n}} h_{n} \in G$, where $f_{m_{n}}$ is the first element of the sequence $\left(f_{n}\right)_{n \in \mathbb{N}}$ such that $d_{\mathcal{C}^{0}}\left(f_{m_{n}}, \mathrm{id}\right)<\delta_{n}$. This gives that

$$
d_{\mathcal{C}^{0}}\left(h_{n+1}, \mathrm{id}\right) \leq d_{\mathcal{C}^{0}}\left(h_{n+1}, h_{n}\right)+d_{\mathcal{C}^{0}}\left(h_{n}, \mathrm{id}\right)<d_{\mathcal{C}^{0}}\left(f_{m_{n}} h_{n}, h_{n}\right)+\sum_{k=0}^{n} \varepsilon_{k}<\sum_{k=0}^{n+1} \varepsilon_{k} .
$$

Since $\sum_{k=0}^{n+1} \varepsilon_{k}<\frac{1}{2}, h_{n+1} \in G$ is a positive circle homeomorphism (Remark 2.2). By our assumption on $G$, the rotation number of $h_{n+1}$ is rational, and we write $\operatorname{rot}\left(h_{n+1}\right)=\frac{p_{n+1}}{q_{n+1}}$, which belongs to $\left(\frac{p_{n}}{q_{n}}, \frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{3}}\right]$ by construction. Hence, the inductive assumptions are satisfied.

We next check that $\left(h_{n}\right)$ is a Cauchy sequence with respect to the $d_{\mathcal{C}^{0}}$-distance (for which Homeo $_{+}\left(\mathbb{S}^{1}\right)$ is complete), so that it admits a limit $h \in \bar{G}$. Indeed, for every $n, m \in \mathbb{N}$ we have

$$
d_{\mathcal{C}^{0}}\left(h_{n+m}, h_{n}\right) \leq \sum_{k=n}^{n+m} d_{\mathcal{C}^{0}}\left(h_{k+1}, h_{k}\right)<\sum_{k=n}^{n+m} \varepsilon_{k}<\sum_{k=n}^{+\infty} \varepsilon_{k} \xrightarrow{n \rightarrow+\infty} 0 .
$$

It remains to prove that $\operatorname{rot}(h) \notin \mathbb{Q}$. To see this, for every $n \in \mathbb{N}$, we consider the interval $I_{n}=\left(\frac{p_{n}}{q_{n}}, \frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{2}}\right)$. By the classical Dirichlet's approximation theorem, we have that $I_{n}$ is a nested sequence of intervals, such that $\bigcap I_{n}$ is an irrational number. Let us detail this for completeness. First, we recall that

$$
\frac{p_{n+1}}{q_{n+1}} \in\left(\frac{p_{n}}{q_{n}}, \frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{3}}\right],
$$

so that $\frac{p_{n+1}}{q_{n+1}}>\frac{p_{n}}{q_{n}}$. Next, we want to prove that $\frac{p_{n+1}}{q_{n+1}}+\frac{1}{q_{n+1}^{2}}<\frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{2}}$. We will first show that $q_{n+1}>q_{n}$. Indeed, if $q_{n+1} \leq q_{n}$ then

$$
p_{n+1} \in\left(\frac{p_{n} q_{n+1}}{q_{n}}, \frac{p_{n} q_{n+1}}{q_{n}}+\frac{q_{n+1}}{q_{n}^{3}}\right] \subset\left(\frac{p_{n} q_{n+1}}{q_{n}}, \frac{p_{n} q_{n+1}}{q_{n}}+\frac{1}{q_{n}^{2}}\right],
$$

which is an absurd, because $\left(\frac{p_{n} q_{n+1}}{q_{n}}, \frac{p_{n} q_{n+1}}{q_{n}}+\frac{1}{q_{n}^{2}}\right]$ does not contain any integer. Now, we have the following inequality

$$
\begin{aligned}
& \frac{p_{n+1}}{q_{n+1}}+\frac{1}{q_{n+1}^{2}} \leq \frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{3}}+\frac{1}{q_{n+1}^{2}} \leq \frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{3}}+\frac{1}{\left(q_{n}+1\right)^{2}}=\frac{p_{n}}{q_{n}}+\frac{q_{n}^{3}+\left(q_{n}+1\right)^{2}}{q_{n}^{3}\left(q_{n}+1\right)^{2}} \\
= & \frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{2}} \frac{q_{n}^{3}+q_{n}^{2}+2 q_{n}+1}{q_{n}^{3}+2 q_{n}^{2}+q_{n}}<\frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{2}} \frac{q_{n}^{3}+q_{n}^{2}+2 q_{n}+1+\left(q_{n}^{2}-q_{n}-1\right)}{q_{n}^{3}+2 q_{n}^{2}+q_{n}}=\frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{2}} .
\end{aligned}
$$

So, we conclude that $I_{n+1} \subset I_{n}$ for every $n \in \mathbb{N}$. On the other hand, $\left(q_{n}\right)_{n \in \mathbb{N}}$ is an increasing sequence of integers, and therefore $\left|I_{n}\right|=\frac{1}{q_{n}^{2}} \longrightarrow 0$. Hence, $\bigcap_{n \in \mathbb{N}} I_{n}$ converges to a point $\alpha \in \mathbb{R}$. We claim that $\alpha$ is not a rational number, otherwise $\alpha=\frac{p}{q}$ with $p, q \in \mathbb{Z}$, and $q \geq 2$, which implies that $\frac{p}{q} \in I_{n}=\left(\frac{p_{n}}{q_{n}}, \frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{2}}\right)$, for every $n \in \mathbb{N}$. Therefore, for $n$ sufficiently large, we have $2 q<q_{n}$ and then

$$
p \in\left(\frac{p_{n} q}{q_{n}}, \frac{p_{n} q}{q_{n}}+\frac{q}{q_{n}^{2}}\right) \subset\left(\frac{p_{n} q}{q_{n}}, \frac{p_{n} q}{q_{n}}+\frac{1}{2 q_{n}}\right),
$$

which is an absurd, because $\left(\frac{p_{n} q}{q_{n}}, \frac{p_{n} q}{q_{n}}+\frac{1}{2 q_{n}}\right)$ does not contain any integer.
Let us go back to our converging sequence $\left(h_{n}\right)$. By construction we have

$$
\operatorname{rot}\left(h_{n+1}\right) \in\left(\frac{p_{n}}{q_{n}}, \frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{3}}\right] \subset\left(\frac{p_{n}}{q_{n}}, \frac{p_{n}}{q_{n}}+\frac{1}{q_{n}^{2}}\right)=I_{n},
$$

so that $\operatorname{rot}\left(h_{n+k}\right) \in I_{n+k} \subset I_{n}$ for any $k \geq 1$. Hence, by continuity of rot: Homeo ${ }_{+}\left(\mathbb{S}^{1}\right) \rightarrow \mathbb{S}^{1}$, it follows that $\operatorname{rot}(h) \in I_{n}$, for every $n \in \mathbb{N}$, and therefore $\operatorname{rot}(h)=\alpha$ is irrational, as desired.

Lemma 4.10. Let $G<$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ be a non-elementary, non-discrete subgroup with at most $N$ fixed points. Then, $\bar{G}$ contains an element which is conjugate to an irrational rotation. Therefore, up to conjugacy, $\bar{G}$ contains $\mathrm{SO}(2)$.
Proof. We will prove that any $f \in \bar{G}$ with irrational rotation number $\alpha=\operatorname{rot}(f)$ (by Lemma 4.9, we can find such an element in $G$ ) is conjugate to the rotation $R_{\alpha}$. We argue by way of contradiction. Let us denote by $\Lambda$ the minimal $f$-invariant Cantor set. Recall that a gap of $\Lambda$ is a connected component of the complement $\mathbb{S}^{1} \backslash \Lambda$. Up to conjugating $G$ by some circle homeomorphism, we can assume that the size of any gap does not exceed $\frac{1}{4}$. After the discussion in Section $2, f$ is semi-conjugate to the rotation $R_{\alpha}$. Denoting by $\left(q_{n}\right)$ the sequence of denominators of rational approximations of $\alpha$, we have $R_{\alpha}^{q_{n}} \rightarrow \mathrm{id}$, which implies that for any $x \in \Lambda$ which is not in the
closure of any wandering interval, we have $f^{q_{n}}(x) \rightarrow x$. (This is because any such $x$ satisfies that $\{x\}=h^{-1}(h(x))$, where $h: \mathbb{S}^{1} \rightarrow \mathbb{S}^{1}$ is a continuous monotone map such that $h f=R_{\alpha} h$ giving the semi-conjugacy.) After the choice of the size of the gaps, we can take $n_{0} \in \mathbb{N}$ sufficiently large so that $d_{\infty}\left(f^{q_{n}}\right.$, id $)<1 / 2$ for any $n \geq n_{0}$, and then take a subsequence $\left(q_{n_{j}}\right)_{j \in \mathbb{N}} \subset\left(q_{n}\right)_{n \geq n_{0}}$ such that $f^{q_{n_{j}}}$ is positive for any $j \in \mathbb{N}$.

Take $\varepsilon>0$ smaller than the size of the $N$ largest gaps. By Lemma 4.6, we can choose a positive element $g \in G$ which is $\varepsilon$-close to the identity. Note that for any $j \in \mathbb{N}$ sufficiently large, $g$ crosses $f^{q_{n}}$ twice on a small neighborhood of any of the $N$ largest gaps, hence at least $2 N$ times. This contradicts the assumption that $g^{-1} f^{n_{j}} \in \bar{G}$ have at most $N$ fixed points. So we conclude that $f \in \bar{G}$ with $\operatorname{rot}(f) \notin \mathbb{Q}$ is conjugate to an irrational rotation and therefore $\bar{G}$ contains a conjugate copy of $\mathrm{SO}(2)$.

We finally use a result by Giblin and Markovic [10, Theorem 1.2]. (A self-contained argument for the conclusion in the case $N=2$ is given in the second author's PhD thesis [4].)
Theorem 4.11 (Giblin-Markovic). Let $G \leq$ Homeo $_{+}\left(\mathbb{S}^{1}\right)$ be a closed transitive subgroup which contains a non-constant continuous path. Then we have the following alternative:
(1) either $G$ is conjugate to $\mathrm{SO}(2)$, or
(2) $G$ is conjugate to $\operatorname{PSL}^{(k)}(2, \mathbb{R})$, for some $k \geq 1$, or
(3) $G$ is conjugate to $\operatorname{Homeo}_{+}^{(k)}\left(\mathbb{S}^{1}\right)$, for some $k \geq 1$, where $\operatorname{Homeo}_{+}^{(k)}\left(\mathbb{S}^{1}\right)$ is the group of all homeomorphisms commuting with the group of order $k$ rotations.

We can now put everything together and prove the main result of our work.
Proof of Theorem $C$. Let $G$ be a non-elementary subgroup with at most $N$ fixed points. If $G$ is non-locally discrete, then after Lemma 4.5, $G$ is non-discrete, so that by Lemma 4.10 its closure $\bar{G}$ contains a conjugate copy of the subgroup of rotations $\mathrm{SO}(2)$. In particular, $\bar{G}$ is closed, transitive and contains a non-constant continuous path. As $G$ is non-elementary, the first possibility in Theorem 4.11 cannot occur. On the other hand, after Lemma $4.7, \bar{G}$ has at most $N$ fixed points, so that the third possibility in Theorem 4.11 cannot occur either. We conclude that $\bar{G}$ is conjugate to $\operatorname{PSL}^{(k)}(2, \mathbb{R})$, for some $k \geq 1$, as desired.
