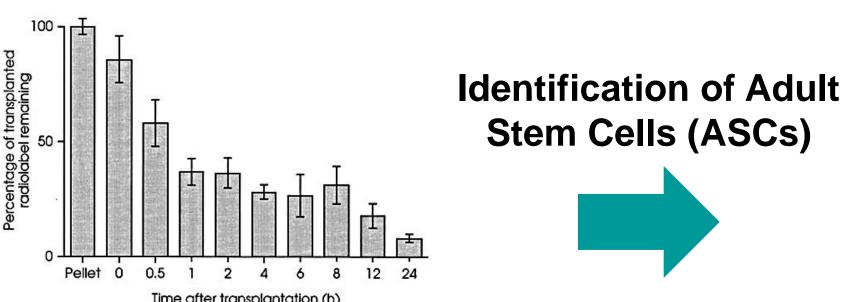

Cell therapy and muscle diseases

- Transplantation myoblasts on of dystrophic patients
- → Poor efficiency: low survival and low integration in the host tissue



Context

Stem Cells (ASCs)

Human MuStem cells [1-2]

- Skeletal muscle-resident cells isolated based on delayed adhesion properties
- Favorable settings for transplantation: high clonogenicity, strong proliferation capacity
- Contribution to muscle regeneration with formation of new muscle fibers and myogenic progenitors
- Persisting clinical and tissue benefits
 - → Good candidate for tissue regeneration in muscle diseases

Clinical potential restricted by moderate ability to survive and engraft after transplantation

Objectives

1-Applied: How to increase the effectiveness of hMuStem cell transplantation?

- Cell engineering to improve in vitro conditioning
- Encapsulation inside 3D network to improve cell viability [3]
- → Enhancement of myogenic properties and secretory capacities
- → Protection against mechanical stress and the immune system

- 2-Fundamental: How to better understand the biology of hMuStem cells using 3D systems analogous to targeted tissues?
- Synthesis of artificial biomimetic matrix to model skeletal muscles [4]
- → Impact of the extracellular matrix (ECM) on myogenic activities of hMuStem cells

Hydrogels

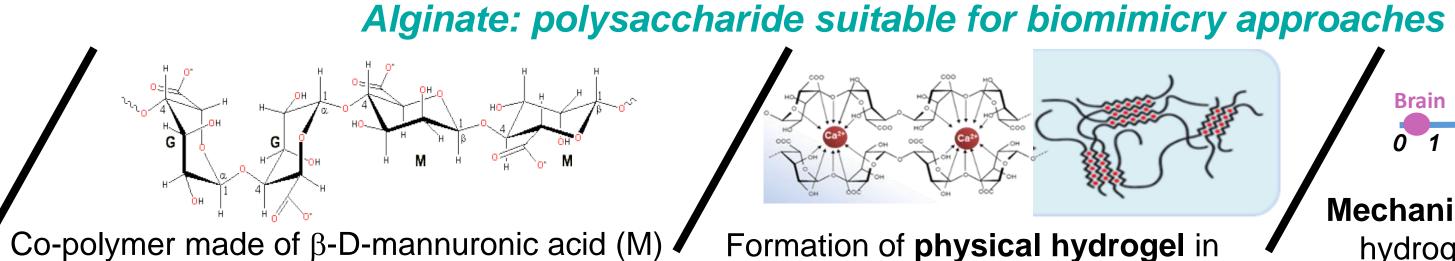
Networks of hydrophilic polymer chains

- Strong affinity with water
- Matrix with mechanical properties similar to natural tissues

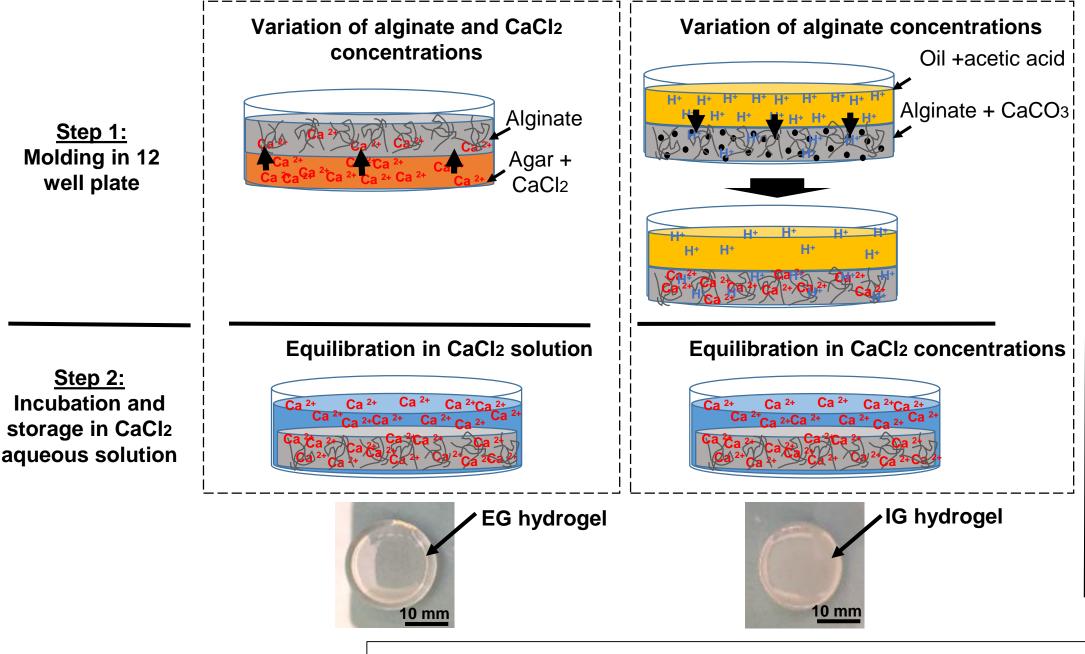

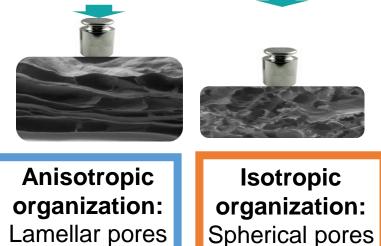
Elaboration of artificial matrix to mimic ECM based on alginate polysaccharide - Two gelation approaches Internal gelation (IG) External gelation (EG)



Elastic moduli using Atomic Force Microscope (AFM) CaCl₂ (mM)

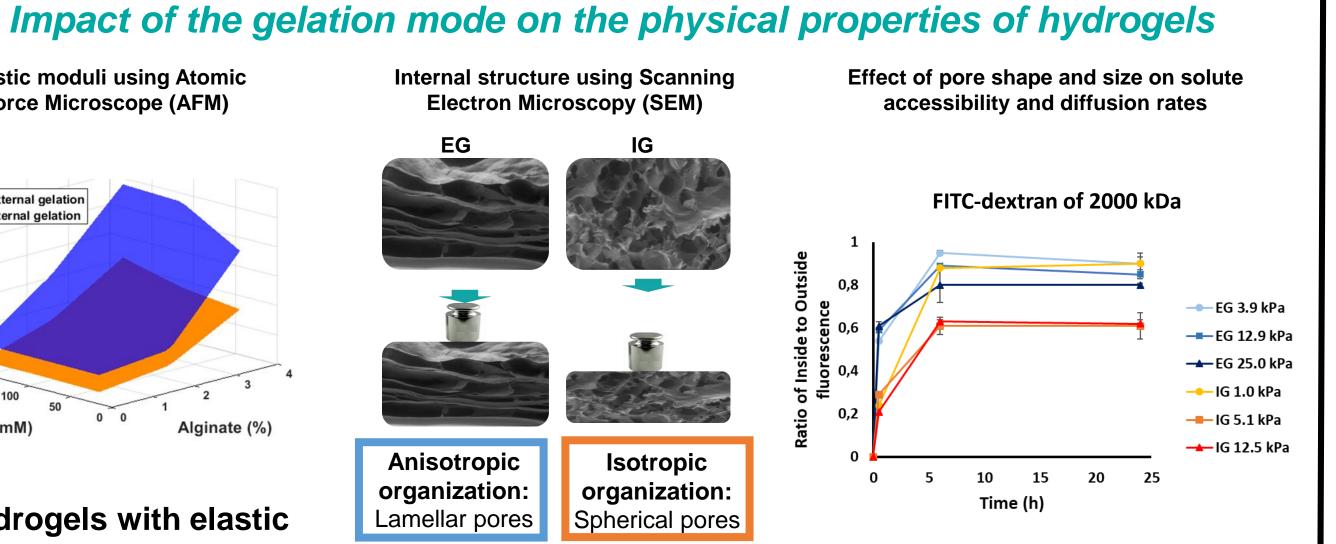
- Hydrogels with elastic modulus from 1 to 25 kPa
- Lower elastic modulus observed for Internal **Gelation mode**

Internal structure using Scanning

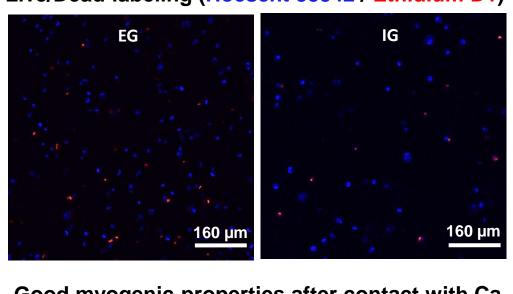
 Lamellar structure more resistant to mechanical pressure

Impact of the mechanical properties of the mimetic matrix on hMuStem cells

Good cell viability (>70%) inside hydrogels mimicking muscle elastic modulus (12 kPa) -Live/Dead labeling (Hoescht 33342 / Ethidium D1)



Good myogenic properties after contact with Caalginate matrices - labeling of sarcomeric myosin Multinucleated myotubes

 Structural constraints do not influence biological activities

Obtention of macroscopic hydrogels using molding methods whose mechanical, structural and diffusion properties have been characterized as a function of the gelation methods used. However, the large size of these hydrogels limits their therapeutic applications to subcutaneous implant.

Result 2: Transposition to droplet microfluidic approaches – change of scale

Microfluidic chip for Ca-alginate microgels

Dispersed phase: Alginate / CaCO₃ / cells **Continuous phase** Oil / Acetic acid

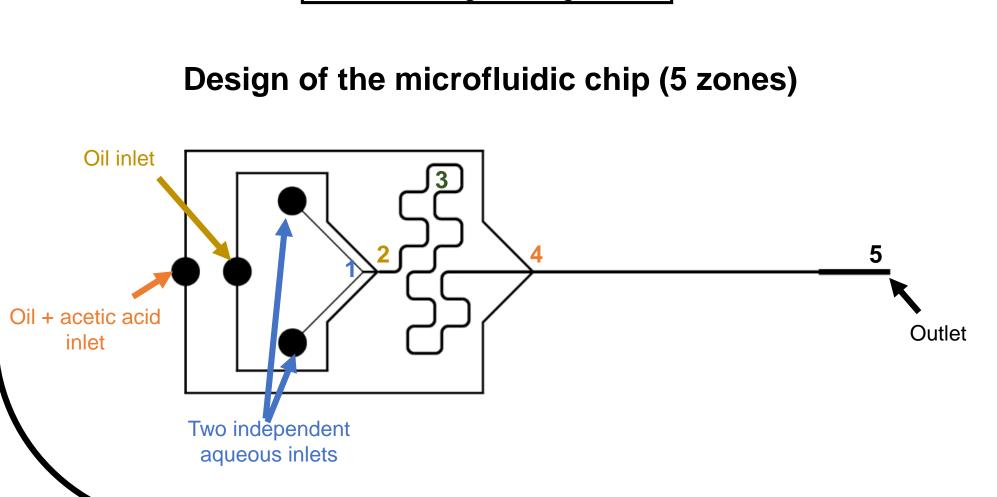

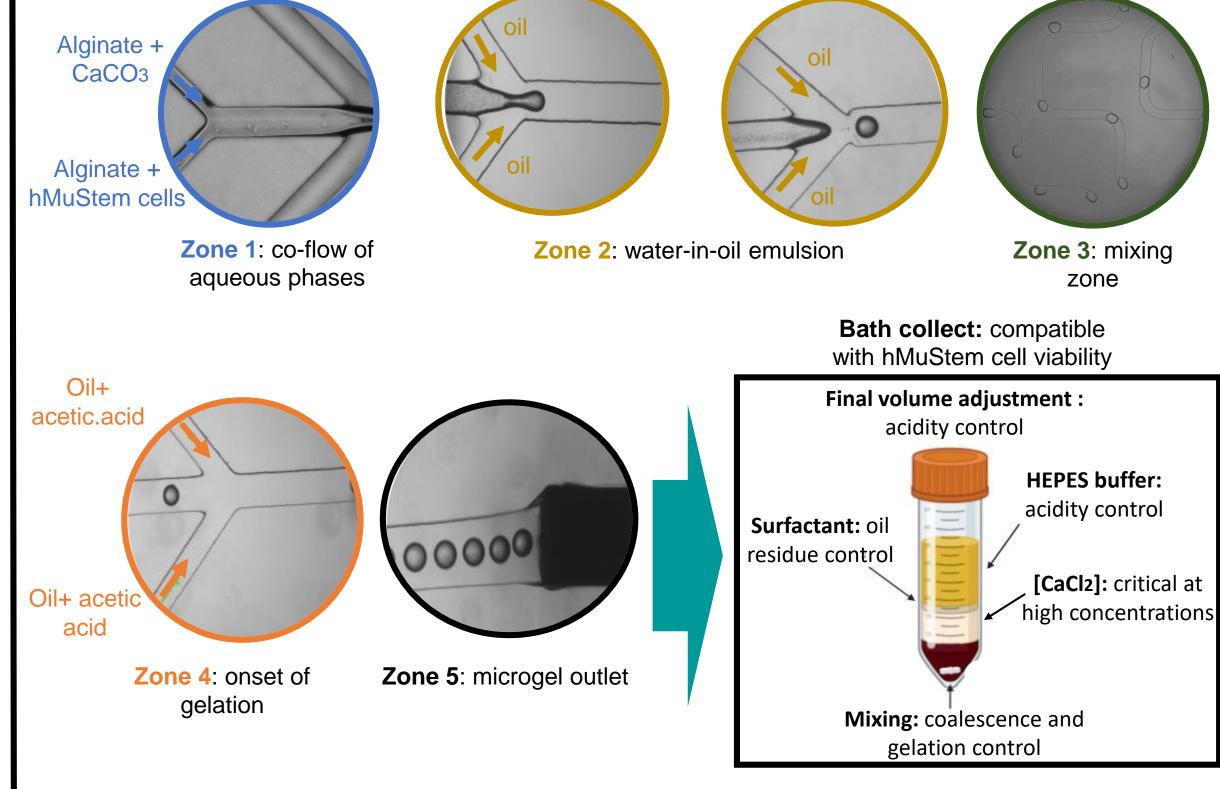

Internal gelation principle in microfluidic chip



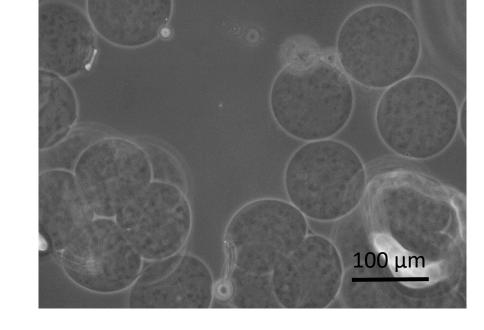
Microencapsulation steps on-chip



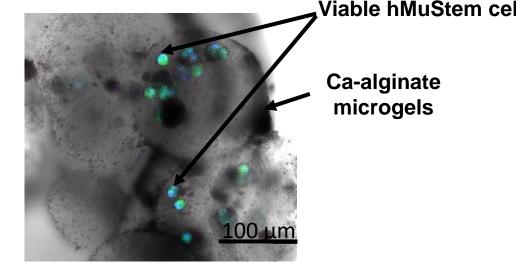
- Limit of impact of CaCO₃ crystals on cells through shear until the droplets formation at the first junction (Zone 2)
- No coalescence of droplets
- Bath collect optimized

Characterization of microgels containing hMuStem cells

Ca-alginate microgels of 100 µm in diameter containing hMuStem cells at the end of the encapsulation process



High cell viability inside microgels, in culture medium, 8 days after encapsulation - Live/Dead labeling (CalCein AM-Hoescht / Ethidium D1) Viable hMuStem cells



 Process of microencapsulation compatible with hMuStem cells

Conclusion

We synthetized calcium-alginate macrogels. We showed that the elastic modulus of the hydrogels ranged from 1-25 kPa and was directly dependent on the gelation mode and on Ca-alginate concentrations. Gelation parameters impacted hydrogel structure and diffusion properties, while leaving small molecules free to circulate. Encapsulation did not alter the viability of hMuStem cells that also preserve morphological and myogenic differentiation characteristics after release. To pave the way for new strategies of cell transplantation treatment by injection, following these first results, we demonstrated the effectiveness of hMuStem cell encapsulation on a microscopic scale through the development of a microfluidic process. As this stage of study, all of our results showed that hMuStem cells can be encapsulated in Ca-alginate hydrogels without compromising functionality, opening the way to new transplant protocols.
