Sharp convergence rates for the homogenization of the Stokes equations in a perforated domain

Abstract

This paper is concerned with the homogenization of the Stokes equations in a periodic perforated domain. The homogenized model is known to be Darcy's law in the full domain. We establish a sharp convergence rate $O(\sqrt{\varepsilon})$ for the energy norm of the difference of the velocities, where ε represents the size of the solid obstacles. This is achieved by using a two-scale asymptotic expansion of the Stokes equations and a new construction of a cut-off function which avoids the introduction of boundary layers. The main novelty is that our analysis applies for the physically relevant case of a porous medium where each of the fluid and solid parts is a connected subdomain.

1 Introduction

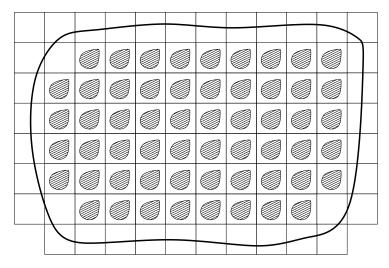


Figure 1: Porous medium Ω^{ε} , obtained from a domain Ω perforated by a set of solid isolated obstacles B^{ε}

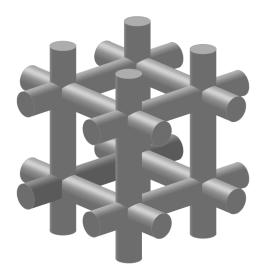


Figure 2: Regular lattice of interconnected cylinders

In this paper, we deal with the Stokes problem for an incompressible viscous fluid in a porous medium which is represented as a periodic perforated domain (see for example Figure 1 or Figure 2). This work is motivated by the derivation of an error estimate for a Multiscale Finite Element Method (MsFEM) applied to the Stokes equations in perforated domains [11, 7] which is based on the homogenization theory. Let $\Omega \subset \mathbb{R}^d$ be a regular bounded open set. As shown in Figure 1, we divide the domain Ω into a fixed solid part B^{ε} and its complementary fluid part Ω^{ε} . Here ε denotes a small parameter equal to the ratio between the characteristic length of the periodic heterogeneities and the characteristic length of the domain. A first typical example of such a porous domain Ω^{ε} is given by Figure 1 where the solid obstacles B^{ε} are a collection of isolated and periodically repeated obstacles. A second typical case, in dimension $d \geq 3$, is a porous domain Ω^{ε} perforated by a regular lattice of interconnected solid cylinders as presented in Figure 2. A precise definition of Ω^{ε} is given in Section 2.

The steady-state Stokes problem with homogeneous Dirichlet boundary condition in a perforated domain is to find the velocity $u_{\varepsilon}: \Omega^{\varepsilon} \to \mathbb{R}^d$ and the pressure $p_{\varepsilon}: \Omega^{\varepsilon} \to \mathbb{R}$ solution to:

$$\begin{cases}
-\nu \Delta \boldsymbol{u}_{\varepsilon} + \boldsymbol{\nabla} p_{\varepsilon} &= \boldsymbol{f} & \text{in } \Omega^{\varepsilon}, \\
\operatorname{div} \boldsymbol{u}_{\varepsilon} &= 0 & \text{in } \Omega^{\varepsilon}, \\
\boldsymbol{u}_{\varepsilon} &= \boldsymbol{0} & \text{on } \partial \mathbf{B}^{\varepsilon} \cap \partial \Omega^{\varepsilon}, \\
\boldsymbol{u}_{\varepsilon} &= \boldsymbol{0} & \text{on } \partial \Omega \cap \partial \Omega^{\varepsilon},
\end{cases} \tag{1}$$

where $\nu > 0$ is the viscosity and f the applied force. Vector valued functions are written in bold. In the literature, some authors consider a different scaling of (1), replacing the velocity u_{ε} by $u_{\varepsilon} = \varepsilon^2 \tilde{u}_{\varepsilon}$. This does not change anything to our methodology and our results, up to this ε^2 factor.

We introduce the classical velocity space $V=H^1_0(\Omega^\varepsilon)^d=\{\boldsymbol{u}\in H^1(\Omega^\varepsilon)^d \ s.t \ \boldsymbol{u}|_{\partial\Omega^\varepsilon}=\boldsymbol{0}\}$ and pressure space $M=L^2_0(\Omega^\varepsilon)=\{q\in L^2(\Omega^\varepsilon),\ s.t\ \int_{\Omega^\varepsilon}q=0\}$. In V we shall often use the semi-norm $|\cdot|_{H^1}$, equivalent to the usual norm and defined by:

$$|v|_{H^1(\Omega^{\varepsilon})} = \|\nabla v\|_{L^2(\Omega^{\varepsilon})}, \quad \boldsymbol{v} \in H^1(\Omega^{\varepsilon})^d.$$

We introduce the bilinear forms $a: V \times V \to \mathbb{R}$ and $b: M \times V \to \mathbb{R}$ by:

$$a(\boldsymbol{u}, \boldsymbol{v}) = \nu(\nabla \boldsymbol{u}, \nabla \boldsymbol{v}), \qquad b(p, \boldsymbol{v}) = (p, \operatorname{div} \boldsymbol{v}).$$
 (2)

Then, assuming that $\mathbf{f} \in L^2(\Omega)^d$, a weak formulation of the Stokes problem (1) reads as follows: find $\mathbf{u}_{\varepsilon} \in V$ and $p_{\varepsilon} \in M$ such that:

$$\begin{cases}
 a(\boldsymbol{u}_{\varepsilon}, \boldsymbol{v}) + b(p_{\varepsilon}, \boldsymbol{v}) &= (\boldsymbol{f}, \boldsymbol{v}) \quad \forall \boldsymbol{v} \in V, \\
 b(q, \boldsymbol{u}_{\varepsilon}) &= 0 \quad \forall q \in M.
\end{cases}$$

It is well known that, if Ω^{ε} is connected (to ensure that the zero-average condition of the pressure is enough to remove the undetermined constant of the pressure), there exists a unique weak solution to (3) [9].

The homogenization of the Stokes equations, i.e. finding the limit system satisfied by the limit of $(u_{\varepsilon}, p_{\varepsilon})$ as ε goes to zero, was first investigated by [13, 15, 1]. A review of these results can be found in [10], [5]. The homogenized or effective equations for the Stokes system, in a periodic perforated domain, is Darcy's law for the velocity u and the homogenized pressure p^* :

$$\begin{cases} \boldsymbol{u} &= \frac{1}{\nu} A^* (\boldsymbol{f} - \boldsymbol{\nabla} p^*) & \text{in } \Omega, \\ \text{div } \boldsymbol{u} &= 0 & \text{in } \Omega, \\ \boldsymbol{u} \cdot \boldsymbol{n} &= 0 & \text{on } \partial \Omega. \end{cases}$$

where A^* is a constant permeability tensor (see Proposition 3.2).

The first convergence result for the homogenization of the Stokes equations was established in [15], where the author proved the weak L^2 convergence of the velocity and the strong L^2 convergence of the pressure. The strong L^2 convergence of the velocity with a corrector was proven later in [1]. The first quantitative result of convergence in the H^1 -norm was obtained in [12] with a relative error estimate of order $\varepsilon^{1/6}$ in a two-dimensional domain (d=2). This result has been improved to $\sqrt{\varepsilon}$ in [11] for the case of isolated solid obstacles (still in two space dimension d=2). This $\sqrt{\varepsilon}$ error estimate was independently and further improved in [14] for any space dimension $d\geq 2$, still under the assumption of isolated solid obstacles (as in Figure 1). The main technical idea in [14] is to construct boundary correctors which control the boundary layers appearing in the proof of the error estimate. Note that the assumption of isolated solid obstacles is not physically realistic in dimension $d\geq 3$.

The goal of the present paper is to extend this $\sqrt{\varepsilon}$ error estimate to the case of connected solid obstacles (as in Figure 2). Before stating our main result (in loose terms, see Theorem 4.1 for a precise statement) we need to introduce some notations. Actually the Darcy velocity \boldsymbol{u} does not see the solid obstacles and thus cannot be a good approximation of the original velocity $\boldsymbol{u}_{\varepsilon}$. It must be corrected by introducing a better approximation which is

$$u_2\left(x, \frac{x}{\varepsilon}\right) = \frac{1}{\nu} \sum_{i=1}^{d} \omega_i\left(\frac{x}{\varepsilon}\right) \left(f_i(x) - \frac{\partial p^*}{\partial x_i}(x)\right)$$

where the local velocities ω_i are solutions of cell problems (12). Actually the link between u_2 and the Darcy velocity u is that u(x) is the average of $u_2(x, y)$ with respect to the periodic variable y.

The main result we shall proved is:

Theorem 1.1. Let u_{ε} , p_{ε} be the solution to the Stokes problem (1) and u_2 , p^* , their homogenized approximations. Assuming that f is smooth enough, there exists a constant C, independent of ε and f, such that

$$\frac{\|p_{\varepsilon} - p^*\|_{L^2(\Omega^{\varepsilon})}}{\|p^*\|_{L^2(\Omega^{\varepsilon})}} \le C\varepsilon^{\frac{1}{2}} \|\boldsymbol{f}\|_{H^2(\Omega)\cap C^{1,\alpha}(\overline{\Omega})},$$

$$\begin{split} &\frac{|\boldsymbol{u}_{\boldsymbol{\varepsilon}} - \varepsilon^2 \boldsymbol{u}_{\mathbf{2}}|_{H^1(\Omega^{\varepsilon})}}{|\varepsilon^2 \boldsymbol{u}_{\mathbf{2}}|_{H^1(\Omega^{\varepsilon})}} \leq C\varepsilon^{\frac{1}{2}} \|\boldsymbol{f}\|_{H^2(\Omega) \cap C^{1,\alpha}(\overline{\Omega})}, \\ &\frac{\|\boldsymbol{u}_{\boldsymbol{\varepsilon}} - \varepsilon^2 \boldsymbol{u}_{\mathbf{2}}\|_{L^2(\Omega^{\varepsilon})}}{\|\varepsilon^2 \boldsymbol{u}_{\mathbf{2}}\|_{L^2(\Omega^{\varepsilon})}} \leq C\varepsilon^{\frac{1}{2}} \|\boldsymbol{f}\|_{H^2(\Omega) \cap C^{1,\alpha}(\overline{\Omega})}. \end{split}$$

Theorem 1.1 is stated in terms of relative errors since $\varepsilon^2 u_2$ (and thus u_{ε}) is small. Its proof follows the same strategy as that in [11] (but extends it to dimensions larger than 2) and differs significantly from the proof in [14]. Actually, our proof is simpler in the sense that no boundary layers (and thus correctors of their effect) appear. It turns out that we are able to use a cut-off argument as in the standard elliptic case [3] but without compromising the divergence-free condition for the velocities. Of course, the main novelty is that Theorem 1.1 applies to any case of solide obstacles, isolated or connected. In dimension $d \geq 3$, the physically relevant case is that of connected obstacles and not isolated obstacles.

The content of this paper is the following. Section 2 gives a precise definition of the geometrical assumptions of a periodic porous medium. Section 3 is devoted to the formal two-scale asymptotic expansion method which delivers the homogenized problem, as well as some cell correctors, including the velocities ω_i appearing in the definition of u_2 . In Section 4 is stated our main result (Theorem 4.1 which is just a rigorous statement of Theorem 1.1) and its proof is decomposed in several technical lemmas.

2 Geometric modeling of the porous medium

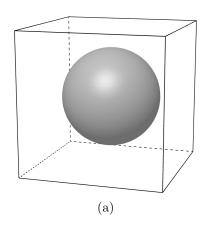
As usual in periodic homogenization theory [3, 10, 13], we consider a porous medium obtained by the periodic repetition of an elementary cell of size ε , in a bounded domain of \mathbb{R}^d . We first define the corresponding dimensionless elementary cell Y.

2.1 Definition of the elementary cell Y

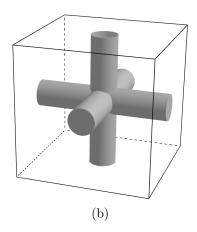


Figure 3: Isolated (left) or connected (right) solid obstacles in the unit cell $Y = Y_F \cup Y_S$

Let $Y =]0,1[^d$ be the open unit cube of \mathbb{R}^d , $d \geq 2$. Let Y_S be a closed subset of \overline{Y} . We define Y_F , an open set of \mathbb{R}^d , by $Y_F = Y \setminus Y_S$, where Y_S represents the part of Y occupied by the solid and Y_F represents the part of Y occupied by the fluid. The fluid part Y_F and the solid part Y_S satisfy $Y_F \cup Y_S = Y$ and $Y_F \cap Y_S = \emptyset$ (see Figure 3). The closed set Y_S is repeated by Y-periodicity and fills the entire space \mathbb{R}^d , in order to obtain a closed set of \mathbb{R}^d , noted E_S . Let the open set E_F be the complementary of E_S in \mathbb{R}^d , i.e $E_F = \mathbb{R}^d \setminus E_S$. We assume the following hypotheses on Y_F and E_F :

- 1. Y_F and Y_S have strictly positive measure on \overline{Y} (the elementary cell Y contains fluid and solid together).
- 2. Y_F is an open connected set with a locally Lipschitz boundary.
- 3. E_F and the interior of E_S are open sets with smooth boundaries of class C^{m+2} , with $m > \frac{d}{2}$, and are locally located on one side of their boundary. Moreover E_F is connected.

Remark that the solid part E_S can be connected or not, corresponding to the two different geometric cases of Figures 1 and 2 which are later called isolated obstacles or connected obstacles. The assumption that E_F is smooth and connected implies that, on each face of Y, there is a fluid sub-domain of non-zero (surface) measure.

2.2 Definition of the open set Ω^{ε}

Let Ω be a bounded and connected open set of \mathbb{R}^d $(d \geq 2)$ which is assumed to have a smooth boundary of class $C^{3,\alpha}$, for some $0 < \alpha < 1$. The set Ω is covered with a regular square mesh of size ε , each cell being a cube Y_i^{ε} . We define for any $i \in \mathbb{Z}^d$:

$$Y_i = Y + i, \quad Y_{i,F} = Y_F + i, \quad Y_{i,S} = Y_S + i,$$

$$Y_i^{\varepsilon} = \varepsilon(Y+i), \quad Y_{i,F}^{\varepsilon} = \varepsilon(Y_F+i), \quad Y_{i,S}^{\varepsilon} = \varepsilon(Y_F+i).$$

The periodic set of solid obstacles (or perforations) inside Ω is defined as:

$$B^{\varepsilon} = \bigcup_{i \in \mathcal{I}} Y_{i,S}^{\varepsilon},\tag{4}$$

where $\mathcal{I} \subset \mathbb{Z}^d$ is a set of indices which is precisely defined in Assumption 2.1 below. The role of \mathcal{I} is to remove obstacles from Ω only if they are sufficiently away from the boundary $\partial\Omega$. Finally, the fluid part Ω^{ε} of the perforated medium is defined by $\Omega^{\varepsilon} = \Omega \setminus B^{\varepsilon}$, i.e:

$$\Omega^{\varepsilon} = \Omega \setminus \bigcup_{i \in \mathcal{I}} Y_{i,S}^{\varepsilon}. \tag{5}$$

The definition of \mathcal{I} depends on the two cases of isolated or connected solid obstacles (see Figure 3).

Assumption 2.1. We consider two different sets of assumptions depending on the two cases of isolated or connected solid obstacles.

- 1. If the solid part Y_S is isolated, namely strictly included in Y (not touching its boundary), then $\mathcal{I} = \{i \in \mathbb{Z}^d \text{ s.t } Y_i^{\varepsilon} \subset \Omega\}$. In other words, only entire obstacles $Y_{i,S}^{\varepsilon}$ are removed from Ω and thus no obstacles are cut by the boundary $\partial\Omega$.
- 2. If the solid part Y_S touches the boundary of Y, meaning that obstacles are connected, then we define a first set of indices $\mathcal{I}_1 = \{i \in \mathbb{Z}^d \text{ s.t } Y_i^{\varepsilon} \subset \Omega\}$ and an open subset of Ω defined by its closure

$$\overline{C_1^{\varepsilon}} = \bigcup_{i \in \mathcal{I}_1} \overline{Y_i^{\varepsilon}}.$$

Then, a second smaller set of indices is

$$\mathcal{I}_2 = \{ i \in \mathcal{I}_1 \text{ such that } \overline{Y_i^{\varepsilon}} \cap \partial C_1^{\varepsilon} = \emptyset \},$$

meaning that no cell Y_i^{ε} in \mathcal{I}_2 touches the boundary $\partial C_1^{\varepsilon}$. Similarly, we define an open subset of Ω defined by its closure

$$\overline{C_2^{\varepsilon}} = \bigcup_{i \in \mathcal{I}_2} \overline{Y_i^{\varepsilon}}.$$

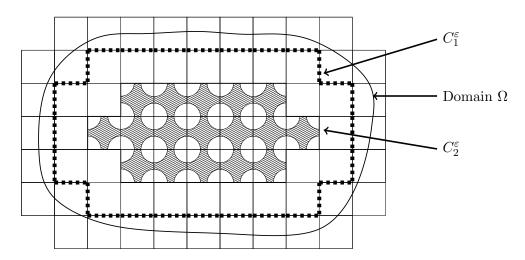


Figure 4: Porous medium Ω^{ε} when the solid part Y_S touches the boundary of Y

Finally, we choose $\mathcal{I} = \mathcal{I}_2$, meaning that the obstacles are not cut by the boundary $\partial\Omega$ and stay away from $\partial\Omega$ and $\partial C_1^{\varepsilon}$ at a distance of the order of ε (see Figure 4).

Remark 2.2. The second item of Assumption 2.1 allows us to treat the realistic case of a connected solid part, which is possible only for space dimensions $d \geq 3$ because in 2-d E_F and E_S cannot be connected simultaneously. The second item of Assumption 2.1 is similar to an assumption in [5] and is slightly different from the assumption made in [1]. It is a necessary assumption for several technical reasons, including the fact that, when E_S is connected, there may be some pathological cut obstacles near the boundary $\partial\Omega$. In particular, the fluid domain may be not connected.

3 Two-scale asymptotic expansion

This section recall how to formally obtain the homogenized problem for the Stokes equations (1), as well as the definitions of several corrector terms in the unit cell which are required for the sequel. This is achieved by applying the classical method of two-scale asymptotic expansion [3, 13]. The following results are already well-known but are recalled since the notations are required for the next sections. The formal method of two-scale asymptotic expansion starts with the following ansatz for the velocity u_{ε} and pressure p_{ε} :

$$\boldsymbol{u}_{\varepsilon}(x) = \sum_{k=2}^{+\infty} \varepsilon^{k} \boldsymbol{u}_{k}\left(x, \frac{x}{\varepsilon}\right), \qquad p_{\varepsilon}(x) = \sum_{k=0}^{+\infty} \varepsilon^{k} p_{k}\left(x, \frac{x}{\varepsilon}\right). \tag{6}$$

All functions $u_k(x, y)$, $p_k(x, y)$ are assumed \mathbb{Z}^d -periodic in y i.e 1-periodic with respect to each component y_1, \ldots, y_d .

Remark 3.1. We begin the asymptotic expansion of the velocity \mathbf{u}_{ε} at k=2 since it is well-known in literature that the first terms $\mathbf{u}_{\mathbf{0}}$ and $\mathbf{u}_{\mathbf{1}}$ vanish.

We recall the following derivation rule:

$$\nabla \left(u_{k}(x, \frac{x}{\varepsilon}) \right) = \left(\varepsilon^{-1} \nabla_{y} u_{k} + \nabla u_{k} \right) \left(x, \frac{x}{\varepsilon} \right), \tag{7}$$

where ∇ and ∇_y denote the partial derivatives with respect to the macroscopic variable x and the microscopic variable y. Then, introducing the series (6) in the Stokes equations (1), using the derivation rule (7), we obtain for the momentum equation:

$$-\nu\Delta\boldsymbol{u}_{\varepsilon}(x) + \boldsymbol{\nabla}p_{\varepsilon}(x) = \varepsilon^{-1}\boldsymbol{\nabla}_{\boldsymbol{y}}p_{0} + \varepsilon^{0}\left\{-\nu\operatorname{div}_{\mathbf{y}}\boldsymbol{\nabla}_{\boldsymbol{y}}\boldsymbol{u}_{2} + \boldsymbol{\nabla}p_{0} + \boldsymbol{\nabla}_{\boldsymbol{y}}p_{1}\right\}$$

$$+\varepsilon\left\{-\nu(\operatorname{div}\boldsymbol{\nabla}_{\boldsymbol{y}}\boldsymbol{u}_{2} + \operatorname{div}_{\mathbf{y}}\boldsymbol{\nabla}\boldsymbol{u}_{2}\operatorname{div}_{\mathbf{y}} + \boldsymbol{\nabla}_{\boldsymbol{y}}\boldsymbol{u}_{3}) + \boldsymbol{\nabla}p_{1} + \boldsymbol{\nabla}_{\boldsymbol{y}}p_{2}\right\}$$

$$+\sum_{k=2}^{+\infty}\varepsilon^{k}\left\{-\nu(\operatorname{div}\boldsymbol{\nabla}\boldsymbol{u}_{k} + \operatorname{div}\boldsymbol{\nabla}_{\boldsymbol{y}}\boldsymbol{u}_{k+1} + \operatorname{div}_{\mathbf{y}}\boldsymbol{\nabla}\boldsymbol{u}_{k+1} + \operatorname{div}_{\mathbf{y}}\boldsymbol{\nabla}_{\boldsymbol{y}}\boldsymbol{u}_{k+2})\right\}$$

$$+\boldsymbol{\nabla}p_{k} + \boldsymbol{\nabla}_{\boldsymbol{y}}p_{k+1}\} = \boldsymbol{f}$$
(8)

and for the incompressiblity condition:

$$\operatorname{div} \boldsymbol{u}_{\varepsilon}(x) = \varepsilon \operatorname{div}_{y} \boldsymbol{u}_{2} + \sum_{k=2}^{+\infty} \varepsilon^{k} \{ \operatorname{div} \boldsymbol{u}_{k} + \operatorname{div}_{y} \boldsymbol{u}_{k+1} \} = 0.$$
 (9)

Now, we identify the quantities associated to the different order of ε . The leading order ε^{-1} of the momentum equation is:

$$\begin{cases}
\nabla_{\boldsymbol{y}} p_0 = 0 & \text{in } Y_F, \\
y \to p_0(x, y) & Y - \text{periodic.}
\end{cases}$$
(10)

From (10) one deduces that p_0 does not depend on y and there exists a function $p^*(x)$ such that $p_0(x,y) = p^*(x)$. At the next order ε^0 for the momentum equation and ε for the incompressibility condition, we get:

$$\begin{cases}
-\nu \Delta_{y} \boldsymbol{u}_{2} + \nabla_{y} p_{1} = \boldsymbol{f} - \nabla p^{*} & \text{in } Y_{F}, \\
\operatorname{div}_{y} \boldsymbol{u}_{2} = 0 & \text{in } Y_{F}, \\
\boldsymbol{u}_{2} = \boldsymbol{0} & \text{on } \partial Y_{S}, \\
y \to \boldsymbol{u}_{2}(x, y), \ p_{1}(x, y) & Y - \text{periodic.}
\end{cases}$$
(11)

It follows that u_2 and p_1 are linear combinations of the solutions to the following cell Stokes problems: for i = 1, ..., d find $\omega_i : Y \to \mathbb{R}^d$ and $\pi_i : Y \to \mathbb{R}$, \mathbb{Z}^d -periodic and solutions to:

$$\begin{cases}
-\Delta_{y}\boldsymbol{\omega_{i}} + \boldsymbol{\nabla_{y}}\boldsymbol{\pi_{i}} = \boldsymbol{e_{i}} & \text{in } Y_{F}, \\
\operatorname{div}_{y}\boldsymbol{\omega_{i}} = 0 & \text{in } Y_{F}, \\
\boldsymbol{\omega_{i}} = \mathbf{0} & \text{on } \partial Y_{S}, \\
\int_{Y} \boldsymbol{\pi_{i}} = 0, \\
\boldsymbol{y} \rightarrow \boldsymbol{\omega_{i}}, \ \boldsymbol{\pi_{i}} & Y - \text{periodic.}
\end{cases} \tag{12}$$

Using the Einstein summation convention on repeated indices, it follows that:

$$\begin{cases}
\mathbf{u_2}(x,y) &= \frac{1}{\nu} \boldsymbol{\omega_i}(y) \left(f_i(x) - \frac{\partial p^*}{\partial x_i}(x) \right), \\
p_1(x,y) &= \pi_i(y) \left(f_i(x) - \frac{\partial p^*}{\partial x_i}(x) \right).
\end{cases}$$
(13)

Furthermore, averaging on Y_F the ε^0 order term of the incompressibility condition (taking into account the boundary conditions for u_3 in (17)) yields

$$\operatorname{div} \langle \boldsymbol{u_2} \rangle = 0, \tag{14}$$

where $\langle \cdot \rangle$ stands for the average over Y_F :

$$\langle \boldsymbol{v} \rangle = \frac{1}{|Y_F|} \int_{Y_F} \boldsymbol{v}(y) dy.$$

Inserting formula (13) for u_2 in (14) leads to the Darcy equation for the pressure p^* . Furthermore, a similar asymptotic analysis can be performed on the boundary $\partial\Omega$ but the homogenized boundary condition turns out to be weaker, namely only the normal component of u vanishes on $\partial\Omega$ [1, 10, 11].

Proposition 3.2. The Darcy velocity is defined as

$$\mathbf{u} = \langle \mathbf{u_2} \rangle = \frac{1}{\nu} \langle \mathbf{\omega_i} \rangle \left(f_i(x) - \frac{\partial p^*}{\partial x_i}(x) \right)$$
 (15)

and the homogenized pressure p^* is the solution to the following Darcy problem:

$$\begin{cases}
\operatorname{div} A^*(\boldsymbol{f} - \boldsymbol{\nabla} p^*) = 0 & \text{in } \Omega, \\
\boldsymbol{n} \cdot (A^*(\boldsymbol{f} - \boldsymbol{\nabla} p^*)) = 0 & \text{on } \partial\Omega,
\end{cases}$$
(16)

where the constant tensor A^* is defined by its columns

$$A^* \boldsymbol{e_i} = \langle \boldsymbol{\omega_i} \rangle = \frac{1}{|Y_F|} \int_{Y_F} \boldsymbol{\omega_i}(y) dy.$$

There exists a solution $p^* \in H^1(\Omega)$ of (16), which is unique up to an additive constant. Furthermore, under Assumption 2.1 and assuming $\mathbf{f} \in C^{1,\alpha}(\overline{\Omega})^d$ with $0 < \alpha < 1$, then ∇p^* is of class $C^{1,\alpha}(\overline{\Omega})$ and p^* is of class $C^{2,\alpha}(\overline{\Omega})$. Similarly, if $\mathbf{f} \in H^2(\Omega)^d$, then $\nabla p^* \in H^2(\Omega)^d$ too.

Proof. Problem (16) is well-posed in $H^1(\Omega)/\mathbb{R}$ because it is just a second-order elliptic equation for the pressure p^* , complemented by a Neumann boundary condition (one can check that A^* is positive definite). Recall that $C^{1,\alpha}(\overline{\Omega})$ is the space of functions in $C^1(\overline{\Omega})$ with derivatives which are α -Hölderian. Since $\mathbf{f} \in C^{1,\alpha}(\overline{\Omega})$ then it is known that ∇p^* is of class $C^{1,\alpha}(\overline{\Omega})$ (see for example [8, Theorems 8.33 and 8.34]). Finally, $\mathbf{f} \in H^2(\Omega)^d$ implies $\nabla p^* \in H^2(\Omega)^d$ by standard Sobolev regularity theory for elliptic equations.

At the next order ε for the momentum equation and ε^2 for the incompressibility condition, we get:

$$\begin{cases}
-\nu \Delta_{y} \boldsymbol{u}_{3} + \nabla_{y} p_{2} = \nu \operatorname{div} \nabla_{y} \boldsymbol{u}_{2} + \nu \operatorname{div}_{y} \nabla \boldsymbol{u}_{2} - \nabla p_{1} & \text{in } Y_{F}, \\
\operatorname{div}_{y} \boldsymbol{u}_{3} = -\operatorname{div} \boldsymbol{u}_{2} & \text{in } Y_{F}, \\
\boldsymbol{u}_{3} = \boldsymbol{0} & \text{on } \partial Y_{S}, \\
\boldsymbol{y} \rightarrow \boldsymbol{u}_{3}(x, y), \ p_{2}(x, y) & Y - \operatorname{periodic.}
\end{cases}$$
(17)

Substituting the expressions (13) of u_2 and p_1 in (17) leads to

$$-\nu \Delta_y \boldsymbol{u_3} + \nabla_y p_2 = (2\nabla_y \boldsymbol{\omega_i}(y) - \pi_i(y)) \nabla \left(f_i(x) - \frac{\partial p^*}{\partial x_i}(x) \right). \tag{18}$$

By linearity, we deduce that

$$\begin{cases}
\mathbf{u_3}(x,y) = \frac{1}{\nu} \gamma_{ij}(y) \frac{\partial}{\partial x_j} \left(f_i(x) - \frac{\partial p^*}{\partial x_i}(x) \right), \\
p_2(x,y) = \theta_{ij}(y) \frac{\partial}{\partial x_j} \left(f_i(x) - \frac{\partial p^*}{\partial x_i}(x) \right),
\end{cases} (19)$$

where, for i, j = 1, ..., d, $\gamma_{ij} : Y \to \mathbb{R}^d$ and $\theta_{ij} : Y \to \mathbb{R}$ are \mathbb{Z}^d -periodic solutions to another cell Stokes problem:

$$\begin{cases}
-\Delta_{y} \gamma_{ij} + \nabla_{y} \theta_{ij} = 2 \frac{\partial \omega_{i}}{\partial y_{j}} - \pi_{i} e_{j} & \text{in } Y_{F}, \\
\operatorname{div}_{y} \gamma_{ij} = -\omega_{i} \cdot e_{j} + \langle \omega_{i} \cdot e_{j} \rangle & \text{in } Y_{F}, \\
\gamma_{ij} = 0 & \text{on } \partial Y_{S}, \\
\int_{Y} \theta_{ij} = 0, \\
y \to \gamma_{ij}, \ \theta_{ij} & Y - \text{periodic.}
\end{cases} \tag{20}$$

We recall some notations on Sobolev spaces of periodic functions (see [10, Appendix B.2.2] for details). The L^2 space of Y-periodic functions is

$$L^2_{\#}(Y) = \{ \varphi \in L^2_{loc}(\mathbb{R}^d), \ \varphi \text{ is } Y\text{-periodic} \},$$

endowed with the usual scalar product and norm of $L^2(Y)$. It turns out that $L^2_{\#}(Y)$ coincides with $L^2(Y)$. Higher-order Sobolev spaces are defined, for $m \geq 1$, by

$$H_{\#}^m(Y) = \{ \varphi \in H_{loc}^m(\mathbb{R}^d), \ \varphi \text{ is } Y\text{-periodic} \},$$

endowed with the usual scalar product and norm of $H^m(Y)$. Let us recall a classical regularity result [4].

Lemma 3.3. Let $m \geq 0$ and Y_F be of class C^{m+2} , consider $\mathbf{f}(y) \in H^m_\#(Y)^d$ and $g(y) \in H^{m+1}_\#(Y)$ with zero mean on Y. The problem

$$\begin{cases}
-\Delta_{y} \boldsymbol{u} + \boldsymbol{\nabla}_{y} p = \boldsymbol{f}(y) & \text{in } Y_{F}, \\
\operatorname{div}_{y} \boldsymbol{u} = g(y) & \text{in } Y_{F}, \\
\boldsymbol{u} = \boldsymbol{0} & \text{on } \partial Y_{S}, \\
y \to \boldsymbol{u}(y), \ p(y) & Y - periodic,
\end{cases} \tag{21}$$

admits a unique solution $\mathbf{u} \in H^{m+2}_{0,\#}(Y_F)^d$ and $p \in H^{m+1}_{\#}(Y_F)/\mathbb{R}$, where the space $H^k_{0,\#}(Y_F)$ is defined by

$$H^k_{0,\#}(Y_F) = \left\{ \varphi \in H^k_\#(Y_F) \text{ such that } \varphi = \mathbf{0} \text{ on } \partial Y_S \right\}$$

Using Lemma 3.3, it is clear that (12) and (20) admits a unique solution since the right hand side of the divergence condition has zero-average in Y_F . In particular ω_i and $\gamma_{i,j}$ are in $H^{m+2}_{0,\#}(Y_F)^d$, π_i and $\theta_{i,j}$ are in $H^{m+1}_{\#}(Y_F)/\mathbb{R}$.

The conclusion of this section is that we obtained an approximation of order 3 of the velocity

$$\boldsymbol{u}_{\varepsilon}(x) \approx \varepsilon^{2} \boldsymbol{u}_{2}\left(x, \frac{x}{\varepsilon}\right) + \varepsilon^{3} \boldsymbol{u}_{3}\left(x, \frac{x}{\varepsilon}\right),$$
 (22)

and of order 1 of the pressure

$$p_{\varepsilon}(x) \approx p^{*}(x) + \varepsilon p_{1}\left(x, \frac{x}{\varepsilon}\right).$$
 (23)

The derivation of (22) and (23) is merely formal but these approximations are key ingredients in the rigorous proof of our main result of quantitative homogenization.

4 A quantitative homogenization result

4.1 Main result

Our main result is a quantitative error estimate for the homogenization of Stokes equations in a periodic porous medium, which was loosely announced as Theorem 1.1 in the introduction. A more precise statement of this result is given below.

Theorem 4.1. Let \mathbf{u}_{ε} , p_{ε} be the solution to the Stokes equations (1), p^* be the solution to the Darcy equation (16) and \mathbf{u}_2 be defined by (13). Under Assumption 2.1 and assuming that \mathbf{f} belongs to $H^2(\Omega)^d \cap C^{1,\alpha}(\overline{\Omega})^d$ with $0 < \alpha < 1$, there holds:

$$\|p_{\varepsilon}(x) - p^{*}(x)\|_{L^{2}(\Omega^{\varepsilon})} \le C\varepsilon^{\frac{1}{2}} \|\boldsymbol{f}(x) - \boldsymbol{\nabla}p^{*}(x)\|_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})}$$
(24)

$$|\boldsymbol{u}_{\varepsilon}(x) - \varepsilon^{2}\boldsymbol{u}_{2}\left(x, \frac{x}{\varepsilon}\right)|_{H^{1}(\Omega^{\varepsilon})} \leq C\varepsilon^{\frac{3}{2}} \|\boldsymbol{f}(x) - \boldsymbol{\nabla}p^{*}(x)\|_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})}$$
(25)

$$\|\boldsymbol{u}_{\varepsilon}(x) - \varepsilon^{2}\boldsymbol{u}_{2}\left(x, \frac{x}{\varepsilon}\right)\|_{L^{2}(\Omega^{\varepsilon})} \leq C\varepsilon^{\frac{5}{2}}\|\boldsymbol{f}(x) - \boldsymbol{\nabla}p^{*}(x)\|_{H^{2}(\Omega)\cap C^{1,\alpha}(\overline{\Omega})}$$
(26)

where C is independent of ε and the data.

Theorem 4.1 was already proved in the easier case of isolated obstacles in [11] when d=2 and in [14] for any dimension. The main novelty of the present paper is that Theorem 4.1 applies to the physically relevant case of connected obstacles (in dimension $d \ge 3$)

Remark 4.2. In Theorem 4.1, the regularity of \mathbf{f} ensures that ∇p^* also belongs to $H^2(\Omega)^d \cap C^{1,\alpha}(\overline{\Omega})^d$ (see Proposition 3.2). We assume that $\mathbf{f} \in H^2(\Omega)^d \cap C^{1,\alpha}(\overline{\Omega})^d$, but all the following only requires the assumption that the difference $(\mathbf{f} - \nabla p^*)$ belongs to $H^2(\Omega)^d \cap C^{1,\alpha}(\overline{\Omega})^d$.

Remark 4.3. The two estimates for the velocity essentially mean that the relative error for the velocity in the H^1 -norm is of the order $\sqrt{\varepsilon}$. Indeed, the velocity is of order ε^2 (be it \mathbf{u}_{ε} or $\varepsilon^2\mathbf{u}_2$), but its gradient is of order ε (see the derivative rule (7)) since they oscillate on the length scale ε . Finally the relative error for the pressure is also of order $\sqrt{\varepsilon}$. Eventually, upon rescaling the velocity, we can write:

$$\varepsilon^{-2} \| \boldsymbol{u}_{\varepsilon} - \varepsilon^{2} \boldsymbol{u}_{2} \|_{L^{2}(\Omega^{\varepsilon})} + \varepsilon^{-1} | \boldsymbol{u}_{\varepsilon} - \varepsilon^{2} \boldsymbol{u}_{2} |_{H^{1}(\Omega^{\varepsilon})} + \| p_{\varepsilon} - p^{*} \|_{L^{2}(\Omega^{\varepsilon})} \leq C \sqrt{\varepsilon} \| \boldsymbol{f} - \boldsymbol{\nabla} p^{*} \|_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})}.$$

The relative error of order $\sqrt{\varepsilon}$ is worse than the expected ε . It is a classical phenomenon in homogenization [3, 2, 11] due to boundary layer effects caused by the Dirichlet boundary condition on $\partial\Omega$. Technically, this is taken into account by introducing a suitably chosen cutoff function η^{ε} in the proof. If the boundary layers were absent, which would be the case, for example, with periodic boundary conditions over a rectangular box $\Omega = \prod_{i=1}^{d} (0, \varepsilon n_i)$ with $n_i \in \mathbb{N}$, the error estimate would improve and give a relative error of order ε :

$$\varepsilon^{-2} \| \boldsymbol{u}_{\varepsilon} - \varepsilon^{2} \boldsymbol{u}_{2} \|_{L^{2}(\Omega^{\varepsilon})} + \varepsilon^{-1} | \boldsymbol{u}_{\varepsilon} - \varepsilon^{2} \boldsymbol{u}_{2} |_{H^{1}(\Omega^{\varepsilon})} + \| p_{\varepsilon} - p^{*} \|_{L^{2}(\Omega^{\varepsilon})} \leq C \varepsilon \| \boldsymbol{f} - \boldsymbol{\nabla} p^{*} \|_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})}.$$

The proof of Theorem 4.1 is given in Subsection 4.5. Beforehand it requires three technicals lemmas concerning (i) solving a non-homogeneous divergence equation in a porous domain (Lemma 4.9), (ii) correcting a non-homogeneous boundary conditions (Lemma 4.13) and (iii) representing periodic divergence-free fields (Lemma 4.15).

4.2 Correction of the divergence condition

Notation 4.4. In the following, for any $\phi \in H_0^1(\Omega^{\varepsilon})$, we also denote by ϕ its extension by zero in $\Omega \setminus \Omega^{\varepsilon}$, which belongs to $H_0^1(\Omega)$.

Definition 4.5. We note π_i^{ε} the linear continuous invertible application, composed of a translation and an homothety of ratio $\frac{1}{\varepsilon}$, which maps any cell Y_i^{ε} onto the reference cell Y:

$$\begin{array}{cccc} \pi_i^{\varepsilon}: & Y_i^{\varepsilon} & \longrightarrow & Y \\ & x & \longmapsto & y = \frac{x}{\varepsilon} + \text{translation.} \end{array} \tag{27}$$

First, we recall the Poincaré inequality in perforated domains (for a proof, see [10]).

Lemma 4.6. Assume that the hypotheses on the unit cell Y (Section 2.1) hold true, then there exists a constant C > 0, independent of ε , such that, for any $\phi \in H_0^1(\Omega^{\varepsilon})$,

$$\|\phi\|_{L^2(\Omega^{\varepsilon})} \le C\varepsilon |\phi|_{H^1(\Omega^{\varepsilon})}. \tag{28}$$

We now recall a result [15, 1] on a restriction operator for velocities defined on the full domain Ω which are restricted to the porous domain Ω^{ε} .

Lemma 4.7. Assume that the hypotheses on the unit cell Y (Section 2.1) hold true. Then there exists a linear continuous operator R_{ε} such that:

- 1. $R_{\varepsilon} \in \mathcal{L}\left(H_0^1(\Omega)^d; H_0^1(\Omega^{\varepsilon})^d\right);$
- 2. $\boldsymbol{u} \in H_0^1(\Omega^{\varepsilon})^d$ implies $R_{\varepsilon}\boldsymbol{u} = \boldsymbol{u}$ in Ω^{ε} ;
- 3. div $\mathbf{u} = 0$ in $\Omega \setminus \Omega^{\varepsilon}$ implies div $(R_{\varepsilon}\mathbf{u}) = \text{div } \mathbf{u}$ in Ω^{ε} ;
- 4. there exists a constant C, which does not depend on ε , such that, for any $\mathbf{u} \in H_0^1(\Omega)^d$, we have:

$$||R_{\varepsilon}\boldsymbol{u}||_{L^{2}(\Omega^{\varepsilon})} + \varepsilon ||\nabla(R_{\varepsilon}\boldsymbol{u})||_{L^{2}(\Omega^{\varepsilon})} \leq C \left(||\boldsymbol{u}||_{L^{2}(\Omega)} + \varepsilon ||\nabla \boldsymbol{u}||_{L^{2}(\Omega)}\right).$$

Remark 4.8. Lemma 4.7 was first proved in [15] for the case of a solid part Y_S strictly included in the cell Y (see Figure 3a) and was then extended in [1] for the more general case of a solid part Y_S which touches the boundary of Y (see Figure 3b).

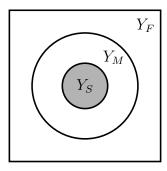


Figure 5: Schematic description of the domain Y_M around Y_S

Proof. Since we shall need specific properties of the operator R_{ε} in the sequel, we briefly recall how to construct this operator. We start with the simpler case of isolated obstacles, namely when the solid part Y_S is strictly included in the cell Y (the general case is presented afterwards). Consider a domain Y_M , strictly contained in Y, such that ∂Y_M is smooth and encloses Y_S as presented in Figure 5.

Then for a given $\mathbf{u} \in H^1(Y)^d$, there exists $\mathbf{v} \in H^1(Y_M \setminus Y_S)^d$, $q \in L^2(Y_M \setminus Y_S)/\mathbb{R}$ satisfying:

$$\begin{cases}
-\Delta \boldsymbol{v} + \boldsymbol{\nabla} p &= -\Delta \boldsymbol{u} & \text{in } Y_{M} \setminus Y_{S}, \\
\operatorname{div} \boldsymbol{v} &= \operatorname{div} \boldsymbol{u} + \frac{1}{|Y_{M} \setminus Y_{S}|} \int_{Y_{S}} \operatorname{div} \boldsymbol{u} & \text{in } Y_{M} \setminus Y_{S}, \\
\boldsymbol{v} &= \boldsymbol{u} & \text{on } \partial Y_{M}, \\
\boldsymbol{v} &= \boldsymbol{0} & \text{on } \partial Y_{S}.
\end{cases} (29)$$

This problem is well posed, since the compatibility condition can easily be checked on the data, namely

$$\int_{Y_M \setminus Y_S} \operatorname{div} \boldsymbol{v} = \int_{\partial (Y_M \setminus Y_S)} \boldsymbol{v} \cdot \boldsymbol{n}.$$

Now, a restriction operator R is constructed as follow: for any $\mathbf{u} \in H^1(Y)^d$:

$$Ru = \begin{cases} u \text{ in } Y \setminus Y_{M}, \\ v \text{ in } Y_{M} \setminus Y_{S}, \\ \mathbf{0} \text{ in } Y_{S}. \end{cases}$$
(30)

Clearly, R is linear continuous from $H^1(Y)^d$ to its subspace of functions vanishing on Y_S , satisfying

$$||R\boldsymbol{u}||_{H^1(Y)} \le C||\boldsymbol{u}||_{H^1(Y)},$$
 (31)

and such that, if $\mathbf{u} = 0$ in Y_S , then $R\mathbf{u} = \mathbf{u}$, and, if $\operatorname{div} \mathbf{u} = 0$ in Y_S , then $\operatorname{div} R\mathbf{u} = \operatorname{div} \mathbf{u}$ in Y. Then the operator R_{ε} is defined by applying the mapping (27) to the operator R and, with standard scaling properties, it comes from (31):

$$\|R_{\varepsilon}\boldsymbol{u}\|_{L^{2}(\Omega^{\varepsilon})}^{2} + \varepsilon^{2}\|\boldsymbol{\nabla}(R_{\varepsilon}\boldsymbol{u})\|_{L^{2}(\Omega^{\varepsilon})}^{2} \leq C\left(\|\boldsymbol{u}\|_{L^{2}(\Omega)}^{2} + \varepsilon^{2}\|\boldsymbol{\nabla}\boldsymbol{u}\|_{L^{2}(\Omega)}^{2}\right),$$

which implies that R_{ε} satisfies all four properties of Lemma 4.7.

We now turn to the case of connected obstacles, namely when Y_S touches the cell boundary ∂Y as presented in Figure 3b. The construction of R_{ε} is slightly more involved. First, we define a linear continuous operator $Q_{\varepsilon} \in \mathcal{L}\left(H_0^1(\Omega)^d; H_0^1(\Omega^{\varepsilon})^d\right)$ by

$$\begin{cases}
-\Delta(Q_{\varepsilon}\boldsymbol{u}) = -\Delta\boldsymbol{u} & \text{in } \Omega^{\varepsilon} \cap C_{1}^{\varepsilon}, \\
Q_{\varepsilon}\boldsymbol{u} = \boldsymbol{0} & \text{on } \partial\Omega^{\varepsilon} \cap C_{1}^{\varepsilon}, \\
Q_{\varepsilon}\boldsymbol{u} = \boldsymbol{u} & \text{on } \partial C_{1}^{\varepsilon}, \\
Q_{\varepsilon}\boldsymbol{u} = \boldsymbol{u} & \text{in } \Omega \setminus C_{1}^{\varepsilon},
\end{cases} \tag{32}$$

where C_1^{ε} is defined by Assumption 2.1 as the union of entire cells inside Ω . Clearly, $Q_{\varepsilon}\boldsymbol{u}=\boldsymbol{u}$ if and only if $\boldsymbol{u}\in H_0^1(\Omega^{\varepsilon})^d$. Thanks to the definition of C_1^{ε} and C_2^{ε} , there exists a smooth cut-off function ζ^{ε} such that $\zeta^{\varepsilon}(x)=1$ on $\partial C_1^{\varepsilon}$, $\zeta^{\varepsilon}(x)=0$ in C_2^{ε} and $\|\nabla \zeta^{\varepsilon}\|_{L^{\infty}}(C_1^{\varepsilon})\leq \frac{C}{\varepsilon}$. One can rewrite (32) for the new unknown $\boldsymbol{w}^{\varepsilon}=Q_{\varepsilon}\boldsymbol{u}-\zeta^{\varepsilon}\boldsymbol{u}$ as

$$\begin{cases}
-\Delta \boldsymbol{w}^{\varepsilon} = -\Delta((1-\zeta^{\varepsilon})\boldsymbol{u}) & \text{in } \Omega^{\varepsilon} \cap C_{1}^{\varepsilon}, \\
\boldsymbol{w}^{\varepsilon} = \boldsymbol{0} & \text{on } \partial\Omega^{\varepsilon} \cap C_{1}^{\varepsilon}, \\
\boldsymbol{w}^{\varepsilon} = \boldsymbol{0} & \text{on } \partial C_{1}^{\varepsilon}.
\end{cases} \tag{33}$$

Multiplying (33) by \mathbf{w}^{ε} leads to an a priori estimate, which, combined with Poincaré inequality (Lemma 4.6), implies that there exists a constant C, which does not depend on ε , such that, for any $\mathbf{u} \in H_0^1(\Omega)^d$, we have:

$$\|Q_{\varepsilon}\boldsymbol{u}\|_{L^{2}(\Omega^{\varepsilon})} + \varepsilon \|\boldsymbol{\nabla}(Q_{\varepsilon}\boldsymbol{u})\|_{L^{2}(\Omega^{\varepsilon})} \leq C \left(\|\boldsymbol{u}\|_{L^{2}(\Omega)} + \varepsilon \|\boldsymbol{\nabla}\boldsymbol{u}\|_{L^{2}(\Omega)}\right).$$

Then, for each cell Y_i^{ε} , we define a linear operator Q_i , from $H^1(Y)^d$ to its subspace of functions vanishing on Y_S , as follows: for any $\boldsymbol{u} \in H_0^1(\Omega)^d$,

$$\left(Q_i\left(\boldsymbol{u}\circ(\pi_i^{\varepsilon})^{-1}\right)\right)\circ\pi_i^{\varepsilon}=Q_{\varepsilon}\boldsymbol{u}\text{ in }Y_i^{\varepsilon}.$$
(34)

Recall from Assumption 2.1 that we defined two set of indices \mathcal{I}_1 and \mathcal{I}_2 , corresponding to the cells Y_i^{ε} which cover C_1^{ε} and C_2^{ε} , respectively. Define a third set $\mathcal{I}_0 = \{i \in \mathbb{Z}^d \text{ s.t } Y_i^{\varepsilon} \cap \Omega \neq \emptyset\}$, so that $\mathcal{I}_2 \subset \mathcal{I}_1 \subset \mathcal{I}_0$. We now define a family of restriction operators R_i , depending in which set $\mathcal{I}_2, \mathcal{I}_1, \mathcal{I}_0$ the index i belongs to.

For $i \in \mathcal{I}_2$ (meaning that the corresponding cell contains a solid obstacle), R_i is defined, for any $\mathbf{u} \in H^1(Y)^d$, by

$$\begin{cases}
-\Delta R_{i} \boldsymbol{u} + \boldsymbol{\nabla} p &= -\Delta \boldsymbol{u} & \text{in } Y_{F}, \\
\operatorname{div} R_{i} \boldsymbol{u} &= \operatorname{div} \boldsymbol{u} + \frac{1}{|Y_{F}|} \int_{Y_{S}} \operatorname{div} \boldsymbol{u} & \text{in } Y_{F}, \\
R_{i} \boldsymbol{u} &= Q_{i} \boldsymbol{u} + \phi_{k} \left(\int_{\Sigma_{k}} (\boldsymbol{u} - Q_{i} \boldsymbol{u}) \cdot \boldsymbol{e_{k}} \right) \boldsymbol{e_{k}} & \text{on } \Sigma_{k} \cap \overline{Y_{F}}, \\
R_{i} \boldsymbol{u} &= \boldsymbol{0} & \text{on } \partial Y_{S},
\end{cases} (35)$$

where $(\Sigma_k)_{1 \leq |k| \leq d}$ are the 2d faces of the unit cube $(\Sigma_k \text{ and } \Sigma_{-k} \text{ are opposite faces})$, with unit normal vector \mathbf{e}_k , and $(\phi_k)_{1 \leq |k| \leq d}$ is a family of smooth, non-negative functions, compactly supported in the periodic repetition of $\overline{Y_F}$, satisfying

$$\int_{\Sigma_k} \phi_k = 1, \quad \phi_{k|_{\Sigma_k}} \equiv \phi_{-k|_{\Sigma_{-k}}} \text{ and } \phi_{k|_{\Sigma_{k'}}} \equiv 0 \text{ if } k \neq k'.$$

The existence of such a family of functions ϕ_k is guaranteed by the assumptions on the unit cell in Subsection 2.1, which imply that the surface measure of $\Sigma_k \cap \overline{Y_F}$ is non-zero (see [1] for more details). Problem (35) is well posed, since the data of the trace of $R_i u$ belongs to $H^{1/2}(Y_F)^d$ and the compatibility condition on the divergence data is satisfied, namely

$$\int_{Y_F} \operatorname{div} R_i \boldsymbol{u} = \int_{\partial Y_F} R_i \boldsymbol{u} \cdot \boldsymbol{n}.$$

For $i \in \mathcal{I}_1 \setminus \mathcal{I}_2$ (meaning that the corresponding cell does not contain a solid obstacle but one of its face may touch an obstacle), R_i is defined, for any $u \in H^1(Y)^d$, by

$$\begin{cases}
-\Delta R_{i} \boldsymbol{u} + \boldsymbol{\nabla} p &= -\Delta \boldsymbol{u} & \text{in Y,} \\
\operatorname{div} R_{i} \boldsymbol{u} &= \operatorname{div} \boldsymbol{u} & \text{in Y,} \\
R_{i} \boldsymbol{u} &= Q_{i} \boldsymbol{u} + \phi_{k} \left(\int_{\Sigma_{k}} (\boldsymbol{u} - Q_{i} \boldsymbol{u}) \cdot \boldsymbol{e_{k}} \right) \boldsymbol{e_{k}} & \text{on } \Sigma_{k}, \\
R_{i} \boldsymbol{u} &= \boldsymbol{u} & \text{on } \tilde{\Sigma}_{k},
\end{cases}$$
(36)

where Σ_k are the faces of the cell which touch an obstacle and $\tilde{\Sigma}_k$ are the faces of the cell which do not touch any obstacle. Problem (36) is well posed, since the data of the trace of $R_i \mathbf{u}$ belongs to $H^{1/2}(Y)^d$ and the compatibility condition on the divergence data is satisfied, namely

$$\int_{Y} \operatorname{div} R_{i} \boldsymbol{u} = \int_{\partial Y} R_{i} \boldsymbol{u} \cdot \boldsymbol{n}.$$

For $i \in \mathcal{I}_0 \setminus \mathcal{I}_1$ (implying that the corresponding cell does not contain a solid obstacle and none of its face touches an obstacle), R_i is simply defined as $R_i u = u$. Note that this case corresponds to cells Y_i^{ε} which are cut by the boundary $\partial \Omega$. Inside such a cell, with a possibly wild geometry, it is not clear that a Stokes problem of the type of (36) satisfies a priori estimates, independent of the geometry (this is precisely why the two sets of indices \mathcal{I}_1 and \mathcal{I}_2 have been introduced). A similar estimate to (31) holds true for all operators R_i with a constant C independent of i and ε .

Finally, the restriction operator $R_{\varepsilon} \in \mathcal{L}\left(H_0^1(\Omega)^d; H_0^1(\Omega^{\varepsilon})^d\right)$ is defined, for any $\boldsymbol{u} \in H_0^1(\Omega)^d$, by

$$R_{\varepsilon} \boldsymbol{u} = (R_i (\boldsymbol{u} \circ (\pi_i^{\varepsilon})^{-1})) \circ \pi_i^{\varepsilon} \text{ in } Y_i^{\varepsilon}.$$

It is easy again to check that R_{ε} satisfies all four properties of Lemma 4.7. Note however that, here, the definition of R_{ε} is not local in each cell since they are all coupled through the operator Q_{ε} .

We now state a key lemma for our analysis. It was already presented in [11] in two dimensions for the case when Y_S is strictly included in Y. It was also stated as Theorem 14.2 in [5] for the general case of any Y_S and any space dimension but its proof was rather technical, decomposed in several exercices. Here, we present a new and detailed proof, using different arguments.

Lemma 4.9. For any $q \in L_0^2(\Omega^{\varepsilon})$ there exists $v_{d\varepsilon} \in H_0^1(\Omega^{\varepsilon})^d$ such that

$$\operatorname{div} \boldsymbol{v}_{d\varepsilon} = q \text{ on } \Omega^{\varepsilon} \text{ and } |\boldsymbol{v}_{d\varepsilon}|_{H^{1}(\Omega^{\varepsilon})} \leq \frac{C}{\varepsilon} ||q||_{L^{2}(\Omega^{\varepsilon})}$$
(37)

where C > 0 is a constant independent of ε .

Proof. For any $q \in L_0^2(\Omega^{\varepsilon})$ we still denote by q its extension by zero inside the obstacles B^{ε} . One can easily check that its average on Ω still vanishes and thus $q \in L_0^2(\Omega)$ with q = 0 on B^{ε} . Using [9, corollary 2.4 (page 24)], there exists a (non unique) $\mathbf{w} \in H_0^1(\Omega)^d$ such that:

$$\operatorname{div} \boldsymbol{w} = q \text{ on } \Omega \quad \text{and} \quad \|\boldsymbol{w}\|_{H^1(\Omega)} \le C \|q\|_{L^2(\Omega)}. \tag{38}$$

Since q = 0 on B^{ε} , we have:

$$\operatorname{div} \boldsymbol{w} = 0 \text{ in } \Omega \setminus \Omega^{\varepsilon}.$$

Using the restriction operator R_{ε} defined in Lemma 4.7, we have:

$$\operatorname{div}(R_{\varepsilon}\boldsymbol{w}) = q \text{ in } \Omega^{\varepsilon}. \tag{39}$$

Considering $\varepsilon < 1$ in the fourth property of Lemma 4.7, it follows:

$$||R_{\varepsilon}\boldsymbol{w}||_{L^{2}(\Omega^{\varepsilon})} + \varepsilon ||\nabla R_{\varepsilon}\boldsymbol{w}||_{L^{2}(\Omega^{\varepsilon})} \le C||\boldsymbol{w}||_{H^{1}(\Omega)}$$

and consequently:

$$\varepsilon \|\nabla(R_{\varepsilon}\boldsymbol{w})\|_{L^{2}(\Omega^{\varepsilon})} \le C \|\boldsymbol{w}\|_{H^{1}(\Omega)} \le C \|q\|_{L^{2}(\Omega^{\varepsilon})}. \tag{40}$$

Therefore, $\mathbf{v}_{d\varepsilon} = R_{\varepsilon} \mathbf{w}$ is a solution of (37).

4.3 Correction of the boundary condition

In this section, we build a divergence-free field which satisfies a given boundary condition. Recall the definition of the curl* operator, proposed in [6].

Definition 4.10. The operator curl* is defined as:

$$\operatorname{curl}^*: C^1(\mathbb{R}^d)^{d(d-1)/2} \longrightarrow C^0(\mathbb{R}^d)^d$$

$$\mathcal{A} \longmapsto \left(\sum_{j=1}^{i-1} \frac{\partial \mathcal{A}_{ji}}{\partial x_j} - \sum_{j=i+1}^d \frac{\partial \mathcal{A}_{ij}}{\partial x_j}\right)_{1 \leq i \leq d}$$

$$(41)$$

where $\mathbf{A} = (A_{ij})_{1 \le i \le j \le d} \in \mathbb{R}^{d(d-1)/2}$.

A simple computation shows that the image of this curl* operator is divergence-free, namely div curl* $\mathcal{A} = 0$ for any $\mathcal{A} \in C^1(\mathbb{R}^d)^{d(d-1)/2}$. This is an expected property since curl* is an extension, to any dimension d, of the standard curl operator in 2-d and 3-d. We now state a preliminary lemma, also adapted from [6]

Lemma 4.11. Let $\Omega \subset \mathbb{R}^d$ be a bounded connected open set with a smooth boundary of class $C^{3,\alpha}$, for some $0 < \alpha < 1$. Let \boldsymbol{g} in $C^{1,\alpha}\left(\overline{\Omega}\right)^d$ with $\boldsymbol{g} \cdot \boldsymbol{n} = 0$ on $\partial\Omega$. Then there exists $\boldsymbol{\mathcal{A}}$ in $C^{2,\alpha}(\overline{\Omega})^{d(d-1)/2}$ such that:

$$\operatorname{curl}^*(\mathcal{A}) = g \text{ on } \partial\Omega \text{ and } \mathcal{A} = 0 \text{ on } \partial\Omega.$$
 (42)

In other words, the vector field $\operatorname{curl}^*(\mathcal{A})$ is divergence-free and its trace on $\partial\Omega$ coincides with g.

Proof. [6, Lemma 1] ensures that there exists $\mathcal{A} \in C^{2,\alpha}(\overline{\Omega})^{d(d-1)/2}$, with $\mathcal{A} = \mathbf{0}$ on $\partial\Omega$, such that

$$\nabla \mathcal{A}_{ij} = (g_j n_i - g_i n_j) \boldsymbol{n} \text{ on } \partial \Omega, \tag{43}$$

where \boldsymbol{n} is the outward unit normal vector, g_i and n_i are respectively the *i*th coordinate of \boldsymbol{g} and \boldsymbol{n} in the canonical basis of \mathbb{R}^d . It remains to check that $\operatorname{curl}^*(\boldsymbol{\mathcal{A}}) = \boldsymbol{g}$ on $\partial\Omega$. Indeed, we have on $\partial\Omega$:

$$(\operatorname{curl}^* \mathcal{A})_i = \sum_{j=1}^{i-1} (g_i n_j - g_j n_i) n_j - \sum_{j=i+1}^d (g_j n_i - g_i n_j) n_j$$
$$= \sum_{j=1, j \neq i}^d g_i n_j^2 - \sum_{j=1, j \neq i}^d g_j n_j n_i = \sum_{j=1}^d g_i n_j^2 = g_i,$$

where we used the assumption that $\mathbf{g} \cdot \mathbf{n} = 0$ on $\partial \Omega$.

The next step is to localize in the vicinity of the boundary $\partial\Omega$ the divergence-free field which lifts a given boundary condition. To do this, we introduce the following classical cut-off function as in [3, 11].

Definition 4.12 (Cut-off function). For a small enough constant c > 0, define a neighborhood of the boundary $\partial \Omega$, denoted by $O^{\varepsilon} := \{x \in \Omega : \operatorname{dist}(x, \partial \Omega) \leq c\varepsilon\}$ (band of width $c\varepsilon$ near $\partial \Omega$). Then we choose a cut-off function $\theta^{\varepsilon} \in C^{\infty}(\Omega)$ such that $\theta^{\varepsilon}(x) = 1$ in $O^{\varepsilon/2}$, $\theta^{\varepsilon}(x) = 0$ in $\Omega \setminus O^{\varepsilon}$, and

$$\|\nabla \theta^{\varepsilon}\|_{L^{\infty}}(\Omega) \le \frac{C}{\varepsilon}, \quad \|\nabla^{2} \theta^{\varepsilon}\|_{L^{\infty}}(\Omega) \le \frac{C}{\varepsilon^{2}}.$$
 (44)

The main result of this section is the following lemma.

Lemma 4.13. For any $\mathbf{g} \in C^{1,\alpha}\left(\overline{\Omega}\right)^d$ with $\operatorname{div} \mathbf{g} = 0$ in Ω , $\mathbf{g} \cdot \mathbf{n} = 0$ on $\partial \Omega$, there exists $\mathbf{v}_{b\varepsilon} \in H^1(\Omega)^d$ such that supp $\mathbf{v}_{b\varepsilon} \subset O^{\varepsilon} := \{x \in \Omega : \operatorname{dist}(x, \partial \Omega) < c\varepsilon\}$ and

$$\mathbf{v}_{b\varepsilon} = \mathbf{g} \text{ on } \partial\Omega, \text{ div } \mathbf{v}_{b\varepsilon} = 0 \text{ in } \Omega \text{ and } |\mathbf{v}_{b\varepsilon}|_{\mathrm{H}^{1}(\Omega)} \leq \frac{\mathrm{C}}{\sqrt{\varepsilon}} ||\mathbf{g}||_{\mathrm{C}^{1,\alpha}(\Omega)}$$
 (45)

where C > 0 is a constant independent of ε .

Remark 4.14. Lemma 4.13 was already proved in [11] in two dimensions. Here, we extend this result to any dimension.

Proof. Let $\mathbf{g} \in C^{1,\alpha}\left(\overline{\Omega}\right)^d$ with div $\mathbf{g} = 0$ in Ω , $\mathbf{g} \cdot \mathbf{n} = 0$ on $\partial\Omega$. By virtue of Lemma 4.11, there exists a function $\mathbf{A} \in C^{2,\alpha}(\overline{\Omega})^{d(d-1)/2}$, such that $\operatorname{curl}^*(\mathbf{A}) = \mathbf{g}$ on $\partial\Omega$. Define:

$$\mathbf{v}_{b\varepsilon} = \operatorname{curl}^*(\theta^{\varepsilon} \mathbf{A}),$$
 (46)

where θ^{ε} is the cut-off function introduced in Definition 4.12. Obviously, div $\mathbf{v}_{b\varepsilon} = 0$ in Ω . Then, $\mathbf{v}_{b\varepsilon} = \mathbf{g}$ on $\partial \Omega$ since, in the vicinity $O^{\varepsilon/2}$ of $\partial \Omega$, we recall that $\theta^{\varepsilon} \equiv 1$. Finally, it remains to bound $|\mathbf{v}_{b\varepsilon}|_{H^1(\Omega)}$. We write:

$$\operatorname{curl}^*(\theta^{\varepsilon} \mathbf{A}) = \theta^{\varepsilon} \operatorname{curl}^*(\mathbf{A}) + \Gamma(\mathbf{A}, \nabla \theta^{\varepsilon})$$
(47)

where $\Gamma(\mathcal{A}, \nabla \theta^{\varepsilon})$ is defined as:

$$\Gamma(\mathcal{A}, \nabla \theta^{\varepsilon})_{i} = \sum_{j=1}^{i-1} \mathcal{A}_{ji} \frac{\partial \theta^{\varepsilon}}{\partial x_{j}} - \sum_{j=i+1}^{d} \mathcal{A}_{ij} \frac{\partial \theta^{\varepsilon}}{\partial x_{j}}.$$

It follows therefore:

$$|v_{b\varepsilon}|_{H^{1}(\Omega)} \leq \|\theta^{\varepsilon} \nabla \operatorname{curl}^{*}(\mathcal{A})\|_{L^{2}(O^{\varepsilon})} + \|\nabla \theta^{\varepsilon} \operatorname{curl}^{*}(\mathcal{A})\|_{L^{2}(O^{\varepsilon})} + \|\nabla \Gamma(\mathcal{A}, \nabla \theta^{\varepsilon})\|_{L^{2}(O^{\varepsilon})}$$

$$\leq C \left(\sqrt{\varepsilon} \|\nabla \nabla \mathcal{A}\|_{L^{\infty}(O^{\varepsilon})} + \frac{1}{\sqrt{\varepsilon}} \|\nabla \mathcal{A}\|_{L^{\infty}(O^{\varepsilon})}\right) + \|\nabla \Gamma(\mathcal{A}, \nabla \theta^{\varepsilon})\|_{L^{2}(O^{\varepsilon})},$$

since $meas(O^{\varepsilon}) \leq c\varepsilon$, and

$$\begin{split} \|\nabla\Gamma(\boldsymbol{\mathcal{A}}, \nabla\theta^{\varepsilon})\|_{L^{2}(O^{\varepsilon})} &\leq C\left(\|\nabla\theta^{\varepsilon}\|_{L^{\infty}(O^{\varepsilon})}\|\nabla\boldsymbol{\mathcal{A}}\|_{L^{2}(O^{\varepsilon})} + \|\nabla\nabla\theta^{\varepsilon}\|_{L^{\infty}(O^{\varepsilon})}\|\boldsymbol{\mathcal{A}}\|_{L^{2}(O^{\varepsilon})}\right) \\ &\leq C\left(\frac{1}{\varepsilon}\|\nabla\boldsymbol{\mathcal{A}}\|_{L^{2}(O^{\varepsilon})} + \frac{1}{\varepsilon^{2}}\|\boldsymbol{\mathcal{A}}\|_{L^{2}(O^{\varepsilon})}\right) \\ &\leq C\left(\frac{1}{\sqrt{\varepsilon}}\|\nabla\boldsymbol{\mathcal{A}}\|_{L^{\infty}(\Omega)} + \frac{1}{\varepsilon\sqrt{\varepsilon}}\|\boldsymbol{\mathcal{A}}\|_{L^{\infty}(O^{\varepsilon})}\right). \end{split}$$

We observe now that any point $x \in O^{\varepsilon}$ can be connected to a point $x' \in \partial \Omega$ by a segment of length no greater than $c\varepsilon$ lying in O^{ε} . Recalling that $\mathcal{A}(x') = 0$ and using the Taylor expansion of order 0 gives $|\mathcal{A}| \leq c\varepsilon |\nabla \mathcal{A}(z)|$ for some point z lying on this segment. Consequently, $||\mathcal{A}||_{L^{\infty}(O^{\varepsilon})} \leq c\varepsilon ||\nabla \mathcal{A}||_{L^{\infty}(O^{\varepsilon})}$ and

$$\|\nabla\Gamma(\mathcal{A},\nabla\theta^{\varepsilon})\|_{L^{2}(O^{\varepsilon})}\leq \frac{C}{\sqrt{\varepsilon}}\|\nabla\mathcal{A}\|_{L^{\infty}(O^{\varepsilon})},$$

which concludes the proof.

4.4 Representation of divergence-free fields

A key ingredient in the proof of Theorem 4.1 is a representation of periodic divergence-free and zero-mean fields as the image of a differential operator, the range of which is always divergence-free. This representation is given by the following.

Lemma 4.15. Let $g \in L^2_{\#}(Y)^d$ be periodic, satisfying

$$\int_{Y} \boldsymbol{g} dy = 0, \quad \operatorname{div}_{\mathbf{y}} \boldsymbol{g} = 0 \text{ in } Y.$$

There exists a (non-unique) periodic solution $\varphi \in H^1_\#(Y)^d$ to the problem

$$\begin{cases}
-\Delta_y \boldsymbol{\varphi} + \boldsymbol{\nabla}_y \operatorname{div}_y \boldsymbol{\varphi} = \boldsymbol{g} & \text{in } Y, \\
y \to \boldsymbol{\varphi}(y) & Y - \text{periodic,}
\end{cases}$$
(48)

which satisfies, for some constant C > 0,

$$\|\varphi\|_{H^2_{\#}(Y)} \le C \|g\|_{L^2_{\#}(Y)}.$$

Furthermore, for any $\psi \in H^2_{\#}(Y)^d$, it holds that

$$\operatorname{div}_{\mathbf{y}}\left(-\Delta_{y}\boldsymbol{\psi}+\boldsymbol{\nabla}_{y}\operatorname{div}_{\mathbf{y}}\boldsymbol{\psi}\right)=0\quad\text{in }Y.$$

Remark 4.16. More generally, the identity

$$\operatorname{div} \left(-\Delta \boldsymbol{\psi} + \boldsymbol{\nabla} \operatorname{div} \boldsymbol{\psi} \right) = 0 \quad \text{in } \mathbb{R}^d$$

holds true for any vector field $\psi \in H^2(\mathbb{R}^d)^d$.

Proof. Using Fourier series the periodic solution φ and the periodic right hand side g are written as

$$\varphi(y) = \sum_{\boldsymbol{\xi} \in \mathbb{Z}^d} \widehat{\varphi}(\boldsymbol{\xi}) e^{2i\pi\boldsymbol{\xi} \cdot y}, \quad \boldsymbol{g}(y) = \sum_{\boldsymbol{\xi} \in \mathbb{Z}^d} \widehat{\boldsymbol{g}}(\boldsymbol{\xi}) e^{2i\pi\boldsymbol{\xi} \cdot y},$$

where $\widehat{g}(\mathbf{0}) = \mathbf{0}$ and $\widehat{g}(\boldsymbol{\xi}) \cdot \boldsymbol{\xi} = 0$ for any $\boldsymbol{\xi} \in \mathbb{Z}^d$, because of the assumptions on \boldsymbol{g} . Then, (48) becomes:

$$4\pi^2 |\boldsymbol{\xi}|^2 \widehat{\boldsymbol{\varphi}} - 4\pi^2 (\boldsymbol{\xi} \cdot \widehat{\boldsymbol{\varphi}}) \boldsymbol{\xi} = \widehat{\boldsymbol{g}}. \tag{49}$$

By writing (49) under matrix form, we have:

$$A\widehat{\varphi} = \widehat{g}, \quad A(\xi) = 4\pi^2 \left(|\xi|^2 I_d - \xi \otimes \xi \right).$$

We see easily that $\ker(A) = \operatorname{span}(\boldsymbol{\xi})$. Since A is symmetric, we have $\operatorname{Im}(A) = \ker(A)^{\perp} = \{\boldsymbol{u} \in \mathbb{R}^d \text{ s.t } \boldsymbol{u} \cdot \boldsymbol{\xi} = 0\}$ and $\widehat{\boldsymbol{g}} \in \ker(A)^{\perp}$. Now, if we restrict the matrix A to its image, it is reduced to $|\boldsymbol{\xi}|^2 I_d$. Consequently, its inverse is simply given by $|\boldsymbol{\xi}|^{-2} I_d$ which gives the following solution:

$$\widehat{\varphi} = \frac{\widehat{g}}{4\pi^2 |\xi|^2}$$
 for any $\xi \neq 0$,

which is unique, up to the addition of a multiple of ξ . In other words, we obtained a solution $\varphi(y)$ of (48) which is unique up to the addition of a constant and of a periodic gradient. Now, recalling that ξ is an integer vector, we note that:

$$|\widehat{\boldsymbol{\varphi}}| = \frac{|\widehat{\boldsymbol{g}}|}{4\pi^2 |\boldsymbol{\xi}|^2} \le C|\widehat{\boldsymbol{g}}|, \quad |\boldsymbol{\xi}\widehat{\boldsymbol{\varphi}}| \le C|\widehat{\boldsymbol{g}}|, \quad |\boldsymbol{\xi}\boldsymbol{\xi}\widehat{\boldsymbol{\varphi}}| \le C|\widehat{\boldsymbol{g}}|,$$

which allows to conclude that φ belongs to $H^2_{\#}(Y)^d$.

In view of the proof of Theorem 4.1, Lemma 4.15 is applied to the solution ω_i of the cell problem (12). More precisely, introduce

$$oldsymbol{\omega_i}' = oldsymbol{\omega_i} - |Y_F| \langle oldsymbol{\omega_i}
angle = oldsymbol{\omega_i} - \int_Y oldsymbol{\omega_i},$$

which satisfies

$$\begin{cases} \operatorname{div}_{\mathbf{y}} \boldsymbol{\omega_{i}}' = 0 \text{ on } Y, \\ \boldsymbol{\omega_{i}}' \text{ is } \mathbb{Z}^{d} - \operatorname{periodic}, \\ \boldsymbol{\omega_{i}}' \text{ has zero mean over } Y. \end{cases}$$

According to Lemma 4.15, there exists a periodic function $\psi_i \in H^2_{\#}(Y)^d$ such that:

$$-\Delta_y \psi_i + \nabla_y \operatorname{div}_y \psi_i = \omega_i' \text{ in Y.}$$
(50)

In particular, since $\omega_i \in H^1_\#(Y)^d$, then $\psi_i \in H^3_\#(Y)^d$. This regularity cannot be improved since, although ω_i is smooth inside Y_F , it is not in the full cell Y. In particular, it implies that, at least for large dimension d, ψ_i and $\nabla_y \psi_i$ may not belong to $L^\infty(Y)$. This lack of regularity requires special care in the next subsection.

4.5 Proof of Theorem 4.1

Inspired by the approximation (22) of the two-scale asymptotic expansion, namely $u_{\varepsilon} \approx \varepsilon^2 u_2 + \varepsilon^3 u_3$, the main idea is to compare the velocity u_{ε} with $\varepsilon^2 u_2 + \varepsilon^3 u_3$. The difficulty is that the velocity correctors u_2 , u_3 , built in Section 3, do not satisfy the boundary condition, i.e. u_2 , u_3 do not vanish on $\partial\Omega$, and are not divergence-free. To satisfy this Dirichlet boundary condition for an approximation of u_{ε} , we introduce a cut-off function η^{ε} as in [11].

Definition 4.17. For a small enough constant c > 0, define a neighborhood of the boundary $\partial\Omega$, denoted by $O^{\varepsilon} := \{x \in \Omega : \operatorname{dist}(x, \partial\Omega) \leq c\varepsilon\}$ (band of width $c\varepsilon$ near $\partial\Omega$). Then we choose a cut-off function $\eta^{\varepsilon} \in C^{\infty}(\overline{\Omega})$ such that η^{ε} and all its derivatives vanish on $\partial\Omega$, while $\eta^{\varepsilon}(x) = 1$ on $\Omega \setminus O^{\varepsilon}$ and

$$\|1 - \eta^{\varepsilon}\|_{L^{2}(\Omega)} \le C\sqrt{\varepsilon}; \quad \|\eta^{\varepsilon}\|_{L^{\infty}(\Omega)} = 1; \quad \|\nabla \eta^{\varepsilon}\|_{L^{\infty}(\Omega)} \le \frac{C}{\varepsilon}; \quad \|\nabla \nabla \eta^{\varepsilon}\|_{L^{\infty}(\Omega)} \le \frac{C}{\varepsilon^{2}}.$$
 (51)

If we simply multiply the approximation $\varepsilon^2 u_2 + \varepsilon^3 u_3$ by the cut-off function η^{ε} , of course the Dirichlet boundary condition will be satisfied on $\partial\Omega$ but the divergence of the product is not under control. Therefore, a more clever use of η^{ε} is required. It turns out that only u_2 needs a special treatment. Recall from (13) that

$$u_2(x,y) = \frac{1}{\nu} \omega_i(y) \left(f_i(x) - \frac{\partial p^*}{\partial x_i}(x) \right).$$

The main idea is to decompose ω_i as

$$\omega_{i} = \omega_{i}' + |Y_{F}|\langle \omega_{i} \rangle,$$

and to use (50) to replace ω_i by its representation as derivatives of the periodic function ψ_i . Then, the cut-off function is inserted inside this differential representation as

$$(-\Delta + \nabla \operatorname{div}) (\eta^{\varepsilon} \psi_{i}),$$

which has the advantage of being divergence-free and vanishing on the boundary $\partial\Omega$. We shall not apply the cut-off function to the other (non-oscillating) term

$$\frac{1}{\nu}|Y_F|\langle\boldsymbol{\omega_i}\rangle\left(f_i(x) - \frac{\partial p^*}{\partial x_i}(x)\right) \equiv |Y_F|\boldsymbol{u}(x),$$

where \boldsymbol{u} is divergence-free (because it is the Darcy velocity) and satisfies $\boldsymbol{u} \cdot \boldsymbol{n} = 0$ on $\partial \Omega$. To correct this boundary condition we apply Lemma 4.13 to $\boldsymbol{g} = |Y_F|\boldsymbol{u}$. The assumptions of Lemma 4.13 are satisfied, by its very definition (15), the Darcy velocity \boldsymbol{u} belongs to $C^{1,\alpha}(\overline{\Omega})^d$, satisfies div $\boldsymbol{u} = 0$ in Ω and $\boldsymbol{u} \cdot \boldsymbol{n} = 0$ on $\partial \Omega$. Thus Lemma 4.13 ensures that there exists $\boldsymbol{v}_{\boldsymbol{b}\boldsymbol{\varepsilon}} \in H^1(\Omega)^d$ supported in $O^{\boldsymbol{\varepsilon}}$ such that:

$$\operatorname{div} \boldsymbol{v}_{\boldsymbol{b}\boldsymbol{\varepsilon}} = 0 \text{ on } \Omega, \quad \boldsymbol{v}_{\boldsymbol{b}\boldsymbol{\varepsilon}} = |Y_F|\boldsymbol{u} \text{ on } \partial\Omega, \\ |\boldsymbol{v}_{\boldsymbol{b}\boldsymbol{\varepsilon}}|_{H^1(\Omega^{\boldsymbol{\varepsilon}})} \leq \frac{C}{\sqrt{\boldsymbol{\varepsilon}}} \|\boldsymbol{u}\|_{C^{1,\alpha}(\overline{\Omega})}$$
(52)

The key observation is that, because of our construction of Ω^{ε} , where obstacles are removed from Ω only if the entire cell is included in Ω , all solid obstacles are uniformly away of the boundary $\partial\Omega$ by a distance of the order of ε . Therefore, in the choice of the cut-off function η^{ε} (see Definition 4.17), one can choose the constant c small enough so that no obstacles are contained or intersect the neighborhood O^{ε} of the boundary $\partial\Omega$, where the support of the derivatives of η^{ε} is restricted.

Based on the asymptotic expansion of order 3 for the velocity, $\varepsilon^2 u_2 + \varepsilon^3 u_3$, we define the following velocity estimator:

$$\boldsymbol{u}_{\varepsilon,3}(x) = \frac{\varepsilon^{2}}{\nu} |Y_{F}| \langle \boldsymbol{\omega}_{i} \rangle \left(f_{i}(x) - \frac{\partial p^{*}}{\partial x_{i}}(x) \right) - \varepsilon^{2} \boldsymbol{v}_{b\varepsilon}
+ \frac{\varepsilon^{4}}{\nu} (-\Delta + \nabla \operatorname{div}) \left(\eta^{\varepsilon}(x) \boldsymbol{\psi}_{i} \left(\frac{x}{\varepsilon} \right) \right) \left(f_{i}(x) - \frac{\partial p^{*}}{\partial x_{i}}(x) \right)
+ \frac{\varepsilon^{3}}{\nu} \gamma_{ij} \left(\frac{x}{\varepsilon} \right) \eta^{\varepsilon}(x) \frac{\partial}{\partial x_{j}} \left(f_{i}(x) - \frac{\partial p^{*}}{\partial x_{i}}(x) \right) - \boldsymbol{v}_{d\varepsilon},$$
(53)

where $v_{b\varepsilon}$, defined in (52), corrects the boundary condition of the first term above and $v_{d\varepsilon} \in H_0^1(\Omega^{\varepsilon})^d$ is going to be defined in the proof of Lemma 4.18 to correct the divergence-free condition of $u_{\varepsilon,3}$. Recall that ψ_i is defined by (50), ω_i by (12), γ_{ij} by (20) and all functions are extended by 0 inside the obstacles so that $u_{\varepsilon,3}$ is well defined on the whole Ω . Similarly, we define an estimator for the pressure, which is exactly the asymptotic expansion at first order of the pressure (no need of using a cut-off function), as:

$$p_{\varepsilon,1} = p^* + \varepsilon p_1,\tag{54}$$

where p^* is the homogenized pressure, solution of the Darcy problem (16) and p_1 is defined by (13).

Lemma 4.18. There exists $\mathbf{v}_{d\varepsilon} \in H_0^1(\Omega^{\varepsilon})^d$ such that the velocity estimator $\mathbf{u}_{\varepsilon,3}$, defined by (53), satisfies:

$$u_{\varepsilon,3} = \varepsilon^2 u_2 + \varepsilon^3 u_3 - v_{d\varepsilon} \quad \text{in } \Omega \setminus O^{\varepsilon},$$
 (55)

$$u_{\varepsilon,3} = \mathbf{0} \quad \text{on } \partial\Omega,$$
 (56)

$$u_{\varepsilon,3} = 0 \quad \text{on } \partial B^{\varepsilon},$$
 (57)

$$\operatorname{div} \mathbf{u}_{\boldsymbol{\varepsilon},\mathbf{3}} = 0 \quad \text{in } \Omega \tag{58}$$

and

$$|\boldsymbol{v}_{d\varepsilon}|_{H^1(\Omega^{\varepsilon})} \le C\varepsilon^{\frac{3}{2}} \|\boldsymbol{f} - \boldsymbol{\nabla} p^*\|_{H^2(\Omega) \cap C^{1,\alpha}(\overline{\Omega})},$$
 (59)

with C independent of ε .

Proof. To check (55), simply recall that $\eta^{\varepsilon} \equiv 1$ in $\Omega \setminus O^{\varepsilon}$. Thus by virtue of (50) the second line of (53) simplifies and, combined with the first line, yields $\varepsilon^2 u_2$, since $v_{b\varepsilon}$ is supported in O^{ε} . Similarly, the third line of (53) coincides with $\varepsilon^3 u_3$ in $\Omega \setminus O^{\varepsilon}$.

To check (56), we recognize that the first line of (53) vanishes on $\partial\Omega$ by construction of $v_{b\varepsilon}$, while the second and third line vanish too because η^{ε} and all its derivatives vanish on $\partial\Omega$, as well as $v_{d\varepsilon}$ by definition.

By construction of the cut-off function and Assumption 2.1 on the solid obstacles which stay away from the boundary $\partial\Omega$, we have $\eta^{\varepsilon} \equiv 1$ in the vicinity of B^{ε} . Therefore $u_{\varepsilon,3} = \varepsilon^2 u_2 + \varepsilon^3 u_3 - v_{d\varepsilon}$ on ∂B^{ε} . Furthermore, since ω_i and γ_{ij} vanish on Y_S , as well as $v_{d\varepsilon}$ on ∂B^{ε} by definition, we deduce that (57) holds true.

It remains to compute the divergence of the estimator $u_{\varepsilon,3}$ and to prove (58) and (59). The first line of (53) is divergence-free by construction and recall that $\operatorname{div}(-\Delta + \nabla \operatorname{div}) = 0$. Therefore,

$$\operatorname{div} \boldsymbol{u}_{\varepsilon,3}(x) = \frac{\varepsilon^4}{\nu} \left(-\Delta + \nabla \operatorname{div} \right) \left(\eta^{\varepsilon}(x) \boldsymbol{\psi}_{i} \left(\frac{x}{\varepsilon} \right) \right) \cdot \boldsymbol{\nabla} (f_{i} - \partial_{i} p^{*})(x)$$

$$+ \frac{\varepsilon^3}{\nu} \operatorname{div} \left(\boldsymbol{\gamma}_{ij} \left(\frac{x}{\varepsilon} \right) \eta^{\varepsilon}(x) \frac{\partial}{\partial x_{j}} (f_{i} - \partial_{i} p^{*})(x) \right) - \operatorname{div} \boldsymbol{v}_{d\varepsilon},$$

$$(60)$$

where, for the sake of clarity, the partial derivative with respect to x_i is simply denoted by ∂_i , An easy computation shows that:

$$(-\Delta + \nabla \operatorname{div})(\boldsymbol{\psi_i}\left(\frac{x}{\varepsilon}\right)\eta^{\varepsilon}(x)) = \frac{1}{\varepsilon^2}\eta^{\varepsilon}(x)(-\Delta_y + \boldsymbol{\nabla_y}\operatorname{div_y})\boldsymbol{\psi_i}\left(\frac{x}{\varepsilon}\right) + \frac{2}{\varepsilon}(\boldsymbol{\nabla}\eta^{\varepsilon}(x) \cdot \boldsymbol{\nabla_y}\boldsymbol{\psi_i}\left(\frac{x}{\varepsilon}\right) - \operatorname{div_y}\boldsymbol{\psi_i}\left(\frac{x}{\varepsilon}\right)\boldsymbol{\nabla}\eta^{\varepsilon}(x)) + (-\boldsymbol{\psi_i}\left(\frac{x}{\varepsilon}\right)\Delta\eta^{\varepsilon}(x) + \boldsymbol{\nabla}\boldsymbol{\nabla}\eta^{\varepsilon}(x)\boldsymbol{\psi_i}\left(\frac{x}{\varepsilon}\right)),$$

which leads to

$$\operatorname{div} \boldsymbol{u}_{\varepsilon,3} = L_{\varepsilon} + G_{\varepsilon} - \operatorname{div} \boldsymbol{v}_{d\varepsilon}, \tag{61}$$

where L_{ε} is made of terms of order 2:

$$L_{\varepsilon} = \frac{\varepsilon^{2}}{\nu} \eta^{\varepsilon}(x) (-\Delta_{y} + \nabla_{y} \operatorname{div}_{y}) \psi_{i} \left(\frac{x}{\varepsilon}\right) \cdot \nabla (f_{i} - \partial_{i} p^{*})(x)$$

$$+ \frac{\varepsilon^{2}}{\nu} \eta^{\varepsilon}(x) \operatorname{div}_{y} \gamma_{ij} \left(\frac{x}{\varepsilon}\right) \frac{\partial}{\partial x_{j}} (f_{i} - \partial_{i} p^{*})(x)$$

and G_{ε} consists of the remaining terms of order 3 and 4:

$$G_{\varepsilon} = \frac{\varepsilon^{3}}{\nu} \left(\nabla \eta^{\varepsilon}(x) \operatorname{div}_{y} \psi_{i} \left(\frac{x}{\varepsilon} \right) - \nabla_{y} \psi_{i} \left(\frac{x}{\varepsilon} \right) \nabla \eta^{\varepsilon}(x) \right) \cdot \nabla (f_{i} - \partial_{i} p^{*})(x)$$

$$+ \frac{\varepsilon^{3}}{\nu} \gamma_{ij} \left(\frac{x}{\varepsilon} \right) \cdot \nabla \eta^{\varepsilon}(x) \frac{\partial}{\partial x_{j}} (f_{i} - \partial_{i} p^{*})(x) + \frac{\varepsilon^{3}}{\nu} \gamma_{ij} \left(\frac{x}{\varepsilon} \right) \eta^{\varepsilon}(x) \cdot \nabla \frac{\partial}{\partial x_{j}} (f_{i} - \partial_{i} p^{*})(x)$$

$$+ \frac{\varepsilon^{4}}{\nu} \left(-\psi_{i} \left(\frac{x}{\varepsilon} \right) \Delta \eta^{\varepsilon}(x) + \nabla \nabla \eta^{\varepsilon}(x) \psi_{i} \left(\frac{x}{\varepsilon} \right) \right) \cdot \nabla (f_{i} - \partial_{i} p^{*})(x).$$

$$(62)$$

Recalling that $\operatorname{div}_{\mathbf{y}} \gamma_{ij} = -\boldsymbol{\omega}_{i} \cdot \boldsymbol{e}_{j} + \langle \boldsymbol{\omega}_{i} \cdot \boldsymbol{e}_{j} \rangle$ and $(-\Delta_{y} + \nabla_{y} \operatorname{div}_{y}) \psi_{i} = \boldsymbol{\omega}_{i} - |Y_{F}| \langle \boldsymbol{\omega}_{i} \rangle$, one can check that L_{ε} vanishes since:

$$L_{\varepsilon} = \frac{\varepsilon^{2}}{\nu} \eta^{\varepsilon}(x) (\boldsymbol{\omega_{i}} - |Y_{F}|\langle \boldsymbol{\omega_{i}} \rangle) \cdot \nabla (f_{i} - \partial_{i} p^{*})(x) - \frac{\varepsilon^{2}}{\nu} \eta^{\varepsilon}(x) (\boldsymbol{\omega_{i}} - \langle \boldsymbol{\omega_{i}} \rangle) \cdot \nabla (f_{i} - \partial_{i} p^{*})(x)$$

$$= \frac{\varepsilon^{2}}{\nu} \eta^{\varepsilon}(x) (1 - |Y_{F}|) \langle \boldsymbol{\omega_{i}} \rangle \cdot \nabla (f_{i} - \partial_{i} p^{*})(x) = 0$$

in view of the homogenized equation (16). Therefore, the estimator divergence simplifies as:

$$\operatorname{div} \boldsymbol{u}_{\boldsymbol{\varepsilon},\mathbf{3}} = G_{\varepsilon} - \operatorname{div} \boldsymbol{v}_{\boldsymbol{d\varepsilon}}$$

and we now prove the following bound

$$||G_{\varepsilon}||_{L^{2}(\Omega^{\varepsilon})} \leq C\varepsilon^{\frac{5}{2}} ||f - \nabla p^{*}||_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})}.$$

$$(63)$$

Indeed, the third term of G_{ε} in (62) is bounded by $C\varepsilon^3\|(f_i-\partial_i p^*)\|_{H^2(\Omega)}$ since $\|\eta^{\varepsilon}\|_{L^{\infty}(\Omega)}=1$ and $\gamma_{ij}\in H^{m+2}(Y_F)^d\subset L^{\infty}(Y_F)^d$ by Sobolev embeddings (note that this bound is slightly better than (63) and it is the only term in (62) to involve the H^2 -norm). All other terms in (62) feature derivatives of η^{ε} and have thus compact supports in O^{ε} . In all those terms we bound $(f_i-\partial_i p^*)$ by its $C^{1,\alpha}$ -norm. Although γ_{ij} is bounded in $L^{\infty}(Y_F)^d$ for the second term of (62), it is not clear that it is the case for ψ_i and $\nabla_y \psi_i$, at least for any space dimension. Therefore, we rely on another argument that we explain on the first term of (62) (the other ones being treated similarly). Since $\|\nabla \eta^{\varepsilon}\|_{L^{\infty}(\Omega)} \leq C\varepsilon^{-1}$, this first term is bounded in $L^2(\Omega^{\varepsilon})$ by

$$C\varepsilon^{2} \| (f_{i} - \partial_{i} p^{*}) \|_{C^{1,\alpha}(\overline{\Omega})} \left(\int_{O^{\varepsilon}} |\nabla_{\boldsymbol{y}} \psi_{\boldsymbol{i}} \left(\frac{x}{\varepsilon} \right) |^{2} dx \right)^{1/2}$$

$$\leq C\varepsilon^{2} \| (f_{i} - \partial_{i} p^{*}) \|_{C^{1,\alpha}(\overline{\Omega})} \left(n_{O^{\varepsilon}} \varepsilon^{d} \|\nabla_{\boldsymbol{y}} \psi_{\boldsymbol{i}} \left(y \right) \|_{L^{2}(Y_{F})}^{2} \right)^{1/2}, \tag{64}$$

where we used the periodicity of $\nabla_y \psi_i$ and $n_{O^{\varepsilon}} = O(\varepsilon^{-d+1})$ is the number of cells Y_i^{ε} which cover O^{ε} . This implies exactly the bound (63). Finally, remark that G_{ε} has zero mean on Ω^{ε} since

$$\int_{\Omega^{\varepsilon}} \operatorname{div} \left(\boldsymbol{u}_{\varepsilon,3} + \boldsymbol{v}_{d\varepsilon} \right) = \int_{\partial \Omega^{\varepsilon}} \left(\boldsymbol{u}_{\varepsilon,3} + \boldsymbol{v}_{d\varepsilon} \right) \cdot \boldsymbol{n} = 0,$$

because $u_{\varepsilon,3}$ and $v_{d\varepsilon}$ vanish on ∂B^{ε} and $\partial \Omega$, Consequently, to prove (58) we can rely on Lemma 4.9 which ensures that there exists $v_{d\varepsilon} \in H_0^1(\Omega^{\varepsilon})^d$ such that:

$$\operatorname{div} \boldsymbol{v}_{\boldsymbol{d\varepsilon}} = G_{\varepsilon} \text{ and } |\boldsymbol{v}_{\boldsymbol{d\varepsilon}}|_{H^{1}(\Omega^{\varepsilon})} \leq \frac{C}{\varepsilon} \|G_{\varepsilon}\|_{L^{2}(\Omega^{\varepsilon})} \leq C\varepsilon^{\frac{3}{2}} \|\boldsymbol{f} - \boldsymbol{\nabla} p^{*}\|_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})},$$

which proves (58) and (59).

Now that all terms in the velocity estimator (53) are well defined, we turn to the estimates for the residuals of the homogenization process. Define the velocity residual $R_{u_{\varepsilon}}$ and the pressure residual $R_{p_{\varepsilon}}$ by:

$$R_{u_{\varepsilon}} = u_{\varepsilon} - u_{\varepsilon,3}, \quad R_{p_{\varepsilon}} = p_{\varepsilon} - p_{\varepsilon,1},$$

where the estimators $u_{\varepsilon,3}$ and $p_{\varepsilon,1}$ are given respectively in (53) and (54).

Lemma 4.19. The velocity and pressure homogenization residuals verify:

$$\begin{cases}
-\nu \Delta \mathbf{R}_{u_{\varepsilon}} + \nabla R_{p_{\varepsilon}} &= \mathbf{F}_{\varepsilon} + \operatorname{div} \mathbf{H}_{\varepsilon} & \operatorname{in} \Omega^{\varepsilon}, \\
\operatorname{div} \mathbf{R}_{u_{\varepsilon}} &= 0 & \operatorname{in} \Omega^{\varepsilon}, \\
\mathbf{R}_{u_{\varepsilon}} &= \mathbf{0} & \operatorname{on} \partial B^{\varepsilon}, \\
\mathbf{R}_{u_{\varepsilon}} &= \mathbf{0} & \operatorname{on} \partial \Omega,
\end{cases} (65)$$

where the source terms are bounded by:

$$\|\boldsymbol{F}_{\varepsilon}\|_{L^{2}(\Omega^{\varepsilon})} \le C\varepsilon \|\boldsymbol{f} - \boldsymbol{\nabla} p^{*}\|_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})},$$
 (66)

$$\|\boldsymbol{H}_{\varepsilon}\|_{L^{2}(\Omega^{\varepsilon})} \leq C\varepsilon^{\frac{3}{2}} \|\boldsymbol{f} - \boldsymbol{\nabla} p^{*}\|_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})}, \tag{67}$$

with C independent of ε .

Proof. Obviously, div $\mathbf{R}_{u_{\varepsilon}} = 0$ in Ω^{ε} and $\mathbf{R}_{u_{\varepsilon}} = \mathbf{0}$ on $\partial B^{\varepsilon} \cup \partial \Omega$. We decompose the velocity residual as $\mathbf{R}_{u_{\varepsilon}} = (\mathbf{u}_{\varepsilon} - \varepsilon^2 \mathbf{u}_2) + (\varepsilon^2 \mathbf{u}_2 - \mathbf{u}_{\varepsilon,3})$ which leads to the first line of (65), where:

$$F_{\varepsilon} = -\nu \Delta (u_{\varepsilon} - \varepsilon^2 u_2) + \nabla (p_{\varepsilon} - p_{\varepsilon,1})$$
 and $H_{\varepsilon} = -\nu \nabla (\varepsilon^2 u_2 - u_{\varepsilon,3})$.

To prove estimate (66) for F_{ε} , we compute:

$$F_{\varepsilon} = f - \nabla p^* + (\Delta_y \omega_i - \nabla_y \pi_i) \left(\frac{x}{\varepsilon}\right) (f_i - \partial_i p^*)(x) + 2\varepsilon \nabla_y \omega_i \left(\frac{x}{\varepsilon}\right) \nabla (f_i - \partial_i p^*)(x) + \varepsilon^2 \omega_i \left(\frac{x}{\varepsilon}\right) \Delta (f_i - \partial_i p^*)(x) - \varepsilon \pi_i \left(\frac{x}{\varepsilon}\right) \nabla (f_i - \partial_i p^*)(x)$$

and, rearranging the terms,

$$\mathbf{F}_{\varepsilon} = (\Delta_{y}\boldsymbol{\omega_{i}} - \nabla_{y}\pi_{i} + \boldsymbol{e_{i}}) \left(\frac{x}{\varepsilon}\right) (f_{i} - \partial_{i}p^{*})(x)
+ 2\varepsilon \nabla_{y}\boldsymbol{\omega_{i}} \left(\frac{x}{\varepsilon}\right) \nabla (f_{i} - \partial_{i}p^{*})(x) - \varepsilon \pi_{i} \left(\frac{x}{\varepsilon}\right) \nabla (f_{i} - \partial_{i}p^{*})(x)
+ \varepsilon^{2}\boldsymbol{\omega_{i}} \left(\frac{x}{\varepsilon}\right) \Delta (f_{i} - \partial_{i}p^{*})(x).$$
(68)

The first term in (68) actually vanishes because of the cell equation (12). The next three terms above are of order ε or higher. To bound the fourth term requires the H^2 regularity of $(f_i - \partial_i p^*)$, while its $C^{1,\alpha}$ regularity is sufficient for all other terms. In the end, we deduce the bound (66) from (68).

Next, to prove estimate (67) for H_{ε} , we rewrite:

$$\boldsymbol{u}_{\varepsilon,3} - \varepsilon^{2} \boldsymbol{u}_{2} = \frac{\varepsilon^{2}}{\nu} (1 - \eta^{\varepsilon}(x)) (|Y_{F}| \langle \boldsymbol{\omega}_{i} \rangle - \boldsymbol{\omega}_{i} \left(\frac{x}{\varepsilon}\right)) (f_{i} - \partial_{i} p^{*})(x) - \varepsilon^{2} \boldsymbol{v}_{\boldsymbol{b}\varepsilon} - \boldsymbol{v}_{\boldsymbol{d}\varepsilon}
+ \frac{\varepsilon^{3}}{\nu} \eta^{\varepsilon}(x) \gamma_{ij} \left(\frac{x}{\varepsilon}\right) \partial_{j} (f_{i} - \partial_{i} p^{*})(x)
+ \frac{\varepsilon^{3}}{\nu} \left(\boldsymbol{\nabla} \eta^{\varepsilon}(x) \operatorname{div}_{y} \boldsymbol{\psi}_{i} \left(\frac{x}{\varepsilon}\right) - \boldsymbol{\nabla}_{y} \boldsymbol{\psi}_{i} \left(\frac{x}{\varepsilon}\right) \boldsymbol{\nabla} \eta^{\varepsilon}(x) \right) (f_{i} - \partial_{i} p^{*})(x)
+ \frac{\varepsilon^{4}}{\nu} \left(-\boldsymbol{\psi}_{i} \left(\frac{x}{\varepsilon}\right) \Delta \eta^{\varepsilon}(x) + \boldsymbol{\nabla} \boldsymbol{\nabla} \eta^{\varepsilon}(x) \boldsymbol{\psi}_{i} \left(\frac{x}{\varepsilon}\right) \right) (f_{i} - \partial_{i} p^{*})(x).$$
(69)

The gradient of (69), equal to H_{ε} up to a ν -factor, is:

$$\nabla (\boldsymbol{u}_{\varepsilon,3} - \varepsilon^{2} \boldsymbol{u}_{2}) = -\varepsilon^{2} \nabla \boldsymbol{v}_{b\varepsilon} - \nabla \boldsymbol{v}_{d\varepsilon} - \frac{\varepsilon^{2}}{\nu} \nabla \eta^{\varepsilon} (|Y_{F}| \langle \boldsymbol{\omega}_{i} \rangle - \boldsymbol{\omega}_{i}) (f_{i} - \partial_{i} p^{*})$$

$$- \frac{\varepsilon}{\nu} (1 - \eta^{\varepsilon}) \nabla_{\boldsymbol{y}} \boldsymbol{\omega}_{i} (f_{i} - \partial_{i} p^{*}) + \frac{\varepsilon^{2}}{\nu} (\nabla \eta^{\varepsilon} \nabla_{\boldsymbol{y}} \operatorname{div}_{\boldsymbol{y}} \boldsymbol{\psi}_{i} - \nabla_{\boldsymbol{y}} \nabla_{\boldsymbol{y}} \boldsymbol{\psi}_{i} \nabla \eta^{\varepsilon}) (f_{i} - \partial_{i} p^{*})$$

$$+ \frac{\varepsilon^{3}}{\nu} (\nabla \nabla \eta^{\varepsilon} \operatorname{div}_{\boldsymbol{y}} \boldsymbol{\psi}_{i} - \nabla_{\boldsymbol{y}} \boldsymbol{\psi}_{i} \nabla \nabla \eta^{\varepsilon}) (f_{i} - \partial_{i} p^{*})$$

$$+ \frac{\varepsilon^{3}}{\nu} (-\nabla_{\boldsymbol{y}} \boldsymbol{\psi}_{i} \Delta \eta^{\varepsilon} + (\nabla \nabla \eta^{\varepsilon}) \nabla_{\boldsymbol{y}} \boldsymbol{\psi}_{i}) (f_{i} - \partial_{i} p^{*})$$

$$+ \frac{\varepsilon^{4}}{\nu} (-\boldsymbol{\psi}_{i} \nabla \Delta \eta^{\varepsilon} + \nabla (\nabla \nabla \eta^{\varepsilon}) \boldsymbol{\psi}_{i}) (f_{i} - \partial_{i} p^{*})$$

$$+ \frac{\varepsilon^{2}}{\nu} (1 - \eta^{\varepsilon}) (|Y_{F}| \langle \boldsymbol{\omega}_{i} \rangle - \boldsymbol{\omega}_{i}) \nabla (f_{i} - \partial_{i} p^{*}) + \frac{\varepsilon^{3}}{\nu} \nabla \eta^{\varepsilon} \boldsymbol{\gamma}_{ij} \partial_{j} (f_{i} - \partial_{i} p^{*})$$

$$+ \frac{\varepsilon^{3}}{\nu} (\nabla \eta^{\varepsilon} \operatorname{div}_{\boldsymbol{y}} \boldsymbol{\psi}_{i} - \nabla_{\boldsymbol{y}} \boldsymbol{\psi}_{i} \nabla \eta^{\varepsilon}) \nabla (f_{i} - \partial_{i} p^{*})$$

$$+ \frac{\varepsilon^{4}}{\nu} (-\boldsymbol{\psi}_{i} \Delta \eta^{\varepsilon} + (\nabla \nabla \eta^{\varepsilon}) \boldsymbol{\psi}_{i}) \nabla (f_{i} - \partial_{i} p^{*})$$

$$+ \frac{\varepsilon^{4}}{\nu} (-\boldsymbol{\psi}_{i} \Delta \eta^{\varepsilon} + (\nabla \nabla \eta^{\varepsilon}) \boldsymbol{\psi}_{i}) \nabla (f_{i} - \partial_{i} p^{*})$$

$$+ \frac{\varepsilon^{2}}{\nu} \eta^{\varepsilon} \nabla_{\boldsymbol{y}} \boldsymbol{\gamma}_{ij} \partial_{j} (f_{i} - \partial_{i} p^{*}) + \frac{\varepsilon^{3}}{\nu} \eta^{\varepsilon} \boldsymbol{\gamma}_{ij} \nabla \partial_{j} (f_{i} - \partial_{i} p^{*}).$$

We bound (70) in the same way as for the estimate of G_{ε} . The two first terms of (70) are bounded by (52) and (59). The last term of (70) is the only one requiring the H^2 -regularity of $(f_i - \partial_i p^*)$: for all other terms the $C^{1,\alpha}$ -regularity of $(f_i - \partial_i p^*)$ is sufficient. By Lemma 3.3 the cell solutions ω_i , γ_{ij} and the gradient $\nabla_y \omega_i$ belong to $L^{\infty}(Y)$. This is not the case for ψ_i and its derivatives (at least for any space dimension d): therefore we rely on a similar trick as in (64) for all terms involving ψ_i . Using the bounds (51) on the cut-off function η^{ε} , it comes that the terms in the first five lines of (70) are of order $\varepsilon^{3/2}$. The terms of the three following lines are of order $\varepsilon^{5/2}$ and eventually in the last line the terms are respectively of order ε^2 and ε^3 . We do not detail the bounds except for the seemingly higher order term

$$\|\frac{\varepsilon}{\nu}(1-\eta^{\varepsilon})\nabla_{\boldsymbol{y}}\boldsymbol{\omega_{i}}(f_{i}-\partial_{i}p^{*})\|_{L^{2}(\Omega^{\varepsilon})} \leq C\varepsilon\|1-\eta^{\varepsilon}\|_{L^{2}(\Omega^{\varepsilon})}\|\nabla_{\boldsymbol{y}}\boldsymbol{\omega_{i}}\|_{L^{\infty}(Y)}\|(f_{i}-\partial_{i}p^{*})\|_{C^{1,\alpha}(\overline{\Omega})}$$
$$\leq C\varepsilon^{3/2}\|(f_{i}-\partial_{i}p^{*})\|_{C^{1,\alpha}(\overline{\Omega})}$$

because of (51). In the end, we deduce estimate (67).

Remark 4.20. We cannot have a better estimate due the presence of boundary layers. Indeed, the lower order $\sqrt{\varepsilon}$ is due to the boundary condition $\mathbf{u}_{\varepsilon} = \mathbf{0}$ on $\partial\Omega$, which worsens the approximation near the boundary. Technically, this is taken into account by the introduction of the cut-off function η^{ε} in the proof. This term satisfies the bound $|\eta^{\varepsilon}|_{H^1(\Omega)} \leq \frac{C}{\sqrt{\varepsilon}}$, which is the origin of the $\sqrt{\varepsilon}$ -order in the estimate.

Since the residual $\mathbf{R}_{u_{\varepsilon}}$ is divergence-free and belongs to $H_0^1(\Omega^{\varepsilon})^d$, it can be used as test function, leading to

$$\nu \int_{\Omega^{\varepsilon}} \nabla R_{u_{\varepsilon}} \cdot \nabla R_{u_{\varepsilon}} = \nu \int_{\Omega^{\varepsilon}} \nabla R_{u_{\varepsilon}} \cdot \nabla R_{u_{\varepsilon}} - \int_{\Omega^{\varepsilon}} R_{p_{\varepsilon}} \operatorname{div} R_{u_{\varepsilon}}$$

$$= \int_{\Omega^{\varepsilon}} F_{\varepsilon} \cdot R_{u_{\varepsilon}} - \int_{\Omega^{\varepsilon}} H_{\varepsilon} \cdot \nabla R_{u_{\varepsilon}}$$

$$\leq \|F_{\varepsilon}\|_{L^{2}(\Omega^{\varepsilon})} \|R_{u_{\varepsilon}}\|_{L^{2}(\Omega^{\varepsilon})} + \|H_{\varepsilon}\|_{L^{2}(\Omega^{\varepsilon})} |R_{u_{\varepsilon}}|_{H^{1}(\Omega^{\varepsilon})}$$

Using estimate (66) and the Poincaré inequality in perforated domain (Lemma 4.6), it follows:

$$\|\boldsymbol{F}_{\boldsymbol{\varepsilon}}\|_{L^{2}(\Omega^{\varepsilon})}\|\boldsymbol{R}_{\boldsymbol{u}_{\boldsymbol{\varepsilon}}}\|_{L^{2}(\Omega^{\varepsilon})} \leq C\varepsilon^{2}\|\boldsymbol{f} - \boldsymbol{\nabla}p^{*}\|_{H^{2}(\Omega)\cap C^{1,\alpha}(\overline{\Omega})}|\boldsymbol{R}_{\boldsymbol{u}_{\boldsymbol{\varepsilon}}}|_{H^{1}(\Omega^{\varepsilon})}.$$

Then, using (67), we conclude that:

$$|\mathbf{R}_{u_{\varepsilon}}|_{H^{1}(\Omega^{\varepsilon})} \leq C\varepsilon^{\frac{3}{2}} \|\mathbf{f} - \nabla p^{*}\|_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})}.$$
 (71)

Now, writing $u_{\varepsilon} - \varepsilon^2 u_2 = R_{u_{\varepsilon}} + u_{\varepsilon,3} - \varepsilon^2 u_2$, using (71) and (67) yields:

$$|\boldsymbol{u}_{\varepsilon} - \varepsilon^{2}\boldsymbol{u}_{2}|_{H^{1}(\Omega^{\varepsilon})} \leq |\boldsymbol{R}_{\boldsymbol{u}_{\varepsilon}}|_{H^{1}(\Omega^{\varepsilon})} + \|\boldsymbol{H}_{\varepsilon}\|_{L^{2}(\Omega^{\varepsilon})} \leq C\varepsilon^{\frac{3}{2}}\|\boldsymbol{f} - \boldsymbol{\nabla}p^{*}\|_{H^{2}(\Omega)\cap C^{1,\alpha}(\overline{\Omega})},$$

which is precisely the H^1 -estimate (25). The L^2 -estimate (26) is then a consequence of the Poincaré inequality in perforated domains (Lemma 4.6). To prove the remaining pressure estimate (24), recall that pressure is always defined up to a constant and choose the original pressure p_{ε} , the homogenized pressure p^* and the pressure estimator $p_{\varepsilon,1}$ with zero mean in Ω^{ε} (if it is not the case, it suffices to consider $p_{\varepsilon,1} = p^* + \varepsilon(p_1 - \int_{\Omega^{\varepsilon}} p_1)$). Lemma 4.9 ensures the existence of $\mathbf{v} \in H_0^1(\Omega^{\varepsilon})^d$ such that div $\mathbf{v} = p_{\varepsilon} - p_{\varepsilon,1}$. Then by integration by parts:

$$\int_{\Omega^{\varepsilon}} (p_{\varepsilon} - p_{\varepsilon,1})^{2} = \int_{\Omega^{\varepsilon}} (p_{\varepsilon} - p_{\varepsilon,1}) \operatorname{div} \boldsymbol{v} = -\int_{\Omega^{\varepsilon}} \boldsymbol{F}_{\varepsilon} \cdot \boldsymbol{v} + \int_{\Omega^{\varepsilon}} \nu \boldsymbol{\nabla} (\boldsymbol{u}_{\varepsilon} - \varepsilon^{2} \boldsymbol{u}_{2}) \cdot \boldsymbol{\nabla} \boldsymbol{v} \\
\leq C \varepsilon^{\frac{3}{2}} \|\boldsymbol{f} - \boldsymbol{\nabla} p^{*}\|_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})} |\boldsymbol{v}|_{H^{1}(\Omega^{\varepsilon})} \leq C \varepsilon^{\frac{1}{2}} \|\boldsymbol{f} - \boldsymbol{\nabla} p^{*}\|_{H^{2}(\Omega) \cap C^{1,\alpha}(\overline{\Omega})} \|p_{\varepsilon} - p_{\varepsilon,1}\|_{L^{2}(\Omega^{\varepsilon})},$$

using the estimate in Lemma 4.9. Thus,

$$\|p_{\varepsilon} - p^*\|_{L^2(\Omega^{\varepsilon})} \leq \|p_{\varepsilon} - p_{\varepsilon,1}\|_{L^2(\Omega^{\varepsilon})} + \|p_{\varepsilon,1} - p^*\|_{L^2(\Omega^{\varepsilon})} \leq C\varepsilon^{\frac{1}{2}} \|\boldsymbol{f} - \boldsymbol{\nabla} p^*\|_{H^2(\Omega) \cap C^{1,\alpha}(\overline{\Omega})},$$

since $(p_{\varepsilon,1}-p^*)$ is of order ε as seen from (54), which concludes the proof of Theorem 4.1.
