# AN ALGORITHM OF CALCULATION OF LOWER SOLUTIONS OF FUZZY RELATIONAL EQUATIONS

Abstract. The paper deals with the problem of the determination of lower solutions of fuzzy relational equations. An algorithm of calculation of such a solution is presented.

#### 1. INTRODUCTION

An extension of well known Boolean equations was provided by Sanchez [4] by introducing the fuzzy relational equations in order to describe fuzzy systems by means fuzzy relations.

In [4] and [5] the method of resolution of fuzzy relational equations was given.

In [1], [2], [3] and [6] the authors obtained further theoretical results dealing e.g. with lower solutions of the fuzzy equations and their algebraic characterization. In this paper we present an algorithm of calculation of lower solutions of fuzzy relational equations.

### 2. BASIC DEFINITIONS AND NOTATIONS

Let L denote a fixed totally ordered lattice with universal bounds 0 and 1. Let's denote by " $\Lambda$ " and " $\gamma$ " the meet and join operations in L,by " $\not$ " the ordering of L.

Let X be a nonempty set and  $F(X) = \{A: X \to L\}$  the set of all fuzzy sets of X [7]. F(X) is a complete lattice with respect to the following relation and operations defined for any  $x \in X$ :

$$A \neq B$$
 iff  $A(x) \leq B(x)$ ,  
 $(A \wedge B)(x) = A(x) \wedge B(x)$ ,  
 $(A \vee B)(x) = A(x) \wedge B(x)$ ,

where A, B  $\epsilon$  F(X).

Definition. A fuzzy relation R between two nonempty sets X and Y is an element of F(X\*Y). We define inverse of R the fuzzy relation  $R \in F(X*Y)$  as:

$$R^{-1}(y,x) = R(x,y)$$
 for any  $(x,y) \in (X^*Y)$ .

Definition. Let be  $Q \in F(X \neq Y)$  and  $R \in F(Y \neq Z)$  two fuzzy relations. We define the fuzzy relation  $T \in F(X \neq Z)$ ,  $T = R \bullet Q$  as:

$$(RoQ)(x,z) = \sqrt{\left[Q(x,y) \land R(y,z)\right]} \qquad \forall (x,z) \in (X * Z).$$

Definition. We define the fuzzy relation Us F(X\*Z) as:

$$U(x,z) = (Q \otimes R)(x,z) = \bigwedge_{y \in Y} [Q(x,y) \otimes R(y,z)] \qquad \forall (x,z) \in (X \times Z)$$

where

$$Q(x,y) \bowtie R(y,z) = \begin{cases} 1 & \text{if } Q(x,y) \leq R(y,z) \\ \\ R(y,z) & \text{if } Q(x,y) > R(y,z). \end{cases}$$

Let suppose that  $X = \{x_1, \dots, x_n\}$ ,  $Y = \{y_1, \dots, y_m\}$   $Z = \{z_1, \dots, z_p\}$  are finite sets, we put  $I_n = \{1, \dots, n\}$ the set of first n natural numbers and  $I_0 = \emptyset$ . Furthermore we put:  $\bigvee$  if  $I_n$ ,  $j \in I_m$ ,  $k \in I_p$ 

$$Q(x_{i},y_{j}) = q_{ij}$$

$$T(x_{i},z_{k}) = t_{ik}$$

$$R(y_{j},z_{k}) = r_{jk}$$

Now let's consider the fuzzy relational equation

where R is an unknown fuzzy relation. Let  $\mathcal{R}$  denote the set of all solutions of Eq. 1, and let's suppose that  $\mathcal{R} \neq \emptyset$ , then the relation  $S = Q^{-1} \bigcirc T$  is the greatest element of  $\mathcal{R}$  (see [4]). From now on we suppose that  $\mathcal{R} \neq \emptyset$ .

#### 3. LOWER SOLUTIONS

We call lower solution any element  ${\mathcal L}$  of  ${\mathcal R}$  such that the following proposition holds

"for any R  $\in \mathcal{R}$  , R  $\not= \mathcal{L}$  implies R =  $\mathcal{L}$  ".

Now we establish a theorem for determining a lower solution of Eq. 1.

Let's consider for any he I  $_{m}$  and for any ke I  $_{p}$  the sequences

$$\gamma(h,k) = (j(w))_{w \in I_h}$$

of h elements of  $I_{m}$  such that, by defining the sets

$$B(j(w),s_{wk}) = \left\{ i \in I_n / q_{ij(w)} \land s_{wk} = t_{ik} \right\}$$

where

$$s_{wk} = v_{ik} t_{ik}$$

$$i \in I_{n} v_{w'} \left[ B(j(w'), s_{w'k}) \right]$$
(3)

it must be 
$$\bigcup_{\mathbf{w} \in \mathbf{I}_{h}} \mathbf{B}(\mathbf{j}(\mathbf{w}), \mathbf{s}_{\mathbf{w}k}) = \mathbf{1}_{n}$$

and

$$\forall w \in I_h \qquad q_{ij(w)} \land s_{wk} \neq t_{ik} \quad \forall i \in I_n.$$
 (5)

Let's denote by  $\Gamma(h,k)$  the set of the sequences  $\gamma(h,k)$  above defined for any  $h \in I_m$  and for any  $k \in I_p$ .

Theorem. For any k  $\in I_p$ , let h(k)  $\in I_m$  be an index such that for any h'  $\in$  h(k) it is  $f'(h',k) = \emptyset$  and  $f'(h(k),k) \neq \emptyset$ . Furthermore let

and

$$\chi(h(k),k) \in \mathcal{P}(h(k),k)$$

then we have that the fuzzy relation  $R \in F(Y \times Z)$  defined as:

$$\begin{cases}
r_{j(w)k} = s_{wk} & \forall w \in I_{h(k)} \\
r_{jk} = 0 & \forall j \in I_{m} - \{j(w)\}_{w \in I_{h(k)}}, (6)
\end{cases}$$

is a lower solution of Eq. 1 .

<u>Proof.</u> Let's prove that firstly R  $\boldsymbol{\epsilon}$   $\boldsymbol{\mathcal{R}}$ . Indeed for any k  $\boldsymbol{\epsilon}$  I and for any l  $\boldsymbol{\epsilon}$  I from (4) it follows that there exists an index w'  $\boldsymbol{\epsilon}$  I such that

and then

$$q_{1j(w')} \wedge s_{w'k} = t_{1k} . \tag{7}$$

Thus from (5) and (7) it follows that

$$\bigvee_{\mathbf{j} \in \mathbb{I}_{m}} \left[ \mathbf{q}_{1,\mathbf{j}} \wedge \mathbf{r}_{\mathbf{j}k} \right] = \bigvee_{\mathbf{w} \in \mathbb{I}_{h(k)}} \left[ \mathbf{q}_{1,\mathbf{j}(\mathbf{w})} \wedge \mathbf{s}_{\mathbf{w}k} \right] = \mathbf{t}_{1k}$$

and this proves that R  $\epsilon$   $\Omega$ .

Now let's prove that R is a lower solution. Firstly we observe that from the hypothesis it follows that for any k  $\epsilon$ I it must be, for any w,w'  $\epsilon$ I such that w $\neq$ w', the sets

 $B(j(w),s_{wk})$  and  $B(j(w'),s_{w'k})$  are not confrontable with respect to the inclusion relation and this implies the following proposition

" 
$$\forall w' \in I_{h(k)} \ni I(w') \in I_n \text{ such that } \left[q_{1(w')j(w)} \land s_{wk}\right] < t_{1(w')k}$$

$$\forall w \in I_{h(k)} \text{ and } w \neq w' . " \tag{8}$$

Let's suppose that there exists a solution R' of Eq. 1 such that

$$R' \leq R$$
 , (9)

then from (6) and (9) it follows that for any  $k \in I_p$  it is

$$r_{jk}^{\dagger} = 0$$
  $\forall j \in 1_{m}^{-} \{j(1), ..., j(h(k))\}$  (10)

and that there exists an index  $\mathbf{A} \in I_{h(k)}$  such that

$$r_{j}(\mathbf{x})k \leftarrow r_{j}(\mathbf{x})k = s \times k \tag{11}$$

furthermore

$$[r'_{j(w)k} = r_{j(w)k}] \quad \forall w \in I_{h(k)} . \quad (12)$$

By (8) then there exists  $l(\alpha) \in I$  such that  $t_{l(\alpha)k} = s \alpha k$ 

thus we have that

$$\left[ q_{1(\alpha)j(\alpha)} \wedge r'_{j(\alpha)k} \right] < t_{1(\alpha)k} , \qquad (13)$$

from  $t_{1(\mathbf{x})k} = s_{\mathbf{x}k}$  and from (3) and (5), it follows that

$$\forall$$
  $w \in I_{h(k)}$  such that  $w \neq \alpha$   $q_{1(\alpha)j(w)} \land s_{wk} < t_{1(\alpha)k}$ . (14)

From (12) and (14) it follows

Furthermore from (10), (11), (12), (13) and (15) it follows

$$\bigvee_{j \in I_{m}} \left[ q_{1(\alpha)j} \wedge r_{jk}^{\dagger} \right] = \bigvee_{w \in I_{h(k)}} \left[ q_{1(\alpha)j(w)} \wedge r_{j(w)k}^{\dagger} \right] \langle t_{1(\alpha)k} \rangle . \tag{16}$$

But (16) is in contradiction with R'  $\in \mathcal{R}$ , then there no exists an index  $\not \sim \mathcal{L}_{h(k)}$  satisfying (11) thus (9) does not hold, and then R is a lower solution.

4. AN ALGORITHM OF CALCULATION OF A LOWER SOLUTION

The above theorem justifies the following algorithm of calculation of a lower solution R of the Eq. 1 .

Start

$$h(k) := 1$$

$$\Gamma(h(k),k) \neq \emptyset$$
 then  $\gamma(h(k),k) \in \Gamma(h(k),k)$ 

$$\gamma(h(k),k) = (j(w)) \text{we } I_{h(k)} \text{ and } I_{h(k)}$$

$$\begin{cases} r_{j(w)k} = s_{wk}, & \forall w \in I_{h(k)} \\ r_{jk} = 0 & \forall j \in I_{m} - (\{j(w)\}_{w \in I_{h}}) \end{cases}$$

• if k < p increase k := k+1 go to (1)

if  $k \neq p$  stop.

If 
$$\Gamma(h(k),k) = \emptyset$$
, increase  $h(k)$ ,  $h(k) := h(k) + 1$   
go to (2).
