Lorentzian and flat affine geometry on $GL(2, \mathbb{R})$

Abstract

The goal of this paper is to study the geometry of the connected unit component of the real general linear Lie group four dimensional G_0 as a Lorentzian and flat affine manifold. As the group G_0 is also naturally equipped with a biinvariant Hessian metric k^+ , relative to the natural bi-invariant flat affine structure ∇ , we examine these structures and the relationships between them. The study of the space-time model (G_0, k^+, ∇) was initiated by the first author (work to appear), and the present paper is an addendum of this one. We naively hope this work will be useful for studying our physical universe. The curvatures, tidal force, and Jacobi vector fields of (G_0, k^+) are determined in Section 1. Section 2 discusses the causal structure of (G_0, k^+) , while Section 3 focuses on the developed map relative to ∇ in the sense of C. Ehresmann.

Keywords: Lorentzian metric, flat affine structure, Hessian structure, quadratic Lie groups, curvatures, Weyl tensor.

1 Introduction

Let G_0 be the connected unit component of the Lie group of isomorphisms of the real vector space \mathbb{R}^2 and \mathfrak{g} its Lie algebra. We will identify \mathfrak{g} with $T_{\varepsilon}(G_0)$, the tangent space of G_0 in the identity element ε , or with the space of left-invariant vector fields on G_0 .

Consider the left-invariant metric k^+ on G_0 given by the inner product k on \mathfrak{g} defined by the trace as

$$k(u, v) := \operatorname{trace}(u \circ v)$$

and the natural bi-invariant flat affine structure ∇ given by

$$\nabla_{u^+} v^+ := (u \circ v)^+$$

where $u, v \in \mathfrak{g}$ and u^+, v^+ are the left-invariant vector fields on G_0 determined by $u, v \in \mathfrak{g}$. Since the operators ad_{u^+} are k^+ -antisymmetric, the right translations on G_0 are also isometries. Then k^+ is a bi-invariant metric, i.e. (G_0, k^+) is a (orthogonal or) quadratic Lie group in the Medina-Revoy's sense (see [12]).

2 The Lorentzian Structure

Consider the following k-orthonormal basis, denoted by \mathcal{B} , of \mathfrak{g} given by

$$e_{1} := \frac{\sqrt{2}}{2} \begin{pmatrix} 0 & 1 \\ -1 & 0 \end{pmatrix}, \qquad e_{2} := \frac{\sqrt{2}}{2} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}, \qquad (1)$$
$$e_{3} := \frac{\sqrt{2}}{2} \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}, \qquad e_{4} := \frac{\sqrt{2}}{2} \begin{pmatrix} 1 & 0 \\ 0 & 1 \end{pmatrix}.$$

that it will be used throughout this paper.

The Lie brackets, except antisymmetries, relatives to \mathcal{B} become

$$[e_1, e_2] = \sqrt{2}e_3, \ [e_1, e_3] = -\sqrt{2}e_2, \ [e_2, e_3] = -\sqrt{2}e_1$$

and as the product k is given by the table

k	e_1	e_2	e_3	e_4
e_1	-1	0	0	0
e_2	0	1	0	0
e_3	0	0	1	0
e_4	0	0	0	1

 k^+ is a Lorentzian metric on G_0 .

Recall that, a tangent vector u to G_0 is called timelike (respectively lightlike, spacelike) if k(u, u) < 0 (respectively k(u, u) = 0, k(u, u) > 0). In particular, the vector e_1 is timelike, and the others e_i are spacelike.

Putting

$$\begin{pmatrix} x_1 & x_2 \\ x_3 & x_4 \end{pmatrix} \equiv (x_1, x_2, x_3, x_4)$$
(2)

the metric becomes

$$k^{+} = -\left(\left(e_{1}^{+}\right)^{*}\right)^{2} + \left(\left(e_{2}^{+}\right)^{*}\right)^{2} + \left(\left(e_{3}^{+}\right)^{*}\right)^{2} + \left(\left(e_{4}^{+}\right)^{*}\right)^{2}$$

$$= \frac{1}{(x_{1}x_{4} - x_{2}x_{3})^{2}} \left(x_{4}^{2}dx_{1}^{2} - 2x_{3}x_{4}dx_{1}dx_{2} - 2x_{2}x_{4}dx_{1}dx_{3} + 2x_{2}x_{3}dx_{1}dx_{4} + x_{3}^{2}dx_{2}^{2} + 2x_{1}x_{4}dx_{2}dx_{3} - 2x_{1}x_{3}dx_{2}dx_{4} + x_{2}^{2}dx_{3}^{2} - 2x_{1}x_{2}dx_{3}dx_{4} + x_{1}^{2}dx_{4}^{2}\right)$$

where

$$(e_1^+)^* = \frac{1}{\sqrt{2}(x_1x_4 - x_2x_3)} (x_3dx_1 + x_4dx_2 - x_1dx_3 - x_2dx_4) (e_2^+)^* = \frac{1}{\sqrt{2}(x_1x_4 - x_2x_3)} (-x_3dx_1 + x_4dx_2 + x_1dx_3 - x_2dx_4) (e_3^+)^* = \frac{1}{\sqrt{2}(x_1x_4 - x_2x_3)} (x_4dx_1 + x_3dx_2 - x_2dx_3 - x_1dx_4) (e_4^+)^* = \frac{1}{\sqrt{2}(x_1x_4 - x_2x_3)} (x_4dx_1 - x_3dx_2 - x_2dx_3 + x_1dx_4)$$

is the dual coframe, relatively to k^+ , of the smooth orthogonal frame

$$e_{1}^{+} = \frac{\sqrt{2}}{2} \left(-x_{2} \frac{\partial}{\partial x_{1}} + x_{1} \frac{\partial}{\partial x_{2}} - x_{4} \frac{\partial}{\partial x_{3}} + x_{3} \frac{\partial}{\partial x_{4}} \right)$$

$$e_{2}^{+} = \frac{\sqrt{2}}{2} \left(x_{2} \frac{\partial}{\partial x_{1}} + x_{1} \frac{\partial}{\partial x_{2}} + x_{4} \frac{\partial}{\partial x_{3}} + x_{3} \frac{\partial}{\partial x_{4}} \right)$$

$$e_{3}^{+} = \frac{\sqrt{2}}{2} \left(x_{1} \frac{\partial}{\partial x_{1}} - x_{2} \frac{\partial}{\partial x_{2}} + x_{3} \frac{\partial}{\partial x_{3}} - x_{4} \frac{\partial}{\partial x_{4}} \right)$$

$$e_{4}^{+} = \frac{\sqrt{2}}{2} \left(x_{1} \frac{\partial}{\partial x_{1}} + x_{2} \frac{\partial}{\partial x_{2}} + x_{3} \frac{\partial}{\partial x_{3}} + x_{4} \frac{\partial}{\partial x_{4}} \right)$$

A direct calculation allows us to obtain the following result.

Lemma 1. Let φ, ψ be k-symmetric linear isomorphisms. Then φ^{-1}, ψ^{-1} are k-symmetrics and $\varphi \circ \psi, \psi \circ \varphi$ are k-symmetrics, if $\varphi \circ \psi = \psi \circ \varphi$. Moreover, every polynomial $p(\varphi)$ with real coefficients is k-symmetric.

Proof. For any $u, v \in \mathfrak{g}$ we have

$$k\left(\varphi(\varphi^{-1}(u)), v\right) = k\left(\varphi^{-1}(u), \varphi(v)\right)$$
$$k(u, v) =$$
$$k\left(u, \varphi^{-1}(\varphi(v))\right) =$$

Since v is arbitrary and φ is isomorphism, then

$$k(u, \varphi^{-1}(w)) = k(\varphi^{-1}(u), w)$$
 for all $u, w \in \mathfrak{g}$

On the other hand

$$\begin{aligned} k((\varphi \circ \psi)(u), v) &= k(\varphi(\psi(u)), v) = k(\psi(u), \varphi(v)) \\ &= k(u, \psi(\varphi(v))) \\ &= k(u, \varphi(\psi(v))) = k(u, (\varphi \circ \psi)(v)) \end{aligned}$$

The next assertion is clear.

Lemma 2. Any left invariant semi-Riemannian metric on a quadratic Lie group (H,g) is given by a g-symmetric linear isomorphism φ on its Lie algebra \mathfrak{h} by the formula

$$\langle u, v \rangle_{\varphi} := g(\varphi(u), v), \ u, v \in \mathfrak{h}$$

From the above lemmas, we obtain

Corollary 1. Let φ, ψ be k-symmetric linear isomorphisms of \mathfrak{g} . Then the following operators determine a left-invariant (respectively right-invariant) semi-Riemannian metric on G_0

- a) $\varphi \circ \psi$, if $\varphi \circ \psi = \psi \circ \varphi$.
- b) φ^{-1} and $p(\varphi)$, where p is a polynomial with real coefficients.

In fact, as all k-symmetric operators can be found using, for instance, Python (see Section 5) we have

Proposition 1. In the basis \mathcal{B} , the k-symmetric linear isomorphisms φ of \mathfrak{g} are given by the matrix representation

$$\begin{pmatrix} u_{11} & u_{12} & u_{13} & u_{14} \\ -u_{12} & u_{22} & u_{23} & u_{24} \\ -u_{13} & u_{23} & u_{33} & u_{34} \\ -u_{14} & u_{24} & u_{34} & u_{44} \end{pmatrix}$$

The Theorem 4.1 in [1], the Proposition 1, and the fact that all left-invariant metrics are given by $\langle u, v \rangle := k(\varphi(u), v)$ for any k-symmetric φ , implies the following result

Theorem 1. Every left (or right) invariant metric on G_0 is not flat.

Example 1. The left-invariant semi-Riemannian metrics on G_0 given by the following k-symmetric linear isomorphisms of \mathfrak{g}

$$\varphi_0(e_1) = -e_1, \ \varphi_0(e_2) = e_2, \ \varphi_0(e_3) = e_3, \ \varphi_0(e_4) = e_4$$

$$\varphi_1(e_1) = e_1, \ \varphi_1(e_2) = e_2, \ \varphi_1(e_3) = e_3, \ \varphi_1(e_4) = e_4$$

$$\varphi_2(e_1) = e_1, \ \varphi_2(e_2) = -e_2, \ \varphi_2(e_3) = e_3, \ \varphi_2(e_4) = e_4$$

have index 0, 1, 2 respectively and $\langle u, v \rangle_i := k(\varphi_i(u), v)$, for i = 0, 1, 2, are not flat.

For the study of the movement space in (G_0, k^+) , in addition to the tangent bundle, it is convenient to introduce certain principal fiber bundles. For instance, the orthonormal fiber bundle over (G_0, k^+) facilitates the understanding of parallel transport along a curve, the holonomy groups, and the corresponding holonomy bundles.

Let $P = L(G_0)$ be the principal fiber bundle of the linear frames over G_0 . Since $GL(4, \mathbb{R})$ is 16-dimensional, P has a dimension of 20. On the other hand, as the orthogonal group O(1,3) is the dimension 6, the principal fiber bundle of the orthogonal frames over G_0 is 10-dimensional.

Now, as the Levi-Civita connection D of (G_0, k^+) can be expressed using left-invariant fields as

$$D_{u^+}v^+ := \frac{1}{2}[u,v]^+$$

the curvature, sectional curvature, scalar curvature, and Ricci tensors become

$$R_{u^+v^+}w^+ := \frac{1}{4} \left[\left[u^+, v^+ \right], w^+ \right]$$
$$K(u^+, v^+) := \frac{1}{4} \frac{k^+ \left(\left[u^+, v^+ \right], \left[u^+, v^+ \right] \right)}{k^+ \left(u^+, u^+ \right) k^+ \left(v^+, v^+ \right) - k^+ \left(u^+, v^+ \right)^2}$$

with $\operatorname{span}\{u^+,v^+\}$ a nondegenerate plane,

$$S := 2 \sum_{i < j} K(e_i^+, e_j^+)$$
$$R_{icci}(u, v) := -\frac{B(u, v)}{4} = -\frac{1}{4} \text{trace} \left(\text{ad}_u \circ \text{ad}_v \right)$$

respectively. Here B is known as the Cartan-Killing form.

If
$$u = \begin{pmatrix} u_1 & u_2 \\ u_3 & u_4 \end{pmatrix}$$
, $v = \begin{pmatrix} v_1 & v_2 \\ v_3 & v_4 \end{pmatrix} \in \mathfrak{g}$, the Ricci tensor can be written as
$$R_{icci}(u, v) = \frac{1}{2} \left(v_1 u_4 - v_1 u_1 - 2v_2 u_3 - 2v_3 u_2 - v_4 u_4 + v_4 u_1 \right)$$

Note that, if $u, v \in sl(2)$, then $R_{icci}(u, v) = -(2u_1v_1 + u_2v_3 + u_3v_2)$

Consequently, we have

Lemma 3. In terms of the above orthonormal basis (1) of (\mathfrak{g}, k) , the curvature tensor, the sectional curvature, the scalar curvature, the Cartan-Killing form and the Ricci tensor of (G_0, k^+, D) are given respectively by

$$\begin{split} R\left(e_{1}^{+}, e_{2}^{+}, e_{1}^{+}\right) &= \frac{1}{2}e_{2}^{+}, R\left(e_{1}^{+}, e_{2}^{+}, e_{2}^{+}\right) = \frac{1}{2}e_{1}^{+}, R\left(e_{1}^{+}, e_{3}^{+}, e_{1}^{+}\right) = \frac{1}{2}e_{3}^{+}, \\ R\left(e_{1}^{+}, e_{3}^{+}, e_{3}^{+}\right) &= \frac{1}{2}e_{1}^{+}, R\left(e_{2}^{+}, e_{1}^{+}, e_{1}^{+}\right) = -\frac{1}{2}e_{2}^{+}, R\left(e_{2}^{+}, e_{1}^{+}, e_{2}^{+}\right) = -\frac{1}{2}e_{1}^{+}, \\ R\left(e_{2}^{+}, e_{3}^{+}, e_{2}^{+}\right) &= -\frac{1}{2}e_{3}^{+}, R\left(e_{2}^{+}, e_{3}^{+}, e_{3}^{+}\right) = \frac{1}{2}e_{2}^{+}, R\left(e_{3}^{+}, e_{1}^{+}, e_{1}^{+}\right) = -\frac{1}{2}e_{3}^{+}, \\ R\left(e_{3}^{+}, e_{1}^{+}, e_{3}^{+}\right) &= -\frac{1}{2}e_{1}^{+}, R\left(e_{3}^{+}, e_{2}^{+}, e_{3}^{+}\right) = e_{3}^{+}, R\left(e_{3}^{+}, e_{2}^{+}, e_{3}^{+}\right) = -\frac{1}{2}e_{2}^{+} \\ R\left(e_{i}^{+}, e_{j}^{+}, e_{k}^{+}\right) &= 0 \text{ in the other cases.} \end{split}$$

$$\begin{split} K(e_1^+,e_2^+) &= K(e_1^+,e_3^+) = K(e_2^+,e_3^+) = -\frac{1}{2}, \\ K(e_i^+,e_4^+) &= 0, \ \ for \ i = 1,2,3, \\ S &= -3 \\ B(e_1,e_1) &= -4, \ B(e_2,e_2) = B(e_3,e_3) = 4, \ B(e_4,e_4) = 0 \\ B(e_i,e_j) &= 0 \ \ for \ i \neq j \\ R_{icci}(e_1^+,e_1^+) &= 1, \ R_{icci}(e_2^+,e_2^+) = R_{icci}(e_3^+,e_3^+) = -1, \\ R_{icci}(e_4^+,e_4^+) &= R_{icci}(e_i^+,e_j^+) = 0, \ \ for \ i \neq j \end{split}$$

Using (2), we have

$$\begin{aligned} R_{icci} &= \left(-\frac{x_1 x_2}{2} + \frac{x_1 x_4}{2} + \frac{x_2^2}{2} \right) dx_1^2 + \left(\frac{\sqrt{2} x_1}{2} + \frac{\sqrt{2} x_2}{2} \right) dx_1 dx_2 \\ &+ \left(\frac{\sqrt{2} x_1}{2} + \frac{\sqrt{2} x_4}{2} \right) dx_1 dx_3 + \left(\frac{\sqrt{2} x_1}{2} + \frac{\sqrt{2} x_3}{2} \right) dx_1 dx_4 \\ &+ \left(\sqrt{2} x_1 \right) dx_2^2 + \left(-\frac{\sqrt{2} x_2}{2} + \frac{\sqrt{2} x_4}{2} \right) dx_2 dx_3 \\ &+ \left(\frac{\sqrt{2} x_2}{2} + \frac{\sqrt{2} x_3}{2} \right) dx_2 dx_4 + \left(\sqrt{2} x_3 \right) dx_3^2 \\ &+ \left(\frac{\sqrt{2} x_3}{2} - \frac{\sqrt{2} x_4}{2} \right) dx_3 dx_4 + \left(\sqrt{2} x_4 \right) dx_4^2 \end{aligned}$$

It is clear that the curvature tensor (respectively the tensor Ricci), viewed in the principal fiber bundle of the orthogonal frames, has 12 components (respectively 3).

The knowledge of these objects allows us to write the Einstein's equation.

Recall that the structure of the gravitational field, without matter (or antimatter), is determined by the Weyl tensor. The next result exhibited the components of the Weyl tensor.

Theorem 2. Using the orthonormal basis (1), the components of the Weyl tensor W

are given by

$$W(e_{i}^{+}, e_{j}^{+}, e_{k}^{+}, e_{l}^{+}) = \begin{cases} 0 & \text{if } i = j = k = l, \ i = j = k \neq l, \ i \neq j \neq k \neq l \\ \frac{3}{2} & \text{if } i = k = 1, j = l = 2, \ or \ i = k = 1, j = l = 3, \\ or \ i = l = 2, j = k = 3 \end{cases}$$
$$W(e_{i}^{+}, e_{j}^{+}, e_{k}^{+}, e_{l}^{+}) = \begin{cases} -\frac{3}{2} & \text{if } i = l = 1, j = k = 2, \ or \ i = l = 1, j = k = 3, \\ or \ i = k = 2, j = l = 3 \end{cases}$$
$$\frac{1}{2} & \text{if } i = l = 2, 3, j = k = 4, \ or \ i = l = 4, j = k = 2, 3, \\ or \ i = k = 1, j = l = 4, \ or \ i = k = 4, j = l = 1 \end{cases}$$
$$-\frac{1}{2} & \text{if } i = l = 1, j = k = 4, \ or \ i = l = 4, j = k = 1, \\ or \ i = k = 2, 3, j = l = 4, \ or \ i = k = 4, j = l = 2, 3 \end{cases}$$

Proof. Recall, the Kulkarni–Nomizu product of two symmetric covariant 2-tensor h and l is defined by

$$(h \otimes l)(w, x, y, z) := h(w, z)l(x, y) + h(x, y)l(w, z) - h(w, y)l(x, z) - h(x, z)l(w, y)$$
(3)

Using (3) we can write de Wey tensor as

$$W = R_m - \frac{1}{2}R_{icci} \otimes k^+ + \frac{S}{12}k^+ \otimes k^+$$
$$= R_m - \frac{1}{2}R_{icci} \otimes k^+ - \frac{1}{4}k^+ \otimes k^+$$

where $R_m(X_1, X_2, X_3, X_4) = \langle R(X_1, X_2, X_3), X_4 \rangle_{k^+}$ for all $X_1, X_2, X_3, X_4 \in \mathfrak{X}(G_0)$ (see [9]). From a direct calculus, the result follows.

Remarks 1. Concerning to the space-time model $(GL(2, \mathbb{R})_0, k^+)$:

- a. Note that the Weyl tensor vanishes at several points. So, the Weyl curvature hypothesis eventually suggests the existence of several Big Bangs (initial singularities) in the space-time model. Could this imply the existence of different space times?
- b. Since (G_0, k^+) is a space-time model locally Hessian (in fact, globally Hessian), we can reverse the arrow of time, using the global potential, for going back to obtain final singularities, eventually black holes or Big Crunches.
- c. It is clear that this model allows several quantification processes.
- d. The Weyl tensor describes the conformal curvature of (G_0, k^+) , and emphasize that the metric k^+ is not conformally flat.

2.1 Tidal Force and Jacobi Vector Fields

Definition 1. For a vector $0 \neq v \in T_{\sigma}(G_0)$ the tidal force operator $F_v : v^{\perp} \to v^{\perp}$ according to v is given by $F_v(y) = R_{yv}v$.

The operator F_v is k^+ -self-adjoint on v^{\perp} and it verifies the condition trace $(F_v) = -R_{icci}(v, v)$ (see [13]). A direct calculation gives

Lemma 4. For $v_{\sigma} = \sum_{i=1}^{4} f_i e_{i,\sigma}^+$, with $\sigma \in G_0$ we have $\operatorname{trace}(F_{v_{\sigma}}) = -R_{icci} (v_{\sigma}, v_{\sigma})$ $= -R_{icci} \left(\sum_{i=1}^{4} f_i e_{i,\sigma}^+, \sum_{j=1}^{4} f_j e_{j,\sigma}^+\right)$ $= -\sum_{i,j=1}^{4} f_i f_j R_{icci} (e_{i,\sigma}^+, e_{j,\sigma}^+)$ $= -f_1^2 + f_2^2 + f_3^2.$

Jacobi Fields. If $\tau(t)$ is a geodesic, the curvature variations along of τ are given by vector fields Y, called Jacobi fields, solutions of the differential equation

$$\frac{D^2 Y}{dt^2} = \mathcal{R}(Y, \tau', \tau') \tag{4}$$

where $\frac{DY}{dt}$ denotes the affine covariant derivative relative to D along τ . Now, we will focus on the Jacobi equation in the Lie Group (G_0, k^+) using the notion of **reflection** introduced by Bromberg-Medina in [4].

Every vector field X on G_0 defines a map

$$\begin{array}{rccc} \tilde{X}: & G_0 & \to & \mathfrak{g} \\ & \sigma & \mapsto & (\mathcal{L}_{\sigma^{-1}})_{*,\sigma} X_{\sigma}. \end{array}$$

Obviously, a vector field is left invariant if and only if the associated map is constant. Given a curve $\sigma : [t_0, t_1] \to G_0$, every vector field Y along σ defines a curve in \mathfrak{g} :

$$Y(t) = \left(\mathcal{L}_{\sigma(t)^{-1}}\right)_{*,\sigma(t)} Y(t)$$

and conversely, every curve in \mathfrak{g} defined on [0, 1] determines a vector field along σ . We say that one is the **reflection** of the other and we write either $y^{\sim} = Y$ or $Y^{\sim} = y$. Notice that $y(t) = (Y(t))^{\sim}$ is equivalent to $y(t)^+_{\sigma(t)} = Y(t)$. **Theorem 3.** The functions components of the reflection field $y(t) = y_1e_1^+ + y_2e_2^+ + y_3e_3^+ + y_4e_4^+$ in \mathfrak{g} of the Jacobi field along a geodesic $\sigma : [0,1] \to G$ with $\sigma(0) = \varepsilon$ and initial velocity $\sigma'(0) = ae_1 + be_2 + ce_3 + de_4$ are given by

$$y_{1}(t) = A_{0}t + A_{1}e^{\alpha t} + A_{2}e^{-\alpha t}$$

$$y_{2}(t) = B_{0} + B_{1}e^{\alpha t} + A_{2}e^{-\alpha t}$$

$$y_{3}(t) = C_{0} + C_{1}e^{\alpha t} + C_{2}e^{-\alpha t}$$

$$y_{4}(t) = D_{0} + D_{1}t$$

where A_i, B_i, C_i, D_i and α are constants that depend on a, b, c, d.

Proof. As Lemma 3 in [4] establish that

from (4), we obtain the differential system on \mathfrak{g}

A direct calculation gives

$$\begin{split} y_{1}(t) &= \frac{1}{2(a^{2}-b^{2}-c^{2})} \left(2at(aC_{1}-bC_{2}-cC_{3}) + \\ &+ \frac{e^{-\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}}}{\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}} \left(b^{2}C_{1}+c^{2}C_{1}-abC_{2}+c\sqrt{-a^{2}+b^{2}+c^{2}}C_{2}-acC_{3}-b\sqrt{-a^{2}+b^{2}+c^{2}}C_{3} \right) + \\ &+ \frac{e^{\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}}}{\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}} \left(-b^{2}C_{1}-c^{2}C_{1}+abC_{2}+c\sqrt{-a^{2}+b^{2}+c^{2}}C_{2}+acC_{3}-b\sqrt{-a^{2}+b^{2}+c^{2}}C_{3} \right) \right) \\ y_{2}(t) &= \frac{1}{2(a^{2}-b^{2}-c^{2})} \left(-2bt(-aC_{1}+bC_{2}+cC_{3}) + \\ &+ \frac{e^{-\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}}}{\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}} \left(abC_{1}+c\sqrt{-a^{2}+b^{2}+c^{2}}C_{1}-a^{2}C_{2}+c^{2}C_{2}-bcC_{3}-a\sqrt{-a^{2}+b^{2}+c^{2}}C_{3} \right) + \\ &+ \frac{e^{\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}}}{\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}} \left(-abC_{1}+c\sqrt{-a^{2}+b^{2}+c^{2}}C_{1}+a^{2}C_{2}-c^{2}C_{2}+bcC_{3}-a\sqrt{-a^{2}+b^{2}+c^{2}}C_{3} \right) \right) \\ y_{3}(t) &= \frac{1}{2(a^{2}-b^{2}-c^{2})} \left(-2ct(-aC_{1}+bC_{2}+cC_{3}) + \\ &+ \frac{e^{\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}}}{\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}} \left(-acC_{1}-b\sqrt{-a^{2}+b^{2}+c^{2}}C_{1}+bcC_{2}+a\sqrt{-a^{2}+b^{2}+c^{2}}C_{2}+a^{2}C_{3}-b^{2}C_{3} \right) + \\ &+ \frac{e^{-\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}}}{\sqrt{2}\sqrt{-a^{2}+b^{2}+c^{2}}} \left(acC_{1}-b\sqrt{-a^{2}+b^{2}+c^{2}}C_{1}-bcC_{2}+a\sqrt{-a^{2}+b^{2}+c^{2}}C_{2}-a^{2}C_{3}+b^{2}C_{3} \right) \right) \\ y_{4}(t) &= C_{4}t+C_{5} \end{split}$$

In the case of $a^2 = b^2 + c^2$, the components of the reflection of Jacobi fields become

$$y_{1}(t) = C_{1} + \frac{1}{3}(3t + b^{2}t^{3} + c^{2}t^{3})C_{2} + \frac{1}{6}(-3\sqrt{2}ct^{2} \pm 2b\sqrt{b^{2} + c^{2}}t^{3})C_{4}$$

$$+ \frac{1}{6}(3\sqrt{2}bt^{2} \pm 2c\sqrt{b^{2} + c^{2}}t^{3})C_{6}$$

$$y_{2}(t) = \frac{1}{6}(-3\sqrt{2}ct^{2} \mp 2b\sqrt{b^{2} + c^{2}}t^{3})C_{2} + C_{3} + \frac{1}{3}(3t - b^{2}t^{3})C_{4}$$

$$+ \frac{1}{6}(\mp 3\sqrt{2}\sqrt{b^{2} + c^{2}}t^{2} - 2bct^{3})C_{6}$$

$$y_{3}(t) = \frac{1}{6}(3\sqrt{2}bt^{2} \mp 2c\sqrt{b^{2} + c^{2}}t^{3})C_{2} + \frac{1}{6}(\mp 3\sqrt{2}\sqrt{b^{2} + c^{2}}t^{2} - 2bct^{3})C_{4}$$

$$+ C_{5} + \frac{1}{3}(3t - c^{2}t^{3})C_{6}$$

$$y_{4}(t) = C_{7}t + C_{8}$$

2.2 Parallel transport in terms of reflections

A smooth vector field Y along a smooth curve $\alpha : [a, b] \to G_0$ is said to be parallel relatively to connection D if its variation is null, i.e. $\frac{DY}{dt} = 0$.

The map $P_a^b : T_{\alpha(a)}(G_0) \to T_{\alpha(b)}(G_0)$ sending each $v_{\alpha(a)}$ to a parallel vector Y on α such that $Y(a) = v_{\alpha(a)}$ is called **parallel transport along** α . In what follows we give an outline of the parallel transport starting at ε , using the notion of reflection

Proposition 2. Let γ be a smooth curve with initial direction $x_0 \neq 0$ starting in the unit of G_0 with tangent vector field γ' and $x = \sum_{i=1}^{4} x_i e_i$ the reflection of γ' . Then the reflection $y := Y^{\sim}$ of the parallel transport of Y along γ is given by the solution of the following system of the differential equations on \mathfrak{g}

$$y_1' = \frac{\sqrt{2}}{2} (x_3 y_2 - x_2 y_3)$$
$$y_2' = \frac{\sqrt{2}}{2} (x_3 y_1 - x_1 y_3)$$
$$y_3' = \frac{\sqrt{2}}{2} (x_1 y_2 - x_2 y_1)$$
$$y_4' = 0$$

To illustrate this notion, we give some examples

Example 2. If γ is an integral curve of e_1^+ (timelike vector) through ε and $y(0) = ae_1 + be_2 + ce_3 + de_4 \in T_{\gamma(0)}G_0$, then

$$\gamma(s) = \begin{pmatrix} \cos\left(\frac{\sqrt{2}}{2}s\right) & \sin\left(\frac{\sqrt{2}}{2}s\right) \\ -\sin\left(\frac{\sqrt{2}}{2}s\right) & \cos\left(\frac{\sqrt{2}}{2}s\right) \end{pmatrix}$$

and the reflection of $\gamma'(s)$ on \mathfrak{g} is $x(s) = e_1$. So, we have the following system of differential equations

$$y'_{1} = \frac{1}{2} (y_{3} + y_{2})$$
$$y'_{2} = -\frac{1}{2} y_{1}$$
$$y'_{3} = -\frac{1}{2} y_{1}$$
$$y'_{4} = 0$$

Taking as initial condition y(0), the components of the reflection y(s) in \mathfrak{g} are

$$y_1(s) = a \cos\left(\frac{\sqrt{2}}{2}s\right) + \frac{\sqrt{2}}{2}(b+c)\sin\left(\frac{\sqrt{2}}{2}s\right)$$
$$y_2(s) = \frac{b-c}{2} + \frac{b+c}{2}\cos\left(\frac{\sqrt{2}}{2}s\right) - \frac{\sqrt{2}}{2}a\sin\left(\frac{\sqrt{2}}{2}s\right)$$
$$y_3(s) = \frac{-b+c}{2} + \frac{b+c}{2}\cos\left(\frac{\sqrt{2}}{2}s\right) - \frac{\sqrt{2}}{2}a\sin\left(\frac{\sqrt{2}}{2}s\right)$$
$$y_4(s) = d$$

Hence, the components of the parallel vector field Y along γ such that $Y(0) = y^+(0)_{\gamma(0)}$ are given by

$$\begin{split} Y_1(s) &= a\cos^2\left(\frac{\sqrt{2}}{2}s\right) + \frac{\sqrt{2}a}{2}\sin^2\left(\frac{\sqrt{2}}{2}s\right) + \frac{(b+c)(\sqrt{2}+2)}{2}\sin\left(\frac{\sqrt{2}}{2}s\right)\cos\left(\frac{\sqrt{2}}{2}s\right) + \frac{c-b}{2}\sin\left(\frac{\sqrt{2}}{2}s\right) \\ Y_2(s) &= \frac{b+c}{2}\cos^2\left(\frac{\sqrt{2}}{2}s\right) + \frac{b-c}{2}\cos\left(\frac{\sqrt{2}}{2}s\right) - \frac{\sqrt{2}a}{2}\cos\left(\frac{\sqrt{2}}{2}s\right)\sin\left(\frac{\sqrt{2}}{2}s\right) + d\sin\left(\frac{\sqrt{2}}{2}s\right) \\ Y_3(s) &= \frac{b+c}{2}\cos^2\left(\frac{\sqrt{2}}{2}s\right) - \frac{\sqrt{2}}{2}(b+c)\sin^2\left(\frac{\sqrt{2}}{2}s\right) - \left(\frac{\sqrt{2}}{2}+1\right)a\sin\left(\frac{\sqrt{2}}{2}s\right)\cos\left(\frac{\sqrt{2}}{2}s\right) + \frac{c-b}{2}\cos\left(\frac{\sqrt{2}}{2}s\right) \\ Y_4(s) &= \frac{\sqrt{2}}{2}a\sin^2\left(\frac{\sqrt{2}}{2}s\right) + \frac{c-b}{2}\sin\left(\frac{\sqrt{2}}{2}s\right) - \frac{b+c}{2}\sin\left(\frac{\sqrt{2}}{2}s\right)\cos\left(\frac{\sqrt{2}}{2}s\right) + d\cos\left(\frac{\sqrt{2}}{2}s\right) \end{split}$$

Example 3. If $\gamma(s)$ is an integral curve of Y through ε , such that $Y_{\gamma}(0)$ is a lightlike vector $u = \begin{pmatrix} a & b \\ c & d \end{pmatrix}$ i.e. $a^2 + 2bc + d^2 = 0$, then

$$\gamma(s) = e^{\frac{a+d}{2}s} \left(\begin{array}{c} \cos\left(\frac{\theta}{2}s\right) + \frac{(a-d)}{\theta}\sin\left(\frac{\theta}{2}s\right) & \frac{2b}{\theta}\sin\left(\frac{\theta}{2}s\right) \\ \frac{2c}{\theta}\sin\left(\frac{\theta}{2}s\right) & \cos\left(\frac{\theta}{2}s\right) - \frac{(a-d)}{\theta}\sin\left(\frac{\theta}{2}s\right) \end{array} \right)$$

and the reflection of $\gamma'(t)$ on \mathfrak{g} will be given by

$$\begin{aligned} x(s) &= \frac{a+d}{2} e^{\frac{a+d}{2}s} I_{2\times 2} + \\ &+ \frac{e^{(a+d)s}}{\det \gamma} \begin{pmatrix} \frac{a-d}{2} - \left(\frac{\theta}{2} + \frac{(a-d)^2}{2\theta} + \frac{2bc}{\theta}\right) \sin\left(\frac{\theta}{2}s\right) \cos\left(\frac{\theta}{2}s\right)}{c} & b \\ &- \frac{a-d}{2} - \left(\frac{\theta}{2} + \frac{(a-d)^2}{2\theta} + \frac{2bc}{\theta}\right) \sin\left(\frac{\theta}{2}s\right) \cos\left(\frac{\theta}{2}s\right) \end{pmatrix} \end{aligned}$$

where $\theta = \operatorname{Re}(\sqrt{2bc - 2ad})$ and $\operatorname{det}(\gamma(s)) = e^{(a+d)s} \left(\cos\left(\frac{\theta}{2}s\right) + 2\left(\frac{ad-bc}{\theta^2}\right)\sin\left(\frac{\theta}{2}s\right)\right)$ The writing and solution of the system of differential equations are left to the reader.

2.3 Geodesics of (G_0, k^+) through ε

Recall that we have

Lemma 5. The left and right multiplication are isometries of (G_0, k^+) , and consequently the inversion map and the map I_{σ} , defined by $I_{\sigma}(\tau) := \sigma \tau^{-1} \sigma$, for any $\sigma, \tau \in G_0$, is an isometry. Consequently, (G_0, k^+) is a symmetric space.

In fact, I_{σ} inverse the geodesic, this means that

$$I_{\sigma}(\gamma(s)) = \sigma \gamma(-s)\sigma$$

where $\gamma(s) = \operatorname{Exp}(su)$ is a geodesic with $\gamma(0) = \varepsilon = I_2 \in G_0$ and $\gamma'(0) = u \in \mathfrak{g}$. In particular for $\sigma = \varepsilon$ and $u = e_1$, the geodesic is timelike, so we have

$$I_{\varepsilon}(\gamma(s)) = \begin{pmatrix} \cos\left(\frac{\sqrt{2}}{2}s\right) & -\sin\left(\frac{\sqrt{2}}{2}s\right) \\ \sin\left(\frac{\sqrt{2}}{2}s\right) & \cos\left(\frac{\sqrt{2}}{2}s\right) \end{pmatrix}$$

Proposition 3. The lightlike geodesics $\gamma(s)$ passing through the identity, with $\gamma'(0) = \begin{pmatrix} x & y \\ z & w \end{pmatrix} \in \mathfrak{g}$ are given by

$$\gamma(s) = \begin{pmatrix} \frac{e^{sA}B + e^{sA'}B'}{C} & \frac{y(e^{sA'} - e^{sA})}{C} \\ \frac{z(e^{sA} - e^{sA})}{C} & \frac{e^{sA}B' + e^{sA}B}{C} \end{pmatrix} \quad where \quad \begin{aligned} A &= \frac{1}{2}(w + x - \sqrt{2yz - 2wx}) \\ A' &= \frac{1}{2}(w + x + \sqrt{2yz - 2wx}) \\ B &= w - x + \sqrt{2yz - 2wx} \\ B' &= -w + x + \sqrt{2yz - 2wx} \\ C &= 2\sqrt{2yz - 2wx} \end{aligned}$$

On the other hand, the metric k^+ can be extended to the Lorentzian metric \tilde{k}^+ over the universal covering \tilde{G} in such a way that the covering map p acts as a local isometry. Examining the isometries of the universal covering space can help us understand the isometries of (G_0, k^+) (for instance see Proposition 2.1 and Theorem 2.2 of [3]).

2.4 Clifford Algebras, Electron Spin

It is clear in the model (G_0, k^+) that the flat affine geometry can be used to describe Pauli's particles. Moreover, this geometry is well adapted to study Dirac's equation, which involves the Lorentzian geometry and quantum fields. Note that the quadratic space (\mathfrak{g}, q) , where $q(A) = \operatorname{trace}(A^2)$, is the case of the opposite of Minkowski space M, whose Clifford algebra is the algebra of quaternion matrices 2×2 , in physics is known as Dirac matrices.

Recall that, the Clifford algebra of the quadratic space (E, q) is the associative algebra C with unit 1_C , equipped with a map φ_C (called Clifford application) from (E, q) to C satisfying the following conditions:

- 1. 1_C and $\varphi_C(E)$ span C
- 2. For any Clifford map φ of (E, q) in an algebra A, there exists a homomorphism of algebras with unity Φ from C to A such that $\varphi = \Phi \circ \varphi_C$.

To find the Clifford algebra of the space of (\mathfrak{g}, q) , we define the Clifford map φ from \mathfrak{g} to real algebra of real matrices 4×4 by

$$\begin{pmatrix} x_1 & x_2 \\ x_3 & x_4 \end{pmatrix} \mapsto \frac{\sqrt{2}}{2} \begin{pmatrix} x_2 + x_3 & x_1 - x_2 + x_3 - x_4 & x_1 + x_4 & 0 \\ x_1 + x_2 - x_3 - x_4 & -x_2 - x_3 & 0 & x_1 + x_4 \\ x_1 + x_4 & 0 & -x_2 - x_3 & -x_1 + x_2 - x_3 + x_4 \\ 0 & x_1 + x_4 & -x_1 - x_2 + x_3 + x_4 & x_2 + x_3 \end{pmatrix}$$

Since the dimension of the Clifford algebra of a *n*-dimensional quadratic space is 2^n , then the Clifford algebra for (\mathfrak{g}, q) is isomorphic to the real matrices $gl(4, \mathbb{R})$.

2.5 Causal Structure

Let W be a subspace of the Lorentz vector space $(T_{\varepsilon}(G_0), k)$. The causal character of W can be classified into three types, Spacelike, Timelike, or Lightlike. The set of all

lightlike vectors in $T_{\sigma}(G_0)$ is called the lightcone at $\sigma \in G_0$, this one determined the causal character of the event σ .

In particular, a real matrix $A = \begin{pmatrix} a & b \\ c & d \end{pmatrix}$ in $T_{\epsilon}(G_0)$ is lightlike (respectively timelike, spacelike) if it verifies the condition $a^2 + 2bc + d^2 = 0$ (respectively $a^2 + 2bc + d^2 < 0$, $a^2 + 2bc + d^2 > 0$).

Now, the timecone containing $u \in T_{\varepsilon}(G_0)$ is the set C(u) of timelike vectors $v \in T_{\varepsilon}(G_0)$ such that k(u, v) < 0. Hence, the timecone containing $e_1 \in T_{\varepsilon}(G_0)$ is

$$C(e_1) = \left\{ \left(\begin{array}{cc} a & b \\ c & d \end{array} \right) \middle| c < b, \ a^2 + 2bc + d^2 < 0 \right\}$$

whereas

$$-C(e_1) = \left\{ \left(\begin{array}{cc} a & b \\ c & d \end{array} \right) \middle| c > b, \ a^2 + 2bc + d^2 < 0 \right\}$$

it is the opposite timecone.

The determination of the lightcone can is left to the reader.

Obviously, the conformal geometry associated with k^+ modifies the causality in the model.

3 Flat Affine Structure on $GL(2, \mathbb{R})_0$

A flat affine connection on a connected manifold can be given by a natural affine representation of the universal covering of the Lie group of diffeomorphisms preserving the connection (see [11]).

Since the matrix multiplication is associative, the above Lie group G_0 is endowed with a bi-invariant flat affine structure ∇ i.e. a linear connection without torsion and curvature.

It is well known that ∇ is highly geodesically incomplete (see [2]).

We have the following result (See [1])

Theorem 4. (G_0, ∇, k^+) is a local (in fact global) Hessian manifold.

Proof. A potential function for k^+ is

$$f: \quad G_0 \to \mathbb{R} \\ M \mapsto \frac{1}{2} \operatorname{tr} \left(M^2 \right)$$

In natural coordinates, the gradient has the expression

$$grad f = \sum_{i=1}^{4} \frac{\partial f}{\partial x_i} \frac{\partial}{\partial x_i}$$
$$= x_1 \frac{\partial}{\partial x_1} + x_3 \frac{\partial}{\partial x_2} + x_2 \frac{\partial}{\partial x_3} + x_4 \frac{\partial}{\partial x_4}$$

Hence

$$\left(\frac{\partial^2 f}{\partial x_i \partial x_j}\right) = \left(\begin{array}{rrrr} 1 & 0 & 0 & 0\\ 0 & 0 & 1 & 0\\ 0 & 1 & 0 & 0\\ 0 & 0 & 0 & 1 \end{array}\right)$$

In fact, we have

Theorem 5. (G_0, k^+) is endowed with a foliation given by the global potential function $f: G_0 \to \mathbb{R}$ of k^+ defined as $f(\sigma) = \operatorname{trace}(\sigma^2)$.

Proof. Since f is a smooth map with constant rank 1, then the level set $f^{-1}(C)$, for any $C \in \mathbb{R}$, is an embedded submanifold of dimension 3.

For instance, if $m = \begin{pmatrix} \frac{\sqrt{2}}{2} & 0\\ 0 & \frac{\sqrt{2}}{2} \end{pmatrix} \in \alpha := f^{-1}(1)$, we obtain that the tangent space to α

in m is

$$T_m(\alpha) = \operatorname{span}\left\{u_1 = \begin{pmatrix} -\frac{\sqrt{2}}{2} & 0\\ 0 & \frac{\sqrt{2}}{2} \end{pmatrix}, u_2 = \begin{pmatrix} 0 & 1\\ 0 & 0 \end{pmatrix}, u_3 = \begin{pmatrix} 0 & 0\\ 1 & 0 \end{pmatrix}\right\}$$

Note that u_1 is spacelike, u_2, u_3 are lightlike, and $u_4 = u_1 + u_2 - u_3$ is timelike. More generally, the set C defined by $au_1 + bu_2 + cu_3$ with $a^2 + bc < 0$ is timelike, and its graph is the interior of a convex cone.

The universal covering group of G_0 is the product manifold $\widetilde{G} = \mathbb{R} \times \text{SDP}(2)$, where SDP(2) are the symmetric definite positive matrices and the covering map is

$$p: \mathbb{R} \times \text{SDP}(2) \to G_0$$

(t,T) $\mapsto O_t T$ (7)

here O_t denotes an orthogonal matrix.

The product of G_0 rises to a product in \widetilde{G} such that \widetilde{G} is a Lie group and p is a homomorphism of Lie groups (see [5] pag. 53).

To find the multiplication in \widetilde{G} , we must calculate the polar decomposition of $O_t TO_r R$, this is

$$\underbrace{O_t T O_r R (R O_{-r} T^2 O_r R)^{-\frac{1}{2}}}_{O_s} \underbrace{(R O_{-r} T^2 O_r R)^{\frac{1}{2}}}_{S}$$

Then the multiplication of two elements in \tilde{G} is given as follows:

$$(t,T) \cdot (r,R) = \left(s(t,r), (RO_{-r}T^2O_rR)^{\frac{1}{2}}\right)$$
(8)

where $s(t, r) \in \mathbb{R}$ can be calculated using the orthogonal matrix of order 2×2

$$O_{s(t,r)} = O_t T O_r R (R O_{-r} T^2 O_r R)^{-\frac{1}{2}}$$

The multiplication (8) can be written as

$$(t,T) \cdot (r,R) = (\arctan(\theta) + t + r, \ O_{-\arctan(\theta) - t - r}TO_rR)$$
(9)

where

$$\theta = \frac{\operatorname{tr}(O_{-r}TO_{r}R\omega)}{\operatorname{tr}(O_{-r}TO_{r}R)} \quad \text{and} \quad \omega = \begin{pmatrix} 0 & 1\\ -1 & 0 \end{pmatrix}$$

A direct calculation shows that $\left(\widetilde{G},\cdot\right)$ is a Lie group.

Theorem 6. The developed map of the flat affine manifold (G_0, ∇) in the Ehresmann's sense [6], following Koszul method [8] (see also [7]), is given by

$$Dev: \begin{array}{ccc} \widetilde{G}_{0} & \to & \mathbb{R}^{4} \\ (y_{1}, y_{2}, y_{3}, y_{4}) & \mapsto & (y_{1}, y_{2} - 1, y_{3}, y_{4} - 1) \end{array}$$

Proof. Let (x_1, x_2, x_3, x_4) be the natural coordinates (2) of G_0 . We know that ∇ is locally isomorphic to usual connection ∇^0 on \mathbb{R}^4 , then its 1-form connection ω can be written in local coordinates $(x_1, x_2, x_3, x_4, (X)_{ij})$, like

$$\omega = (\omega_{ij}) = \left(\sum_{k=1}^{4} Y_{ik} \, \mathrm{d} \, X_{kj}\right), \text{ where } (Y_{ij}) = (X_{ij})^{-1}$$

Let (\widetilde{G}, p) be the universal covering group of G_0 , where p is the covering map (7), and $\widetilde{\mathfrak{g}}$ the Lie algebra of \widetilde{G} .

We can lift the affine structure to \widetilde{G} through $\widetilde{\omega} := p^* \omega$. Now, we will compute the developed map of $(\widetilde{G}, \widetilde{\nabla})$. First, we find the vector fields Y on \widetilde{G} such that $\widetilde{\nabla}Y = 0$. In the local coordinates

$$\left(y_1, \left(\begin{array}{cc}y_2 & y_3\\y_3 & y_4\end{array}\right)\right) \cong \left(y_1, y_2, y_3, y_4\right)$$

they are

$$Y = \sum_{i=1}^{4} a_i \frac{\partial}{\partial y_i}, \quad \text{with } a_i \in \mathbb{R}$$

Second, we shall calculate the close $\tilde{\mathfrak{g}}$ -valued 1-form η on \tilde{G} such that $\tilde{\nabla}\eta = 0$ and $\eta(Y) = Y_{\tilde{\varepsilon}}$. A direct calculation shows that $\eta = (dy_1, dy_2, dy_3, dy_4)$

Finally, the developed map is given by $Dev(\tilde{\sigma}) = \int_C \eta$, where C is a curve joining $\tilde{\varepsilon} = (0, 1, 0, 1)$ and $\tilde{\sigma}$. Then

$$Dev: \quad \widetilde{G}_0 \quad \to \quad \mathbb{R}^4 \\ (y_1, y_2, y_3, y_4) \quad \mapsto \quad (y_1, y_2 - 1, y_3, y_4 - 1)$$

4 Conclusions

It is possible to think that the singularities in the model (i.e. nongeneric points of (G_0, k^+)) can be studied with the flat affine geometry, which is a local geometry. This geometry can also be used to study quantum fields.

Chiral phenomena could be analyzed by taking left (or right) invariant metrics different to k^+ , as described above.

As in the model (G_0, k^+) , we have two geometries, one local (flat affine) and one global (Lorentzian), linked by a global potential function, it can be conjectured that the model allows the unification of general relativity with quantum mechanics.
