# Some geometric perspectives related to the kappa-model

#### Abstract

Very recently, a straightforward way was proposed in order to understand the galaxy and galactic cluster world without using the very elusive dark matter concept. This way was called $\kappa$-model $[1,2,3,4]$. The main idea is to save the form of the usual physical laws, especially the Newton's laws of motion when gravity is weak, but only by applying a local renormalization procedure for the lengths, distances and velocities. This local renormalization appears as a correspondance principle in the $\kappa$-model. In this model the fundamental physical constants remain universal, i.e. are independent of the point and of time. The $\kappa$-model is Newtonian in essence but a relativistic extension can easily be built. The aim of the present paper is to detail the mathematical formalism supporting it.


Keywords : Galaxy, Galaxy cluster, dark matter, modified gravity, kappa-model.

## 1 Introduction

The classical laws of physics (for instance the Newtonian dynamics) have been defined at the meter scale. This scale goes from the sub-micrometric dimension to the scale of the solar system. However, we know that at the scale of the nanoscopic world these classical laws are no longer valid and the quantum field theory has to be used. Let us note that the ratio between the radius of an atom and the base unit length (meter) is $10^{-10}$. Despite this statement, when we go now in the opposite direction, i.e. the macrocosmos world, the physicists use the same physical laws than those valid at the meter scale, with no changes, whereas the ratio between one meter and one parsec is $10^{-16}$. The $\kappa$-model relies on the very simple suggestion that the matter does no longer behave on the same manner when the characteristic dimension of the region under study is very large (of the order of one parsec or more). The perception of an observer must then necessarily be changed $[1,2,3,4]$. Our aim is also to reduce the modification compared to the Newtonian law at the minimal level. The main idea is that the environment of the observer modifies his perception, a bit like when this one or the observed object are immersed in different media with various refractive indices (even though the analogy can strongly be misleading). Furthermore the lengths and the velocities which are measured by him are differently renormalized following the mean densities surrounding him and the observed object. Let us note that it relates only to apparent effects, the unit of length (for instance the radius of a hydrogen atom) is obviously the same everywhere in the Universe. The renormalization coefficient, labelled $\kappa$, is linked to the local mean density $\rho$ by a simple relationship $\kappa=1 /(1+\operatorname{Ln}(1 / \rho)))$ assuming $\rho<1$ with appropriate normalization $[2,3]$. In section 2 some basic mathematical concepts are recalled, section 3 develops the framework of the $\kappa$-model, in section 4 the $\kappa$-structure for Minkowski space is presented, Eventually in section 5 a few illustrative applications to astrophysics are supplied. A few didactic figures have also been added.

## 2 Some basic structures on $\mathbb{R}^{n}$

### 2.1 Algebraic structures

### 2.1.1 Affine and vectorial structure

When endowed with its usual vector space structure the set $\mathbb{R}^{n}$ of the real $n$-tuples will be noted $\mathbb{R}^{n}$ and when endowed with its affine structure it will be denoted simply by $\mathbb{R}^{n}$. The affine structure being a 1-transitive action of the additive group $\left(\mathbb{R}^{n},+\right)$ on $\mathbb{R}^{n}$ :

When $x+\boldsymbol{u}=y$ we will sometimes write $\boldsymbol{u}=y-x$.

### 2.1.2 Euclidean structures

The vector space $\mathbb{R}^{n}$ is equipped with a Euclidean structure once a scalar product on $\mathbb{R}^{n}$ has been selected. A scalar product is a definite positive bilinear symmetric form, in other words it is an application

linear in each variable, symmetric and satisfying $\forall \boldsymbol{h} \in \mathbb{R}^{n},\langle\boldsymbol{h}, \boldsymbol{h}\rangle \geq 0$, the cancellation hapenning only when $\boldsymbol{h}=\mathbf{0}$.
This means that in some base $\mathcal{B}=\left(\boldsymbol{e}_{1}, \ldots, \boldsymbol{e}_{n}\right)$ of $\mathbb{R}^{n}$ the matrix representing the bilinear form $\langle.,$.$\rangle i.e. the matrix \left(g_{i j}\right)_{1 \leq i, j \leq n}$ where $g_{i j}=\left\langle\boldsymbol{e}_{i}, \boldsymbol{e}_{j}\right\rangle$ is $\operatorname{Id} d_{n}=\operatorname{diag}(1, \ldots, 1)$ which means that $g_{i j}=\delta_{i j}$, the Kronecker symbol.
If $\boldsymbol{h}=h^{i} \boldsymbol{e}_{i}$ and $\boldsymbol{k}=k^{i} \boldsymbol{e}_{i}$ we have then

Such a base of $\mathbb{R}^{n}$ is an orthonormal base (with respect to the particular scalar product considered).
The application

is a norm on $\mathbb{R}^{n}$ in other words it fullfills the conditions:

- Positivity $\left(\forall x \in \mathbb{R}^{n},\|x\| \geq 0\right)$
- Separation $\left(\forall \boldsymbol{x} \in \mathbb{R}^{n},\|\boldsymbol{x}\|=0 \Longleftrightarrow \boldsymbol{x}=\mathbf{0}\right)$
- Homogeneity $\left(\forall x \in \mathbb{R}^{n}, \forall \lambda \in \mathbb{R},\|\lambda \boldsymbol{x}\|=|\lambda|\|x\|\right)$
- Subadditivity $\left(\forall \boldsymbol{x}, \boldsymbol{y} \in \mathbb{R}^{n},\|\boldsymbol{x}+\boldsymbol{y}\| \leq\|\boldsymbol{x}\|+\|\boldsymbol{y}\|\right)$

To a scalar product is also associated a way to measure angles :

are called (vectorial) isometries. The set of vectorial isometries is a sub-group of the linear group $(G L(n), \circ)$ called the orthogonal group and denoted $O(n)^{3}$.
When the vectorial space $\mathbb{R}^{n}$ is equipped with a Euclidean structure, the affine space $\mathbb{R}^{n}$ is endowed with a distance defined by

In other words we have

- Symmetry $\left(\forall x, y \in \mathbb{R}^{n}, d(x, y)=d(y, x)\right)$,
- Separation $\left(\forall x, y \in \mathbb{R}^{n}, d(x, y)=0 \Longleftrightarrow x=y\right)$,
- Triangle inequality $\left(\forall x, y, z \in \mathbb{R}^{n}, d(x, z) \leq d(x, y)+d(y, z)\right)$.

Furthermore this distance will be compatible with the affine structure :

- Invariance by translation :

- Homogeneity :

The affine transformations with linear part in $O(n)$ are the (affine) isometries.

### 2.1.3 Minkowski structure

A structure of Minkowski space on $\mathbb{R}^{4}$ is the choice of some symmetric bilinear form, $\langle\langle.,\rangle$. on $\mathbb{R}^{4}$ with signature $(1,3)$, that means that in some base $\mathcal{B}=\left(e_{0}, e_{1}, e_{2}, e_{3}\right)$ of $\mathbb{R}^{4}$ the matrix associated to $\langle\langle.,\rangle$.$\rangle is J=\operatorname{diag}(1,-1,-1,-1)$. In other words, if $\boldsymbol{h}=h^{i} \boldsymbol{e}_{i}$ and $\boldsymbol{k}=k^{i} \boldsymbol{e}_{i}$ we have then

It is common to refer to vectors of a Minkowski space as "quadrivectors" and to $\langle\langle.,\rangle$.$\rangle as a$ Minkowki product.
According to the sign of $\langle\langle\boldsymbol{h}, \boldsymbol{h}\rangle\rangle$, a quadrivector $\boldsymbol{h}$ is
time-like when $\langle\langle\boldsymbol{h}, \boldsymbol{h}\rangle\rangle>0$.
light-like when $\langle\langle\boldsymbol{h}, \boldsymbol{h}\rangle\rangle=0$, the isotropy cone of $\langle\langle, .\rangle$,$\rangle .$
space-like when $\langle\boldsymbol{h}, \boldsymbol{h}\rangle\rangle<0$.

[^1]The linear transformations $f$ of $\mathbb{R}^{4}$ respecting the Minkowski product $M$ in other words such that

are called Lorentz transformations. The Lorentz transformation is a sub-group of $(G L(4), \circ)$ called the Lorentz group and denoted $\mathcal{L}$, it is straightforward to see that Lorentz transformation $f$ respect quadrivector's types.
When the space $\mathbb{R}^{4}$ is equipped with a Minkowski structure the affine space $\mathbb{R}^{4}$ points are usually called events.
Two events $e=\left(\varepsilon_{0}, \varepsilon_{1}, \varepsilon_{2}, \varepsilon_{3}\right)$ and $e^{\prime}=\left(\varepsilon_{0}^{\prime}, \varepsilon_{1}^{\prime}, \varepsilon_{2}^{\prime}, \varepsilon_{3}^{\prime}\right)$ are time-oriented when the unique quadrivector $\boldsymbol{u}$ such that $E^{\prime}=E+\boldsymbol{u}$ is time-like.

### 2.2 Topological structure of $\mathbb{R}^{n}$

A topology on a set $E$ is a way to give a meaning to expressions like " $x$ and $y$ are close" without having a way to measure a distance between $x$ and $y$.
A standard way to do so is to select for each point $x$ of $E$ a set of parts of $E, N e i g h(x)$, called the set of the neighborhoods of $x$. The sets $\operatorname{Neigh}(x)$ fullfilling the conditions expected for such a notion :
$\dagger$ The set $E$ must contain whatever is "close" to $x: \forall x \in E, E \in \operatorname{Neigh}(x)$.
$\dagger$ The point $x$ is among what is close to $x: \forall x \in E, \forall V \in \operatorname{Neigh}(x), x \in V$.
$\dagger$ If two sets contain whatever is close to $x$ their intersection too :
$\forall x \in E, \forall V, W \in \operatorname{Neigh}(x), V \cap W \in \operatorname{Neigh}(x)$.
$\dagger$ If $V$ contains whatever is close to $x$ and $W$ contains $V, W$ contains whatever is close to $x$ :
$\forall x \in E, \forall V \in \operatorname{Neigh}(x)$, if $V \subset W$ then $W \in \operatorname{Neigh}(x)$
$\dagger$ If $V$ contains whatever is close to $x$ then there exists $W$, containing also whatever is close to $x$, and such that $V$ contain whatever is close to whatever points in $W$ :
$\forall x \in E, \forall V \in \operatorname{Neigh}(x), \exists W \in \operatorname{Neigh}(x) / \forall y \in W, V \in \operatorname{Neigh}(y)$
Once a topology on $E$ has been chosen an open set of $E$ is a part $O$ of $E$ such that $\forall x \in$ $O, O \in \operatorname{Neigh}(x)$.

Different topologies can be defined on $\mathbb{R}^{n}$, the usual one is defined using the distance $d$ defined in (5). The set $B\left(x, r\left[=\left\{y \in \mathbb{R}^{n} / d(x, y)<r\right\}\right.\right.$ is the open ball with center at $x \in \mathbb{R}^{n}$ and radius $r$. A neighborhood of $x$ is any subset of $\mathbb{R}^{n}$ containing an open ball centered at $x$. We will also use this topology on $\mathbb{R}^{4}$ when equipped with its Minkowski affine structure even though in that case there is no distance directly linked to the topologic stucture.

The notion of topology allows correct definition of some very usefull "local" notions in particular the notion of continuity at a point for a function $f: E \rightarrow F$ between two topological spaces and $x \in E, f$ is continuous at $x$ when $\forall W \in \operatorname{Neigh}(f(x)), \exists V \in \operatorname{Neigh}(x) / f(V) \subset W$. The affine orthogonal transformations (and the affine Lorentz transformations) are continuous on $\mathbb{R}^{n}$ (and on $\mathbb{R}^{4}$ )
In the Minkowsi space the set of light-like quadrivectors has two path connected components. $\mathbf{4}_{4}^{4}$.

[^2]A Lorentz transformation is orthochrone when the path connected components are respected, and antichrone when the components are exchanged.

### 2.3 Differentiable structure of $\mathbb{R}^{n}$

$\mathbb{R}^{n}$ being equipped with a scalar product and the associated norm defined in (2) and $\mathbb{R}^{n}$ with the distance defined in (5).

### 2.3.1 Differential of a function, tangent vectors at a point

An application $f: \mathbb{R}^{n} \rightarrow \mathbb{R}^{p}$ is differentiable at $x \in \mathbb{R}^{n}$ whenever

where $d f /{ }_{x}$ is continuous and linear from $\mathbb{R}^{n}$ to $\mathbb{R}^{p}{ }^{5}$ and $o(\boldsymbol{h})=\|\boldsymbol{h}\| \varepsilon(\boldsymbol{h})$ with $\varepsilon: \mathbb{R}^{n} \rightarrow \mathbb{R}^{p}$ such that $\varepsilon(\mathbf{0})=\mathbf{0}$ and $\lim _{\boldsymbol{h} \rightarrow \mathbf{0}} \varepsilon(\boldsymbol{h})=\mathbf{0}$.
The linear application

is the differential at $x$ of $f$.
The application

is the differential of $f$.
At first glance, the definition of the differentiability of $f$ at a point $x$, suggests that the vectors $\boldsymbol{h}$ are picked in the "same" space $\mathbb{R}^{n}$ independantly of the point $x$ we are looking at, but this point of view would be baren if we want to go further.
To each point $x \in \mathbb{R}^{n}$ is associated a copy of $\mathbb{R}^{n}$, called the tangent space to $\mathbb{R}^{n}$ at $x$ and denoted $\mathbf{T}_{x} \mathbb{R}^{n}$, its elements are called tangent vectors to $\mathbb{R}^{n}$ at $x$.
With those definitions in mind, the definition of differentiability becomes

where $d f /_{x}: \mathbf{T}_{x} \mathbb{R}^{n} \rightarrow \mathbf{T}_{f(x)} \mathbb{R}^{p}$ is linear and $o(\boldsymbol{h})=\|\boldsymbol{h}\| \varepsilon(\boldsymbol{h})$ with $\varepsilon: \mathbf{T}_{x} \mathbb{R}^{n} \rightarrow \mathbf{T}_{f(x)} \mathbb{R}^{p}$ satisfying $\varepsilon(\mathbf{0})=\mathbf{0}$ and $\lim _{\boldsymbol{h} \rightarrow \mathbf{0}} \varepsilon(\boldsymbol{h})=\mathbf{0}$.
We have to clarify the status of the differential application $d f: x \mapsto d f / x$, for its arrival set had became unclear.
Let

[^3]The set $\mathbf{T} \mathbb{R}^{n}$ is the tangent space of $\mathbb{R}^{n}$, it identifies to $\mathbb{R}^{n} \times \mathbb{R}^{n}$ and then the projection $p$ becomes the first projection of $\mathbb{R}^{n} \times \mathbb{R}^{n}$ on $\mathbb{R}^{n}$. The tangent space $\mathbf{T} \mathbb{R}^{n}$ identifies also with the affine space $\mathbb{R}^{2 n}$.
Now let $f: \mathbb{R}^{n} \rightarrow \mathbb{R}^{p}$ be an application differentiable at each point of $\mathbb{R}^{n}$, the application

is called the tangent application or differential application of $f$.
Furthermore the projection

is a (trivial) "fiber bundle", in that very simple case it just means that $p$ is differentiable on $T \mathbb{R}^{n}$.
The bitangent space to $\mathbb{R}^{n}$ at $(x, \boldsymbol{h}), \mathbf{T}_{(x, \boldsymbol{h})}\left(\mathbf{T} \mathbb{R}^{n}\right)$ identifies with the product vector space $\mathbf{T}_{x} \mathbb{R}^{n} \times \mathbf{T}_{h} \mathbb{R}^{n}$ then

The process of differentiation can be repeted indefinitelly, applications admitting differential at all orders are said of class $\mathcal{C}^{\infty}$, the set of functions from $\mathbb{R}^{n}$ to $\mathbb{R}$ of class $\mathcal{C}^{\infty}$ is denoted $\mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right)$.

### 2.3.2 Tangent vector fields on $\mathbb{R}^{n}$

A vector field $\mathcal{U}$ on $\mathbb{R}^{n}$ is a section of the tangent fiber bundle i.e. an application

As the first factor of a tangent vector fields is always known, in the sequels, we will note the tangent vector field $\mathcal{U}$ by its second factor $U$.
Let $\left(\boldsymbol{e}_{1}, \ldots, \boldsymbol{e}_{n}\right)$ the canonical base of $\mathbb{R}^{n}$ the tangent vector field $x \mapsto\left(x, \boldsymbol{e}_{i}\right)$ will be denoted $\frac{\partial}{\partial x^{i}}$ so that any tangent vector field on $\mathbb{R}^{n}$ has a unique expression

\forall U \in \Gamma\left(\mathbb{R}^{n}\right), \forall \lambda \in \mathbb{R}, \forall x \in \mathbb{R}^{n},(\lambda U)(x)=\lambda \boldsymbol{U}(x)
$$

- Multiplication by a function defined by

\forall(f, \boldsymbol{U}) \in \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right) \times \Gamma\left(\mathbb{R}^{n}\right), \forall x \in \mathbb{R}^{n},(f \boldsymbol{U})(x)=f(x) \boldsymbol{U}(x)
$$

A derivation on the real algebra $\mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right)$ is a linear application

$$
D: \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right) \rightarrow \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right)
$$

satisfying

$$
\forall f, g \in \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right), D(f g)=D(f) g+f D(g)
$$

To $U \in \Gamma\left(\mathbb{R}^{n}\right)$ correspond a derivation $D_{U}$ on $\mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right)$ where $\forall f \in \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right)$,
$D_{U}(f): \mathbb{R}^{n} \rightarrow \mathbb{R} ; x \mapsto d f /_{x}(\boldsymbol{U}(x))$
Indeed we have

\forall f, g \in \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right), D_{U}(f g)=D_{U}(f) \cdot g+f D_{U}(g) \tag{10}

$D_{U}(f)(x)$ can be seen as the directional derivative of $f$ in the direction of $\boldsymbol{U}$ at $x$. The notations $\frac{\partial}{\partial x^{i}}$ introduced previously for a tangent vector field are now clear : If the expression of a tangent vector field is $\boldsymbol{U}=U^{i}(x) \frac{\partial}{\partial \boldsymbol{x}^{i}}$ and $f \in \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right)$ for $x \in \mathbb{R}^{n}:$

The Lie bracket of two tangent vector fields $U=U^{i} \frac{\partial}{\partial x^{i}}$ and $V=V^{i} \frac{\partial}{\partial x^{i}}$ is defined by

[\boldsymbol{U}, \boldsymbol{V}]=\left(U^{j} \frac{\partial V^{i}}{\partial \boldsymbol{x}^{j}}-V^{j} \frac{\partial U^{i}}{\partial \boldsymbol{x}^{j}}\right) \frac{\partial}{\partial \boldsymbol{x}^{i}} \tag{13}
\end{equation*}
$$

we have

D_{[U, V]}=D_{U} \circ D_{V}-D_{V} \circ D_{U} \tag{14}
\end{equation*}
$$

Endowed with this bracket the vector space $\Gamma\left(\mathbb{R}^{n}\right)$ is a Lie algebra.

### 2.3.3 Covariant derivation

A covariant derivation on $\mathbb{R}^{n}$ is an application

\nabla: \Gamma\left(\mathbb{R}^{n}\right) \times \Gamma\left(\mathbb{R}^{n}\right) \rightarrow \Gamma\left(\mathbb{R}^{n}\right) ;(\boldsymbol{U}, V) \mapsto \nabla_{\boldsymbol{U}} V
$$

satisfying

\begin{gather*}
\forall a, b \in \mathbb{R}, \forall \boldsymbol{U}, \boldsymbol{V}, \boldsymbol{W} \in \boldsymbol{\Gamma}\left(\mathbb{R}^{n}\right), \forall f \in \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right) \\
\nabla_{a \boldsymbol{U}+b \boldsymbol{V}} \boldsymbol{W}=a \nabla_{\boldsymbol{U}} \boldsymbol{W}+b \nabla_{\boldsymbol{V}} \boldsymbol{W}  \tag{15}\\
\nabla_{\boldsymbol{U}}(a \boldsymbol{V}+b \boldsymbol{W})=a \nabla_{\boldsymbol{U}} \boldsymbol{V}+b \nabla_{\boldsymbol{U}} \boldsymbol{W}  \tag{16}\\
\nabla_{f \boldsymbol{U}} \boldsymbol{V}=f \nabla_{\boldsymbol{U}} \boldsymbol{V} \text { and } \nabla_{\boldsymbol{U}}(f \boldsymbol{V})=D_{\boldsymbol{U}}(f) \boldsymbol{V}+f \nabla_{\boldsymbol{U}} \boldsymbol{V} . \tag{17}

A covariant derivation, $\nabla$, on $\mathbb{R}^{n}$ is entirely defined by the family of tangent vector fields $\left(\nabla_{\frac{\partial}{\partial \boldsymbol{x}^{i}}} \frac{\partial}{\partial \boldsymbol{x}^{j}}\right)_{i, j=1 \ldots n}$. If

\nabla_{\frac{\partial}{\partial \boldsymbol{x}^{i}}} \frac{\partial}{\partial \boldsymbol{x}^{j}}=\Gamma_{i, j}^{k} \frac{\partial}{\partial \boldsymbol{x}^{k}} \tag{18}
\end{equation*}
$$

the functions $\Gamma_{i j}^{k}$ are called Christoffel symbols of $\nabla$.
For $\boldsymbol{U}=U^{i} \frac{\partial}{\partial \boldsymbol{x}^{i}}$ and $\boldsymbol{V}=V^{i} \frac{\partial}{\partial \boldsymbol{x}^{i}}$ we have

\nabla_{\boldsymbol{U}} \boldsymbol{V}=U^{i} \frac{\partial V^{j}}{\partial \boldsymbol{x}^{i}} \frac{\partial}{\partial \boldsymbol{x}^{j}}+U^{i} V^{j} \Gamma_{i j}^{k} \frac{\partial}{\partial \boldsymbol{x}^{k}} \tag{19}
\end{equation*}

### 2.3.4 Flat covariant derivation

The flat covariant derivation $\nabla$ is the covariant derivation whose Christoffel symbols are all null, in that case we have

\nabla_{\boldsymbol{U}} V=\sum_{i, j=1}^{n} U^{i} \frac{\partial V^{j}}{\partial \boldsymbol{x}^{i}} \frac{\partial}{\partial \boldsymbol{x}^{j}}

$\nabla_{U} \boldsymbol{V}$ can be seen as the derivative of $\boldsymbol{V}$ in the direction of $\boldsymbol{U}$.

### 2.3.5 Covariant derivation along a curve, parallel transport

Let

$$
\gamma: \mathbb{R} \rightarrow \mathbb{R}^{n} ; t \mapsto \gamma(t)=\left(\gamma_{1}(t), \ldots, \gamma_{n}(t)\right)
$$

a class $\mathcal{C}^{\infty}$ function.
A tangent vector field of $\mathbb{R}^{n}$ along $\gamma$ is an application

$$
\mathcal{U}: \mathbb{R} \rightarrow \mathbb{T}^{n}
$$

such that

$$
\forall t \in \mathbb{R}, \quad \mathcal{U}(t)=(\gamma(t), \boldsymbol{U}(t)) \in \mathbf{T}_{\gamma(t)} \mathbb{R}^{n}
$$

The set of tangent vector fields of class $\mathcal{C}^{\infty}$ along $\gamma$ is denoted $\Gamma(\gamma)$, it is a $\mathcal{C}^{\infty}(\mathbb{R})$-modulus. The velocity $\dot{\gamma}$ is the tangent vector field along $\gamma$ defined by

$$
\begin{equation*}
t \mapsto \dot{\gamma}(t)=\left(\gamma(t), \dot{\gamma}^{i}(t) \frac{\partial}{\partial \boldsymbol{x}^{i}}\right) \tag{20}
\end{equation*}
$$

Where $\dot{\gamma}^{i}=\frac{d \gamma^{i}}{d t}$. Its value depends only on the differential structure of $\mathbb{R}^{n}$ and $\forall t \in$ $\mathbb{R}, \forall h \in \mathbb{R}, d \gamma / t(h)=h . \dot{\gamma}(t)$.

Let $\nabla$ be a covariant derivation on $\mathbb{R}^{n}$. There is exactly one operator $\nabla_{d}^{d}{ }^{6}{ }^{6}$ on the vector space of tangent vector fields along $\gamma$ such that

$$
\forall f \in \mathcal{C}^{\infty}(I), \forall \boldsymbol{U} \in \Gamma(\gamma), \nabla_{\frac{d}{d t}}(f \cdot \boldsymbol{U})(t)=f^{\prime}(t) \cdot \boldsymbol{U}(t)+f(t) . \nabla_{\frac{d}{d t}} \boldsymbol{U}(t)
$$

and if $\boldsymbol{U}$ is the restriction to $\gamma$ of a tangent vector field $V$ on $\mathbb{R}^{n}$

\nabla_{\frac{d}{d t}} \boldsymbol{U}(t)=\nabla_{\dot{\boldsymbol{\gamma}}(t)} \boldsymbol{V}(t)
$$

For $\boldsymbol{U}(t)=U^{i}(t) \frac{\partial}{\partial x^{i}}$ we have

\begin{equation*}
\nabla_{\frac{d}{d t}} \boldsymbol{U}(t)=\left(\dot{U}^{k}(t)+\Gamma_{i j}^{k} U^{i}(t) U^{j}(t)\right) \frac{\partial}{\partial \boldsymbol{x}^{k}} \tag{21}
\end{equation*}
$$

When $\mathbb{R}^{n}$ is equipped with the flat covariant derivative $]$, the covariant derivative of $\mathcal{U}$ with $\mathcal{U}(t)=\left(\gamma(t), U^{i}(t) \frac{\partial}{\partial \boldsymbol{x}^{i}}\right)$ along $\gamma$ is the tangent vector field along $\gamma$ defined by

$$
\begin{equation*}
\nabla_{\frac{d}{d t}} \boldsymbol{U}(t)=\left(\gamma(t), \dot{U}^{i}(t) \frac{\partial}{\partial \boldsymbol{x}^{i}}\right) \tag{22}
\end{equation*}
$$

A tangent vector field $\boldsymbol{U}$ along $\gamma$ is said parallel with respect to the covariant derivation $\nabla$ whenever $\nabla_{\frac{d}{d t}} \boldsymbol{U}=0$. General results on differential equations insure that a parallel tangent vector field along $\gamma$ is determined by its value at one point of the trajectory of $\gamma$. For $t_{0}, t_{1} \in \mathbb{R}$ the application

$$
/ /_{t_{0}}^{t_{1}}: T_{\gamma\left(t_{0}\right)} \mathbb{R}^{n} \rightarrow T_{\gamma\left(t_{1}\right)} \mathbb{R}^{n} ;\left(\gamma\left(t_{0}\right), \boldsymbol{U}\left(\gamma\left(t_{0}\right)\right) \mapsto\left(\gamma\left(t_{1}\right), \boldsymbol{U}\left(\gamma\left(t_{1}\right)\right)\right.\right.
$$

where $\boldsymbol{U}$ is parallel along $\gamma$ is called the parallel transport along $\gamma$ between time $t_{0}$ and $t_{1}$. When $\nabla$ is the flat covariant derivation for any class $\mathcal{C}^{\infty}$ curve $\gamma$ the parallel vector fields along $\gamma$ are simply the constant vector fields.

### 2.3.6 Acceleration

Let $\gamma: \mathbb{R} \rightarrow \mathbb{R}^{n}$ a class $\mathcal{C}^{\infty}$ function.
The covariant derivative of the vector field $\dot{\gamma}$ along $\gamma$ is the covariant acceleration of $\gamma$ it is denoted $\ddot{\gamma}$, note that unlike the velocity $\ddot{\gamma}$ depends on the choice of a covariant derivation on $\mathbb{R}^{n}$.
When a curve $\gamma$ satisfies $\nabla_{\frac{d}{d t}} \dot{\gamma}=0$ it is called a geodesic curve of the covariant derivation $\nabla$, for the flat covariant derivation the geodesics are the parametrizations with constant velocity of straight lines.

### 2.4 Riemannian structures on $\mathbb{R}^{n}$

A Riemannian metric on $\mathbb{R}^{n}$ is an application $G$ associating to each point $x \in \mathbb{R}^{n}$ a scalar product $G_{x}$ on $\mathbf{T}_{x} \mathbb{R}^{n}$ with the condition that

$$
\forall \boldsymbol{U}, \boldsymbol{V} \in \Gamma\left(\mathbb{R}^{n}\right), f: \mathbb{R}^{n} \rightarrow \mathbb{R} ; x \mapsto f(x)=G_{x}(\boldsymbol{U}(x), \boldsymbol{V}(x))
$$

is differentiable of class $\mathcal{C}^{\infty}$.
The general expression of a Riemannian metric on $\mathbb{R}^{n}$ is

$$
\begin{equation*}
G_{x}=g_{i j}(x) d x^{i} d x^{j} \tag{23}
\end{equation*}
$$

Where the coefficients $g_{i j}(x) \in \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right)$ are such that $\forall x \in \mathbb{R}^{n}$, the matrix $\left(g_{i, j}(x)\right)_{1 \leq i, j \leq n}$ is symmetric definite positive and $d x^{i}$ is defined on $\Gamma\left(\mathbb{R}^{n}\right)$ by $d x^{i}\left(U^{j} \frac{\partial}{\partial x^{j}}\right)=U^{i}$.
For a Riemannian metric $G$ and $\gamma: I \rightarrow \mathbb{R}^{n}$ a class $\mathcal{C}^{\infty}$ application, the real

$$
\begin{equation*}
\|\dot{\gamma}(t)\|_{G}=\sqrt{G_{\gamma(t)}(\dot{\gamma}(t), \dot{\gamma}(t))} \tag{24}
\end{equation*}
$$

is the speed of $\gamma$ at instant $t$ with respect to the Riemannian metric $G$ or $G$-speed, the application

$$
t \mapsto\left(\gamma(t),\|\dot{\gamma}(t)\|_{G}\right)
$$

is a scalar field along $\gamma$.
The $G$-length of $\gamma$ is

$$
\begin{equation*}
L_{G}(\gamma)=\int_{a}^{b}\|\dot{\gamma}(t)\|_{G} d t \tag{25}
\end{equation*}
$$

The $G$-kinetic energy of $\gamma$ is

$$
\begin{equation*}
E_{G}(\gamma)=\frac{1}{2} \int_{a}^{b}\|\dot{\gamma}(t)\|_{G}^{2} d t \tag{26}
\end{equation*}
$$

The $G$-length does not depend on the parametrization $\gamma$ but the $G$-kinetic energy does. We obtain a distance on $\mathbb{R}^{n}$ setting for $x, y \in \mathbb{R}^{n}$

$$
d_{G}(x, y)=\operatorname{Inf}\left\{L_{G}(\gamma), \gamma \text { differentiable with } \gamma(a)=x, \gamma(b)=y\right\}
$$

Though $d_{G}$ is in general not associated to any norm on $\mathbb{R}^{n}$, the topology of $\mathbb{R}^{n}$ induced by $d_{G}$ is always the usual topology of $\mathbb{R}^{n}$.
For $\boldsymbol{u}, \boldsymbol{v} \in T_{x} \mathbb{R}^{n}$ the $G$-angle, $\theta_{G}(\boldsymbol{u}, \boldsymbol{v})$ ), of $\boldsymbol{u}$ and $\boldsymbol{v}$ is defined by

$$
\begin{equation*}
G(\boldsymbol{u}, \boldsymbol{v})=\|\boldsymbol{u}\|_{G}\|\boldsymbol{v}\|_{G} \cos \left(\theta_{G}(\boldsymbol{u}, \boldsymbol{v})\right) . \tag{27}
\end{equation*}
$$

### 2.4.1 Levi-Civita connection

Let $G$ be a Riemannian metric on $\mathbb{R}^{n}$, a covariant derivation $\nabla$ on $\mathbb{R}^{n}$ is compatible with $G$ when

$$
\begin{equation*}
\forall \boldsymbol{U}, \boldsymbol{V}, \boldsymbol{W} \in \Gamma\left(\mathbb{R}^{n}\right), D_{\boldsymbol{U}}(G(\boldsymbol{V}, \boldsymbol{W}))=G\left(\nabla_{\boldsymbol{U}} \boldsymbol{V}, \boldsymbol{W}\right)+G\left(\boldsymbol{V}, \nabla_{\boldsymbol{U}} \boldsymbol{W}\right) \tag{28}
\end{equation*}
$$

For any Riemannian metric $G$ on $\mathbb{R}^{n}$ there is exactly one torsion-free 8 covariant derivation compatible with $G$ called the Levi-Civita connection of $G$.

[^5]The Christoffel symbols of the Levi-Civita connection have expressions

$$
\begin{equation*}
\Gamma_{i j}^{k}=\frac{1}{2} g^{k \ell}\left(\frac{\partial g_{i \ell}}{\partial \boldsymbol{x}^{j}}+\frac{\partial g_{j \ell}}{\partial \boldsymbol{x}^{i}}-\frac{\partial g_{i j}}{\partial \boldsymbol{x}^{\ell}}\right) \tag{29}
\end{equation*}
$$

where $\left(g^{i j}\right)_{1 \leq i, j \leq n}$ is the inverse matrix of $\left(g_{i j}\right)_{1 \leq i, j \leq n}$.

### 2.4.2 Some Riemannian metrics

1) The usual affine Euclidean structure of $\mathbb{R}^{n}$ can be seen as a Riemannian structure on $\mathbb{R}^{n}$ :

$$
\begin{equation*}
G^{E u c}=\delta_{i j} d x^{i} d x^{j} \tag{30}
\end{equation*}
$$

When $\mathbb{R}^{n}$ is equipped with the metric $G^{E u c}$ the Levi-Civita connection is the flat covariant derivation $\nabla$ defined previously. The distance $d_{G E u c}$ is the usual Euclidean distance and the angle measurement is the usual angle measurement. The geodesics are parametrizations of straightlines with constant velocities.
2) For $\lambda \in \mathbb{R}_{+}^{*}$ we put

$$
\begin{equation*}
G_{\lambda}^{E u c}=\lambda^{2} G^{E u c}=\lambda^{2} \delta_{i j} d x^{i} d x^{j} \tag{31}
\end{equation*}
$$

The Levi-Civita connection of $G_{\lambda}^{E u c}$ is also the flat covariant derivation.
The distance associated is

$$
\begin{equation*}
d_{G_{\lambda}^{E u c}}=\lambda d_{G^{E u c}} . \tag{32}
\end{equation*}
$$

The angles measurement associated satisfies

$$
\begin{equation*}
\forall x \in \mathbb{R}^{n}, \forall \boldsymbol{u}, \boldsymbol{v} \in T_{x} \mathbb{R}^{n}, \theta_{G_{\lambda}^{E u c}}(\boldsymbol{u}, \boldsymbol{v})=\theta_{G^{E u c}}(\boldsymbol{u}, \boldsymbol{v}) . \tag{33}
\end{equation*}
$$

The application $I d_{\mathbb{R}^{n}}$ from $\left(\mathbb{R}^{n}, G^{E u c}\right)$ to $\left(\mathbb{R}^{n}, G_{\lambda}^{E u c}\right)$ is a scaling.
The geodesics are straightlines parametrized with constant velocities.
For $G^{E u c}$ as well as for $G_{\lambda}^{E u c}$ the parallel transport is trivial, the parallel tangent vector fields are of the form $\boldsymbol{U}=\sum_{i=1}^{n} u^{i} \frac{\partial}{\partial \boldsymbol{x}_{i}}$ where $u^{i}$ are constants.
3) For $\mu \in \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right)$ such that $\left.\forall x \in \mathbb{R}^{n}, \mu(x) \in\right] m, M[,(m>0)$ we put

$$
\begin{equation*}
G_{\mu}=\mu^{2} \delta_{i j} d x^{i} d x^{j} \tag{34}
\end{equation*}
$$

The Levi-Civita connection is not anymore the flat covariant derivation, a straightforward computation gives the expressions of the Christoffel symbols

$$
\begin{equation*}
\Gamma_{i j}^{k}=\frac{1}{\mu} \delta^{k l}\left(\delta_{i l} \frac{\partial \mu}{\partial x^{j}}+\delta_{l j} \frac{\partial \mu}{\partial x^{i}}-\delta_{i j} \frac{\partial \mu}{\partial x^{m}}\right) \tag{35}
\end{equation*}
$$

The geodesics are not anymore straightlines. The application $I d_{\mathbb{R}^{n}}$ from $\left(\mathbb{R}^{n}, G^{E u c}\right)$ to $\left(\mathbb{R}^{n}, G_{\mu}\right)$ is conformal.

### 2.5 Pseudo-Riemannian structure on $\mathbb{R}^{4}$

A pseudo-Riemannian metric on $\mathbb{R}^{4}$ is an application $G$ associating to each point $x \in \mathbb{R}^{4}$ a Minkowski product $G_{x}$ on $T_{x} \mathbb{R}^{4}$ with the condition that

$$
\forall \boldsymbol{U}, \boldsymbol{V} \in \Gamma\left(\mathbb{R}^{4}\right), F: \mathbb{R}^{4} \rightarrow \mathbb{R} ; x \mapsto G_{x}(\boldsymbol{U}(x), \boldsymbol{V}(x))
$$

is differentiable of class $\mathcal{C}^{\infty}$.
The general expression of a pseudo-Riemannian metric on $\mathbb{R}^{4}$ is

$$
\begin{equation*}
G_{x}=g_{i j}(x) d x^{i} d x^{j} \tag{36}
\end{equation*}
$$

where the coefficients $g_{i j} \in \mathcal{C}^{\infty}\left(\mathbb{R}^{n}\right)$ are such that $\forall x \in \mathbb{R}^{4}$, the matrix $\left(g_{i j}(x)\right)$ is symmetric with signature $(1,3)$.
Let $\eta_{i j}$ be the coefficient of the matrix $\operatorname{diag}(1,-1,-1,-1)$. The usual affine Minkowski structure of $\mathbb{R}^{4}$ is a pseudo-Riemannian structure :

$$
\begin{equation*}
G^{M i n k}=\eta_{i j} d x^{i} \cdot d x^{j} \tag{37}
\end{equation*}
$$

It will be practical to limit the summation to $i \in\{1,2,3\}$. With this convention we have

$$
\begin{equation*}
G^{M i n k}=d x^{0} d x^{0}-\delta_{i j} d x^{i} \cdot d x^{j} \tag{38}
\end{equation*}
$$

As in the Riemannian case, for any pseudo-Riemannian structure on $\mathbb{R}^{4}$ the Levi-Civita connection is the unique torsion-free covariant derivation satisfying

$$
\begin{equation*}
\forall \boldsymbol{U}, \boldsymbol{V}, \boldsymbol{W} \in \Gamma\left(\mathbb{R}^{4}\right), D_{\boldsymbol{U}}(G(\boldsymbol{V}, \boldsymbol{W}))=G\left(\nabla_{\boldsymbol{U}} \boldsymbol{V}, \boldsymbol{W}\right)+G\left(\boldsymbol{V}, \nabla_{\boldsymbol{U}} \boldsymbol{W}\right) \tag{39}
\end{equation*}
$$

The Levi-Civita connection of $G^{M i n k}$ is once again the flat covariant derivation.
For $\lambda>0$ we will consider later the pseudo-Riemannian metric defined by

$$
\begin{equation*}
G_{\lambda}^{M i n k}=d x^{0} d x^{0}-\lambda^{2} \delta_{i j} d x^{i} d x^{j} \tag{40}
\end{equation*}
$$

For this pseudo-Riemannian metric the Levi-Civita connection is still the flat covariant derivation.

## 3 Framework for the $\kappa$-model

## $3.1 \kappa$-structure on a Riemannian metric

A $\kappa$-structure on $\mathbb{R}^{3}$ or a Riemannian metric affected with a $\kappa$-effect is a couple $(G, \kappa)$ where
$\dagger G=g_{i j} d x^{i} d x^{j}$ is a fixed Riemannian metric on $\mathbb{R}^{3}$.
$\dagger \kappa$ is an application of class $\mathcal{C}^{\infty}$ from $\mathbb{R}^{3}$ to $] m, M[$ with $m>0$.
Then, when $(G, \kappa)$ is a $\kappa$-structure on $\mathbb{R}^{3}$ we have :

1) On one hand two Riemannian metrics on $\mathbb{R}^{3}$ :

$$
\left(\mathbb{R}^{3}, G\right) \text { and }\left(\mathbb{R}^{3}, G_{\kappa}\right)
$$

where $G_{\kappa}=\kappa^{2} g_{i j} d x^{i} d x^{j}$ is a metric conformal to $G$
2) On the other hand to each point $a \in \mathbb{R}^{3}$ is associated the Riemannian metric $\left(\mathbb{R}^{3}, G_{\kappa(a)}\right)$ which is a rescaling of $G$.
A point in $\mathbb{R}^{3}$ endowed with a $\kappa$-structure will be called a sitting-observer.
We can think of this situation as the trivial bundle $\left.\mathbb{R}^{3} \times\right] m, M\left[\rightarrow \mathbb{R}^{3}\right.$ where each constant section $\mathbb{R}^{3} \times\{\lambda\}$ is equipped with the Riemannian metric $G_{\lambda}$, the function $\kappa$ associating to each point $a$ of $\mathbb{R}^{3}$ the constant section $\mathbb{R}^{3} \times\{\kappa(a)\}$.

## $3.2 k$-structure on the Euclidean metric

Let us equip $\mathbb{R}^{3}$ with a $\kappa$-structure ( $G^{E u c}, \kappa$ ), and choose once and for all a global system of coordinates $\left(\sigma^{1}, \sigma^{2}, \sigma^{3}\right)$ such that $G^{E u c}=\delta i j d \sigma^{i} d \sigma^{j}$. The distance associated is the Euclidean distance, $d_{E u c}$.
Each sitting-observer $a \in \mathbb{R}^{3}$ is equipped via $\kappa$ with the flat Riemannian metric $G_{\kappa(a)}^{E u c}$ defined by

$$
\begin{equation*}
\forall a \in \mathbb{R}^{3}, \forall \sigma \in \mathbb{R}^{3}, \forall \boldsymbol{u}, \boldsymbol{v} \in T_{\sigma} \mathbb{R}^{3}, G_{\kappa(a)}(\boldsymbol{u}, \boldsymbol{v})=\kappa^{2}(a)\langle\boldsymbol{u}, \boldsymbol{v}\rangle \tag{41}
\end{equation*}
$$

from which a distance on $\mathbb{R}^{3}$ is deduced :

$$
\begin{equation*}
d_{a}(x, y)=\kappa(a) d_{e}(x, y) \tag{42}
\end{equation*}
$$

However there should be no confusion between the collection of flat Riemannian metrics $G_{\kappa(a)}^{E u c}=\kappa^{2}(a) \sum\left(d \sigma^{i}\right)^{2}$ which are rescalings of $\left(\mathbb{R}^{3}, G^{E u c}\right)$ and the non-flat Riemannian metric $G_{\kappa}=\kappa^{2} \sum\left(d \sigma^{i}\right)^{2}$.


Fig 2: Circles with same radii and centers

$$
\text { in } \mathbb{R}_{\mu}^{3}, \mathbb{R}_{\nu}^{3} \text { and } \mathbb{R}_{\lambda}^{3} \text { with } \lambda>\mu>\nu
$$

Any information retrieved using the flat Riemannian metric $G_{\kappa(a)}^{E u c}$ on $\mathbb{R}^{3}$ will be called an observation made by a sitting-observer at $a$.

The application $I d:\left(\mathbb{R}^{3}, d_{a}\right) \rightarrow\left(\mathbb{R}^{3}, d_{b}\right)$ is not an isometry but it is nevertheless a scaling. Observations made by two sitting observers are linked, for example

$$
\begin{equation*}
\forall a, b \in \mathbb{R}^{3}, \forall \sigma, \sigma^{\prime} \in \mathbb{R}^{3}, d_{a}\left(\sigma, \sigma^{\prime}\right)=\frac{\kappa(a)}{\kappa(b)} d_{b}\left(\sigma, \sigma^{\prime}\right) \tag{43}
\end{equation*}
$$

while

$$
\begin{equation*}
\forall a, b \in \mathbb{R}^{3}, \forall \sigma \in \mathbb{R}^{3}, \forall \boldsymbol{u}, \boldsymbol{v} \in T_{\sigma} \mathbb{R}^{3}, \theta_{a}(\boldsymbol{u}, \boldsymbol{v})=\theta_{b}(\boldsymbol{u}, \boldsymbol{v}) \tag{44}
\end{equation*}
$$

This means that two sitting-observers will agree on angles measurements but not on length measurements. If they exchange their measurements two sitting-observers would desagree.

### 3.2.1 Speed fields

Let $\gamma: \mathbb{R} \rightarrow \mathbb{R}^{3}$ a smooth curve, $t \mapsto \dot{\gamma}(t)$ its velocity, its Euclidean-speed is the scalar field along $\gamma$

$$
\begin{equation*}
v_{E u c}(t)=\|\dot{\gamma}(t)\|_{G^{E u c}} . \tag{45}
\end{equation*}
$$

The speed measured by a sitting-observer at $a$, the $a$-speed of $\gamma$, is the scalar field along $\gamma$ defined by

$$
\begin{equation*}
v_{a}(t)=\|\dot{\gamma}(t)\|_{G_{\kappa(a)}^{E u c}}=\sqrt{\kappa^{2}(a)\langle\dot{\gamma}(t), \dot{\gamma}(t)\rangle}=\kappa(a) v_{E u c}(t) \tag{46}
\end{equation*}
$$

The a-velocity of $\gamma$ is the tangent vector field along $\gamma$ defined by

$$
\begin{equation*}
\boldsymbol{v}_{a}(t)=\kappa(a) \dot{\boldsymbol{\gamma}}(t) \tag{47}
\end{equation*}
$$

so that the $a$-speed at time $t$ is $\left\|\boldsymbol{v}_{a}(t)\right\|_{G^{E u c}}$.
The $\kappa$-speed of $\gamma$ at time $t$ is the speed measured by the sitting-observers coincident with $\gamma(t)$.

$$
\begin{equation*}
v_{\kappa}(t)=\|\dot{\gamma}(t)\|_{G_{\kappa(\gamma(t))}^{E u c}}=\sqrt{\kappa^{2}(\gamma(t))\langle\dot{\gamma}(t), \dot{\gamma}(t)\rangle}=\kappa(\gamma(t)) v_{E u c}(t) \tag{48}
\end{equation*}
$$

The $\kappa$-velocity of $\gamma$ is the tangent vector field along $\gamma$ defined by

$$
\begin{equation*}
\boldsymbol{v}_{\kappa}(t)=\kappa(\gamma(t)) \dot{\gamma}(t) \tag{49}
\end{equation*}
$$

so that the $\kappa$-speed at time $t$ is $\left\|\dot{\boldsymbol{v}}_{\kappa}(t)\right\|_{G^{E u c}}$.
The relations between the different speeds is

$$
\begin{equation*}
\forall a, b \in \mathbb{R}^{3}, v_{a}(t)=\frac{\kappa(a)}{\kappa(b)} v_{b}(t) \tag{50}
\end{equation*}
$$

and

$$
\begin{equation*}
\forall a \in \mathbb{R}^{3}, v_{\kappa}(t)=\frac{\kappa(\gamma(t))}{\kappa(a)} v_{a}(t) \tag{51}
\end{equation*}
$$

A smooth curve $\gamma: \mathbb{R} \rightarrow \mathbb{R}^{3}$ is $\kappa$-uniform when its $\kappa$-speed is constant, in other words when

$$
\begin{equation*}
d \kappa /_{\gamma(t)}(\dot{\gamma}(t))\|\dot{\gamma}(t)\|+\kappa(\gamma(t)) \frac{<\ddot{\gamma}(t), \dot{\gamma}(t)>}{\|\dot{\gamma}(t)\|}=0 \tag{52}
\end{equation*}
$$

or

$$
\begin{equation*}
\left\langle\boldsymbol{G r a d} \gamma_{\gamma(t)} \kappa, \dot{\gamma}(t)\right\rangle v_{E u c}(t)+\kappa(\gamma(t)) \frac{<\ddot{\gamma}(t), \dot{\gamma}(t)>}{v_{E u c}(t)}=0 \tag{53}
\end{equation*}
$$

### 3.2.2 $\kappa$-uniform straight lines

Let $\sigma$ and $\sigma^{\prime}$ two distinct points of $\mathbb{R}^{3}$. For any sitting-observer $a$ the parametrization

$$
\begin{equation*}
\gamma: \mathbb{R} \rightarrow \mathbb{R}^{3}, t \mapsto \sigma+t\left(\sigma^{\prime}-\sigma\right) \tag{54}
\end{equation*}
$$

is the geodesic passing through $\sigma$ at time 0 and $\sigma^{\prime}$ at time 1 with constant $a$-speed $v_{a}=d_{a}\left(\sigma, \sigma^{\prime}\right)$.
Since $\forall t \in \mathbb{R}, v_{\kappa}(t)=\left\|\sigma^{\prime}-\sigma\right\|_{\kappa(\gamma(t))}$ is not a constant function, the smooth curve $\gamma$ is not $\kappa$-uniform (unless $\kappa$ is constant along it).
Nevertheless we can reparametrize the support of $\gamma$ in a $\kappa$-uniform way.
Let $c: \mathbb{R} \rightarrow \mathbb{R}^{3}$ defined by

$$
\begin{equation*}
c(t)=\sigma+\phi(t) \boldsymbol{u} \tag{55}
\end{equation*}
$$

where
$\dagger \phi: \mathbb{R} \rightarrow \mathbb{R}$ is some class $\mathcal{C}^{\infty}$ function with $\phi(0)=0$.
$\dagger \quad \boldsymbol{u}=\frac{1}{\left\|\sigma^{\prime}-\sigma\right\|}\left(\sigma^{\prime}-\sigma\right) \in \mathbb{R}^{3}$.
The $\kappa$-speed of $c$ is $v_{\kappa}(t)=\kappa(\sigma+\phi(t) \boldsymbol{u})\left|\phi^{\prime}(t)\right|$.
The parametrization $c$ is $\kappa$-uniform with constant $\kappa$-speed $V$ if and only if

$$
\begin{equation*}
\forall t \in \mathbb{R},\left|\phi^{\prime}(t)\right|=\frac{V}{\kappa(\sigma+\phi(t) \boldsymbol{u})} \tag{56}
\end{equation*}
$$

Then $\forall t \in \mathbb{R}, \frac{V}{M} \leq\left|\phi^{\prime}(t)\right| \leq \frac{V}{m}$ so the derivative $\phi^{\prime}(t)$ never cancels. If $c$ is to reach $\sigma^{\prime}$ at some positive time we have $\forall t \in \mathbb{R}, \phi^{\prime}(t)>0$.
Let $K: \mathbb{R} \rightarrow \mathbb{R}$ the function defined by

$$
\begin{equation*}
K(\theta)=\int_{0}^{\theta} \kappa(\sigma+s \boldsymbol{u}) d s \tag{57}
\end{equation*}
$$

as $\kappa$ is a strictly positive function, $K$ is a strictly increasing bijective function from $\mathbb{R}$ to itself, let $\chi$ be its reciprocal.
The curve defined by

$$
c(t)=\sigma+\chi(t V) \boldsymbol{u}
$$

is $\kappa$-uniform with $\kappa$-speed $V$.
Indeed its $\kappa$-speed

$$
\begin{equation*}
v_{\kappa}(t)=\kappa(\sigma+\chi(t V) \boldsymbol{u}) \chi^{\prime}(t V)=\kappa(\sigma+\chi(t V) \boldsymbol{u}) \frac{1}{K^{\prime}(\chi(t V))} V=V \tag{58}
\end{equation*}
$$

### 3.2.3 Velocity fields and covariant accelerations

Let $\gamma: \mathbb{R} \rightarrow \mathbb{R}^{3}$ a smooth curve.
For a given sitting-observer $a, \mathbb{R}^{3}$ is equipped with $G_{\kappa(a)}^{E u c}$, the Levi-Civita connection is flat and the solutions of the equation of cancellation of covariant derivation of the $a$-velocity

$$
\begin{equation*}
\nabla_{\frac{d}{d t}} \dot{\boldsymbol{v}}_{a}=0 \tag{59}
\end{equation*}
$$

are the parametrizations with constant $a$-speed of straight lines, those are the $a$-geodesics. Another sitting-observer $b$ will agree with $a$ on saying that a curve is a geodesic but $b$ will measure a different speed.
A straightforward computation gives the equation of cancellation of the flat covariant derivation of the $\kappa$-velocity

$$
\begin{equation*}
\nabla_{\frac{d}{d t}} \dot{\boldsymbol{v}}_{\kappa}=\kappa(\gamma(t)) \ddot{\gamma}(t)+\left\langle\boldsymbol{G} \operatorname{rad}_{\gamma(t)} \kappa, \dot{\gamma}(t)\right\rangle . \dot{\gamma}(t)=0 \tag{60}
\end{equation*}
$$

The flat covariant derivation is not the Levi-Civita of the metric $G_{\kappa}^{E u c}$ so the equation (60) is not the equation of geodesics of $G_{\kappa}^{E u c}$. The solution curves are the parametrizations of straightlines with constant $\kappa$-speed.
This can be checked easily : (60) admits one unique solution with given initial conditions $\gamma(0), \dot{\gamma}(0)$. Using an adapted frame we can assume that $\gamma(0)=O$ and $\dot{\gamma}(0)$ is colinear to $\frac{\partial}{\partial \boldsymbol{\sigma}^{1}}$. We have seen that the $\kappa$-uniform parametrization of the straight line $\gamma$ such that $\gamma(0)=O$ and $\kappa$-speed 1 is

$$
\gamma(t)=(\chi(t), 0,0)
$$

where $\chi$ is the reciprocal of the function $K$ defined by

$$
K(\theta)=\int_{0}^{\theta} \kappa\left(O+s \frac{\partial}{\partial \mathbf{x}^{1}}\right) d s
$$

The velocity of $\gamma$ writes

$$
\dot{\gamma}(t)=\chi^{\prime}(t) \frac{\partial}{\partial \boldsymbol{x}^{1}}=\frac{1}{\kappa(\gamma(t))} \frac{\partial}{\partial \boldsymbol{x}^{1}}
$$

then

$$
\ddot{\gamma}(t)=\nabla_{\frac{d}{d t}} \dot{\gamma}(t)=\frac{-\frac{\partial \kappa}{\partial \mathbf{x}^{1}}(\gamma(t)) \chi^{\prime}(t)}{\kappa^{2}(\gamma(t))} \frac{\partial}{\partial \boldsymbol{x}^{1}}=-\frac{1}{\kappa(\gamma(t))^{3}} \frac{\partial \kappa}{\partial x^{1}}(\gamma(t)) \frac{\partial}{\partial \boldsymbol{x}^{1}}
$$

From where we find again relation (60).

### 3.2.4 Laser distance

Let $\sigma, \sigma^{\prime} \in \mathbb{R}^{3}$, let $\boldsymbol{u}=\frac{1}{d_{E u c}\left(\sigma, \sigma^{\prime}\right)}\left(\sigma^{\prime}-\sigma\right)$. Let

$$
\begin{equation*}
\gamma: \mathbb{R} \rightarrow \mathbb{R}^{3} ; \quad t \mapsto \sigma+t \boldsymbol{u} \tag{61}
\end{equation*}
$$

we have

$$
\gamma(0)=\sigma, \quad \gamma\left(d_{E u c}\left(\sigma, \sigma^{\prime}\right)\right)=\sigma^{\prime}
$$

and as $\forall t \in \mathbb{R}, \dot{\gamma}(t)$ is the Euclidean-unit tangent vector $\boldsymbol{u}$ the $\kappa$-speed $v_{\kappa}(t)=\kappa(\gamma(t))$.
The laser distance $d_{\text {las }}\left(\sigma, \sigma^{\prime}\right)$ is defined by $G_{\kappa}^{E u c}$-length of $\gamma$ between $\sigma$ and $\sigma^{\prime}$ is

$$
\begin{equation*}
d_{l a s}\left(\sigma, \sigma^{\prime}\right)=L_{G_{\kappa}^{E u c}}\left(\left[\sigma, \sigma^{\prime}\right]\right)=\int_{0}^{d_{E u c}\left(\sigma, \sigma^{\prime}\right)} \kappa(\sigma+t \boldsymbol{u}) d t \tag{62}
\end{equation*}
$$

This laser-distance can also be obtained with the $\kappa$-uniform parametrization of $\left[\sigma, \sigma^{\prime}\right]$ with $\kappa$-speed equal to 1 .

$$
\tilde{\gamma}: \mathbb{R} \rightarrow \mathbb{R}^{3} ; \quad t \mapsto x=\sigma+\chi(t) \boldsymbol{u}
$$

where $\chi=K^{-1}$ with $K(\theta)=\int_{0}^{\theta} \kappa(x+s \boldsymbol{u}) d s$.
$L_{\text {las }}\left(\sigma, \sigma^{\prime}\right)$ is the "distance" obtained by compiling the measurement of speed made by sittingobservers along the straightline segment $\left[\sigma, \sigma^{\prime}\right]$ which is not a $G_{\kappa}^{E u c}$ geodesic.
The application $\left(\sigma, \sigma^{\prime}\right) \mapsto d_{\text {las }}\left(\sigma, \sigma^{\prime}\right)$ is not in general a distance for it fails to satisfy the triangle inequality, but nevertheless

The positivity $\forall \sigma, \sigma^{\prime} \in \mathbb{R}^{3}$, $d_{\text {las }}\left(\sigma, \sigma^{\prime}\right) \geq 0$.
The separation $\forall \sigma, \sigma^{\prime} \in \mathbb{R}^{3}, d_{\text {las }}\left(\sigma, \sigma^{\prime}\right)=0 \Longleftrightarrow \sigma^{\prime}=\sigma$.
The symmetry $\forall \sigma, \sigma^{\prime} \in \mathbb{R}^{3}, d_{\text {las }}\left(\sigma, \sigma^{\prime}\right)=d_{\text {las }}\left(\sigma^{\prime}, \sigma\right)$.
are satisfied.

### 3.2.5 Circular motions

Let $\gamma: \mathbb{R} \rightarrow \mathbb{R}^{3}$ a parametrization of class $\mathcal{C}^{\infty}$ of some Euclidean circle $\mathcal{C}$ of $\mathbb{R}^{3}$, in a well chosen orthonormal coordinates system $\left(\sigma^{1}, \sigma^{2}, \sigma^{3}\right)$ we have

$$
\begin{equation*}
\gamma(t)=R(\cos \theta(t), \sin \theta(t), 0)) \tag{63}
\end{equation*}
$$

with $R>0$ and $\theta$ some $\mathcal{C}^{\infty}$ function.
For $\theta \in \mathbb{R}$, let us define the tangent vector fields

$$
\begin{equation*}
\boldsymbol{u}(\theta)=\cos (\theta) \frac{\partial}{\partial \boldsymbol{\sigma}^{1}}+\sin (\theta) \frac{\partial}{\partial \boldsymbol{\sigma}^{2}} \text { and } \boldsymbol{v}(\theta)=-\sin (\theta) \frac{\partial}{\partial \boldsymbol{\sigma}^{1}}+\cos (\theta) \frac{\partial}{\partial \boldsymbol{\sigma}^{2}} \tag{64}
\end{equation*}
$$

For a sitting-observer $a$, the apparent radius is $\kappa(a) R$, the $a$-velocity at time $t$ is

$$
\begin{equation*}
\boldsymbol{v}_{a}(t)=\kappa(a) R \theta^{\prime}(t) \boldsymbol{v}(\theta(t)) \tag{65}
\end{equation*}
$$

While the $\kappa$-velocity at time $t$ is given by

$$
\begin{equation*}
\boldsymbol{v}_{\kappa}(t)=\kappa(\gamma(t)) R \theta^{\prime}(t) \boldsymbol{v}(\theta(t) \tag{66}
\end{equation*}
$$

The (covariant) $a$-acceleration of $\gamma$ is

$$
\begin{equation*}
\nabla_{\frac{d}{d t}} \dot{\boldsymbol{v}}_{a}(t)=\kappa(a) R\left[\theta^{\prime \prime}(t) \boldsymbol{v}(\theta(t))-\theta^{\prime}(t)^{2} \boldsymbol{u}(\theta(t))\right] \tag{67}
\end{equation*}
$$

The (covariant) $\kappa$-acceleration of $\gamma$ writes

$$
\begin{equation*}
\nabla_{\frac{d}{d t}} \dot{\boldsymbol{v}}_{\kappa}(t)=\nabla_{\frac{d}{d t}}((\kappa \circ \gamma) \dot{\gamma})(t)=\frac{d(\kappa \circ \gamma)}{d t}(t) \dot{\gamma}(t)+\kappa \circ \gamma(t) \nabla_{\frac{d}{d t}} \dot{\gamma} \tag{68}
\end{equation*}
$$

### 3.2.6 $a$-uniform and $\kappa$-uniform circular motions

When a circular motion $\gamma$ is $a$-uniform, in other words when for a sitting observer $a$ the $a$-speed is a constant, the expression of $\theta$ has the form $\theta(t)=\varphi+\omega t$ with $\varphi$ and $\omega$ some constants. Changing the origin of time we may assume that $\varphi=0$, and changing the orientation we may assume that $\omega \geq 0$.
Then

$$
\gamma(t)=R(\cos (\omega t), \sin (\omega t), 0)
$$

(in polar coordinates $\gamma(t)=(R, \omega t))$

For any sitting-observer $a \in \mathbb{R}^{3}$ the motion will also be circular $a$-uniform with angular speed $\omega$ but with apparant radius of the trajectory $R_{a}=\kappa(a) R$.
The $a$-speed and the $\kappa$-speed writes

$$
\begin{equation*}
v_{a}(t)=R \kappa(a) \omega \text { and } v_{\kappa}(t)=R \kappa(\gamma(t)) \omega \tag{69}
\end{equation*}
$$

The derivative of the $\kappa$-speed is

$$
\begin{equation*}
\frac{d v_{\kappa}}{d t}(t)=R^{2} \omega^{2}\left\langle\boldsymbol{G} \operatorname{rad}_{\sigma(t)} \kappa, \boldsymbol{v}(\omega t)\right\rangle=R \omega^{2} \frac{\partial g}{\partial \theta}(\sigma, \omega t) \tag{70}
\end{equation*}
$$

where $g$ is defined by

$$
g(r, \theta)=\kappa(r \cos (\theta), r \sin (\theta), 0)
$$

Of course if $\kappa$ happens to have radial symmetry, in other words if $\frac{\partial g}{\partial \theta}=0$ the motion is also $\kappa$-uniform.

## $3.3 \kappa$-structure on a Minkowski metric

Let us equip $\mathbb{R}^{4}$ with the Minkowski metric $G^{\text {Mink }}$. We choose once and for all a global system of coordinates $\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right)$ such that the expression of the pseudo-metric is

$$
G^{M i n k}=d \sigma^{0} d \sigma^{0}-\delta_{i j} d \sigma^{i} d \sigma^{j}
$$

Then $\forall e \in \mathbb{R}^{4}, \forall \mathbf{u}=u^{i} \frac{\partial}{\partial \boldsymbol{\sigma}^{i}}, \mathbf{v}=v^{i} \frac{\partial}{\partial \boldsymbol{\sigma}^{i}} \in T_{e} \mathbb{R}^{4}$,

$$
\begin{equation*}
G_{e}^{M i n k}(\mathbf{u}, \mathbf{v})=\langle\langle\mathbf{u}, \mathbf{v}\rangle\rangle=u^{0} v^{0}-\left(u^{1} v^{1}+u^{2} v^{2}+u^{3} v^{3}\right) \tag{71}
\end{equation*}
$$

The choice of the global coordinates system provides a trivial foliation of $\mathbb{R}^{4}$ which leaves are the equivalence classes of the relation $\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right) \simeq\left(\sigma^{\prime 0}, \sigma^{\prime 1}, \sigma^{\prime 2}, \sigma^{\prime 3}\right)$ when $\left(\sigma^{1}, \sigma^{2}, \sigma^{3}\right)=$ $\left(\sigma^{11}, \sigma^{2}, \sigma^{\prime 3}\right)$. Each leaves of that foliation will be called a sitting-observer relative to the chosen global coordinate system. To each point $a$ in $\mathbb{R}^{3}$ is associated a unique sitting-observer $\bar{a}$.
Changing the coordinate system will of course change the sitting-observers.
A Minkowski metric affected with a $\kappa$-effect is a couple
$\left(\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right), \kappa\right)$ where
$\dagger\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right)$ is a global coordinates system such as $G^{\text {Mink }}$ has expression $d \sigma^{0} d \sigma^{0}-$ $\delta_{i j} d \sigma^{i} d \sigma^{j}$.
$\left.\dagger \quad \kappa: \mathbb{R}^{3} \rightarrow\right] m, M\left[\right.$ with $m>0$ is a class $\mathcal{C}^{\infty}$ function.
When $\left(\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right), \kappa\right)$ is a Minkowski metric affected with a $\kappa$-effect we have On one hand two pseudo-metrics on $\mathbb{R}^{4}$ :

- The Minkowski metric $G^{M i n k}=d \sigma^{0} d \sigma^{0}-\delta_{i j} d \sigma^{i} d \sigma^{j}$
defined at (71).
- The non-flat pseudo-metric $G_{\kappa}=d \sigma^{0} d \sigma^{0}-\kappa^{2} \delta_{i j} d \sigma^{i} d \sigma^{j}$ defined by

On the other hand a collection of Minkowski metrics on $\mathbb{R}^{4}, \forall a \in \mathbb{R}^{3}$

Any information retrieved using the pseudo-metric $G_{\kappa(\bar{a})}^{M i n k}$ on $\mathbb{R}^{4}$ is an observation made by a sitting-observer $\bar{a}$. For example, let $e$ and $e^{\prime}$ two events, if $\mathbf{u}$ is the unique quadrivector such that $e^{\prime}=e+\mathbf{u}$ the sitting observer $\bar{a}$ will interpret $e$ and $e^{\prime}$ separated by a time-like gap when $G_{\kappa(\bar{a})}^{M i n k}(\mathbf{u}, \mathbf{u})>0$. Another sitting-observer may interpret $e$ and $e^{\prime}$ separated by a space-like gap.

### 3.3.1 Quadrivelocities

Let

be a smooth worldline expressed in the coordinates system $\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right)$, the triplet $\left(\Gamma^{1}(\tau), \Gamma^{2}(\tau), \Gamma^{3}(\tau)\right)$ will be denoted $\Gamma^{s}(\tau)$ and $\bar{\Gamma}(s)(\tau)$ the sitting-observer associated.
The quadrivelocity is

When (83) is fullfilled for all $\tau \in \mathbb{R}$ we say that $\Gamma$ is a $\bar{a}$-worldline. and

\dot{\Gamma}_{\kappa}(\tau)=\dot{\Gamma}^{0}(\tau)\left(\frac{\partial}{\partial \boldsymbol{\sigma}^{0}}+\kappa\left(\bar{\Gamma}_{s}(\tau)\right) \frac{\dot{\Gamma}^{i}(\tau)}{\dot{\Gamma}^{0}(\tau)} \frac{\partial}{\partial \boldsymbol{\sigma}^{i}}\right)=\dot{\Gamma}^{0}(\tau)\left(\frac{\partial}{\partial \boldsymbol{\sigma}^{0}}+\kappa\left(\bar{\Gamma}^{s}(\tau)\right) \boldsymbol{v}_{\Gamma}(\tau)\right) \tag{84}
\end{equation*}

we get the equivalence

When condition (85) is fullfilled for all $\tau \in \mathbb{R}$ we say that $\Gamma$ is a $\kappa$-worldline. Let us put

Such a worldline is seen as a geodesic by any sitting-observer and its general form is $\sigma: \mathbb{R} \rightarrow$ $\mathbb{R}^{4}, \tau \mapsto\left(\sigma^{0}(\tau), \sigma^{1}(\tau), \sigma^{2}(\tau), \sigma^{3}(\tau)\right)$ with affine coordinate functions.

### 3.3.2 Changing coordinate systems

Without $\kappa$-effect :
The choice of a "reference frame" $\mathcal{F}=(O, \mathcal{B})$ where $O=\left(x^{0}, x^{1}, x^{2}, x^{3}\right)$ is an event and $\mathcal{B}=\left(\boldsymbol{\partial}_{0}, \boldsymbol{\partial}_{1}, \boldsymbol{\partial}_{2}, \boldsymbol{\partial}_{3}\right)$ is a base of $\boldsymbol{T}_{O} \mathbb{R}^{4}$ such that for $\mathbf{u}=u^{i} \boldsymbol{\partial}_{i}$ and $\mathbf{v}=v^{i} \boldsymbol{\partial}_{i}$ two tangent vectors at $O$, we have

determines a global system of coordinates $\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right)$ on $\mathbb{R}^{4}$. For example we can choose $\boldsymbol{\partial}_{i}=\frac{\partial}{\partial \boldsymbol{\sigma}^{i}}$ for $i=0,1,2,3$.
Let $O^{\prime}: \mathbb{R} \rightarrow \mathbb{R}^{4}, T \mapsto\left(a_{0} T, a_{1} T, 0,0\right)$, with $a_{0}, a_{1} \in \mathbb{R}$, be a geodesic worldline. If we adjust a base $\mathcal{B}^{\prime}=\left(\boldsymbol{\partial}_{0}^{\prime}, \boldsymbol{\partial}_{1}^{\prime}, \boldsymbol{\partial}_{2}^{\prime}, \boldsymbol{\partial}_{3}^{\prime}\right)$ of $T_{O^{\prime}(0)} \mathbb{R}^{4}$ so that the global coordinate system $\left(\sigma^{\prime 0}, \sigma^{11}, \sigma^{2}, \sigma^{\prime 3}\right)$ generated by the frame $\mathcal{F}^{\prime}=\left(O^{\prime}(0), \mathcal{B}^{\prime}\right)$ fullfills the conditions
(1) The coordinates functions of a geodesic worldline $\mathbb{R} \rightarrow \mathbb{R}^{4}$ are affine functions
(2) If $e \in \mathbb{R}^{4}$ has coordinates $\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right)$ satisfying

\left(\sigma^{0}\right)^{2}-\left(\left(\sigma^{1}\right)^{2}+\left(\sigma^{2}\right)^{2}+\left(\sigma^{3}\right)^{2}\right)=0

its coordinates $\left(\sigma^{\prime 0}, \sigma^{\prime 1}, \sigma^{\prime 2}, \sigma^{\prime 3}\right)$ satisfy

\end{equation*}
$$

where

v=\frac{a_{1}}{a_{0}} \text { and } \gamma=\frac{1}{\sqrt{1-v^{2}}} \tag{91}
\end{equation*}
$$

Then if $e$ has coordinates $\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right)$ in $\mathcal{F}$, its coordinates in $\mathcal{F}^{\prime}$ are

This is the $\sigma^{1}$-boost.
With the $\kappa$-effect :
Let $\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right)$ an event and $\bar{O}$ the sitting-observer associated. We can choose a base $\mathcal{B}_{\bar{O}}=\left(\boldsymbol{\partial}_{0}, \boldsymbol{\partial}_{1}, \boldsymbol{\partial}_{2}, \boldsymbol{\partial}_{3}\right)$ of $T_{O} \mathbb{R}^{4}$ such that for $\mathbf{u}$ and $\mathbf{v}$ two tangent vectors we have

\langle\langle\mathbf{u}, \mathbf{v}\rangle\rangle_{\bar{O}}=u^{0} v^{0}-\left(u^{1} v^{1}+u^{2} v^{2}+u^{3} v^{3}\right)
$$

Such a base is for example given by $\boldsymbol{\partial}_{0}=\frac{\partial}{\partial \boldsymbol{\sigma}^{0}}$ and $\boldsymbol{\partial}_{i}=\frac{1}{\kappa(\bar{O})} \frac{\partial}{\partial \boldsymbol{\sigma}^{i}}$. Let $\mathcal{F}_{\bar{O}}$ be the frame $\left(O, \mathcal{B}_{\bar{O}}\right)$ As previously if we consider an inertial observer $O^{\prime}$ passing at $T=0$ by a point of $\bar{O}$ adjusting the coordinates system will give

\end{equation*}
$$

where

v_{\bar{O}}=\kappa(\bar{O}) \frac{a_{1}}{a_{0}} \text { and } \gamma_{\bar{O}}=\frac{1}{\sqrt{1-v_{\bar{O}}^{2}}} \tag{93}

We get the $\bar{O}-\sigma^{1}$-boost.

### 3.3.3 Observation of a far away geodesic worldline

Let $\Gamma: \mathbb{R} \rightarrow \mathbb{R}^{4}, \tau \mapsto \Gamma(\tau)=\left(\Gamma^{0}(\tau), \Gamma^{1}(\tau), \Gamma^{2}(\tau), \Gamma^{3}(\tau)\right)$ a geodesic worldline.
This means that each sitting-observer $\bar{a}$ interpret $\Gamma$ as a geodesic worldine, so the quadrivelocity $\dot{\Gamma}(\tau)$ is a constant vector field $\dot{\Gamma}$ along $\Gamma$. Let $\psi: \mathbb{R} \rightarrow \mathbb{R}^{4}$ a reparametrization of this geodesic worldline in such a way that there exists a strictly positive constant $\Lambda$ such that

\forall \tau \in \mathbb{R}, \quad\langle\langle\dot{\psi}(\tau), \dot{\psi}(\tau)\rangle\rangle_{\overline{\psi(\tau)}}=\Lambda \tag{94}

This means that for a sitting-observer located at some point of the trajectory, $\psi$ is locally a geodesic worldline.
As $\psi$ is a reparametrization of the geodesic worldine $\Gamma$, there exists a function $f: \mathbb{R} \rightarrow \mathbb{R}_{+}^{*}$, such that we have

so the condition (94) reformulate into

\end{equation*}

Let us remark that

\end{equation*}

The worldine $\psi$ appears also rectilinear to a distant sitting-observer $\bar{a}$, even though it is not a $a$-geodesic worldline. For example, this means that if along a geodesic worldline $\Gamma$ the function $\kappa$ is decreasing we may get a reparametrization of $\Gamma$ such that it stays a geodesic worldline. In other word the quadri-velocities measured by local observers are quadri-velocities yet. On the other hand a remote sitting-observer would observe a quadrivector evolving from time-like to space-like.

## 4 Applications

Let us specify that these applications are just given here for illustrative purposes. Concrete and much more complex situations in the case of spiral galaxies and galactic clusters have been discussed elsewhere $[2,3,4]$.
We need to clarify "where" the objects we will be considering and "where" the observers actually are. A $\kappa$-structure is conceived as the trivial bundle $\left.\mathbb{R}^{3} \times\right] m, M\left[\rightarrow \mathbb{R}^{3}\right.$ where each constant section $\mathbb{R}_{\lambda}^{3}=\mathbb{R}^{3} \times\{\lambda\}$ is equipped with the metric $G_{\lambda}^{E u c}$ and the base space is equipped with the metric $G^{E u c}$. Each leaf $R_{\lambda}^{3}$ of the bundle is accessible to the sittingobservers $a$ such that $\lambda=\kappa(a)$, those sitting-observers are subject to an illusion (associated to the surrounding density). The real space is the base space where the objets are, but no real observer can see the geometry of that space per se. Rather these observers see the base through the magnifying glass provided by both their own environment and that of the perceived object. Any potential observer in the base space accessing to $G^{E u c}$ would be a "shadow-observer".

### 4.1 What a sitting-observer sees, size measurement

Let $a$ and $b$ two sitting-observers, as the Levi-Civita connections of $G_{\kappa(a)}^{E u c}$ and $G_{\kappa(b)}^{E u c}$ are both equal to the trivial covariant derivation, $a$ and $b$ will agree on which tangent vector fields
along a smooth curve $\gamma$ joining them are parallel : the constant vector fields. Assume that $\kappa(a) \neq \kappa(b)$ and let $\mathbf{U}$ and $\mathbf{V}$ two constant tangent vector fields along $\gamma$ such that

we have

d_{a}(a, a+\mathbf{V}(a))=\kappa(a)\|\mathbf{V}\|_{G^{E u c}} \neq \kappa(b)\|\mathbf{U}\|_{G^{E u c}}=d_{b}(a, a+\mathbf{U}(a))
$$



Fig 3 : Discrepancy in size measurement a hold a stick $(a, a+U)$ and $b$ a stick $(b, b+V)$. exchanging their measurement of length $a$ and $b$ may find $d_{a}(a, a+U)=d_{b}(b, b+V)$ while $a$ alone finds $d_{a}(a, a+U) \neq d_{a}(b, b+V)$
Practically, this means that two different sitting-observers, each one holding a stick, could agree on saying that the two sticks have the same length when they exchange the measurements of their own stick but if one of them use his own measurement system to measure the stick hold by the other one he would say that the two sticks have different lengths.
This can be illustrated on the following figure, two sitting-observers compare the radii of their own unit ball, $a$ sees the unit ball hold by $b$ bigger than his own.


Fig 4 : Discrepancy in size measurement for a disk
Another illustrative point of view appears very interesting. We assume here that there is no gravity. The base is equipped with an Euclidean metric. Let a free particle emitted at some instant from the point a (Fig. 5). Arrived at b the particle emitted a photon in the direction of the observer A. Then the observer A sees the particle at the position b'. He measures the spectroscopic velocity $\kappa_{B}\|\dot{\boldsymbol{\sigma}}\|$ (shown in orange). Likewise the observer B sees the particle starting from a at the position a' and he measures the spectroscopic velocity $\kappa_{A}\|\dot{\boldsymbol{\sigma}}\|$.


Fig 5: Two observers $A$ and $B$ separated by a very large distance $\gg 1$ pc. Very close to each of them an universal "atom" of small size $\sim 10 A U$ is represented. The dashed straight line $a b$ ' (resp. $a^{\prime} b$ ) is a geodesic of the sheet of the observer $A$ (resp. B) equipped with $\kappa_{A}\left(\right.$ resp. $\left.\kappa_{B}\right)$. Let us note that the norm of the vector $\dot{\boldsymbol{\sigma}}$ is a constant in the base, but this norm varies as $\frac{1}{\kappa}$ in the respective sheets of the observers. On the other hand the curve $a b{ }^{\prime \prime}$ displayed in blue is a geodesic of the bundle equipped of a variable $n 9$.

## $\kappa$-aberration

In Figure 5 a linear variation of $\kappa$ as a function of $\boldsymbol{\sigma}$ is assumed. Then the image of the straight line ab taken in the base (the real trajectory of the particle $P$ ) is represented by a multiplet of parallel straight lines $a b^{\prime}, a^{\prime} b, \ldots$, each of these lines being attached to a real observer. Let us note that the real trajectory of the particle $P$ in the base space does not seem to be parallel to the corresponding multiplet of its images in the bundle. In fact there is no reason why this should be so. The base space is linked to the bundle by a projection which can diversely tilt any small portion of a trajectory, even though this tilt is fictitious (see also Fig.15, where the fictitious trajectory is shown as composed of a series of infinitesimal segments, each one of these segments being parallel to the real trajectory). Moreover the base space is not accessible to the real observers present in the bundle. Then an unreflected comparison of a vector in the base to the "same" vector in the bundle makes no sense regarding its apparent direction. In the base the vector $\dot{\boldsymbol{\sigma}}$ (denoted by $\dot{\boldsymbol{\sigma}_{\boldsymbol{b}}}$ ) is constant for a free particle, while in the bundle it is $\kappa \dot{\sigma}$ that is a constant vector. In the sheet of the observer A, we have, respectively for the radial (spectroscopic) and (apparent) tangential components of the velocity, as seen by this observer $\left(d_{A}=10 \mathrm{AU}\right)$

[^6]Applying the Hamilton's Principle we find the geodesic equation (curve displayed in blue in Fig 5)

the dot over $\kappa$ denotes the Lagrangian time derivative of $\kappa$. We can verify that if $\dot{\kappa}=0$, then the tangential velocity cancels out.

## Overlapping images.

Let $a$ be a sitting-observer, $\Delta$ be a straight line passing through $a, \mathcal{S}$ and $\mathcal{P}$ be two planes orthogonal to $\Delta, B$ a disk and $C$ is a small concentric flattened annulus both in $\mathcal{P}$ and centered at $\Delta \cap \mathcal{P}$. Assume that $d_{E u c}(a, \mathcal{P}) \gg R_{B}=R_{C} \gg d_{E u c}(a, \mathcal{S})$, where $R_{B}$ is the radius of $B$ and $R_{C}$ the thickness of $C$, for example $d_{\text {Euc }}(a, P) \gg 1 p c, R_{B}=R_{C}=10 \mathrm{AU}$ and $d_{E u c}(a, \mathcal{S})=$ a few meters.
The points of $B$ are all affected with a $\kappa$ coefficient $\kappa_{b}$ and the points of $C$ are all affected with a coefficient $\kappa_{c}$.
We have $\forall x \in B \cup C, d(a, x) \simeq d(a, \mathcal{P})$. Let $b \in B$ and $c \in C$, we have $d_{b}(a, b)=\frac{\kappa_{b}}{\kappa_{a}} d_{a}(a, b)$ and $d_{c}(a, c)=\frac{\kappa_{c}}{\kappa_{a}} d_{a}(a, c)$. The photons are emitted by $b$ and $c$ in direction of $a$, but of course each emitter estimates the direction of $a$ with their own tools, the ratio $\kappa_{b} / \kappa_{c}$ induces a magnification of the image received by $a$ on a screen in the plane $\mathcal{S}$, as shown in figure 5 .
To illustrate this phenomenon let consider three cases, in the first case (Fig 6.a) $\frac{\kappa_{b}}{\kappa_{c}}=1$, in the second case (Fig 5.b) we assume that $\frac{\kappa_{b}}{\kappa_{c}}>1$ (3 in the figure 6.b), in the third case (Fig 6.c) we assume the $\frac{\kappa_{b}}{\kappa_{c}}<1$ (1/3 in figure 6.c)

If $\kappa_{b}=\kappa_{c}$ there is no $\kappa$-effect, the observer $a$ perceives an image with no magnification as shown on figure 6.a. The second case is represented in figure 5.b. it shows the modification of the image received by $a$, the image of the flattened annulus is stretched. The third case is represented in figure 5.c, the image of the central disk is stretched and overlaps the image of the flattened annulus.


Fig 6.a : Images obtained without $\kappa$-effect, the annulus is represented in yellow,; the central disk is represented in red

### 4.2 The circular motion of a test mass $m=1$ around a motionless mass $M$

### 4.2.1 Without $\kappa$-effect

Without $\kappa$-effect, in other words for any observer considering $\mathbb{R}^{3}$ endowed with the Euclidean metric $G^{E u c}$, the motion is the usual Newtonian motion.
Let us consider the elementary situation of a very massive point of mass $M$, located at the origin $O$ of coordinates and surrounded by a spherical gas cloud of very weak density $\rho$ with radial symmetry. Limiting us to the examination of a circular motion $t \mapsto \sigma(t)$ of a test mass $m=1$ around this point, the dynamic equation is (assuming the gravitational constant $G=1$ )

$$
\begin{equation*}
\frac{d}{d t}(\dot{\boldsymbol{\sigma}})=-\frac{M(R)}{R^{2}} \boldsymbol{u}(t) \tag{102}
\end{equation*}
$$

where $\boldsymbol{u}=\frac{\sigma(t)-O}{\|\sigma(t)-O\|}$ is the radial $G^{E u c}$-unit vector at $\sigma(t)$ and $R$ is the constant $G^{E u c}$-distance from $\sigma(t)$ to $O$ and $M(R)=M+4 \pi \int_{0}^{R} \rho(r) r^{2} d r$.


Fig 7: Circular Newtonian motion
It is a very simple affair to show that the Newtonian speed $v_{N e w t, 0}$ is that which would be measured by a fictive observer using the metric $G_{E u c}$. We find the trivial result

$$
\begin{equation*}
v_{\text {New }, 0}=\left(\frac{M+4 \pi \int_{0}^{R} \rho r^{2} d r}{R}\right)^{\frac{1}{2}}=\sqrt{\frac{M(R)}{R}} \tag{103}
\end{equation*}
$$

The index 0 indicating that this is what is measured by the fictive observer. In the $\kappa$ model framework the Newtonian velocity $v_{N e w, 0}$ as defined above (102) is fictive, it cannot be measured by any real sitting-observer.

### 4.2.2 With $\kappa$-effect

Let a local sitting-observer $a_{l o c}$, situated on the trajectory of the test mass. He sees the whole space endowed with the metric $G_{\kappa(a)}^{E u c}$, but of course this observer has no acces neither to $\kappa(a)$ nor to $G^{E u c}$. As the $\kappa$-effect affects the distances but does not affect the masses, the apparent radius of the trajectory is $\kappa_{l o c} R$, while the mass $M$ remains unchanged. Applying the Newtonian dynamics with this modified metric, the sitting-observer $a$ measures the speed

$$
\begin{equation*}
v_{\text {New }, l o c}=\sqrt{\frac{M(R)}{\kappa_{l o c} R}}=\sqrt{\frac{\kappa_{E}}{\kappa_{l o c}}} v_{\text {Newt }, E} \tag{104}
\end{equation*}
$$

where $v_{N e w, E}$ is the Newtonian velocity calculated (but not measured) by a terrestrial observer $a_{E}$.
We are aware that in astrophysics the radial velocity (the velocity component directed along the line of sight) is measured by spectroscopy while the component of the velocity projected on the sky plane is deduced from the measurement of the proper motions. Thus within the $\kappa$-model framework, a clear distinction must be made between these two components. We will call spectroscopic velocity the (radial) velocity measured by any observer. This velocity is universal and is defined by

$$
\begin{equation*}
v_{\text {spec }}=v_{N e w, l o c} \cos (\theta)=\sqrt{\frac{\kappa_{E}}{\kappa_{\text {loc }}}} v_{N e w, E} \cos (\theta) \tag{105}
\end{equation*}
$$

where $\theta$ is the projection angle along the line of sight.
It is very commonly observed in the outskirts of the spiral galaxies that the density $\rho(r) \sim$ $\exp (-r)$ where $r$ is the distance to the center of a galaxy, measured by a terrestrial observer, i.e. $\kappa_{E} R$. If we assume that $\left.\frac{\kappa(r)}{\kappa_{E}}=\frac{1}{1+\operatorname{Ln}\left(\frac{1}{\rho(r)}\right)}\right]^{11}$, we get $\frac{\kappa(r)}{\kappa_{E}} \simeq \frac{1}{r}$ for $r \gg 1$. In this case we can conclude that $v_{\text {Newt,loc }}$ becomes constant and by consequence $v_{\text {spec }}$ becomes constant too. In other words, the observed flatness of the rotational curves of the spiral galaxies is correlated to the variation of the density in the disk as a decreasing exponential function of the radius $r$. A few concrete examples are given in Fig 8.
A contrario the tangential velocity measured by a terrestrial observer $a_{E}$ is

v_{t a n}=\frac{\kappa_{E}}{\kappa_{l o c}} v_{N e w t, l o c} \sin (\theta)=\frac{\kappa_{E}}{\kappa_{l o c}} \sqrt{\frac{1}{\kappa_{l o c}}} v_{N e w t, 0} \sin (\theta) . \tag{106}
\end{equation*}

${ }^{11}$ The detailed relationship is $\frac{\kappa(r)}{\kappa_{M}}=\frac{1}{1+\operatorname{Ln}\left(\frac{\rho M}{\rho(r)}\right)}$ where $\rho_{M}$ denotes the maximal density in the galaxy (galaxy center). Here we assume that $\rho_{M} \sim \rho_{E}$ and the density $\rho$ is normalized to this value.

### 4.3 An analysis of the spiral substructure

The spiral galaxies are dominant in the Universe. It is therefore most interesting to understand the link existing between the observation of a tight spiral substructure as it would be seen by a fictive Newtonian observer (i.e. located in the Euclidean space without $\kappa$-effect), compared to the point of view of a sitting-observer, affected by the $\kappa$-effect. If the $\kappa$-effect is now taken into account (each real observer lives in the bundle and not in the base which is for them an unreachable place). In a spiral galaxy the density varies as $\rho(\sigma) \simeq e^{-\sigma}$ and $\frac{1}{\kappa(\sigma)} \simeq 1+\sigma$.
Without the $\kappa$-effect the equation supporting the spiral substructure is that of a tight logarithmic spiral of maximal extension equal to the unit

$$
\begin{equation*}
\sigma=e^{\theta} \quad(\theta<0) \tag{107}
\end{equation*}
$$

With the $\kappa$-effect the equation becomes

$$
\begin{equation*}
\frac{\sigma}{1+\sigma}=e^{\theta} \tag{108}
\end{equation*}
$$

or

$$
\begin{equation*}
\sigma=\frac{e^{\theta}}{1-e^{\theta}} \tag{109}
\end{equation*}
$$

For any siting-observer $a$

r=\kappa(a) \frac{e^{\theta}}{1-e^{\theta}} \quad \theta<0 \tag{110}
\end{equation*}

While a hypothetical Newtonian observer would see a tightly coiled spiral, any real sittingobserver sees a grand design spiral. Two distinct real sitting-observers $a$ and $b$ see the same grand design spiral, but differing by a homothety ratio $\frac{\kappa(a)}{\kappa(b)}$.


Fig 9: A toy example : A well-developed conservative spiral substructure seen in the bundle as opposed to its counterpart living in the base (a tightly coiled spiral)


Fig 10 : A conservative grand design spiral produced by a numerical simulation in the $\kappa$ model framework (for the details see [2]). The elapsed time is given in the unit of 100 Myr. The Newtonian equivalent would be a much tighter spiral with a larger number of turns.

A side-on galaxy
If we assume for simplicity that a terrestrial observer measures a constant thickness for a disk galaxy, then

\delta_{E}(\sigma)=\delta_{0}
$$

In addition we have

$$
\frac{\kappa}{\kappa_{E}}=\frac{1}{1+\kappa_{E} \sigma}
$$

Then the local thickness is

$$
\delta_{L}(\sigma)=\frac{\kappa}{\kappa_{E}} \delta_{E}(\sigma)=\frac{\delta_{0}}{1+\kappa_{E} \sigma}
$$

Without $\kappa$-effect a side-on galaxy, seen as a very extended flat disk of constant thickness by a terrestrial observer, would appear as a much more compact object (for $\kappa_{E} \sigma=10, \quad \delta_{L}(\sigma)=$ $\left.\frac{\delta_{0}}{11}\right)$.


Fig 11: A side-on galaxy seen by a terrestrial observer (a) as opposed to its compact counterpart living in the base (b). On this illustrative example the terrestrial observer measures the density $\rho(r, z)=\exp (-r-(5+r)|z|)$.

### 4.4 Translation of an extended object and $\kappa$-effect

We have assumed that the coefficient $\kappa$ is linked to the average mass density, $\rho$, by the relationship

\end{equation*}

The way we carry out this averaging operation at a given point, may depend on what we are observing. If we observe the inner motion of a little part of a galaxy, the observed zone must be affected with a coefficient $\kappa_{i}$ deduced from an averaging of $\rho$ on a "small" ball $U_{i}$ with radius $\delta_{i} \simeq 1 p c$; now if we observe a galaxy as a whole, taken in a galaxy cluster, we need to affect this galaxy with a coefficient $\kappa_{e}$, deduced from an average of $\rho$ on a ball $U_{e}$, containing the whole galaxy with radius $\delta_{e} \simeq 1 M p c$.
Let us consider a unit gaussian distribution, $w_{\delta}$, centered on $\mathbf{r}$ (fig 12)

$$

The convolution with any quantity gives the mean value of this quantity. For instance for the mean mass density

The simultaneous consideration of both inner motions in a galaxy and global motion of the galaxy, as a whole in a galaxy cluster, will necessitate the consideration of two values of $\kappa$. A sitting-observer in the observed galaxy correspond to the selection of two sheets in the bundle $\left.\mathbb{R}^{3} \times\right] m, M\left[\rightarrow \mathbb{R}^{3}\right.$ or two different ways of measuring distances : $\left(\mathbb{R}^{3}, G_{\kappa_{e}}^{E u c}\right)$ and $\left(\mathbb{R}^{3}, G_{\kappa_{i}}^{E u c}\right)$. As previously the spectroscopic velocities, whether they are associated with internal motions in the galaxy or with global movement of the galaxy, are universally accessible, that means that spectroscopic velocities can therefore slide along a fiber without change.
Let us consider a galaxy moving in a cluster, and two small regions $I$ and $J$ of that galaxy moving into that galaxy.

With no $\kappa$-effect
The velocities of $I$ and $J$ decompose in sums

\dot{\boldsymbol{I}}=\dot{\boldsymbol{\sigma}}_{t}+\dot{\boldsymbol{\sigma}}_{i n t} \text { and } \dot{\boldsymbol{J}}=\dot{\boldsymbol{\sigma}}_{t}+\dot{\boldsymbol{\sigma}}_{i n t}^{\prime}
$$

With $\kappa$-effect inside the galaxy
At $I$ the coefficients $\kappa$ are $\kappa_{e x t}$ for translational movement and $\kappa_{i}(I)$ for internal movements. An observer $O_{i}^{\prime}$ travelling with the galaxy coinciding with $I$ only perceives the internal movements, i.e. at $I$ that observer measures $\kappa_{i}(I) \dot{\boldsymbol{\sigma}}_{\text {int }}$. The fixed observer $O_{i}$ measures the speed of the observer $O_{i}^{\prime}$ which is $\kappa_{e} \dot{\sigma}_{t}$. Finally, the observer $O_{i}^{\prime}$ transmits to $O_{i}$ the internal velocity of $I$. The observer $O_{i}$ makes then the sum to get the speed

$$
\kappa_{e} \dot{\boldsymbol{\sigma}}_{t}+\kappa_{i}(I) \dot{\boldsymbol{\sigma}}_{i n t}
$$

At $J$ the coefficients $\kappa$ are $\kappa_{e}$ for the translation motion and $\kappa_{i}(J)$ for the inner motions. The fixed observer $O_{j}$ measures the speed

$$
\kappa_{e} \dot{\sigma}_{t}+\kappa_{i}(J) \dot{\boldsymbol{\sigma}}_{i n t}^{\prime}
$$

With $\kappa$-effect outside the galaxy
For a sitting observer $a$ out of the galaxy the coefficient $\kappa$ is locally computed $\kappa(a)$. Cancelling the translation velocity of the galaxy, this observer only perceives the internal motions, resp. $\kappa_{i} \dot{\boldsymbol{\sigma}}_{\text {int }}$ at $I$ and $\kappa_{j} \dot{\boldsymbol{\sigma}}^{\prime}{ }_{i n t}$ at $J$. The fixed observer $O_{e}$ measures the speed of the observer $O^{\prime}{ }_{e}$
which is obviously unique, i.e. $\kappa_{e} \dot{\sigma}_{t}$. On the other hand the observer $O^{\prime}{ }_{e}$ transmits to $O_{e}$ the values of the internal velocities of $I$ and $J$. The observer $O_{e}$ then makes the respective sums :
at $I$

$$
\kappa_{e} \dot{\boldsymbol{\sigma}}_{t}+\kappa_{i}(I) \dot{\boldsymbol{\sigma}}_{i n t}
$$

at $J$

$$
\kappa_{e} \dot{\boldsymbol{\sigma}}_{t}+\kappa_{i}(J) \dot{\boldsymbol{\sigma}}_{i n t}^{\prime}
$$

### 4.5 The relativistic extension

In the world of galaxies and galaxy clusters, as both gravity and velocities are weak, a relativistic extension may not appear very useful. However this extension is needed at the cosmological level.
In general relativity, the background, i.e. $\mathbb{R}^{4}$, is equipped with a pseudo-Riemannian metric. In some local coordinate system $\left(\sigma^{0}, \sigma^{1}, \sigma^{2}, \sigma^{3}\right)$, the expression of the metric at point $\varphi$ has the form

$$
d s_{\varphi}^{2}=g_{00}(\varphi)\left(d \sigma^{0}\right)^{2}+g_{11}(\varphi)\left(d \sigma^{1}\right)^{2}+g_{22}(\varphi)\left(d \sigma^{2}\right)^{2}+g_{33}(\varphi)\left(d \sigma^{3}\right)^{2}
$$

where $g_{i i}$ are some functions of $\varphi$ with $g_{00}>0$ and $g_{i i}<0$ for $i \in\{1,2,3\}$.
Hence the background is equipped with a pseudo-distance. An ideal observer having access to this pseudo-metric would use this metric for measurement of the space-time interval between two events, $\varphi_{1}$ and $\varphi_{2}$, in other words, the pseudo-length of the $d s^{2}$-geodesic segment joining $\varphi_{1}$ to $\varphi_{2}$.
For $i, j \in\{1,2,3\}$ distinct, the Christoffel symbols are

\Gamma_{00}^{0}=\frac{g^{00}}{2} \frac{\partial g_{00}}{\partial \boldsymbol{\sigma}^{0}}, \quad \Gamma_{i 0}^{0}=\Gamma_{0 i}^{0}=\frac{g^{00}}{2} \frac{\partial g_{00}}{\partial \boldsymbol{\sigma}^{i}}, \quad \Gamma_{i i}^{0}=-\frac{g^{00}}{2} \frac{\partial g_{i i}}{\partial \boldsymbol{\sigma}^{0}}, \quad \Gamma_{i j}^{0}=0
$$

For $i \in\{1,2,3\}$ and $j, k \in\{0,1,2,3\} \backslash\{i\}$ distinct (with no summation over $i$ )

In the $\kappa$-model each sitting-observer $a$ associates to the background a modified pseudo-metric. The modification is a rescaling of the spatial coordinates of tangent quadrivectors with no change of time coordinate. Then the general form of modified pseudo-metric is

Each current sitting-observer $a$ is provided with a value for $\lambda=\kappa(a)$.
The modification of the pseudo-metric induces a modification of the Christoffel symbols. If we note $\stackrel{\lambda}{g}_{i j}$ the coefficients of the modified metric $d s_{\lambda}^{2}$ we have

the Christoffel symbols of the modified metric and the initial metric are linked

This means that the supports of geodesic curves may differ from one observer to another. The full background is also equipped with a modified pseudo-metric.

d s_{\kappa, \varphi}^{2}=g_{00}(\varphi)\left(d \sigma^{0}\right)^{2}+\kappa^{2}(\varphi)\left(g_{11}(\varphi)\left(d \sigma^{1}\right)^{2}+g_{22}(\varphi)\left(d \sigma^{2}\right)^{2}+g_{33}(\varphi)\left(d \sigma^{3}\right)^{2}\right)
$$

If we note $\stackrel{\kappa}{g}_{i j}$ the coefficients of the modified metric $d s_{\kappa}^{2}$ we have

\stackrel{\kappa}{g}_{00}=g_{00}, \text { and for } i \in\{1,2,3\}, \stackrel{\kappa}{g}_{i i}=\kappa^{2} g_{i i}
$$

then

{\stackrel{\kappa}{\kappa_{00}}}_{g}=g^{00} \text { and } \stackrel{\kappa}{i i}_{g}=\frac{1}{\lambda^{2}} g^{i i}
$$

the Christoffel symbols of this modified metric and the initial metric are linked (with no summation over $i$ )

$$
\begin{gathered}
\stackrel{\kappa}{\Gamma_{00}^{0}}=\Gamma_{00}^{0}, \quad \stackrel{\kappa}{\Gamma_{i 0}^{0}}=\Gamma_{i 0}^{0}, \quad \stackrel{\kappa}{\Gamma_{i i}^{0}}=\kappa^{2} \Gamma_{i i}^{0}-\frac{1}{\kappa} \frac{\partial \kappa}{\partial \boldsymbol{\sigma}^{0}}, \quad \stackrel{\kappa}{\Gamma_{i j}^{0}}=\Gamma_{i j}^{0}=0 \\
\Gamma_{i i}^{i}=\Gamma_{i i}^{i}+\frac{1}{\kappa} \frac{\partial \kappa}{\partial \boldsymbol{\sigma}^{i}}, \quad \stackrel{\kappa}{\Gamma}_{j i}^{i}=\Gamma_{j i}^{i}+\frac{1}{\kappa} \frac{\partial \kappa}{\partial \boldsymbol{\sigma}^{j}}, \quad \stackrel{\kappa}{\Gamma_{j j}^{i}}=\Gamma_{j j}^{i}-\frac{g^{i i} g_{j j}}{\kappa} \frac{\partial \kappa}{\partial \boldsymbol{\sigma}^{i}}, \\
\Gamma_{00}^{\kappa}=\frac{1}{\kappa^{2}} \Gamma_{00}^{i}, \quad \stackrel{\kappa}{\Gamma_{j k}^{i}}=\Gamma_{j k}^{i}=0
\end{gathered}
$$

The geodesics of this pseudo-metric are not geodesics for any metric used by sitting-observers

### 4.5.1 Without gravity

Without gravity the metric $d s^{2}$ is Minkowskian, we have

g_{00}=\eta_{00}=1, g_{11}=g_{22}=g_{33}=\eta_{11}=\eta_{22}=\eta_{33}=-1

In this special case the $\kappa$-effect does not affect the Christoffel symbols, and then the geodesic equation has been considered in paragraph 3.3.3.

### 4.5.2 With weak gravity

## Without $\kappa$-effect

In the case of weak gravitational fields, the metric coefficients are slightly modified

Furthermore if we assume that the weak gravitation field is stationary, we have

For $i \in\{1,2,3\}$ and $j, k \in\{0,1,2,3\} \backslash\{i\}$ distinct (with no summation over $i$ )

\begin{gathered}
\Gamma_{i i}^{i} \simeq \frac{\eta^{i i}}{2} \frac{\partial h_{i i}}{\partial \boldsymbol{\sigma}^{i}}, \quad \text { if } j \neq 0, \Gamma_{j i}^{i}=\Gamma_{i j}^{i} \simeq \frac{\eta^{i i}}{2} \frac{\partial h_{i i}}{\partial \boldsymbol{\sigma}^{j}}, \quad \text { and } \Gamma_{0 i}^{i}=\Gamma_{i 0}^{i} \simeq 0 \\
\Gamma_{j i}^{i}=\Gamma_{i j}^{i} \simeq 0, \quad \Gamma_{j j}^{i} \simeq-\frac{\eta^{i i}}{2} \frac{\partial h_{j j}}{\partial \boldsymbol{\sigma}^{i}}, \quad \Gamma_{j k}^{i}=0
\end{gathered}
$$

If $\tau \mapsto \gamma(\tau)=\left(\gamma^{0}(\tau), \gamma^{1}(\tau), \gamma^{2}(\tau), \gamma^{3}(\tau)\right)$ is a geodesic we have

## With $\kappa$-effect

The metric coefficients are changed : $\eta_{i i}+h_{i i} \rightarrow \kappa^{2}\left(\eta_{i i}+h_{i i}\right)$ for $i \in\{1,2,3\}$. With the same hypothesis of weak stationary gravity and low speed, the geodesic equation simplifies (for eq. 117 , see eq. 60)

for $i \in\{1,2,3\}$ with $\stackrel{\kappa}{\Gamma}{ }_{00}^{i} \sim \frac{1}{2 \kappa^{2}} \frac{\partial h_{00}}{\partial \boldsymbol{\sigma}^{i}}$. Using the variable $\gamma^{0}(\tau)$, for $i \in\{1,2,3\}$,

\frac{d \gamma^{i}}{d \tau}=\dot{\gamma}^{0} \frac{d \gamma^{i}}{d \gamma^{0}}
$$

and

$$
\begin{aligned}
\frac{d}{d \tau}\left[\kappa[\gamma(\tau)] \frac{d \gamma^{i}}{d \tau}\right]+\stackrel{\kappa}{\Gamma}_{00}^{i}\left(\dot{\gamma}^{0}\right)^{2} & =\frac{d}{d \tau}\left[\dot{\gamma}^{0} \kappa[\gamma(\tau)] \frac{d \gamma^{i}}{d \gamma^{0}}\right]+\stackrel{\kappa}{\Gamma}{ }_{00}^{i}\left(\dot{\gamma}^{0}\right)^{2} \\
& =\frac{d}{d \tau}\left[\dot{\gamma}^{0}\right] . \kappa\left[\gamma\left(\gamma^{0}\right)\right] \frac{d \gamma^{i}}{d \gamma^{0}}+\dot{\gamma}^{0} \kappa\left[\gamma\left(\gamma^{0}\right)\right] \frac{d}{d \tau}\left[\frac{d \gamma^{i}}{d \gamma^{0}}\right]+\stackrel{\kappa}{\Gamma}_{00}^{i}\left(\dot{\gamma}^{0}\right)^{2} \\
& =\left(\dot{\gamma}^{0}\right)^{2} \frac{d}{d \gamma^{0}}\left[\kappa\left[\left(\gamma^{0}\right)\right] \frac{d \gamma^{i}}{d \gamma^{0}}\right]+\stackrel{\kappa}{\Gamma_{00}^{i}\left(\dot{\gamma}^{0}\right)^{2}}
\end{aligned}
$$

Eventually (118) becomes

Let the Schwarzschild metric (with the attractive mass $M$ situated at the origin of the coordinates and very far from the singularity). We have then $h_{00}=-\frac{2 M}{\sigma}$.
For any sitting-observer $a$, equipped with his own coordinates and located along the trajectory of the test mass, the motion equation is $\left(\gamma^{0} \equiv t\right.$ with the speed of light $\left.c=1\right)$

\end{equation*}

where the right side of this equation can be compared to eq. (60). Especially for a terrestrial observer equipped with his usual coordinates $(\boldsymbol{r}(x, y, z))$

The motions perceived by two sitting-observers are homothetic to each other. All observers are equivalent and there is no priviliged observer.

## Gravitational Tide

Let two particles $A$ and $A^{\prime}$ submitted to the gravitational action of a massive particle of mass $M$ and located at the origin of coordinates. The two particles are assumed to be very close to each other. Let $\boldsymbol{r}$ and $\boldsymbol{r}^{\prime}$ their respective position vectors. Putting $\delta \boldsymbol{r}=\boldsymbol{r}^{\prime}-\boldsymbol{r}$, the relative motion is given by the equation

\frac{d}{d t}\left[\frac{\kappa[\gamma(t)]}{\kappa_{E}} \frac{d}{d t} \delta \boldsymbol{r}\right]=-\left(\frac{\kappa_{E}}{\kappa[\gamma(t)]}\right)^{2} M \frac{\left[r^{2} \delta \boldsymbol{r}-3(\delta \boldsymbol{r} \cdot \boldsymbol{r}) \boldsymbol{r}\right]}{r^{5}} \tag{122}
\end{equation*}
$$

Let us note that when $\kappa[\gamma(t)]<\kappa_{E}$, the self-interaction is strengthened.

## Two "paradoxes" that emerge from the motion of free particles

For a free motion the equation is

$$

i. A free particle (not submitted to any force) may exhibit an (apparent) auto-accelerated (or auto-decelerated) motion for a terrestrial observer. This result seems to be inconsistent with the first law of Newton. In fact the motion perceived by a terrestrial observer is fictitious. This motion is the image of a real motion taking place in the base. In the base the first law of Newton is obviously respected.
ii. Let two free particles $A$ and $A^{\prime}$, sufficiently close to each other to share the same $\kappa$, moving along parallel straight lines in the base. Paradoxically enough, for a terrestrial observer these particles can now appear to move toward and away from each other (Fig.15), following the sign of $\dot{\kappa}$.


Fig 15 : Apparent variation of a disk of constant size seen from the point of view of a terrestrial observer. The real size is the disk shown in gray.
In other words the trajectories of these particles no longer appear as two absolutely continuous parallel lines. Each of these lines rather appears as a kind of Devil's Staircase. The relative motion of these two particles reflects the apparent variation of the size of any astronomical object (a planetary system in a galaxy or a galaxy in a galaxy cluster), represented by a gray disk on figure 15. The variation represented on the latter figure has been artificially magnified. In reality such a variation is very slow and it cannot be detected on the scale of a few hundred of millennia. In the base the velocity $\dot{\boldsymbol{\sigma}}$ (denoted $\dot{\boldsymbol{\sigma}}_{b}$ on Fig. 15), measured by a fictitious observer, obeys to the equation (free particle)

$$

\end{equation*}

and $\dot{\boldsymbol{\sigma}}=$ const, whereas in the bundle the velocity $\kappa \dot{\boldsymbol{\sigma}}$ (measured by a local observer), obeys to the equation

$$

\end{equation*}

and in this case $\dot{\boldsymbol{\sigma}} \propto \kappa^{-1}$. If figure 15 displays the projection of a moving disk on the sky plane, for instance as seen by a terrestrial observer $E$, then the measured velocity is $\kappa_{E} \dot{\boldsymbol{\sigma}}$. For him the size of the disk (shown in orange) increases in a first phase and then decreases
in a second phase. Likewise the velocity of the disk varies as $\frac{\kappa_{E}}{\kappa}$ (increasing in a first phase and decreasing in a second phase). In fact the motion perceived by the terrestrial observer is fictitious, the real velocity is constant (free particle).

## 5 Conclusion

We have presented in this paper the formalism of the $\kappa$-model. Astonishingly this formalism is fairly straightforward when compared to other formalisms which try to modify the standard general relativity $[5,6,7]$. The $\kappa$-model is thus characterized by its relative simplicity. Furthermore any type of modified gravity necessarily leads to the introduction of new fields and surreptitiously to new particles. Thus all the various versions of modified gravity, with their lot of new unknown particles, even seems much more complex compared to the dark matter paradigm (Newtonian in essence), apparently for a very limited gain in the understanding. However the number of parameters in the modified gravity models is generally restricted to two or three. It is a very good point, also regardless of the type of modified gravity model, it can be considered as a predictive one whereas dark matter, with also two or three parameters but different for each galaxy, is not at all predictive, but merely postdictive. By contrast, it is indisputable that the MOND model [8, 9], at least in its original form, and characterized by an unique universal parameter, $a_{0}$, still constitutes even today the better way to predictively generate the rotational curves of individual galaxies. Unfortunately some issues persist for MOND at the scale of the galactic clusters, even though some solutions have been proposed to circumvent the problem [10]. The $\kappa$-model has the same level of efficiency as MOND to fairly predict the profiles of the rotational curves of individual spiral galaxies [4], but moreover can also help to understand the physics of galactic clusters [3]. Other interesting ways have also been suggested to circumvent the dark matter conundrum [11, 12, 13, 14,15]. We have already noticed that the latter theories share some common points with the $\kappa$-model [4]. Eventually we can report that, in parallel, a study focusing on the cosmological implications of the $\kappa$-model is in progress.
