# Signature of the atmospheric asymmetries of hot and ultra-hot Jupiters in light curves

#### Abstract

With the new generation of space telescopes such as the James Webb Space Telescope (JWST), it is possible to better characterize the atmospheres of exoplanets. The atmospheres of Hot and ultra-hot Jupiters are highly heterogeneous and asymmetrical. The difference between the temperatures on the day and night sides is especially extreme in the case of ultra-hot Jupiters. We introduce a new tool to compute synthetic light curves from 3D general circulation model (GCM) simulations, developed in the Pytmosph3R framework. We show how rotation induces a variation in the flux during the transit that is a source of information on the chemical and thermal distribution of the atmosphere. We find that the day-night gradient linked to ultra-hot Jupiters has an effect close to stellar limb darkening, but opposite to tidal deformation. We confirm the impact of the atmospheric and chemical distribution on variations in the central transit time, though the variations found are smaller than those in available observational data, which could indicate that the east-west asymmetries are underestimated, due to the chemistry or clouds.

## 1. Introduction

One-dimensional plane-parallel geometry is sufficient to explain low-resolution data in the case of cold planets, since the atmosphere is more or less homogeneous (MacDonald et al. 2020). However, in the case of hot Jupiters, this assertion does not hold anymore. Such planets, tidally locked and very close to their host star, present a strong dichotomy between their inflated hot day side and their cold and shrunken night side (Showman \& Guillot 2002; Showman et al. 2008; Menou \& Rauscher 2009; Wordsworth et al. 2011; Heng et al. 2011; Charnay et al. 2015; Kataria et al. 2016; Drummond et al. 2016; Tan \& Komacek 2019; Pluriel et al. 2020, 2022). It is necessary, then, to use models with more than one dimension to explain spectral features.

In the case of transmission spectroscopy, the sampled atmospheric space is limited to a narrow region around the terminator (Brown 2001; Kreidberg 2018), and we may extract information about the day and night sides from the signal Fortney et al. (2010); Caldas et al. (2019); Wardenier et al. (2022). Morningevening asymmetries may also have an impact on the spectrum (Line \& Parmentier 2016; Parmentier et al. 2016; MacDonald et al. 2020; Espinoza \& Jones 2021). Even so, retrieval techniques - that is, the inference of input parameters for the atmospheric simulation based on the fitting of a spectral observation - mostly relied on 1D models until quite recently. Studies have now started to include more dimensions (MacDonald \& Lewis 2022; Nixon \& Madhusudhan 2022; Zingales et al. 2022) for the fitting of observations.

Observations not only have spectral information, but also temporal information about how the observed flux varies over
time, and especially during the transit of one or more exoplanets. Konings et al. (2022) have also shown that stellar flares are also expected to have a time-dependent impact on transmission spectra (this effect will not be considered in this study).

The question is what information light curves (variations in the flux during the transit of an exoplanet) provide. Through time-resolved high-resolution spectroscopy, it is possible to detect species by cross-correlation of the features of each species (Prinoth et al. 2023). Prinoth et al. (2023) emphasize that the observational data is expected to fluctuate during the transit and is influenced by the characteristics of the atmosphere, such as the thermal dissociation occurring at very high temperatures on the day side of ultra-hot Jupiters. Using low-resolution spectral information, light curves can provide evidence of morning and evening asymmetries (Line \& Parmentier 2016; von Paris et al. 2016). They also allow us to probe other regions of the atmospheres, due to the rotation of the planet. Light curve models have historically relied on 1D spherical models (Kreidberg 2015; Tsiaras et al. 2016), though recent tools extend the concept to different shapes and dimensions (Maxted 2016; Akinsanmi et al. 2019; Jones \& Espinoza 2020; Barros et al. 2022; Grant \& Wakeford 2022).

There is a similar trend in emission spectroscopy. For example, Chubb \& Min (2022) rely on a 3D model to study phase curves, enabling them to extract information such as a shift of the hot spot in the simulation.

In this work, we consider 3D general circulation model (GCM) simulations (Wordsworth et al. 2011; Leconte et al. 2013), from which we can extract information such as a temperature map and the chemical composition of the atmosphere.

Caldas (2018); Caldas et al. (2019) introduced a tool, namely Pytmosph3R, which produces transmission spectra from the simulation data. A new, more user-friendly and open-source implementation of Pytmosph3R has since been introduced, namely Pytmosph3R 2.0 (Falco et al. 2022). The present paper is linked to a new release (2.2), which introduces light curves, among other functionalities. Section 2 describes the transit model parameters and details. Section 3 shows the biases of a homogeneous spherical 1D light curve model (a solid sphere, or a completely opaque ball), as generally used by the literature, to a full 1D atmospheric model. It is followed by a discussion (Sect. 5) on the impact of a 2D day-night temperature gradient approximation, as well as a full 3D GCM simulation on the shape of the resulting light curve, when taking into account rotation or when it is ignored. This has been studied for a hot Jupiter (WASP-39b) and an ultra-hot Jupiter (WASP-121b), both cases being presented in Sect. 4. We compare the effect of the rotation of a tidally locked planet to stellar limb darkening in Sect. 6, and to the ellipsoid approximation (Maxted 2016; Barros et al. 2022) in Sect. 7.

## 2. Transit model

We briefly reintroduce here the method that we use to compute the transit depth of an exoplanet. Let us consider a situation like the one represented in Fig. 1.
$\Gamma_{\mathcal{T}}$ is defined as the polar coordinate system of the transmittance grid, $\mathcal{T}$, located in the plane of the sky, orthogonal to the planet-observer axis. The points in this coordinate system are noted $(r, \theta)$. In this coordinate system, the point $\left(R_{P}, 0\right)$ is the projection of the northernmost point on the planet of radius $R_{P}$ on the transmittance grid. The transmittance grid, $\mathcal{T}$, is composed of $N_{r}$ radial points and $N_{\theta}$ angular points.

The rays of light crossing the atmosphere are partially absorbed by the interaction of the rays with the molecules present in the atmosphere. The opacity of each ray can be calculated through the optical depth, which has already been detailed in Caldas et al. (2019); Falco et al. (2022).

### 2.1. Transmittance map and spectrum

A transmittance map can be computed from the optical depth, $\tau$, via
$\mathcal{T}_{r, \theta}^{\lambda, \phi}=\mathrm{e}^{-\tau_{r, \theta}^{\lambda, \phi}}$,
for each ray $(r, \theta)$ in the transmittance grid, wavelength, $\lambda$, and phase, $\phi$. In the case of a homogeneous stellar disk, the relative dimming of the stellar flux of the planet and its atmosphere
during transit is given by
$\Delta_{\lambda}(\phi)=\frac{\pi R_{p}{ }^{2}+\sum_{r} \sum_{\theta}\left(1 \mathrm{c}^{-\tau_{r, \theta}^{\lambda, \phi}}\right) S_{r, \theta}^{\phi}}{\pi R_{s}{ }^{2}}$,
with $S_{r, \theta}^{\phi}=2 \pi\left(r+\frac{\mathrm{d} r}{2}\right) \mathrm{d} r / N_{\theta}$, for phases, $\phi$, when the planet is completely in front of the star. $R_{p}$ is the radius of the planet, $R_{s}$ the radius of the star, and $\mathrm{d} r$ the distance between two consecutive $r$.

However, during the ingress and egress, the surface area of $S_{r, \theta}^{\phi}$ will change according to its intersection with the stellar disk. The details of this calculation are laid out in Appendix A.

In this study, light curves were generated for 30000 wavelength points between 0.5 and $10 \mu \mathrm{~m}$.

### 2.2. Transit parameters

The transit is parameterized by the inclination of the orbit of the planet, its distance to the star, $a$ (i.e., the semi-major axis, or the orbit radius, since we consider the orbit to be spherical in the current study), and the number of phases at which we calculate the forward model.

The calculation of the transmittance map, $\mathcal{T}_{r, \theta}^{\lambda, \phi}$, is quite costly, so we calculate $N_{\mathcal{T}}$ transmittance maps, a number that can be different from the number of phases, $N_{\phi}$, for which we calculate Eq. (2). In practice, we therefore calculate $\mathcal{T}_{r, \theta}^{\lambda, \phi}$ for phases
$\phi_{\mathcal{T}}=\left\{\phi_{j}, \forall j \in\left[1, N_{\mathcal{T}}\right]\right\}$,
preferably with a low $N_{\mathcal{T}}$, and using these reference points, $\phi_{\mathcal{T}}$, we interpolate $\mathcal{T}_{r, \theta}^{\lambda, \phi}$ for the phases, $\phi_{\lambda}$ :
$\phi_{\lambda}=\left\{\phi_{i}, \forall i \in\left[1, N_{\phi}\right]\right\}$,
which enables us to calculate Eq. (2) for all phases, $\phi_{\lambda}$. The advantage of doing so is that $N_{\phi}$ can be much larger than $N_{\mathcal{T}}$ and we can therefore compute numerous time steps without enduring the full cost of the computation of a transmittance map for each and every one of them.

An alternative method to improve speed without significantly compromising accuracy is to distribute the points, $\phi_{\lambda}$, in a way that allocates more points for segments of the transit where the light curve is expected to exhibit a more intricate fluctuation. Considering homogeneous stellar disks in this study, this will take place during the ingress and egress. We considered the orbit to be spherical at this time. The phase at which the atmosphere will emerge from the transit (when it is not superimposed with the stellar disk anymore) - that is, the start of the egress - is equal to
$\phi_{\text {start }}=\arcsin \left(\frac{R_{S}-R_{P}+z_{\text {max }}}{a}\right)$,
where $z_{\text {max }}$ is the maximum altitude of the simulation, and $a$ is the planet's orbit radius. Similarly, the egress stage will stop at phase
$\phi_{\text {stop }}=\arcsin \left(\frac{R_{S}-R_{P}-z_{\max }}{a}\right)$.
These functions are valid only for circular orbits. They also depend on the scale of the simulation and the lower pressures for which the atmosphere has been computed.

We consider the egress to take place between $\phi_{\text {start }}$ and $\phi_{\text {end }}$, and the ingress between $-\phi_{\text {end }}$ and $-\phi_{\text {start }}$. The egress space defined by these points is discretized into $N_{\text {egress }}$ phases, the ingress into $N_{\text {ingress }}$ phases, and the rest of the phases $\left(N_{\phi}-\right.$ $\left.N_{\text {egress }}-N_{\text {ingress }}\right)$ discretize the plateau in between, when the entire atmosphere of the planet is completely superimposed with the stellar disk.

In practice, we set $N_{\text {ingress }}=N_{\text {egress }}$, and the implementation sets as $N_{\text {egress }}=N_{\phi} / 3$ by default. Setting a higher phase resolution for the egress or ingress allows us to better replicate the fineness of the egress or ingress, during which the intersection between the atmosphere's projection and the stellar disk is going to change drastically at each phase. During the rest of the transit, the main change in the transmittance is induced by the rotation of the planet. This can be approximated with a lower phase resolution, $N_{\phi}$, interpolated between the $N_{\mathcal{T}}$ phases (for which a transmittance map is computed). The matter of choosing $N_{\mathcal{T}}$ is discussed in Appendix B, considering a balance between accuracy and computational time.

## 3. Homogeneously opaque solid sphere one-dimensional fitting of the transmittance of a one-dimensional atmosphere

We study here the biases of 1D and homogeneously spherical light curve models, meaning those in which the entire solid sphere (or ball) is considered to be completely opaque. We show here that these models are able to retrieve the signal of a 1 D atmosphere almost consistently all along the transit, except during the ingress or egress. To that end, we thus compared two models:

1. the 1 D atmosphere, for which the light curve was generated via Pytmosph3R 2.2 (see details in Table 1); and
2. the homogeneously spherical model, which was generated via batman.
batman is a python package introduced by Kreidberg (2015) for modeling 1D transit and eclipse light curves, which were used as a reference point. A simple representation of the two models is shown in Fig. 2.

The diffuse opacity of the atmosphere (which generally decreases with the altitude) calculated by Pytmosph3R cannot be reproduced via a homogeneously opaque solid sphere. This effect is only visible when the atmosphere partially absorbs the star light; in other words, during the ingress or egress. This is shown in Fig. 3.

Though the integration of the opacity of the atmosphere over its apparent disk in Pytmosph3R is equal to the circular surface calculated by batman, the atmosphere calculated by Pytmosph3R extends over a larger space than that of batman, and is more transparent at high altitude, as is shown by the schematics in Fig. 2. Therefore, during the egress, the upper

part of the atmosphere in Pytmosph3R disappears from the transit before the equivalent disk in batman does, and the opacity of batman will thus be overestimated at the early stage of the egress. Reversely, it is underestimated in the late stage of the egress. The same holds true during the ingress.

The strength of this effect is relatively small (almost one order of magnitude) compared to the biases introduced by the spherical approximation in the presence of east-west or daynight asymmetries, which will be discussed in the following sections.

## 4. From hot to ultra-hot Jupiters

In the later sections, we will study the effects of asymmetries in hot and ultra-hot Jupiters on the associated light curves. For that purpose, we have selected three cases that we detail below.

## 4.1. ultra-hot Jupiter WASP-121b

In this study, we took a SPARC/MITgem simulation (Showman et al. 2009) of WASP-121b (Parmentier et al. 2018) as a reference for ultra-hot Jupiters. Its temperature map is shown in Fig. 4. This simulation has a strong day-night temperature gradient and also a shift of the hot spot toward the east. The chemistry includes He , $\mathrm{H}, \mathrm{H}_{2}, \mathrm{H}_{2} \mathrm{O}, \mathrm{CO}, \mathrm{TiO}$, and VO, for which some of the relevant distribution maps are displayed in Fig. 5.

The star temperature was set to 6460 K , its radius was set to $1.458 R_{\odot}$ (solar radii), and the orbital radius of WASP-121b was set to 0.025 au.

### 4.2. Two-dimensional day-night gradient

To be able to distinguish the signal due to day-night variations from the signal due to east-west variations in ultra-hot Jupiters, we took as an example a 2D description of the atmosphere, for which the temperature was defined using Eq. (7) following a day-night gradient, as was proposed by Caldas et al. (2019).

The atmosphere is thus symmetrical around the star-observer axis; that is, there are no morning-evening or east-west asymmetries. The parameters used in this study for this 2D case are listed in Table 1.

## 4.3. hot Jupiter WASP-39b

hot Jupiters and ultra-hot Jupiters have a notable difference concerning the strength of the equatorial jet and the resulting east-west asymmetries. We will take here the example of the hot Jupiter WASP-39b, which is based on the Met Office Unified Model (Drummond et al. 2018). For our simulation of WASP39b, we used a constant chemistry and chose two species that display a readily identifiable spectral signature; that is, $\mathrm{H}_{2} \mathrm{O}$ and

$\mathrm{CO}_{2}$, with a VMR of $3.57 \times 10^{-3}$ for $\mathrm{H}_{2} \mathrm{O}$ and $1.25 \times 10^{-4}$ for $\mathrm{CO}_{2}$. We used a $\mathrm{He} / \mathrm{H}_{2}$ ratio of 0.2577 . These abundances were not extracted from James Webb Space Telescope (JWST) observational data of WASP-39b. Our C/O ratio (0.03) is quite low compared to the ratios ( $>0.3$ ) retrieved by Rustamkulov et al. (2023) for WASP-39b and should thus be taken with caution. It should be noted that there is no CO in our simulation, while it should be a substantial part of the carbon-bearing species, and thus the C/O ratio. This study is focused on the observational implications of thermal asymmetries of hot Jupiters rather than simulating the exact case of WASP-39b. Temperature maps of our simulation for WASP-39b are displayed in Fig. 6. This figure shows the temperature structure of the atmosphere of a simulation corresponding to WASP-39b, sliced at an altitude of 7800 km and at the equatorial plane. The simulation presents a strong jet going eastward, with the hot spot shifted by more than $60^{\circ}$. The temperature of the equatorial jet is also still very hot on the night side ( $>1300 \mathrm{~K}$ ) at an altitude of 7800 km , and the temperatures in the overall equatorial inner annulus (up to around $10^{4} \mathrm{~km}$ ) are all higher than 1400 K . Above this altitude, the cold spot $(900 \mathrm{~K})$ is located between the west limb and the anti-stellar point (longitudes $\sim 200^{\circ}-280^{\circ}$ ). The west limb is more or less uniform, with a temperature around 1200 K .

This is quite different from the case of WASP-121b, in which the eastward shift of the hot spot is much less pronounced and does not reach the night side. The day-night gradient is therefore much stronger. The cold spot also covers more angle on the night side.

The star temperature was set to 5326.6 K , its radius was set to $1 R_{\odot}$, and the orbital radius of WASP-39b was set to 0.0486 au.

## 5. Biases of one-dimensional light curve retrievals of rotating hot to ultra-hot Jupiters due to atmospheric asymmetries

Using Pytmosph3R 2.2, we tried to unravel the biases inherent in 1D light curve models by generating light curves of 2D or 3D atmospheric models. For this purpose, we again used the 1D solid-sphere model batman (Kreidberg 2015), but also Juliet (Espinoza et al. 2019), a wrapper of multiple tools (including batman) that offers the possibility of fitting data through Bayesian inference (naturally here we focused on fitting light curves).

The parameters used for the Juliet retrievals are listed in Table 2. They include the time of inferior conjunction (midtransit), or the central transit time, normalized by the orbital period of the planet, and the planet radius and the orbit radius (considering a circular orbit) normalized by the host star's radius.

Appendix C discusses the impact of the time or phase resolution on the input light curve calculated by Pytmosph3R during a retrieval. The parameters used by Pytmosph3R in the calculation of the light curves are listed in Table B. 1 (i.e., the ingress and egress are discretized with a higher resolution). As is explained in Appendix C, all the light curves were re-interpolated over $N_{\phi}=300$ phases before feeding them to the retrieval in order to be statistically more adequate.

### 5.1. Biases during the ingress and egress for a translating ultra-hot Jupiter with a three-dimensional atmosphere (no rotation)

Let us start with a simple case, and assume that we can neglect rotation during the transit due to its brevity (we set the number of computed transmittances, $N_{\mathcal{T}}$, to 1 ). We use the term "translation" to refer to a transit for which rotation was not considered. We took the case of the ultra-hot Jupiter WASP-121b as an example and generated its light curve using Pytmosph3R 2.2. We also

generated the corresponding 1D solid sphere, homogeneously opaque, setting the input planet radius of batman to the apparent radius at mid-transit of the light curve of WASP-121b.

The difference between the 1D (batman) and 3D (Pytmosph3R) light curves is shown in Fig. 7. We can see on this figure the east-west asymmetry of the simulation. The spherical model (batman) finds an apparent disk larger than Pytmosph3R during the ingress and overestimates it during the egress. This effect is similar to Fig. 12 from von Paris et al. (2016), for example. This is due to the lower temperature in the west limb of the simulation, and higher temperature in the east limb as the hot spot on the day side is slightly shifted toward eastern longitudes, as is shown in Fig. 4. We will see that this effect can be partially reduced by changing the central time, $T_{0}$ (Sect. 5.3).

### 5.2. The translation approximation

Rotation is usually excluded from the current models, the planets being thought to be too cold and the transits too short for the rotation to usually have an effect on the light curve. We will try to characterize here the effects of the tidally locked rotation that can be expected, from a pure geometrical perspective (i.e., ignoring Doppler effects). In the "translation" case, the planet slides along the plane of the sky, ignoring the tidally locked rotation. Figure 8 shows the difference between light curves generated for WASP39b, the 2D day-night gradient, and WASP-121b, each with and without rotation ( $N_{\mathcal{T}}=8$ and $N_{\mathcal{T}}=1$, respectively).

In the case of WASP-39b (top plot), we can see that the signal is stronger in the early stage than the late stage. This is due to the fact that the cold spot is located near the western longitudes ( $\sim 200^{\circ}-280^{\circ}$, see Fig. 6). This cold spot moves toward the edge of the west limb during the late stage, accentuating the decrease in the apparent radius in the west. Indeed, the scale height of the atmosphere is linearly dependent on the temperature ( $H=R T / m g$, with $R$ standing for the ideal gas constant, $m$ the mean molar mass, $g$ the surface gravity, and $T$ the atmosphere temperature). The cold spot moves toward the anti-stellar point during the early stage, and is therefore less probed by stellar rays crossing the atmosphere on the star-observer axis. At the same time, the higher temperatures of the day side move to the

west limb, increasing its scale height. The effect is stronger for wavelengths with a high apparent radius (see Fig. 11 or Fig. 13, for example). The signals during the ingress and egress are also boosted, reaching a peak of almost 200 ppm . This peak during the ingress and egress is due to the overall day-night temperature difference.

To understand this effect, let us focus on the 2D day-night gradient simulation (middle plot of Fig. 8), for which the gradient between the day temperatures and the night temperatures is much stronger. The light curves in this case are symmetric with respect to the mid-transit, meaning that $\Delta_{\lambda}(\phi)=\Delta_{\lambda}(-\phi)$. The variations between different wavelengths are solely linked to the height of the absorption lines. In this case, the greatest differences between the rotation case and the translation case occur

(by far) during the ingress and egress, due to the (hotter) day side partially obscuring the star when the (colder) night side is out of the transit zone. For a visualization, one can see how the east limb is much larger (due to the day side being more visible) in the last transmittance map (late transit) in Fig. 9. This figure shows the example of WASP-121b, although the same effect is happening for the 2D day-night gradient. The west limb (which corresponds to a larger fraction of the night side) is much smaller and is going to disappear first from the signal during the egress. If we go back to Fig. 8, we can also see in the 2D case that, in the early and late stages, the differences between rotation and translation can go as low as -450 ppm due to the projection average area of the atmosphere being smaller (see again the same transmittance maps in Fig. 9). This difference follows a U-shaped curve during the transit, excluding the ingress and egress (the difference is close to zero at mid-transit but increasingly negative for phases far from mid-transit).

Our simulation of WASP-121b presents a very strong daynight asymmetry, but also a smaller east-west asymmetry. The U-shaped signal of the day-night gradient (as is discussed above for the 2D case) is again visible in the background in the 3D case (bottom plot of Fig. 8), but the east-west asymmetry breaks the symmetry of the pattern. The differences during the late-transit are positive. They are due to the shift of the hot spot on the day side to the east, as it moves toward the east limb during the late stage and is therefore more visible. The differences amount to more than 100 ppm during the ingress and egress (reaching a peak of 600 ppm in wavelengths with larger apparent radii). During the early and late stages, they can go as low as -450 ppm due to the day-night gradient and reach +100 ppm due to the shift of the hot spot.

Appendix B also shows the errors and the times expected for different numbers of transmittances maps $N_{\mathcal{T}}$ calculated during the transit (for faster calculation, interpolating between each phase, see Sect. 2.2), in the case of an ultra-hot Jupiter).

### 5.3. Central time variations and east-west effects

We are interested here in studying the relationship between the atmosphere characteristics and the variations in the central time, $T_{0}$, retrieved by the 1D spherical model of Juliet.

Rustamkulov et al. (2023) have published the variations in the central transit time, or time of inferior conjunction, $T_{0}$ (see
their extended data Fig. 3), for WASP-39b. They show variations in $T_{0}$ between -50 and +60 s , depending on the wavelength (going from 0.5 to $6 \mu \mathrm{~m}$ ). We have generated a synthetic light curve with Pytmosph3R for which we retrieve $T_{0}$, for wavelengths going from 1 to $5 \mu \mathrm{~m}$. We have done so for the hot Jupiter WASP-39b, considering a tidally locked rotation, and for the ultra-hot Jupiter WASP-121b. The results are shown in Fig. 10.

In the case of the 2D day-night model, as is shown in the middle plot of Fig. 8, the shape of the transit is symmetrical before and after the mid-transit; that is, $\Delta_{\lambda}(\phi)=\Delta_{\lambda}(-\phi)$, due to the symmetry of the simulation along the star-observer axis. Therefore, retrievals by Juliet find no variation in the time of inferior conjunction, $T_{0}$.

Figure 10 shows that the variations in the central time, $T_{0}$, are stronger in the case of the hot Jupiter WASP-39b than in the case of the ultra-hot Jupiter WASP-121b. This is due to the fact that east-west asymmetries are stronger in the case of the hot Jupiter than that of the ultra-hot Jupiter. The amplitude of the variations is around 5 s for all wavelengths (from 3 to 8 s ) in the case of the ultra-hot Jupiter WASP-121b, meaning that the retrieval method finds a solid-sphere equivalent planet that transits 5 s late compared to the actual planet. It is 10 s at minimum (around $1 \mu \mathrm{~m}$ ) and goes up to 22 s (around $4.5 \mu \mathrm{~m}$ ) for the hot Jupiter WASP39b. For WASP-39b, the spectral features are clearly visible. As for errors on the flux discussed above, wavelengths with larger apparent radii are also linked to a larger bias in the transit timing.

In the case of WASP-39b, Rustamkulov et al. (2023) show an amplitude of more than 50 s on the same spectral range. Thus, we manifestly do not account for the whole amplitude of the variations in $T_{0}$. This could be due to cloud coverage or the chemical structure of the simulation. As was mentioned before, we considered a quite simple constant chemistry for this simulation. The observational (Rustamkulov et al. 2023) and simulated data (this study) central time variations both follow the spectral features and especially the $\mathrm{H}_{2} \mathrm{O}$ and $\mathrm{CO}_{2}$ bands. Both data can also be fitted by a non-zero slope linear regression. Let us assume a linear fit under the form $a x+b$, where $x$ is within $1-5 \mu \mathrm{~m}$. In the case of the observational data (Rustamkulov et al. 2023), we obtain $a=2.07$ and $b=-4.77$, while we obtain $a=1.40$ and $b=12.68$ for our simulation of WASP-39b. The differences between the slope values (a) may be due to the stellar spectrum (if the real stellar temperature is different from ours, which is 5326.6 K ) but

also to our choice of chemistry, which does not correspond to the actual observations of WASP-39b. Indeed, a potential discrepancy in our simulation is the absence of CO, as there is a CO band around $5 \mu \mathrm{~m}$. The differences might also arise from an overestimated amount of $\mathrm{H}_{2} \mathrm{O}$, as the water bands dominate the wavelengths shortward of $3 \mu \mathrm{~m}$.

In our translation simulation of WASP-121b (displayed in orange in the bottom plot of Fig. 10) the shift in the transit timing (on the order of 5 s for all wavelengths) is in line with previous results. Indeed, Line \& Parmentier (2016) found that light curve residuals could be reduced by a factor of ten when shifting the transit timing of $\sim 10^{-5}$ and $\sim 10^{-4}$ days, following the scale height difference between the morning and evening limbs of the planet.

The value found for $T_{0}$ in this translating case is also impacted by the chemistry. For example, the value found for $\lambda=0.6 \mu \mathrm{~m}$ in the translation case is higher than in the other one, due to the distribution of TiO in the simulation. TiO is less symmetrically distributed than its counterparts $\mathrm{H}_{2} \mathrm{O}$ and CO , and therefore its east-west asymmetry leads to an overestimation of

$T_{0}$. Other spectral features have less impact over the variations in $T_{0}$ and one might have difficulties in distinguishing the water or CO bands from the error bars.

When we account for the tidally locked rotation of WASP121b (blue curve in Fig. 10), the central time is shifted by the same order of magnitude, around 5 s . However, there are some differences, including in the spectral region dominated by the opacity of $\mathrm{TiO}(<1 \mu \mathrm{~m})$, where the shift is slightly smaller. This could be linked to the distribution of TiO in the atmosphere, which is indeed present at higher altitude on the east limb, but also in both terminators. The fact that the planet rotates seems to reduce the difference between the east and west limbs, due to the fact that the oversized east limb (see Fig. 5) is reduced by being partly masked from the observer during the early and late stages, and the east-west differences are therefore less visible than in the translation case. In the translation case, the east-west asymmetries present in both limbs stay constant throughout the whole transit. Concerning the impact of the chemistry, we can hardly see the spectral signatures in either the rotating case or the translating case. Spectral signatures are much more significant in the variations of $T_{0}$ in the hot Jupiter WASP-39b than in the ultra-hot Jupiter WASP-121b.

### 5.4. Reduced radius retrieved due to the rotation of the planet

Due to the shape of the signal during the transit (a $U$ shape due to the day-night gradient or a slope due to east-west asymmetries), which cannot be simulated by a 1D spherical model, 1D retrievals will tend to average the observed radius over the whole duration of the transit.

In the case of WASP-39b, the radius retrieved for the rotation and the translation case is displayed in Fig. 11. In the 2D daynight case, the radius retrieved for the rotation and the translation case is displayed in Fig. 12. In the case of WASP-121b, the radius retrieved for the rotation and the translation case is displayed in Fig. 13.

One may notice that the retrieved values for the planet radius are almost always inferior to the input value. This is due to the

fact that the input value shown in the plot is taken at mid-transit. For light curves that have a $U$ shape, the average value of the signal will always be lower than the mid-transit value, since it is the maximum value of the whole transit. This is more readily visible in Fig. 14. The input radius given to batman is the maximum apparent radius, $R_{P}$, of the light curve generated via Pytmosph3R, and hence the residual of batman is always equal to zero when the light curve of Pytmosph3R reaches its minimum. In this case, there is no meaningful value of $R_{P}$ for either batman or Juliet since the 1D model used cannot reproduce the nonlinear curve shape during transit due to the asymmetries in the input model.

The differences between the Juliet retrieved light curves and the 2D day-night simulation are almost constantly at their

maximum in mid-transit (Fig. 14), and thus the retrieved apparent radii in Fig. 12 also have the largest errors among the three examples. Indeed, in the cases of WASP-39b and WASP-121b, the light curves in some wavelengths follow a slope instead of a U-shaped curve, and the maximum difference between the retrieved value of $R_{P}$ and its initial value is therefore not at mid-transit but during the early and late stages (the retrieved value being an average of the overall slope, it is closer to the intermediate value of $R_{P}$ in mid-transit).

If we take a closer look at Fig. 14, we can see that Juliet always overestimates the apparent radius during the early and late stages of the transit (which is equivalent to saying that it underestimates the relative flux). This is due to the fact that the projection of our 3D simulation of WASP-121b over the observer's field of view is larger in mid-transit, as was explained in previous sections (the hot temperatures from the day side contribute to the absorption all around the terminator), and smaller during early and late stages, due to the hot day-side temperatures being replaced by the night side's on the east and the west limbs, respectively (see Fig. 9 for a visualization).

During the ingress and egress, Juliet underestimates the apparent radius compared to the input simulation due to the day side being the major part of the atmosphere obscuring the star (the night side exits the transit before the day side and enters after the day side).

In conclusion, a 1D model would be biased up to a few hundred ppm depending on the current phase of the transit due to

the rotation of the tidally locked planet. One might need to take this effect into account in the calculation of the limb darkening associated with the star.

## 6. Rotation of the atmospheric signal versus limb darkening

Since the 2D day-night gradient introduces a reduction of the signal during the early and late stages, the effect could be mistaken for the limb darkening of the star. When considering limb darkening, the flux emitted by the star when the planet is obscuring the edge of the star is lower than when it obscurs the center. Limb darkening therefore also induces a U-shaped signal in the transit light curve, which is coincidentally similar to the effect of the day-night gradient of the planet, although the U-shaped signal does not have the same properties. We will consider here a quadratic law for the limb darkening.

In this section, we retrieve the light curves generated via Pytmosph3R for the 2D day-night gradient case and WASP-121b. The limb-darkening-specific parameters retrieved by Juliet are listed in Table 2.

Figure 15 shows the differences between the 1D retrieved model, including limb darkening, and the input light curve calculated via Pytmosph3R for WASP-121b. Let us keep in mind here that the ingress-egress reductions are mainly due to the $T_{0}$ shift, as is discussed in Sect. 5.3. We are therefore more interested in the full transit. We can see that the $U$ shape of the limb-darkening light curve (here using a quadratic law) is a better match for most wavelengths, as it can better fit the $U$ shape or slope of the Pytmosph3R light curve.

However, this better fit does not represent the original data, in which no limb darkening was used. The limb-darkening
coefficients retrieved are shown in Fig. 16. The values of these retrieved coefficients vary from one wavelength to another. Around $1 \mu \mathrm{~m}$, the shape of the light curve is almost flat for the 2D day-night gradient, and thus the limb-darkening coefficient is very low. The shape of the spectral features can be easily distinguished in the values of $q_{1}$.

The retrieved apparent radius, shown in Fig. 13, is therefore even more biased when it comes to the day-night thermal difference (top plot). East-west effects of the simulation of WASP-121b (bottom plot) seem to reduce this bias. Indeed, the retrieved values of the limb-darkening coefficients in the case of WASP-121b are much smaller than for the 2D day-night gradient, as is shown by Fig. 16, and the resulting retrieved light curve is consequently closer to a retrieval without limb darkening.

There are two caveats to this study. The first one is that we generated the forward light curves without limb darkening. This is an implementation issue, as the computation of the intersection area of the transmittance grid with the stellar disk (see Appendix A) relies on the assumption that the stellar flux is uniform over the disk. To take into account the limb darkening of the stellar flux, one should use a different method; that is, integrate the flux over each cell by discretizing the cell following the radial dimension, allowing us to plug in the limb darkening law, based on the radial coordinate. One downside of this integration is its additional cost, which would slow down the overall computation. This has not been implemented in our model yet.

The second caveat is that these limb-darkening fits were done using the quadratic law. It could be interesting to see how other laws behave, although studying other limb-darkening laws in addition to the generation of limb-darkening forward 3D light curves deserves the focus of an entire study

and is thus not addressed further here. We emphasize that the retrieved limb-darkening coefficients depend on the wavelength and we therefore conclude that light curves retrievals of ultra-hot Jupiters should be realized over multiple wavelengths to avoid being biased by the day-night gradient of the planet's atmosphere.

## 7. Atmosphere versus ellipsoid rotation in the case of ultra-hot Jupiters

Barros et al. (2022) propose using an ellipsoid model to fit the light curve of Wasp-103b, using ellc, a tool developed by Maxted (2016) that provides an ellipsoid light curve model that also has the ability to conduct a Bayesian analysis. They suggest that this model fits the data better than a spherical model. However, as we can see in Fig. 17, the light curve generated by Pytmosph3R (with a spherical core, it should be noted) is better fitted by the spherical model. We used a Love number equal to 1.39 in this study, corresponding to WASP-121b (Hellard et al. 2020).

The deformation of the ellipsoid has the reverse shape to that of the atmospheric signal of the day-night temperature gradient (see the light curve at $0.6 \mu \mathrm{~m}$, for example). This is due to the apparent surface projected onto the plane of the sky. As is shown in Fig. 18, the ellipsoid covers more surface during the early and late stages compared to the mid-transit stage. The atmospheric signal due to the day-night dichotomy of ultra-hot Jupiters has a reverse effect, as was mentioned before: the atmosphere covers more surface during the mid-transit stage due to the hot day side being visible all around the limb, while the night side is more visible during the early and late stages, decreasing the scale height of the atmosphere and the apparent surface (see Fig. 9).

For hot Jupiters, when the atmospheric signal is more influenced by east-west effects than by day-night thermal differences, this is less visible.

We can therefore only conclude that if the ellipsoid model is indeed fitting better the original data of Wasp-103b, the actual Love number found may be underestimated due to the signal linked to the atmosphere, and more especially if there is a strong day-night dichotomy. A coupling between a tidally deformed core and an atmospheric model would be needed to study both effects simultaneously.

## 8. Conclusion

In this paper, we have introduced a novel framework to compute light curves from a 3D GCM simulation. The parameters of the model include the planet's orbit radius, period (optional, but necessary for the conversion between phase and time), and inclination, as well as the number of phases and transmittances

for computing the light curve. The documentation for this tool, Pytmosph3R 2.2, is available here ${ }^{1}$.

We used Pytmosph3R to generate light curves in either 2D (with a day-night temperature gradient) representative of an ultra-hot Jupiter, or in 3D (with simulations of WASP-121b and WASP-39b) and studied how 1D models behave in retrieving such data. The 1D light curve retrieval model used is Juliet (Espinoza et al. 2019), which is based on the 1D light curve model batman (Kreidberg 2015).

Our conclusions are that the 2D day-night dichotomy of an ultra-hot Jupiter has two impacts on the light curve: 1) the planet's apparent radius decreases in the early and late stages of the transit, compared to the mid-transit, leading to a U-shaped light curve, and 2) the planet's apparent radius increases during the ingress and egress due to the day side obscuring the star longer than the night side.

The light curve's $U$ shape due to the day-night thermal dichotomy may be confused with limb darkening. However, the limb-darkening coefficients depend on the wavelength, and could therefore be distinguished from the atmospheric signal in this way. East-west asymmetries might also enable this degeneracy to be broken.

Furthermore, we find that the atmospheric signal of a daynight strong temperature gradient has a signature opposite to the tidal deformation of the planet's core (not taking into account east-west asymmetries), and therefore the Love number retrieved by an ellipsoid model may be underestimated if the atmospheric signature in the light curve is not taken into account.

The east-west asymmetries of the ultra-hot Jupiter simulation (WASP-121b) are also visible in the light curve data, and will mostly translate as a shift in the time of the mid-transit (or central transit time) $T_{0}$ for the light curve retrieval code. As the hot spot is shifted to the east in our simulation, the planet's apparent radius appears larger during the late (egress) stage compared to the early (ingress) stage. We included TiO/VO in our simulations. However, recent studies show that WASP-121b might be depleted in TiO/VO Hoeijmakers et al. (2024). This does not change the general conclusions of the study.

The east-west asymmetries are stronger in the case of the hot Jupiter WASP-39b, leading to a larger shift in the central transit time, $T_{0}$, retrieved by the 1D retrieval model. This simulation of WASP-39b is linked to a shift that can be as large as 20 s and that varies from one wavelength to another. Between 1 and 5 $\mu \mathrm{m}$, the amplitude of these variations is around 17 s . This is less than the real observations by JWST (Rustamkulov et al. 2023), which could be due to the chemistry or cloud structure in the atmosphere.

A very promising tool that could better describe the spatial deformations of the atmosphere comes under the form of transmission strings, namely harmonica (Grant \& Wakeford 2022). In this tool, the planet's radius is described as a function of

[^0]the angle around the limb, parameterized in terms of Fourier series. Further studies could investigate how well this model may retrieve a full 3D GCM light curve generated via Pytmosph3R.

## Appendix A: Area of intersection between transmittance cells and the stellar disk

The transmittance map is defined using the polar coordinate system, $\Gamma_{\mathcal{T}}$, and a grid of $N_{r}$ radial points and $N_{\theta}$ angular points. To properly evaluate the opacity of each cell in this grid, defined by its boundaries, ( $r_{1}, r_{2}, \theta_{1}, \theta_{2}$ ), we need to calculate the surface of intersections between the star apparent disk and this cell $S_{r, \theta}^{\phi}$ (see Eq. (2)). This is illustrated by Fig. A.1.


Fig. A.1: Area of intersection, $A$ (in red), of one cell $\left(r_{1}, r_{2}, \theta_{1}, \theta_{2}\right)$ in the transmittance grid with a stellar disk of radius $R s$. The star center is located at ( $r_{S}, \theta_{S}$ ). The coordinates follow the transmittance coordinate system $\Gamma_{\mathcal{T}}$.

The star's projected center is defined as the point at coordinates $\left(r_{S}, \theta_{S}\right)$ in $\Gamma_{\mathcal{T}}$. Its Cartesian coordinates are $x_{S}=D \sin \left(\theta_{S}\right)$ and $y_{S}=D \cos \left(\theta_{S}\right)$. The boundary of the stellar disk is defined as a circle of radius $R_{S}$ around that point. The points $(0,0),\left(r_{S}, A s\right)$ and $(r, \theta)$ form a triangle whose sides are equal to $r_{S}, r$, and $R_{S}$. The law of cosines states:
$R_{S}{ }^{2}-r^{2}-r_{S}{ }^{2}+2 r \cdot r_{S} \cos \left(\theta-\theta_{S}\right)=0$.
For a fixed angle, $\theta$, we can rewrite Eq. (A.1) as
$r^{2}+b \cdot r+c=0$,
with $b=-2 r \cdot r_{S} \cos \left(\theta-\theta_{S}\right)$ and $c=r_{S}{ }^{2}-R_{S}{ }^{2}$, which is a polynomial equation of degree 2 that can easily be solved to get $r$. The angle, $\theta$, can be computed from a fixed $r$ by rewriting Eq. (A.1) as
$\theta=\theta_{S} \pm \arccos \left(\frac{R_{S}^{2}-r^{2}-r_{S}^{2}}{-2 r \cdot r_{S}}\right)$.
It should be noted that for both Eqs. (A.2) and (A.3), there are zero, one, or two solutions. We can apply Eqs. (A.2) and (A.3) to find all intersections of the star boundary (circle of radius $R_{S}$ ) with the radial and angular points of the transmittance grid. A cell of the transmittance grid is defined using its boundaries, $\left(r_{1}, r_{2}, \theta_{1}, \theta_{2}\right)$. The area of the cell $\left(r_{1}, r_{2}, \theta_{1}, \theta_{2}\right)$ can be expressed as

& A_{\text {cell }}\left(r_{1}, r_{2}, \theta_{1}, \theta_{2}\right)= \\
& \left|A_{\text {sector }}\left(r_{2}, \theta_{1}, \theta_{2}\right)-A_{\text {sector }}\left(r_{1}, \theta_{1}, \theta_{2}\right)\right| \tag{A.4}

Fig. A.2: Intersection of one sector $\left(r, \theta_{1}, \theta_{2}\right)$ of the transmittance grid (boundaries in blue) with the star (boundaries in yellow). The intersection area can be subdivided into the sum of circular segments (yellow when the circle is the star; blue when the circle is the planet) and triangles (subparts of $A_{0}$, in red). Here, the maximum number of intersections has been displayed. Fig. A. 3 shows examples of cases with fewer intersections.
(see Fig. A. 1 for an illustration of the intersection area). Therefore, following Eq. (A.4), we now reduced the problem to finding the area of a sector of the transmittance grid, $A_{\text {sector }}\left(r, \theta_{1}, \theta_{2}\right)$, as is illustrated in Fig. A.2. As is shown in this figure, this intersection can be expressed as the sum of simpler geometric objects, composed of circular segments and triangles. We express below the intersection for the maximum number of intersections. If an intersection is outside the sector, we can simply select the nearest corner instead. If there are no intersections (no solution to either Eq. (A.2) or Eq. (A.3)), two circular segments will join. Examples of such cases are shown in Fig. A.3.


Fig. A.3: Examples of cases with fewer intersections between the sector $\left(r, \theta_{1}, \theta_{2}\right)$ and the star. Some areas have merged together.

The area of a triangle can be computed from its sides, $a, b$, and $c$, using Heron's formula:
$A_{\text {triangle }}(a, b, c)=\sqrt{s(s-a)(s-b)(s-c)}$,
where $s=(a+b+c) / 2$.
The area of a circular segment of angular width, $\alpha$, for a circle of radius, $R$, is given by
$A_{\text {segment }}(\alpha, R)=\left|\frac{\alpha-\sin (\alpha)}{2} R^{2}\right|$.
Finally, we consider the core of the planet to be completely opaque, and therefore the surface area of intersection of a core of radius $R_{P}$ with the stellar disk of radius $R_{S}$, of which the centers are at a distance, $r_{S}$, is equal to the area of intersection of two disks. If $d \geq R_{S}+R_{P}$, then the surface area of intersection is zero. Otherwise, if $d \geq\left|R_{S}-R_{P}\right|$, the surface is equal to the area of the smallest circle. Alternatively, we can use

$$
\begin{align*}
A_{\text {circles }}\left(R_{P}, R_{S}, d\right)= & R_{P}^{2} \arccos \left(\frac{A_{P}}{R_{P}^{2}}\right) \\
& +R_{S}^{2} \arccos \left(\frac{A_{S}}{R_{S}^{2}}\right) \\
& -A_{P} \sqrt{R_{P}-A_{P}^{2}} \\
& -A_{S} \sqrt{R_{S}-A_{S}^{2}}, \tag{А.7}
\end{align*}
$$

where

$$
\begin{align*}
A_{P}=\frac{R_{P}^{2}-R_{S}^{2}+d^{2}}{2 d}, \\
A_{S}=d-A_{P} . \tag{A.8}
\end{align*}
$$

These equations are equivalent to Eq. (3) from Kreidberg (2015).

## Appendix B: Convergence and computational cost

We have previously validated the computation of transmission spectra in Pytmosph3R in Falco et al. (2022) by studying the stability of the model when changing the position of the observer in the frame of reference of the planet.

We have also validated our light curve implementation using batman in the case in which no atmosphere is present, but this comes down to validating the equations calculating the intersection area of two circles; that is, Eq. (A.7), or its equivalent, Eq. (3) in Kreidberg (2015).

We have in addition studied the convergence of the light curve module in Pytmosph3R. Studying a case that is symmetric along the star-observer axis (translation 2D day-night temperature map defined in Eq. (7), or 1D), the number of angular points in the transmittance map $\left(N_{\theta}\right)$ should have no effect on the resulting integral. We have observed an accuracy of less than 1 ppm for all $N_{\theta}$ in the 2D case of Table 1. The parameters used for generating light curves with Pytmosph3R are listed in Table B.1.

We have also introduced a number of transmittance maps, $N_{\mathcal{T}}$, to calculate all along the transit in Sect. 2.2. For the rest of the $N_{\phi}$ phases, the transmittance map is interpolated from the
$N_{\mathcal{T}}$ maps. We assume that the $N_{\mathcal{T}}$ maps are regularly distributed in the phase space. This induces an error in the resulting light curve. Fig. B. 1 shows the errors that one can expect when using a number of transmittance maps, $N_{\mathcal{T}}$, that is too low for a hot Jupiter (2D study case of Table 1). With $N_{\mathcal{T}}=1$, we can actually

see the effect of not including rotation in the model, which is not negligible. This is discussed more at length in Sect. 4.2.

Computing one transmittance map scales with the number of molecules, the spectral resolution, and the atmospheric resolution used. We can see in Fig. B. 2 how interpolating between
the $N_{\mathcal{T}}$ transmittances can prove to be very effective.


Fig. B.2: Cost of increasing the number of transmittances $N_{\mathcal{T}}$ computed for 30000 wavelengths. The 2D study-case has been used for this experiment (Table 1).

Overall, $N_{\mathcal{T}}=8$ seems to be an acceptable trade-off between computational time and accuracy. It even seems acceptable to use $N_{\mathcal{T}}=5$, though this might prove to be inadequate in some cases.

## Appendix C: Time or phase resolution in light curve retrieval

When generating a light curve with Pytmosph3R, the default option will discretize the ingress or egress with a higher resolution (in the time, or phase, dimension), compared to the rest of the transit, as a trade-off between accuracy and computational time. We therefore discuss here the difference between light curves:

- generated using Pytmosph3R with no resampling, here with parameters from Table B.1; that is, $N_{\text {egress }}=30$ and $N_{\phi}=$ 100 , and
- interpolated from the above over $N_{\phi}=300$ equally distributed phases.

The values retrieved by Juliet are shown in Fig. C. 1 for both cases, and the corresponding light curves are shown in Fig. C.2.

The egress or ingress (which lasts a shorter amount of time than the rest of the transit) is overrepresented from a statistical point of view in case one. This leads to a bias in the retrieval, in which the algorithm will try to minimize the egress or ingress more that the rest of the transit. To avoid this statistical bias, we can interpolate the signal over a finer phase grid, or we can change the weight of each point using the error bars used in the retrieval. We have used the first method here, though they are equivalent from a statistical point of view.

We can see that in case one in Fig. C, the apparent radius during the main transit (when the planet, including its atmosphere, is fully in front of the star, excluding the ingress or egress) is underestimated by Juliet by more than 50 ppm at $0.6 \mu \mathrm{~m}$. This

is more than the maximum residual during the ingress or egress, though this varies from wavelength to wavelength.

In case two (Fig. C), the maximum residual always occurs during ingress or egress, and more precisely when only a small portion is either in front or out of the star (due to the atmosphere

opacity, in a similar way as is explained in Fig. 3 and Fig. 2).
In conclusion, we highly recommend that a user of Pytmosph3R be aware of this statistical bias. When computing a light curve with a higher resolution over the ingress or egress (for computational reasons), one should always either interpolate it over an equally distributed sample, or change the error bars accordingly, before using it in retrieval methods.

This study does not take into account other biases that unfold when changing the temporal binning of light curves and we refer interested readers to Kipping (2010) for more information.
