
# From Ethology to Robotics ....

□ How can Ethology contribute biomimetic arguments in Robotics ?

- If a living organism survives, it may have developed behaviours that solve problems
  - What kind of solutions ... in what contexts (i.e. scale, mechanical, physical, chemical)?
  - If this is the case, what kind of behaviours are involved ? and how do they emerge ?
    - Are they related to stuctural materials or mechanics ?
    - Do they involve sensory-motor organisation ?
    - How are these behaviours regulated and organised (from « cells » to network and cognition) ?
    - Are the emergent behaviours optimal ?


#### Auto-optimization of locomotion pattern in vertebrates ..... criteria identification




Walking and running patterns so as the switch from one to the other are in accordance with the optimization of :

Stack of constraint priorities


Minimal joints moments

Energy cost


**Running pattern generation**

Cheetah » asymetric pattern emerges at 30 km/h to optimize stability and energy transfer at high speed.




# From Robotics to Ethology....

□ How can robots be used to test Ethology's hypothesis ?

- If a robot behaves correctly, it is the physical demonstration that a solution has been identified and correctly implemented (Physical proof of concept).
- Biomimetics approach can be apply at many levels
  - Structure mechanics and materials ?
  - Sensors and engine ?
  - Biomimetic algorithms to address regulation and organisation
    - Inverse optimal control, deep learning etc ...
- Sometimes, the robot reveals an unlikely solution

<u>Survival advantages :</u> High speed : 2m/s Avoid contacts with sand (60-70°C)




- Inverse engineering biomimetic approach to address Ethology.....


