# Explicit formulae for the mean value of products of values of Dirichlet $L$-functions at positive integers

#### Abstract

Let $m \geq 1$ be a rational integer. We give an explicit formula for the mean value $$
\frac{2}{\phi(f)} \sum_{\chi(-1)=(-1)^{m}}|L(m, \chi)|^{2},
$$ where $\chi$ ranges over the $\phi(f) / 2$ Dirichlet characters modulo $f>2$ with the same parity as $m$. We then adapt our proof to obtain explicit means values for products of the form $L\left(m_{1}, \chi_{1}\right) \cdots L\left(m_{n-1}, \chi_{n-1}\right) \overline{L\left(m_{n}, \chi_{1} \cdots \chi_{n-1}\right)}$.


## 1 Introduction

For $m \geq 1$ and $f>2$, let

$$
M(m, f)=\frac{2}{\phi(f)} \sum_{\chi(-1)=(-1)^{m}}|L(m, \chi)|^{2}
$$

denote the mean value of $|L(m, \chi)|^{2}$, where $\chi$ ranges over the $\phi(f) / 2$ Dirichlet characters modulo $f$ such that $\chi(-1)=(-1)^{m}$, i.e. over the Dirichlet characters modulo $f$ of the same parity as $m$.

The first step towards the study of these $M(m, f)$ 's was made in [Wal], where the formula for $M(1, f)$ was obtained, but only for prime moduli $f$. Secondly, in [QiMG] and [Lou93] the formula for $M(1, f)$ for non necessarily prime moduli $f$ was obtained. Thirdly, in [Lou01] a method was developed for obtaining recursively a formula for $M(m, f)$ for a given $m$. This method was applied to obtain the formulae below for $M(m, f)$ for $m=1,2,3$ and 4. Fourthly, in [Lin] the author developed another way for obtaining recursively a formula for $M(m, f)$ for a given $m$. S. Louboutin and X. Lin's methods are easy to use with any software for mathematical computation for obtaining a formula for $M(m, f)$ for a given $m$. But they did not give an explicit formula for these $M(m, f)$ 's. Fifthly, in [LZ] the authors gave a rather complicated but explicit formula for $M(m, f)$ and the mean value of the product of the values of two Dirichlet $L$-functions at positive integers of the same parity.

[^0]Here, inspired by [BY, Proof of Theorem 2.1], we obtain in Theorem 1 an explicit formula for these $M(m, f)$ 's. Then, we extend our method developed to obtain Theorem 1 to get in Theorem 7 an explicit formula for the mean value of more general products of the form $L\left(m_{1}, \chi_{1}\right) \cdots L\left(m_{n-1}, \chi_{n-1}\right) \overline{L\left(m_{n}, \chi_{1} \cdots \chi_{n-1}\right)}$. In particular, for $n=2$ we obtain in Theorem 9 a much simpler formula than the one given in [LZ, Theorem 1.1] for the mean value of the product of the values of two Dirichlet $L$-functions at positive integers of the same parity.

Theorem 1. For $m=1$ we have

$$
\begin{equation*}
M(1, f)=\frac{\pi^{2}}{6}\left(\phi_{2}(f)-3 \frac{\phi_{1}(f)}{f}\right) \tag{1}
\end{equation*}
$$

and for $m \geq 2$ we have
$M(m, f)=\zeta(2 m) \times\left(\phi_{2 m}(f)+(-1)^{m-1}\binom{2 m}{m} \sum_{k=1}^{\lfloor m / 2\rfloor} \frac{m}{m-k}\binom{m}{2 k} \frac{B_{2 k} B_{2(m-k)}}{B_{2 m}} \frac{\phi_{2 k}(f)}{f^{2 m-2 k}}\right)$,
where $\phi_{l}(f)=\prod_{p \mid f}\left(1-1 / p^{l}\right)$ and the Bernoulli rational numbers $B_{k}$ are given by

$$
\frac{t}{e^{t}-1}=\sum_{k \geq 0} \frac{B_{k}}{k!} t^{k}
$$

In particular, $M(m, f)$ is asymptotic to $\zeta(2 m) \phi_{2 m}(f)$ as $f$ goes to infinity.
For example, in accordance with [Lou93, Theorem 2] and [Lin, Page 371] we have:

$$
\begin{aligned}
M(2, f) & =\frac{\pi^{4}}{90}\left(\phi_{4}(f)+10 \frac{\phi_{2}(f)}{f^{2}}\right) \\
M(3, f) & =\frac{\pi^{6}}{945}\left(\phi_{6}(f)-21 \frac{\phi_{2}(f)}{f^{4}}\right) \\
M(4, f) & =\frac{\pi^{8}}{9450}\left(\phi_{8}(f)+\frac{14}{3} \frac{\phi_{4}(f)}{f^{4}}+\frac{200}{3} \frac{\phi_{2}(f)}{f^{6}}\right) \\
M(5, f) & =\frac{\pi^{10}}{93555}\left(\phi_{10}(f)-22 \frac{\phi_{4}(f)}{f^{6}}-231 \frac{\phi_{2}(f)}{f^{8}}\right)
\end{aligned}
$$

## 2 Proof of Theorem 1

Theorem 1 readily follows from the well known formula

$$
\begin{equation*}
\zeta(2 m)=(-1)^{m-1} \frac{(2 \pi)^{2 m} B_{2 m}}{2 \cdot(2 m)!} \tag{2}
\end{equation*}
$$

and from following Lemmas 2, 3 and 4.
Lemma 2. (See [Lou01, Proposition 3 and Proof of Proposition 5]). Let $m \geq 1$ and $f>2$ be rational integers. Let $\cot ^{(k)}$ denote the $k$ th derivative of $\cot :=\cos / \sin$. We have

$$
M(m, f)=\frac{\pi^{2 m}}{2 \cdot((m-1)!)^{2} f^{2 m}} \sum_{\substack{d \mid f \\ d>1}} \mu(f / d) S_{m}(d)
$$

where

$$
S_{m}(d):=\sum_{k=1}^{d-1}\left(\cot ^{(m-1)}(\pi k / d)\right)^{2} \quad(d>1)
$$

Lemma 3. If $R(X)=\sum_{l=0}^{k} r_{k, l} X^{l} \in \mathbb{Q}[X]$ is such that $R(1)=0$, then for $f>2$ we have

$$
\sum_{\substack{d \mid f \\ d>1}} \mu(f / d) R(d)=\sum_{d \mid f} \mu(f / d) R(d)=\sum_{l=1}^{k} r_{k, l} \phi_{l}(f) f^{l}
$$

Proof. Notice that $\sum_{d \mid f} \mu(f / d) d^{l}=\sum_{d \mid f} \mu(d)(f / d)^{l}=f^{l} \phi_{l}(f)$.
Lemma 4. Set $R_{1}(X)=\left(X^{2}-3 X+2\right) / 3$ and for $m \geq 2$ set
$R_{m}(X)=2^{2 m} \cdot\left((-1)^{m-1} \frac{B_{2 m}}{m^{2}\binom{2 m}{m}} X^{2 m}+\sum_{k=0}^{\lfloor m / 2\rfloor} \frac{B_{2 k} B_{2(m-k)}}{m(m-k)}\binom{m}{2 k} X^{2 k}-\frac{1+(-1)^{m}}{2} \frac{B_{m}^{2}}{m^{2}}\right)$.
Then $R_{m}(1)=0$ for $m \geq 1$ and $S_{m}(d)=R_{m}(d)$ for $m \geq 1$ and $d \geq 2$.
Proof. For $d \geq 1$, set

$$
g_{m}(d, z)=d \cot (d z)\left(\cot ^{(m-1)}(z)\right)^{2}=\frac{1}{z^{2 m+1}}(d z \cot (d z))\left(z^{m} \cot ^{(m-1)}(z)\right)^{2}
$$

a $\pi$-periodic meromorphic function of the complex variable $z$, with a simple pole at each $k \pi / d, k \in \mathbb{Z} \backslash d \mathbb{Z}$, of residue

$$
\begin{equation*}
\operatorname{Res}_{z=k \pi / d}\left(g_{m}(d, z)=\left(\cot ^{(m-1)}(k \pi / d)\right)^{2} \quad(k \in \mathbb{Z} \backslash d \mathbb{Z})\right. \tag{3}
\end{equation*}
$$

and poles of order $2 m+1$ at each $k \pi, k \in \mathbb{Z}$. For $R>0$, let $C_{R}$ be the positively oriented rectangle of width $\pi$, height $2 R$ and center of gravity at $\pi / 2-\pi /(2 d)$.
(i). We claim that

$$
\lim _{R \rightarrow+\infty} \frac{1}{2 \pi i} \int_{C_{R}} g_{m}(d, z) \mathrm{d} z= \begin{cases}-d & \text { if } m=1 \text { and } d \geq 1  \tag{4}\\ 0 & \text { if } m \geq 2 \text { and } d \geq 1\end{cases}
$$

Indeed, since $g$ is $\pi$-periodic the integrals over the vertical sides of $C_{R}$ cancel. Moreover, since $|\cot (t+i b)+i \operatorname{sign}(b)| \leq 2 /\left(e^{|b|}-1\right)$ we have $\lim _{b \rightarrow+\infty} \cot (a+i b)=-i$ and $\lim _{R \rightarrow+\infty} \cot (a-i b)=i$ uniformly in $a \in I$, where $I$ is a given closed interval. Hence for $m=1$ we have $\lim _{R \rightarrow+\infty} g_{1}(d, t+i R)=d i$ and $\lim _{R \rightarrow+\infty} g_{1}(d, t-i R)=-d i$, uniformly in $t \in[-\pi /(2 d), \pi-\pi /(2 d)]$. The first case of claim (4) follows. Now assume that $m \geq 2$. Then $\cot ^{(m-1)}=Q_{m}(\cot )$ where the polynomials $Q_{k}(X)$ 's are defined inductively by $Q_{1}(X)=X$ and $Q_{k+1}(X)=-\left(X^{2}+1\right) Q_{k}^{\prime}(X)$. Consequently, we have $\lim _{R \rightarrow+\infty} g_{m}(d, t+i R)=Q_{m}(-i)=0$ and $\lim _{R \rightarrow+\infty} g_{m}(d, t-i R)=Q_{m}(i)=0$, uniformly in $t \in[-\pi /(2 d), \pi-\pi /(2 d)]$. Hence the integrals over the horizontal sides tend to 0 as $R$ goes to infinity for $m \geq 2$ and the second case of claim (4) follows.
(ii). Now, we claim that

$$
\begin{equation*}
R_{m}(d)=\lim _{R \rightarrow+\infty} \frac{1}{2 \pi i} \int_{C_{R}} g_{m}(d, z) \mathrm{d} z-\operatorname{Res}_{z=0}\left(g_{m}(d, z)\right) \quad(m \geq 1 \text { and } d \geq 1) \tag{5}
\end{equation*}
$$

Indeed, if $m=1$ then $g_{1}(d, z)=d \cot (d z) \cot ^{2} z$,

$$
\operatorname{Res}_{z=0}\left(g_{1}(d, z)=-\left(d^{2}+2\right) / 3\right.
$$

and the claims follow by (4) and the definition of $R_{1}(X)$. Now assume that $m \geq 2$. Using the power series expansion

$$
\begin{equation*}
z \cot (z)=\sum_{k \geq 0}(-1)^{k} \frac{2^{2 k} B_{2 k}}{(2 k)!} z^{2 k} \quad(|z|<\pi) \tag{6}
\end{equation*}
$$

we have

$$
\begin{equation*}
z^{m} \cot ^{(m-1)}(z)=(-1)^{m-1}(m-1)!+\sum_{k \geq m / 2}(-1)^{k} \frac{2^{2 k} B_{2 k}}{2 k \cdot(2 k-m)!} z^{2 k} \quad(|z|<\pi) \tag{7}
\end{equation*}
$$

Using (6) and (7) to compute the coefficient of the term $z^{2 m}$ in the power series expansion of the function $(d z \cot (d z))\left(z^{m} \cot ^{(m-1)}(z)\right)^{2}$, we readily obtain that

$$
\operatorname{Res}_{z=0}\left(g_{m}(d, z)\right)=-R_{m}(d) \text { for } m \geq 2 \text { and } d \geq 1
$$

Hence claim (5) follows from (4).
(iii). Finally, we use the residue theorem. For $d=1$, noticing that $z=0$ is the only pole of $g_{m}(1, z)$ inside $C_{R}$ and using (5) we obtain $R_{m}(1)=0$ for $m \geq 1$. For $d \geq 2$, noticing that $z=0$ and $z=k \pi / d, 1 \leq k \leq d-1$, are the only poles of $g_{m}(d, z)$ inside $C_{R}$ and using (5) and (3) we obtain $R_{m}(d)=S_{m}(d)$ for $d \geq 2$ and $m \geq 1$, as desired.

In [EL, Corollary 6.8] the authors gave a reformulation of [BY, Corolloray 2.2]. It would be interesting to see if their method can also be applied to a reformulation of our Lemma 4.

## 3 A general explicit formula

For $f>2, n \geq 2$ and $m_{1}, \cdots, m_{n} \geq 1$ such that $m_{1}+\cdots+m_{n}=2 s$ is even, we set $\vec{m}=\left(m_{1}, \cdots, m_{n}\right)$ and

$$
\begin{aligned}
& M(\vec{m}, f)=\left(\frac{2}{\phi(f)}\right)^{n-1} \\
& \times \sum_{\chi_{1}(-1)=(-1)^{m_{1}}} \cdots \sum_{\chi_{n-1}(-1)=(-1)^{m_{n-1}}} L\left(m_{1}, \chi_{1}\right) \cdots L\left(m_{n-1}, \chi_{n-1}\right) \overline{L\left(m_{n}, \chi_{1} \cdots \chi_{n-1}\right)} .
\end{aligned}
$$

Hence, $\left(\chi_{1} \cdots \chi_{n-1}\right)(-1)=(-1)^{m_{n}}$. Using the formula

$$
L(m, \chi)=\frac{(-1)^{m-1} \pi^{m}}{2 \cdot f^{m} \cdot(m-1)!} \sum_{k=1}^{f-1} \chi(k) \cot ^{(m-1)}(\pi k / f) \quad\left(\text { whenever } \chi(-1)=(-1)^{m}\right)
$$

proved in [Lou01, (1)], we have

$$
\begin{aligned}
& M(\vec{m}, f)=\frac{(-1)^{n} \pi^{2 s}}{2^{n} f^{2 s} \prod_{l=1}^{n}\left(m_{l}-1\right)!} \\
& \times \sum_{k_{n}=1}^{f-1} \sum_{k_{1}=1}^{f-1} \cdots \sum_{k_{n-1}=1}^{f-1}\left(\prod_{l=1}^{n} \cot ^{\left(m_{l}-1\right)}\left(\pi k_{l} / f\right)\right)\left(\prod_{l=1}^{n-1} \frac{2}{\phi(f)} \sum_{\chi_{l}(-1)=(-1)^{m_{l}}} \chi_{l}\left(k_{l}\right) \overline{\chi_{l}\left(k_{n}\right)}\right) .
\end{aligned}
$$

We have the following orthogonality relations for the $\phi(f) / 2$ characters $\chi_{l}$ 's modulo $f>2$ for which $\chi_{l}(-1)=(-1)^{m_{l}}$ :
$\frac{2}{\phi(f)} \sum_{\chi_{l}(-1)=(-1)^{m_{l}}} \chi_{l}\left(k_{l}\right) \overline{\chi_{l}\left(k_{n}\right)}= \begin{cases}1 & \text { if } k_{l} \equiv k_{n} \quad(\bmod f) \text { and } \operatorname{gcd}\left(k_{n}, f\right)=1, \\ (-1)^{m_{l}} & \text { if } k_{l} \equiv-k_{n} \quad(\bmod f) \text { and } \operatorname{gcd}\left(k_{n}, f\right)=1, \\ 0 & \text { otherwise. }\end{cases}$
Noticing that $\chi_{l}\left(-k_{n}\right) \cot ^{\left(m_{l}-1\right)}\left(-\pi k_{n} / f\right)=\chi_{l}\left(k_{n}\right) \cot ^{\left(m_{l}-1\right)}\left(\pi k_{n} / f\right)$ whenever $\chi_{l}(-1)=$ $(-1)^{m_{l}}$, we obtain

$$
M(\vec{m}, f)=\frac{(-1)^{n} \pi^{2 s}}{2 f^{2 s} \prod_{l=1}^{n}\left(m_{l}-1\right)!} \sum_{\substack{k_{n}=1 \\ \operatorname{gcd}\left(k_{n}, f\right)=1}}^{f-1} \prod_{l=1}^{n} \cot ^{\left(m_{l}-1\right)}\left(\pi k_{n} / f\right)
$$

The following generalization of Lemma 2 follows:

Lemma 5. For $f>2, n \geq 2$ and $m_{1}, \cdots, m_{n} \geq 1$ such that $m_{1}+\cdots+m_{n}=2 s$ is even we have

$$
M(\vec{m}, f)=\frac{(-1)^{n} \pi^{2 s}}{2 \cdot\left(m_{1}-1\right)!\cdots\left(m_{n}-1\right)!\cdot f^{2 s}} \sum_{\substack{d \mid f \\ d>1}} \mu(f / d) S_{\vec{m}}(d)
$$

where

$$
S_{\vec{m}}(d)=\sum_{k=1}^{d-1} \prod_{l=1}^{n} \cot ^{\left(m_{l}-1\right)}\left(\frac{k \pi}{d}\right) \quad(d>1)
$$

Now, for $d \geq 1$ a rational integer, we set

$$
g_{\vec{m}}(d, z)=d \cot (d z) \prod_{l=1}^{n} \cot ^{\left(m_{l}-1\right)}(z)=\frac{(d z \cot (d z)) \prod_{l=1}^{n} z^{m_{l}} \cot ^{\left(m_{l}-1\right)}(z)}{z^{2 s+1}}
$$

a $\pi$-periodic meromorphic function of the complex variable $z$, with a simple pole at each $k \pi / d, k \in \mathbb{Z} \backslash d \mathbb{Z}$, of residue

$$
\begin{equation*}
\operatorname{Res}_{z=k \pi / d}\left(g_{\vec{m}}(d, z)=\prod_{l=1}^{n} \cot ^{\left(m_{l}-1\right)}(k \pi / d) \quad(k \in \mathbb{Z} \backslash d \mathbb{Z})\right. \tag{8}
\end{equation*}
$$

and poles of order $2 s+1$ at each $k \pi, k \in \mathbb{Z}$. Let $T_{\vec{m}}(X)$ denote the coefficient of $z^{m_{1}+\cdots+m_{n}}$ in the formal power series expansion

$$
\left(\sum_{k \geq 0}(-1)^{k} \frac{2^{2 k} B_{2 k}}{(2 k)!} X^{2 k} z^{2 k}\right) \prod_{l=1}^{n}\left((-1)^{m_{l}-1}\left(m_{l}-1\right)!+\sum_{k \geq m_{l} / 2}(-1)^{k} \frac{2^{2 k} B_{2 k}}{2 k \cdot\left(2 k-m_{l}\right)!} z^{2 k}\right)
$$

Hence, $T_{\vec{m}}(X)$ is a polynomial of degree $2 s=m_{1}+\cdots+m_{n}$, with rational coefficients and leading coefficient

$$
(-1)^{s-n} \frac{2^{2 s} B_{2 s}}{(2 s)!} \prod_{l=1}^{n}\left(m_{l}-1\right)!
$$

and

$$
\begin{equation*}
\operatorname{Res}_{z=0}\left(g_{\vec{m}}(d, z)\right)=T_{\vec{m}}(d) \text { for } d \geq 1 \tag{9}
\end{equation*}
$$

With the same proof, we have the following generalization of (4):

$$
\lim _{R \rightarrow+\infty} \frac{1}{2 \pi i} \int_{C_{R}} g_{\vec{m}}(d, z) \mathrm{d} z= \begin{cases}(-1)^{n / 2} d & \left(\text { if } m_{1}=\cdots=m_{n}=1\right)  \tag{10}\\ 0 & \text { otherwise }\end{cases}
$$

( $n$ must be even if $m_{1}=\cdots=m_{n}=1$ ).
We have the following generalization of Lemma 4:
Lemma 6. Set

$$
R_{\vec{m}}(X)=-T_{\vec{m}}(X)+ \begin{cases}(-1)^{n / 2} X & \left(\text { if } m_{1}=\cdots=m_{n}=1\right) \\ 0 & \text { otherwise }\end{cases}
$$

Then $R_{\vec{m}}(1)=0$ and $S_{\vec{m}}(d)=R_{\vec{m}}(d)$ for $d \geq 2$.
Proof. By (9) and (10), for $d \geq 1$ we have

$$
R_{\vec{m}}(d):=\frac{1}{2 \pi i} \int_{C_{R}} g_{\vec{m}}(d, z) \mathrm{d} z-\operatorname{Res}_{z=0}\left(g_{\vec{m}}(d, z)\right)
$$

We use the residue theorem. For $d=1$, noticing that $z=0$ is the only pole of $g_{\vec{m}}(1, z)$ inside $C_{R}$, here again we get

$$
\begin{equation*}
R_{\vec{m}}(1)=0 . \tag{11}
\end{equation*}
$$

For $d \geq 2$, noticing that $z=0$ and $z=k \pi / d, 1 \leq k \leq d-1$, are the only poles of $g_{\vec{m}}(d, z)$ inside $C_{R}$ and using (8), we obtain $\left.\left.R_{\vec{m}} d\right)=S_{\vec{m}} d\right)$.

By Lemma 6, Lemma 3 and (2), and noticing that $T_{\vec{m}}(X)$ is even we end up with the following generalization of Theorem 1 :

Theorem 7. Write

$$
T_{\vec{m}}(X)=(-1)^{s-n} \frac{2^{2 s} B_{2 s}}{(2 s)!}\left(\prod_{l=1}^{n}\left(m_{l}-1\right)!\right)\left(X^{2 s}+\sum_{k=0}^{s-1} r_{\vec{m}, 2 k} X^{2 k}\right)
$$

Then, for $f>2$ we have

$$
\begin{aligned}
& M(\vec{m}, f)=\zeta(2 s) \times\left(\phi_{2 s}(f)+\sum_{k=1}^{s-1} r_{\vec{m}, 2 k} \frac{\phi_{2 k}(f)}{f^{2 s-2 k}}\right) \\
& \quad+ \begin{cases}(-1)^{n / 2} \frac{\pi^{n} \phi_{1}(f)}{2 f^{n-1}} & \text { (if } \left.m_{1}=\cdots=m_{n}=1\right) \\
0 & \text { otherwise } .\end{cases}
\end{aligned}
$$

In particular, as $f$ goes to infinity $M(\vec{m}, f)$ is asymptotic to

$$
\zeta(2 s) \phi_{2 s}(f), \text { where } 2 s=m_{1}+\cdots+m_{n}
$$

## 4 Several explicit examples

### 4.1 First example.

By Lemma 6 we have $S_{\overrightarrow{(1,1,2)}}(d)=R_{\overrightarrow{(1,1,2)}}(d)=-T_{\overrightarrow{(1,1,2)}}(d)$. By (9), we obtain

$$
S_{\overrightarrow{(1,1,2)}}(d)=-T_{\overline{(1,1,2)}}(d)=-\operatorname{Res}_{z=0}\left(d \cot (d z) \cot ^{2}(z) \cot ^{\prime}(z)\right)=-\frac{1}{45} d^{4}+\frac{1}{9} d^{2}-\frac{4}{45}
$$

Therefore

$$
M(\overrightarrow{(1,1,2)}, f)=-\frac{\pi^{4}}{2 f^{4}} \sum_{d \mid f} \mu(f / d) S_{\overrightarrow{(1,1,2)}}(d)=\frac{\pi^{4}}{90}\left(\phi_{4}(f)-5 \frac{\phi_{2}(f)}{f^{2}}\right)
$$

by Lemma 5 and Lemma 3. We have recovered [Alk, Theorem 1].

### 4.2 Second example.

Theorem 8. Let $n \geq 2$ be even. For $f>2$ set

$$
M_{n}(f)=\left(\frac{2}{\phi(f)}\right)^{n-1} \sum_{\chi_{1}(-1)=-1} \cdots \sum_{\chi_{n-1}(-1)=-1} L\left(1, \chi_{1}\right) \cdots L\left(1, \chi_{n-1}\right) \overline{L\left(1, \chi_{1} \cdots \chi_{n-1}\right)}
$$

Then

$$
M_{n}(f)=\zeta(n) \times\left(\phi_{n}(f)+\frac{n!}{B_{n}} \sum_{k_{0}=1}^{n / 2-1} C_{n, n / 2-k_{0}} \frac{B_{2 k_{0}}}{\left(2 k_{0}\right)!} \frac{\phi_{2 k_{0}}(f)}{f^{n-2 k_{0}}}\right)+(-1)^{n / 2} \frac{\pi^{n} \phi_{1}(f)}{2 f^{n-1}}
$$

where

$$
C_{n, N}=\sum_{\substack{e_{1}, \cdots, e_{N} \geq 0 \\ e_{1}+2 e_{2} \cdots+N e_{N}=N}} \frac{n!}{\left(n-\left(e_{1}+\cdots+e_{N}\right)\right)!} \prod_{l=1}^{N} \frac{1}{e_{l}!}\left(\frac{B_{2 l}}{(2 l)!}\right)^{e_{l}} \quad(n \geq N \geq 1)
$$

Proof. Here

$$
T_{\vec{m}}(d)=(-1)^{n / 2} \frac{2^{n} B_{n}}{n!} \sum_{\substack{k_{0}, k_{1}, \cdots, k_{n} \geq 0 \\ k_{0}+k_{1}+\cdots+k_{n}=n / 2}} \frac{n!}{B_{n}}\left(\prod_{l=1}^{n} \frac{B_{2 k_{l}}}{\left(2 k_{l}\right)!}\right) \frac{B_{2 k_{0}}}{\left(2 k_{0}\right)!} d^{2 k_{0}}
$$

Now, for $n \geq N \geq 1$ and $F: \mathbb{Z}_{\geq 0} \rightarrow \mathbb{C}^{*}$ such that $F(0)=1$, e.g. for $F(k)=B_{2 k} /(2 k)$ !, we have

$$
\sum_{\substack{k_{1}, \cdots, k_{n} \geq 0 \\ k_{1}+\cdots+k_{n}=N}} \prod_{l=1}^{n} F\left(k_{l}\right)=\sum_{\substack{e_{1}, \cdots, e_{N} \geq 0 \\ e_{1}+2 e_{2} \cdots+N e_{N}=N}} \frac{n!}{\left(n-\left(e_{1}+\cdots+e_{N}\right)\right)!} \prod_{l=1}^{N} \frac{F(l)^{e_{l}}}{e_{l}!}
$$

by letting $e_{l}$ denote the number of $k_{i}$ 's which are equal to $l$ and by noticing that we have $\binom{n}{e_{0}}$ possible choices of the $k_{i}$ 's which are equal to 0 , then $\binom{n-e_{0}}{e_{1}}$ possible choices of the $k_{i}$ 's which are equal to $1, \ldots$, and finally by using $e_{0}+e_{1}+\cdots e_{N}=n$ and

$$
\binom{n}{e_{0}}\binom{n-e_{0}}{e_{1}} \cdots\binom{n-\left(e_{0}+e_{1}+\cdots+e_{N-1}\right)}{e_{N}}=\frac{n!}{e_{0}!\times e_{1}!\times \cdots \times e_{N}!}
$$

For example,

$$
M_{2}(f)=\frac{\pi^{2}}{6}\left(\phi_{2}(f)-3 \frac{\phi_{1}(f)}{f}\right)
$$

in accordance with (1),

$$
M_{4}(f)=\frac{\pi^{4}}{90}\left(\phi_{4}(f)-20 \frac{\phi_{2}(f)}{f^{2}}+45 \frac{\phi_{1}(f)}{f^{3}}\right)
$$

and

$$
M_{6}(f)=\frac{\pi^{4}}{945}\left(\phi_{6}(f)-21 \frac{\phi_{4}(f)}{f^{2}}+\frac{483}{2} \frac{\phi_{2}(f)}{f^{4}}-\frac{945}{2} \frac{\phi_{1}(f)}{f^{5}}\right)
$$

For $f=3$, there is only one odd character $\chi$ modulo 3 , and $L(1, \chi)=\frac{\pi}{3 \sqrt{3}}$. Hence, $M_{n}(3)=\frac{\pi^{n}}{3^{3 n / 2}}$. Our formulae do give $M_{2}(3)=\frac{\pi^{2}}{3^{3}}, M_{4}(3)=\frac{\pi^{4}}{3^{6}}$ and $M_{6}(3)=\frac{\pi^{6}}{3^{9}}$.

### 4.3 Third example.

We have the following generalization of Theorem 1:
Theorem 9. For $m \geq 1, n \geq 1$ of the same parity and $(m, n) \neq(1,1)$, we have

$$
\begin{aligned}
M(\overrightarrow{(m, n)}, f)= & \frac{2}{\phi(f)} \sum_{\chi(-1)=(-1)^{m}=(-1)^{n}} L(m, \chi) \overline{L(n, \chi)} \\
= & \zeta(m+n) \times\left(\phi_{m+n}(f)\right. \\
& +(-1)^{m-1}\binom{m+n}{m} \sum_{k=1}^{\lfloor m / 2\rfloor} \frac{n}{m+n-2 k}\binom{m}{2 k} \frac{B_{2 k} B_{m+n-2 k}}{B_{m+n}} \frac{\phi_{2 k}(f)}{f^{m+n-2 k}} \\
& \left.+(-1)^{n-1}\binom{m+n}{n} \sum_{k=1}^{\lfloor n / 2\rfloor} \frac{m}{m+n-2 k}\binom{n}{2 k} \frac{B_{2 k} B_{m+n-2 k}}{B_{m+n}} \frac{\phi_{2 k}(f)}{f^{m+n-2 k}}\right) .
\end{aligned}
$$

In particular, $M(\overrightarrow{(m, n)}, f)$ is asymptotic to $\zeta(m+n) \phi_{m+n}(f)$ as $f$ goes to infinity.

Proof. Use Lemma 6, notice that

$$
\begin{aligned}
T_{\overline{(m, n)}}(X)=2^{m+n} \times & \left((-1)^{\frac{m+n}{2}} \frac{B_{m+n}}{m n\binom{m+n}{n}} X^{m+n}\right. \\
& -(-1)^{\frac{m-n}{2}} \sum_{k=1}^{\lfloor m / 2\rfloor} \frac{B_{2 k} B_{m+n-2 k}}{m(m+n-2 k)}\binom{m}{2 k} X^{2 k} \\
& -(-1)^{\frac{n-m}{2}} \sum_{k=1}^{\lfloor n / 2\rfloor} \frac{B_{2 k} B_{m+n-2 k}}{n(m+n-2 k)}\binom{n}{2 k} X^{2 k} \\
& \left.+(-1)^{\frac{m+n}{2}} \frac{1+(-1)^{m}}{2} \frac{1+(-1)^{m}}{2} \frac{B_{m} B_{n}}{m n}\right)
\end{aligned}
$$

and finally use Lemma 5.
Our explicit formula for $M(\overrightarrow{(m, n)}, f)$ is much simpler than the ones given in [LZ, Theorem 1.1] and [OO, Theorem 1.2]. For example, the first term in the formula given [LZ, Theorem 1.1] is

$$
(-1)^{(m-n) / 2} \frac{(2 \pi)^{m+n}}{2 \cdot m!\cdot n!} \phi_{m+n}(f) \sum_{a=0}^{m} \sum_{b=0}^{n} B_{m-a} B_{n-b} \frac{\binom{m}{a}\binom{n}{b}}{a+b+1}
$$

By (2), this first term being equal to the one $\zeta(m+n) \phi_{m+n}(f)$ of Theorem 9 is tantamount to saying that $B_{m+n}=(-1)^{n}\binom{m+n}{n} \sum_{a=0}^{m} \sum_{b=0}^{n} B_{m-a} B_{n-b}$. This is probably correct and at least we checked it for several values of $m$ and $n$.

Notice that for $m \geq 2$ we have $M((m, m), f)=M(m, f)$ and we recover the formula given in Theorem 1.

### 4.4 Fourth example.

For $m, n \geq 1$, Theorem 7 gives a formula for
$M(\overline{(m, n, m+n)}, f)=\frac{4}{\phi(f)^{2}} \sum_{\chi_{1}(-1)=(-1)^{m}} \sum_{\chi_{2}(-1)=(-1)^{n}} L\left(m, \chi_{1}\right) L\left(n, \chi_{2}\right) \overline{L\left(m+n, \chi_{1} \chi_{2}\right)}$
much simpler than the one given in [OO, Theorem 1.1].
