Chl fields as forcing for ocean circulation models



Absorption module : Solar radiation absorption by Chl









<u>Objective:</u> Impact of the ChI field used in the Mediterranean and throughout the water column on a decadal scale



Chl fields

Chl field derived from the Eco3M-MED model

Adimensional Chl vertical profile

= vertical profile / surface value

The Eco3M-Med model can be used to represent the vertical variability of Chl in time and space

Comparison of the two Chl fields (Difference in cumulative Chl over one year)

relative \triangle ChI = (ChI (SAT_VHOM) – ChI (SAT_VVAR)) / ChI (SAT_VHOM)



more Chl in SAT_VHOM below ~ 100m

Evolution of ΔT (SAT_VHOM - SAT_VVAR) in MED sub-basin

<u>Upper surface layer (0-70m):</u> seasonality Less Chl in SAT VHOM \Rightarrow colder Strongly controled by winter mixing Lower surface layer (70-150m): seasonality + heat accumulation \rightarrow More residual energy arrive in SAT VHOM + More Chl \Rightarrow warmer \rightarrow Less impacted by winter mixing (under mean MLD) ⇒ heat accumulation

Two components: interannual trend + seasonal oscillation (+ residual)

 \times Differences in heat absorption by ChI in 0-70m leads to ΔT trend in the deeper layers

 $|\Delta T_{10}|$ max < 0.1°C (max value in 70-150m layer), which seems negligible BUT :

- \rightarrow becomes significant on the scale of a climate projection (if the trend remains the same)
- $\rightarrow \Delta T$ can be locally and ponctually higher (e.g. in summer)

X T of **MOD_DAY is increasingly higher** in surface and intermediate layers

Why MOD_DAY is warmer in the surface layers?

Take Home Messages						

X Using of a vertically homogeneous Chl field results in :

- \rightarrow errors in temperature that can be significant (> 1°C) from time to time or locally
- \rightarrow a temperature bias in the lower surface and intermediate layers, which becomes increasingly significant over time, reaching up to **1°C** on the scale of a climate projection (100 years).

※ The introduction of a **realistic vertical profile of Chl varying monthly** (here provided by the Eco3M-MED model) improves the temperature profile in the layers most affected by the concentration of Chl.

X The **asymmetrical role** of Chl extremes is the reason proposed for the warmer temperatures in the simulation forced by the **daily Chl field** compared with those forced by climatological or monthly Chl fields.

Evolution of the vertical profile of temperature (Mean profil in MED)

Entire water column

In the case of the model

All the energy absorbed by the phytoplankton will be transformed 100% into heat in the water.

cf. Huner N P A, Öquist G, Sarhan F. Energy balance and acclimation to light and cold[J]. Trends in plant science, 1998, 3(6): 224-230.

In the realistic case

All the energy absorbed by phytoplankton will be transformed into fluorescence (~3%), photochemical production of organic matter and heat in the water.
