The sociophonetically inscribed nonchalance of the non-standard 1SG and its mass media origins¹

Abstract

The re-emergence of the non-standard 1SG in English ("i", herein NS1sg) suggests that the inclusion of the novel form as an online variant is indeed encoding sociophonetic variation; that it is deployed for its attenuative effects in a language with only one 1SG and no speech levels. The attenuation afforded by the variant is displayed in both a graphemic and—as suggested here—an acoustic reduction; a strong graphemic "I" becomes a weak graphemic "i", and a diphthong /ai/ shifts to a monophthong /ə/ or /a:/. This pairing of phonemegrapheme attenuation is socially useful. The very sound of /aɪ/ is salient and self-assertive, the sound of /ə/ is not. The perception of this phonetic variation relies on endophasia, but where do these vocal depictions come from, and are they faithful to the grapheme? This paper aims to demonstrate how vocal characterizations of nonchalant stance are being inscribed and enregistered in the NS1sg using personae, which are essentialized personifications of the imagined typical user. Enregisterment has been characterized as a social process whereby diverse behavioural signs (whether linguistic, non-linguistic, or both) are functionally reanalysed as cultural models of action, as behaviours capable of indexing stereotypic characteristics of incumbents of particular interactional roles, and of relations among them. Multiple tokens from 47 media sources, satisfy the prediction (p-value=<0.05) that the perceived NS1sg sits in the frequency area of high F2, and that as expected the 1SG personae reside in the low F2.

1 Introduction—Wielding tropes

This paper looks at the written discourse strategy named *Shielding*. Shielding is one of six usages of the nonstandard 1SG proposed in Burnett (2023c) imbued with social meaning. As its name suggests, Shielding is a protective implementation. It is an effective usage as it leans

on the aural implicature re-created by the reader during the reading process. I suggest that the original aural implicature of this online variant was (as is often the case) youth driven, and as such would have a prosody constructed in opposition to formality, stagnation, rigidity, tradition; traits and ideologies which are interestingly encapsulated in the standard Received Pronunciation rendition of the diphthonic 1SG. The Oxford English Dictionary (online) defines the adjective "nonchalant²" as "Calm and casual; (deliberately) lacking in enthusiasm or interest; indifferent, unconcerned". Sociophonetic enregisterments themselves rely on indexicality (pointing to a stance that did not originate in the reader's mind). This nonconflictual voice is identified and re-purposed by individuals online finding themselves in the situation of, for example, wanting to share information or an opinion on a thorny topic without being 'shot down', as shown in Fig.1.

In some contexts it could substitute the tone indicator IMHO³. I posit that CMC users have identified the prosodic effects of the variant 1SG, and are redeploying it as a shorthand for "don't shoot me; let me say my piece, and don't verbally abuse me in written form on a public website, especially since I am adopting this non-conflictual stance". The online author is thus able to 'import' single or swathes of socially recognizable enactments, compressing them into the lexical layer of the non-standard 1SG allomorph. To quote Silverstein (2004, p.196) "people sometimes use explicit primary performative constructions to denote conventional "moves" constituted by language-in-use, that is, to parse language-in-use as chunks of interactional text; this constitutes a kind of full-tilt metapragmatic discourse."

The beauty of enregisterments is their portability, because as a language function—contingent almost solely⁴ on the producer's and receiver's shared culture—they can be

extremely efficient in injecting a semantic load into a small place, allowing the author to render explicit their stance in the blink of a reader's eye. This could be seen as a protective, or a strategic use of conversational politeness (see Leech, 2014) or diplomacy, in metapragmatic form. However one wishes to frame it, this is a democratic usage in the public forum of digitally mediated text, where Goffman's principle of private and public selves comes to the fore. Elizabeth Bruenig, opinion writer for the New York Times and public figure, used the standard form of the 1SG in their publications on Twitter/X, before they received increasingly noxious communications particularly from users identifying as male, for political and misogynistic motives. This began sometime in 2020 and peaked in February 2021 after the journalist posted photos of themselves breastfeeding. 4chan⁵ members inundated the site with sexist memes and spiteful and sexualised comments. Following this event, Bruenig began to employ the lowercase <i>, culminating in it being the only 1SG form that they employed on Twitter/X. This observation may be a false correlation; their transition into the NS1sg could correspond to an aesthetic trend, for it is true we have seen usage of the form increase in frequency since 2009. However, having analyzed the variant and proposed a taxonomy of usages (Burnett, 2003c), I posit that this is not the case, and that the journalist's use of the lowercase (see Fig.2) is an epitomic example of Shielding; borrowing the aural implicature of the enregistered prosody of younger language and implementing it to impress a nonconflictual tone upon the reader.

The usage of the NS1sg in Fig. 2 is tantamount to saying, "It is my job to publish on social media, and I have to publish my opinion, so since that is the case I will use this

minuscule to let you know that a) there is a feeling human behind these typed words, and b) "this human doesn't want to be attacked." Note that after a hiatus and accepting only approved followers, Bruenig renewed with the standard form⁶, although this could be an indication of renewed strength in the journalist, and the standard 1SG could be an iconic embodiment of that renewal (see Burnett, 2023c, p.205).

In order for this stance to function, it needs to 'borrow' the aural implicature from the common stock; but how do CMC users know what sound that is? I posit that they are able to identify the sound because vocal characterizations are being inscribed and sociophonetically enregistered in the NS1sg using personae, which are essentialized personifications of the imagined typical user (Ilbury, 2020, p.249). Enregisterment has been characterized (Agha, 2015, p.27) as a social process whereby diverse behavioural signs (whether linguistic, non-linguistic, or both) are functionally re-analysed as cultural models of action, as behaviours capable of indexing stereotypic characteristics of incumbents of certain interactional roles, and of relations among them. Levels of indexicality progress in a hierarchical manner: any nth + 1-order index relies on an nth-order index, indicating that indices emerge through a dialectical relationship with other indices. (Squires, 2006, p.459).

A useful description of the path from indexicality (Silverstein, 2003) to enregisterment is recalled by Squires (*ibid*, p.459-60):

In examining "Pittsburghese", Johnstone and colleagues (2006) show that certain features, such as /aw/ monophthongization, are sociodemographically correlated with speakers in Southwestern Pennsylvania, which establishes a first-order (nth-order) index of linguistic form to social property. When those regionally distributed features

become noticed and metapragmatically linked to regional speech, a second-order (nth + 1-order) index is established. When they are objectified and metadiscursively linked to stereotypic personae, a third-order (nth + 1 + 1-order) index is established, and the features are enregistered as belonging to a variety folk-named "Pittsburghese".

It could be that non-standard minuscules—particularly in the case of the pronominally-impacting NS1sg, the grapheme being an allomorph, carries both nth-1st order (<I>) and 3rd order (<i>) indexicalities, which may seem to be a violation of indexical function; however, this could work if the different indices are distributed simultaneously in the functional (I=nth) and the lexical (nth+1+1) layers of the allomorph.

I suggest some implementations of the NS1sg operate on a solely visually iconic level, others on an indexical level, and I posit that the instant recognition of the NS1sg amongst younger social actors can certainly engage the reader's subvocalization⁷, but that logic would have it bypass the slower cognition that mobilizes reading on a *multimodal* prosodic level, engaging rather on a more abstract, *amodal* level of inner language. Some usages of the novel form—those deploying aural implicature and/or a sociophonetically enregistered form—do however rely on reader access to multimodal endophasia, and that the decision to be informed by a particular external voice relies heavily on the characterisation afforded by its tone and intonation over all other idiosyncrasies. So, I do not oppose abstract and concrete in the sense that only one is a true understanding of inner-speech representations. Rather I account, once again, for usage being bound to the context; the "wilful, volitional" use of the cognitive tool of concrete⁸ multimodality over abstract, amodal inner language. "The seemingly opposite views of Abstraction and Motor Simulation are not mutually exclusive". (Lœvenbruck, Grandchamp, Rapin, Nalborczyk, & Dohen, 2018, p.9)

This phenomenon is an aural borrowing, and the target inner voice will have been chosen as appropriate to the NS1sg grapheme from an 'archive' of aural representations, either of the reader's own voice, of a voice encountered during social interaction, or a voice heard via various forms of media—in any case having originated <u>elsewhere</u> than in the reader's mind. These aural depictions of the standard and non-standard 1SG personae may come to us via television or online platforms, news and information, fiction series, movies, video games, YouTube, Instagram, and advertising, etc. "(...)the metapragmatic typification of

a register can be found in "everyday reflexive behaviours" and "metadiscursive genres", including journalistic, literary and pedagogic representations of language use" (Androutsopoulos, 2014, p.32). A word might otherwise be said on cultural subjectivity, but herein we'll take the position of Anglo-Saxon utterances by and for English L1 or fluent speakers.

2 Corpus—Actor personae

The corpus construction rationale is that interlocutors found (base) their reception of tropic reenactment on only a few models of verbal art (Agha, 2015) and that mass-mediatised artefacts are thus disseminated internationally, expanding the social domain of those able to recognize the contrast in register. In the Anglo-Saxon culture, being now predominantly North American in regard to mass media and entertainment, it was important to find actor personae containing 1SG and NS1sg from most-viewed media. The corpus was created from 6 categories and 47 main primary sources (Appendix A) further divided into multiple tokens; all highly viewed English language material. 131 audio file segments⁹ containing expressions of the 1SG were isolated, and the tokens annotated as 'perceived as' 1SG or NS1sg. The high exposure is important for their memetic potential, but also for their impact potential, since the authority of the personae is enhanced by the implication of high numbers of views if not significant material resources (Foucault, 1981, *ibid*).

Netflix: Per Netflix's¹⁰ Top 10 site, this is how their 'all-time list' works¹¹: "... we provide a list of the Top 10 most popular Netflix films and TV overall (...) in each of the four categories based on the hours that each title was viewed during its first 28 days. Since some titles have multiple premiere dates, whether weekly or in parts, we count the 28 days from each episode premiere date in each country."

Presidential and prime ministerial speeches: In 2022, NBC topped ad-supported TV networks in the U.S. with 1.2 million average viewers aged 18-49, as per Statista. Fox followed with 902 thousand viewers, and ABC with 864 thousand. These figures exclude extensive social media views, where BBC News boasts 14 million YouTube subscribers alone.

Commercials: Since Netflix started gaining popularity between 2007-2012, commercials were chosen from 2011 onwards. This date coincides with when Facebook began gaining traction, and the year Instagram was launched. In Appendix A, these are ranked by most-views.

Instagram: A heavily publicity-focused social media platform, Instagram blends user-generated content with promotional videos from celebrities compensated by brands. These videos, meticulously crafted to seem spontaneous, wield significant influence, reaching millions of users through the Instagram mobile application. In Appendix A, these are ranked by most-views.

Theatrical movies: The films appear as top-ranked by theatrical exhibition revenues. Note that the data doesn't include views of trailers on platforms like YouTube, potentially indicating a much larger audience for these auditory depictions.

Video games: Also ranked by most-sold units. I dismissed non-speaking games such as *Minecraft* (though it ranks first), which contains dialogs but that are based on superimposed texts; for the same reason I dismissed *Tetris, Wii Sports, Pokémon RGB, Animal Crossing*, or *Human: fall flat V*, all high ranking but lacking natural voice representations. Games are useful because they are 'heavily' weighted since they are typically played several times, and as they are participatory, the multimodal engagement is greater, which in cognitive terms such as recall has a deep footprint (see Nelson, 2002). The games retained either had Non Player Characters (NPC) with spoken dialog, and/or cinematic scenes. Games such as *Skyrim* (MMORPG¹²) are particularly interesting because they have character interactions with NPC that have spoken dialog and often represent story characters with defined (archetypal, stereotypical) personalities and/or perlocutionary goals.

The audio examples in the corpus were in the original form accompanied with multimodal information (corporal stance) and semantically rich discursive environment (fictional scene, political discourse). For example, President Biden's standard 1SG is enhanced by the rigidity and authority of the discursive environment (situation) that the enregisterment is founded in (see Fig.4). *The* discursive environment, or situation, that the enregisterment of say, the protagonist in *Avatar* brings to their 1SG is an experimental military environment, and a young veteran, who despite paralysis explores a new world (Fig.5).

The media herein are created for an international market, with broad tropic brush strokes, meant to be understood by the masses; a modern-day *commedia dell 'Arte*. The use of

a socially-laden variant form only has sense if there is an informed audience to acknowledge its meaning and attribute its sociophonetic properties to its author. The usage of a monophthong for the 1SG acts as a metonymic signifier. This signifier must unfold in what Foley (2004) calls a "performance arena", which pertains to the ability of the people present—speech participants—to understand the semantic properties of the enregisterment.

If we accept nonchalance as residing in the same semantic plot as the more commonly used word 'cool', for which the Oxford English Dictionary's definition is "not affected by passion or emotion, dispassionate", then we may apply such values to prosodic attributes. In line with Crystal (1969), Cruttenden (1997) and Jun (2005), we will assume that intonation is an amalgam of prosodic variables. Table 1 proposes a prosodic blueprint of a 'cool' voice.

Table 1 Components of 'cool' voices.

Regional accents also play a role in the perception of cool—actor Mathew McConnaughy's Southern drawl likely sounds far more casual to most ears than the clipped voiced consonants of Mark Gatiss's *Mycroft Holmes* (public schoolboy RP) which is why the corpus was not filtered for accented vocal depictions, as they are part and parcel of the personae.

3.1 Background—The phonetic analysis of aural stances

The vocal tract's first four lowest resonant frequencies are formants F1-F4, (Carlson, Granström, & Fant, 1970), Stevens (2000). Most vowels have at least four formants, and often five or even six, however it is the F1 and F2 formants that play an important role in vowel measurement. It is a well-documented (*ibid*) fact that the first formant F1 has a higher frequency for an open or low vowel such as [a] and a lower frequency for a closed or high vowel such as [i] or [u]; and the second formant F2 has a higher frequency for a front vowel such as [i] and a lower frequency for a back vowel such as [u]. This paper focuses on the F2 to identify standard and non-standard forms of the 1SG, positing that the actor personae frequencies will be faithful to the corresponding IPA cardinals.

Acoustic studies of several languages indicate that second formant (F2) slopes in high vowels have opposing directions (independent of consonantal context): front [i:]-like vowels are produced with a rising F2 slope while back [u:]-like vowels are produced with a falling F2 slope (Chládková, Hamann, Williams, & Hellmuth, 2017). Their paper suggests that in Standard Southern British English at least, a rising F2 seems to be perceptually associated with an abstract feature such as [+front] while a falling F2 with an abstract feature such as [-front]. So, apart from the stable formant values measured during the pronunciation of a vowel, the direction in which the formant trajectory moves also helps to identify diphthongs. For example, the diphthong [ɛi] is characterized by a falling F1 slope and a rising F2 slope, whereas [ɔu] has a falling F1 slope and a falling F2 slope. Thus, an NS1sg monophthong may have a perceptual edge of the standard form based on its F2 slope alone.

The hypothesised vowel sounds of the NS1sg are adjacent to that of a schwa as an end vowel (Flemming 2009), which the monophthong essentially is, the mean F1 of schwa vowels is 665 Hz, while mean F2 is 1772 Hz, which corresponds to a mid-central vowel, i.e., in IPA [ə]. The exact frequencies of course vary depending on the individual speaker and the specific pronunciation of the vowel.

3. 2 Hypothesis and predictions

The hypothesis is that the encoding and decoding of social meaning in the aurally implied implementations of NS1sg and 1SG rely on hyperbolic tropes that are inscribed in cultural enregisterments. These aural and multimodal indexicals come to interlocutors via mass media (state and commodity) and so by questioning corpora from these sources, one can measure the

acoustics of the NS1sg and 1SG vowel sounds. The prediction is that these formants will correlate with the locations on the IPA chart of higher-front tongue final position for the offglide of the standard diphthong /ai/ enactments, or a lower-mid/back tongue final position for the NS1sg monophthong /ə/, /p/, or, at a push/ Λ /13.

4 Method

Audio segments were isolated first by lexical and auditory analysis. The desired segments were identified using Closed Caption, then extracted and filed. Lexemes perceived as standard 1SG were labelled 1SG, and those perceived as non-standard 1SG were labelled as NS1sg. This was done with audio only to avoid a McGurk type effect (MacDonald & McGurk, 1978) of being influenced by the visual environment. At this point in the process the lexemes were studied in context because as Jun (2005, p.431) points out, we cannot predict the post lexical prosody of a pitch (e.g., intonational pitch accent, phrase accent) based on the lexical prosody; and it is interesting to look at the utterances surrounding the target lexeme "I" to observe the articulatory effects and possible liaison constraints. The spectrogram was analysed in Praat¹⁴, then the lexeme separation fine-tuned using formant analysis. Formants are resonant frequencies in the vocal tract that shape the distinctive sound quality of speech vowels. The 'shape' of a vowel can be seen in a spectrogram, allowing for precision isolation.




Figure 6 Jurassic World Token 3: Long epitomic 1SG "I guess...", spectrogram of isolated "I" highlighted in pink. Blue line is pitch. Note the squid-like shape of the standard form.

Some of the media extracts were too "noisy" with music or other background tracks. These were removed from the file using a tool made by Dmitry Melnik¹⁵. Following the isolation of the lexeme/phoneme <I> in the spectrogram (see fig. 6), the F1 and F2 formants of the perceived standard and non-standard forms were measured at their optimal length, at around 80% of the sound.




Figure 7 Handmade corpus of perceived 1SGs & NS1sg F1 & F2 formants plotted as Hz (inversed x and y axis).

(Jacewicz, Fujimura, & Fox, 2003). 1SG nuclei and offglides were measured. These data were collected in the csv file¹⁶ then plotted in a scatter chart with flipped x (f2) and y(f1) axes to approach a replication of IPA plotting (fig. 7).

After confirming that the chosen formants contained accurate phonemic information, ensuring no clipping or inclusion of F0 data from adjacent phonemes, F2 formants were isolated, and F1 mostly disregarded. The ultimate data relied solely on F2 since the offglide position inherently indicates tongue position for both vowels.

This approach remains representative of the intended utterance, even in voiceless versions of diphthong offglides (Chládková, Hamann, Williams, Hellmuth, 2017). Finally, the actor personae representation formants (F2s) were plotted to test the hypothesis and confirm whether Anglo-Saxon mass media sociophonetically inscribes coolness into the non-standard 1SG via enregisterment¹⁷.




Figure 8 Perceived-as-cool isolated 1SG + Modal Auxilliary. Token 4 from Lucifer Season 5."I thought i'd pop back up". F1-F4 Formant track.

Note the levelness in Fig.8 of the F2 from onset to offglide, entailing smoothly with an under-accented voiced consonant <d>.




Figure 9 COD: Modern Warfare token of isolated perceived-as-non-standard ISG.




Figure 10 Video game COD Modern Warfare Token 1 Isolated perceived-as non-standard 1SG.

Note how in figures 9 and 10 the actor, with a role and personae established by the game's producers as 'cool', manages somehow to articulate the words and also compress the offglide of the F2 formant, spreading its nonchalant prosody to the entailment, providing the utterance with a general sense of coolness that perhaps wouldn't exist had the phrase been uttered by a non-actor.




Figure 11 COD Modern Warfare (token 4) Isolated perceived-as-cool 1SG. "then give me what i need", between a mid back and a schwa.

It's an interesting entailment from closed-labial vowel sound, to attenuated 1SG, to ensuing phone have the chunking effect affords a non-standard feel to the utterance. Figure 11 demonstrates how actors can modulate their voices to utter the 1SG clearly yet still have its intonation transpire as 'cool'.

The formant tracks show the token from the end of the utterance "then give me/ what i need". It is spoken by the same actor as token 1, who displays therein an English (perhaps Northern) accent with American overtones.

In Fig.11, the accent slides notably—during the utterance—into a fully American, even Southern drawl to perform the NS1sg; creating a first part "then give me" = UK, and a second part "what i need" = US.

5 Results




Figure 12 Distribution of the F2 formants showing the shifted locus of the proposed NS1sg.

The initial results (Fig.12), based on auditory acoustics showed that of the 131 tokens (F1 & F2 of both nucleus and offglides), 92 were perceived as 1SG, and 37 as NS1sg. The full corpus had a frequency range of 1984Hz from min. 758Hz to 2742Hz max, with a mean 1827.04Hz and median of 1810Hz and SD of 1431Hz. The perceived NS1sg sits in the frequency area of high F2, and that as expected the 1SG personae reside lower in the F2. The frequency of the 'less self-asserting' voice correlates with the same personae from highly viewed mass media.




Figure 13 F2 measurements with typical IPA values.

In a more acoustically fine-grained representation of the data, the end points mapped over IPA norms (Fig.13) showed that actor personae in mass media displaying coolness is weighted away from the 1SG diphthong offglide (/I/). I expected clustering of schwa and lower mid back unrounded vowels, however I discover that the monophthongal expression of the non-standard form is indeed (also) performed using the nuclear vowel of the standard diphthong and discarding the high front of the offglide.

6 Conclusion

In conclusion, this study has provided some evidence that the NS1sg and 1SG rely on hyperbolic tropes deeply rooted in cultural enregisterments. Through the examination of aural and multimodal indexicals disseminated by mass media, including state and commodity sources, the acoustics of the corresponding NS1sg and 1SG vowel sounds have been measured. As anticipated, the findings demonstrate a correlation between these formants and their general locations on the IPA chart, confirming the presence of a higher-front tongue final position for the offglide of the standard diphthong /ai/ enactments, as well as a lower-

mid/back tongue final position for the NS1sg monophthong. This empirical evidence strengthens our understanding of the linguistic dynamics within these cultural contexts and highlights the significance of mass media in shaping phonetic features in production.

7 Discussion

Noteworthy: some monophthongs with a higher F2 were perceived as standard. During the analysis it was interesting to note that several speakers managed to produce, despite constraints of speed and accent, liaison monophthongs of the 1SG with the nuclear pitch closer to the fundamental frequency of a standard diphthong offglide—thus retaining the *implication* of standard (RP) English, but with a cooler register. A standard /at/ diphthong may be perceived as a NS1sg due to chunking and to the prosodic effects of homogeneous intensity, reduced articulation, and spectral characteristics in particular creakiness or breathiness. The maintaining of even and lower pitch is crucial to an utterance sounding cool, so it makes sense to omit the diphthong offglide to do so. Which leads us to suggest that the NS1sg, when in the lexical string, because it is subject to 'loss of space and ensuing speeding up' (Burnett, 2023c, pp.113-118) performs not as word-final schwa but as a word-medial schwa:

We have seen that English non-final schwa vowels are very variable in quality, particularly F2, and that most of this variation can be explained in terms of assimilation to context. But we still need to understand why this kind of schwa is more variable than a full vowel. Flemming (2004) argues that two related factors are involved: word-medial schwa is (i) very short, and (ii) it does not minimally contrast with other vowel qualities. These two factors are related because the short duration of non-final unstressed syllables motivates the neutralization of vowel quality contrasts in these contexts. Flemming (2009, p.12).

A full performance of the standard form offglide is a culturally and socially charged phone. Flattening the diphthong helps actors imbue their phrases with a mix of nonchalance and assertiveness by preventing too much of an intonational rise as in a declarative phrase. When paired with the 1SG, this makes for a strong intonational message: "I am, no need to overstate". There are degrees of non-standardness however, and not all when listened to conveyed coolness. A few of them conveyed that their speakers were sad or ashamed. They remain in this corpus however a minority. The findings support the hypothesis that the NS1sg is

frequently enregistered, and these aural depictions correspond to the frequencies found in mass media, in turn bestowing upon the social actor a 'recombinant self' (Agha 2007, p. 334) within our "contemporarily dominant chronotope of mass mediated spacetime"—The interconnectedness of temporal and spatial elements in shaping the portrayal of the self within the context of linguistic enregisterment. This does suggest that in the usage of Shielding, the grapheme < i > is sociophonetically inscribed and maintained via actor personae enregisterment, allowing users to state their opinion more safely with an attenuated, modest 'voice'.

The results of this paper's analyses—however satisfying—are based on preliminary acoustic categorization by one person; hence in a sister paper¹⁹, I will share the results of an experiment conducted with n=84 participants to hopefully glean more evidence for shared perception of personae enregisterment and grapheme-phone pairing.
