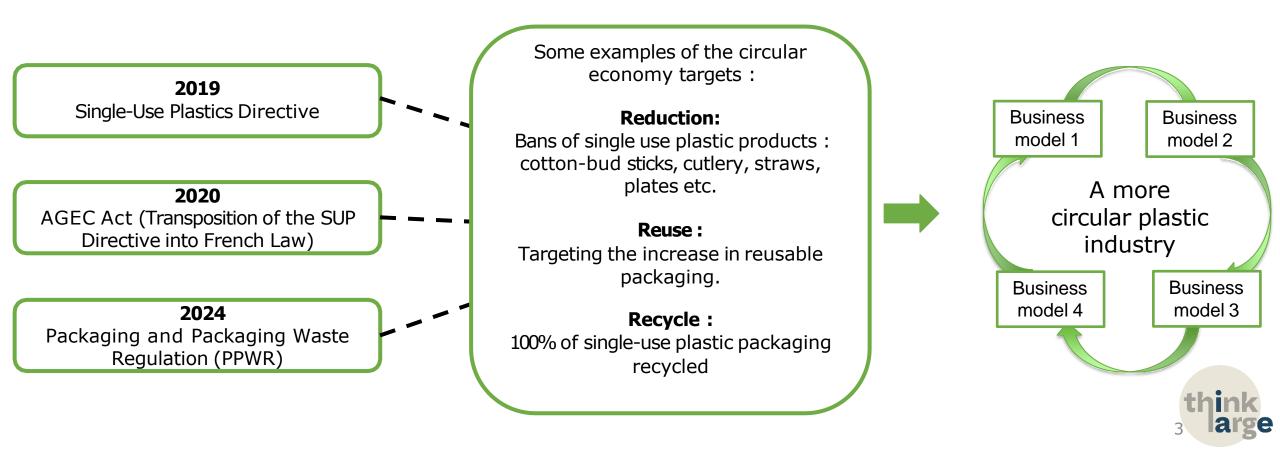

1.2 Introduction

A systemic approach to CE transition



Several studies have highlighted the importance of a systemic approach, enabling the simultaneous examination of the three levels—micro, meso, and macro—and their co-evolution (Korhonnen, 2018; Boldrini et al., 2019; Borrello et al., 2020).



Research question

What are the emerging business models in the transition to a circular economy within the plastic packaging industry in France?





2.1. Theoretical framework

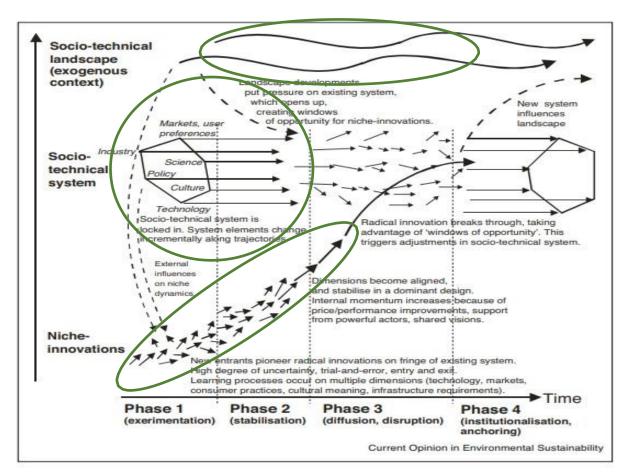
Connect business model research with the literature on the multi-level perspective

Multi-level Perspective (MLP) for the transition to a circular economy (Geels, 2019)

 Analyzing the transition to a circular economy requires an approach that takes into account the multi-level nature of the transition.



The MLP conceptualizes the transition as a result of dynamic interactions among the niche (micro level), the regime (meso level), and the landscape (macro level).







2.2. Theoretical framework

Business model in the MLP...as the coordination of social and physical technology (1/2)

Technology can be divided into (Nelson & Nelson, 2002):

For ex. Baking a cake

Physical technology:

Recipe (inputs and equipment)

- Social technology (play a crucial role by facilitating the implementation of physical technologies).

The way work is divided and coordinated

Business model:

- a conceptual tool of a company's organizational and financial architecture (Teece, 2010).
- It represents the coordination of the "recipe" + "the way work is divided and coordinated"
- ⇒ Business model can be conceptualized as the coordination of social and physical "technology"





2.2. Theoretical framework

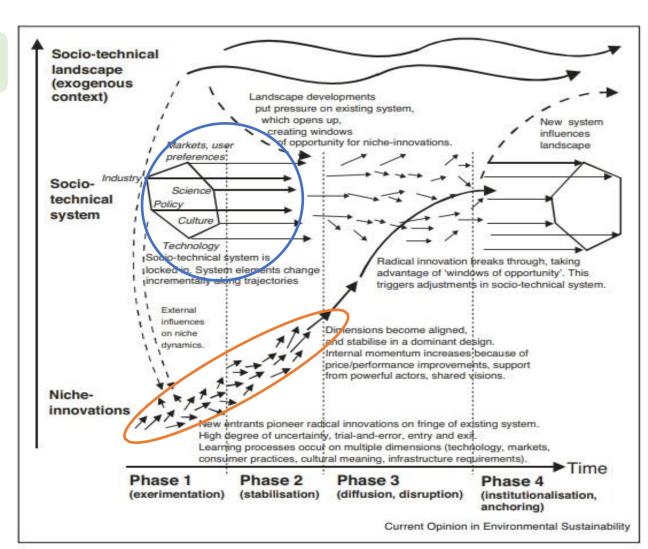
Business model in the MLP... as the coordination of social and physical technology (2/2)

In the MLP technology plays a crucial role in transitions.

=> Transition: interactions between new technology in the niche, the regime, and the landscape(Geels, 2004).

Integrate BM in the multi-level perspective.

- Niche => New BM
- Regime => Established BM



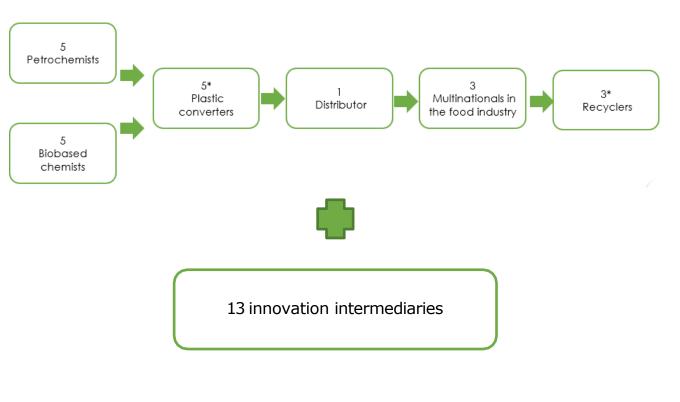


3. Methodology



Qualitative research approach (Yin, 2009)

Case study: 39 semi-directive interviews in total

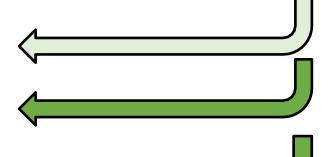

New 100% biobased biodegradable plastics "Conventional" biobased plastic (partially derived from renewable resources)



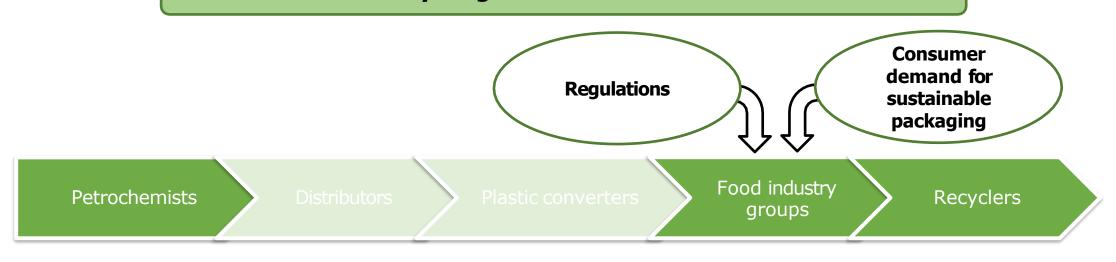

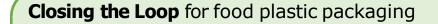
Chemical recycling and business model innovation



Chemical recycling

Incorporate recycled plastic into food contact packaging

Sorting, grinding and washing them if necessary



However, the degree of its' circularity can be questioned:

- -High energy consumption
- -Needs an important volume of plastic to be economically viable





4.3. Results

The transformation of the macro level and the destabilisation of the meso level create opportunities for the emergence of innovations and new business model

<u>Innovations in competition or symbiosis with the socio-technical</u> regime?

Chemical recycling symbiotic nature with the regime

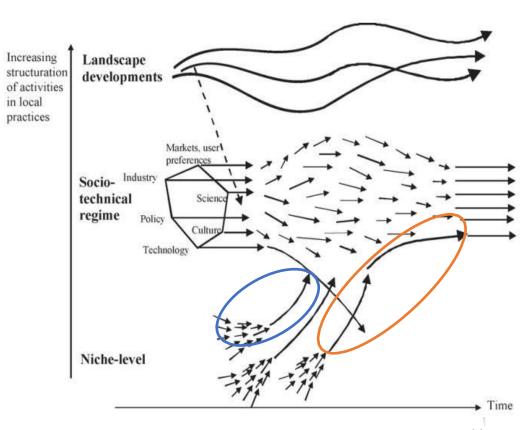
- Maintains the status quo of supply chain organization
- Receives support from influential actors
- Closes the loop without affecting the standards and practices of the regime

Conventional bio-based plastics symbiotic nature with the regime

- Maintain the status quo of supply chain organization
- Articulated with user preferences, regulation and infrastructure
- However, price is an important obstacle to it's diffusion

New bio-based biodegradable plastics <u>in competition with the regime</u>

- Do not maintain the status quo
- Do not (yet) receive support from the influential actors (ecoorganisms, regulation is not clear about them)



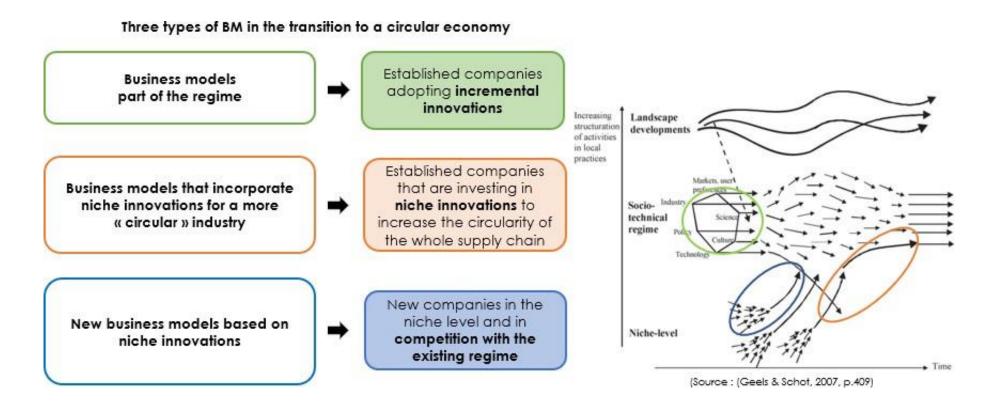




5. Conclusion

The macro-level changes have disrupted the established linear organization of the plastic packaging industry.

- At the micro level, this has created opportunities for the **emergence of new business model** (new bio-based plastics).
- At the meso level, **established companies** are opting for incremental innovations or niche innovations that **are in symbiose with the current organization** of the plastic packaging industry .
