The results indicate that social entrepreneurship significantly contributes to economic empowerment, particularly for marginalized groups, by providing employment opportunities, innovative business models, and capacity-building initiatives. Furthermore, social enterprises stimulate local economies, presenting sustainable solutions to complex social challenges. However, there is a need for comprehensive measurement frameworks to quantify their economic contributions accurately. Recommendations include fostering cross-sector collaborations, developing supportive ecosystems, integrating social entrepreneurship education, and encouraging knowledge-sharing platforms. Effective implementation of these recommendations can unlock the full potential of social entrepreneurship for inclusive economic growth.

#### **INTRODUCTION**

Social entrepreneurship is an innovative form of business (Essafar. 2023). that aims to solve social problems while also having a positive economic, social, and environmental impact (Diaz-Sarachaga & Ariza-Montes. 2022; Kalendzhjan & Kadol. 2022). It is a private activity in the social economy that aims to have a social impact rather than generate profit (Khan et al., 2023), involving innovative business models that drive change and have a positive impact on society (Klein. 2023). Social entrepreneurship plays a vital role in achieving sustainable socio-economic development by promoting intersectoral cooperation and involving different stakeholder groups (Praszkier & Munnik. 2023; Martin & Osberg. 2007). It addresses social problems that the public sector cannot meet and the private sector ignores, by providing innovative solutions and meeting the needs of the community (Praszkier & Munnik. 2023). Social entrepreneurship, in its turn, tends to foster the richness of constitutional rights and freedoms, specifically, human right to work, live in dignity, and be protected (Khan et al., 2023).

Through partnerships, networking, social-environmental orientation, social entrepreneurial success is fostered (Rahdari et al. 2016; Godwin et al., 2022). - Provide incentives and supportive ecosystems, such as access to finance, mentorship programs, and regulatory frameworks, to foster the growth and scalability of social enterprises, enabling them to maximize their economic contributions.
