Societal issues

600 tons of plastic waste are daily dumped into the Mediterranean Sea, 94% of these discharges being macroplastics (plastic mm). Among the particules consequences of this pollution, floating plastics constitute for the supports diverse microbial development of community leading to new ecosystems called **plastisphere**.

- ⇒ On plastics, antimicrobial resistance (AMR) is supported by BGN
- ⇒ Bacterial gender of ARBs depends on geographical site, but not on physical support
- \Rightarrow ARGs bla_{NDM} et *Intl2* genes are specific of plastics

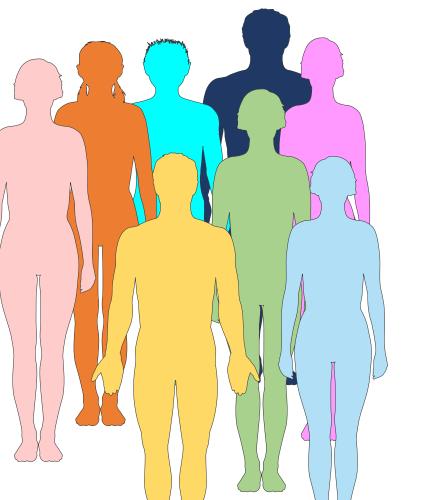

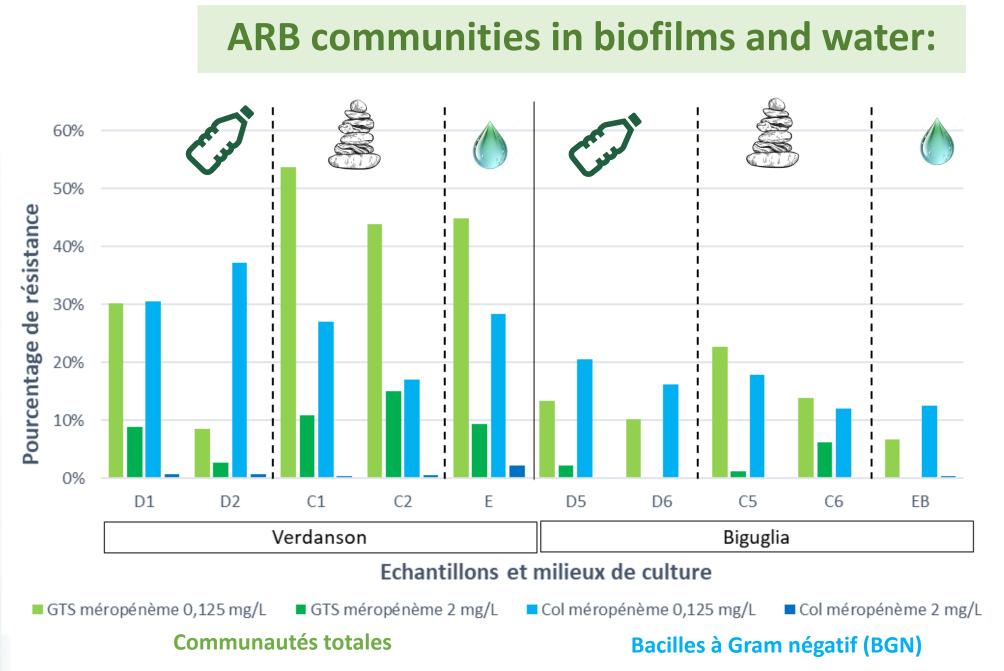

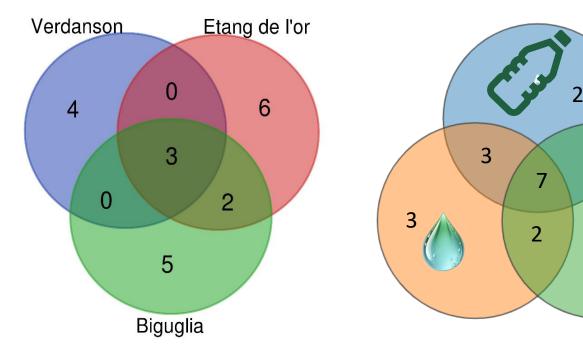
Raising user awareness

Survey respondents (volunteers) have good plastic waste reduction practices, 85% of whom set a goal of limiting their plastic production Respondents have a good knowledge of microplastics, but are not informed about the microbiological risks associated with plastic pollution. Respondents mostly surprised by scientific data on plastic pollution 63% of respondents have plans to improve their plastic waste reduction practices.

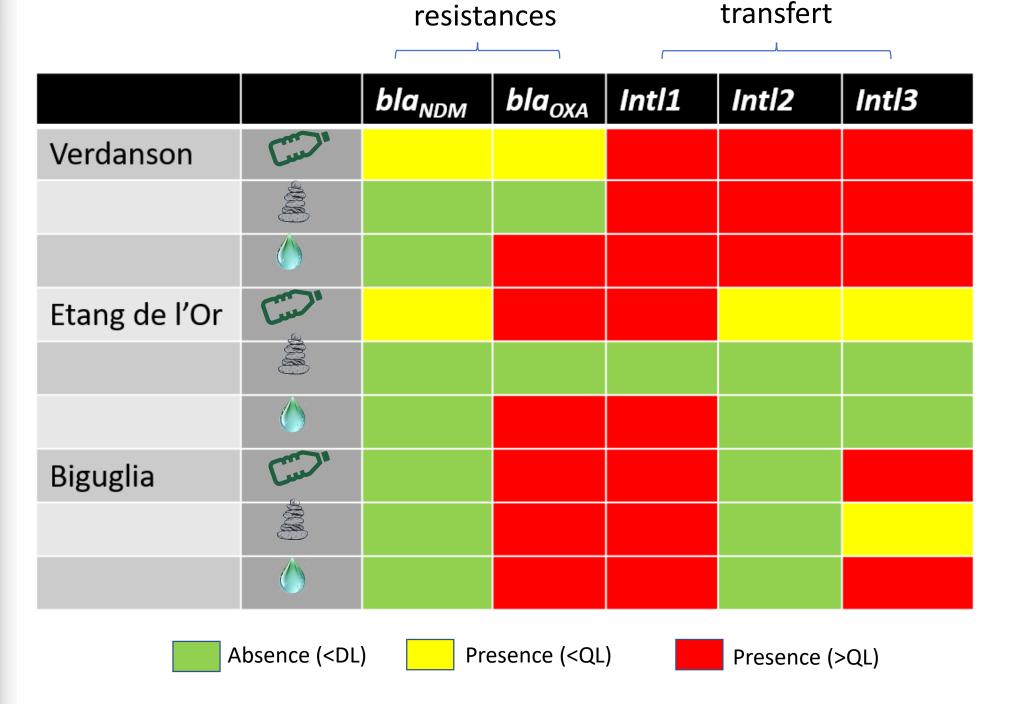
Comparison of bacterial communities (gender) on biofilms (and water):

How can scientific data constitute good arguments for adopting righteous behavior?

This study has been conducted at the interface between environmental ecology, chemistry and public health. Two aspects of the consequences of plastic pollution have been explored :

- Microbial question: This work has contributed to a better knowledge of antimicrobial resistance spreading conditions and a better understanding of the impacts of macroplastics on microbial ecology and public health. But the life cycle of the plastics collected is unknown. Thus a study of plastics "impregnation" (controlled life cycle) is planned as well as studies of macroplastics floating in salt water impacted by human activities (marina of Port Camargue).
- > Societal issues: According to this work, interested users have been recruited for survey. They are sensitive to scientific data, they want to reduce plastic waste, and are willing to apply good practices. Interviews analysis is scheduled to address the question of information transfert, to investigate how scientific informations can be well received to encourage users to adopt virtuous behavior or to identify the levers for action to improve plastic pollution management.

Another question is also planned to be addressed: Could antimicrobial resistance evidenced on macroplastics be useful as sensitive markers of public health and constitute a supplementary argument:

- > To persuade local public services and decision makers to improve the sites cleaning and the waste sorting and recycling;
- > To convince national stakeholders to limit plastic production, to support the reuse of plastics (circular economy) and to incite the use of non-plastic materials;
- > To inform the population on the risks of plastic pollution and to adopt an ethical behavior.
