
## INTRODUCTION

Per- and polyfluoroalkyl substances (PFAS) represent a class of emerging contaminants with over 4,700 variants, raising concerns for marine ecosystems due to their pervasive presence and unknown impacts. Despite regulatory efforts, the use of PFAS alternatives persists, necessitating a deeper understanding of their effects on marine organisms. Our aim was to assess the biochemical effects of chronic exposure of blue mussels (Mytilus spp.) to a mixture of PFAS at environmentally relevant doses via water and food routes.



# FATTY ACID PROFILES

**1. Identification of Key Fatty Acids Influenced by PFAS Exposure** 

Fatty acids with a proportion greater than 0.05% of the total fatty acids were considered for the analysis.



# **BIOCHEMICAL MARKERS**

### **1. Data Distribution Overview**





Fig. 1. VIP scores (left) and hierarchical Ward clustering heatmap (right) of the 10 most influential compounds identified by PLS-DA from normalized data.

**Ether C19H38O\_4** has the highest discriminant ability (VIP > 2.5), followed by several unsaturated fatty acids (C18:2n-6, C22:1, C21:2, C20:5n-3) and DMA\_3, suggesting their **potential as biomarkers**.

The heatmap shows higher fatty acid levels in Food&Water condition, with a notable **decrease in C21:2**, indicating a specific response to PFAS exposure. Combined PFAS exposure (Food&Water) may have a greater impact on fatty acid composition compared to single exposure (Food).

2. Comparison of Key Fatty Acids Proportions Between Conditions



Sample clustering is primarily driven by tissue type, with minimal influence from experimental conditions, suggesting strong tissue-specific biomarker responses.

**2.** Tissue-Specific Variations in Biomarker Levels




Fig. 4. GST activity (A), AChE activity (B) and LOOH concentrations (C) in Mytilus spp. under three experimental conditions (Control, Food, Food&Water). Letters indicate significant differences between tissues, and asterisks indicate significant differences bewteen conditions (Two-way ANOVA, p<0.05).

### PFAS exposure has **minimal impact** on most fatty acid proportions, except for **C21:2** which is significantly reduced in Food&Water condition, indicating a specific response to PFAS.

Ether C19H38O 4 shows no significant difference between conditions, questioning VIP scores' predictability of actual differences.

Significant differences in biomarker levels across tissues for each condition, with few significant variations between conditions within a specific tissue, except for GST activity, which is higher in gills and lower in mantle in Food&Water compared to Control. This confirms that **tissue type is the dominant factor influencing biomarker responses**.

# CONCLUSION

Combined PFAS exposure (via food and water) has a greater impact on fatty acid composition and GST activity in *Mytilus* spp. compared to single exposure routes. Specifically, the fatty acid C21:2 is significantly reduced under combined exposure, indicating a specific biochemical response to PFAS at environnemental concentrations.
