# Individual and contextual determinants of early access to post-rape care: A retrospective cohort study of 4048 women in the Democratic Republic of Congo from 2014 to 2019

# ABSTRACT

*Background:* Armed conflict in the eastern Democratic Republic of Congo (DRC) has significantly increased the incidence of sexual violence against women. Victims who manage to access health care within 72 h of experiencing rape can receive critical preventive care to mitigate the consequences of such violence. Despite this, a disproportionately small number of victims are able to obtain medical care within this crucial time frame. This study aimed to identify both individual and contextual factors that influence the likelihood of accessing post-rape care within 72 h in the eastern DRC.

Methods: This retrospective cohort study utilized patient records from Panzi Hospital along with contextual

data provided by the South Kivu Provincial Ministry of Health. It encompassed rape victims residing in South Kivu province who sought post-rape care between 2014 and 2019. To identify individual and contextual factors influencing timely access to care (within 72 h), multilevel logistic regression analysis was employed. *Results*: The study included a total of 4,048 women, with 30 % being under 18 years old and 40 % married. Around 13 % accessed care within 72 h of rape. Multivariate analysis revealed that timely access to care (within 72 h) was negatively influenced by factors such as the isolation of the victim's health zone of residence (aOR = 0.29 [0.14–0.63], p = 0.002), the distance between the home health zone and the hospital (aOR = 0.75 [0.54–0.99], p = 0.041), instances of rape occurring in 2015 or earlier (aOR = 0.44 [0.34–0.57], p < 0.001), and referrals to the hospital from other health facilities or organizations (aOR = 0.78 [0.61–1.00], p = 0.049). Conversely, being single was positively associated with access to care within this critical period (aOR = 1.29 [1.03–1.61], p = 0.024). Furthermore, statistical trends indicate that the presence of Panzi partner

NGOs in the victim's health zone might facilitate access to care (aOR = 1.33 [0.99-1.80], p = 0.057), highlighting an area of interest, while being internally displaced at the time of rape was associated with a trend towards reduced access to care (aOR = 0.78 [0.59-1.02], p = 0.068), underscoring the need for further

research and targeted interventions. *Conclusion*: To enhance access to post-rape care, our study highlights the need for strengthened collaboration with all partnering organizations and focused efforts on raising awareness, particularly among married women and their husbands. Enhancing security measures, constructing or upgrading roads to better connect major cities with currently inaccessible or isolated areas, bolstering the efforts of both local and international NGOs, and offering comprehensive reproductive health services to internally displaced women and those residing in the victims' health zones, are crucial steps toward ensuring access to post-rape care within the critical 72-hour window.

# 1. Introduction

Sexual violence (SV) is a major public health problem. Access to treatment and care after rape is another. Access to preventive health care after sexual assault remains low, and most victims suffer adverse consequences. In both war and peacetime, these consequences are

highly traumatic in both the short and long term, affecting both the victim and society as a whole [1,2]. In conflict zones, unwanted births, sexually transmitted infections (STIs) or HIV, fistula and sterility are the most frequently cited physiological consequences [3–6]. A meta-analysis of 20 studies on the consequences of rape, including 12 on the DRC (Democratic Republic of Congo), shows that up to 46.3 % of women raped in conflict zones became pregnant as a result of rape. Between 2.1 % and 28.7 % of victims have traumatic genital lesions or tears. Between 9 and 40.7 % of rapes result in rectal and vaginal fistula. STIs and sexual dysfunction were the most common problems, with prevalence rates ranging from 4.6 % to 83.6 % and 20.1 % to 56.7 %, respectively [7–9].

Rape is also associated with poor psychosocial health<sup>1</sup> among women. The most commonly reported psychosocial problems are fear and anxiety, posttraumatic stress disorder, depression, poor self-esteem, social adjustment issues, and sexual dysfunctions [10]. These physiological and psychosocial consequences vary according to the circumstances and nature of the rape. According to a series of studies conducted in eastern DRC, women who had been sexually assaulted by four or five attackers were two to three times more likely to develop gynecological problems than women who had been raped by a single attacker. Victims who had given birth as a result of rape were 2.5 times more likely to suffer severe trauma than those who had not[7,9]. Victims of conflict-related sexual violence were more likely to develop severe symptoms of post-traumatic stress disorder and psychological distress than victims of non-conflict-related sexual violence [12].

Despite the link between rape and health problems, few victims have access to post-rape treatment and prevention. A study conducted by UNFPA in the DRC shows that less than 25 % of victims reach a health facility within 72 h of being raped [13]. In addition, statistics from Panzi Hospital<sup>2</sup> show that approximately 13 % of victims receive medical consultation within 72 h of rape. However, medical care after rape varies depending on the time between the rape and the medical consultation, i.e. whether the victim access medical care before or after 72 h. Victims who access post-rape medical care before 72 h receive special care. This includes prevention of sexually transmitted diseases, pregnancy, HIV, hepatitis B, and tetanus [15]. Thus, the health consequences of rape can be avoided or reduced if victims seek care before 72 h.

In reviewing the literature on this topic, we identified a number of studies that analyzed the factors associated with delayed post-rape medical consultations in countries not affected by conflict. For example, Leye *et al.* [16] found that delayed access to medical care among rape victims in Senegal was associated with being over 18, being married, and being pregnant. Hanson et al. [4] found that in the United States, teenage victims were more likely to seek early post-rape care. Little attention has been paid to access to post-rape care in conflict zones. In addition, the identified studies did not analyze contextual factors related to the provision of care in the victim's place of residence.

This study aimed to identify both individual and contextual factors that influence the likelihood of accessing post-rape care within 72 h in the eastern DRC.

# 2. Patients and methods

# 2.1. Study design, data sources and population

This retrospective cohort study was conducted in eastern DRC, involving female victims of sexual violence (SV) who received treatment for rape at Panzi Hospital in Eastern DRC from 2014 to 2019 and resided in South Kivu. Individual data were sourced from the Panzi Hospital database, while contextual data were obtained from the South Kivu Provincial Ministry of Health and the Panzi Hospital administration.

# 2.2. Inclusion and exclusion criteria

The database documented many forms of sexual violence, with rape being by far the most common (99 %). Only victims who had been raped, who lived in the province of South Kivu at the time of the rape, and who had never received post-rape medical care elsewhere were included. Rape victims who received post-rape care at other facilities before being transferred to Panzi for further treatment were not included in the sample analyzed (49 records). Similarly, rape victims from other provinces or countries (132 records) were not included in the study because contextual information on their health zones of residence was not available.

# 2.3. Measures

The outcome variable was access to care within 72 h following the rape, represented as a dichotomous variable: 1 for victims who accessed care within this timeframe, and 0 for those who did not.

Twenty-three (23) independent variables were selected, which are listed in Table 1. Most of the variables were selected based on their availability in the datasets and their theoretical relationship with access to health care after rape, as reported in previous studies [4,11]. Other variables were included in the model after interviewing various people involved in rape care in South Kivu. Some variables were measured at the individual level, others at the level of the health zone where the victim resides at the time of the rape.

Individual level (level 1) factors. Nineteen (19) individual level variables were selected: age (<18 years, ≥18 years), marital status (married, single, separated/widow), highest educational attainment (no diploma, completed primary school, completed secondary school), tribe (Bashi, Barega, other), religion (no religion, Protestant, Catholic, other), rape cohort (coded 2015 or before and After 2015, to account for the change in the predominant type of rape before and after 2015<sup>3</sup>), head of household (no/yes), engaged in income-generating activity (no/yes), place of residence (urban, rural), disability (yes if the victim has a physical or mental disability as assessed by a doctor or psychologist, and no otherwise), vulnerable (yes if the victim is in any of the following situations: victim living alone or on the street, minor abandoned by family, married woman abandoned by husband, and no otherwise), displaced (no/yes), having been referred to the hospital (no/yes), previous rape (no/yes), relationship with perpetrator (no/yes), armed perpetrator (no/yes), number of perpetrators (no/ yes), kidnapped (no/yes), tortured (no/yes).

**Contextual level (level 2) factors.** The victim's health zone of residence was the identifier for the contextual variables. Four contextual variables were selected: the number of active NGOs working with Panzi Hospital in the victim's health zone of residence, the number of health facilities in the victim's health zone of residence, the distance

by road between the victim's health zone of residence and Panzi Hospital, and the isolation of the victim's health zone of residence. The number of NGOs and health facilities variables can in principle vary over time, but due to a lack of data, they were fixed at their 2018 value. However, given low social investment or entrepreneurship, they were assumed to vary little over time, limiting potential bias. They were also not calculated per 1000 inhabitants due to a lack of credible population data by health zone. The distance variable was

measured using Google Maps. The variable isolation of health zone was coded 1 if there was no viable road<sup>4</sup> connecting the victim's health zone of residence to the city of Bukavu, where Panzi Hospital is located, and 0 otherwise. The number of NGOs and the number of

health facilities were taken from the Panzi Hospital administration and from the Ministry of Health of the Province of South Kivu, respectively.

# 2.4. Statistical analysis

In the bivariate analysis, we examined the relationship between access to care within 72 h following the rape and both categorical and quantitative variables. Categorical variables were analyzed using the chi-squared test, while quantitative variables were evaluated with the Student's t-test, assuming normality and homogeneity of variances, or with the Welch's test when these assumptions were not met. A two-level multilevel logistic model with random intercept was used in the multivariate analysis. All independent variables used in the bivariate analysis were included in the multivariate analysis, as some variables that were not statistically significant in the univariate analysis were found to be statistically significant in the multivariate analysis [20]. Independent variables were included in the model based on their level of measurement (individual or contextual) using a four-step approach (Table 2). First, an empty multilevel model (null model) was estimated, i.e. a model with no explanatory variables, showing the proportion of variability in access to post-rape care before 72 h that is explained by health zones (the intraclass correlation, ICC). The greater this variability, the more relevant multilevel modeling is [21]. The results (Table 2) showed that health zones explained a very large (intraclass correlation = 25 %) and significant  $(p < 0.001)^5$  proportion of the total variability in access to care, indicating the relevance of multilevel modeling. Second, only individual level variables were included (Model 2, Table 2). Third, only health zone level variables were included (Model 3, Table 2). Fourth, a full model including all individual and contextual level variables was estimated (Model 4, Table 2). The multilevel model allowed estimating both fixed and random effects [21]. The fixed effects, reported as adjusted odds ratios (aOR) along with their 95 % confidence intervals (CI), enabled the analysis of factors associated with access to care before 72 h. The fixed effects results of the full model (Model 4) were retained for interpretation and discussion, as the full model outperformed the first three models (lowest Akaike information criterion, AIC). Random effects, represented by the contextual variance, its standard deviation and the ICC, were used to analyze the variability in access to health care explained by individual and contextual level factors. To assess the significance of this variability, the likelihood ratio (LR) test was used. This test compared the variability in access to care explained by the variables included in each model with that explained by the null model. The Wald test was used to test whether the contextual variance in each model was not significantly different from 0. The multilevel model (AIC = 2615.9, Table 2) fitted the data better than the logistic model (AIC = 2662.3).

We tested for possible collinearity between the explanatory variables using generalized variance inflation factors, GVIF [22]. The results (Supplementary Table 1) showed no evidence of high collinearity among the explanatory variables (mean GVIF = 1.19, median GVIF = 1.12, maximum GVIF = 2.09, and minimum GVIF = 1.03).

There were 8 % missing values in the dataset. We replaced missing values using multiple imputation. To assess the effect of imputing missing values on the results, we ran a two-level multilevel model after dropping all rows with missing data. The results were very similar to those reported in Table 2.

Variables with a p-value less than 0.05 were considered to have a statistically significant effect on access to care. However, those with a p-value  $\geq 0.05$  but < 0.075 were identified as exhibiting a trend towards significance. This nuanced approach, distinguishing between full statistical significance and trending significance, allows us to

broaden the discussion to include variables that suggest important trends in practice for access to post-rape care. Although these variables do not meet the conventional threshold for statistical significance, their *p-values* in the specified range may point to potential patterns or trends deserving of attention for their practical implications in understanding and improving access to care. Analyses were performed using the *lme4* and *mice* packages of R software, version 4.3.2.

# 2.5. Ethical consideration

The database used is totally anonymous. Patients are identified by a numerical code that does not allow them to be identified in any way.

# 2.6. Data availability statement

Access to the data requires a request, accompanied by the study project, to the ICART Research Center of the Panzi Foundation. Data on health zones are available in a document, 'the health pyramid', published by the Ministry of Health of the province of South Kivu in 2018.

# 3. Results

# 3.1. Sample description and bivariate analysis

The study encompassed a total of 4048 women, of whom approximately 13 % accessed care within 72 h following the incident of rape. Most of the victims are over 18 years old (70 %), married (40 %) or single (38.9 %), have no diploma (44.6 %), are not heads of household (74.3 %), live in a rural area (67.2 %), live an average of 84 kms from the hospital, have no relationship with their perpetrators (71.5 %), have been raped before (79.6 %). Half of them (50 %) were attacked by a single person; 43.2 % were attacked by an armed person (see Table 1).

The bivariate analysis of factors associated with access to post-rape care within 72 h is presented in Table 1. Most victims access care after 72 h (87.1 %), while a minority (12.9 %) access medical consultation before 72 h, confirming the problem of the present study. Access to care before 72 h varies significantly (*p-value*<0.05) according to age, education, tribe, being head of household, occupation, urban or rural environment, isolation of the area of residence, disability, time of rape, presence of a relationship with the perpetrator, number of perpetrators, type of perpetrator, distance, number of health facilities in the health zone, number of Panzi partner NGOs and number of health facilities in the victim's health zone of residence.

# 3.2. Multivariate analysis of factors associated with access to post-rape care before 72 h

Table 2 (full model) shows the individual and health zone-level determinants of access to post-rape care within 72 h.

Access to care before 72 h is statistically significantly and negatively associated with the isolation of the victim's health zone of residence (aOR = 0.29[0.14–0.63], p = 0.002), the distance between the home health zone and the hospital (aOR = 0.75[0.54–0.99, p = 0.041]), having been raped in 2015 or earlier (aOR = 0.44[0.34 –0.57], p < 0. 001), being referred to the hospital by other health facilities or organizations (aOR = 0.78[0.61–1.00], p = 0.049), being Murega<sup>6</sup> (aOR = 0.63[0.41–0.97], p = 0,037) and with the number of

perpetrators (aOR = 0.73[0.55–0.96], p = 0.024). Being internally displaced at the time of rape (aOR = 0.78[0.59–1.02], p = 0.068) is associated with a trend towards decreased access to post-rape care. However, access to care before 72 h was statistically significantly and positively associated with being single (aOR = 1.29[1.03–1.61], p = 0.024), having been tortured during the rape (aOR = 1.69[1.23–2.32], p < 0.001), while having experienced a previous rape (aOR = 1.26[0.98–1.62], p < 0.072) and the number of Panzi partner NGOs working in the victim's health zone of residence (aOR = 1.33 [0.99–1.80], p = 0.057) were associated with a trend towards increased access to care.

# 4. Discussion

# 4.1. Main findings

Our main findings highlight factors amenable to intervention by public health practitioners or policy makers aimed at enhancing access to care, or those presenting a significant public health concern [23,24]. Only about 13 % of sexual violence (SV) victims receive postrape care within the crucial 72-hour window. Factors negatively impacting the likelihood of accessing timely post-rape care include being married, residing in an isolated health zone, greater distance between the home and hospital, incidents of rape occurring in 2015 or earlier, referrals from other health facilities or organizations, and being internally displaced at the time of the rape. Conversely, the presence of Panzi partner NGOs within a victim's health zone might facilitate access to post-rape care.

# 4.2. Factors associated with access to post-rape medical care within 72 h

All factors related to access to care before 72 h were grouped into socio-demographic factors, factors related to the context of the rape, geographical factors and factors related to care delivery.

# 4.2.1. The role of sociodemographic factors

Our results showed that married victims were less likely to access post-rape care before 72 h than single victims. This finding, which confirms that of Leye et al. [16], could be explained by the fear of rejection by the husband and implies total discretion on the part of the victim. In fact, in the African context and particularly in South Kivu, non-marital rape of a married woman is one of the multiple causes of couple separation [25]. This rejection is often based on the feeling that these women are contaminated with STIs [26]. Aware that women who are raped by someone other than their husbands are likely to be rejected by their husbands, Panzi Hospital mediates between rape victims and their husbands, talking to the husbands so that the victims can be calmly reintegrated into their families. The low propensity of married women to seek post-rape care before 72 h means that awareness raising is also needed not only among husbands whose wives have been raped, but also among husbands whose wives have not been raped and in the community. Women's lack of confidentiality with certain health workers or peer mediators in their village of residence may be another factor explaining married women's low propensity to seek treatment, as other studies have shown [27,28]. Provisions for confidentiality or anonymity would probably be necessary to encourage more women to go to health facilities to receive post-rape medical care.

# 4.2.2. The role of factors related to rape context

Access to care before 72 h was associated with factors related to the context of the rape. Victims raped in 2015 or before have less access to care than those raped after 2015. This would be mainly the result of greater access to information leading to changes in knowledge and attitudes about SV. Several factors may have contributed to this improvement in access to care over

time, including, first, the media and various community awareness activities carried out by Panzi Hospital<sup>7</sup> and other NGOs [15]; second the community health programs run by NGOs, offering health education to all members of the community in partnership with local providers, addressing negative gender norms through education and awareness-raising [30]. The effectiveness of such programs has been highlighted in the literature on prevention and response to sexual violence [31].

Internally displaced (IDPs) victims are less likely to receive care within 72 h. Refugees and IDPs are more vulnerable to sexual violence [32,33]. They are also less likely to have access to health care, as we have just found and as other studies have shown [34]. Factors contributing to poor access to reproductive health care among IDPs include lack of availability of care, lack of knowledge about services, lack of financial resources, and language barriers between patients and health care providers [35,36]. Although many efforts have been made by NGOs to facilitate access to reproductive health care for displaced people [37], our findings underscore the need for further efforts to provide care by strengthening existing programs or changing intervention strategies.

Victims raped by two or more people are less likely to access care before 72 h. However, victims who have been tortured are more likely to access care before 72 h. These findings highlight two opposing mechanisms through which conflict affects access to post-rape care. On the one hand, discouragement and despair following gang rape limit access to care before 72 h. On the other hand, in cases of torture, victims are more likely to seek treatment for their wounds, as other studies have shown [38].

# 4.2.3. The role of factors related to care delivery

Victims referred to Panzi are less likely to receive preventive care before 72 h. Those who refer victims to Panzi Hospital include the police, community or religious leaders, health structures and NGOs. This low propensity to seek post-rape care within 72 h for referred victims may be explained by a stock-out or lack of post-exposure prophylaxis (PEP) kits [29] at the health facilities where the victim first went immediately after the rape, or by the fact that some victims first seek legal assistance from the police before being referred by the police to Panzi Hospital.

According to our findings, the number of NGOs in the health zone facilitates access to care before 72 h. In the limited context of access to health care at Panzi Hospital, the NGO's work on access to care before 72 h consists of raising awareness of the right attitudes to adopt in the event of SV. Some local NGOs that do not have sufficient funds facilitate the transportation of victims to Panzi Hospital by paying for the transportation and then being reimbursed by the hospital. In some cases, the international NGOs also help to overcome the obstacles of distance, insecurity and isolation of the victim's home. For example, some patients are brought to Panzi by air (for example, by Aviation Without Borders or by the United Nations Organization Mission in Congo, MONUSCO) [17]). However, the role of NGOs in addressing sexual violence and promoting access to health care is much broader. They contribute, among other things, to the management of emergency rape care, the provision of PEP kits and equipment to health facilities [40], the coordination and capacity building of local actors in the fight against sexual and gender-based violence, the empowerment of victims [41], the collection of data on sexual violence and the reporting of cases of sexual violence [42].

Panzi Hospital has a communication department whose mission is to raise awareness about the right behavior to adopt in case of sexual violence. Awareness-raising is carried out in local media, schools, neighborhoods, public markets in rural areas, churches, etc. The Panzi Foundation also has a Mobile Clinic with a mobile team that provides preventive care against SV in remote areas of the city of Bukavu and the DRC (https://panzifoundation.org/fr/mobile-clinics-and-rapid-response-missions/).

# 4.2.4. The role of geographic factors

Access to post-rape care before 72 h is negatively associated with the distance between the victim's health zone of residence and the Panzi hospital. Behind this distance barrier are economic barriers, including transportation costs, physical infrastructure, travel time and its opportunity costs [39,43].

There are also disparities in access to care before 72 h between landlocked and non-landlocked health zones where the victim lives. Women living in landlocked health zones have less access to care before 72 h due to lack of viable roads and transportation.

# 4.3. Strengths and limitations

The first strength of this study is its sample size. Conflict was measured indirectly, mainly through practices such as being attacked by armed men, torture or kidnapping. This points to the relevance of more objective measures of conflict, such as deaths by health zone or the number of armed groups operating in each health zone of the victim's residence during the period covered by the study. This information was not found by health zone of residence of the victim and was therefore not analyzed in this study. The results of this study are based on an empirical approach. They can be complemented by a qualitative study in the form of an interview in which victims are asked about the reasons why they did or did not have access to medical care within 72 h of the rape. Due to a lack of data, we were unable to analyze the characteristics of Panzi Hospital's partner organizations, which transfer more victims to the hospital after 72 h. Knowledge of these organizations (police, local NGOs, international NGOs, community leaders, churches, working conditions, headquarters, etc.) would help guide the hospital's actions and collaborations to facilitate access to care before 72 h.

# 5. Conclusion

These findings underscore the critical need to enhance access to post-rape medical care by focusing on targeted awareness campaigns, particularly among married women and their husbands. To overcome the various barriers—be they material, financial, or organizational—that lead some organizations to refer patients to the hospital after the crucial 72-hour window, it is imperative to strengthen collaborations with law enforcement, healthcare facilities, and all partnering organizations. Enhancements in security measures, the construction or improvement of roads connecting major cities to currently inaccessible or isolated areas, bolstering the efforts of both local and international NGOs, and ensuring the provision of reproductive health care to internally displaced women and those residing in affected health zones are vital steps toward facilitating timely access to post-rape care.
