

Supplementary Figure 1. Illustration of DECOMICS based deconvolution of DNA methylation data. A. Parameters used in the DECOMICS application are described. B. Scree plot illustrating the selection process for the number of components to be deconvolved (module 1, step 3: Number of cell types). C-D. Deconvolution results are presented: (C) Component signatures are plotted, and (D) a heatmap showing component proportions (module 1, step 5: Results). E-F. Visualization of component distribution: (E) Distribution of a specific component across the cohort, and (F) distribution of all components within a given sample (module 2, step 7: Proportion visualization). G. Enrichment plot displaying the enrichment analysis for each component (module 2, step 6: Enrichment analysis) ORA indicates if an Overrepresentation Analysis has been performed, GSEA indicates if a Gene Set Enrichment Analysis has been performed for a given sample. Pval corresponds to the adjusted p-values of the Enrichment Score (ES) after correction for multiple testing.
