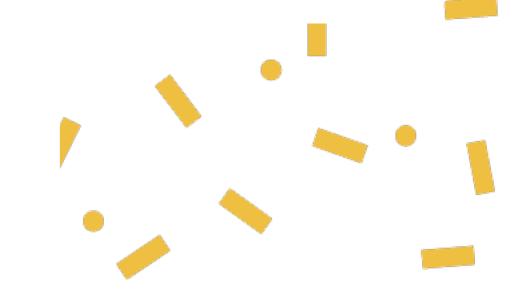

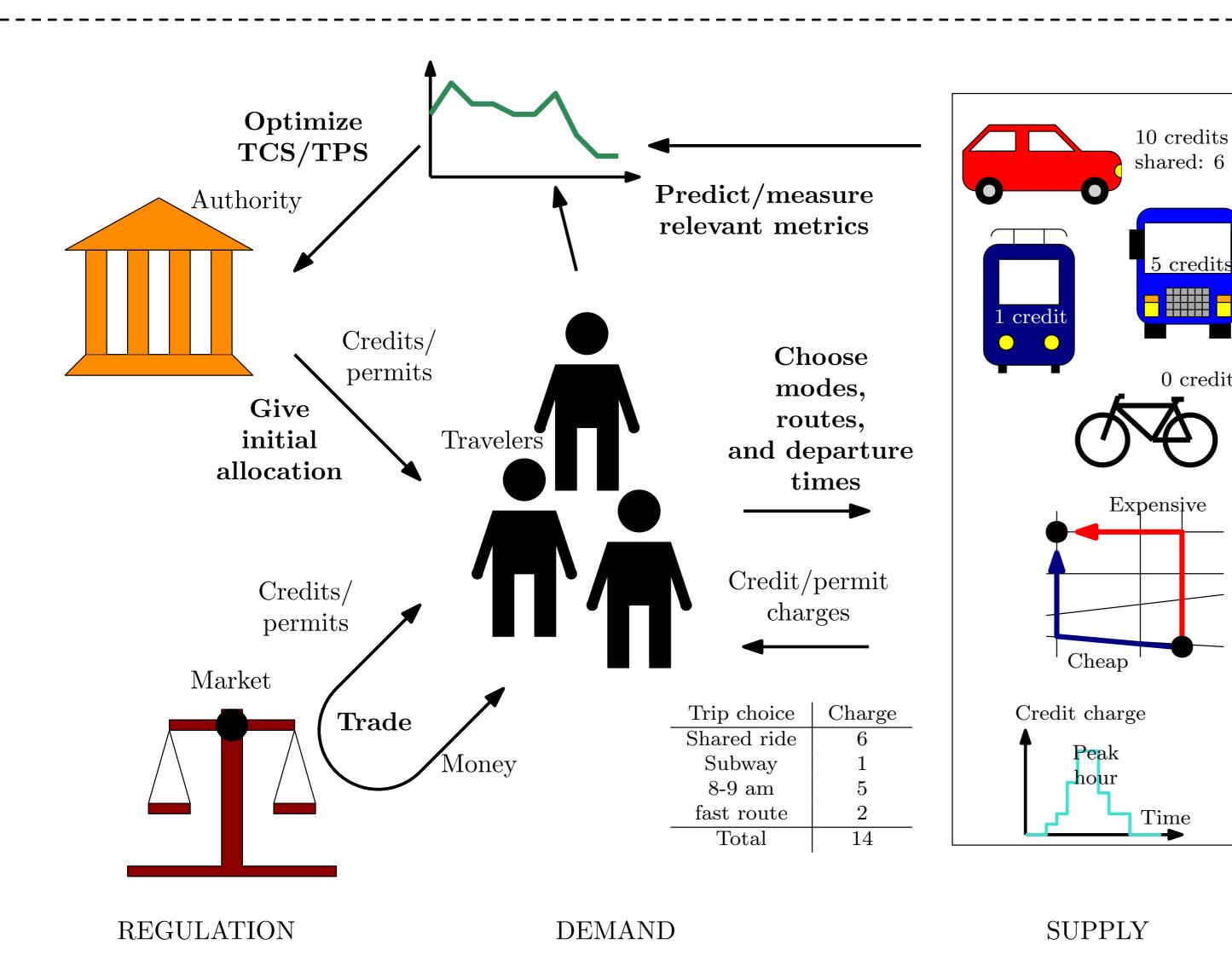

## Tradable mobility credits and permits: state of the art and future research directions



### TCS and TPS from the literature

#### Objectives/KPI

Reduce congestion Reduce pollution Ensure equity

#### **Charging schemes**

Link Time Distance Area Class Vehicle Negative charge

#### Market settings

Free initial allocation / auction Market clearing condition Regulator updates the price Double-auction market Transaction costs

#### **Credits and permits**

Urban mobility faces challenges to be more **sustainable** (pollution, congestion, equity). The redistribution of the travel demand in space, time, and transportation modes can improve the efficiency of the transportation network. User equilibrium → System optimum

Tradable Credit and Permit Schemes (TCS/TPS) are quantity-based policies: the regulator fixes the quantities, and the price is an outcome of the market. Credits and permits are commodities needed to access the transportation network.

The credits are indifferentiable, while permits are **specific** to a link and a timeslot.

Each travel alternative requires a given amount of credits (TCS) or a specific permit (TPS).

#### Limits and future research directions

Most contributions are based on Vickrey's bottleneck (fixed capacity and same trip length) and BPR function (no dynamics) to compute the travel times.

→ Use Macroscopic Fundamental Diagram (MFD) and agent-based simulators.

Most contributions deal with only car driving: changing routes and departure times. Some account for carpooling or transit riding but no on-demand services.

→ Investigate TCS/TPS to regulate **multimodal** networks with on-demand services.
