18	ABSTRACT

20	MicroRNAs (miRNAs) are recognized as key molecular regulators in most of intracellular processes
21	essential for plant adaptation to environmental changes. microRNAs can mediate regulation of gene
22	expression involved in development, acquisition of nutrients, defense and interactions with soil
23	microorganisms to enhance stress tolerance of plants. Accumulating evidences indicate that
24	microRNAs are also transferred within cells, organs or whole plant and released in soil as stress signals
25	of the plant-microbiome communication. However, little information is available about how mobile
26	microRNAs are conveyed from plants to the rhizosphere. To understand whether this intriguing
27	phenomenon occurs through root secretion, morphological changes, peroxidase (POX), superoxide

dismutase (SOD) and catalase (CAT) antioxidant enzymes activities, as well as the expression profiles

of developmental and oxidative stress responsive microRNAs were analyzed in root tissues and exudates

collected from wheat (triticum aestivum) exposed to bisphenol A (BPA) at low and high concentrations

(0.1 and 5000 mg. kg<sup>-1</sup> soil). BPA contamination significantly affected aerial and root biomass, and

miR164, miR167 and miR398 expression in roots of the group that received the highest dose. The presence of miR156, miR164, miR167 was detected in root exudates of controls and contaminated plants while BPA exposure increased miR 167 levels in exudates at high dose. Collectively, this experiment provided first results reporting microRNAs regulatory network participation in the BPA stress response of wheat. The identification of microRNAs as integral component of the root exudates will extend our knowledge about the molecular signaling in plant - soil microbiome interactions.

40 Main

Interactions between host and microbiomes in soil can exert through a complex and continuous 42 dialogue materialized by root exudation of bioactive molecules that select and modulate the 43 44 structure, functions, and activities of soil microbiota communities. Recently, research on new metabolites obtained from plant exudates focused on plant protection mechanisms against 45 46 pathogens and leads to the discovery of extracellular DNA secreted by border cells to neutralize root infection (Baetz and Martinoia 2014). Other nucleic acids as circulating microRNAs may 47 probably be secreted from root to influence surrounding microbiota in soil when grown under 48 abiotic stress. There is accumulating investigations showing that environmental stresses affect 49 production or degradation of miRNAs in root tissue and promote their movement throughout 50 the entire plant and its surface (Pandey et al. 2018; Daniela et al. 2018) but whether microRNAs 51 are transferred from root cell to the rhizosphere remains unknown. Here, we bridge this gap of 52 knowledge by demonstrating physiological changes and expression of miRNAs related to stress 53 tolerance in roots and root exudates from wheat grown on BPA contaminated soil. 54

BPA has emerged as a serious environmental concern owing to its extensively use for consumer
goods production, release into soils with effluents and wastes, and negative impact on soil

microbial communities and plants (Zaborowska et al. 2023). We used the same experimental 57 58 set-up as described in Yacoumas et al., (2020) to generate abiotic stress in wheat model exposed to increasing doses of BPA and to investigate root expression and transfer to exudates of several 59 conserved miRNAs that have been reported to modulate growth and ROS responsive genes 60 under drought and chemical exposure (Shi et al., 2018; Li et al., 2020; Geng et al., 2020). In 61 accordance with previous works, BPA exposure at high concentration level significantly 62 63 affected wheat biomass (Kim et al. 2018) and oxidative stress response measured by the activity of antioxidant enzymes. Unlike POX, SOD and CAT activities were enhanced by the soil 64 contamination at 500 mg. kg<sup>-1</sup> BPA after the 7 weeks of cultivation (figure 1). No evidence of 65 66 BPA effects was observed on root growth and enzymatic antioxidant defense systems at environmentally relevant concentration, confirming that homeostasis of ROS played an 67 important role in limiting root growth of highly exposed plants. 68

In the present study, we identified 5 miRNAs in root samples from BPA treated and untreated 69 plants, respectively. Among them, 3 miRNAs (miR164, miR167, miR398) were appeared to be 70 71 differentially expressed in wheat exposed to high BPA dose (figure 2). In addition, to our knowledge, this is the first time that BPA induced down expression of plant miRNAs has been 72 described. This reduction of root miRNA content was only observed in plants suffering from 73 74 severe growth delay, implying that the miRNAs participate directly or indirectly, to the coordination of the complex network of signaling molecules involved in developmental process 75 and stress adaptive response. Several down-regulated miRNAs such as mir164 and mir167 76 identified in our study have been previously reported to target transcripts encoding for auxin 77 signaling and transcriptional regulators of root growth and redox status in developing wheat, 78 rice, barley, soya and sugar cane (Shriram et al. 2016). 79

BPA stress among other abiotic stress that generate ROS production in plants was shown to
alter the expression of redox sensitive miRNAs regulated by oxidative stress. These responsive

miRNAs included miRNAs families such as miR398 and miR164 which were already known
to regulate key antioxidant enzymes activities by controlling mRNA stability of these enzymes
under oxidative stress conditions (Li et al. 2017).

85 The turnover of root miRNAs may have important role inside root cells of stressed plants but their modified expression might also account for secondary side effects such as a plausible 86 extracellular trafficking and elimination of root miRNAs trough secretion mechanisms. To 87 88 explore this possibility, we performed molecular profiling analysis of the exudation solutions and showed that root exudates collected from control and BPA exposed plants were enriched 89 for miRNAs. Of five miRNAs found in root tissue, all except miR398 and miR159 were 90 91 expressed in exudate samples and detected with fewer than 30 cycles of PCR, suggesting they were relatively abundant (figure 2). Using root miRNA that does not vary considerably between 92 individuals to perform data normalization of miRNA expression analysis, we found that root 93 system facilitates export of miRNAs in exudates of highly stressed plants. MiR167 displayed 94 higher expression in exudate of plants exposed to high BPA dose and correlate with its relative 95 96 abundance in root tissue. These findings suggest that the accumulation of these compounds in 97 root exudates are likely to be the result of endogenous production and transport from root cells toward to the surrounding environment. Further investigations are needed to understand exactly 98 99 how root tissue transfers miRNAs to the root rhizosphere interface and how exudation is controlled by BPA exposure. 100

Moreover, it remains unresolved under what circumstances plants benefit from miRNAs exudation such as the precise role of miRNAs exuded in improving plant tolerance to soil contamination. MiRNAs are not simply repressors of gene expression within the plant but also an external messenger, whose movement outside the plants can spread post transcriptional gene silencing to microorganisms living in close relation with them (Song et al. 2019). Although this mechanism is probably similar from the cross-kingdom exchange of miRNAs recently

described between plants to plants and plants to pathogenic fungi interactions. Indeed, miR167, 107 108 miR156 and miR164 have been identified and predicted among 78 miRNAs in wheat to target transcripts of several fungal species using computational approaches (Mathur et al. 2020). 109 110 MiR156 was also reported to shuttle from plants overexpressing miR156 to neighboring plants sharing the same hydroponic medium (Brosnan and Mitter 2021). Therefore, it is reasonable to 111 think that exuded miRNAs which are evolutionary conserved from species to species could play 112 113 a more important role than just waste elimination from the root system and influence the composition and activity of the soil microbiome to their advantage. 114

In conclusion, our results showed that plant miRNAs exist in root exudates of wheat model. 115 116 Abiotic stress conditions reduced expression level of several oxidative stress and developmentally regulated miRNAs in root resulting to increased exudation of miR167. The 117 relative abundance of this emerging family of metabolites know affecting plant-microbiome 118 interactions provides new insight on complexity and function of root exudation and holds great 119 potential for improve our understanding on soil ecosystem functioning and find new strategies 120 121 for enhancing the ability of plants to adapt and survive under harsh conditions caused by soil degradation. 122

#### 124 METHODS

#### 125 1. Soil properties and contamination

The soil used in the present study was collected in the 10-20 cm depth horizon of cultivated soil below wheat crop in the farm of UniLaSalle Institute in Beauvais, France (N 49°28'13.88", E 2°4'0.45"). The physicochemical properties of the soil were described previously and was classified as haplic luvisol (Yacoumas et al., 2020). The soil was sieved through a 5mm stainless mesh and mixed with river sand (22%; v:v). Then a sub-sample of soil was spiked with 50 ml solution of bisphenol A dissolved in acetone. After evaporating acetone in the room temperature
overnight, the spiked soil was homogenized and mixed with unspiked soil using a roller mixer
to reach environmental relevant and roots growth phytotoxic concentrations of 0,1 and 5000
mg BPA. kg<sup>-1</sup> dry soil (Kim et al. 2018). A solvent control soil was prepared with BPA free
acetone solution using similar procedure.

137 2. Greenhouse experiment and plant cultivation

A greenhouse experiment was conducted from April to May 2020 according to the protocol 138 detailed by Yacoumas et al 2020. Wheat seed (Triticum aestivum cultivar pakito, RAGT 139 semences Rodez, France) were sterilized with 10% (v/v) H2O2 for 30 min, washed with distilled 140 water, soaked in saturated CaSO4 for 6 h, and then germinated at 17°C for 7 days in the dark 141 142 between two layers of filter paper moistened with saturated CaSO<sub>4</sub>. Six uniform seedlings with visible 1-2cm roots were selected and planted using polypropylene pots filled with 2L of 143 uncontaminated soil (control), solvent control soil (acetone) or soil contaminated with BPA at 144 0.1 and 5000 mg.kg<sup>-1</sup> dry soil. All of the treatments were performed in four replicates. Pots 145 were randomly positioned in a greenhouse with controlled conditions (photoperiod 16h light/8 h 146 dark, light intensity of 10 Watts. m<sup>-2</sup>, day/night temperature of 20 °C). Plants were watered 147 three times per week with tap water. Half of seedlings were removed after one week of 148 exposure. Other seedlings (3 per pot) were grown and harvested after 6 additional weeks of 149 150 culture. Roots were gently rinsed with tap water to eliminate adhering soil and cleaned with adsorbing paper. Root exudates were collected then, roots with their leaves were weighted for 151 the measurement of biomass. Fresh leaves and root tissues were sampled separately and 152 immediately frozen in liquid nitrogen for molecular and biochemical analysis. 153

154 3. CAT, SOD and POX activity analysis

Root and leaves sample (300 mg) of frozen tissues was used for the determination of total 155 156 proteins, SOD, POX, and CAT activities. Plant tissue samples were ground and homogenized in a buffer solution. Next, the homogenized tissue was centrifuged and supernatants were 157 analyzed using a UV-light spectrophotometer microplate reader according to the protocol 158 described by Firmin et al., (2015) and Labidi et al., (2017). Total SOD and CAT activity were 159 determined using commercial kits (SOD kit, Sigma Aldrich; catalase assay kit Gaithersburg, 160 161 USA). SOD activity was measured by monitoring the absorbance at 550 nm due to the inhibition of nitroblue tetrazolium (NBT) reduction during 5 min. CAT activity was detected by recording 162 the decrease of absorbance at 540 nm due to H<sub>2</sub>O<sub>2</sub> reduction. Total POX activity was quantified 163 164 by monitoring 2,2'-azino-bis(3)-ethylbenzothiazoline-6-sulfonate (ABTS) oxidation induced absorbance at 405 nm using a calibration curve made with horseradish peroxidase (Sigma-165 Aldrich, Saint-Quentin Fallavier, France). Activity values were normalized to proteins 166 167 concentration (BCA protein assay kit, Sigma Aldrich)

#### 169 4. Total RNA extraction

Total RNA was isolated from wheat roots and exudates using miRNA miRNeasy Mini
extraction Kit (Qiagen, France) according to the manufacturer's protocol. Exudate samples
were purified prior extraction using membrane filtration followed by differential
ultracentrifugation. Total RNA was then quantified and assessed for quality using a Nanodrop
2000 (Thermo Fisher Scientific). RNA samples were stored at -80 °C until further analysis.

### 176 5. Real-time quantitative RT-PCR

The expression of miRNAs was measured by quantitative reverse transcription PCR. In brief,
cDNA was synthesized using 1 µg of total RNA, miScript Nucleics Mix and the miScript

Reverse Transcriptase Mix in HiFlex Buffer incubated at 37°C for 60 min and 95°C for 5 min 179 180 according to the protocol of miScript II RT Kit (Qiagen). Quantitative Real time -PCR was performed by using a StepOne plus apparatus (Thermo Fisher Scientific) with PCR kits. The 181 PCR primers sequences presented in supplementary table S1 were obtained commercially from 182 Eurofins (Ebersberg, Germany). MiRNA quantification was carried out using MiScript SYBR 183 Green PCR kit (Oiagen) consisting of QuantiTect SYBR Green PCR Master Mix and miScript 184 Universal Primer. Reaction mixtures were incubated at 95°C for 15min, followed by 40 cycles 185 of 94°C for 15 s, 55°C for 30 s,70°C for 30s. The expression levels of miRs were measured in 186 terms of threshold cycle (Ct) value and normalized to TEF1 in each root sample, which was 187 188 used as an internal control, whereas miR156 was selected as the housekeeper for gene expression of miRs in exudates. 189

191 6. Statistics

Parameters were analyzed by kruskall-Wallis test and pairwise comparison using R statistics 3.3.2 software (R Core team, 2017). Differences between the treatments were declared significant at the p-value of 0.05 (p < 0.05).
