





Introduction - Rhythmic patterns

ENGLISH




- **Stress accent**
Words can be distinguished **based on stress**.
- **Syllable** as a rhythmic unit
Stressed syllables are usually **higher, louder, longer**.


Look at that beautiful rainbow!



JAPANESE



- **Pitch accent**
Words can be distinguished **based on pitch**.
- **Mora** as a rhythmic unit
Each mora has **similar duration with different pitch height**.




Introduction - Hypotheses

Compared to L1 English speakers (NE), Japanese English learners (JE) demonstrate...


- 1) lower prosodic **contrast between syllables** within polysyllabic words

-> Syllabic Contrast Scores: NE > JE



- 2) lower prosodic **contrast between content and function words**

-> Lexical Contrast Scores: NE > JE



Would it be possible to measure the syllabic prominences automatically?

Data analysis - Corpus

34-hour read-aloud corpus

- 877 JE samples recorded by 42 Japanese university students
- 91 NE samples recorded by 7 professional English narrators

21 topics

- Japanese students wrote their presentation manuscripts and read them aloud.
- Professional narrators read aloud model presentation passages.

Participants' English proficiency levels


- Japanese students: ranging from CEFR A1 or below - B2
- Professional narrators: 5 AmE, 2 BrE; 3 males, 4 females


For each polysyllabic word:

Stress Score (word-level)



$\text{mean}(\text{pitch, intensity, duration})_{\text{most prominent syllable}} - \text{mean}(\text{other syllables})$

Syllabic Contrast (text-level)




Lexical Contrast (text-level) = mean(mean(prominent syll. of content words) - mean(prominent syll. of lexical words))


Conclusion

Compared to L1 English speakers (NE), Japanese English learners (JE) demonstrate...

- 1) lower prosodic **contrast between syllables** within polysyllabic words
-> Syllabic Contrast Scores: NE > JE -> YES



- 1) lower prosodic **contrast between content and function words**
-> Lexical Contrast Scores: NE > JE
-> **Basically YES, but NOT with pitch contrast**




Would it be possible to measure the syllabic prominences automatically?

-> **YES**


Unbalanced groups



- Resampling to 55 recordings per group.
- consider A2.1, A2.2...


Monosyllabic words stress estimation method

- Monosyll. words are considered stressed if their mean acoustic prominence level is ≥ 50



→ compare to immediate context or utterance median value.

Stress estimation



- devoicing,
- natural lengthening
- vowel intrinsic duration

Context-dependent stress patterns

Look at that beautiful rainbow!



- conduct stress analysis at the sentence level
- investigate how learners emphasize essential information within their utterances




Multidimensional (O/o)




Mean F0 (O/o)




Mean intensity (O/o)






Data analysis - Speech processing




- All the files (966) manually checked for word-alignment precision
81% of words correctly aligned


79% for JP and 92% for EN
per recording: median at 90% for JP and 96% for EN)

→ Keep only correctly aligned words (1)
within recordings of at least 80% of correct alignment




















Random resampling to 55 recordings per group


