The Talan Charter of Jayabhaya: A Kadiri-period Inscription Casting New Light on Airlangga's Kingdom

#### 1. Introduction

This article has sprung from the convergence of two separate research endeavors. On the one hand, all three authors have been collaborating over several years now on studying the epigraphic corpus of King Airlangga, who ruled in the first half of the 11th century with a powerbase in what is today *kabupaten* Lamongan. On the other hand, the first author is carrying out doctoral research on the inscriptions of Airlangga's successors first in Janggala and later in Kadiri, which are the terms commonly used in historiography and historical cartography to designate two historical territories in what is now the province of East Java, presented in the sources as having resulted from a division of Airlangga's realm and having gone through a period of armed conflict.<sup>1</sup>

As we have pointed out in our recent study (Titi Surti Nastiti, Eko Bastiawan & Griffiths 2022: 65–67), these events are known mainly from sources postdating it by several centuries, and it is not sure that all aspects of the commonly accepted historical narrative may be taken as fact.

After the end of Airlangga's reign, in the same territory as that, generally north of the Brantas river, where Airlangga's inscriptions have been found,<sup>2</sup> we find a small number of inscriptions dating from the 970s and 980s of the Śaka era, i.e. from ca. the 1040s CE.<sup>3</sup> This territory is conventionally called Janggala, although the name is hardly attested, if at all, in the relevant inscriptions, from which we learn about three kings, namely Garasakan (inscriptions of Malenga, 974 Śaka;<sup>4</sup> Garaman, 975 Śaka;<sup>5</sup> Turun Hyang B, 976 Śaka;<sup>6</sup> Kambang Putih, no date),<sup>7</sup> Samarotsaha (Sumengka, 981 Śaka),<sup>8</sup> and Alanjung Ahyes (Banjaran, 974 Śaka).<sup>9</sup> Since the epigraphic evidence is

For reasons unclear to us, even though the charter was discovered early on and commented on by Brandes in Groeneveldt's catalog (1887), no reading of it seems to have been available when Krom prepared Brandes' unpublished transcriptions for publication (Brandes 1913). A provisional reading was published only a few years ago (Hasan Djafar & Trigangga 2019: 234–237). In this charter, line A8, we encounter the word *jangalāñchana*. extremely limited, only little can be said about these figures. Nonetheless, two inscriptions issued by Garasakan, namely Garaman and Turun Hyang B, are of great importance as they are the only two contemporary sources on the partition of Airlangga's kingdom into territories here called *jangala* and *panjalu* as well as the subsequent strife between the two. According to the *Deśavarnana*, the division took place in 974 Śaka, and we learn from the Garaman charter, issued one year later, about a conflict between the two parties. <sup>10</sup> One year later still, the partition is alluded to in the inscription of Turun Hyang B. <sup>11</sup> After a few decades from which we entirely lack inscriptional sources, the historical record resumes with inscriptions issued from a different territory, conventionally called Kadiri or Pangjalu, although these names too are not so prominent in the contemporary sources. <sup>12</sup>

that Shalihah Sri Prabharani (2009), in her undergraduate thesis (*skripsi*), investigated an inscription she calls Mataji which is found in *desa* Bangle, *kecamatan* Lengkong, *kabupaten* Nganjuk. She concluded that the charter in question was issued in 973 Saka by a king from Pangjalu called Jitendrakara. She further raised the question whether Jitendra and the *haji panjalu* mentioned in the Garaman charter are the same figure. Regrettably, without having direct access to the stone or to a usable reproduction, we do not yet dare to give credence to the Mataji data.

Third, the charter contains two specific parallels which are seen in the Kadiri-period inscription of Kemulan (1116 Saka). The passage in 1v2-1v4... tan·kna ri(m) parabyăpăra, man·dikṣa vulu-vulu pravulu, salvirnim tuha jaga, ludan· tutan, pavu-Avu, ... is similar to Kemulan Ab17-18 ... tan kaparabyapara denin alakvan in vuvuh tan kna salvirnin mandikan pakalinkin lūdan tūtan pakrāk pakrīk pahavu-havu ... whereas the expression dodot (t)inulis (3r1-3r2) is also observed in Kamulan Cd12. It is worth mentioning that in terms of paleography, the inscription is comparable to the charter of Malenga (originally written in 974 Saka and reissued in

As for this territory of Kadiri, corresponding to the present *kabupatens* of Kediri, Blitar, Tulungagung and Trenggalek, among the names of kings who reigned here during the century between 1038 and 1138 Śaka (1116–1216 CE), that of King Jayabhaya is the only one with broad appeal, associated as it is with the so-called "Prophecies of Jayabhaya." Many people are still flocking regularly to the pilgrimage site associated with him called Pamuksan Sri Aji Joyoboyo located in *desa* Menang, *kecamatan* Pagu, *kabupaten* Kediri (fig. 1). The site is popularly considered as the place where Jayabhaya attained his liberation (*mokṣa*). While there is no evidence to confirm that the prophecies and pilgrimage site associated with his name have any factual connection with the historical King Jayabhaya, the king in question has left us a textual legacy in the form of stone inscriptions and literary works in Old Javanese called *kakavins*.

At least two such works were composed under his patronage (Zoetmulder 1974: 250–278, 1983: 317–349), namely the *Harivanśa* (Teeuw 1950) and the *Bhāratayuddha* (Supomo Suryohudoyo 1993). Three royal inscriptions have so far been discovered from his reign, which lasted for almost three decades, <sup>14</sup> namely the charters of Hantang (1057 Śaka), Talan (1058 Śaka), and Tamparang (1066 Śaka). <sup>15</sup> Studies on both the inscriptional record and literary works sponsored by Jayabhaya started in colonial times and are pursued down to the present-day.

Regarding the inscriptional record, a complete reading of the Hantang inscription was offered by Brandes (1913: 154–158, OJO LXVIII), Dwi

These inscriptions bear the Saka dates 1058 (from Kandangan, Kediri), 1058 (from Kauman, Nganjuk), 1060 (two stones from Botoran and Rejotangan, Tulungagung), 1061 (from Kalidawir, Tulungagung), 1061 (from Karangpatihan, Ponorogo), 1061 and 1063 (from Kanigoro and Kepanjenkidul, Blitar). Sardjuningsih Setyawardhani (1980),<sup>16</sup> and Hasan Djafar & Trigangga (2019: 82–89). However, it is only Dwi Sardjuningsih Setyawardhani who provides a translation of the inscription. By contrast, although it is perhaps the best preserved record of this period, the Talan inscription has not been adequately studied. It was partially read by Brandes (1913: 163–164, *OJO* LXX) and fully read by Nakada (1994: 1–7) as well as Machi Suhadi & Richadiana Kartakusuma (1996: 27–30, 56–57).<sup>17</sup> However, no scholar has so far attempted to translate it, and the data contained in it have consequently played on a very small role in historiography. The last inscription, Tamparang, is less well preserved than the other two. Many of its *akṣara*s are badly weathered. Nonetheless, the first nine lines were read by Damais (1955: 145–146).<sup>18</sup> Even in the cases of Hantang and Talan, the published readings are in many instances inaccurate.

Jayabhaya's inscriptional legacy constitutes the primary source material to study his reign. In view of the fact that it has not been comprehensively studied, whether from the epigraphic or from the historiographic viewpoint, it is not surprising that the figure of Jayabhaya is still known more from the prophecies ascribed to him. Against this background, the following study of one of his inscriptions, the Talan charter, aims first and foremost to offer a critical edition of the text, accompanied by a reliable translation. On that basis, we will turn our attention to some major topics that emerge from this primary source, namely the fact that besides its date of issue it contains the date of an earlier charter that is incorporated, the identity of the figure Bhaṭāra Guru who is the issuer of the incorporated charter and his relation to Jayabhaya, the significance of the Garuḍamukha emblem, the issue of territorial connections between Janggala and Kadiri, and the role played by agents other than the king in the transaction that is the *raison d'être* of this charter.

## 2. Location and physical description

The Talan charter, also known (it would seem erroneously) as Munggut inscription, <sup>19</sup> is engraved on a large stela situated at *dusun* Gurit, *desa* Babadan, *kecamatan* Wlingi, *kabupaten* Blitar, East Java (fig. 2). The coordinates of the location are 8°04'22.6" S and 112°19'34.8" E. This is not far from the sites of two other stone inscriptions, viz. the Panumbangan charter (1042 Śaka) (fig. 3) and the charter of Pagiliran (1042 Śaka) (fig. 4), <sup>20</sup> both issued by King Bameswara, also of the Kadiri period. The stela we are concerned with here, standing under a small *pendopo*, is relatively well preserved with text clearly visible on its four faces. Its measurements are H. 157, W. 71–95, D. 19–28 cm. A circular roundel at the top of the front face (A) shows the emblem called Garuḍamukha, to which we return below in section 6. The base of the stone takes the form of a lotus.

The common toponymic element Gurit may have created confusion and led to the Talan stone being referred to as Munggut.

#### 3. Previous research

Two inscribed stones from the district of Wlingi in Kediri are alluded to for the first time in scholarly literature in 1869 in a list of estampages that were part of the estate of R. H. Th. Friederich entrusted to the Batavian Society of Arts and Sciences, apparently comprising in part estampages made by N. W. Hoepermans who had been working under Friederich's charge (*NBG* 7, 1869: 8, XCVII, CVIII).<sup>21</sup> These two inscriptions must be the aforementioned Panumbangan charter as well as the one that concerns us here.<sup>22</sup> Duplicates of these estampages of the Talan stele, in four sheets, were subsequently dispatched to the Leiden Museum of Antiquities in 1891 (*NBG* 14, 1876: I–IV, no. 24).<sup>23</sup> The inscription then figures under no. 555 in R. D. M. Verbeek's inventory of Javanese antiquities, which assigns to it the date 1068 Śaka (1891: 10, 269) mentioning the estampages kept in Batavia and in Leiden. Two

years later, the Batavian Society's Museum received another reproduction, this time a "facsimile on linen cloth" ("*afteekening op doortreklinnen*"), sent by J. Knebel. We learn from J. L. A. Brandes' report on the receipt of this reproduction that the charter was issued by King Jayabhaya and that he read the date not as 1068 but as 1058 Śaka (*NBG* 31, 1893: 72–73).

A decade later, Brandes (1904: 452–453) reported that two facsimiles (afteekening) of the beginning of this inscription are found in the University Library in Leiden, one in the H. N. van der Tuuk collection and another among the papers suspected to come from C. J. van der Vlis. Brandes detailed that the facsimiles cover only the beginning part of a stone inscription that, judging from the form of the lettering as well as the content, could have been from East Java. The one from the van der Tuuk collection comes with a caption "Inscription found at Soengkoeh" (inscriptie gevonden te Soengkoeh). In relation to that. Brandes refers to an entry about Soengkoep in the Geographical and Statistical Dictionary (Veth & van Alphen 1869: 392) citing it as basis for the idea that the inscribed stone would once have been found at that site, but that it had gone missing. The entry in question in fact only elaborates that Soengkoep was the ruin of a *candi* situated in Kediri but does not mention any inscribed stone, in surprising contrast with what is suggested by Brandes. Brandes proposed that the stone reproduced in the facsimile may have been found at Soengkoep as one of the names Soengkoeh and Soengkoep may have been a writing error for the other. He also recorded that the facsimiles concern a charter of King Javabhava from Saka 1068. Finally, he noted, erroneously, that the stone had not been listed in Verbeek's inventory. It seems that the varying readings of the date induced this error, and it is important to note that the whole section in Brandes 1904 is somewhat incoherent. Frankly, we have the impression that it was written by someone other than Brandes himself.

Reporting on fieldwork undertaken in 1908, Knebel noted that the stela was located to the east of the road from Wlingi to Semen, and that it is decorated with the figure of Garuḍamukha as emblem (1910: 161). Shortly thereafter, this charter was included in N. J. Krom's list of dated inscriptions which indicates 1058 Śaka as its date (1911a: 251) and the same scholar in the same year published a list of estampages preserved at the Archaeological Office in Batavia, including two estampages, one of them on linen (1911b: 52, nos. 539 and 341). In the report on his fieldwork in the years 1864–1867, published a half century later, Hoepermans (1913: 348) had described the stone as inscribed on its four faces, resting on a bed of lotus leaves, still intact and undamaged, and described the emblem engraved on the top of the front face as a rosette containing a monstrous figure. In the same year, a significant part of the contents of the inscription figured under the designation Soengkoeh/Soengkoep, in the posthumous publication of transcriptions by Brandes (1913: 163–164, *OJO* LXX), the date being read here as 1068 Śaka.<sup>24</sup>

In his study on the kings from Kadiri, Krom corrected Brandes' naming of the stone and pointed out that the stela in question is the one from *desa* Gurit which was in fact still *in situ* (1914: 243). Further, the information that had been published until then was summarized in the new inventory of antiquities edited under the responsibility of F. D. K. Bosch (*ROD* 1915: 348, no. 2098). Twenty-five years later, in a discussion of King Teguh's records, W. F. Stutterheim highlighted the different epithets used by King Jayabaya in the Hantang and Talan inscriptions. He expressed doubt as to the correct reading of the date of the Talan inscription but was unable to investigate it further as he was unaware of the existence of the estampages kept in Batavia and believed that only the eyecopies at Leiden were available to decipher the date (1940: 354, n. 1).

The seminal publications of L.-Ch. Damais (1952: 66–67 no. A.152, 1955: 71) comprised a decipherment of the first five lines of the text with the dating formula where Damais read 1058, on which basis he was able to convert the date to 24 August 1136 CE. In subsequent decades, the inscription kept figuring now and then in scholarly literature, 25 but it was not until 1994 that a complete reading of the inscription was first published, by the Japanese scholar Kōzō Nakada (1994: 1–7). Two years after that, another complete edition of the inscription was published by Indonesian scholars, namely Machi Suhadi & Richadiana Kartakusuma (1996: 27–30). This last edition was presumably based on the undergraduate thesis (*skripsi*) by Machi Suhadi when he was a student at the University of Indonesia in 1970. Unfortunately, we have not been able to get access to his thesis. 26

Despite more than a century of publication record, and three editions (two of which complete), the text cannot be said to have started being studied in earnest, as none of the publications was accompanied by a translation, and the reliability of the editions evidently suffers from the fact that the editors did not carry out the counter-check on their readings which comes from translating them.<sup>27</sup>

by Krom had not been updated in the light of Brandes's own observations in *NBG* 31 (1893), referred to above. As editor, Krom also failed to make the connection with the stele on which Hoepermans, Verbeek and Knebel had reported.

#### 4. Text

The text starts on the large front face (here called A), each line of which is continued on the lateral face (b) to its right. After the 25th line on face Ab, the text continues on the opposite large face (C) each line of which is again to be read together with the lateral face to its right (d).

The reading presented here was established by using Nakada's edition (1994: 1–7) as a base text (N). This base text was checked against the readings of Brandes (1913: 163–164, *OJO* LXX) only covering Ab lines 1–22 (B), of Damais (1955: 71) only covering Ab lines 1–5 (D), and of Machi Suhadi & Richadiana Kartakusuma (1996: 27–30) (M&R). It was then verified using the set of estampages, made during a field trip led by Titi Surti Nastiti and Arlo Griffiths in 2012, and held at the EFEO library in Paris (n. 2287–2290). The text was checked again by direct inspection of the stone on the 25th of September 2021 and the 18th & 22nd of March 2022 by Eko Bastiawan, benefiting from remote supervision and assistance from Arlo Griffiths. Arlo Griffiths finished revising the edition, using the EFEO estampages, on the 28th of June 2022.

In editing the inscription, we follow the transliteration system proposed by Balogh & Griffiths (2020) and use the following editorial signs:

We find  $pratist\bar{a}kna$  in similar contexts in Pagiliran A5, Panumbangan Ab9, and Hantang Ab10, and so we have considered the possibility of supplying kna here. Nevertheless, the fact that  $pratist(h)\bar{a}$  is also observed in the same context in Tamparang Ab9, Kemulan Ab8 and Palah Ab8 means that this reading must be accepted as a viable alternative, in the intransitive, to the passive construction with  $pratist(h)\bar{a}kna$ .

#### 5. Translation

#### Faces A and b

(Ab1–4) Hail! Elapsed Śaka year 1058, month of Śravaṇa, eleventh tithi, waning fortnight, Tunlai, Vage, Monday, [the vuku being] Pranbakat, the grahacāra being in the South, lunar mansion Punarvasu, the deity Aditi, the conjunction Siddhi, the karaṇa Vava, the parveśa Kuvera, the maṇḍala being in the north-west. That was the time when the decree of the Great King — whose royal (deva) names were 'Incarnation of Madhu's destroyer, i.e. of Viṣṇu' (śrī-varmeśvara, madhusūdanāvatāra), 'Who brings joy to friends' (ānanditasuhrt), 'Lofty conqueror of the directions thanks to his lion's power' (sinhaparākrama-digjayottunga), whose emblem was Jayabhaya — was received by the Lord Great Minister of Halu, the kabayan at Sarvagata. <sup>168</sup> It came down to all the high functionaries (taṇḍa rakryān) in the council, beginning with the Lord of Kanuruhan, with the byname Maṇḍaka.

(Ab4–8) The occasion: All of the inhabitants in Talan, rank upon rank, paid respect to the dust of the footprints of the Great King. They had as intermediary the *apatih* Lord [named] *mpu* Kesareśvara, 'endowed with right judgment and of unstoppable valor' (*kṛta-vivekālanghanīya-parākrama*), with the byname Bāguṇa. Not left behind was the teacher of the Great King,

'promoter of Nyāya doctrine, serving as a chief of Yogins following the path of Bhairava' (naiyāyikadarśana-samrddhi-kāraṇa bhairava-mārgānugamana-yogīśvarādhikāra). They informed (the Great King) that they had in custody an edict (praśasti) recorded (muṅgu)<sup>169</sup> on palm leaves [and] marked with the Garuḍa-face [as] their guarantee that they were granted by Bhaṭāra Guru [the right] to hold their land (deśa) in Talan as a sīma [and] to have authority over all of its low land and elevated ground, including non-irrigated rice-fields, paddy fields, river edges, marshlands, kuluvutans<sup>170</sup> [and] patapans of all types. In addition, they begged for the transfer of their edict to be recorded on a stone stele. Such was the substance of the petition of the inhabitants of Talan to the dust of the footprints of the Great King.

(Ab8–11) Because of the greatness of His Majesty the Great King's sympathy for the request of the inhabitants of Talan — for the nature of one like him is [that of] the highest *kṣatriya* manifested as the incarnation of Viṣṇu, constantly guarding the whole world, who brings joy to all subjects, attentive to all intentions of those who respectfully implore him, kind to those who seek for protection, [and] unwilling to be put in debt of service by those who are unwaveringly loyal to him — this is the reason why His Majesty (lit., 'the dust of his footprints') approved the request of the inhabitants of Talan for the transfer of their edict to be recorded on a stone stele. At the same time, their grant was added to (*inimbuhan*) by the Great King.<sup>171</sup>

(Ab12–Cd1) As for the substance of the grant of the Bhaṭāra Guru to Colo, Ubheni, [and] Rntət, [it was] that Talan, a village of the district Panumbanan including all its (constituent) villages [and] circumscription (atagan) of

Vantavan, [whose] corvée is [equal to] 1 kupan, would serve to become the sīma of the inhabitants of Talan. It is seized including its low land and elevated ground, including all kinds of non-irrigated rice-fields, paddy-fields, orchards. river edges, marshland. All of them are taken by the inhabitants of Talan. And they will not be entered by the subordinates of the three high dignitaries: the Pankur, the Tavan and the Tirip, [i.e.] all those who previously had a claim on royal revenue [from] the occupational groups big or small, beginning with the various Miśras, the panuran, the krin, the padəm, the manimpiki. the paranakan, the limus galuh, the panaruhan, the taji, the vatu tajam, the manriñca, the manhūri, the paran, the sukun, the halu varak, the ramanan, the rakasan, the overseer of gəndin, the pininlai, the katangaran, the tapa haji, the air haji, the malandan, the loca, the olob-olob, the kalankan, the kutak, the tankil, the trapan, the salvīt, the sinagiha, the kyab, the srakan, the lingan, the vatu valan, the vilan thani, the pamanikan, the aniga, the sikəpan, the rumban, the tirvan, the viji kavah, the tinkəs, the māvī, the manambani, the tanhiran, the overseer of merchants, the overseer of smiths, the manrumbai. the manguñjai, the overseer of Klin, the overseer of Huñjəman, the overseer of gambling, the pulun padi, the overseer of harlots, the pabisar, the pagulun, the pavunkunun, the overseer of Banantan, the miśra hino, the miśra anin-anin, the vli tamban, the vli vadun, the vli hapū, the vli harən, the vli panjut, the suval, the  $tamb\bar{a}$ , the  $limba\dot{n}$ , the kavah, the palamak, the urutan, the dampulan, the pakalunkun, the təpun kavun, the sunsun panuran, the karərənan, the pasuk alas, the sipat vilut, the jukun, the pānin-anin, the pāmāvasva, the hopan, the panranan, the skar tahun, the garihan, the pabayai, the panrana, the avur, the panatak, the goldsmiths, the panigan-atak, the pandva-mās, the paniganblah, the pakarapa, the tampō sirir, the pinta-palaku, the paṅharaṅ-haraṅ, the tulun hutan, the pobhava, the kipa-kipah, the pavalanda, the pakanan tahun, the panirin, the pacumbi, the paprāyaścitta, the pavuvuh, the pāngarai, the pavlan-vlan, the tundan, the royal corvée, the eunuchs, the royal servants, the healers, the sambal, the sumbul, the mavulun-vulun, the singing actors, the wayang-performers, the comedians (abañol), the singah, the pabrasi, all of the courtiers, and so forth — they shall not enter

the  $s\bar{\imath}ma$  in Talan. It is only the inhabitants of Talan who shall have the authority over all of their royal revenue.

(Cd1-4) Likewise are all the [fines to be imposed for] 'pain and relief' (sukha-duḥkha), great or small, no matter what their types may be, such as 'areca-blossom without betelnut' (mayan tan pavvaḥ), 'gourd vines that grow in the courtyard' (valū rumambat in natar), 'disaster' (vipati), 'a corpse covered with dew' (vankai kābunan), 'blood spattered on the road' (rāh kasavur i havan), 'spittle that is sprayed' (hidū kasirat), 'slander' (dūhilatən), 'violence' (sāhasa),

'rash speech' (vākcapala), 'rash acts with the hand' (hastacapala), 'producing the dust of a file' (mamijilakən vurinin kikir), 'attacking in fury' (mamūk), 'rape' (mamunpan), 'repeated attack' (lūdan), 'following' (tūtan), 'apportioning of shares' (anśa pratyanśa), 'punishment and wrongful punishment' (danḍa kuḍaṇḍa), 'poisons of all sort' (maṇḍihala) and such like. It is only the inhabitants of Talan who shall have the authority over all of them.

(Cd4–7) Such was the substance of the grant of Bhaṭāra Guru to the inhabitants of Talan — an edict recorded on palm leaves [and] marked with the Garuḍa-face — which was confirmed by the Great King. Consequently, the Great King agreed that it would stand permanently on a stone stele. As for the time of the grant of Bhaṭāra Guru to the inhabitants of Talan, it was in Śaka 941, additional month of Māgha, first *tithi*, waning fortnight, Haryan, Umanis, Wednesday, [the *vuku* being] Dukut.

(Cd7–15) As for the substance of the addition (panimbuh)<sup>172</sup> of the Great King to the inhabitants in Talan, it concerned their being entitled to have a longer platform (? varuga inantun), to have eight pillars (? aśakā inaṣṭa), to pave the courtyard (anumpyatak),<sup>173</sup> to build a palanquin in layers, to have a palanquin with turnery, to offer nāgapuṣpa (cloth), to use jənu humalan (unguent); they would be entitled to have intercourse, pierce the ear-lobes, cut the hair, given in possession to ... (amanlva) [or] inflict wounds (anrāhana) on children; they would be entitled to take a prostitute as slave, to mate with a kamambanan prostitute, to eat royal meat, to serve kamalai fruit on a wooden tray, to cut hair on the seat, to play on the seat, to hold yellow wood, to have a taban-taban (drum). But there should not be a forerunner for them when they take a walk.

As for the course of action to be taken by the inhabitants of Talan, it concerns their reliability in delivering (*atahil*)<sup>174</sup> royal revenue [in the form

of]  $panaṣṭ\bar{a}ng\bar{\iota}$  (tax) of 2  $m\bar{a}ṣa$  without arik levy to the holy foundation in Dharuṇa every Full Moon of the month of Asuji. It should not be interfered with by others.

Such was the substance of the addition of the Great King (granted) to the inhabitants of Talan, to stand permanently on a stone stele [and] to be considered to be irrevocable by them including their descendants [into] the future's future. It is not to be disturbed by the future kings. But if there are ones who will disturb the stability of the grant of Bhaṭāra Guru along with the addition of the Great King to the inhabitants of Talan, be they *brāhmaṇas* or *kṣatriyas*, let alone if they are *vaiśyas* [or] *śūdras*, they should be fined 2 *kāṭi* and 10 *suvarṇa*. In addition, they will encounter the five forms of suffering in this world and hereafter.

(Cd15–21) For that reason, you (may please) pay heed, you gods of the five elements, you (gods of the directions) East, South, West, North, Southeast, Southwest, Northwest, Northeast, Zenith, Nadir, including the Center. If there are people who misbehave [or] offend by disturbing the stability of the grant of His Majesty the Great King, all the more so the grant of Bhaṭāra Guru to the inhabitants of Talan: catch them, cut them off, throw them down, turn them upside down, strangle their necks, bind together their hands, break up their feet, split their skulls, scoop up their brains, tear out their livers, rip open their entrails, pull out their intestines, break any of their ribs, cut off their flesh, drop [them] in the copper-cow-headed (cauldron), to be cooked in the cauldron of Yama's slaves. Such should be the future deaths of the miscreants who disturb the stability of the grant of His Majesty the Great King, all the more so the grant of Bhaṭāra Guru to the inhabitants of Talan.

(Cd21–25) As for the names of the inhabitants who received the grant of His Majesty the Great King to the inhabitants of Talan, [they were] Gambhīra and Viro. Enumeration of the names of the inhabitants of Talan who benefited from the grant by His Majesty the Great King: Sudhi, Panagar, Putravatī, Haṣap, Sicin, Saprāṇa, Abron, Palagān, Sayo, Tumantar, Kaviṣṭa, Sagnən, Ratih, Ñaruk, Tan Adoh, Rambha, Jīva, Adumās, Dumunun, San Bhaṇi. In Adhikānī [and] Nyū Dantī: Gambhīra, Ahyəs, Śrī Vidgī, Krtayaśa, Dumunun [and] Vagəd, the first being Viro. Such was the enumeration of the inhabitants who benefited from the grant by His Majesty the Great King. The document was written by master Prakāśa, whose chief was the official of Kəlpvan<sup>175</sup> (called) master Amogha.<sup>176</sup>

#### 6. Historiographical Discussion

#### Dates




Fig. 9a – Diagram for the first date contained in the inscription, generated with HIC software.

One of the remarkable features of the Talan stela is the fact that it is inscribed with two dates. The first date which fell in 1058 Śaka is engraved on the front face (Ab), line 1. All of the dating elements, with the exception of the *yoga*, point to the month of Bhādrapada instead of Śravaṇa mentioned in the text (see the HIC diagram in fig. 9a). We find no indication that Damais (1955: 71) was aware of the fact that the month appears to be off by one, while Eade & Gislén (2000: 85) signal the problem but do not comment on it further, although it must be connected with the intercalation system that was used.<sup>177</sup>

The second date is observed on the back face (C) line 6. The presence of this date had been noticed by Krom who cited the year as 961 Saka. He argued that the 12th-century inscription is a confirmation of a charter issued by Airlangga (1931: 294, see below), and that the year 961 is that of the original charter. Damais merely cited Krom for the second date (1955: 71, n. 3), but did not have the chance to check any estampage and hence could not determine whether it comprised only a year or also other dating parameters. <sup>178</sup>

While Nakada evidently did not recognize the presence of a date and read the digits as the meaningless words *rnan ugaḥ*, Machi Suhadi & Richadiana Kartakusuma were able to read the year as 961 Śaka (1996: 27).




Fig. 9b – Diagram for the second date contained in the inscription, generated with HIC software.

Upon inspecting the stone in person, we have found the reading 961 offered by Krom as well as Machi Suhadi & Richadiana Kartakusuma not to be accurate. The year has to be read 941 Śaka. The HIC diagram demonstrates that this reading fits well with the other dating elements (fig. 9b).<sup>179</sup> The HIC software also shows that there is no matching date in 961 Śaka. The charter thus bears one date falling in the reign of Jayabhaya (24 August 1136 CE) and another associated with a figure called Bhaṭāra Guru (13 January 1020 CE).

## Bhaṭāra Guru: the posthumous name of Airlangga

The charter of Talan is a confirmatory grant that incorporates a grant that was originally issued in 941 Saka for the inhabitants of Talan by an authority referred to as Bhaṭāra Guru and authenticated with the Garuḍamukha (Garuḍa-face) emblem. 180 The name Bhaṭāra Guru figures for the first time

in the Sumengka charter (981 Śaka) that was issued by the king of Janggala called Samarotsaha 'because of the way in which the channel created by the venerable Bhaṭāra Guru, who rests at Tīrtha, was taking from the river meandering by way of the land of Tinkilikan.' The stone itself is engraved with the Garuḍamukha emblem on the top of the front face (fig. 10). Currently displayed in the Nasional Museum of Indonesia with the inventory number D.12, it originates from *desa* Sumengko, *kecamatan* Jatirejo, *kabupaten* Mojokerto. Besides the famous case of Ken Angrok who, in the *Pararaton*, receives the name Bhaṭāra Guru from the gods (Brandes 1920: 12, 56), the same name is also observed in two charters from Bali, that date respectively from 1126 Śaka and from 1246 Śaka (Goris 1967: 43, 45–46). Although the identity of the figures referred to in these Balinese charters is not yet clearly understood, it seems certain that neither one of the two figures called Bhaṭāra

Guru there can be identified with the Bhaṭāra Guru mentioned in the Sumengka and Talan charters. By contrast, in the latter two the same figure may very well have been intended.

While the name Bhaṭāra Guru in the Sumengka charter is preceded by pāduka mpuṅku, this expression is not seen in Talan. With reference to the former, Krom observed some similarities between Samarotsaha and Airlangga, namely their use of the rake halu title, of the 'family name' Dharmawangsa, and of the Garuḍamukha emblem. In relation to the name pāduka mpuṅku bhaṭāra guru, he was of the opinion that pāduka refers to a princely figure, while mpuṅku suggests a religious title and bhaṭāra guru is the name of a god. Thus, he argued, the name may denote the deity with which a deceased prince was identified after death, according to a tradition of posthumous naming which is also observed in the Majapahit period. 183

The similar expression *pāduka mpuňku bhaṭāra tripuruṣa* appears in another inscription, the Kedung Wangi stone from Lamongan.<sup>184</sup> Boechari associated this expression with what is often called the 'priestly title' of Airlangga in scholarly literature (1990: 130). However, our recent research<sup>185</sup> suggests that *pāduka mpuňku bhaṭāra tripuruṣa* is more likely to refer to the first ruler of Majapahit, namely Kertarajasa alias Raden Wijaya.<sup>186</sup> And we are somewhat skeptical of the whole notion of Javanese rulers bearing 'priestly titles,' which is essentially a modern scholarly construct devised to address the problems that arise from a single Majapahit-period reissue (the Gandhakuti charter) that records a grant

made by a certain *aji pāduka mpunku* on a date falling within Airlangga's reign without mentioning the king by any of his usual titles. 187

Based on the observed connections between Samarotsaha and Airlangga. plus the fact that the contents of the Sumengka charter brings to mind the Kamalagyan inscription (959 Saka) issued by Airlangga, which is found 34 km downstream along the Brantas river from Sumengko and also deals with waterworks. Krom inferred that the name Bhatāra Guru in the Sumengka charter refers to none other than Airlangga (1913: 596-598). The same scholar interpreted the data as indicating that Airlangga, after retreating from worldly affairs towards the end of his life, was interred at Tīrtha, a site which Krom identified as the Belahan bathing place located on the slope of Mount Penanggungan in *kabupaten* Pasuruan. He further endorsed the double theory that a large sculpture of a Visnu mounted on Garuda originated from the same site and was a representation of Airlangga himself. 188 Concerning the 'family name' Dharmawangsa, he suggested that Samarotsaha was the immediate successor of Airlangga. Most importantly for us, in the present context, he concluded that the figure of Bhatāra Guru observed a few decades later in the Talan charter must be the same figure as the one alluded to in the Sumengka charter, namely Airlangga (1931: 270–271, 283, 294). 189

Krom's proposal was later challenged by Resink who argued that the *tīrtha*s mentioned in both the Sumengka and Talan charters (*sic*!) have to be found in close proximity to where these two stones are situated. Further, he claimed that the Belahan bathing place is the site where Sindok's predecessor, namely King Wawa, was entombed so that the Viṣṇu sculpture may not be associated with Airlangga, nor with any other historical figure in his view (1968: 27, 32–37). Coming to the defense of Krom's proposals, Jordaan found that there is no reason not to associate the word *tīrtha* occurring in the Sumengka and Talan charters (*sic*!) with Belahan. He was of the opinion that the absence of the specific name of the *tīrtha* is primarily because the charters are intended as administrative records. Emphasizing the fact that the

one who was interred at Tīrtha, interpreted as Belahan, had the Garudamukha emblem, he agreed with Krom's hypothesis that the figure is none other than Airlangga and that the sculpture of Viṣṇu is his representation. He concluded that the other two goddesses still observed at Belahan, namely Sri and Laksmi, correspond to Airlangga's consorts (2007: 338, 342–343). It is crucial to point out that Resink's argument assumes that the word *tīrtha* is observed in both the Sumengka and the Talan charters, whereas in reality this word is only found in the above-quoted passage of the Sumengka charter but is absent altogether from the Talan charter. This fundamental error was taken over uncritically by Jordaan. As a matter of fact, the Talan charter had not been fully deciphered when Resink was writing, and Jordaan evidently failed to consult the readings that had been published in the 1990s by Nakada, on the one hand, and by Machi Suhadi & Richadiana Kartakusuma, on the other. Their erroneous assumption must derive from a misinterpretation of the way in which Krom had previously presented the data.

Despite the fact that the inscriptions of Sumengka and Talan are issued by different kings from different territories, they have two things in common. First, the presence of the Garudamukha emblem. Second, the appearance of this figure called Bhaṭāra Guru. Although unfortunately we still lack clinching evidence to prove Krom's proposal identifying Bhaṭāra Guru as a posthumous name for Airlangga, we do see some facts that may be interpreted as supporting it while there seems to be no strong reason to reject it. <sup>190</sup> Since the grant of Bhaṭāra Guru to the inhabitants of Talan, incorporated in the Talan charter, took place in 941 Śaka, this then becomes the earliest hard date for a charter issued by Airlangga.

#### The Garudamukha emblem

The majority of the stone inscriptions issued by the Kadiri kings are engraved with emblems placed on the top of the front face.<sup>191</sup> These emblems are different from one king to another. Generally, each king has one specific emblem which is consistently depicted on each inscription he issued such as the Candrakapāla emblem for issues of Bameswara,<sup>192</sup> Gaṇamūrti for those of Aryeswara,<sup>193</sup> and

the Śringa for those of Kertajaya. 194 Curiously enough, by contrast, each of the three inscriptions issued by Jayabhaya has a different emblem.

The inscription of Hantang (1057 Śaka) bears the emblem of Narasinha (a man with lion head) while the Talan charter (1058 Śaka) bears the Garuḍamukha. The emblem of the Tamparang inscription (1066 Śaka) has not been satisfactorily identified but is different from that of the other two (fig. 11). The Narasinha emblem mentioned in the Hantang and Tamparang charters and depicted on the former can be identified with certainty as Jayabhaya's own emblem. <sup>195</sup> As we make further progress with deciphering the Tamparang charter, we hope that an explanation will emerge for the fact that the emblem depicted on this charter seems not to match with the one mentioned in the part of the text deciphered so far. In the case of the Talan charter, the use of the Garuḍamukha emblem is clearly due to the fact that the charter incorporates an earlier grant which bore the same emblem. <sup>196</sup>

The Garudamukha is indeed found depicted on some stone inscriptions issued by kings before the Kadiri period. The earliest depiction of Garudamukha as an emblem is found in at least two inscriptions issued by Airlangga, namely Baru (952 Śaka) and Silet (975 Śaka). 197 The same emblem is also engraved

in two inscriptions issued by kings of Janggala, namely Kambang Putih (958 Śaka) of Garasakan and Sumengka (981 Śaka) of Samarotsaha.<sup>198</sup> The last inscription known so far which indicates the use of the Garuḍamukha emblem is the (still unpublished) Patitihan charter of the Singasari period.<sup>199</sup> But the charter is incompletely preserved and we cannot exclude that the relevant passage too refers to a grant from a previous king who bore the Garuḍamukha emblem.

As mentioned in the previous section, the use of the Garudamukha as an emblem by kings from Janggala seems to indicate a tie of kinship between Airlangga and the kings who ruled Janggala in the decades after Airlangga's reign. The likelihood that the Talan charter incorporates an Airlangga charter

leaving much space for a hypothetical emblem.

while it is engraved with the Garudamukha emblem establishes a connection between Jayabhaya and Airlangga, in a way that finds no parallels in any other inscription of a Kadiri king. However, the nature of the connection remains undetermined, and was not necessarily one of kinship in Jayabhaya's case, by contrast with the kings of Janggala.

## The toponyms Talan and Panumbangan

Talan as a toponym is found in two inscriptions from the Airlangga period, namely Bimalasrama (date lost) and Kamalagyan (959 Śaka) as well as in a 10th-century charter called Kancana. In the Bimalasrama charter, Talan is mentioned as one of the neighboring villages (*təpi sirin*) of the place concerned by the grant; In the Kamalagyan charter, Talan is listed as one of the downstream villages; and in the Kancana charter, Talan is said to border with the *sīma* land of Kancana. All of these three inscriptions originate from the area of Sidoarjo. All of these three inscriptions originate from the area of Sidoarjo.

If we accept the hypothesis that the figure of Bhaṭāra Guru refers to Airlangga, the fact that the toponym Talan is also found in two of his inscriptions gives reason to consider whether the Talan intended in our inscription was also situated in the vicinity of Sidoarjo. The inscription details that the inhabitants of Talan were granted by Bhaṭāra Guru the right to hold their land (deśa) in Talan as a sīma and to have authority over all of its 'low land and elevated ground, including non-irrigated rice-fields, paddy fields, river edges, marshlands, kuluvutans [and] patapans of all types'. These landscape features are stereotypical expressions most of which are also observed in several other

inscriptions.<sup>205</sup> They do not necessarily portray the actual characteristics of the landscape mentioned in the inscriptions, and do not stand in the way of assuming that the Talan in question was situated in the flat delta of the Brantas, rather than in the mountainous Wlingi area.<sup>206</sup>

Nevertheless, another piece of information mentioned in the Talan charter proves that such an assumption would be untenable. For the charter states that the village Talan formed part of the district (*vatak*) of Panumbangan. This second toponym, likewise, is observed in several inscriptions. The earliest attestation is in the Sima Anglayang charter issued by Airlangga at some time in or after 968 Śaka and found near Malang.<sup>207</sup> Although the exact

location of Panumbangan is not clearly stated, it appears to be among places or territories lying outside of Janggala such as Waharu, Tagaran, Hujung, and Kanuruhan. The Sukun charter (1083 Śaka), also found near Malang, lists a *rakryan* Panumbangan among those who receive gifts during a *sīma* ceremony (6r1).<sup>208</sup> The aforementioned Patitihan charter of the Singasari period includes Panumbangan in the list of 'all the ones who hold a *kanar* in the land of Kadiri' (*samāmanku kanar samudāya, rim bhūmi kadiri*).<sup>209</sup>

The name Panumbangan as a *vatək* is mentioned in the stone of Pagiliran (1042 Śaka),<sup>210</sup> issued by King Bameswara, which is located around 3 kilometers to the west of the Talan stone. The same name is frequently mentioned in the Panumbangan inscription (1042 Śaka), also issued by King Bameswara, which is located around 2 kilometers to the east of the Talan stone. The expression *Ikam rāma lima dūvān i panumbanan i dal,m thāni* is found in the text several times. Although this expression is only partly understood, given that the charter was installed in the same year and by the same king as the one of the Pagiliran stone, not far from both the Pagiliran and the Talan stones, the place called Panumbangan with which the eponymous charter deals must have been the same *vatək* as that in the Pagiliran and Talan charters. The name Panumbangan itself survives in the name Plumbangan of the *dusun* and *desa* where the Panumbangan stele is still to be found in the present day.

A place called Panumbangan is also included as one of the regions on the bank of the river (*nadītīrapradeśa*), namely the Brantas, in the Canggu charter of the Majapahit period (1280 Śaka).<sup>211</sup> Another Majapahit inscription which mentions the name Panumbangan is the Waringin Pitu charter (1369 Śaka), where Panumbangan figures as one of the borders of the holy foundation at Waringin Pitu.<sup>212</sup> Although the charter was discovered in *kabupaten* Trenggalek, the fact that it mentions toponyms of Kamalagen (8r1) and Kalagen (8r5) reminds us of an inscription issued by Airlangga, namely the Kamalagyan

charter (959 Saka) situated in *dusun* Klagen, *desa* Tropodo, *kecamatan* Krian, *kabupaten* Sidoarjo. The name Waringin Pitu is synonymous with the name Waringin Sapta in the Kamalagyan charter. Hence, it is probable that the Panumbangan of the Canggu and Waringin Pitu charters was located in the area of Mojokerto and Sidoarjo.

Observing the occurrences of Panumbangan in the charters mentioned above, it is evident that a *vatak* called Panumbangan existed in the historical territory of Kadiri, possibly already from Airlangga's time and certainly from the Kadiri period onward. The data also indicate, however, that there was a (probably less significant) place of the same name in the northern part of East Java (Janggala) a few centuries later, and that place is likely to have existed already at Airlangga's time too.

Bringing together all the data presented in this section, one can then imagine at least three scenarios regarding the community called Talan. First, that the community had moved from Sidoarjo to Wlingi between Airlangga's and Jayabhaya's time. Second, that the Talan charter, despite being found in Wlingi, actually concerns a village in Sidoarjo and as a consequence Jayabhaya's territory extended into Sidoarjo. Third, that the Talan in Sidoarjo at Airlangga's time and the one in Wlingi at Airlangga's and at Jayabhaya's time are two different villages sharing the same name.

#### Named individuals

Besides issues related to chronology, toponomy and territory, another major challenge for the historiography of early Java is to establish connections between the plethora of individuals who find mention in the inscriptions. The Old Javanese inscriptions often contain lists of those who receive the gifts (pasak-pasak) at the occasion of a sīma foundation. Generally, such a list is structured in descending order of social status, with function terms followed by named individuals holding those functions, with the exception of the king and other high dignitaries as their names have normally already been mentioned at the beginning of the inscription. Each of those listed will receive a combination of cash in the form of gold  $(m\bar{a}s)$  or silver (pirak) and cloth (vədihan or kain) as gifts. In some inscriptions, not in the context of gift presentation, lists of names consisting of individuals from the village level are also observed such as those found in the charter of Cane (943 Saka) issued by King Airlangga and in the charter that we are studying here. Regrettably the data set is generally not large enough to yield appearances of the same figure in more than a single record, thus impeding proper prosopographic research.

One notable feature of the inscriptions issued by the kings of the Kadiri is the use of the expression *makasopāna* meaning 'by intermediary of' in describing the process of transmission of a petition to the sovereign. The earliest epigraphic record of this expression is found in the Waharu II charter

(851 Śaka)<sup>213</sup> issued by King Sindok, but its authenticity is questionable.<sup>214</sup> The same expression is observed in the Mataji inscription (973 Śaka)<sup>215</sup> and then becomes a standard element of grants issued by the Kadiri kings,<sup>216</sup> but is rarely observed in inscriptions after the Kadiri period.<sup>217</sup> Outside of Java, the same expression is also found in at least ten charters from Bali.

These intermediaries hold various positions such as official (paməgat), lord (rakryān), or teacher (panajyan). Although they do not always appear in every inscription issued by the kings of Kadiri, their role seems to be vital as it is through them that petitioners addressed the Great King. The presence of these intermediaries in the Kadiri period deserves comprehensive investigation. Limiting ourselves here to the case of our inscription, we find in it two intermediaries: the apatih Lord (a kind of chief minister?) named mpu Kesareśvara, 'endowed with right judgment and of unstoppable valor' (krta-vivekālanghanīya-parākrama), with the byname Bāguna, and the teacher of the Great King, 'promoter of Nyāya doctrine, serving as a chief of Yogins following the path of Bhairava' (naiyāyikadarśana-samrddhikāraņa bhairava-mārgānugamana-yogīśvarādhikāra). The second person also figures as intermediary in the Hantang inscription (1057 Saka), likewise issued by Jayabhaya. His name suggests that the cult of Bhairava played an important role during Jayabhaya's reign. The Hantang inscription is indeed perhaps the earliest attestation of the Bhairava cult in eastern Java (Robson & Hadi Sidomulyo 2021: 150–151).

Among the two fully deciphered inscriptions issued by Jayabhaya, namely the Hantang and the Talan charters, it is only in the latter that the name of the calligrapher is mentioned. It ends with the information that 'the document was written by master Prakāśa, whose chief was the official of Kəlpvan (called) master Amogha.'218 As already stated in n. 176, the names of the masters sound Buddhist. If indeed their bearers were Buddhists, it implies that both (Bhairava) Śaivism and Buddhism coexisted during the reign of Jayabhaya. The presence of Buddhism in the 10th–11th century is perhaps also attested through an inscribed sculpture of Akṣobhya found in *desa* Sukodono (formerly Gondang Lor), *kecamatan* Karangrejo, *kabupaten* Tulungagung, now displayed in Museum Wajakensis, Tulungagung.<sup>219</sup>

#### 7. Conclusion

We are aware that there are many other topics that could and should be elucidated in this single inscription, but this can be done better once the first author's study of the Janggala-Kadiri corpus as a whole will have advanced further. The present study has showcased how much new light a critical edition of even a single charter, if accompanied by a reliable translation, may shed on historical events, the persons involved, as well as the social and geographic contexts. Once this approach will have been applied to a larger corpus of inscriptions of the same period, it may be expected that a significant number of new facts will emerge for revising the historiography of early Java.

We have shown that the Talan charter yields substantial information not just on the reign of Jayabhaya but also on that of Bhatāra Guru. We have reevaluated the hypothesis proposed by previous scholars regarding the identification of Bhatāra Guru as King Airlangga and are indeed inclined to accept it. This identification means that the Talan charter, by incorporating a charter of Bhatāra Guru dated to 941 Śaka, will have an impact on the issue of the duration of Airlangga's reign, which has occupied Indonesian historiography for decades.<sup>220</sup>

Perhaps more importantly, the Talan charter raises questions about the territorial limits of Airlangga's kingdom. In particular, the Talan charter challenges the notion — which we ourselves had until recently — that Airlangga's territory was exclusively situated in the northern part of East Java and opens up the possibility that more southerly territories, where no stone inscriptions issued by Airlangga have so far been found, may also have been part of his territory.<sup>221</sup>

As for the community called Talan, out of three possibilities that we have offered above, it is the third scenario that seems most plausible to us, namely that two different village communities called Talan are intended in the historical sources: one in Sidoarjo that existed at Airlangga's time and another Talan that also existed at Airlangga's and Jayabhaya's time, despite the absence in Wlingi or even the larger Kediri-Blitar-Tulungagung area of any stone inscriptions directly preserved from Airlangga's time to corroborate the hypothesis that his territory extended so far beyond the area of Lamongan where most of his inscriptions have been found. The fact that Panumbangan figures already as an important territory in the Sima Anglayang charter implies that the Panumbangan where Talan was situated possibly existed already in Airlangga's time. More generally, our study gives reason to reconsider the territorial organization of polities in early Java and the extent to which the distribution pattern of stone inscriptions reflects the extent of the issuers' political control.

As regards the history of Jayabhaya's reign, while we still need to revisit the relatively well-known Hantang charter, we have to give special attention to the Tamparang charter which has not been fully read, let alone translated. Alas its state of preservation is considerably worse than that of the other two charters issued by Jayabhaya. The stone which was for decades kept unprotected outside of the Penataran Museum in Blitar has recently been moved just behind the entrance gate of the area of the museum and placed under a small *cungkup*, and we have begun but not yet finished our decipherment of this record.
