A new benchmarking method for the study of dynamic interactions in island power systems with hybrid conventional and inverter-based resources controlled in grid-forming mode

Abstract-This paper presents a novel methodology for detecting and analyzing oscillation modes resulting from interactions between synchronous machines (SMs) and inverterbased resources (IBRs). The methodology utilizes a conceptual benchmark specifically designed to identify various oscillation modes, particularly those involving SMs and IBRs in a minimal order model for any power system. These phenomena can be studied by adapting the benchmark to represent any power system - in this paper a French island power system - where the IBR is controlled in grid-forming mode. In this system, oscillations among its generation sources raise concerns for the grid operator, necessitating comprehensive studies to understand potential stability and safety risks. The benchmark is linearised around an operating point and the type of each detected mode is identified through calculation of participation factors. The impact of key parameters on the damping of the modes is studied through sensitivity analyses. Nonlinear time-domain simulations, based on electromagnetic transient (EMT) modeling using EMTP-RV software are employed to validate the linearised model of the benchmark. Finally, a power oscillation damping (POD) controller installed on the inverter is proposed to mitigate critical oscillation modes.

Index Terms—Grid-forming control, Modal Analysis, Synchronous Machine, Conceptual Benchmark, Inverter Based Resources, Interactions

I. INTRODUCTION

As power systems transition towards cleaner energy sources, integrating both synchronous machines (SMs) and inverterbased resources (IBRs) like photovoltaics (PV), battery energy storage systems (BESS), and wind turbines, the dynamics of SMs may interact with the inverter controls, introducing new modes of oscillation and potentially threatening system stability.

Inverters can operate in either current control mode, commonly referred to as grid-following mode, or in voltage control mode, known as grid-forming mode. Grid-following sources use a phase-locked loop (PLL) to measure the grid voltage angle, enabling synchronisation and the injection of active and reactive power into the ac grid [1]. Nevertheless, this control mode lacks the inertia contribution provided by conventional SM [2] and may encounter stability challenges in weak grids. To address these concerns, grid-forming controls in which both the magnitude and phase at the point of common coupling (PCC) are imposed, have been explored in the literature [3]. Numerous grid-forming strategies exist in the literature, among which droop control stands out as a well established and robust approach, essentially replicating the droop behavior seen in traditional power plants [4]. Additionally, various methods have been developed to not only replicate damping but also emulate the inertial effect of SMs. These include virtual synchronous machine control (VSIMA) [5], virtual synchronous generator (VSG) [6], synchronverter [7], and matching control [8]. The distinction between these strategies lies in their ability to capture the dynamics of SMs with varying levels of detail. In previous works, many studies have been conducted to examine the stability limits of power systems comprising SMs and IBRs controlled in grid-forming mode [9]–[13]. Coupling modes due to the interaction between SMs and IBRs have been highlighted in low inertia power systems, as well as the impact of key parameters such as short circuit ratio and IBR penetration level on small-signal stability [14] [15].

All these studies were conducted on a simplified academic representation consisting of an inverter vs SM model that does not capture the influence or dynamics of the rest of the system. Having a model for the rest of the system is essential as the dynamics of the ac system can significantly impact the stability of the power system, as demonstrated later in this paper. This paper proposes a methodology to comprehensively investigate novel coupling modes resulting from interactions between SMs and IBRs, as well as the influence of IBR control parameters on existing modes. This methodology, based on a conceptual benchmark introduced in [16] originally proposed for the synthesis of new IBR controls, represents a multi-source system comprising a SM, an IBR,

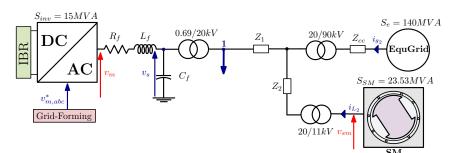


Fig. 1: A benchmark representing a real power system.

and an equivalent grid to model the rest of the system. Derived from previous works [17] [18], where it was designed to study oscillation modes in any power system in a reduced-order modeling, the benchmark is adapted in this study to replicate the characteristics of a real French island power system.

The inverter is controlled in grid-forming mode with the VSM control strategy. Modes are identified and examined using modal analysis and participation factors. Additionally, sensitivity analyses are conducted to identify key parameters influencing system stability. Finally, a power oscillation damping (POD) controller that aims to improve the damping of critical oscillation modes is proposed.

The remainder of this paper is structured as follows: section II explains the concept of the benchmark and its adaptation to represent the island power system of interest. In section III, the modes of oscillation obtained from the modal analysis are identified and analysed using participation factors. Section IV presents sensitivity analyses by adjusting essential parameters and examining their effect on the oscillation modes. Section V proposes a corrective measure to damp critical modes of oscillation. Section VI is devoted to the conclusion.

II. A CONCEPTUAL BENCHMARK FOR THE STUDY OF INTERACTIONS IN A REAL FRENCH ISLAND POWER SYSTEM

For a comprehensive investigation and quantification of coupling modes resulting from the interactions between SMs and IBRs controlled in grid-forming mode, the benchmark proposed in [17] and [18] is employed to ensure a thorough study. This benchmark, shown in Fig. 1, is simple yet sufficient in its design; it includes dynamic elements of interest required for analysis, and ensures that every component is modeled in Electromagnetic Transient (EMT), thus avoiding the risk of oversight of critical dynamics.

Modifications have been applied to the benchmark to accurately represent the French island power system, divided into two regions: an eastern area encompassing production and load, represented by the EquGrid block, and a western area incorporating a mix of a traditional SM and an IBR unit (PV or BESS) linked to a 20 kV medium-voltage grid. These generators in the western region represent upcoming projects planned for grid integration. A 90 kV high-voltage transmission line denoted by Z_{cc} interconnects the two regions.

Equivalent line impedance values derived from the detailed grid data are as follows: $Z_1 = Z_2 = 0.12 + j0.1 \ \Omega/km$ and $Z_{cc} = 0.14 + j0.4 \ \Omega/km$ with distances $l_1 = l_2 = 15 \ km$ and $l_{cc} = 200 \ km$.

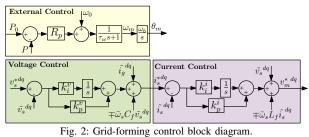
A diesel generator, with an exciter, prime mover, and governor as described in [17], has been employed to model the conventional generation within the medium-voltage grid of the western area.

A. Inverter model and grid-forming control

The IBR in the western area is modeled as a voltage source converter (VSC) using an ideal average model, neglecting the high-frequency switching of the inverter. The DC link is modelled as a constant voltage source without energy limitations. This study focuses on the inverter operating in grid-forming mode, whereas previous research primarily investigated the inverter under grid-following control mode [17] [18].

As shown in Fig. 2, a cascaded voltage and current loop configuration is used to regulate the voltage at the synchronisation point. As discussed in the previous section, different grid-forming strategies have been documented in the literature, each distinguished by its external control mechanisms. It is noteworthy that the filtered droop-based strategy and the VSM strategy are equivalent [15]. Additionally, the droop strategy without a filter represents a specific instance of the VSM strategy with zero inertia as demonstrated in [19]. In the present study, the VSM grid-forming control structure is adopted, as depicted in Fig. 2. In this form, the relationship between the filter time constant τ_{ω} and the equivalent inertia constant H_{VSM} is provided in equation (1).

$$\tau_{\omega} = 2H_{VSM}R_p \tag{1}$$



B. Equivalent grid model

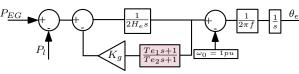


Fig. 3: Equivalent grid block diagram.

In the island power system under examination, primary frequency control is performed by a combination of BESS and conventional power plants equipped with SM including hydroelectric and thermal technologies. To accommodate this, and better represent the overall aggregate dynamics of the system, enhancements have been made to the equivalent grid model proposed in [17] by incorporating a lead-lag filter in the feedback loop of the swing equation as proposed in [20] and illustrated in Fig. 3.

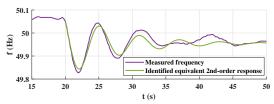


Fig. 4: Frequency response of the island power system after a sudden load variation of 3 MW.

 P_{EG} denotes the active power generated within the grid, while P_l represents the power consumed by the system's loads. The equivalent grid parameters have been tuned using the island system's measured frequency response to a 3 MW load step. As shown in Fig. 4, this response has been approximated by a second-order response, whose transfer function was used to identify the parameters of the equivalent grid model shown in Fig. 3. The identification results in: $H_e = 3.78$ s, $K_g = 10.24$, $T_{e1} = -0.5056$ s, and $T_{e2} = 1.21$ s.

III. MODAL ANALYSIS RESULTS

To explore oscillation modes resulting from the interactions between SMs and IBRs in grid-forming mode, both nonlinear time-domain simulations and modal analysis are employed. The latter enables the capture of highly damped modes and provides insights into all the different mode types. The modal analysis approach involves developing and linearising the differential-algebraic equations of the system as explained in [17] around an operating point and expressing the system equations in state-space representation as in (2). Subsequently, the eigenvalues of matrix A, representing the modes of oscillation, are analysed. Additionally, from matrix A, participation factors can be computed to gain insights into the states involved in each mode. Consequently, this provides an understanding of the nature of each mode.

$$\dot{x} = Ax \tag{2}$$

The critical modes of oscillation detected are presented in Table I. The droop value R_p is set at 4% in this case, and the inertia H_{VSM} of the VSM is equal to 2.5 s.

The main participation factors of the first mode identified in Table I are $\Delta \omega_{SM}$ and $\Delta \theta_e$, the rotor speed of the SM and equivalent grid angle respectively, with little participation of the grid-forming control angle $\Delta \theta_m$. As the states are related to the swing equation of both SM and equivalent grid, the detected mode is identified as the well-known inter-area mode [21] between the equivalent grid and the SM.

The frequency mode is the one at very low frequency, representing the global frequency dynamics of the system. The states involved in this mode are the SM's speed deviation $\Delta \omega_{SM}$, the SM's governor-related state ΔP_{gov} , the equivalent grid's dynamics ($\Delta \omega_e, \Delta T_e$) and the grid-forming control's speed $\Delta \omega_m$.

The VSM mode is the one introduced by the VSM control strategy of the grid-forming inverter. The main participation factors in this mode are the dynamics related to the VSM control strategy ($\Delta \omega_m$, $\Delta \theta_m$), the angle of the equivalent grid swing equation $\Delta \theta_e$ and a minor involvement of the SM's rotor speed $\Delta \omega_{SM}$. This mode is eliminated when τ_{ω} equals zero, indicating that it is introduced by the VSM control strategy. This particular situation corresponds to the unfiltered droop strategy as explained in Section II.A.

IV. SENSITIVITY ANALYSIS

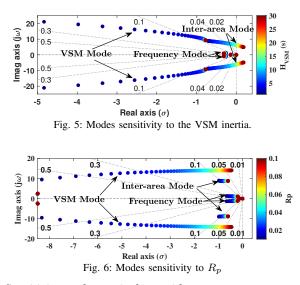
To evaluate the influence of key parameters such as the droop value R_p , the VSM's inertia H_{VSM} and the equivalent grid parameters (H_e and K_g), a sensitivity analysis has been performed to observe the behavior of the identified modes.

A. Sensitivity to the VSM inertia

Given that the inertia constant of the VSM is purely a control parameter with no physical constraints, unlike actual SM-based generators, any inertia value can be chosen for the VSM. In the sensitivity analysis performed here, it has been varied across a wide range, spanning from 1 to 30 s. As shown in Fig. 5, the damping of the inter-area and VSM modes decreases drastically when increasing the VSM inertia, and the inter-area mode even becomes unstable for values greater than 10 s. In contrast, there is a slight increase in the damping of the frequency mode with the increase in H_{VSM} .

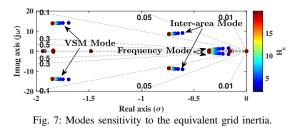
B. Sensitivity to the VSM droop control gain

To evaluate the influence of the primary frequency control gain on the system stability, R_p has been varied from 1% to 10%. As illustrated in Fig. 6, a reduction in R_p from 10% to 1% improves the overall system stability as the damping of the three modes increases.



C. Sensitivity to the equivalent grid parameters

As depicted in Fig. 7, increasing the inertia of the equivalent grid H_e results in increasing the damping of the frequency mode. This effect is consistent with increasing the inertia of the VSM as shown in Fig. 5, as both contribute to the overall inertia of the grid, thus influencing the in-phase oscillation of all states in the system's global dynamic response which the frequency mode represents. In contrast, the inter-area and VSM modes involve oscillations between elements in the grid, depending on the inertia ratio of different sources. Here, the damping is primarily influenced by the inertia ratio (H_{VSM}/H_e) , not the total grid inertia. Thus, increasing H_e enhances damping by reducing this ratio, while increasing H_{VSM} diminishes damping by raising the ratio. This aligns with Fig. 5 and Fig. 7, where lower H_{VSM}/H_e ratios correspond to improved damping in these modes.



V. POWER OSCILLATION DAMPING CONTROL

As indicated by the sensitivity analyses conducted in the preceding section, it has been observed that under certain critical conditions, the three low-frequency oscillation modes identified in this study may exhibit insufficient damping characteristics. To ensure enhanced stability of the power system, a POD controller, depicted in Fig. 8, is proposed and added to the IBR control.

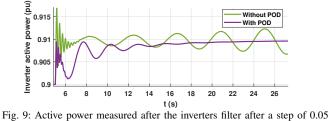
This controller takes the frequency ω_m of the VSM as an input and its output P^* is subtracted from P_0 of the external power loop in Fig. 2. A washout filter with a time constant T_{POD} set to 5 s is used to eliminate the steady-state value,

and a low-pass filter with a time constant of $T_{filt} = 0.2$ s is used to suppress the high frequencies. The gain K_{POD} is set to 200 pu. To test the effectiveness of the proposed controller, R_p is set at 10%. Furthermore, adjusting K_g to 20 enables to intentionally destabilize the initial condition. In this case the frequency mode is unstable as indicated by a negative damping value and the two other modes have a very low damping as shown in Table II where 1, 2 and 3 are the inter-area, frequency and VSM modes respectively. The

nonlinear time-domain simulations depicted in Fig. 9 validate the conclusions drawn from the modal analysis outlined in Table II. Specifically, the VSM mode is observed immediately following the step change, while the frequency mode emerges as the diverging oscillation that can be observed toward the end of the simulation result. While the inter-area mode oscillation is also present, it is not visible on the active power curves shown in Fig. 9 as its amplitude is insignificant compared to the other two depicted modes. Moreover, in instances where additional damping for the inter-area mode is needed, the installation of a Power System Stabilizer (PSS) on the SM can also be considered [21].

VI. CONCLUSION

This paper primarily proposes a new methodology to examine the dynamic stability of any real power system. This methodology is based on a conceptual benchmark designed to analyze various modes of oscillation between targeted dynamic elements of a power system, achieved by associating IBR and SM with a dynamic equivalent grid model. The structure of the benchmark allows for the representation of any real power system in a minimal order model as illustrated by the French island power system studied in this paper. The analysis of participation factors has revealed that the VSM control of IBR introduces a low-frequency mode, in addition to the well-known inter-area mode between SM and the equivalent grid, and the frequency mode governing system-wide frequency behavior.

Sensitivity analyses reveal that higher VSM inertia reduces damping of certain critical modes, while a lower droop value (corresponding to a greater primary frequency regulation contribution) enhances it, consistent with prior research. However this study goes further by investigating the impact of equivalent grid model parameters on system dynamics, finding that increasing its inertia increases damping of critical modes, contrary to VSM inertia. Additionally, this methodology enables the identification of the frequency mode and its effect on the system stability and provides a reduced order model for the power system of interest.

A POD installed on the external loop of the grid-forming control has been proposed and proven to be effective in increasing the damping of all three detected low-frequency modes.
