Intimate contact between red blood cells and vessel walls is sufficient to stabilize capillary networks during development

Hierarchical branching networks are ubiquitous around us in nature, including river networks, lightnings, trees and their root systems. Most of them form transportation networks. Some have a convergent architecture transporting for example water from the smallest streams to the largest rivers. Others have a divergent architecture transporting for example electrons from clouds to ground throughout an increasing number of branches. Trees combine a convergent root system under ground with a divergent one above ground, where sap flows from trunk to leaves during evapotranspiration. In general, such hierarchical branching networks are consistent with the constraints that the time for supplying resources as well as the length of distribution pathways should be minimized. However, because of the large distances separating their terminal branches, they are not optimal for the delivery of goods to distributed locations that are filling a space, such as buildings in a city center. That's why humanbuilt logistic networks, including roads and water-distribution and waste-collection systems, mostly combine branching networks (e.g. freeways, highways and large avenues) with interconnected, loopy ones (smaller streets enclosing city blocks).

A striking natural example of such a combination of branching and interconnected networks is the blood vascular system of vertebrates, including fishes, birds, and mammals (Fig. 1). This system is able to ensure adequate blood supply, feeding every cell in peripheral tissues with oxygen and nutrients under a wide range of physiologic conditions and varying metabolic needs. For 42 that purpose, it is comprised of three distinct families of vessels, 43 functionally organized in series (Fig. 1A,B): 1/ the arteries, which 44 collectively form a divergent tree that carries blood away from 45 the heart; 2/ the capillaries, the smallest vessels in the body 46 with sizes typically matching or smaller than that of individual 47 red blood cells (RBCs), which together form an interconnected 48 (or loopy) network connecting the arteries to the veins; and, 3/ the veins, which carry blood back to the heart through a 49 convergent arborescence (1-3). Blood flow has been known to be 50 a primary driver of vascular network growth since the pioneering 51 work of Thoma in 1893 (4). Schematically, the cells lining the 52 walls of high-flow vessels (endothelial cells) are submitted to high 53 54 friction forces, which trigger them to reorganize (by migrating and 55 changing shapes/orientations), leading to vessel enlargement, and 56 vice-versa (5, 6). However, this simple mechanism essentially leads to the extension of trees in the vascular network, with 57 concurrent regression of vascular loops, giving rise to direct 58 connections, or shunts, between arteries and veins (5, 7-9). In 59 PNAS, by combining mathematical models of vascular adaptation 60 and experiments in the zebrafish embryo (Fig. 1D), Qi et al. (10) 61 thus address the long-lasting and unresolved question in vascular 62

physiology: what are the underlying mechanisms for the stability of loopy vascular structures, characteristic of capillary beds, in microvascular networks? In such capillaries, Qi et al. (10) underline that the friction forces strongly fluctuate in time and space, being maximal when RBCs, which typically flow in single files in these small vessels, are passing by. Taking inspiration from network physics, where fluctuations have been put forward to explain the coexistence of branching and loopy structures (11), their central hypothesis is that diameter changes in capillaries are driven by these peak friction forces. 63

Previous experimental work elegantly demonstrated the in-84 volvement of blood flow in the proper formation of the branching 85 microvessels. For example, in chick embryos, suppressing blood 86 circulation after heart removal prevented the growth of arteries 87 and veins, despite the capillary network continuing to develop 88 for several days (1). Manipulation of blood flow, for example by 89 ligation of an artery, dramatically affected the final vascular pattern 90 (Fig. 1C) (1, 12). In mouse embryos, sequestrating RBCs out of 91 the blood vessels also prevented the growth of branching vessels, 92 while restoring the viscosity by adding biopolymers, which mainly 93 increases the average friction, restored normal vascular devel-94 opment (6). However, theoretical models considering the rate of 95 enlargement of blood vessels being proportional to average friction 96 fundamentally lead to unstable solutions for two vessels organized 97 in parallel (7). In other words, for this minimal representation of a 98 loopy network, the underlying mathematical structure representing 99 this simple problem is unstable, inevitably leading to one of the 100 vessel vanishing while the other one enlarges (7, 10). In larger 101 networks, this progressively drives the regression of all capillaries, 102 with the ultimate collapse of all remaining branches into a single 103 pathway that connects the main arterial inlet with the main venous 104 outlet (5, 7, 8). This fundamental gap in our understanding of 105 vascular development has been called "the shunt problem" (9). 106

Qi et al. (10) first mathematically rewrite the simplest minimal 107 problem for the diameter evolution of two parallel vessels, with 108 peak friction now being the driver. For that purpose, they make the 109 following assumptions: 1/ a simple geometrical model can describe 110 how spherical particles, representing RBCs, are squeezed in 111 vessels with diameter smaller than their undeformed diameter; 2/ 112 a thin liquid film with approximately constant thickness is trapped 113 between their squeezed portion and the vessel wall, in which the 114 local friction is much higher than the activation value triggering 115 the reorganization of endothelial cells; 3/ the fraction of activated 116 endothelial cells in each vessel is thus proportional to the total 117

length of this liquid film, i.e. summing over all squeezed RBCs in
this vessel, divided by the vessel length, and 4/ the rate of vessel
enlargement is proportional to the difference between this activated
fraction and an activation threshold. They show that the simplest
associated mathematical problem of vascular adaptation driven
by peak friction leads to a stable equilibrium point, in which both
parallel vessel converge to an equal radius.

With this result, Qi et al. (10) move on to a more complex 161 network structure representing the main vessels in the tail of 162 the zebrafish embryo four days after fertilization. In doing so, 163 they focus their attention on the subsequent evolution of a single 164 pair of artery and vein, the dorsal aorta (DA) and the posterior 165 cardinal vein (PCV) and their interconnecting ladder-like capillary-166 sized vessels, the intersegmental vessels (Se-vessels) (Fig. 1D). 167 Keeping the above assumptions, they also introduce the unequal 168 repartition of RBCs downstream microvascular bifurcations, with 169 more RBCs generally biased toward the highest flow vessel (14), 170 as an additional ingredient. Whatever the model used to represent 171 this phenomenon, their peak friction vascular adaptation model 172 yields increasing Se-vessel diameters and increasing RBC concen-173 trations from head to tail when starting from a uniform or random 174 affectation of the diameters of Se-vessels, consistent with their ex-175 perimental observations at four days. These systematic variations 176 compensate for the decreased pressure gradient that establishes 177 across each successive Se-vessel due to the increasing distance 178 from the network inlet, and ensure uniform perfusion of RBCs 179 from head to tail, once again consistent with the experiments. In 180 contrast, adaptation driven by average friction would lead to the 181 opposite trends, leading to a large shunt depleting the tail region 182 from blood and RBCs. Thus, peak friction forces provide a simple 183 mechanical cue stabilizing the loopy Se-vessels in the tail region, 184 and, in the same time, ensuring uniform RBC perfusion throughout 185 the tail. 186

in each vessel for the endothelial cell activation fraction to stay 216 higher than the activation threshold. If not, the vessel will regress 217 to a size too small for RBCs to squeeze in, potentially disrupting 218 perfusion uniformity. Qi et al. (10) thus make the assumption that, 219 between 7 and 15 days after fertilization, when the amount of 220 RBCs in blood drops possibly due to RBC maturation, uniform 221 perfusion must be lost. They first experimentally measure RBC 222 fluxes from head to tail during this time frame, and confirm almost 223 complete loss of RBC perfusion in the four Se-vessels closest to 224 the head at day 10. Then, keeping the same starting network 225 as previously, they reproduce their computations of peak friction 226 force adaptation with smaller and smaller values of the inlet RBC 227 concentrations, mimicking the observed evolution. They show 228 a complete loss of RBC perfusion on these same vessels after 229 ten days, combined to a lower value of their diameters due to 230 the associated drop in the activation fraction. Noteworthy, just 231 reducing the inlet RBC concentration while keeping fixed values 232 of the diameters (no adaptation) does not lead to vanishing RBC 233 perfusion in the head-most Se-vessels. Once again, adaptation 234 driven by average friction cannot either explain this observation. 235

However, this mechanism requires a sufficient number of RBCs

236 Finally, as increasing concentrations of RBCs from head to tail 237 emerged as a central ingredient of loop stabilization as well as 238 uniform perfusion, Qi et al. (10) further examined whether a simple 239 experimental manipulation could affect the distribution of RBCs. In 240 doing so, they realize that, due to RBCs being biased toward the 241 highest flow vessel at bifurcations, a majority of them remains in 242 the DA after each successive intersection with Se-vessels. A large 243 proportion of them therefore continues directly downstream to be 244 drained by the PCV. They conclude that amputating the tail to ablate 245 the direct connection between the DA and PCV at the tail should 246 have a strong effet on both the RBC distribution in Se-vessels 247 and vascular adaptation. Indeed, performing this experiment, they 248

gualitatively show a strong increase of the number of RBCs in the 249 tail-most Se-vessels. Consistently, the adaptation model predicts a 250 large (\sim 5-fold) increase of the RBC concentration in these vessels, 251 which consistently leads to increased diameters. In combination, 252 this leads to a strong increase in RBC perfusion towards the tail. 253 Uniform perfusion is retrieved by the model if the conductance of 254 the DA/PCV connection is progressively restored, with a diameter 255 matching that of the real zebrafish embryo. 256

Overall, by combining experiments in the zebrafish embryo. 257 including manipulation of blood flow by ablating the DA/PCV 258 connection, highly idealized mathematical models of vascular 259 adaptation induced by peak shear stress and more realistic 260 physically-based models integrating some aspects of the complex 261 behavior of blood flow in microvessels, Qi et al. (10) provide 262 strong evidence that vascular adaptation driven by peak friction 263 forces could be a mechanical driver for the stabilization of capillary 264 loops, yielding uniform perfusion. Other mechanisms have been 265 previously proposed to counteract the formation of vascular shunts 266 during development, including capillary disconnection from the 267 larger arteries and veins (12, 15, 16), upstream information transfer 268 along vessel walls (8, 9) and metabolic signaling, by which vessel 269 diameter increase if oxygen is locally insufficient to support the 270 metabolic demand (8, 9). However, the two first ones mostly avoid 271 proximal shunting (shunting between larges arteries and veins) 272 while the last one is ineffective at early stages of development 273 when the embryo is sufficiently small to get its oxygen by diffusion 274 from the surrounding atmosphere, as underlined in (10). 275

Of course, this study also opens a wealth of additional questions. 276 In particular, is the peak friction model also relevant for larger 277 vessels or is average friction driving vessel remodelling there? If 278 yes, what is the cut-off size between these two regimes? The 279 ideas exposed in (10) suggest it would correspond to the transition 280 between single and multiple file RBC motion in small vessels (14). 281 This transition also roughly corresponds to a minimum in the 282 viscous dissipation for blood flow in small vessels. Does this 283 contribute to setting up the diameter of vessels at the transition 284 between branching vessels and loopy ones in the vascular hi-285 erarchy and/or to minimizing the cost of blood distribution? On 286

another side, the results obtained by (10) pinpoint the importance 311 of the connection between the DA and the PCV at the end of 312 the tail. As these connecting vessels establish as soon as the 313 heart begins to beat around 24h postfertilization in the zebrafish 314 embryo (13), and at that time are the only ones in the trunk and 315 tail regions, this raises the question of the mechanisms driving this 316 initial, large-scale circulatory loop. Previous work in the chicken 317 yolk-sac suggested that growth of the yolk-sac induces tissular 318 pressure gradients contributing to the formation of the initial arterio-319 venous pattern (17). In the brain, this initial pattern has been 320 suggested to be involved in the formation of large penetrating 321 arterioles and ascending venules in the cortex (16). Importantly, 322 up to now, the initial organization of this large-scale pattern must 323 be postulated as a starting point in modeling studies of vascular 324 development, in the yolk-sac as well as in the brain (12, 18). Com-325 bined with emerging experimental observations of the postnatal 326 development of the capillary bed in complex tri-dimensional organs, 327 including the brain (19), this opens the perspective to understand 328 whether the present results are generalizable. Finally, how the 329 above mechanical cues interplay with the genetic and molecular 330 machinery that drives the reorganization of endothelial cells and 331 sets up vessel identities (1, 6) still needs to be uncovered. 332

333 Answering these questions will be key to understand how 334 disregulations of this interplay leads to impaired microvascular 335 architecture and function in a large range of diseases, including 336 cancer, diabetis, neurodegenerative diseases, as well as normal 337 aging, possibly leading to novel diagnosis and/or therapeutic 338 strategies. Moreover, it will help overcome our current inability 339 to engineer organoids with functional vasculatures, a fundamental 340 bottleneck that strongly limits their size and their maturation 341 potential beyond the developmental phases (20). This will open 342 future opportunities, especially in the field of organ replacement. 343
