INTRODUCTION

Context

Significant presence of food-related content on Social Networks Sites (SNSs) -> considerations related to health, pleasure, and sustainability.

Emergence of influencers, particularly health professionals like dietitians, who gather followers around their dietary recommendations.

They leverage SNSs to democratize health information and engage in self-presentation tactics (Goffman, 1973) to maintain their audience's attention (Citton, 2014).

-> How does influencer's activity coexist with the nutrition professional's discourse?

Context


Influencers on platforms like Instagram attract users, but they aren't paid for content production -> they rely on partnerships with brands as a form of rewarding.

influencers by Applications shape competition among incentivizing content production to maintain user engagement.

Dietitian influencers face tensions between :


- meeting follower expectations and platform algorithms, •

- and the desire to disseminate nutritional information. •

-> Interest in the communicational and commercial issues of dietary discourses conveyed by dietetic influencers.



Field and methodology

Daily manual data collection on 8 Instagram accounts of dietitian influencers (Table 1) from September to October 2023.

INTRODUCTION


The corpus is made up of 372 productions (carousels, reels and stories). This collection was carried out according to an analysis grid that considers:

· Strategies for sharing personal and professional life, · Staging of food and lifestyle,

• Product placement strategies.



Nutrition

Dietitian influencers participation in the nutritionalization of society (Poulain, 2009).

The national nutrition and health program in France identifies nutrition as a key to fight obesity and diabetes in particular.

-> The communication strategy of the programm is part of a process of mass dissemination of nutritional knowledge through the media (Romeyer, 2015).







-> 33% publications of the corpus are related to the promotion of physical activity = running and weight

-> Representative of the "healthy" lifestyle promoted by the fitness content on the SNSs (David, 2021). This lifestyle is subordinated to objectives such as maintaining one's health or body performance (David,

Watering down of the nutritional discourse with other themes like well-being and mental health.

-> An extension of the field of expertise of dietitians.

-> The promotion of intuitive eating or consciousness eating = based on a logic of empowerment. The aim is to regain control over unconscious or emotional bodily processes through the monitoring of hunger signals or sensations during the act of eating.

-> These discourses appears to be a form of "biomorality" (Zupancic, 2008).

Diet and physical activity can be instrumentalized in the name of well-being in a strictly individual way. This imperative of well-being generates a whole dialectic between the good bio-citizens and the bad bio-citizens that should be saved (Rail, 2016).

Dietitian's authority

Instagram represents a way to showcase the profession of dietitian.

14% (51 publications out of 372) correspond to the sharing of to-do lists, certain tasks and even testimonials from their patients.

The number of dietitians increases every year in France, from 7,000 in 2012 to more than 16,000 in 2023 -> consultations are not supported by social security = subscribers can represent a pool of potential patients.


The posture of the professional is part of both health communication and the register of influence marketing (Staii, 2022)


Article R4127-13 of the French Public Health Code states:

"When the doctor participates in a public information action of an educational, scientific or health nature, whatever the means of dissemination [...] He does not aim to profit from his intervention in the context of his professional activity, nor to benefit from it organizations within which he practices or to which he lends his assistance".

French Association of Dietitian Nutritionists, 2018:

"The dietitian nutritionist undertakes to behave loyally towards his colleagues and to respect the free choice exercised by the person or partners in their choice of professional. He undertakes not to practice his profession as a business and refrains from any advertising process."

This authority is built notably through brand partnerships.

Influencers are capable of creating a reputational authority online (notoriety) -> many brands lack this authority, which is sold to them as a lever of authenticity (Alloing, 2022).

Influencer's authority

Partnerships represent :

• a form of recognition by brands of the quality of the content

produced by the influencer,

• a gain in legitimacy that helps to reinforce his reputation, the number

• and, thanks to his "partnership", the ability to "help and advise" his followers (Godefroy, 2021).

2. ONLINE AUTHORITY AND COMMERCIAL ACTIVITY


Influencer's authority

This reputational authority is the result of affective and emotional work (Alloing, 2022).

-> Knowledge of the audience (Quizz, Q&As, etc.).

-> Provoke a reaction enables content to be circulated, made visible and even viral + create proximity and attachment.

It invites to explore the link between extending the field of expertise and emotional work to maintain a link with the public -> the construction of expertise through the staging of requests (e.g. Q&As).



Dietitian influencers show concrete applications of a nutritional discourse, while at the same time lightening the hygienist character of nutrition.

- aesthetics (healthy and foodporn),
- use of devices,

The themes of weight loss and dieting are not clearly verbalized, but are scattered throughout the representations.

The coexistence of the posture of health professional and influencer which seems to be based mainly on the demonstration of authority = appears to be proof of their legitimacy -> ethical stakes of this online activity.
