Resolving ambiguities in phase correction term for optical field encoding

This article addresses ambiguities regarding the existence and definition of a phase correction term in phase and amplitude optical field encoding techniques. We present a generalized mixed Fourier-Taylor series expansion that is valid for any phase-wrapping interval. Our theoretical analysis and numerical validations confirm that maintaining consistency within a given phasewrapping convention ensures equivalent results and reconciles previously conflicting interpretations.

 Advancements in optical engineering have continually refined our ability to manipulate light at microscopic levels. Among these developments, the method introduced by Davis *et al.* [1] for encoding both amplitude and phase information onto phase-only filters stands out. This well-known approach employs a spatially-modulated blazed phase grating to tailor the diffraction efficiency in the first order. This technique has been applied for wavefront shaping tasks such as the gener-11 ation of vortex beams $[2-4]$, Bessel beams $[5, 6]$ and mode- matching for photonic structures excitation [7]. It has permitted advances in fiber communications [8], nonlinear fluorescence 14 microscopy [9], imaging [10] and holographic data storage [11]. It is also central for the creation and manipulation of high-16 dimensionality entangled states [12, 13] and more recently for 17 optical skyrmions $[14, 15]$. Independent work $[16]$ used a similar approach to achieve 1D phase and amplitude shaping using a phase-only 2D mask in the context of femtosecond laser pulse 20 shaping using 4*f*-lines.

 Subsequently, Karimi *et al.* [2] proposed improvements to the method proposed in [1] by accounting for a phase correction term. More recently, Clark *et al.* [17] conducted a comparative study of various complex amplitude encoding approaches, con- cluding that the method introduced by Davis *et al.* originally yielded superior results. However, confusion persists regard- ing the use of the phase correction term highlighted by Karimi *et al.* [2], its application being dependent on the conventions adopted in the Fourier series expansion.

 Our contribution addresses the apparent contradictions in 31 the current literature. In particular, we demonstrate that these discrepancies are due to different phase-wrapping conventions, which are indeed equivalent provided that consistency is main-

³⁴ tained within a given convention across all the calculations required to generate the blazed grating. For instance, one convention wraps the phase between $[-\pi, +\pi]$ [17], while another wraps it between $[0, 2\pi]$ [2]. Each convention has a corresponding correct expression for the phase correction term. Issues occur when expressions valid for one range are applied to another. We assert that any 2π range $\left[\alpha, \alpha + 2\pi\right]$ can be used, provided that the specific expression for that wrapping interval is correctly ⁴² derived. Furthermore, we present a generalized expression that ⁴³ depends on *α*, making it valid for any wrapping convention. ⁴⁴ Our work provides theoretical analysis and numerical examples ⁴⁵ to demonstrate the implications of these conventions, thereby ⁴⁶ resolving the ambiguities and enhancing the understanding of 47 amplitude and phase encoding techniques.

⁴⁸ **1. CLARIFICATION ON THE FOURIER CONVENTIONS**

⁴⁹ We hypothesize that the contradictory conclusions observed in ⁵⁰ the works of Karimi *et al.* [2] and Clark *et al.* [17] stem from ambiguities concerning the valid range over which the expres-⁵² sions apply. Specifically, the phase correction term mentioned ⁵³ in [2] is applicable only when the phase-wrapping convention is $[0, 2\pi]$. Since many simulation tools typically wrap the phase in $\begin{bmatrix} -\pi, +\pi \end{bmatrix}$, it is crucial to be mindful of the conventions used.

 To substantiate our hypothesis, we present an analysis using a Fourier-Taylor expansion, akin to that in [1], but adapted to the phase convention in the [*α*, 2*π* + *α*] range, valid for any *α*. Additionally, we provide a straightforward example to clearly demonstrate the implications of these conventions.

⁶¹ **A. Derivation of the mixed series with** [*α*, 2*π* + *α*] **convention**

 62 The transfer function of the SLM is written as:

63 where $M(u)$ represents the amplitude and $φ(u)$ represents the ⁶⁴ phase of the shaping as a function of the position *u*. Following ⁶⁵ the work of [1], we propose to rewrite this function. We perform 66 a Taylor series expansion of *T* with respect to $M(u)$ around 0:

- \mathbf{F} We now consider the p^{th} derivative of *T* with respect to *M*(*u*),
- ⁶⁸ which is written as:

- ⁶⁹ Since the function *φ* is 2*π*-periodic and varies between *α* and
- π 2 π + α , the p^{th} derivative of T with respect to $M(u)$ evaluated 71 at $M(u) = 0$ is also 2π -periodic. Therefore, we expand it into a
- ⁷² Fourier series with respect to *φ*(*u*):

⁷³ with *cn*,*p* being Fourier coefficients defined as:

⁷⁴ Inserting equation Eq. (4) into equation Eq. (2) yields the follow-⁷⁵ ing expression for *T*:

79 Using this expression in Eq. (7) to rewrite the coefficients $B_{n,p}$ ⁸⁰ yields:

82 By interchanging the integral and the sum, we can evaluate the 83 following series:

85 We do a change of variable $ψ = φ - α - π$ and obtain :

We get the constant term out of the integral and evaluate the integral between $-\pi$ and $+\pi$:

We use Euler formula to simplify the exponential terms in brackets and obtain the corrected $T_n(u)$ formula :

with $\Phi_c(u, \alpha, n) = (\pi + \alpha)[M(u) - n]$ (16)

 $\frac{1}{90}$ Examining expression Eq. (16), it becomes evident that the 91 presence of the phase correction term is contingent on the spe-⁹² cific phase-wrapping convention used, specifically on the value of α . Notably, with $\alpha = 0$, we obtain the correction term $\Phi_c(u,n) = \pi[M(u) - n]$ which is coherent with [2]. In contrast, with $\alpha = -\pi$, we obtain the correction term $\Phi_c(u, n) = 0$ which is coherent with [17]. Our phase correction term $\Phi_c(u, n)$ 97 is indeed a generalized phase correction term whose expression ⁹⁸ depend on the considered *α*, thus reconciling conflicting results 99 presented in the literature.

¹⁰⁰ **B. Numerical example**

¹⁰¹ To validate the implications of employing different Fourier con-¹⁰² ventions, we present a numerical example comparing the exact expression *T* with its mixed Fourier-Taylor series expansions *T α* for various arbitrary values of $\alpha = -\pi$, 0 , $\frac{3\pi}{2}$. These expansions ¹⁰⁵ are defined as follows:

In these equations, *N* represents the number of terms in-¹⁰⁷ cluded in the expansion, and *M* is a constant amplitude value 108 used for the comparison. The phase term ϕ is varied between $109 -2\pi$ and 4π to comprehensively test the validity domains.

110 As illustrated in Figure 1, with $N = 100$ and $M = 0.33$, the real and imaginary parts of *T* are compared with those of the m mixed Fourier-Taylor series expansions T^{α} . The value $M =$ 0.33 is chosen arbitrarily and the number of terms $N = 100$ is selected to ensure a high level of accuracy in the series expansion, providing a sufficient number of terms to approximate the exact transfer function closely.

 The figures clearly show that the real and imaginary parts of the transfer function *T* align perfectly with their respective mixed Fourier-Taylor series expansions T_n^{α} only within the spe-120 cific phase-wrapping range $[\alpha, 2\pi + \alpha]$, that repeats every 2π . Outside this range, indicated by the gray areas in the figure, the expansions do not align with the exact transfer function. This highlights the necessity for consistency in applying the correct phase term across various wrapping ranges and confirms the validity of the generalized expression that depends on *α*.

¹²⁶ **2. ENCODING OF AMPLITUDE AND PHASE IN 2D**

 To test our generalized expression Eq. (16) for 2D amplitude and phase modulation, we present simulations and experimen-129 tal results, based on the approach described in [1], where we generate a truncated sinusoidal pattern as described in [7]. The 131 aim is to demonstrate the effectiveness of our generalized mixed Fourier-Taylor expansion expression for tailoring a 2D beam profile under various phase-wrapping conventions.

Fig. 1. Real and imaginary parts of the transfer function *T* and its corresponding mixed Fourier-Taylor series expansions *T α* for different phase-wrapping conventions. Each row corresponds to a different *α* value: (a) $-\pi$, (b) 0, and (c) $3\pi/2$. The grey areas indicate ranges where the expansions are not expected to align with the exact transfer function.

¹³⁴ **A. Experimental and Simulation Setup**

 135 The setup is a 2 f optical system in which a phase-only mask is placed in the Fourier plane of a lens. The optical field *Eⁱ* 136 137 incident on the phase mask is a 2D Gaussian with a waist $w =$ ¹³⁸ 4.3 mm which is modulated by the phase mask, thus resulting in ¹³⁹ a modulated field *Em* as illustrated in figure 2. A lens with a focal 140 length $f = 300$ mm is used to produce the Fourier transform 141 of the modulated beam E_m in the image plane. In practice, the ¹⁴² phase mask is a Liquid Crystal Spatial Light Modulator (LCSLM) ¹⁴³ that accurately approximates a blazed phase grating, provided ¹⁴⁴ that the phase grating periodicity is large compared to the pixel ¹⁴⁵ size of the LCSLM.

 We aim at generating a truncated sinusoidal pattern with a 147 period of 360 µm, as illustrated on the simulations presented in Figure 3. We follow the approach described in [1] and use our mixed Fourier Taylor expansion expression Eq. (16) to generate the appropriate phase masks.

Fig. 2. Optical setup. The incident beam *Eⁱ* phase is modulated by the mask and the Fourier transform of the modulated beam is obtained in the image plane. The targeted profile, a truncated sinusoidal pattern, is generated in the first order of diffraction as illustrated in both intensity and phase maps.

¹⁵¹ **B. Results and Discussion**

 We examine only the beam profile corresponding to the first order of diffraction in the image plane as it corresponds to the targeted sinusoidal profile. Figure 3 presents the resulting inten- sities for the truncated sinusoidal pattern under various phasewrapping conventions and phase correction terms.

Fig. 3. Simulated profile intensities with different phasewrapping conventions and phase correction terms. Each row corresponds to a different wrapping convention : (a) $[-\pi, +\pi]$, (b) $[0, 2\pi]$, and (c) $\left[\frac{3\pi}{2}, \frac{7\pi}{2}\right]$. Each column applies the phase correction term Φ*^c* according to a different wrapping convention.

Each row represents a different phase-wrapping convention ¹⁵⁸ used in the simulations: row (a) uses the wrapping convention ¹⁵⁹ $[-π, +π]$, similar to the convention used in [1], row (b) uses 160 the wrapping convention $[0, 2\pi]$, corresponding to what is pro-¹⁶¹ posed in [2], and row (c) uses the arbitrary wrapping convention ¹⁶² $\left[\frac{3\pi}{2}, \frac{7\pi}{2}\right]$. Each column shows the application of the phase cor-¹⁶³ rection term Φ*^c* from Eq. (16) according to a specific wrapping ¹⁶⁴ convention: column (i) applies the phase correction term for ¹⁶⁵ $\alpha = -\pi$, column (ii) for $\alpha = 0$, and column (iii) for $\alpha = \frac{3\pi}{2}$.

166 The results illustrate that when using the $[-\pi, +\pi]$ conven- 167 tion, i.e *α* = −*π*, no phase correction term is needed, as the ¹⁶⁸ phase naturally aligns within this range. For other conventions, ¹⁶⁹ as illustrated by the red frames, applying the appropriate phase 170 correction term according to the selected wrapping range en-¹⁷¹ sures accurate phase shaping and avoids discrepancies. Specifi-172 cally, the intensity profiles show that the target beam profile is 173 correctly formed only when the phase correction term matches ¹⁷⁴ the phase-wrapping convention used in the beam shaping simu-¹⁷⁵ lation.

 This validation further confirms the robustness of our gener-177 alized mixed Fourier-Taylor expansion expression for phase cor- rection across different phase-wrapping conventions. It enables precise amplitude and phase shaping in optical beam shaping applications, ensuring that the desired 2D beam profile is accu- rately achieved regardless of the phase-wrapping convention employed.

 used to calculate the phase mask that defines the blazed grat- ing and the effective phase modulation range of experimental systems used to actually implement this blazed grating. The wrapping convention impacts the position of the grating grooves relative to the amplitude modulation envelope, thus affecting the generated profile. However, once this profile is generated, 190 the actual phase modulation range $[\gamma, \gamma + 2\pi]$ of the device used experimentally does not matter.

 To illustrate, we present experimental results obtained with 193 the setup described at the beginning of section A. Our LCSLM used for the phase mask induces phase delays over a range $[\gamma, \gamma + 2\pi]$ with $\gamma \gg 1$. However, the generated profile for the blazed grating is the same but for a global phase constant applied uniformly to the diffracted shaped wavefront. The quality of the generated profiles, highlighted in red in Figure 4, provides experimental proof that the effective phase modulation range does not need to correspond to the phase-wrapping convention used to calculate the mask.

3. CONCLUSION

 This study addresses and resolves ambiguities in the phase cor- rection term for optical field encoding by analyzing different Fourier conventions. We have shown that discrepancies in the lit- erature arise from varying phase-wrapping conventions, which, when consistently applied, yield equivalent results. Our the- oretical analysis and numerical validations demonstrate the importance of selecting and adhering to appropriate Fourier conventions.

²¹¹ We presented a generalized expression for the phase correc- tion term that is valid for any phase-wrapping convention. This expression allows for consistent and accurate phase encoding, crucial for the effective implementation of phase-only filters

 across various optical systems. Our approach was validated through simulations and experiments of 2D beam shaping, illus-217 trating the robustness of our method in achieving precise ampli- tude and phase modulation regardless of the phase-wrapping convention used.

 We hope this clarification work will help enhance the un- derstanding of amplitude and phase encoding techniques, pro- viding a clearer theoretical framework and helping to resolve existing ambiguities. We expect it will pave the way for more re- liable wavefront shaping and advance the capabilities of optical engineering at microscopic levels.
