## 1 Silicon mobilisation by root-released carboxylates

- 15 **Capillaroid roots:** roots that are covered with closely crowded persistent root hairs, which 16 attract moisture and dissolved nutrients through capillary action.
- Carboxylate: the conjugate base of carboxylic acid. For example, the carboxylate citrate is
   the conjugate base of the organic acid, citric acid.
- 19 Chronosequences: sequences of soils derived from the same parent material that differ in 20 properties primarily because of time as a soil-forming factor; can represent strong soil 21 nutrient availability gradients.
- 22 Cluster roots: bottle-brush-like or Christmas-tree-like structures in roots with a dense
- packing of root hairs; these structures release carboxylates into the rhizosphere, thus
  solubilising poorly available nutrients (*e.g.*, P, Mn) in the soil.
- Dauciform roots: carrot-shaped roots with long root-hairs that release carboxylates into the
   rhizosphere.
- Facilitation: positive interaction that can occur between plants and results in an increase inperformance of at least one of the interacting species.
- Ligand-promoted dissolution: release of metal cations (*e.g.*, Al, Fe, Mn) from minerals
   promoted by chelating organic anions (*e.g.*, citrate, oxalate, EDTA)
- 31 **Mycorrhizal species:** plant species able to establish a symbiotic association with any type of 32 mycorrhizal fungus (from the Greek;  $\mu\nu\kappa\eta\sigma$ , fungus +  $\rho\iota\zeta\alpha$ , root).
- 33 Non-mycorrhizal species: plant species unable to establish a symbiotic association with any
- type of mycorrhizal fungus; examples include most species belonging to Brassicaceae(cabbage family), Cyperaceae (sedge family) and Proteaceae.
- 36 **Phenols/phenolics:** plant secondary metabolites consisting of aromatic compounds with one
- or more hydroxyl groups. They are broadly distributed in the plant kingdom, and protect plants against stresses.
- Phytoliths: hydrated amorphous silica structures precipitated in and between plant cells.
  Useful tools in archaeology and palaeobiology, they are also thought to be responsible for the
- 41 Si-related stress alleviation (from the Greek; Φύτον, plant +  $\lambda$ ίθος, stone).
- 42 **Phytosiderophores:** root-released organic substances (*e.g.*, avenic, mugineic, deoxymugineic
- acids) produced by Poaceae species which strongly chelate metals and increase their
  subsequent uptake (Fe, Zn, Cu, Mn, Cd).
- 45 **Quantitative defence compounds:** secondary plant compounds that reduce the digestibility
- 46 and/or palatability of the food source and invariably make up a major fraction of the biomass.
- 47 They are mostly phenolic compounds (phenolic acids, tannins, lignin).

- 48 Sand-binding roots: roots with a prominent dense sheath of sand particles bound together by
   49 a mesh of root hairs and/or mucilaginous exudates.
- 50 **Silica**: silicon oxide with the chemical formula SiO<sub>2</sub>.
- 51 Silicon transporters: specific influx/efflux transporters that allow movement of Si from the
- 52 rhizosphere into roots.
- 53 Sorption/sorbed ion: chemical processes by which a dissolved ion becomes bound to the
- 54 surface or inside a mineral.
- 55 **Primary minerals:** minerals of lithogenic origin (*e.g.*, quartz, feldspars).
- 56 Secondary minerals: minerals of pedogenic origin that have been formed in soils as
- 57 products of weathering (e.g., kaolinite, Fe/Al oxides).
- 58 **Trade-off:** increase of a functional trait that is inevitably associated with the decrease of 59 another.
- 60 **1:1 clay minerals:** phyllosilicates consisting of one tetrahedral silicate sheet bound to an 61 octahedral hydroxide sheet (*e.g.*, kaolinite).
- 62 **2:1 clay minerals:** phyllosilicates consisting of an octahedral hydroxide sheet bound between
- 63 two tetrahedral silicate sheets (*e.g.*, chlorite).

#### 65 Abstract

Plants have evolved numerous strategies to acquire poorly-available nutrients from soil, 66 including the release of carboxylates from their roots. Silicon (Si) release from mineral 67 dissolution increases in the presence of chelating substances, and recent evidence shows that 68 leaf [Si] increases markedly in old phosphorus (P)-depleted soils, where many species exhibit 69 70 carboxylate-releasing strategies, compared with younger P-richer soils. Here, we propose that 71 root-released carboxylates, and more generally rhizosphere processes, play an overlooked role in plant Si accumulation by increasing soil Si mobilisation from minerals. We suggest 72 73 that Si mobilisation is costly in terms of carbon, but becomes cheaper if those costs are 74 already met to acquire poorly-available P. Uptake of the mobilised Si by roots will then 75 depend on whether they express Si transporters.

#### 76 Manganese as a proxy for rhizosphere carboxylates

77 In 2015, Lambers *et al.* proposed that leaf manganese concentrations ([Mn]) can be used as a 78 proxy for rhizosphere carboxylate (see Glossary) concentrations [1]. This tool has now been 79 used to screen native plant species growing in natural habitats [2–4] as well as genotypes of 80 chickpea (*Cicer arietinum*) under glasshouse conditions [5,6]. The tool is also valuable to investigate to what extent neighbours depend on **facilitation** of their phosphorus (P) uptake 81 by carboxylate-releasing species [7,8]. Results on leaf [Mn], therefore, offer tremendous 82 83 potential to obtain information on rhizosphere processes that is very hard to get, especially under field conditions. Not only does it allow us to find out if a particular species uses a 84 carboxylate-releasing P-mobilising strategy, but it can also provide evidence for facilitation 85 of P acquisition of neighbours of species that release carboxylates [4,9]. Carboxylate-86 87 releasing strategies are particularly important on severely P-impoverished ancient soils [10] 88 and on young volcanic soils with low P availability due to strong P sorption onto Fe oxides [11,12]. 89

90 Recently, de Tombeur et al. [13,14] showed that on ancient soils along the Jurien Bay chronosequence (south-western Australia) where many species exhibit carboxylate-releasing 91 P-mobilising strategies, leaf silicon concentrations ([Si]) are markedly higher than on 92 younger P-richer soils, despite very low plant-available [Si] in those ancient soils. This 93 pattern was found both at the community-level via species replacement across the 94 chronosequence, and also within some families and species that occur at different stages 95 along the chronosequence [13,14]. Conversely, all leaf macronutrient concentrations decrease 96 97 with increasing soil age [2,13,14]. In addition to a contribution of recycled soil phytoliths

98 (*i.e.* phytogenic **silica**) as a source of plant-available Si in these old soils [13], this 99 observation led us to explore if there is a causal relationship, with carboxylates not only 100 mobilising P and Mn, but also Si, which is abundant in soil, but not invariably readily 101 available for plants (Box 1). We propose a conceptual model (Figure 1) that explains why 102 leaf [Si] increases in some species on ancient soils. We also propose ways to test our model 103 and suggest future research directions.

#### 104 Silicon uptake in plants

Silicon uptake in plants is predominantly an active process, and Si enters the plant from the 105 106 soil solution in the form of H<sub>4</sub>SiO<sub>4</sub> through specific influx channels (Si transporters) encoded by a specific gene, OsLSi1 in rice (Oryza sativa), in which it is constitutively 107 108 expressed in the roots [15]. The gene Lsil is expressed in a range of other plant species including maize (Zea mays), barley (Hordeum vulgare), wheat (Triticum aestivum), soybean 109 110 (Glycine max), and tomato (Solanum lycopersicum) [16–20]. Plant species differ greatly in Si accumulation, ranging from 1 to 100 g kg<sup>-1</sup> shoot dry weight [21]. The difference depends on 111 whether a species expresses transport proteins allowing Si permeability [22]. In addition to 112 actively taking up Si, plants acquire it passively [23]. Active transport is the major 113 mechanism in rice and maize (Zea mays), whereas passive uptake prevails in sunflower 114 (Helianthus annuus) and wax gourd (Benincase hispida) at higher external Si concentrations 115 [23]. Even in these species, active transport contributes to the total Si uptake, especially at 116 lower external Si concentrations. Silicon occurs as hydrated amorphous silica (phytoliths) in 117 specific cells of roots, stems and leaves. 118

#### 119 Silicon in plants: phytoliths

120 Phytoliths in plants are thought to function as structural support [24] and in herbivore defence, by abrading herbivore mouthparts [25]. Plant silicification also increases plant 121 122 resistance to water stress [26], reduces the soil-to-plant translocation of mineral toxicants [22], and probably interferes with the recognition process upon pathogen infection [22]. 123 Phytoliths vary widely in chemical composition. In addition to Si, carbon (C) and oxygen (O) 124 [27], some contain aluminium (Al), and this is considered a mechanism to detoxify Al 125 [28,29]. Phosphorus may also become trapped in phytoliths [30] as do a wide range of other 126 elements, both nutrients and toxic elements [29,31]. 127

Silica-based defences are considered cheap alternatives for carbon-based quantitative
 defence compounds. Raven [32] indeed calculated that, on a weight basis, the energetic cost

130 of incorporating 1 g of lignin is about 27 times greater than that of incorporating 1 g of SiO<sub>2</sub>. There also appears to be a trade-off between investments in silica- and C-based 131 defence/structural compounds, because numerous studies reported negative correlations 132 between leaf [Si] and concentrations of phenols or C-based structural components [33–36]. In 133 support of this, de Tombeur et al. [14] found a trade-off between phenol- and silica-based 134 defences along the Jurien Bay chronosequence that exhibits a very strong gradient of nutrient 135 availability [14,37], with a stronger expression of silica-based defences in old P-depleted 136 soils. Investing in silica-based defences, rather than phenol-based defences in nutrient-137 138 depleted habitats, when resources are severely limiting, would make sense from an energetic perspective [32]. Nevertheless, if silica-based defence is effective and less costly, why do not 139 all plants invest greatly in this putatively cheap defence strategy, rather than one based on 140 more costly carbon-based quantitative defence compounds? The higher density of silica 141 compared with C-based compounds might be a disadvantage to plants [32], but, as we 142 explore below, this might also be because Si-based defence involves less metabolic costs only 143 144 if there is plenty of plant-available Si in the rhizosphere, and involves substantial costs if Si 145 needs to be mobilised to become available for plant uptake.

#### 146 Silicon mobilisation by root-released carboxylates

#### 147 Carboxylate effects on soil Si mobilisation

Carboxylate-releasing strategies are crucial for plants growing in severely P-impoverished 148 149 soils [10,38], but their role for plant Si uptake in mobilising soil Si from soil minerals has never been considered seriously. Yet, root-released carboxylates do not only increase soil P 150 151 and Mn mobilisation, but also that of Al, iron (Fe), calcium (Ca), potassium (K) and several other metals [39–42]. Carboxylates mobilise P from sorbed forms by complexing metal ions 152 153 constituting the minerals that bind phosphate (e.g., Fe and Al oxides), and displace P from the soil solid phases as ligand exchange reactions are precursor to the dissolution reaction (Figure 154 1) [43]. This accounts for the strong increase in dissolved [A1] and [Fe] in the rhizosphere of 155 cluster roots compared with that in bulk soil [39]. Fe and Al oxides show a strong potential to 156 sorb Si [44–46], and Si can be associated with those pedogenic oxides. Therefore, release of 157 monosilicic acid after ligand-promoted dissolution of Al/Fe oxides is very likely (Figure 1). 158 In support of this, the Si and Fe co-released from a quartz-rich soil containing Fe oxides is 159 significantly increased by three carboxylates abundantly exuded by specialised roots, and the 160 releases of both elements are positively correlated (Figure 2A, B). Similarly, the dissolution 161 162 of primary minerals like feldspars, 2:1 clay minerals like chlorite and 1:1 clay minerals

like kaolinite are also ligand-promoted, and release monosilicic acid in solution (Figure 2C)[47,48].

Mobilising Si from crystalline silicates via root-released carboxylates involves metal 165 166 complexation. In old highly-weathered soils, Si-bearing minerals are eventually dominated by quartz and phytoliths, because most primary minerals and Al/Fe-containing secondary 167 minerals have been lost by dissolution (Box 1). Here, carboxylates may also play a role in 168 mobilising Si, because low-molecular-weight organic acids increase Si release from quartz 169 [49], and we may expect the same for phytoliths, especially given their order-of-magnitude 170 greater dissolution rate compared with that of most silicate minerals [50]. In support of this, 171 the release of Si from pure quartz is slightly increased by oxalate (Figure 2C), yet not by two 172 others carboxylates (malate, citrate). Nevertheless, adding carboxylates in a phytoliths and 173 pure quartz mixture with phytolith concentration commonly encountered in soils (4 g kg<sup>-1</sup>; 174 e.g., [13,51]) significantly increases the effect of carboxylates on Si release (Figure 2C). This 175 176 demonstrates the prominent influence of carboxylates on phytolith dissolution relative to quartz dissolution. This process combined with the relatively high reactivity of phytoliths 177 compared with that of soil-derived minerals (Box 1) might explain why Si biocycling remains 178 intense in old soils having extremely low plant-available [Si] [13]. Many questions remain, 179 180 however, in particular whether the dissolution of phytoliths can be accelerated by complexation of the metals they contain. Moreover, the dissolution rates of silicates exhibit a 181 182 typical V-shape dependent on pH, with lowest rates around pH = 5.5/6.5 [52]. Rates increase with decreasing pH under acidic conditions, and also increase with increasing pH under 183 alkaline conditions [52,53]. Localised rhizosphere acidification by root activity [54] might 184 therefore also increase Si release through silicate dissolution in addition to the effect of 185 carboxylates. 186

#### 187 Evidence based on relationships between leaf [Si] and [Mn]

Because leaf [Mn] can be used as a proxy for carboxylate-releasing strategies under the same pedological conditions [1,3,5], similar patterns for the two elements are expected if Si is also mobilised during the process (Figure 1). Interestingly, foliar [Si] and [Mn] increase along the Jurien Bay chronosequence, as opposed to a decrease in concentrations of all macronutrients [2,14]. For leaf [Si], such an increase is not only observed at the community-level, but also within some species that occur at different stages along the chronosequence [13,14]. This pattern is associated with a strong decline in soil P concentration [14], and a subsequent increase in the relative cover of species with cluster roots or their functional equivalent [55]
that release carboxylates to acquire poorly-available P [10].

Interestingly, both leaf [Si] and leaf [Mn] are significantly greater in non-mycorrhizal 197 198 species than in mycorrhizal species across the Jurien Bay chronosequence, with most nonmycorrhizal species known to release carboxylates (Figure 3A) [1,2]. This pattern was found 199 despite increased Si accumulation by mycorrhizal colonisation [56,57], and occurs across all 200 soils of the chronosequence (except for leaf [Si] at stage 1), despite wide variation in pH-201 values (~5-8) (Figure S1) [2]. This may be because mycorrhizas appear to contribute little to 202 uptake of P on ancient soils [38]. In addition, high leaf [Si] in the mycorrhizal group (> 5g 203 kg<sup>-1</sup>) only occur in Poaceae, which have Si transporters [15], and in *Hibbertia hypericoides* 204 individuals (Dilleniaceae) that do not release carboxylates but are typically facilitated by 205 cluster roots of neighbouring banksias (Proteaceae) [4,58]. In contrast, non-mycorrhizal 206 species with relatively low leaf [Si] ( $< 5g \text{ kg}^{-1}$ ) are dominated by Proteaceae, for which the 207 presence of Si transporters is unknown. Such similarity between leaf [Si] and [Mn] along this 208 chronosequence is supported by a positive relationship between the concentrations of both 209 elements when species from different families are considered (Figure 3B). This occurs across 210 all soils of the chronosequence, whatever the variations in soil pH (Figure S2). These 211 212 relationships are significant, but rather weak, as to be expected because species from different families with contrasting capacities to accumulate Si are considered together in the analyses. 213

Because leaf [Si] vary greatly among terrestrial plant species [21] due to the 214 presence/absence of Si transporters [59], lower leaf [Si] among mycorrhizal species likely 215 216 reflects lower expression of Si transporters in this group (e.g., Asparagaceae, Fabaceae, 217 Myrtaceae, Rhamnaceae) compared with non-mycorrhizal species (e.g., Cyperaceae, Haemodoraceae, Proteaceae, Restionaceae). Therefore, we also reanalysed data from de 218 219 Tombeur *et al.* [14] for family- and species-level variation. Interestingly, both nutrients are positively correlated for both mycorrhizal (Fabaceae, Poaceae) and non-mycorrhizal 220 (Proteaceae, Cyperaceae) families (Figure 3C). The relationships are clearer for Poaceae and 221 Cyperaceae than for Fabaceae and Proteaceae, most likely because the first two strongly 222 223 express Si transporters [59]. Leaf [Si] and [Mn] are also correlated for Desmocladus asper (Restionaceae) (Figure 3C), a non-mycorrhizal species that forms sand-binding roots [60] 224 225 and possibly capillaroid roots [61]. Similarly, Kothari et al. [62] found a highly significant positive correlation between leaf [Si] and [Mn] in maize shoots. We suggest that these 226 227 relations between leaf [Si] and [Mn] are partly explained because both elements are mobilised by carboxylates in the rhizosphere (Figure 1), and perhaps also via root-inducedacidification of the rhizosphere [54].

In environments where soil Mn availability is far greater than the very low concentration in 230 231 Jurien Bay, for example New Caledonia [63], Si mobilisation might be important to ameliorate Mn toxicity in carboxylate-releasing species. In 1978, Horst & Marschner [64] 232 showed that *Phaseolus vulgaris* (common bean) plants treated with Si showed much greater 233 tolerance to Mn toxicity than untreated plants. In particular, 1.8 mM of Mn was toxic for 234 leaves in the absence of Si, but this critical level was 18 mM with Si addition [64]. The 235 authors explained the beneficial effect of Si on Mn toxicity by the prevention of local Mn 236 237 accumulation within leaf tissues and a more homogeneous distribution. This conclusion is supported by more recent studies on a range of species [65–67]. 238

239 The situation for Poaceae differs from that outlined above, because grasses tend not to 240 enhance the release of carboxylates in response to P starvation yet do accumulate both Si and Mn (Figure 3C). Poaceae typically enhance the release of phytosiderophores, which are 241 strong chelators of Fe, in response to Fe deficiency [68–70]. Phytosiderophores also mobilise 242 zinc [71], Mn [72], and Si [73]. Gattullo et al. [73] showed that Fe-deficient barley (Hordeum 243 vulgare) mobilises Si, in addition to Fe, from smectite through the exudation of organic 244 ligands. Interestingly, Fe-deficient maize plants not only enhance expression of transporters 245 for Fe<sup>2+</sup>, but also those involved in transport of P (ZmPHT1;7 and ZmPHO1) [70]. Being 246 strong chelators, phytosiderophores are expected to mobilise P sorbed onto Fe oxides. We are 247 not aware of enhanced phytosiderophore release in response to P-starvation, but that is what 248 249 we might expect to account for increases in leaf [Mn] in Poaceae with decreasing P 250 availability along the Jurien Bay chronosequence [14].

251 Decrease of leaf [Si] with fertilization

In wheat, an elevated P supply reduces foliar [Si] [74], suggesting a role for chelating 252 compounds in mobilising both P and Si in this species. These might be phytosiderophores, as 253 these do mobilise Si when chelating Fe [73], whereas grasses tend not to release large 254 amounts of carboxylates. There are exceptions, however, for example oats (Avena sativa) 255 [75] and sorghum (Sorghum bicolor) [76]. Carboxylate release would be suppressed under 256 257 high P supply, thus reducing Si mobilisation and uptake. Similarly, leaf [Si] of Holcus lanatus (Poaceae) increases under P deficiency [77], and Johnson et al. [78] showed that leaf 258 259 [Si] decreased markedly in three grass species (Cynodon dactylon, Eragrostis curvula and

*Microlaena stipoides*), following fertilisation (nitrogen, K, P). More generally, recent studies suggest that grasses may not have evolved silica-based defences in response to extensive herbivory, but in response to dry hot [79] and infertile environments [80]. In summary, fertilisation, and especially P fertilisation, tends to decrease leaf [Si] in a range of Poaceae which we suggest is caused by a decrease in soil Si mobilisation through the suppression of exudation of chelating substances.

#### 266 Concluding remarks and perspectives

We propose that plants growing in P-impoverished environments that express Si transporters 267 268 exhibit relatively higher leaf [Si] because of the mobilisation of Si by root-released carboxylates or other chelators into the rhizosphere. Moreover, protons released in the 269 270 rhizosphere alongside carboxylates [81] might further increase Mn, P [54] and possibly Si solubilisation for subsequent plant uptake. These processes are expected mainly at the family 271 272 or species-level, because plants exhibit great variation in their leaf [Si] due to presence/absence of Si transporters [59]. At this level, correlations between leaf [Si] and 273 274 [Mn] are expected if species/individuals are sampled across a gradient of P availability, and therefore of rhizosphere carboxylate concentrations, particularly if they exhibit Si 275 276 transporters. Nevertheless, an overall correlation between leaf [Si] and [Mn] when species 277 from different families are considered reveals a possible greater role of carboxylates on plant Si uptake (Figure 3B). Because carboxylate-releasing P-mobilising strategies incur significant 278 C costs [82], the costs of silica-based defences might be higher than commonly realised [32] 279 if carboxylates or other root exudates are needed to mobilise Si in the rhizosphere, especially 280 when plant-available [Si] is low. 281

While many questions remain, this Opinion Paper paves the way towards the exploration of a 282 283 role for root exudates in soil-plant-herbivore Si dynamics, thus providing promising perspectives for ecosystem Si research in both natural systems and agroecosystems (see 284 285 Outstanding questions) [83]. Indeed, the role of root exudates has been considered for mobilisation of many essential nutrients, but ignored for Si, a beneficial element [22]. It is, 286 287 however, time to consider these aspects, since the significant role of Si in plant biology [22,84] and ecology [85] is increasingly acknowledged. A detailed understanding of the 288 289 factors influencing its dynamics in soil-plant systems is therefore urgently required.

Carboxylates chelate metal cations (e.g., Fe, Al and Mn) of pedogenic oxides 528 (e.g., Fe, Al and Mn oxides) and metal-containing silicates, thereby increasing their 529 dissolution. Carboxylates also increase quartz and phytolith dissolution [49] (Figure 2C), 530 531 although the underlying mechanisms are less clear. In Strategy 1 species, chelated Fe moves to the root surface, where it is reduced, followed by uptake via a Fe<sup>2+</sup> transporter [iron-532 regulated transporter (IRT)]; this transporter is not specific and transports other 533 micronutrients, including Mn<sup>2+</sup>. In Strategy 2 species, ligand exchange converts Fe to Fe<sup>3+</sup>-534 phytosiderophore (PS) complexes for root uptake via the Fe<sup>3+</sup>-PS transporter [yellow stripe 1 535 (YS1) and yellow stripe-like (YSL) transporter] [87,88]. Silicon occluded in metal-containing 536 silicates as well as Si sorbed onto or co-precipitated in pedogenic oxides is subsequently 537 released into the soil solution in the form of monosilicic acid (i.e. H<sub>4</sub>SiO<sub>4</sub>) by this ligand-538 539 promoted dissolution process [48,89]. Monosilicic acid can then be taken up passively or actively, the latter involving Si transporters, e.g., LSi1, which is highly expressed in some 540 species, e.g., rice (Oryza sativa) [15], but not in some other species. In soils with low plant-541 available [Si], we expect accumulation of Si in plants with high rhizosphere carboxylate 542 543 concentrations that highly express Si transporters. High concentrations of carboxylates in the 544 rhizosphere may be the result of release of the Si-accumulating plants themselves, as shown here, or by their neighbours [7]. ### **Box 1: Silicon in soils**

Silicon is the second most abundant element in the Earth's crust (28.8%), after oxygen (47.2%) [91]. It is the basis for a wide range of silicate minerals which makes it ubiquitous in most soil types, but only a small fraction of soil Si is available for plant uptake [92]. During the weathering of silicate minerals, monosilicic acid is released in the soil solution and can then be taken up by plants, mobilised in the formation of secondary minerals, sorbed onto reactive soil particles (e.g., Fe and Al oxides), or transferred towards the hydrosphere, where it serves as a nutrient for marine phytoplankton known as diatoms [92,93]. The concentration of dissolved Si primarily depends on the dissolution rates of primary and secondary Si-bearing minerals in soils [92,93]. During prolonged soil weathering, plant-available Si is first driven by the dissolution of primary minerals (e.g., feldspars), followed by secondary 2:1 (e.g., smectite), and then 1:1 (e.g., kaolinite) clay minerals [93]. Plant-available [Si] decreases following this sequence, as the degree of desilication (i.e. Si loss by leaching) increases over time [92-94]. The lowest plantavailable [Si] are typically found in old, highly-weathered soils dominated by residual sand-sized poorly-soluble [50] quartz minerals, most of primary and secondary minerals having been lost by dissolution [94]. Because the solubility of phytoliths (*i.e.* phytogenic silica) is greater than that of many primary and secondary Si-bearing minerals [50], their dissolution also contributes to plant-available Si [13,95]. Such contribution is thought to increase with increasing soil age and desilication [13,93].
