Substructuring based FEM-BEM coupling for Helmholtz problems

Abstract

This talk concerns the solution of the Helmholtz equation in a medium composed of a bounded heterogeneous domain and an unbounded homogeneous one. Such problems can be expressed using classical FEM-BEM coupling techniques. We solve these coupled formulations using iterative solvers based on substructuring Domain Decomposition Methods (DDM), and aim to develop a convergence theory, with fast and guaranteed convergence.

A recent article [1] proposed a substructuring Optimized Schwarz Method, with a nonlocal exchange operator, for Helmholtz problems on a bounded domain with classical conditions on its boundary (Dirichlet, Neumann, Robin). The variational formulation of the problem can be written as a bilinear application associated with the volume and another with the surface, for which, under certain sufficient assumptions, convergence of the DDM strategy is guaranteed.

In this presentation we show how some specific FEM-BEM coupling methods fit, or not, the previous framework, in which we consider Boundary Integral Equations (BIEs) instead of classical boundary conditions. In particular, we prove that the symmetric Costabel coupling satisfies the framework assumptions, implying that the convergence is guaranteed.

Keywords: Helmholtz equation, substructuring DDM, FEM-BEM coupling, guaranteed convergence, symmetric Costabel coupling

1 DDM substructuring framework

We consider the scattering of an acoustic wave by a penetrable heterogeneous bounded domain Ω_1 , with refractive index $n \in L^{\infty}(\Omega_1)$, assuming that $\Omega_0 \coloneqq \mathbb{R}^d \setminus \overline{\Omega_1}$ is homogeneous.

For each Ω_j , consider interior γ_N^j $N\over N$ (resp. γ_I^j $_{D}^{J})$ and exterior $\gamma_{N,c}^j$ (resp. $\gamma_{D,c}^j$) Neumann (resp. Dirichlet) traces, the orientation given by the unit normal vector to $\partial\Omega_j$ outgoing with respect to Ω_j . Denote trace operators $\gamma^j := (\gamma_D^j, \gamma_N^j)$ $_{N}^{j}),$ $\gamma_c^j \coloneqq (\gamma_{D,c}^j, \gamma_{N,c}^j)$ and the interface $\Gamma \coloneqq \partial \Omega_1$. We seek to solve the transmission problem

$$
\Delta u_1 + n(x) k^2 u_1 = f, \text{ in } \Omega_1,
$$

\n
$$
\Delta u_0 + k^2 u_0 = 0, \text{ in } \Omega_0,
$$

\n
$$
\gamma_D^0(u_0) - \gamma_D^1(u_1) = g, \text{ on } \Gamma,
$$

\n
$$
\gamma_N^0(u_0) + \gamma_N^1(u_1) = h, \text{ on } \Gamma,
$$
 (1)

+ Sommerfeld condition

with $k^2 > 0$, $f \in H^{-1}(\Omega_1)$ a source term. It is known that there exists a unique solution in $H_{\mathrm{loc}}(\Delta,\mathbb{R}^d)$.

Problem (1) can be reformulated equivalently as an equation posed only on the interface Γ , following the Optimized Schwarz Method proposed by [2,4], and involving a non-local exchange operator Π — as in [1] — and a scattering operator S:

$$
(\mathrm{Id} + \Pi S)\mathbf{q} = \mathbf{b}
$$

for $\mathbf{q} \in H^{-\frac{1}{2}}(\Gamma) \times H^{-\frac{1}{2}}(\Gamma)$.

Ensuring ΠS is a contraction implies strong coercivity of Id +ΠS, and thus convergence of iterative schemes (at continuous level), such as Richardson or GMRes. The framework of [1] identifies several sufficient assumptions, which will be described afterward, to ensure this contractivity. Our contribution consists in using BIEs from FEM-BEM coupling techniques, instead of classical Dirichlet, Neumann or Robin boundary conditions, and studying if those assumptions are satisfied.

On the one hand, (1) is supposed to rewrite as: find **u** in $H(\Omega_1 \times \Gamma) := H^1(\Omega_1) \times H^{-\frac{1}{2}}(\Gamma)$ such that

$$
A_{\Omega_1 \times \Gamma}(\mathbf{u}) = \mathbf{r}\mathbf{h}\mathbf{s},\tag{2}
$$

where **rhs** stands for some source term, and $A_{\Omega_1\times\Gamma}$ takes the form:

$$
\langle A_{\Omega_1 \times \Gamma}(u, p), (v, q) \rangle \coloneqq \langle A_{\Omega_1}(u_{|\Omega_1}), v_{|\Omega_1} \rangle + \langle A_{\Gamma}(\gamma_D^{\dagger}(u), p), (\gamma_D^{\dagger}(v), q) \rangle
$$
 (3)

where A_{Ω_1} corresponds to a volume part which accounts for the first line of Equation (1). A_{Γ} : $H^B(\Gamma) \to H^B(\Gamma)^*$ corresponds to a pure surface part accounting for the outer boundary contribution, with $H^B(\Gamma) := H^{\frac{1}{2}}(\Gamma) \times H^{-\frac{1}{2}}(\Gamma)$. On the other hand, our convergence theory requires:

- (a) $\text{Im}(\langle A_{\Gamma}(\phi, p),(\overline{\phi}, \overline{p})\rangle) \leq 0 \quad \forall (\phi, p),$
- (b) range($A_{\Omega_1 \times \Gamma}$) is closed in $H(\Omega_1 \times \Gamma)^*$.

2 Application with FEM-BEM coupling

The expression of A_{Γ} relies on Boundary Integral Operators. We introduce G_k the Helmholtz k-outgoing Green kernel, and

$$
\mathrm{SL}_k(q)(\mathbf{x}) \coloneqq \int_{\Gamma} G_k(\mathbf{x} - \mathbf{y}) q(\mathbf{y}) \, d\sigma(\mathbf{y}),
$$

$$
\mathrm{DL}_k(v)(\mathbf{x}) \coloneqq \int_{\Gamma} (\gamma_N^0 G_k)(\mathbf{x} - \mathbf{y}) v(\mathbf{y}) \, d\sigma(\mathbf{y}),
$$

$$
\mathcal{A} \coloneqq \begin{pmatrix} {\gamma_D^0} \circ \mathrm{DL}_k & {\gamma_D^0} \circ \mathrm{SL}_k \\ {\gamma_N^0} \circ \mathrm{DL}_k & {\gamma_N^0} \circ \mathrm{SL}_k \end{pmatrix},
$$

with $\{\gamma_{\bullet}^0\} := (\gamma_{\bullet}^0 + \gamma_{\bullet,c}^0)/2, \bullet \in \{D, N\},\$ the mean of interior and exterior traces.

We choose here to focus on two classical FEM-BEM coupling methods: the Johnson-Nédélec one [5], and the symmetric Costabel one [3]. Then, the assumptions (2) and (3) on $A_{\Omega_1 \times \Gamma}$ rewriting are fulfilled. Indeed, $\langle A_{\Omega_1}(u), v \rangle :=$ $\int_{\Omega_1} \nabla u(x) \cdot \nabla v(x) dx - \int_{\Omega_1} k^2 n(x) u(x) v(x) dx,$ and the volume equation writes

$$
\langle A_{\Omega_1}(u), v \rangle + \int_{\Gamma} \gamma_N^0(u) \gamma_D^1(v) = \int_{\Omega_1} fv + \int_{\Gamma} h \gamma_D^1(v).
$$

Johnson-Nédélec method is then obtained by adding to the the volume equation a BIE derived using the first line of operator A.

A second BIE can also be derived using the second line of operator A , allowing to express $\gamma_N^0(u)$ as a sum of BIEs. Symmetric Costabel method is then derived by replacing $\gamma_N^0(u)$ in the volume equation with this new expression, and by adding to the volume equation the BIE derived using the first line of operator A (the same as in Johnson-Nédélec method).

Using Dirichlet transmission condition for both methods, problem (1) is thus reformulated with $A_{\Omega_1\times\Gamma}$ satisfying (3) — see Theorems 1 and 2 for expressions of A_{Γ} . Defining the skewsymmetric pairing

$$
[(u,p),(v,q)] \coloneqq \langle q,u\rangle - \langle p,v\rangle,
$$

which puts in duality $H^B(\Gamma)$ with itself, we state our new contributions.

Theorem 1 The operator A_{Γ} for Johnson-Nédélec coupling writes: $\forall (\phi, p) \in H^B(\Gamma), (v, q) \in H^B(\Gamma)$

$$
\langle A_{\Gamma}(\phi, p), (v, q) \rangle := \left[\left(\frac{\mathrm{Id} - A}{2} \right) (\phi, p), (0, q) \right] + [(\phi, p), \theta(v, 0)]
$$

with $\theta(v, q) = (-v, q)$. We show that
 $\exists (\Phi, P) \in H^B(\Gamma) | \mathrm{Im}(\langle A_{\Gamma}(\Phi, P), (\overline{\Phi}, \overline{P}) \rangle) > 0.$

In the case of Johnson-Nédélec coupling, assumption (a) appears too restrictive. Yet, this does not discard convergence of DDM schemes.

Theorem 2 The operator A_{Γ} for Costabel coupling writes: $\forall (\phi, p) \in H^B(\Gamma), (v, q) \in H^B(\Gamma)$

$$
\langle A_{\Gamma}(\phi, p), (v, q) \rangle := -\left[\frac{\mathcal{A}}{2}(\phi, p), (v, q)\right] + \frac{1}{2} [(\phi, p), \theta(v, q)]
$$

from which it can be shown

 $\forall (\phi, p) \in H^B(\Gamma)$, $\text{Im}(\langle \mathcal{A}_{\Gamma}(\phi, p), (\overline{\phi}, \overline{p}) \rangle) \leq 0.$

In the case of Costabel coupling, a generalized Gårding inequality can be also derived, implying that $A_{\Omega_1 \times \Gamma}$ is Fredholm with index 0. Thus, except for spurious resonances (Dirichlet eigenvalues of Laplacian problem in Ω_1), assumption (b) is fulfilled, and the convergence of the substructuring method can be proved.
