Image Characteristics and Task Influence Interobserver Consistency

Background

Interobserver consistency (IOC) refers to the degree of similarity in the gaze patterns of different observers when viewing the same image. Here, we explored how image characteristics and observers' viewing task influence IOC.

Our Study

- Participants (N = 96) viewed 192 images of scenes taken from the ADE20K dataset (Zhou et al., 2017).
- Participants either free-viewed the images or performed a memory task (between-subjects design).
- We recorded their eye movements.

Image Characteristics

We focused on two measures: visual clutter and semantic complexity.

Visual Clutter

- We used the Feature Congestion measure of visual clutter (Rosenholtz et al., 2007) which analyses how features (e.g., colour and luminance contrast) interact across an image.
- Feature Maps → Pooling → Conspicuity Maps → Normalisation →
 Feature Congestion Value.
- A higher Feature Congestion value indicates greater clutter.

Semantic Complexity

- We used GloVe (Pennington et al., 2014) to capture the complexity of the semantic content of each image.
- To do this, we selected images from the ADE20K dataset of labelled images (Zhou et al., 2017).
- We mapped object labels to vectors in the GloVe word embedding and calculated the pairwise semantic dissimilarity between objects within each image.
- Then, we took the average to obtain a 'semantic complexity' value per image, where higher scores indicate greater complexity.







Image Selection

- We wanted a diverse set of images covering the range of visual clutter and semantic complexity scores, with these metrics uncorrelated.
- To achieve this, we computed metrics for all images and selected a final stimulus set meeting this criteria.

How well the fixation heatmap of N-1 observers predicts the fixation


heatmap of the remaining observer using Pearson's correlation coefficient.





Linear Mixed Effects Model

IOC ~ Visual Clutter * Task + Semantic Complexity * Task + Number of Labels + (1|Image) + (1|Participant)



Conclusions

- Image characteristics influence IOC, with IOC decreasing as visual clutter increases and IOC increasing with semantic complexity.
- Task also impacts IOC, being higher during the memory task compared to freeviewing. However, a more defined task may enhance this effect.
- Clutter exerts a greater influence on IOC during the memory task compared to freeviewing.
